The ornamental design for a collapsible enclosure, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of the collapsible enclosure
showing my new design;

FIG. 2 is a front elevational view of the collapsible enclosure
of FIG. 1;

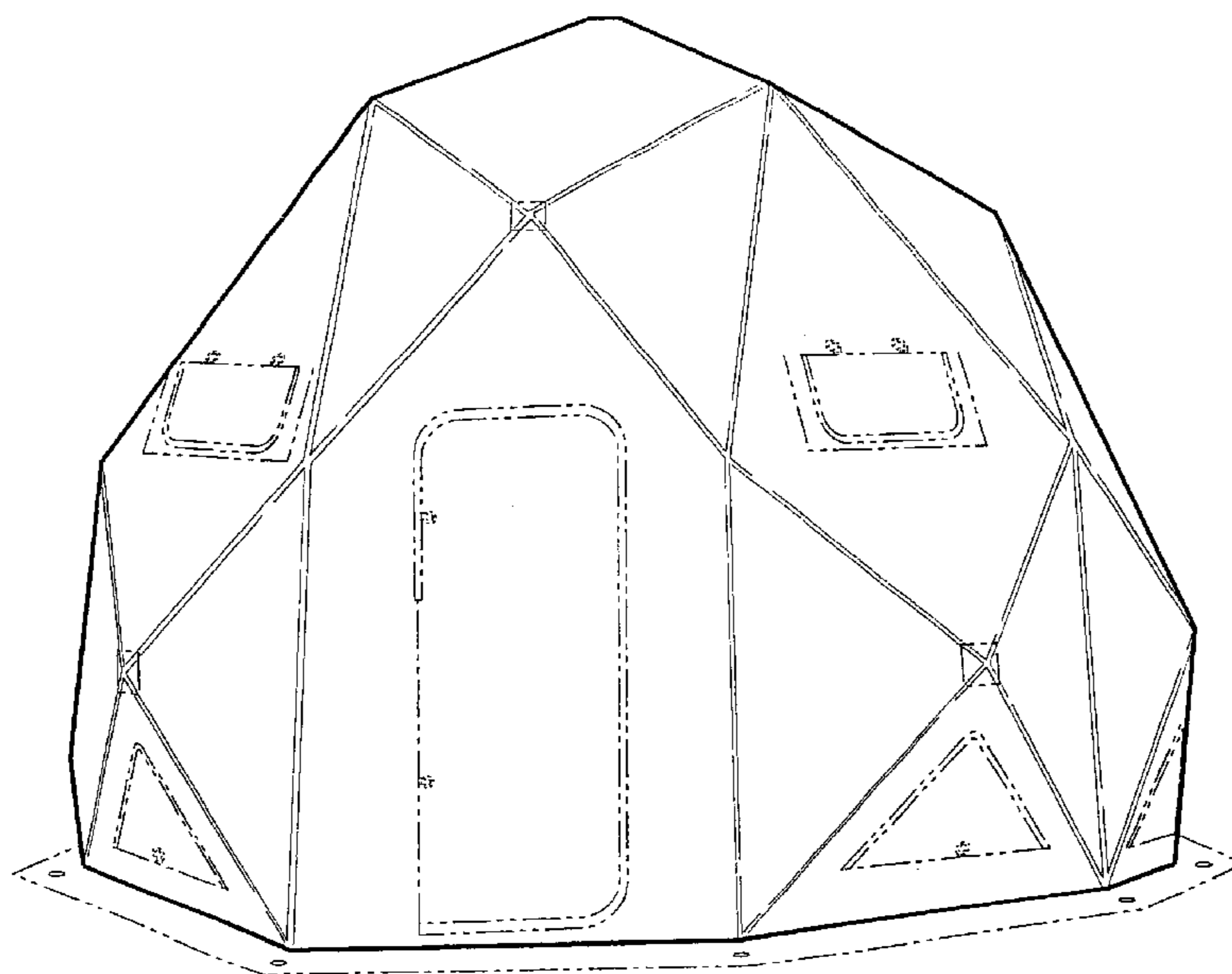
FIG. 3 is a rear elevational view of the collapsible enclosure

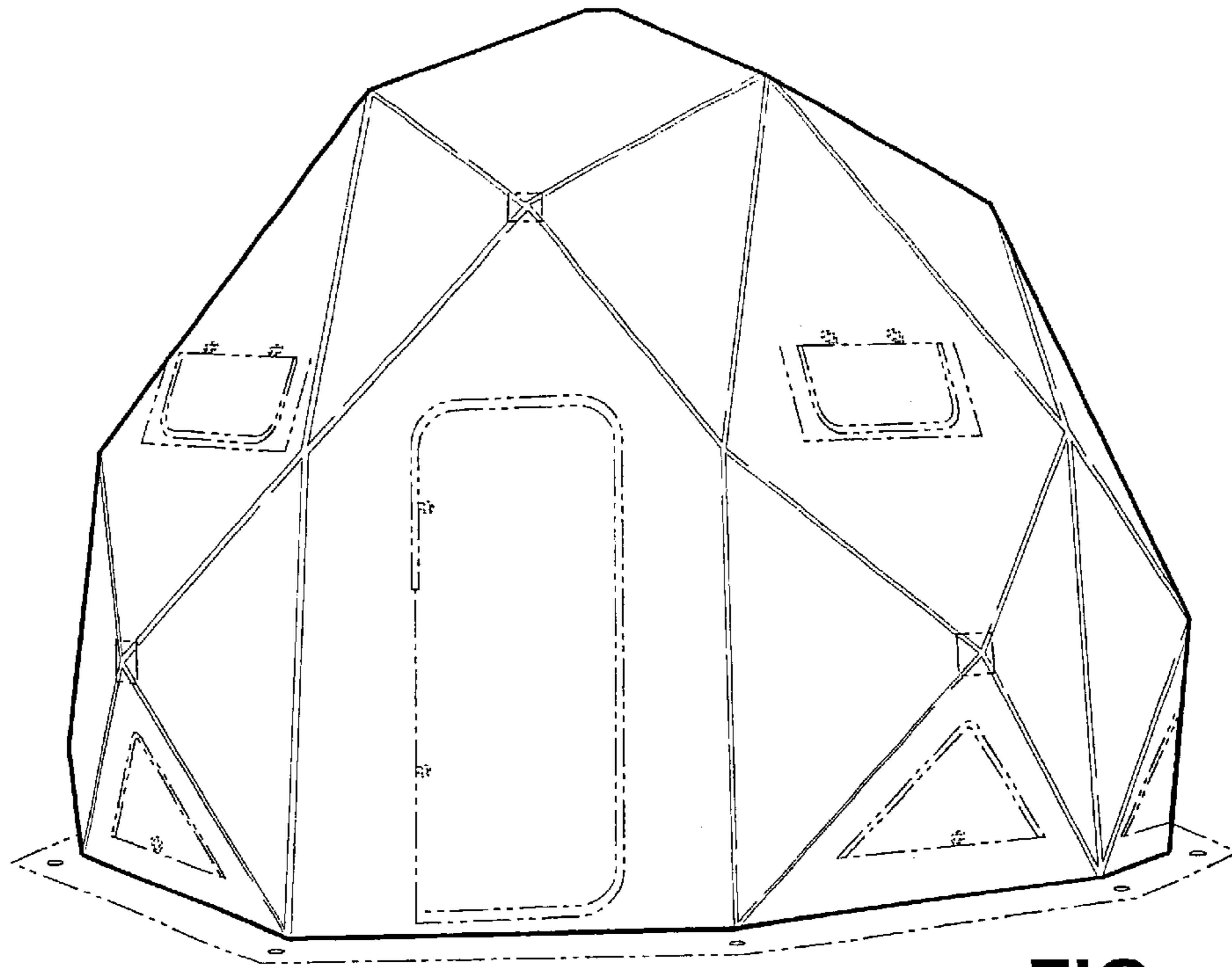

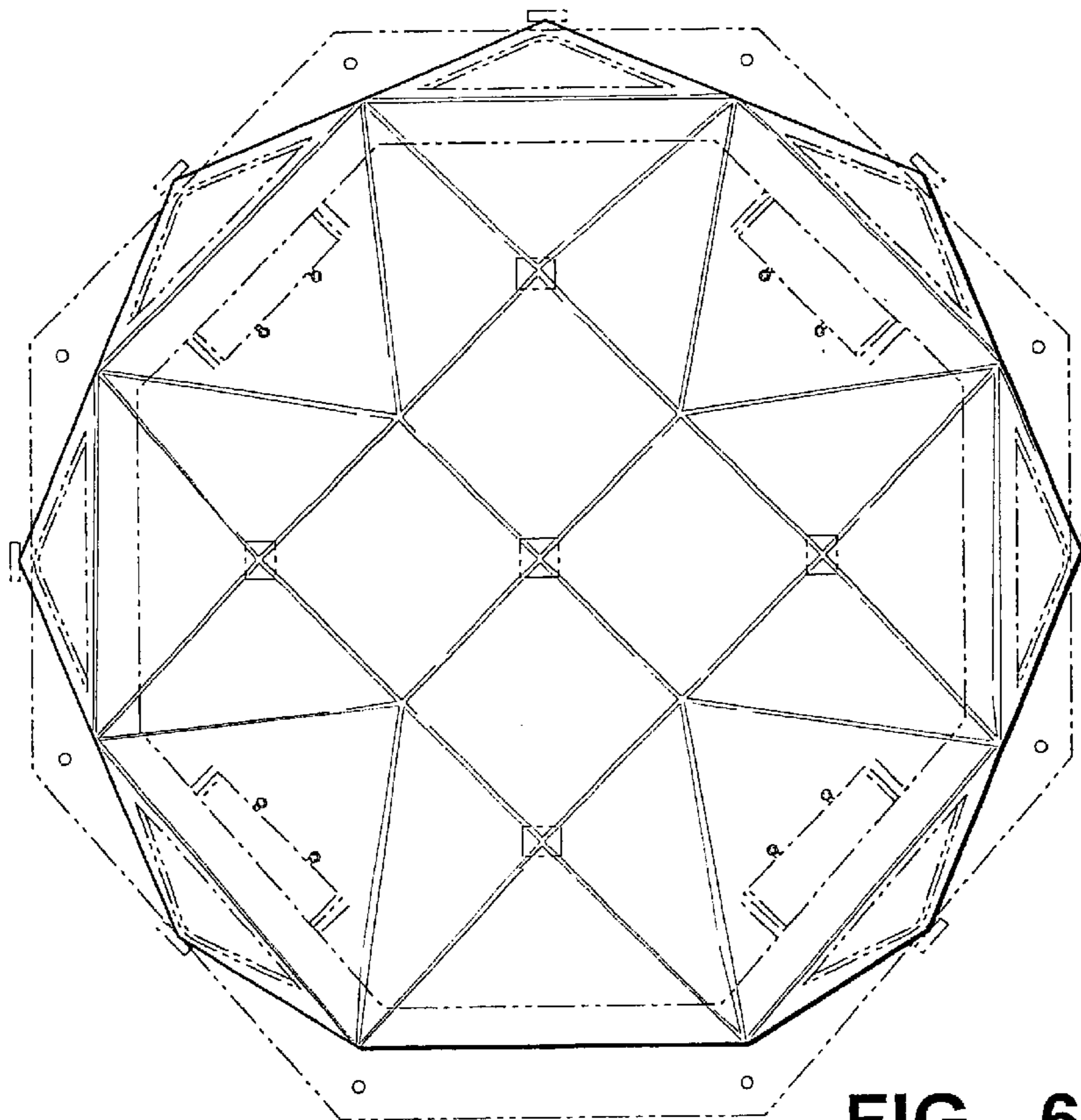

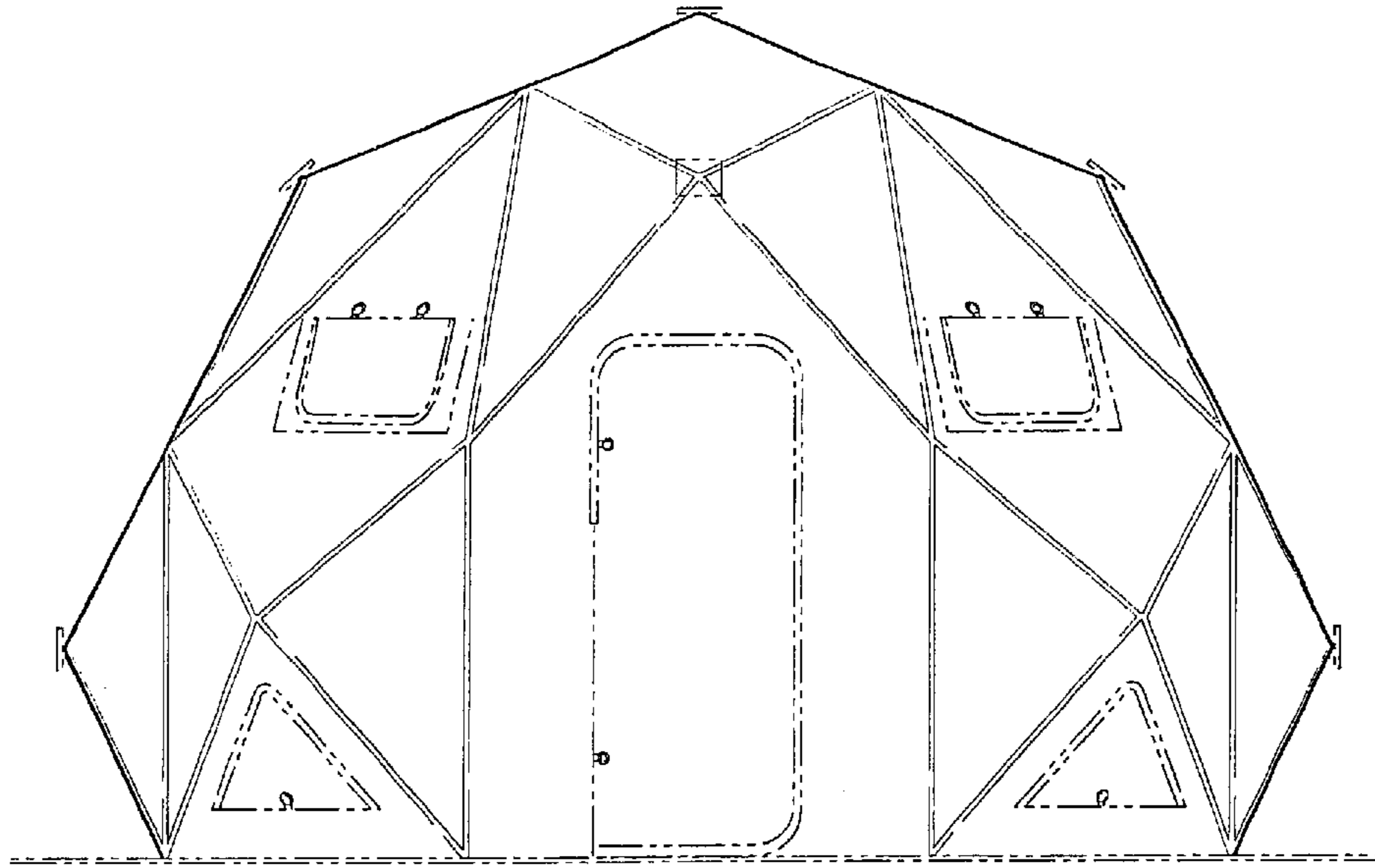

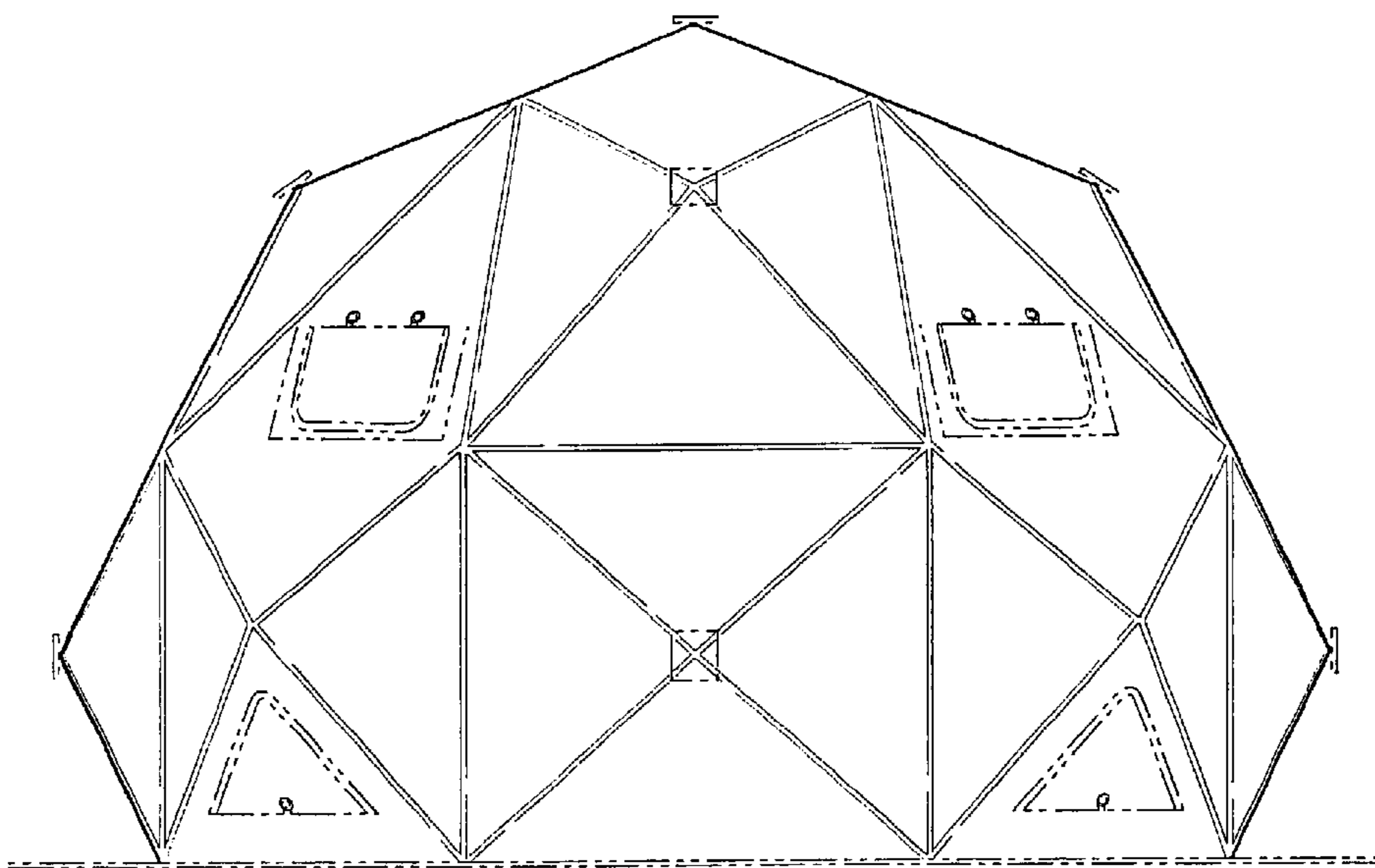

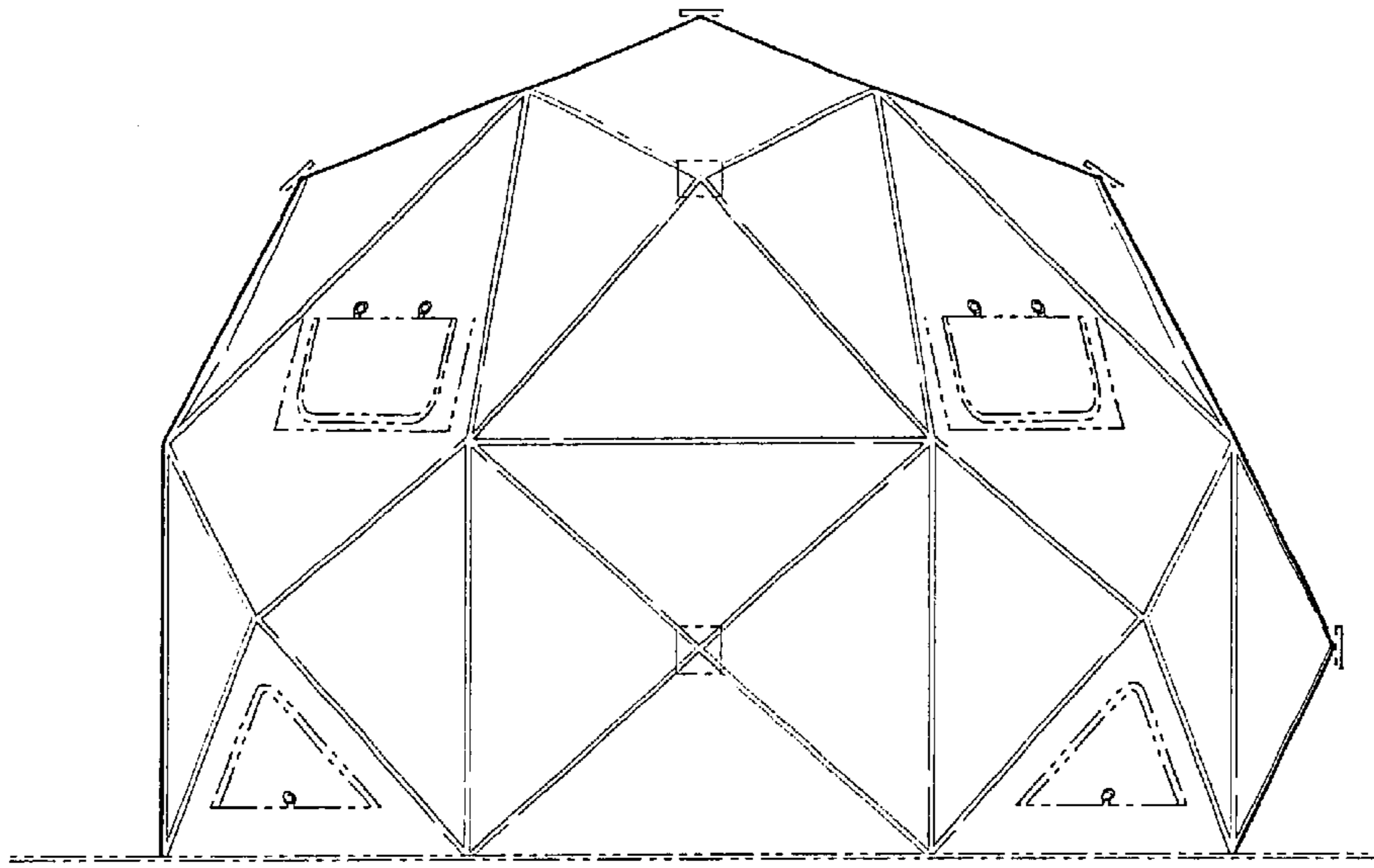

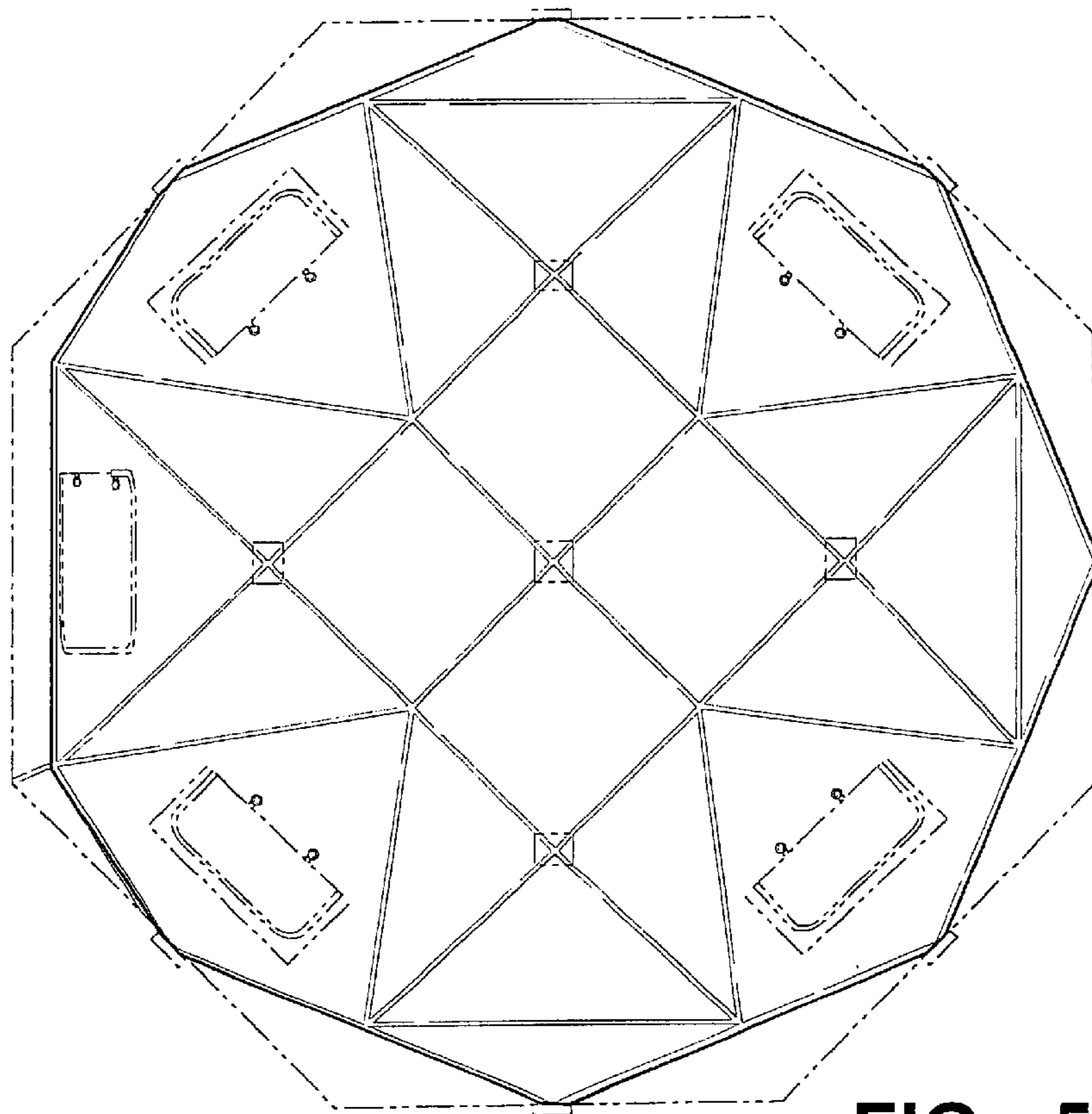
