(57) **CLAIM**

The ornamental design for a bowl attachment, as shown and described.

DESCRIPTION

In a preferred embodiment, the nature of this product is an attachment in the form of a seat, cover or cover and seat assembly for a plumbing fixture having a bowl, such as a water closet or a bidet.

FIG. 1 is a left, top, front perspective view of a bowl attachment in the form of a cover according to another embodiment of my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a left side elevational view thereof, the right side elevational view thereof being a mirror image of the left side shown;

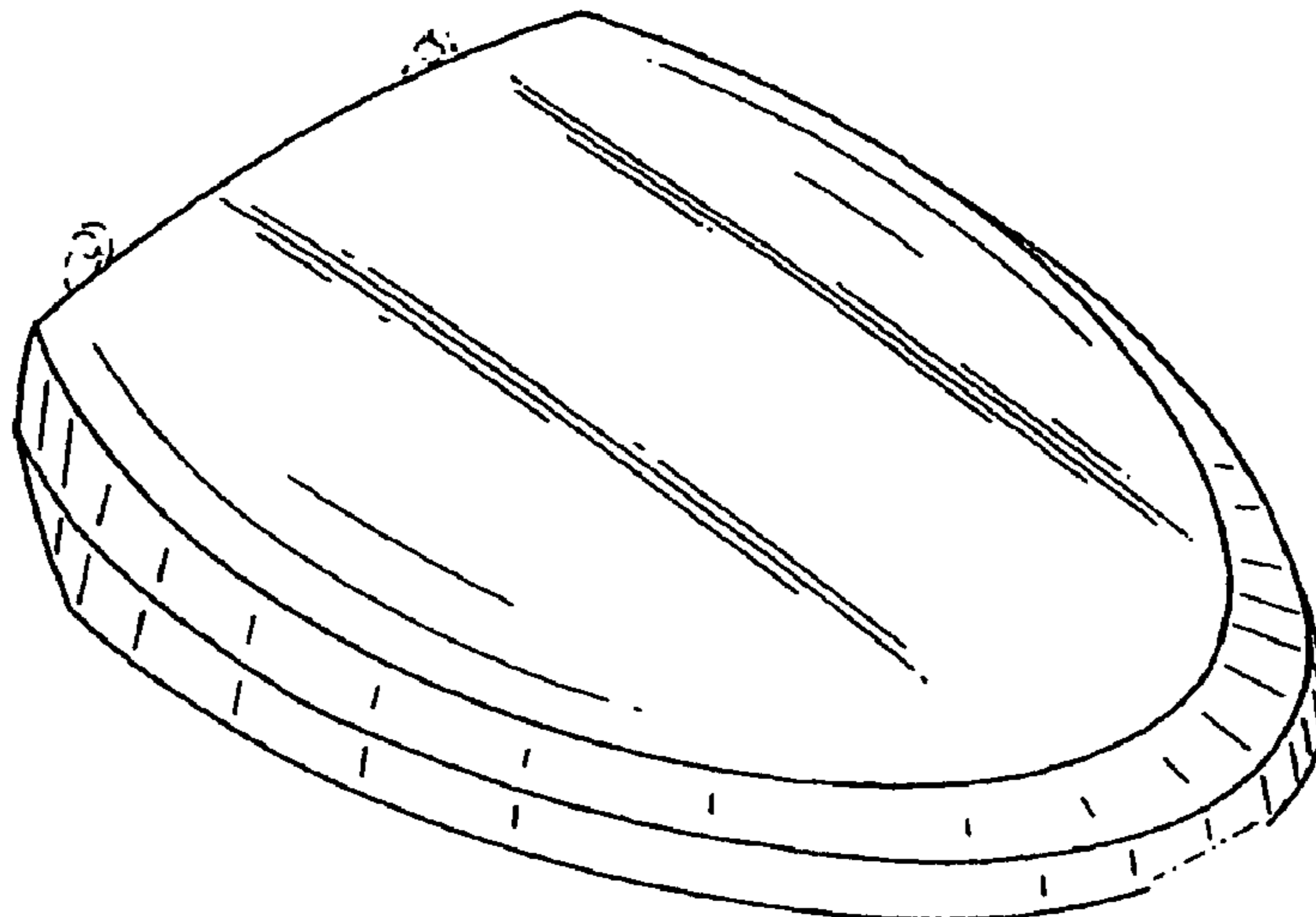
FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof; and,

FIG. 6 is a bottom plan view thereof.

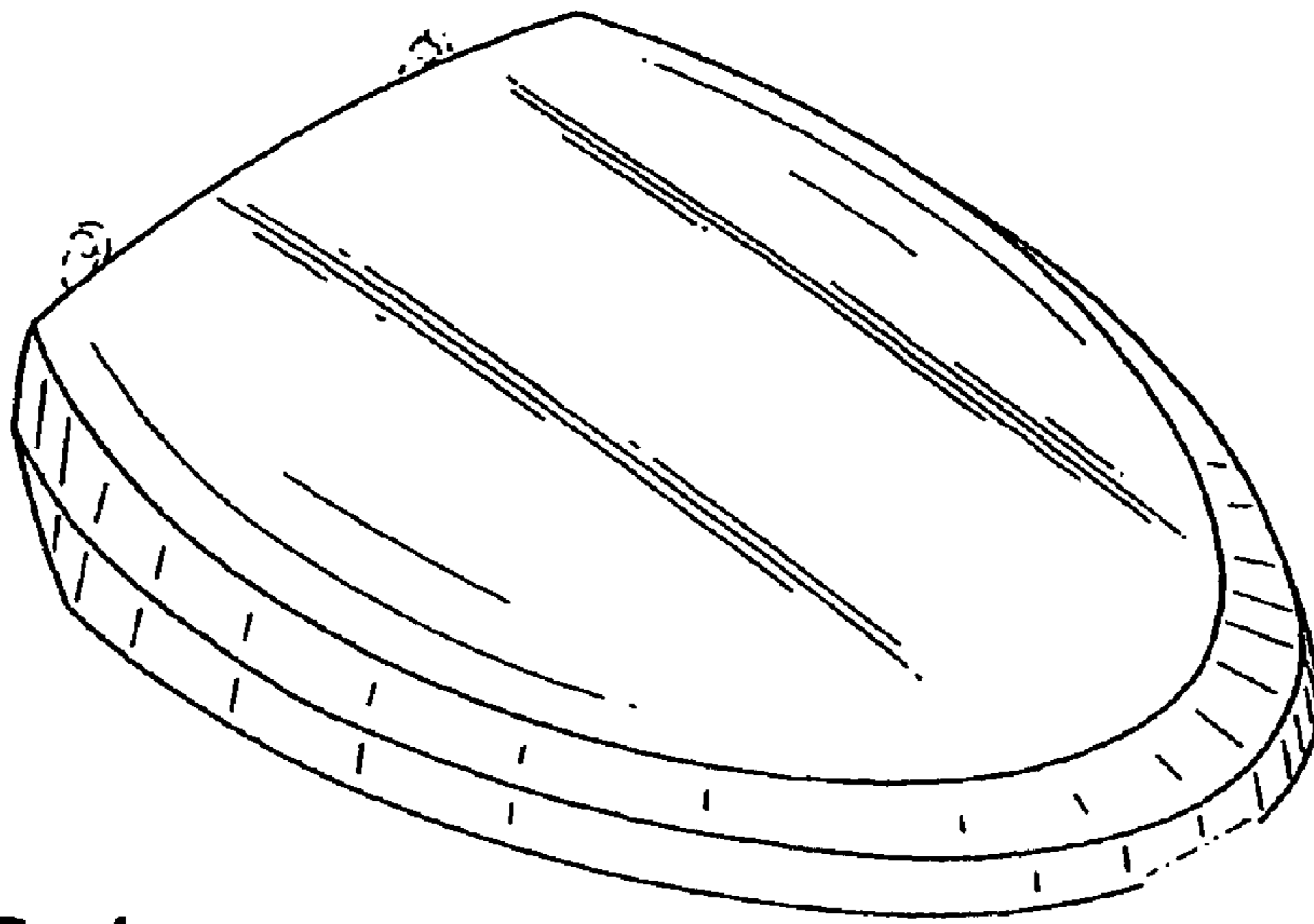

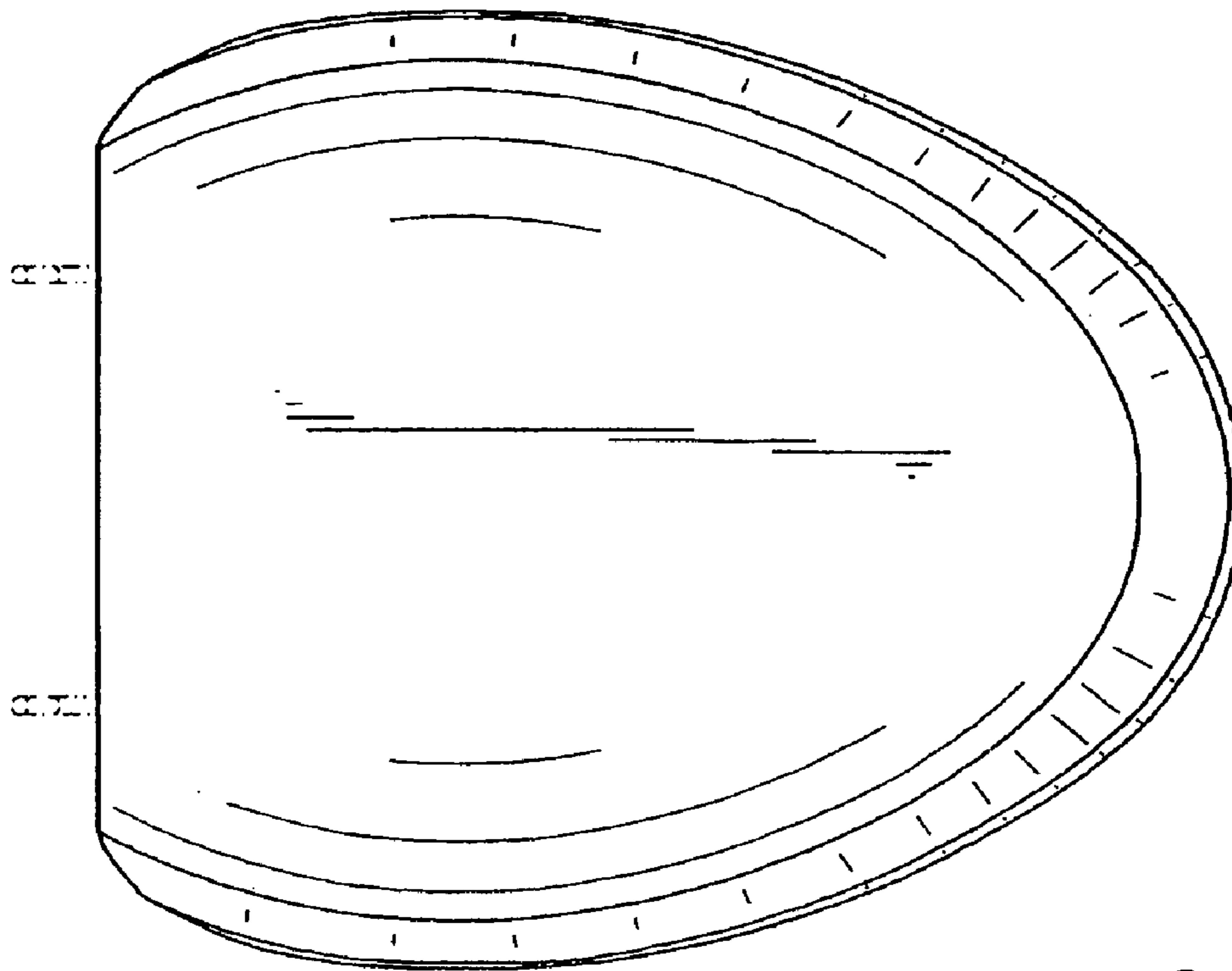

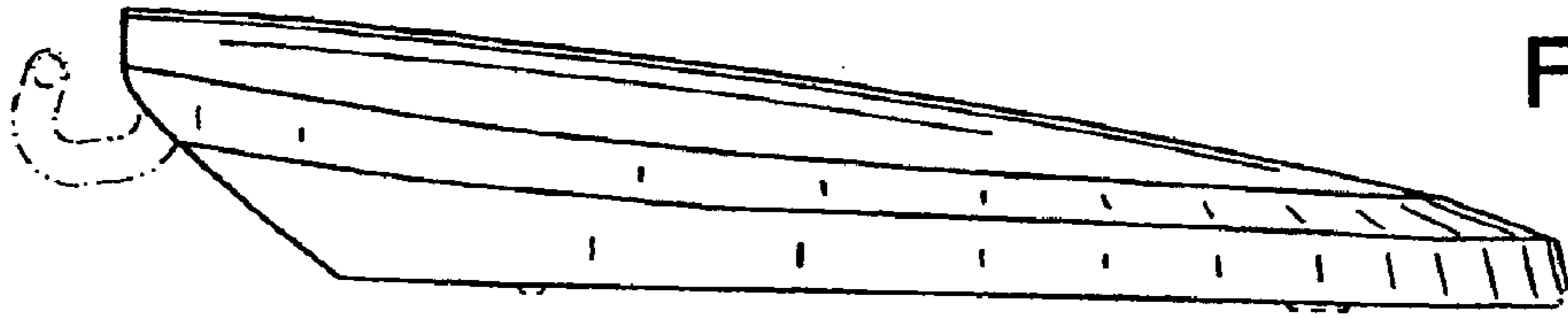

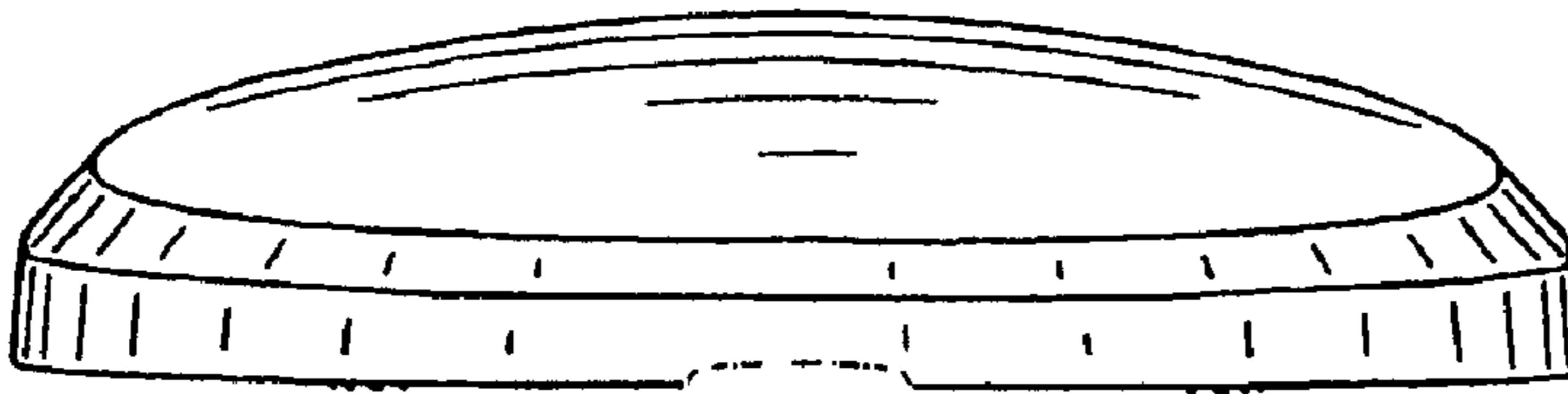

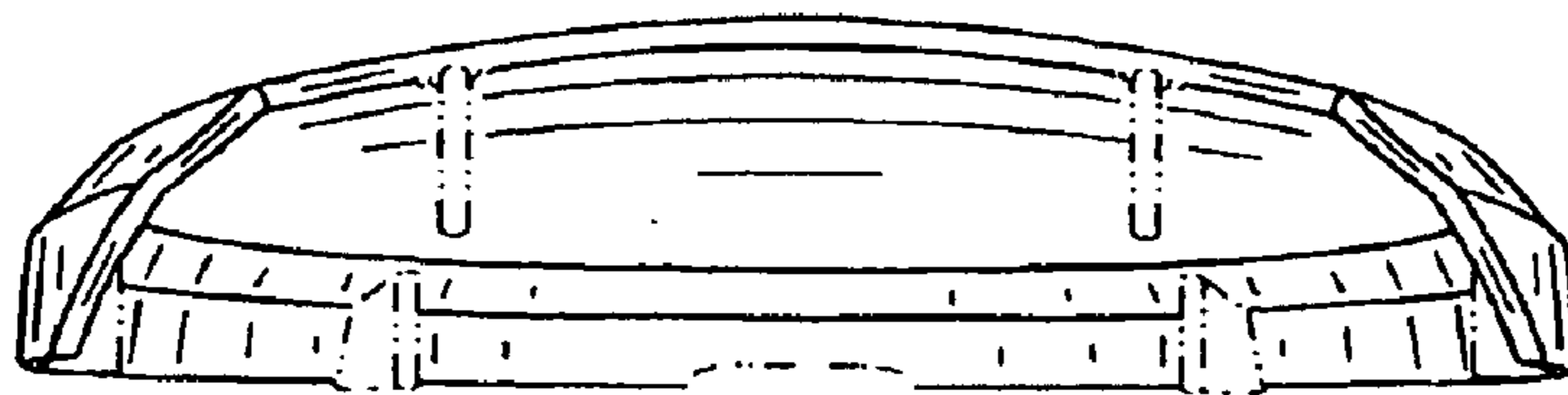

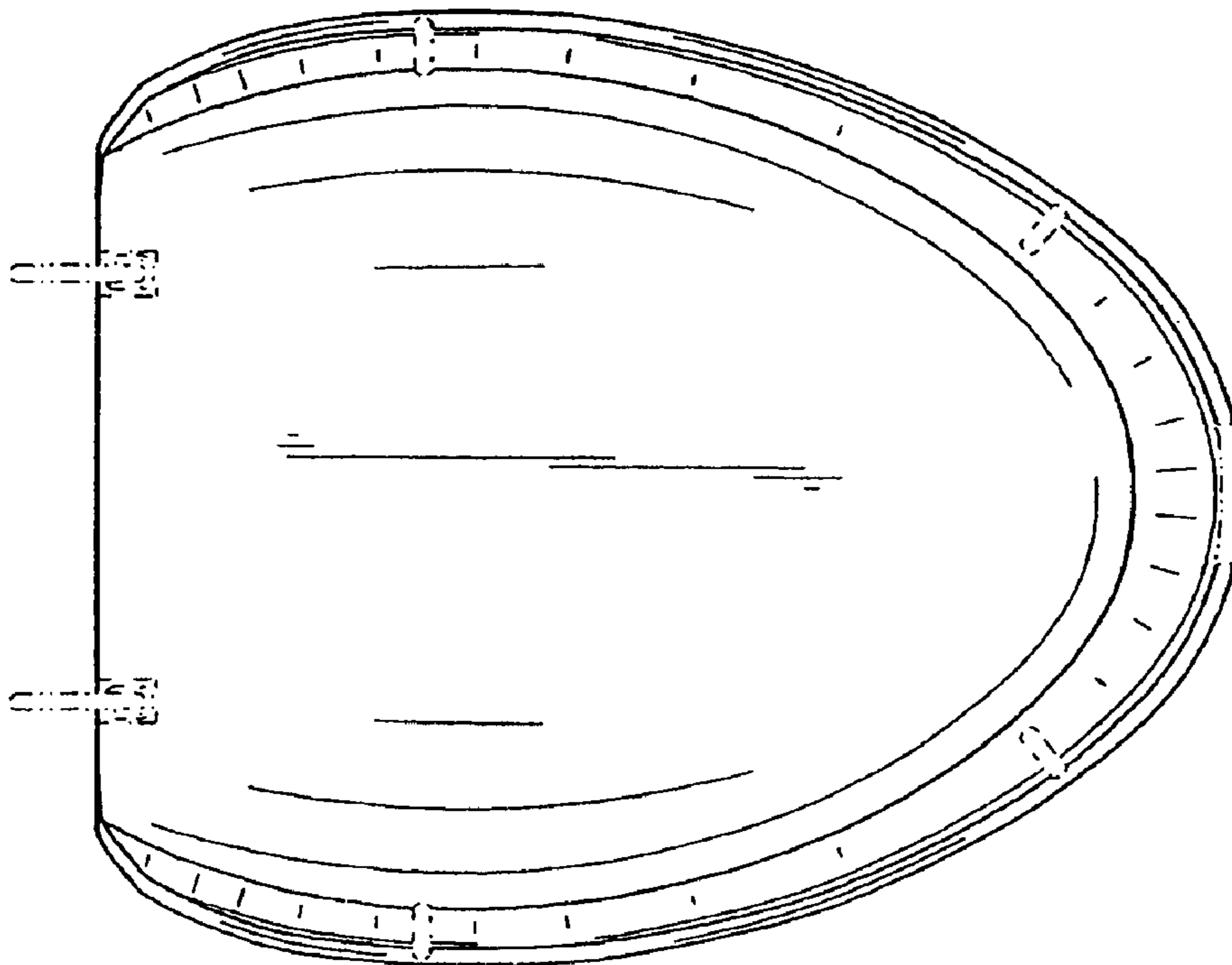
