(57) **CLAIM**

The ornamental design for an applicator, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of an applicator showing our design;

FIG. 2 is a bottom perspective view of the applicator of FIG. 1;

FIG. 3 is a side view of the applicator of FIG. 1, the opposite side being a mirror image thereof;

FIG. 4 is a top view of the applicator of FIG. 1;

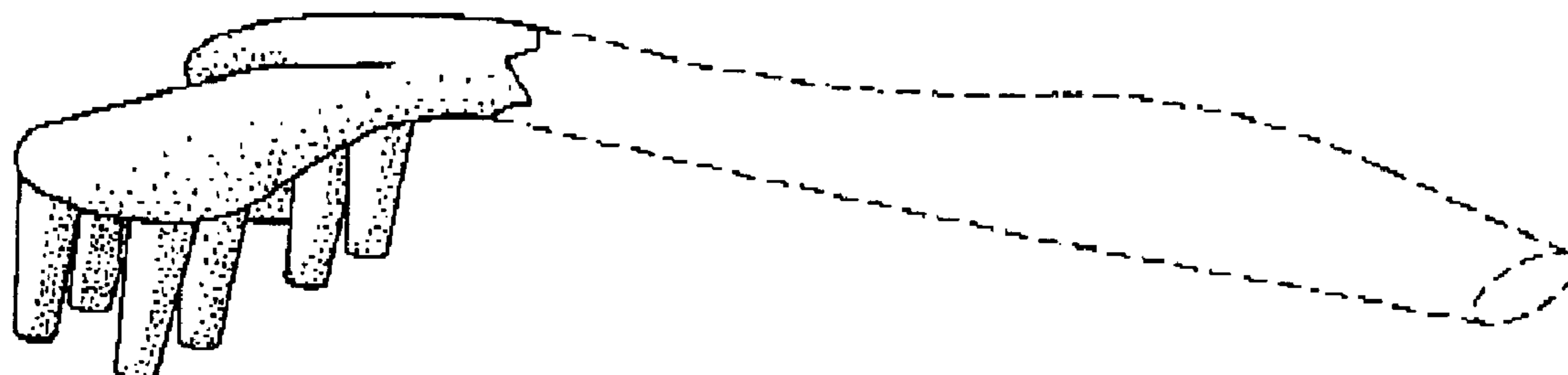
FIG. 5 is a bottom view of the applicator of FIG. 1;

FIG. 6 is a front view of the applicator of FIG. 1; and,

FIG. 7 is a rear view of the applicator of FIG. 1.

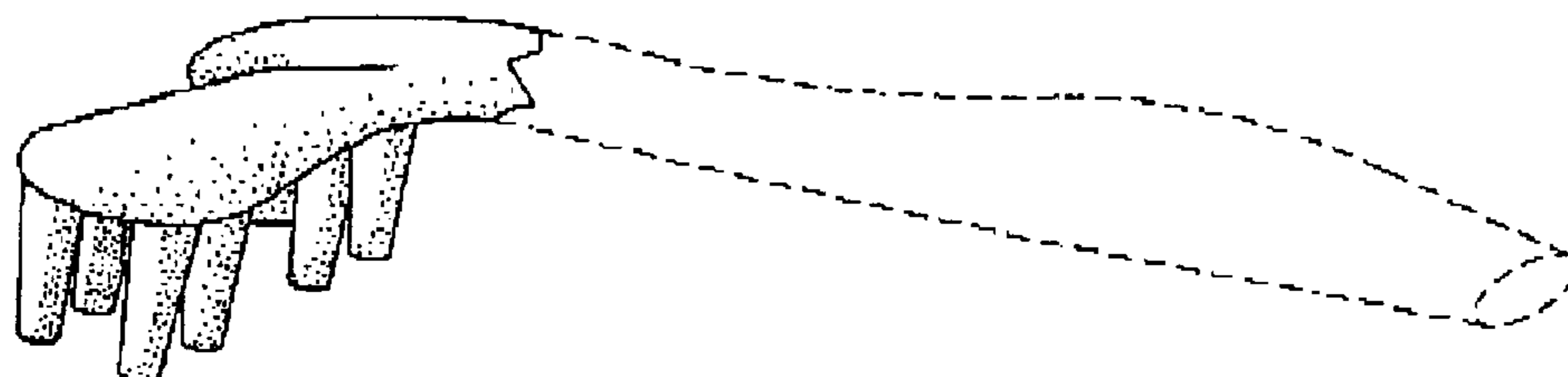

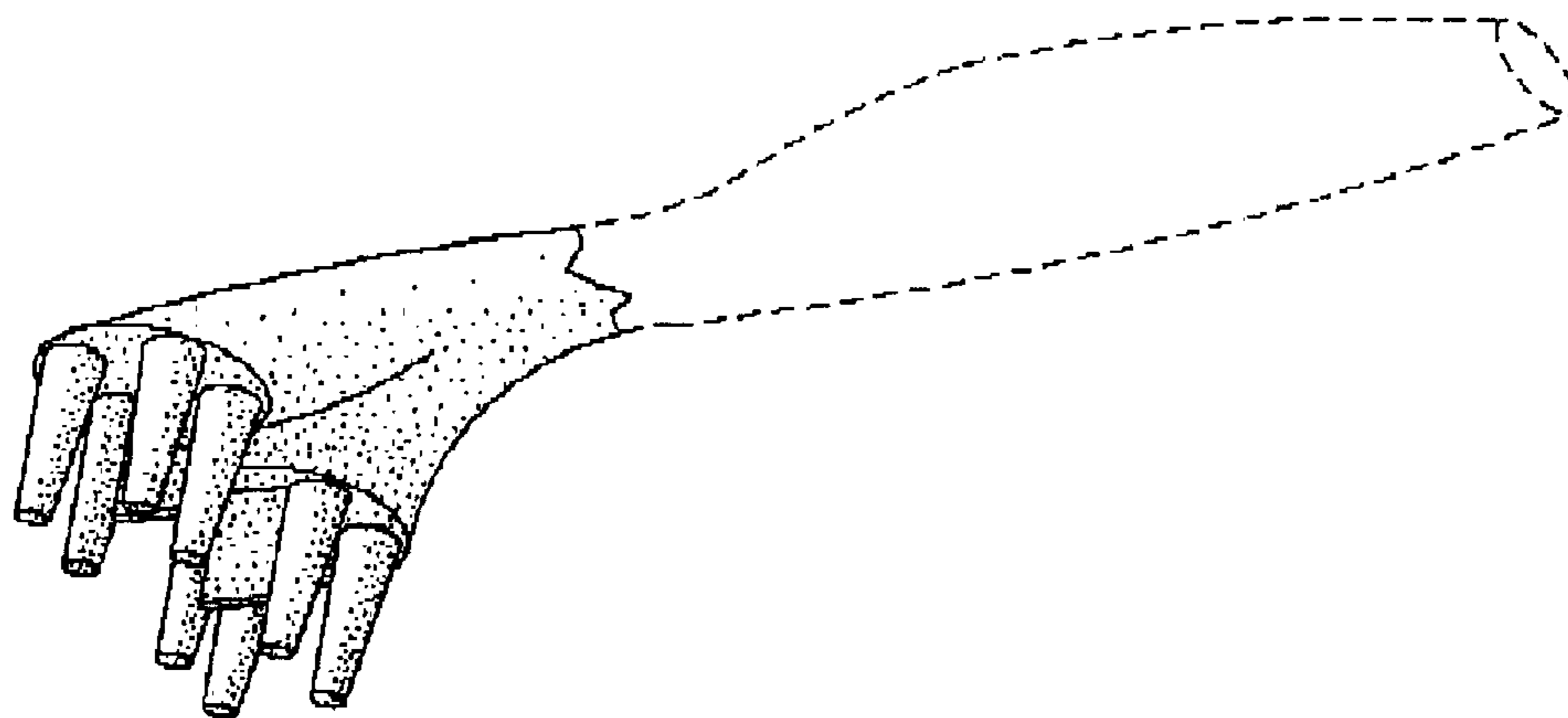

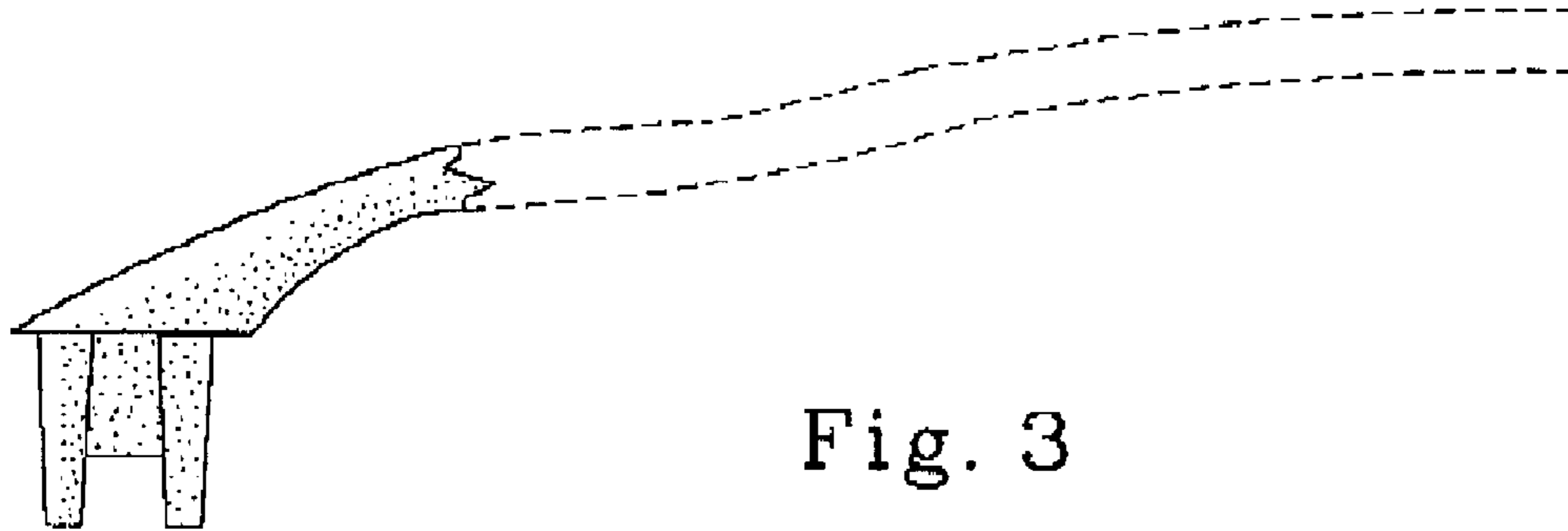

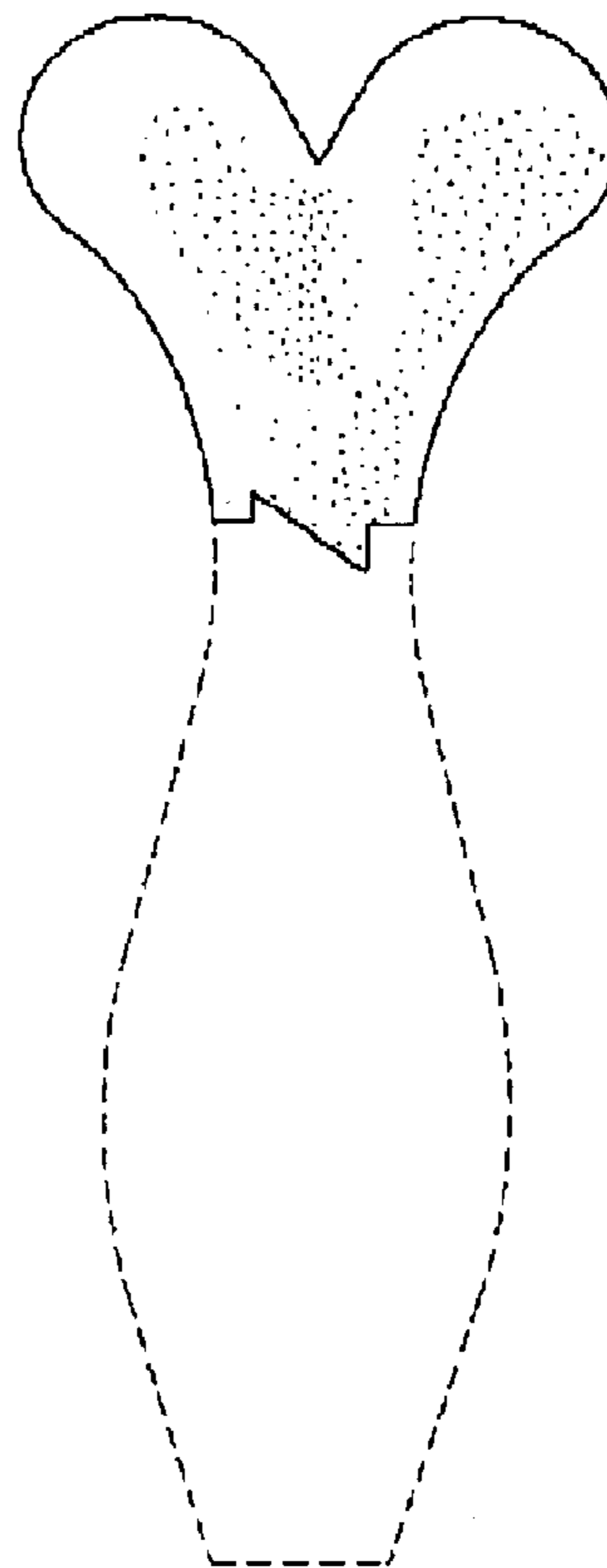

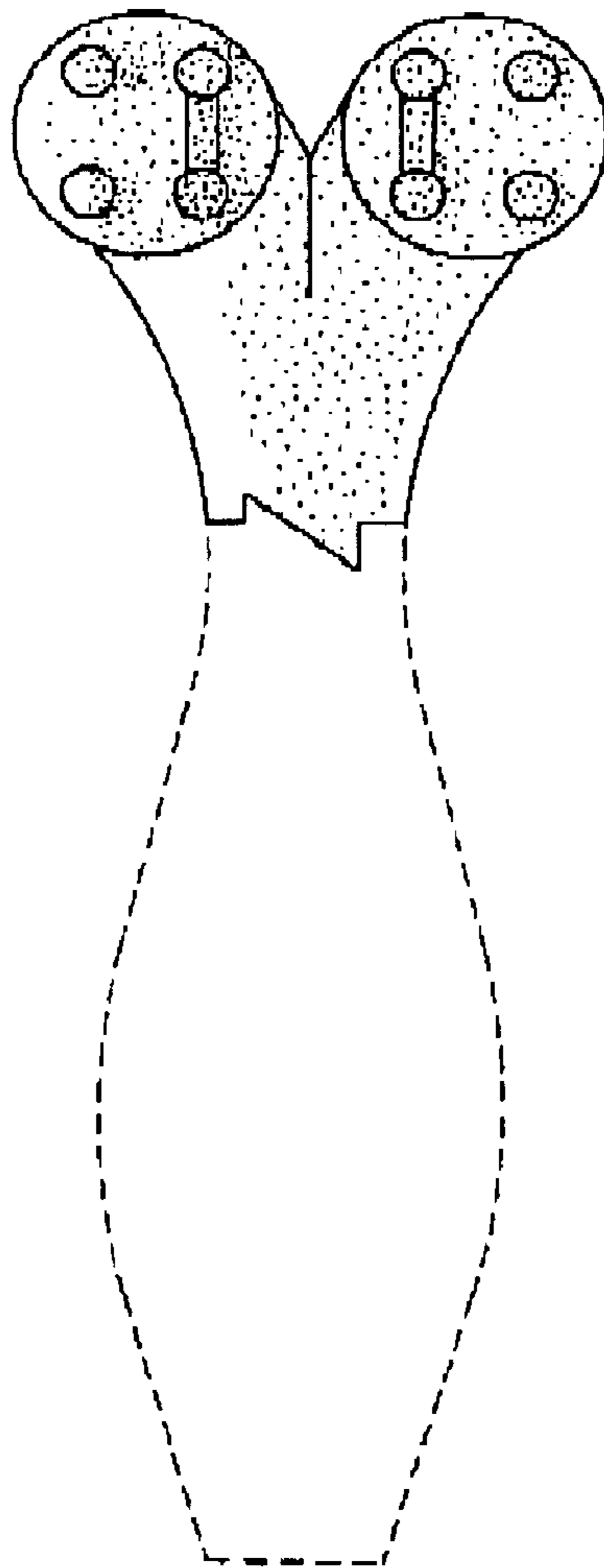

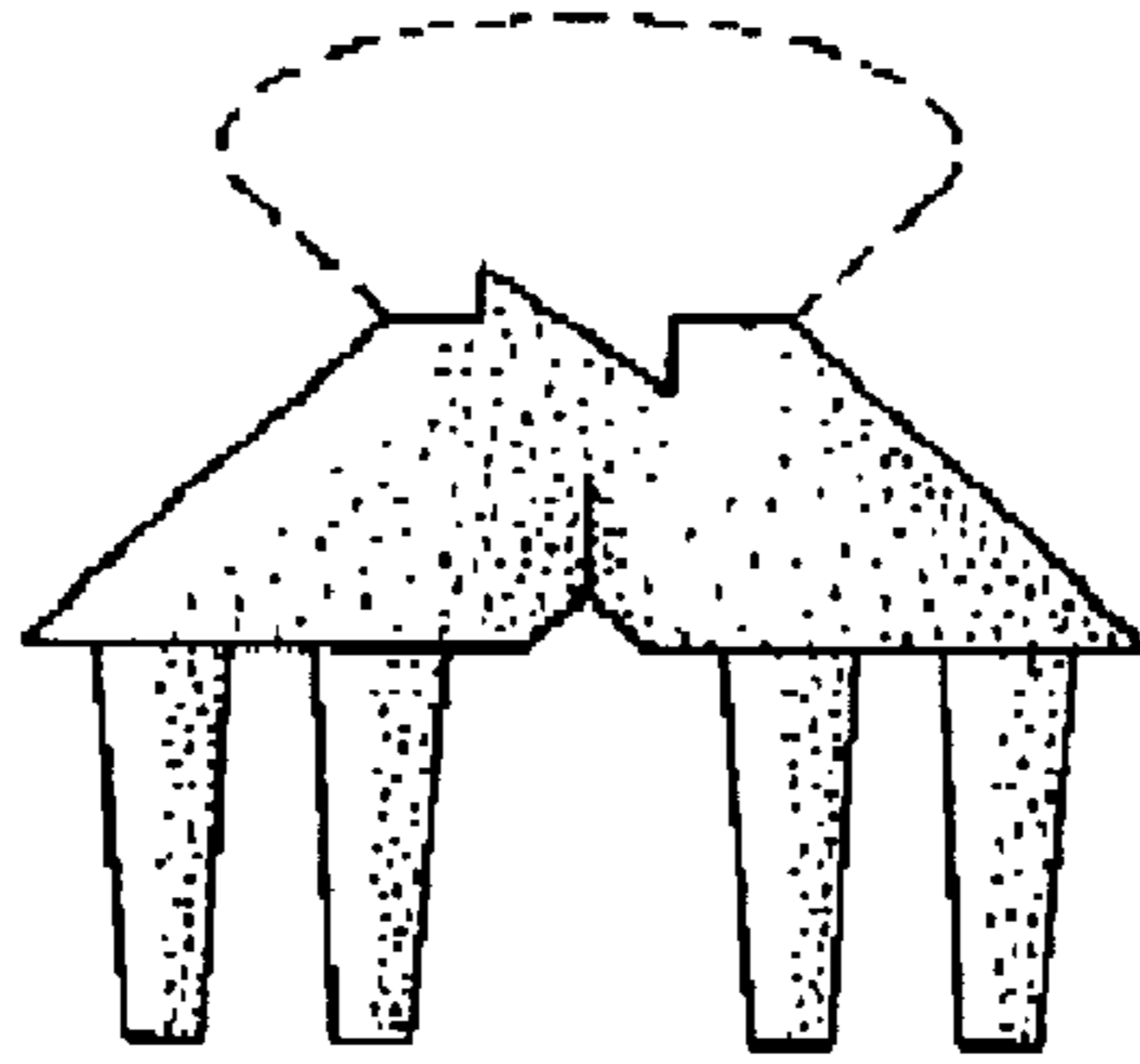

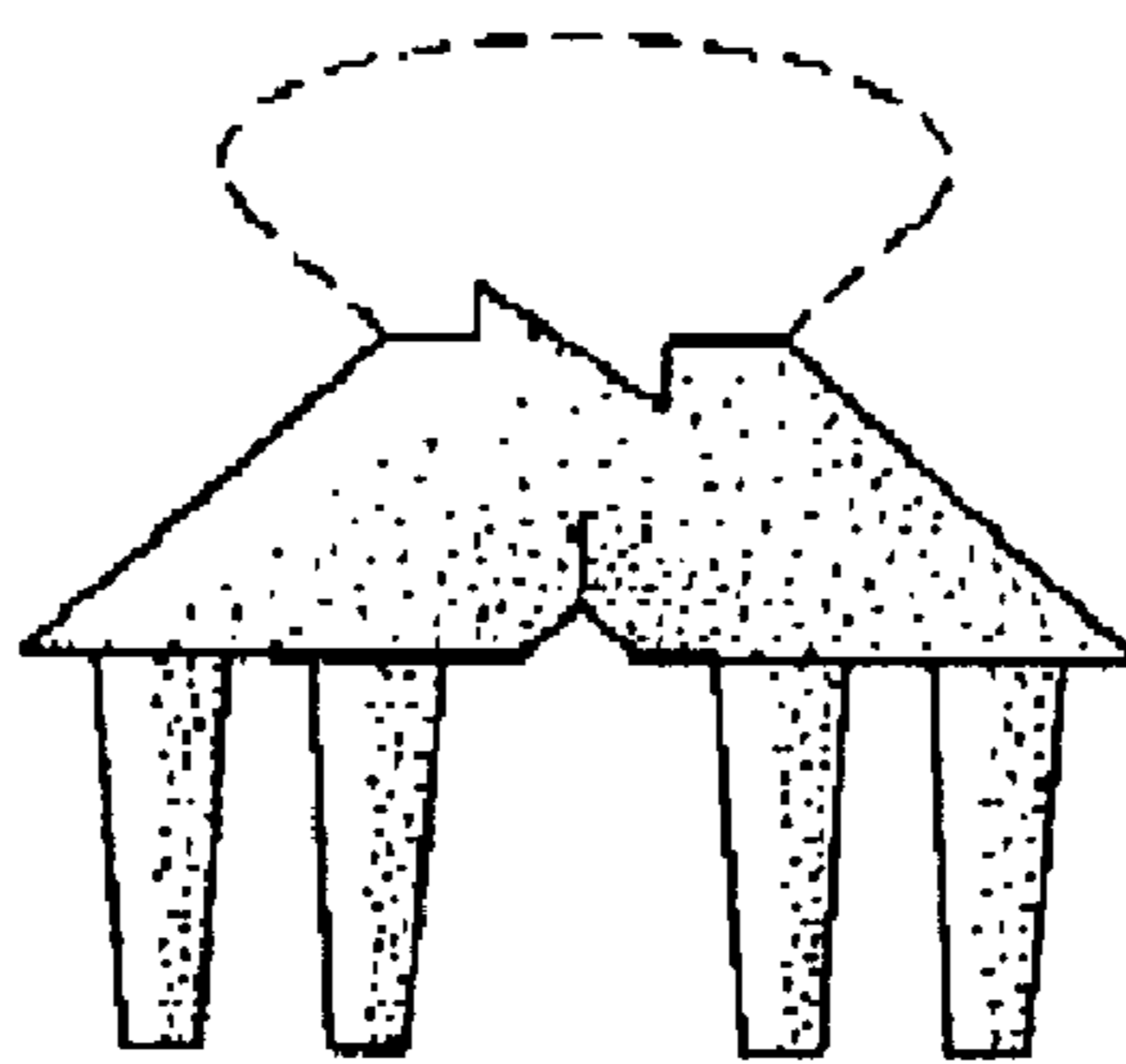
