(57) **CLAIM**

The ornamental design for a square funnel top container, as
shown and described.

DESCRIPTION

FIG. 1 is a top frontal perspective view of a square funnel
top container according to my new design;
FIG. 2 is a front view of the square funnel top container
shown in FIG. 1;
FIG. 3 is a back view of the square funnel top container
shown in FIG. 1;
FIG. 4 is a left side view of the square funnel top container
shown in FIG. 1;
FIG. 5 is a right side view of the square funnel top container
shown in FIG. 1;
FIG. 6 is a top view of the square funnel top container shown
in FIG. 1; and,
FIG. 7 is a bottom view of the square funnel top container
shown in FIG. 1.

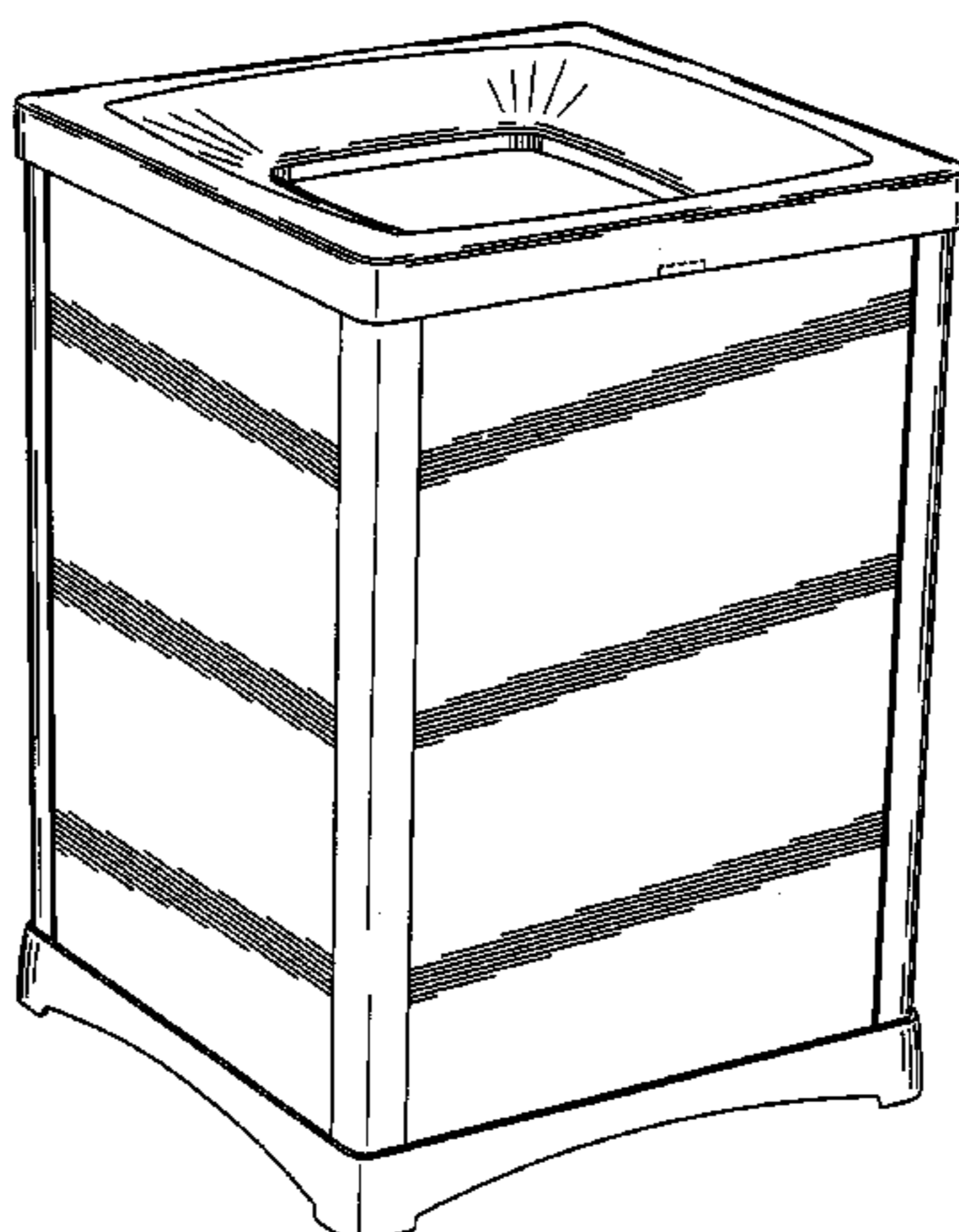

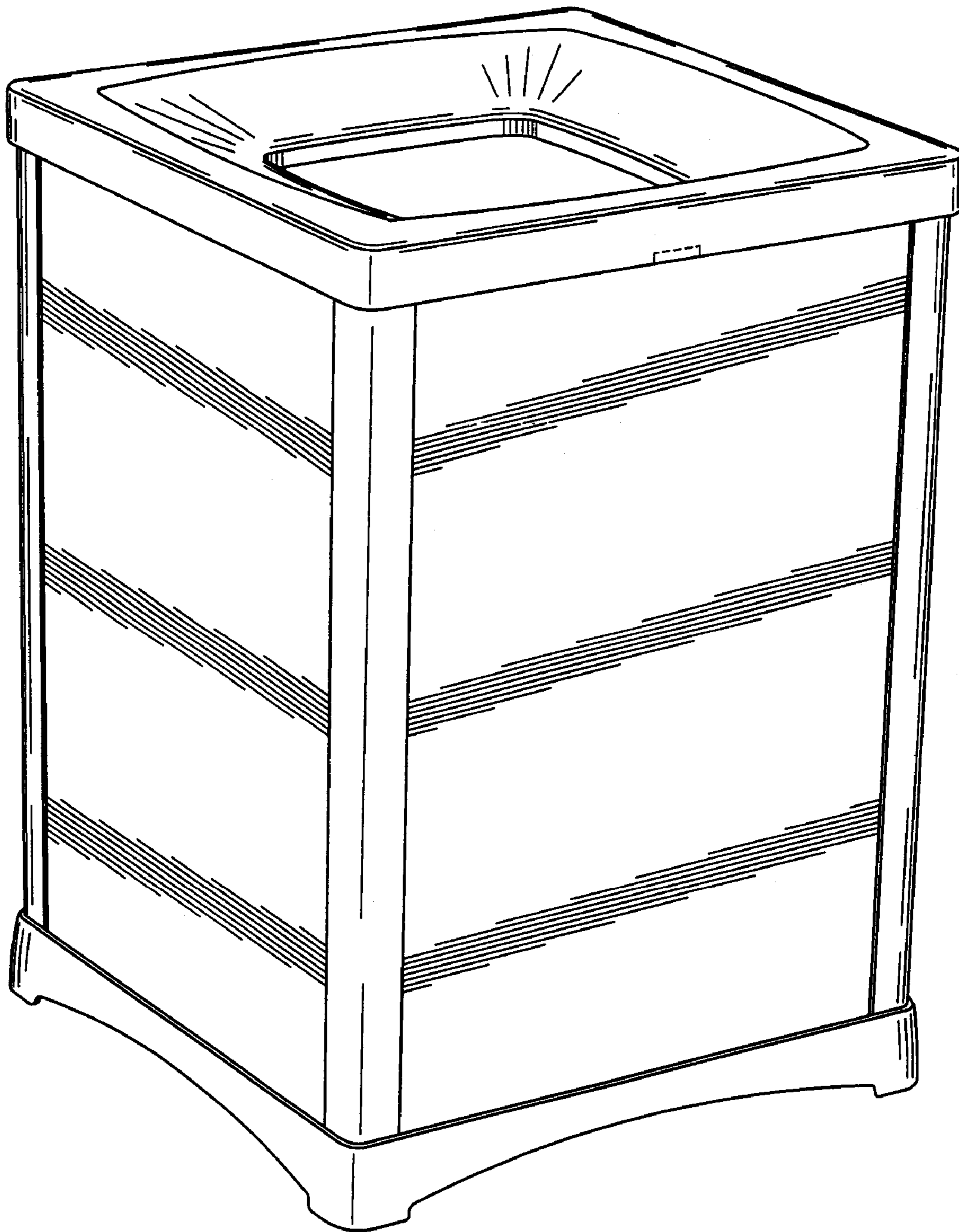

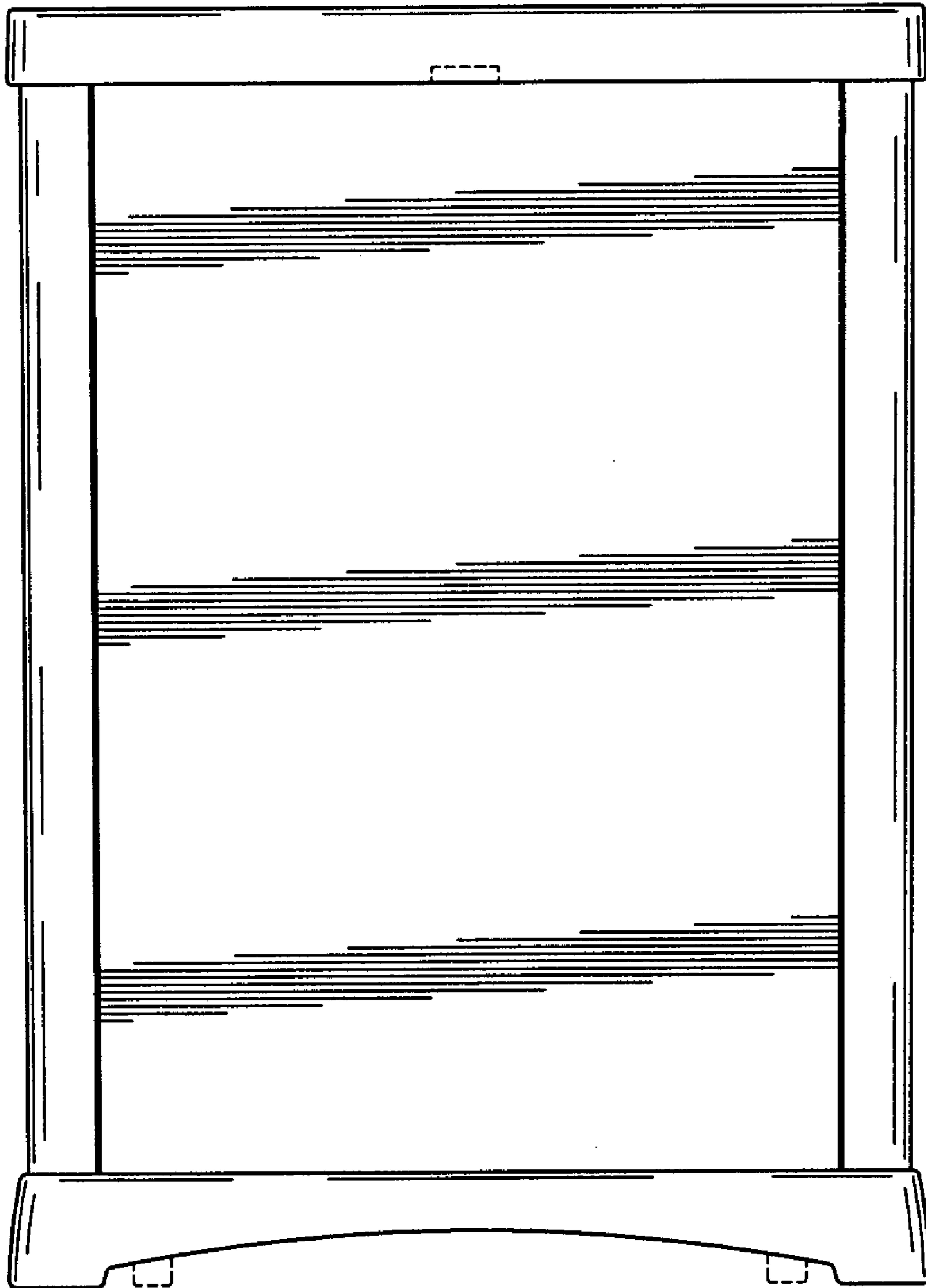

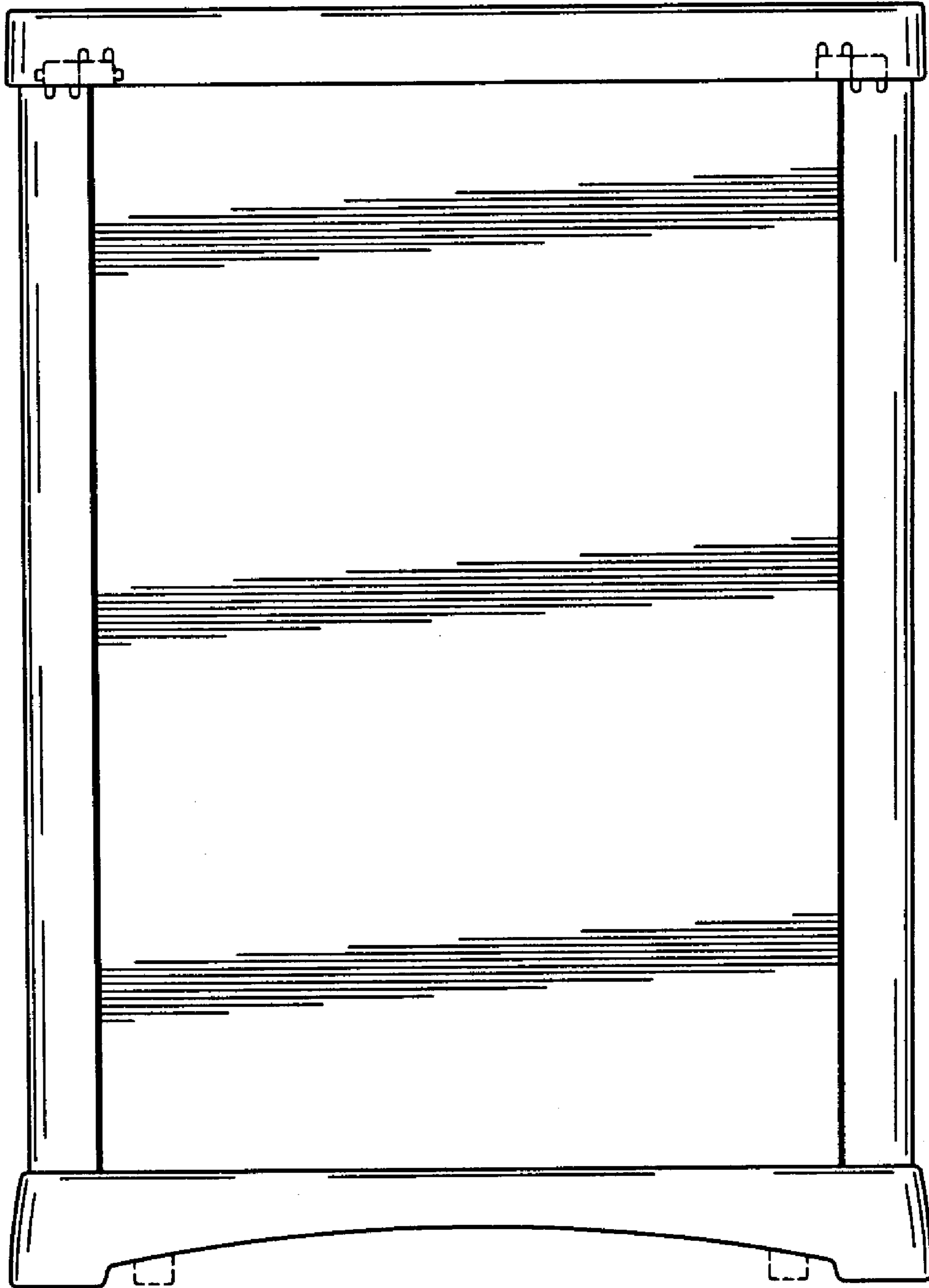

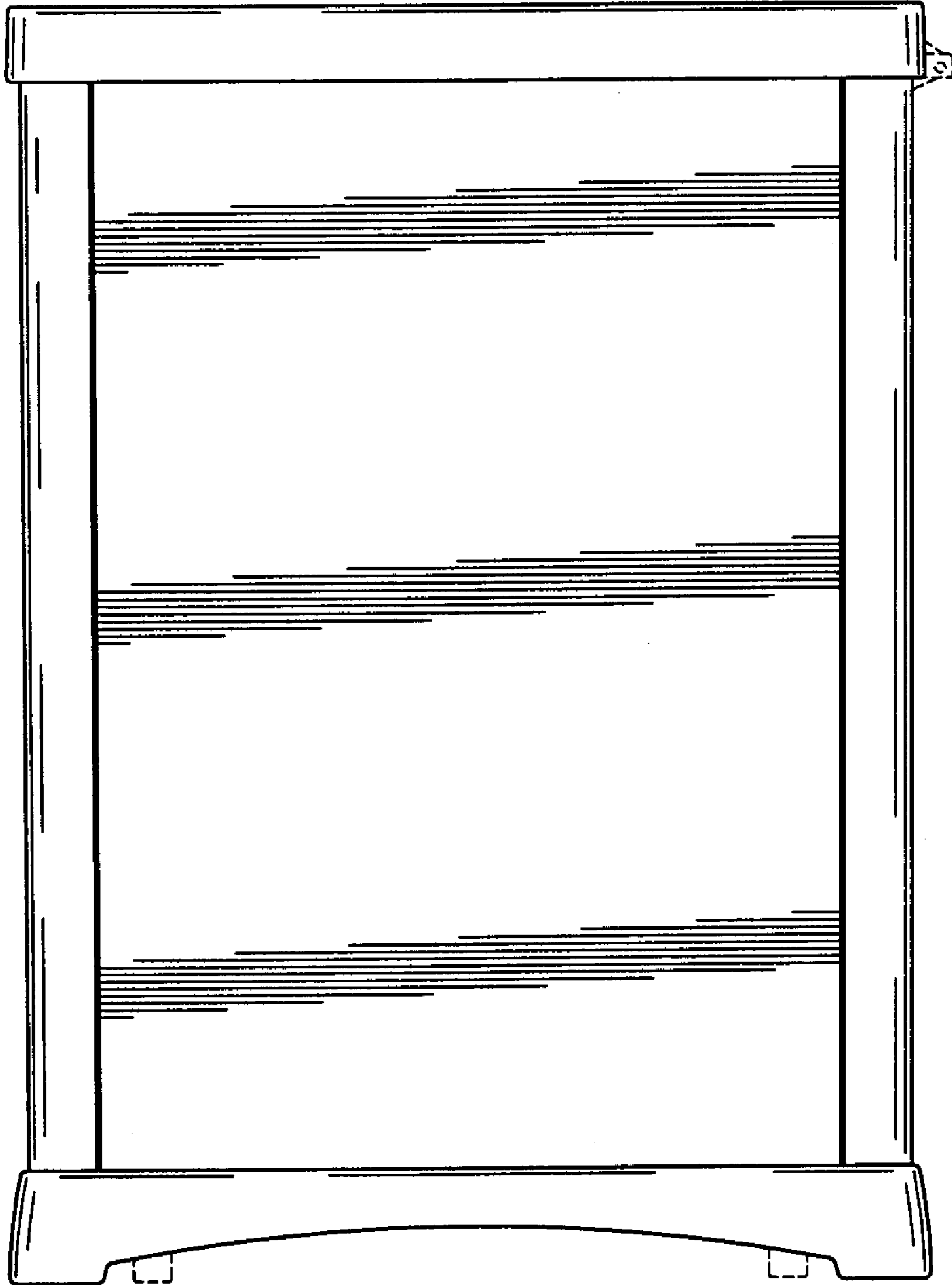

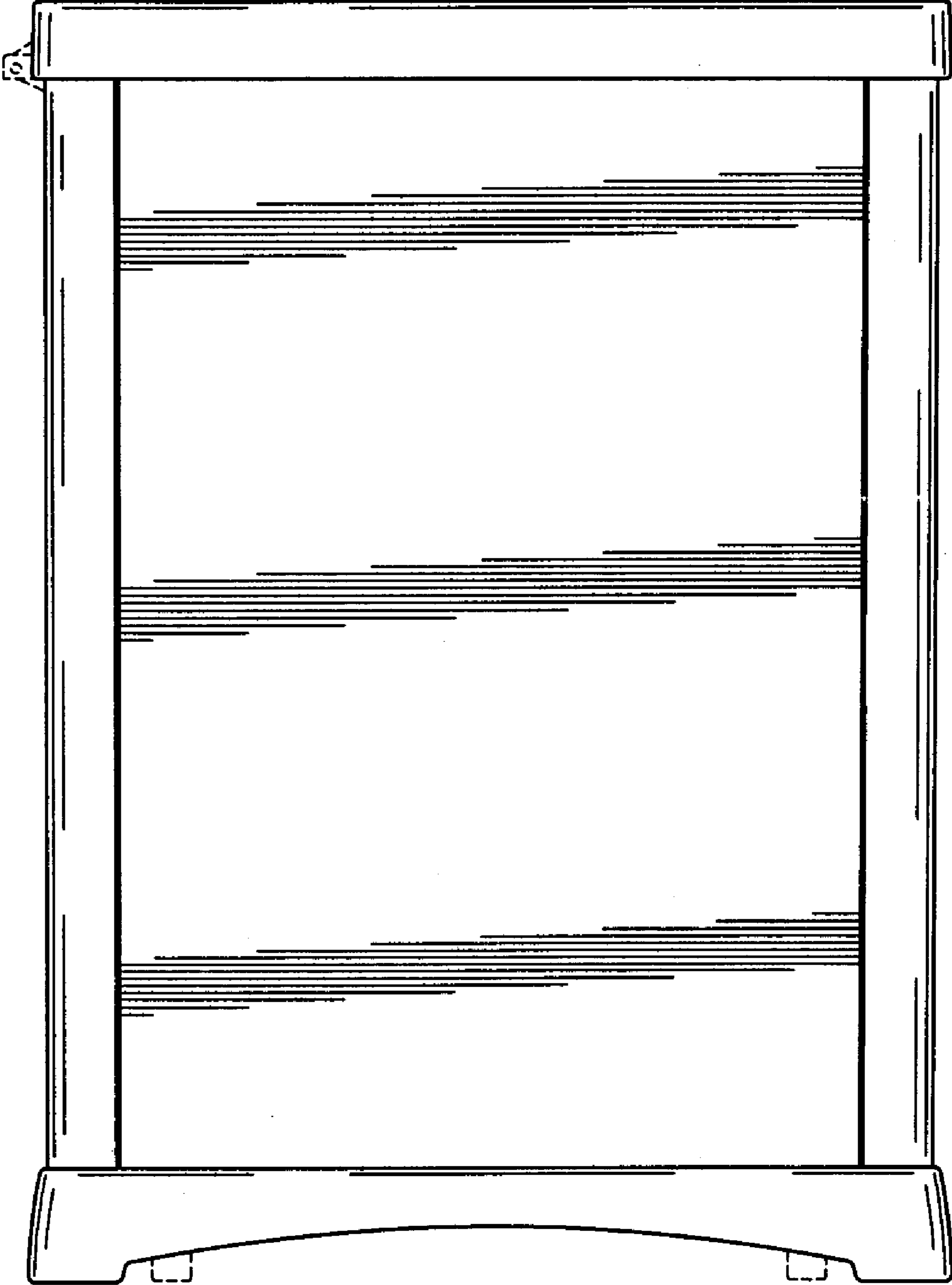

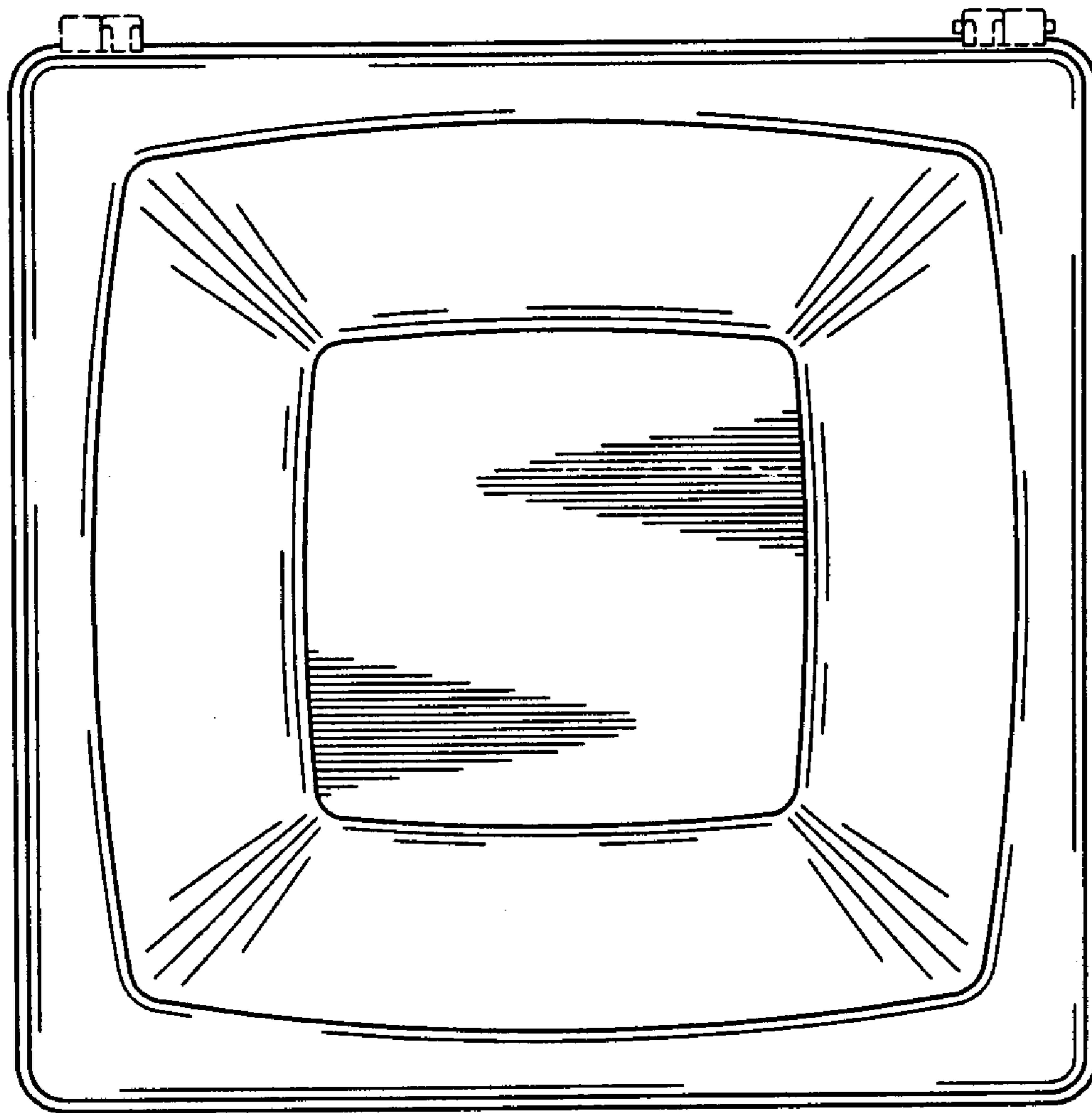
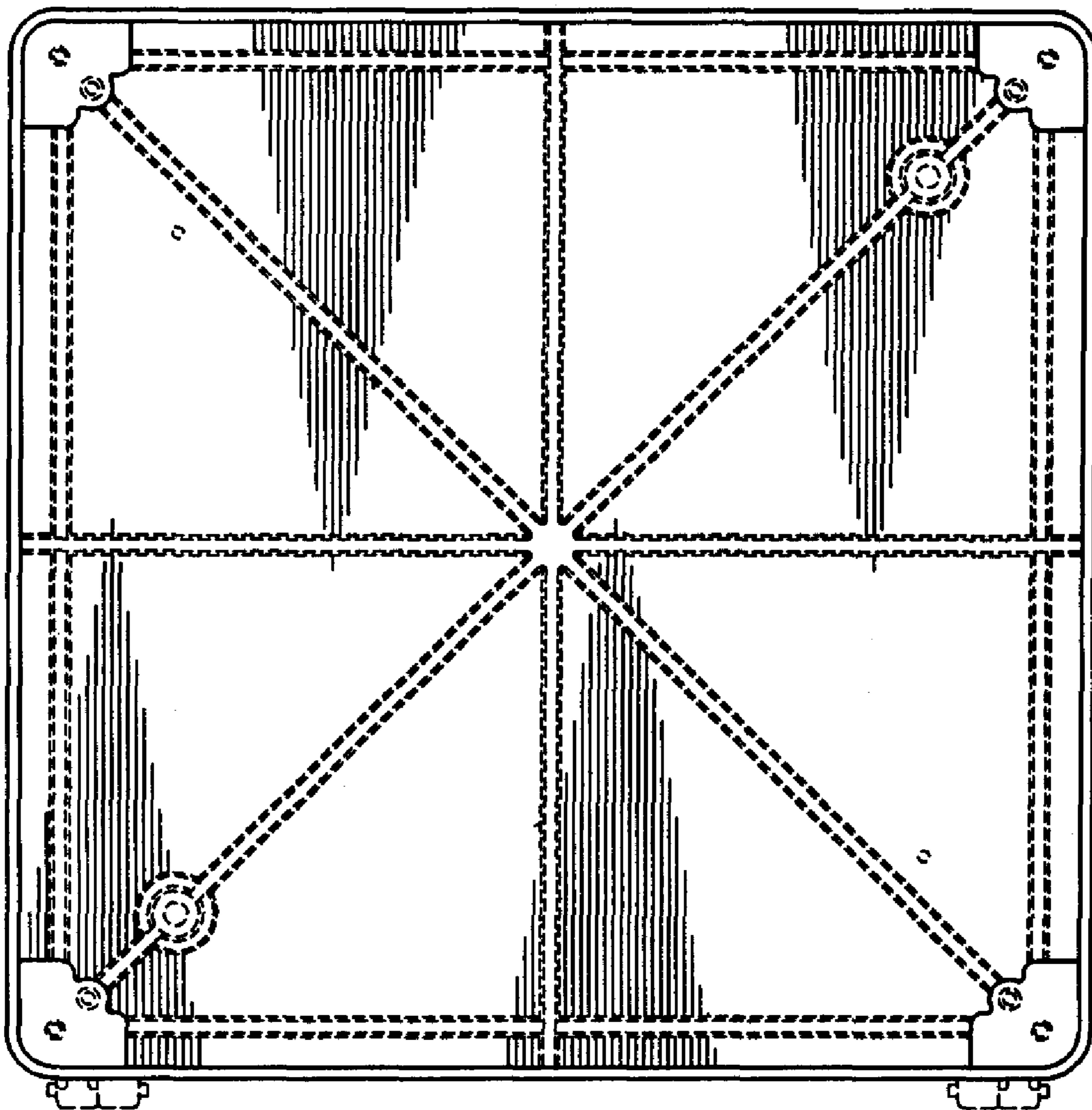
