FIG. 6 is a perspective view of a second embodiment of a lighted mirror, showing our new design;

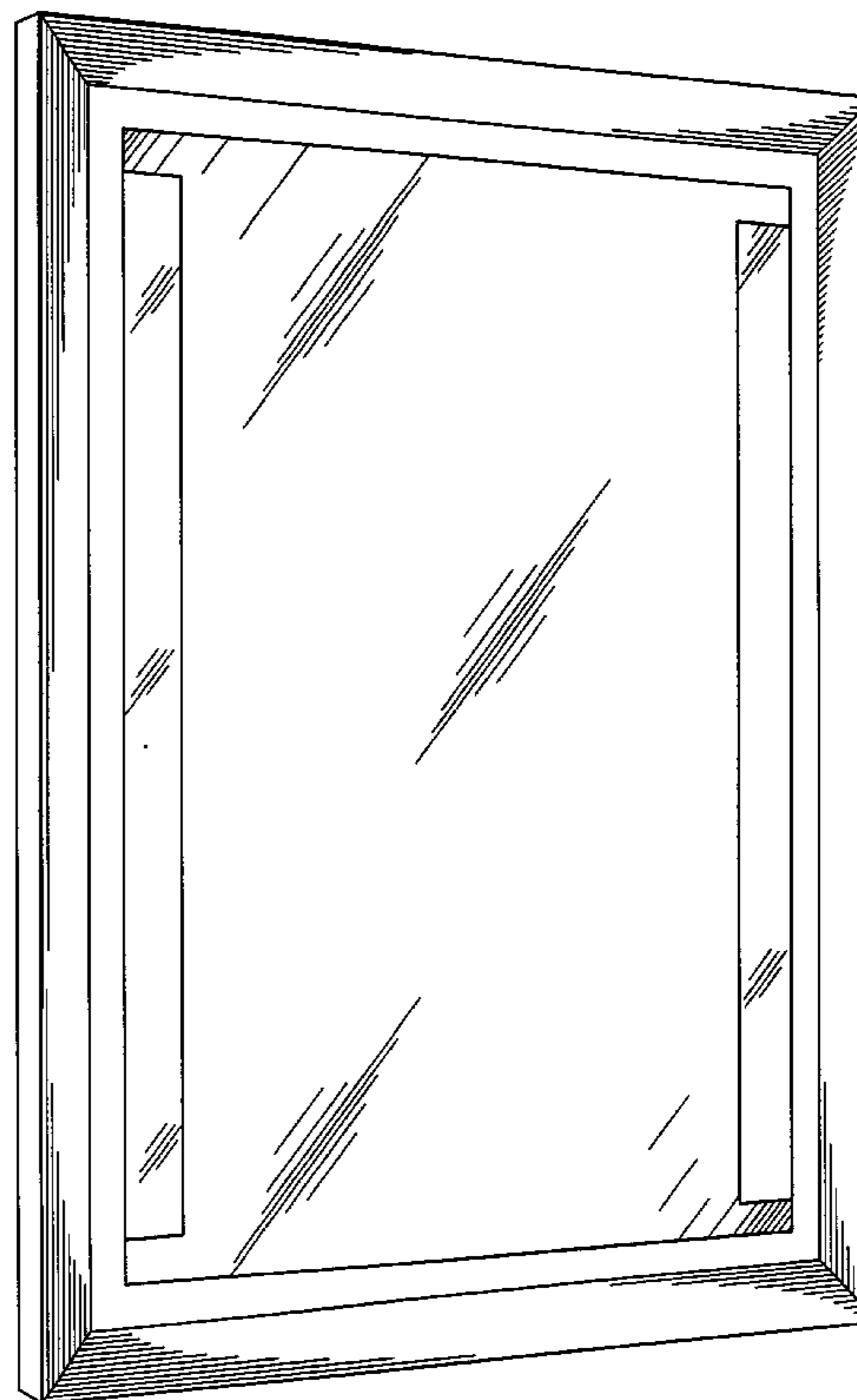
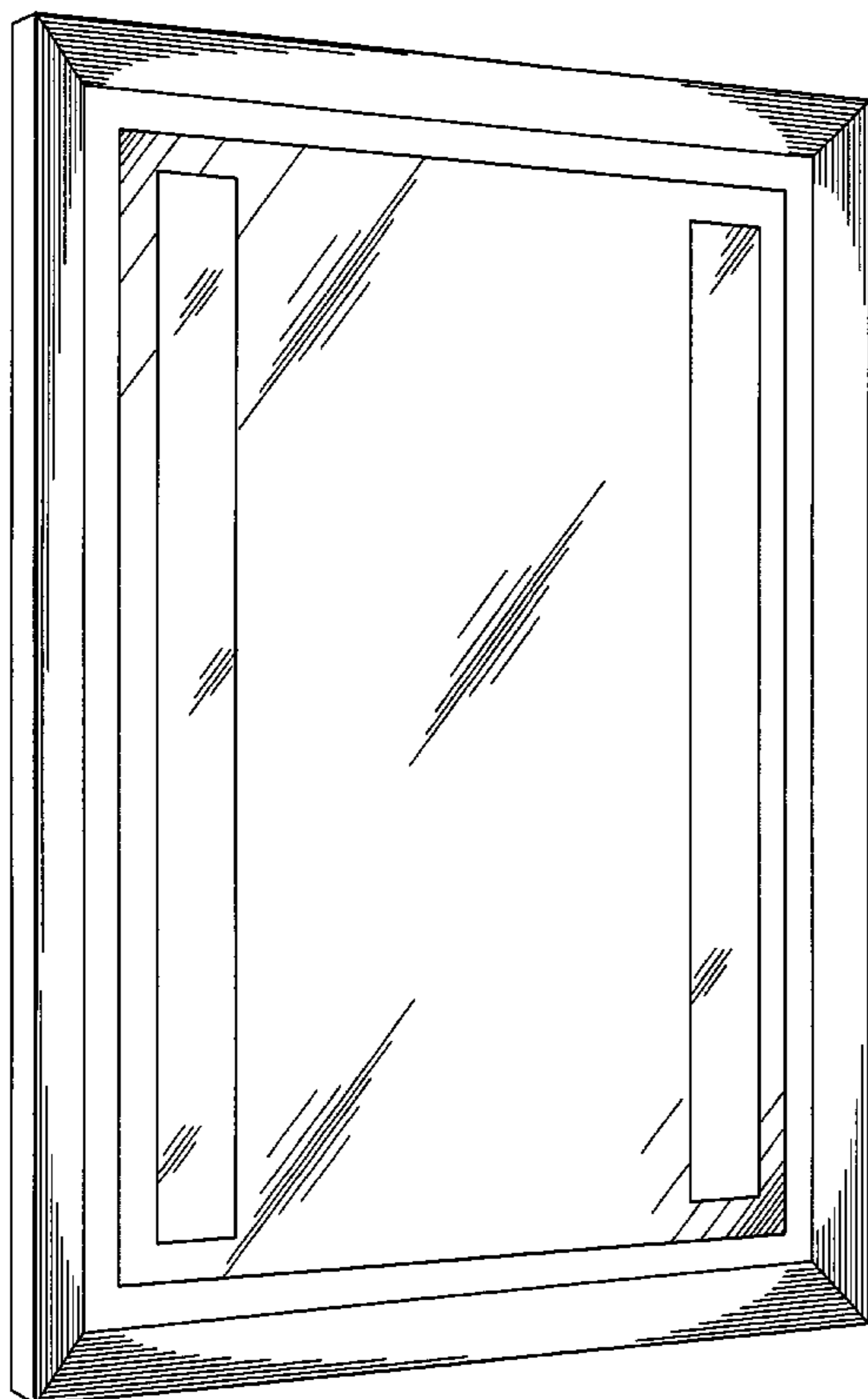
FIG. 7 is a front view thereof;

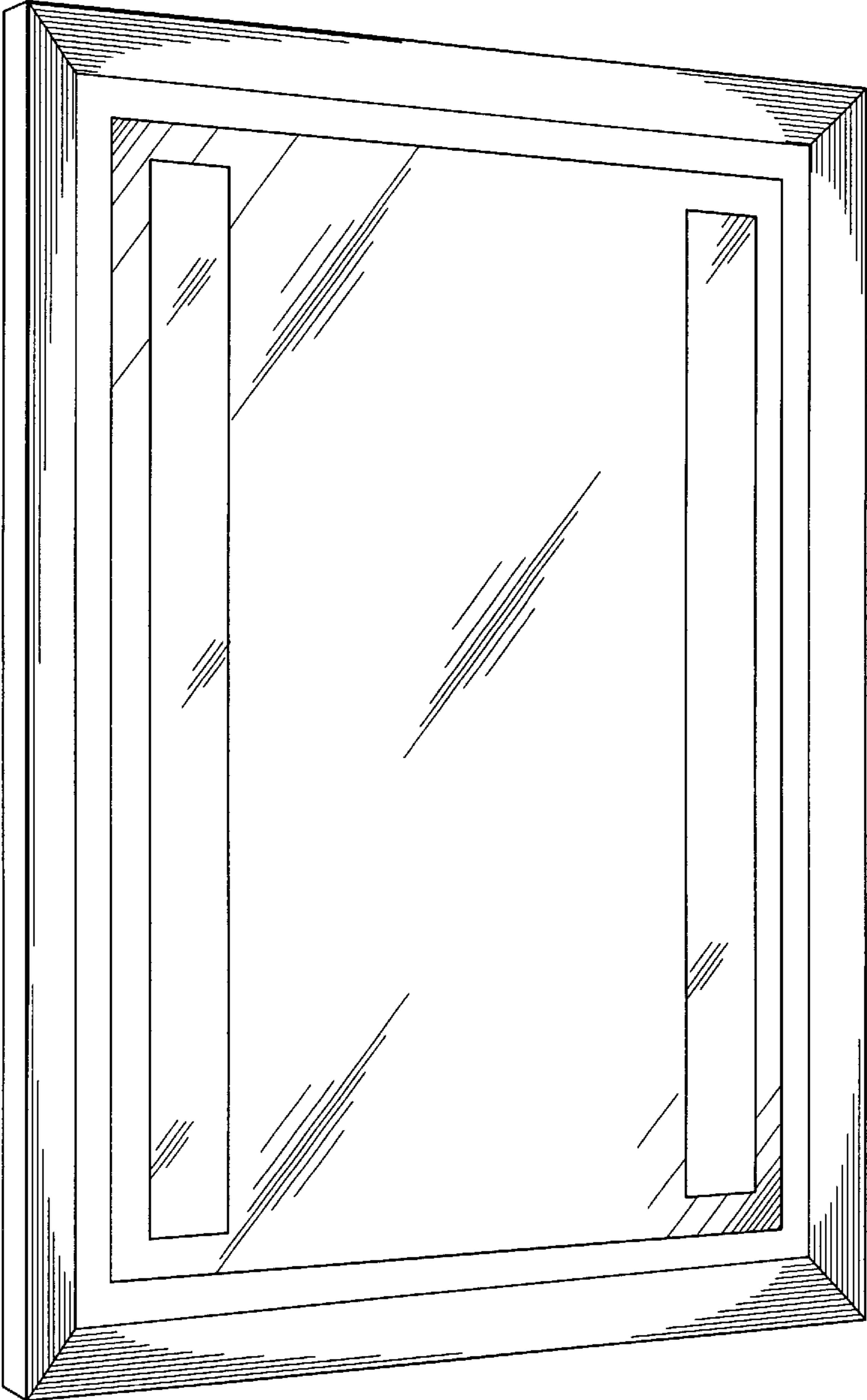
FIG. 8 is a left side view and a right side view thereof;

FIG. 9 is a top view and a bottom view thereof; and,

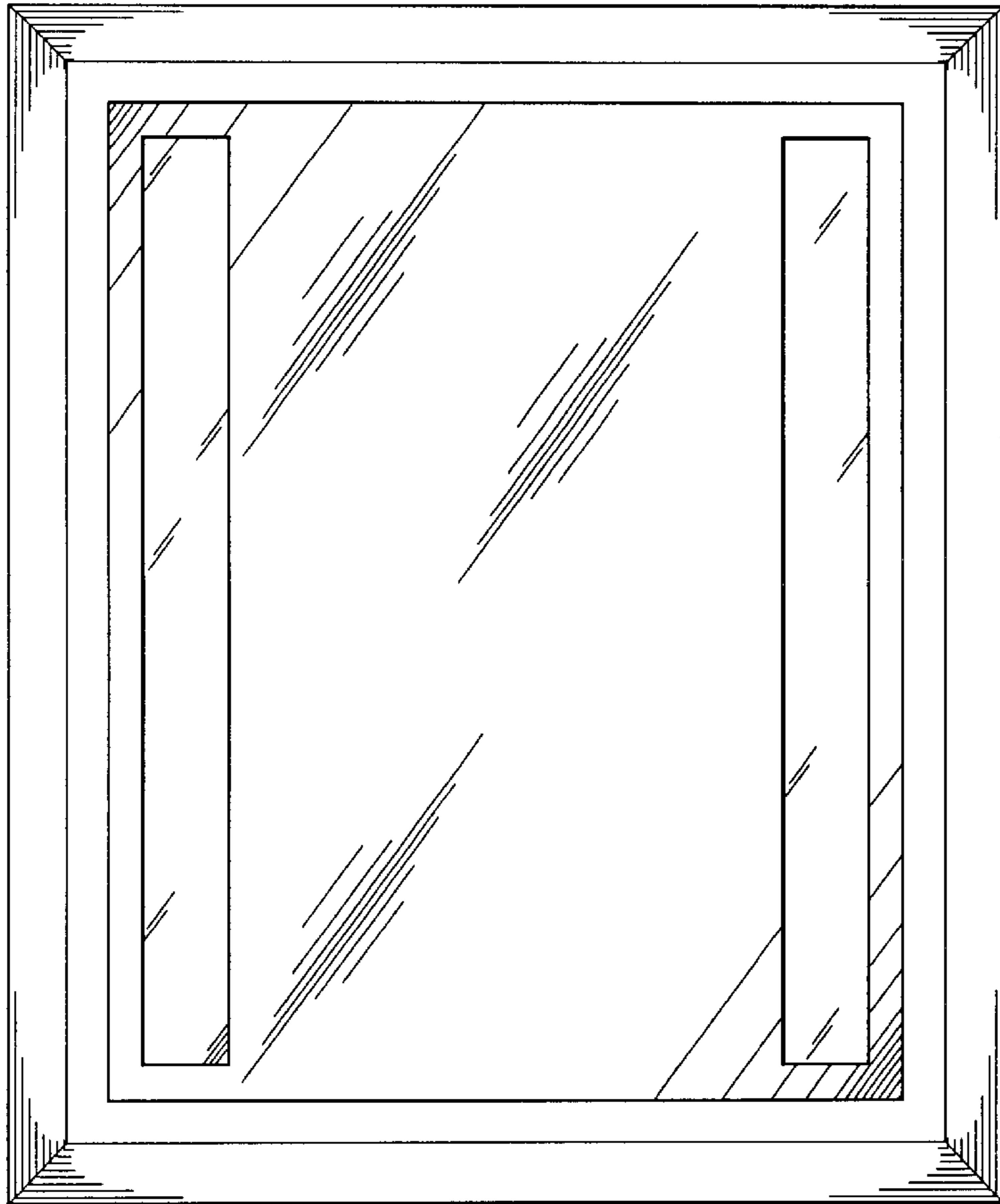
FIG. 10 is a back view thereof.

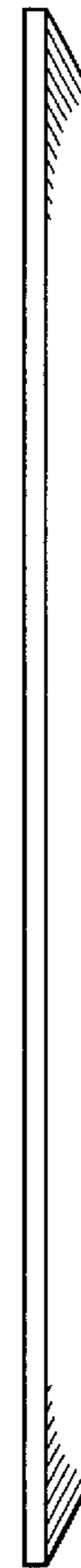




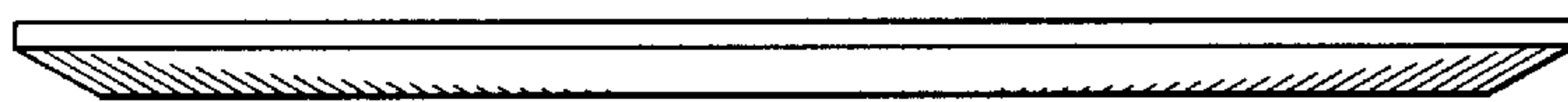

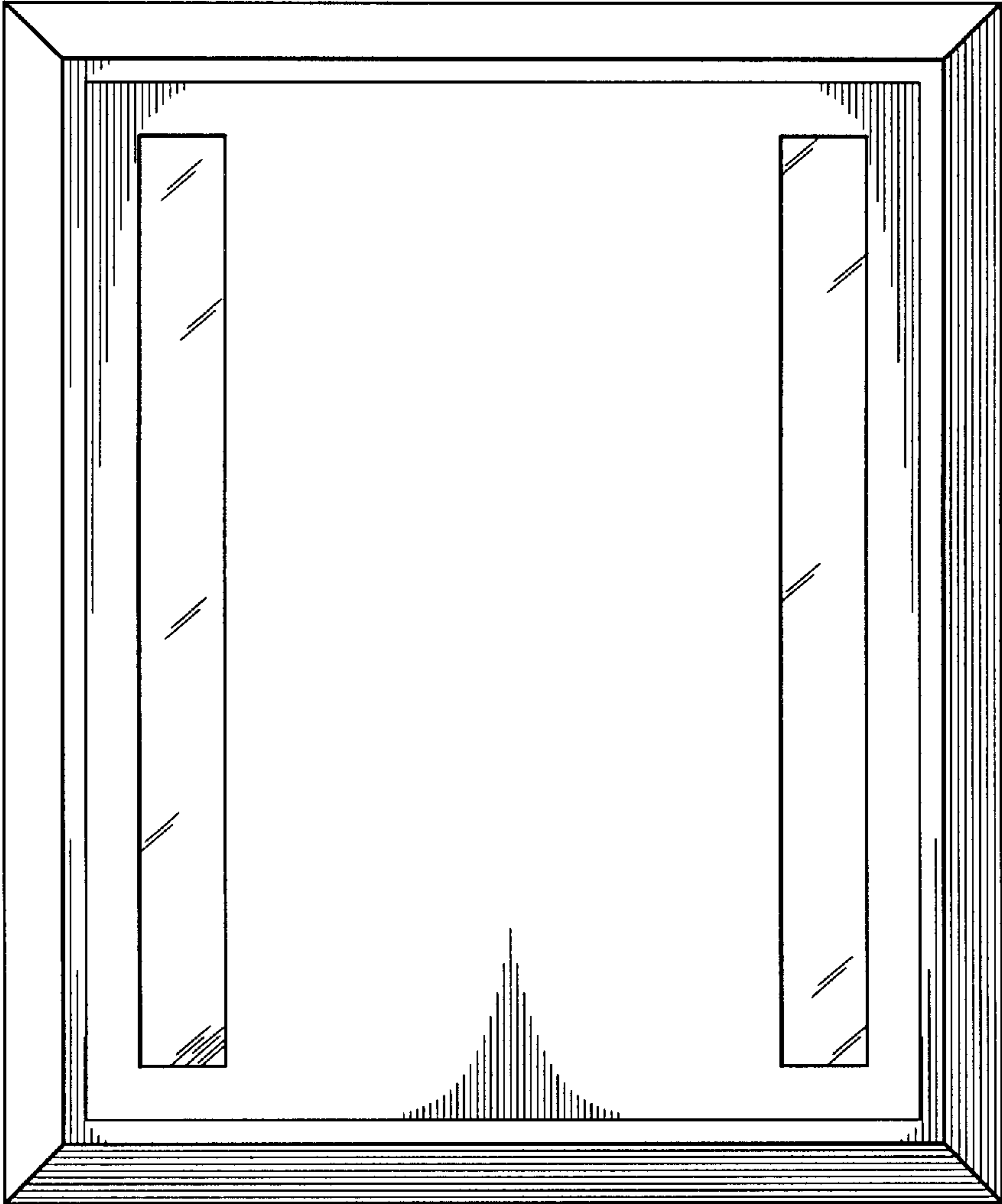

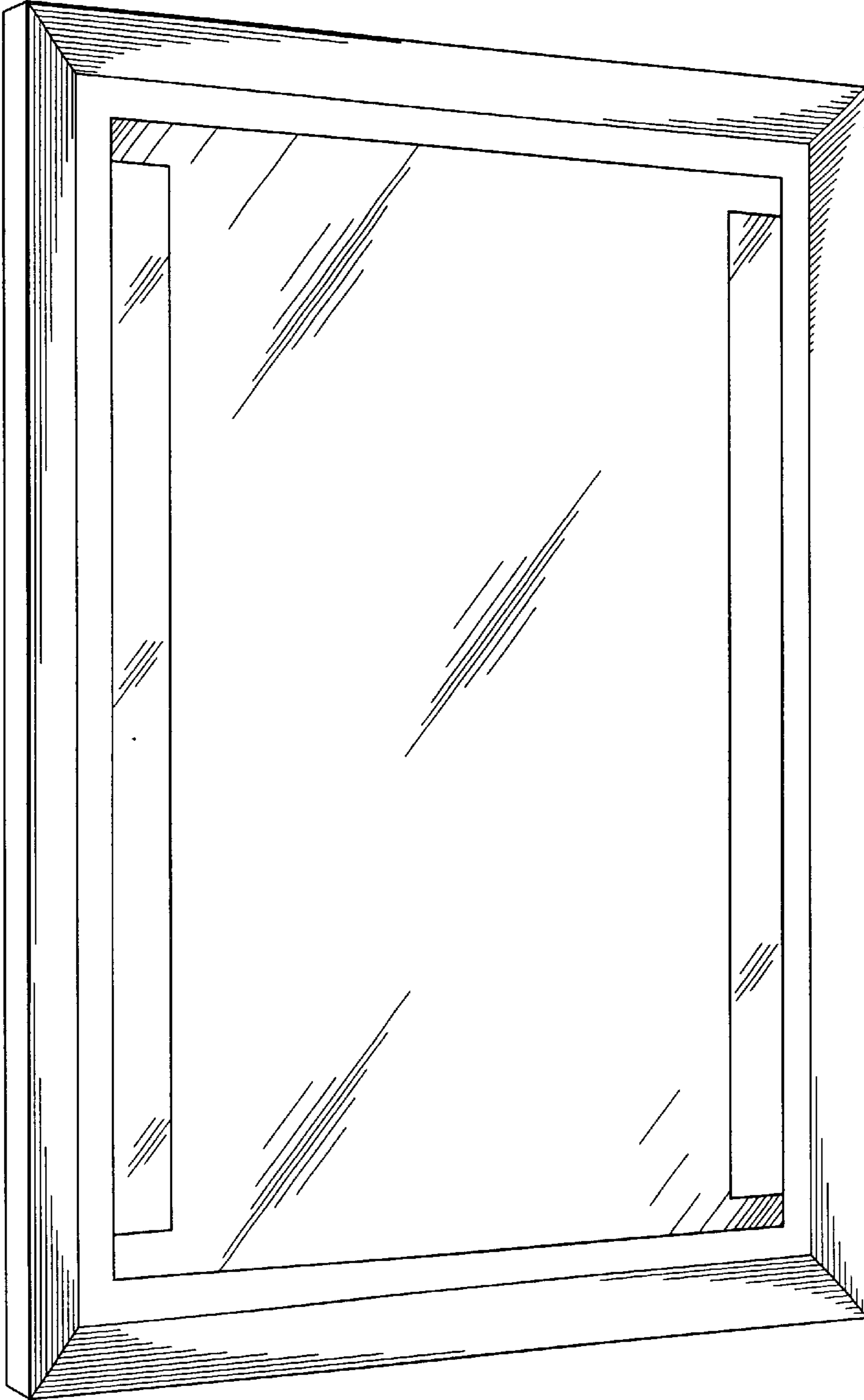

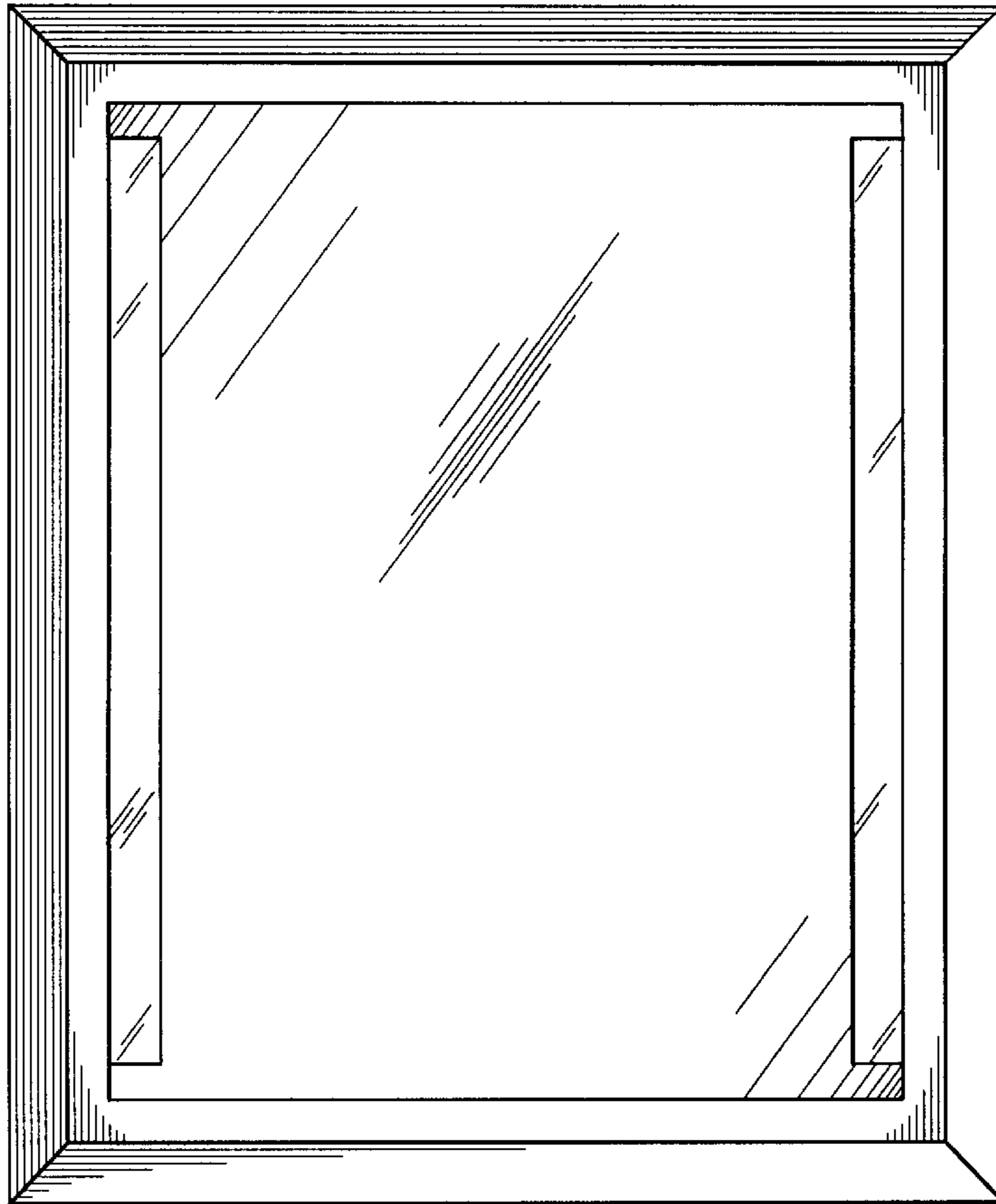

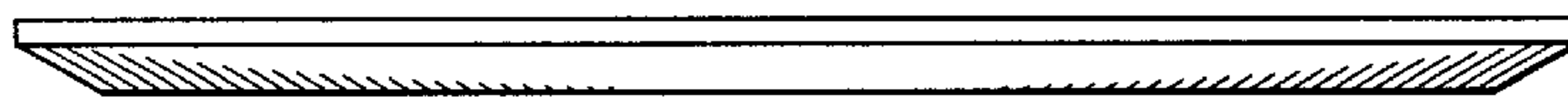

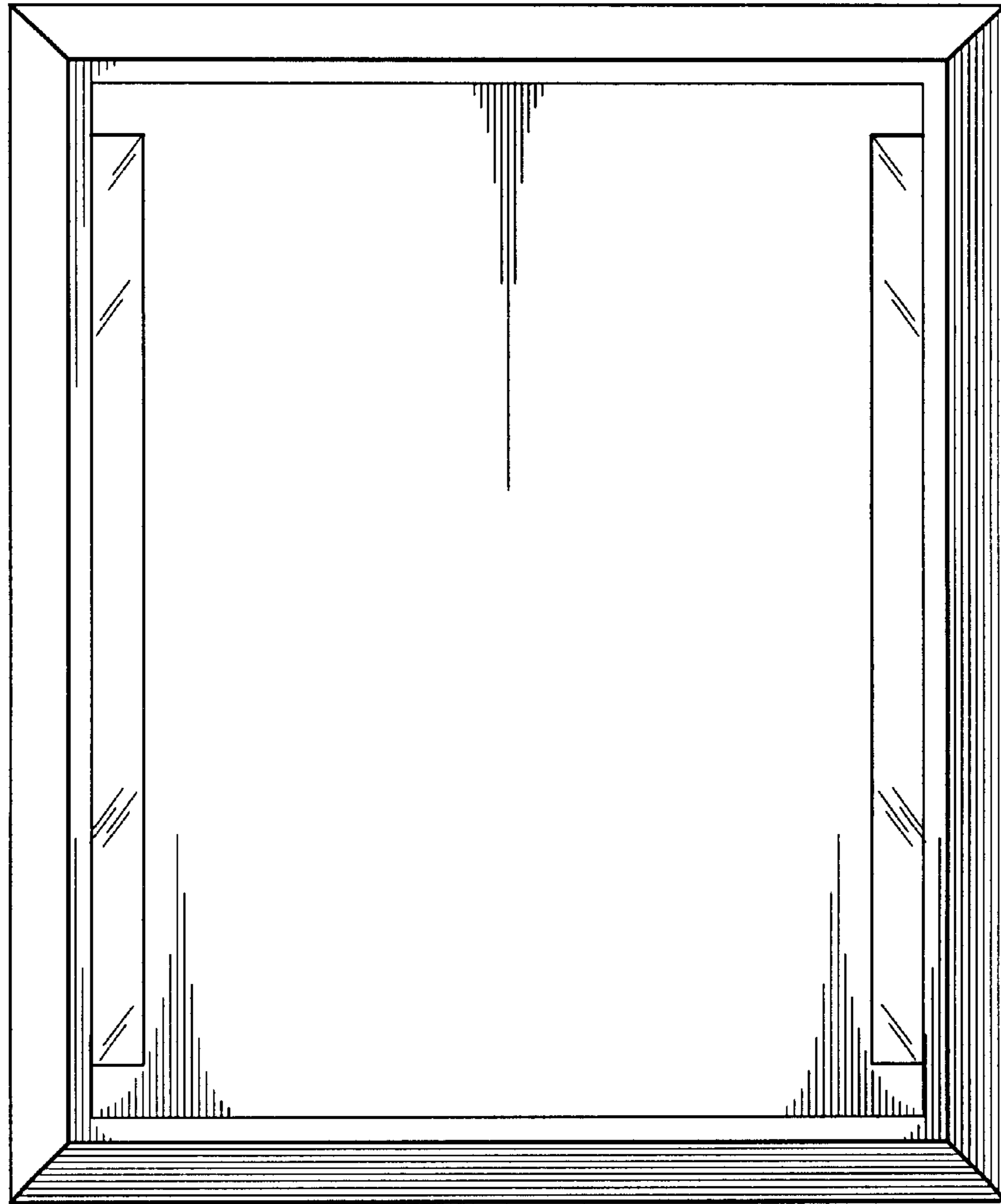
