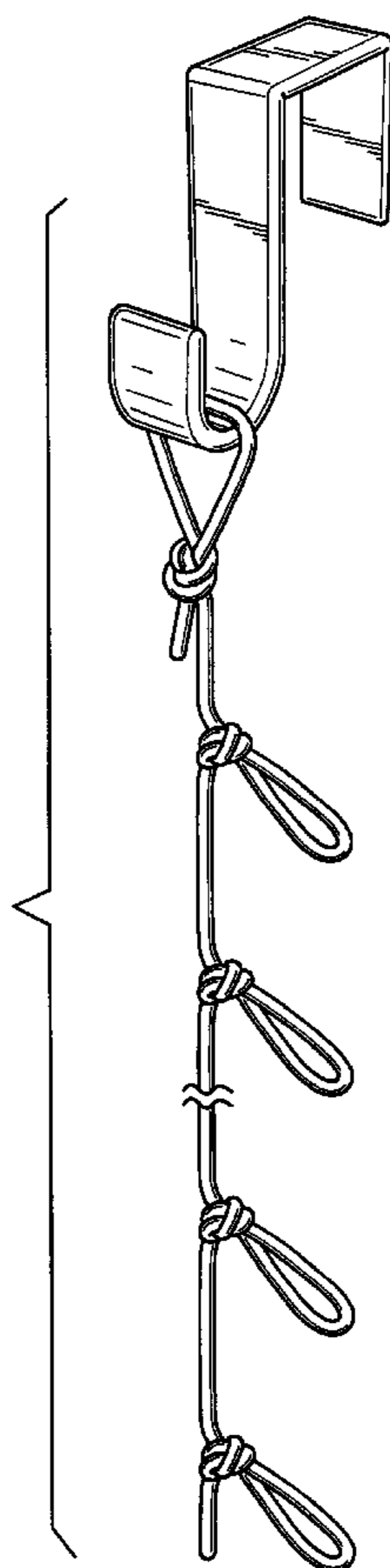

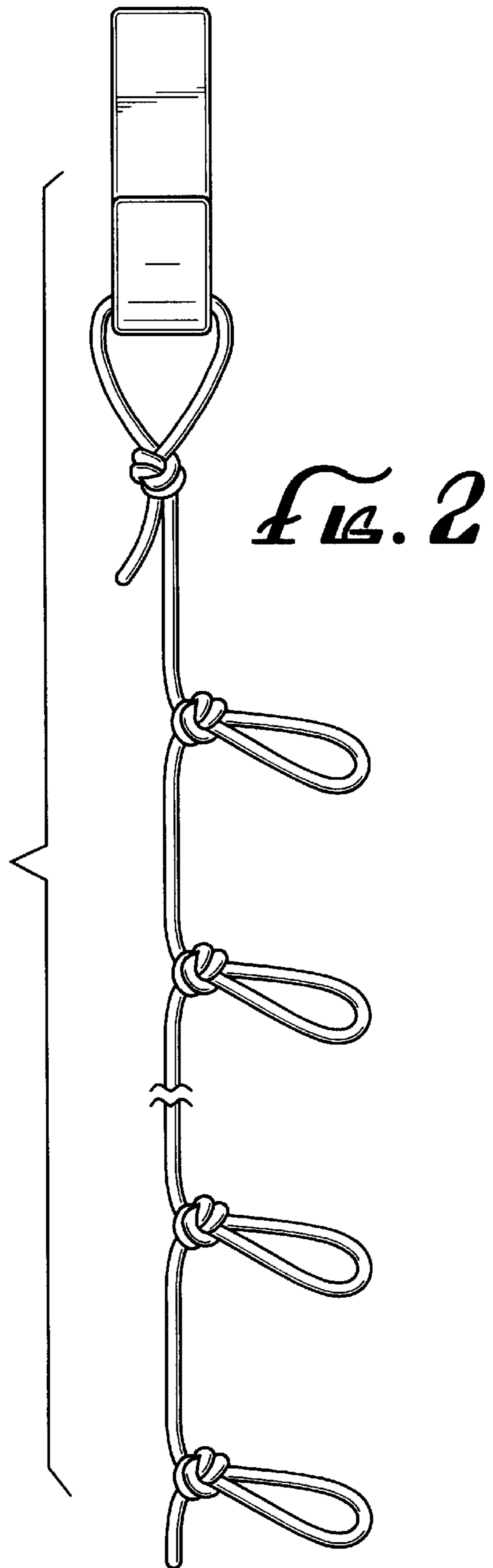
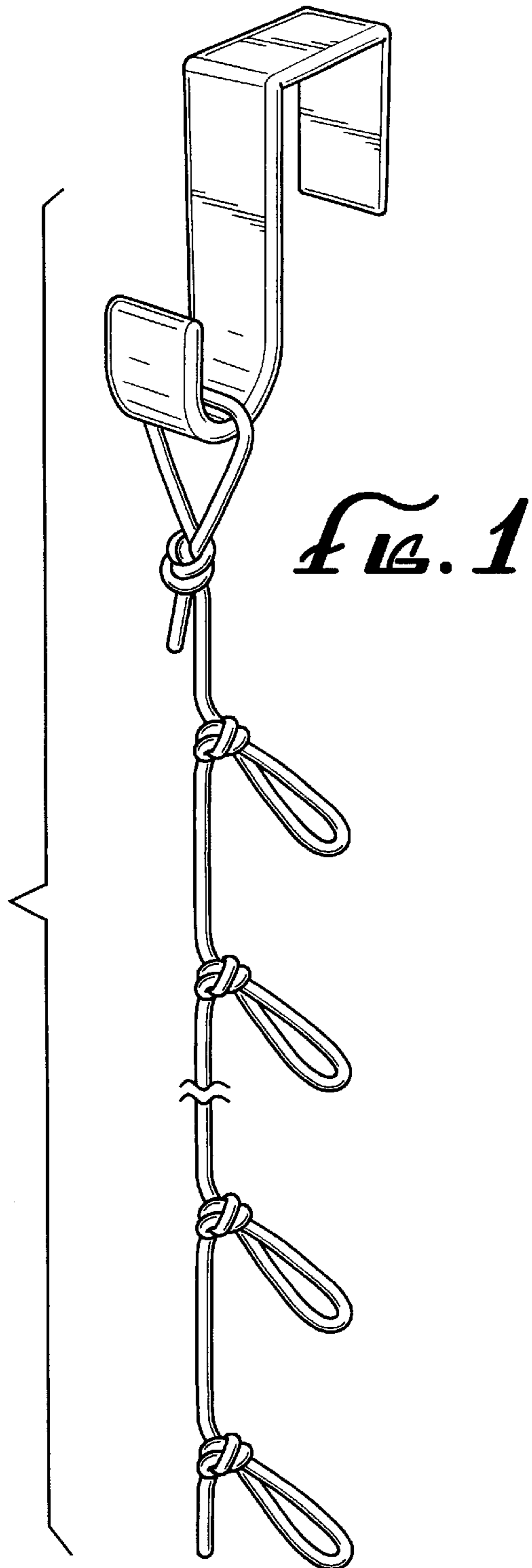
The ornamental design for a door clothes hanger, as shown and described.

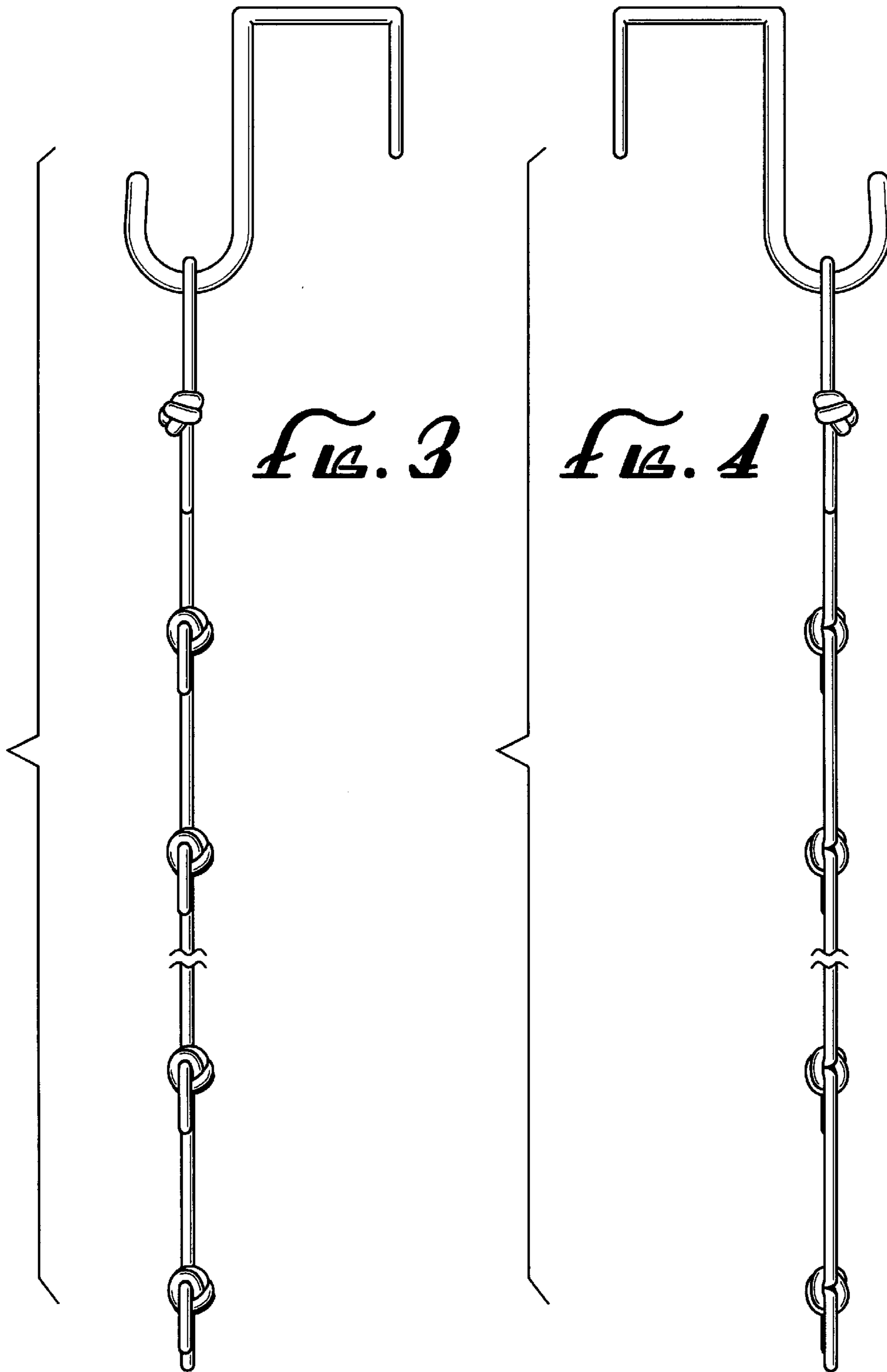
**DESCRIPTION**

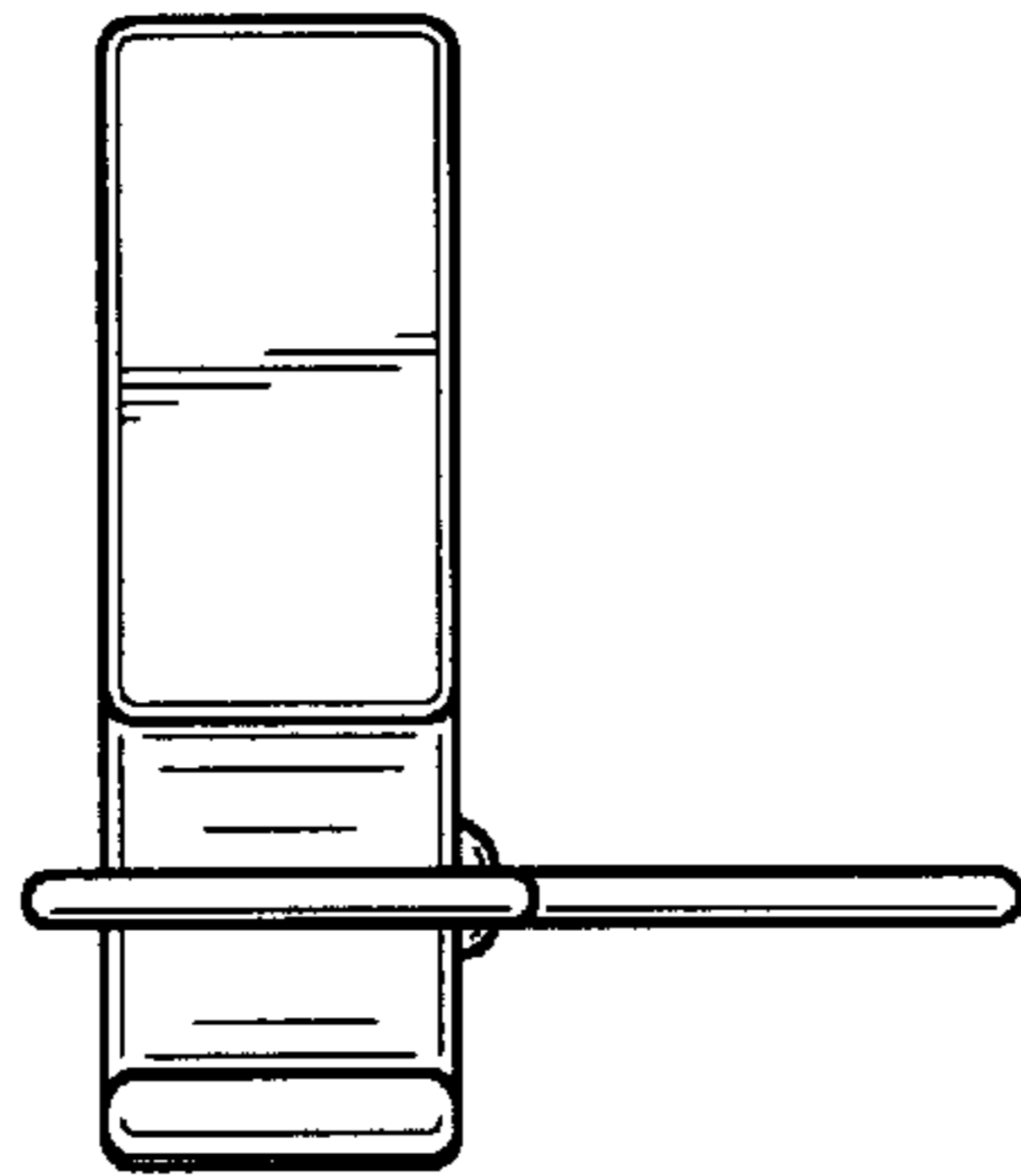
FIG. 1 is a front perspective view of a door clothes hanger, showing my new design;

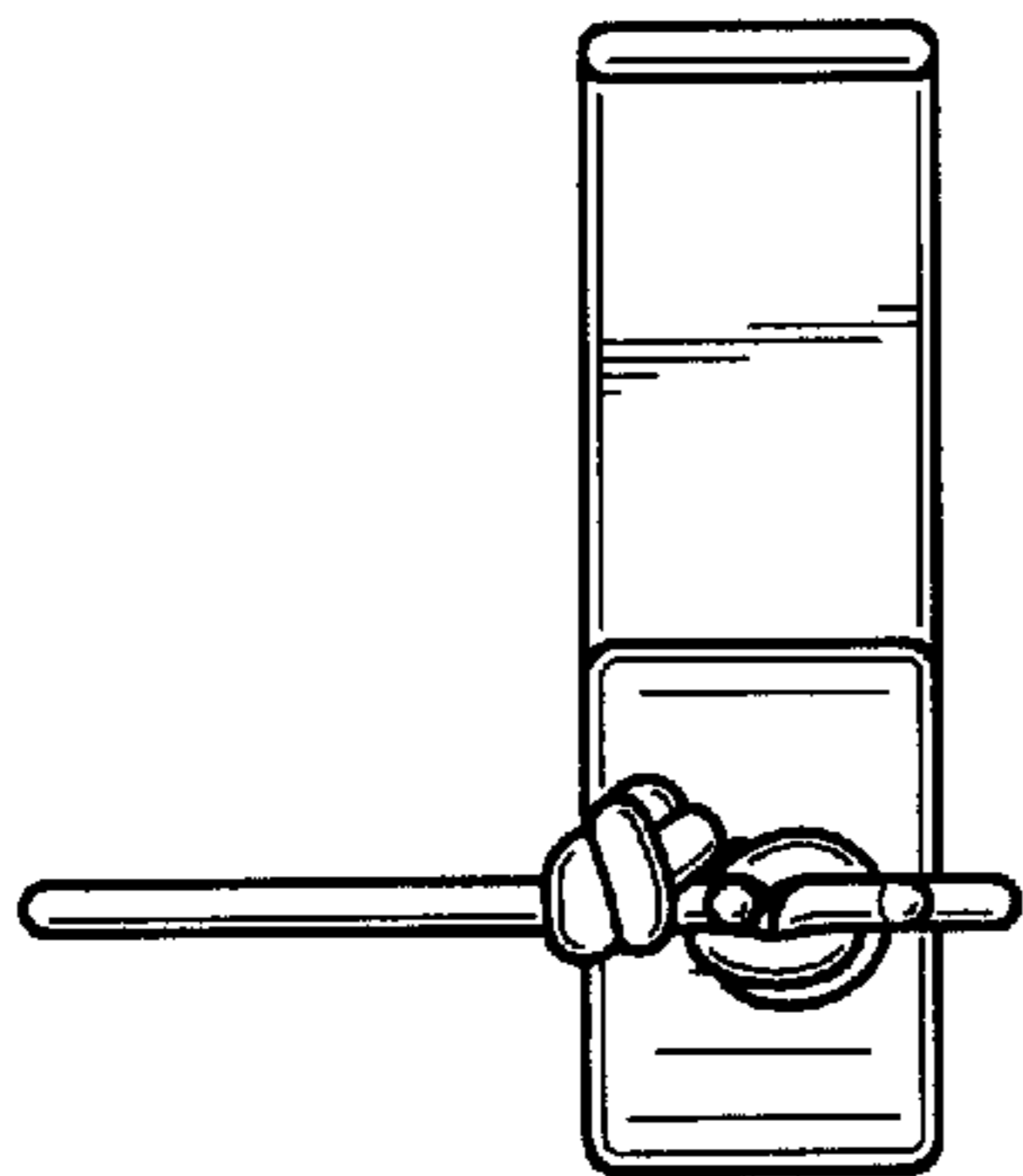




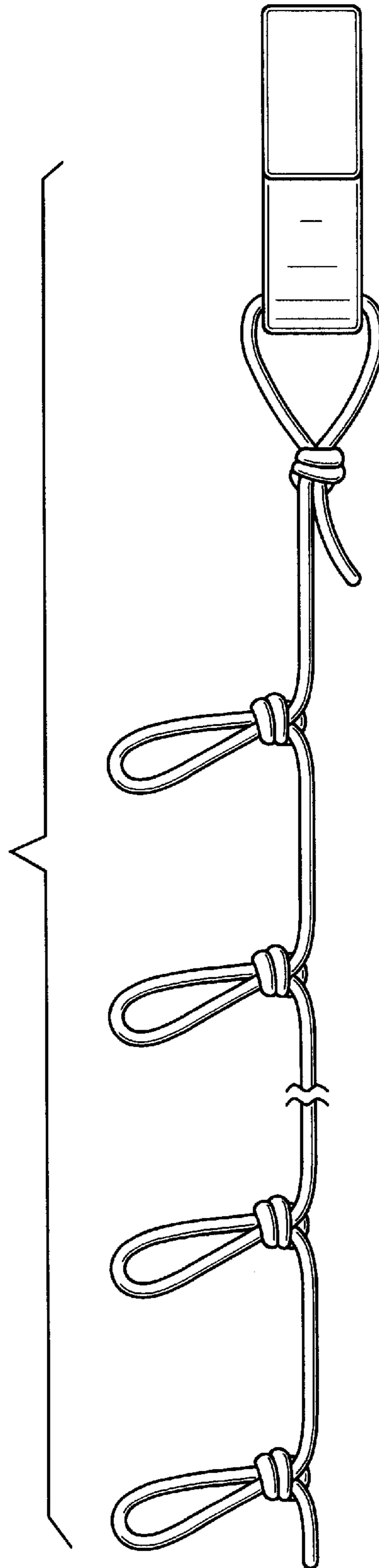
