(57) **CLAIM**

The ornamental design for a vehicle seat, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a vehicle seat incorporating our new design, viewed from in front of, above, and from the left side of the vehicle seat;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a left side elevation view thereof, with the right side being a mirror image of the left side;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a top plan view thereof; and,

FIG. 6 is a bottom plan view thereof.

The broken lines in FIGS. 2-4 and 6 are for illustrative purposes only and form no part of the claimed design.

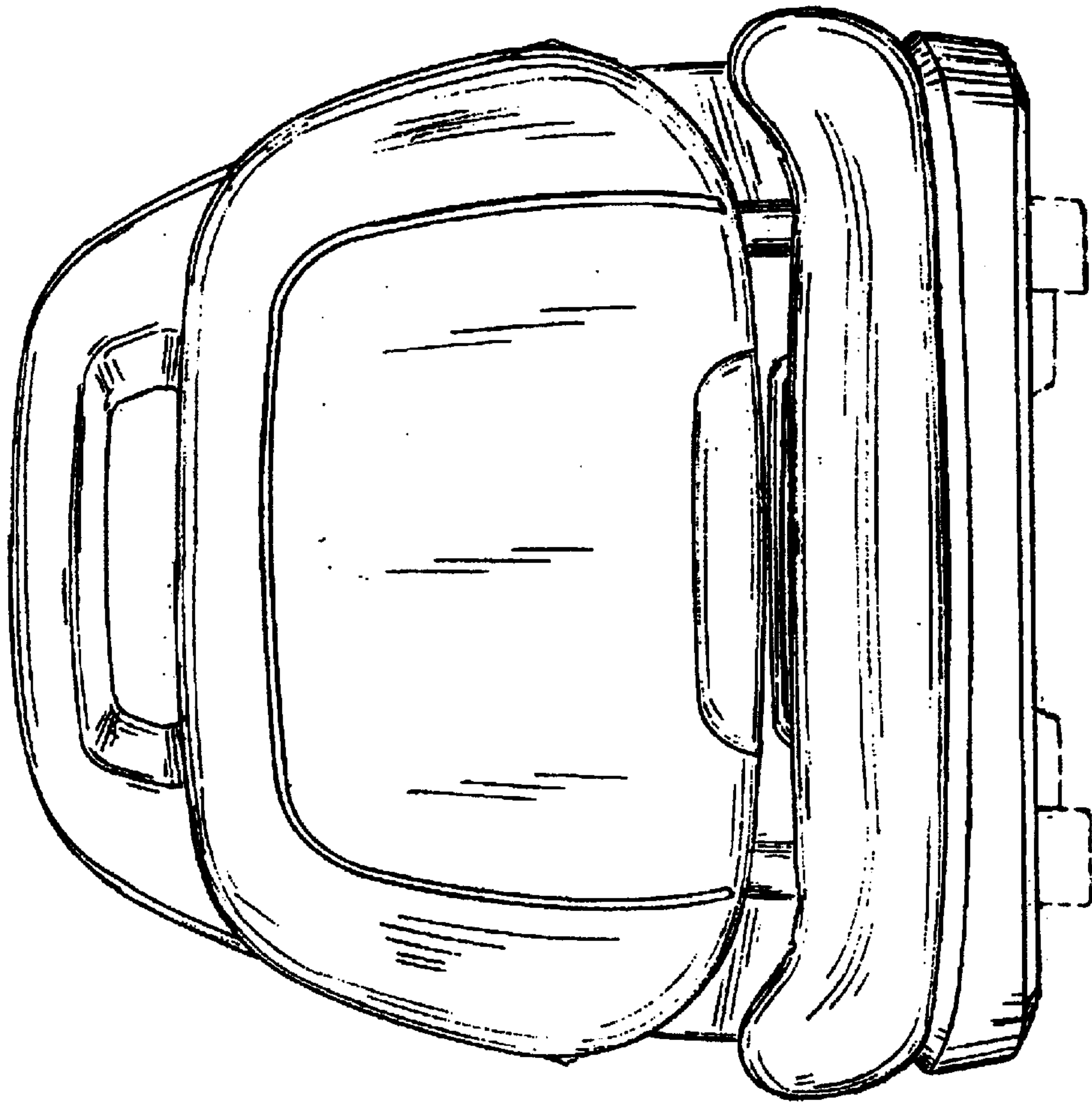

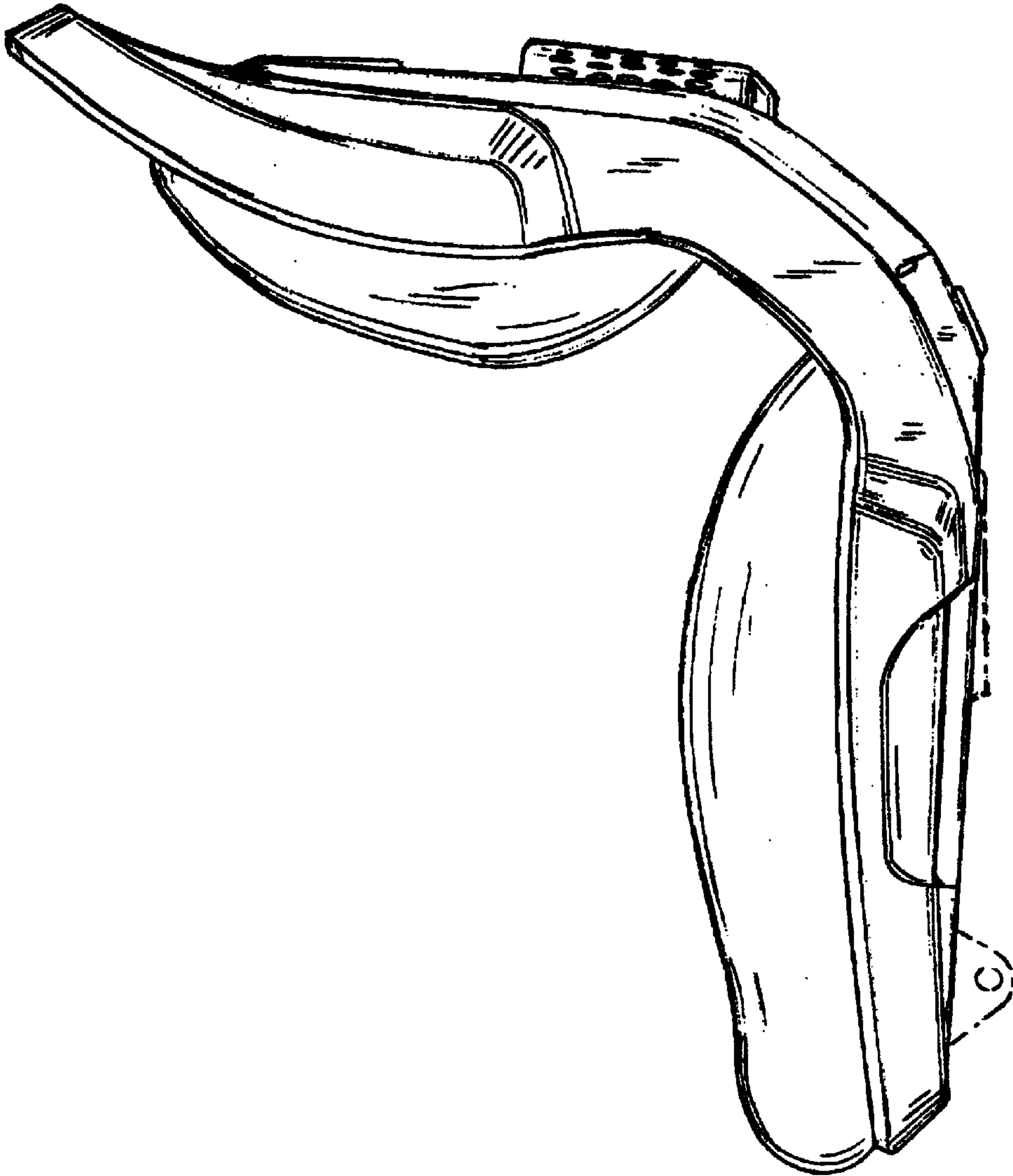

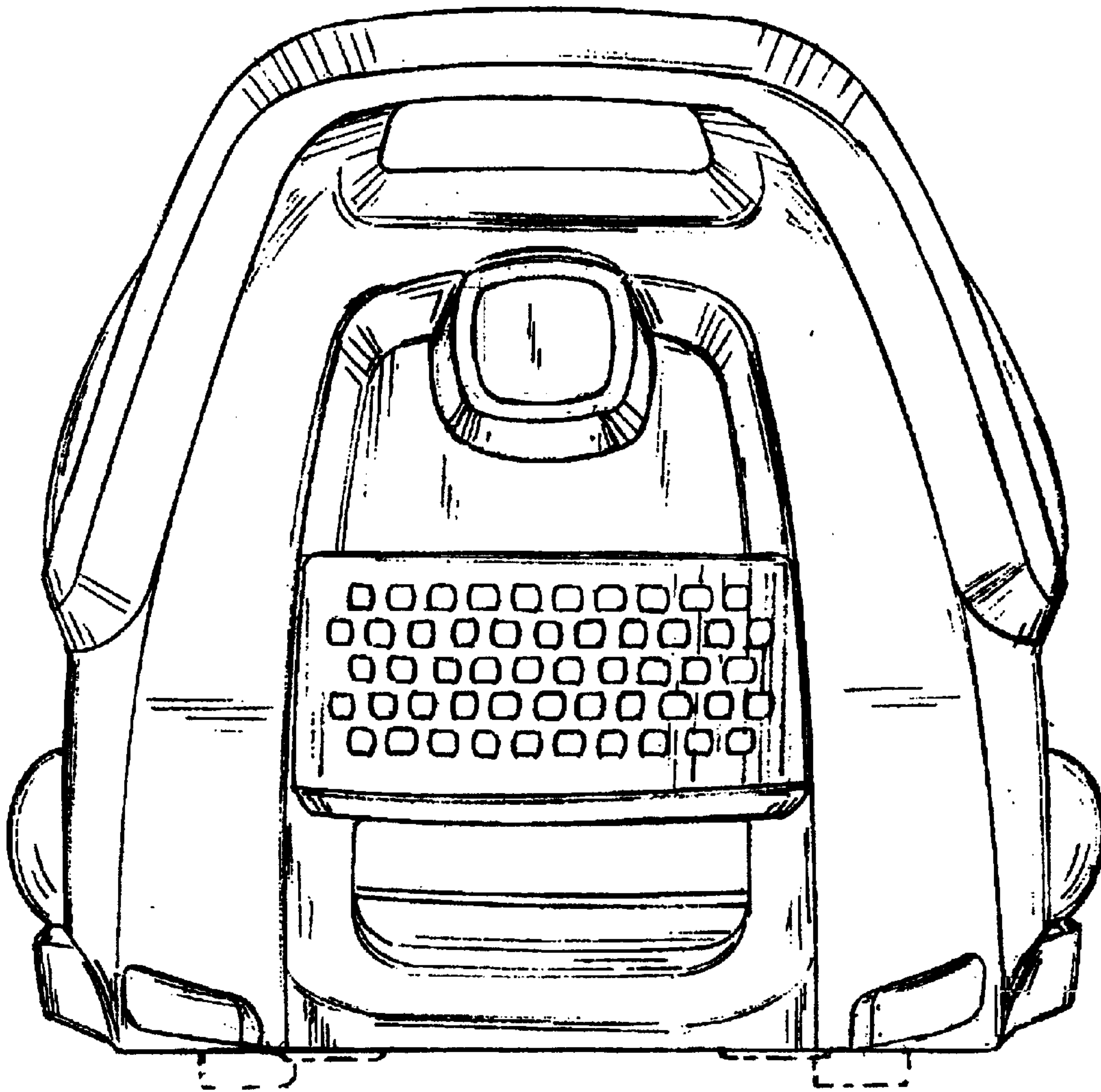

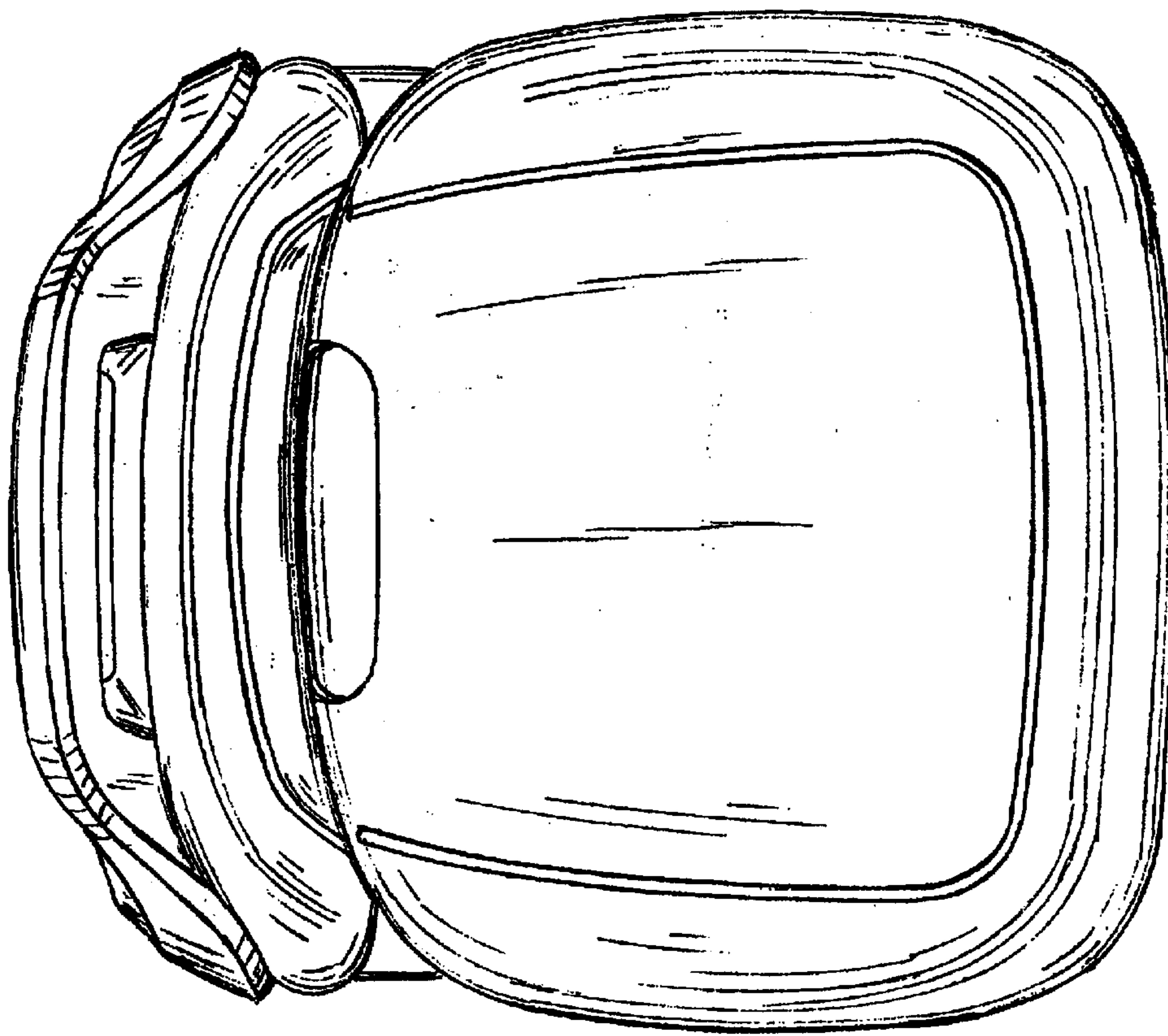

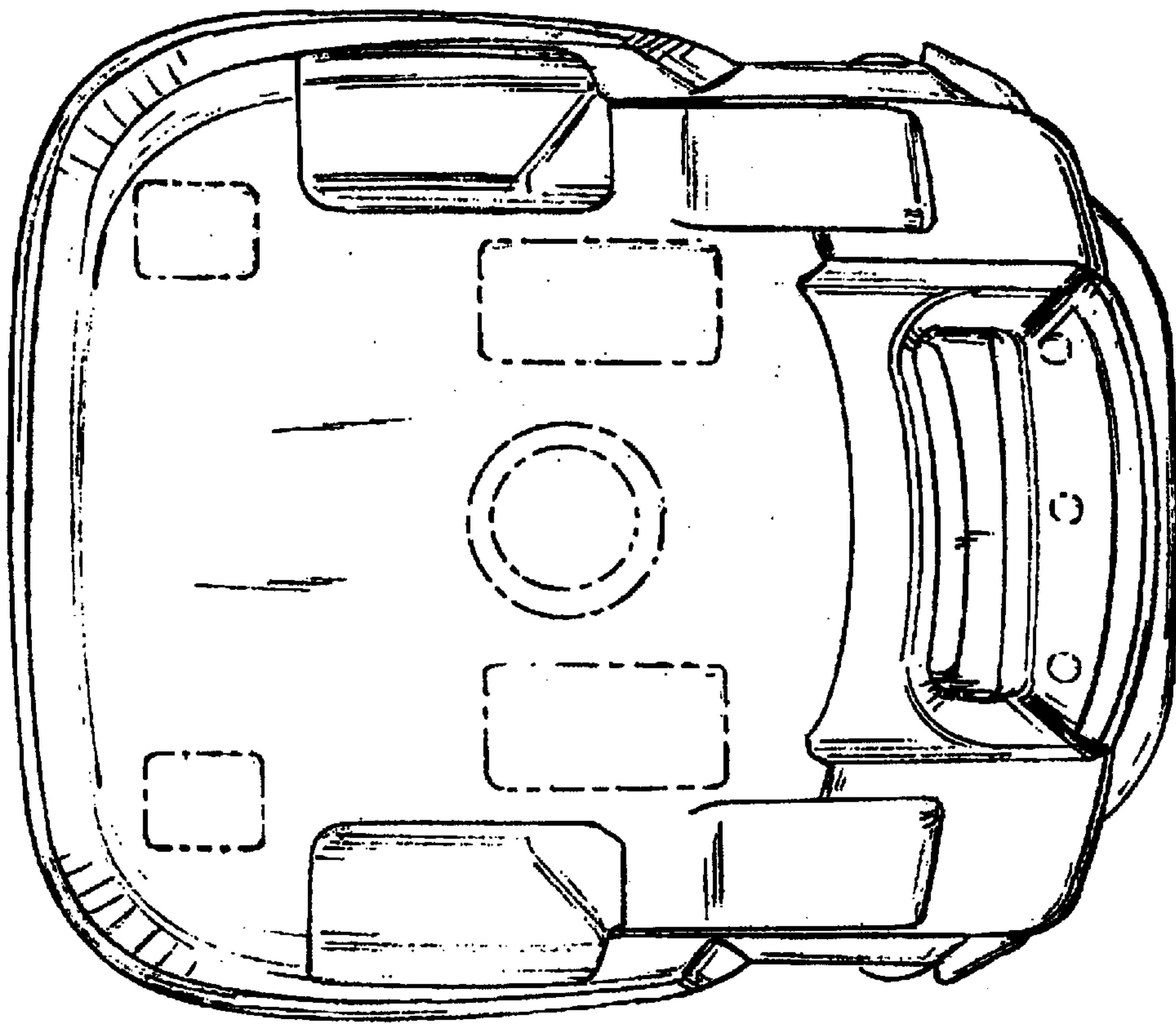
