I claim the ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a container showing my new design;

FIG. 2 is a front view of the design embodiment shown in FIG. 1;

FIG. 3 is a back view of the design embodiment shown in FIG. 1;

FIG. 4 is a right side view of the design embodiment shown in FIG. 1;

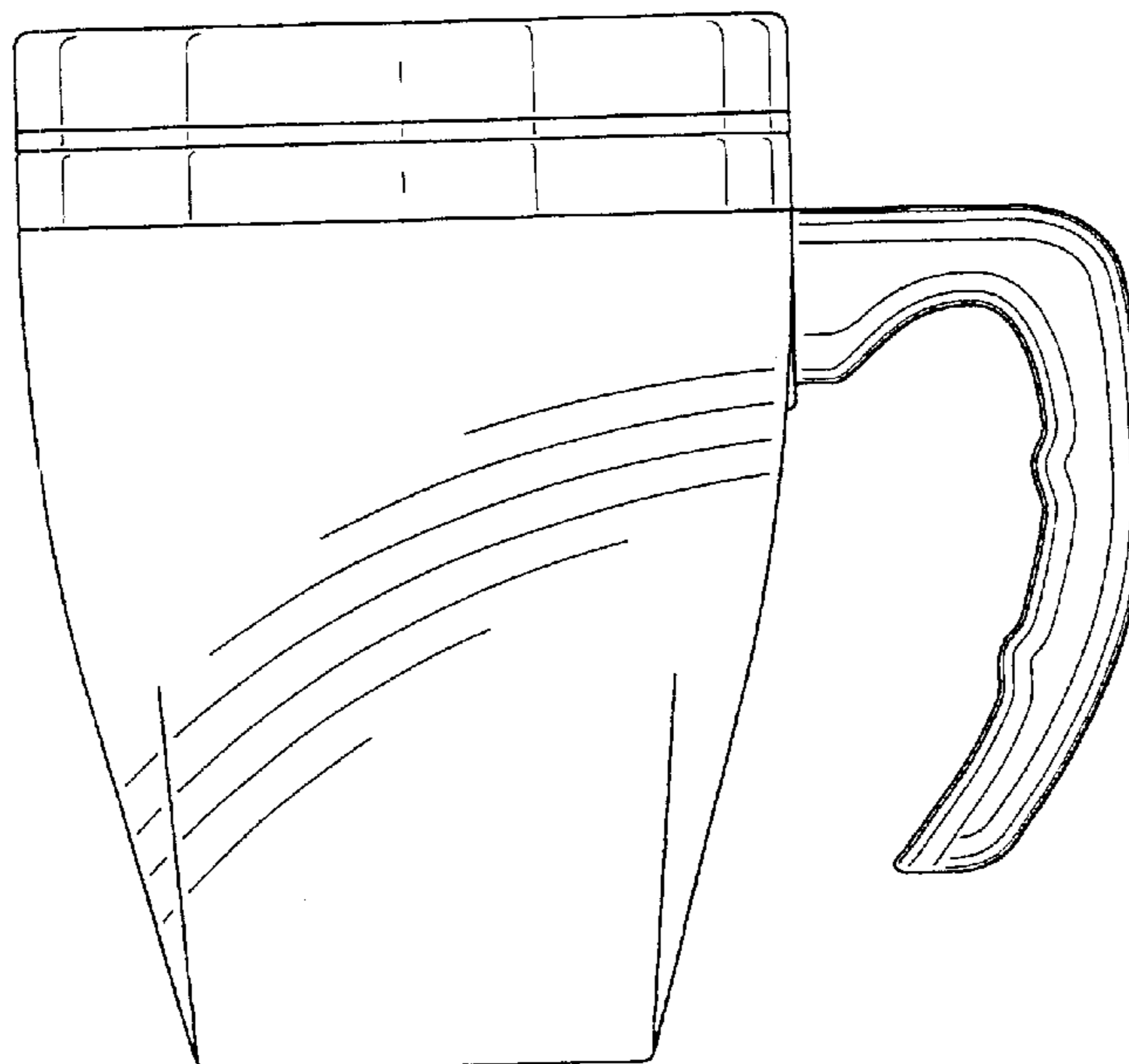
FIG. 5 is a left side view of the design embodiment shown in FIG. 1;

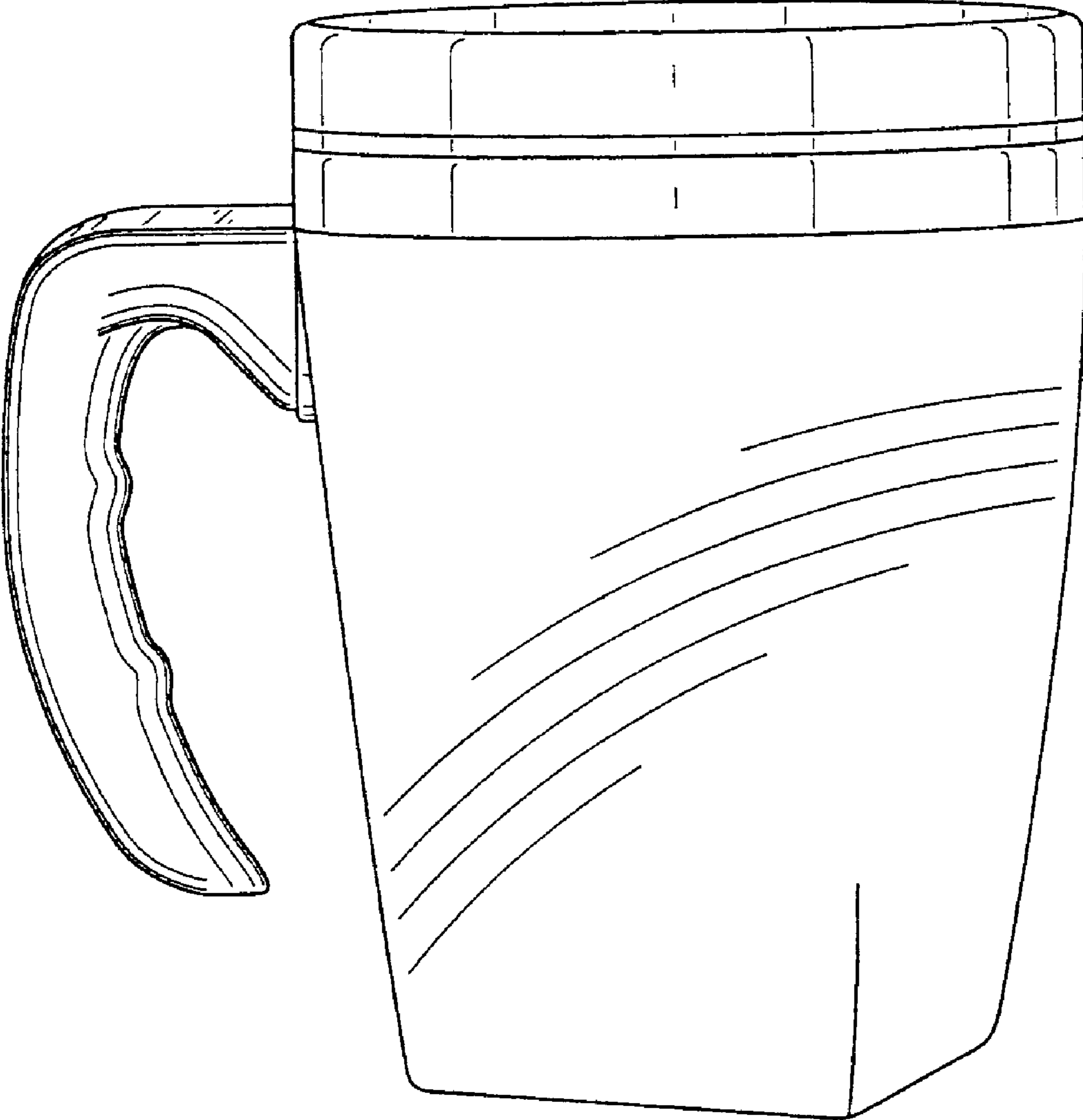

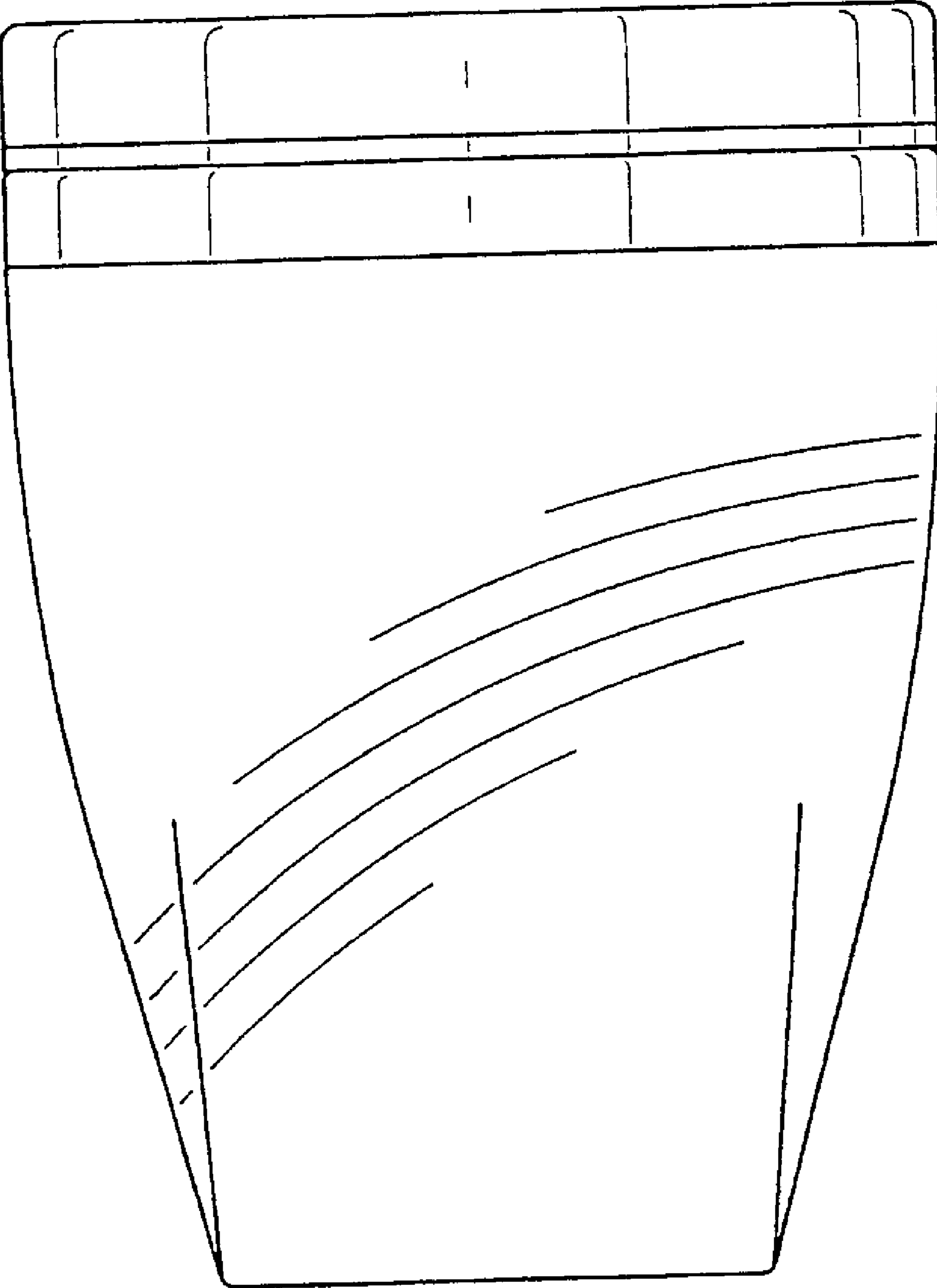

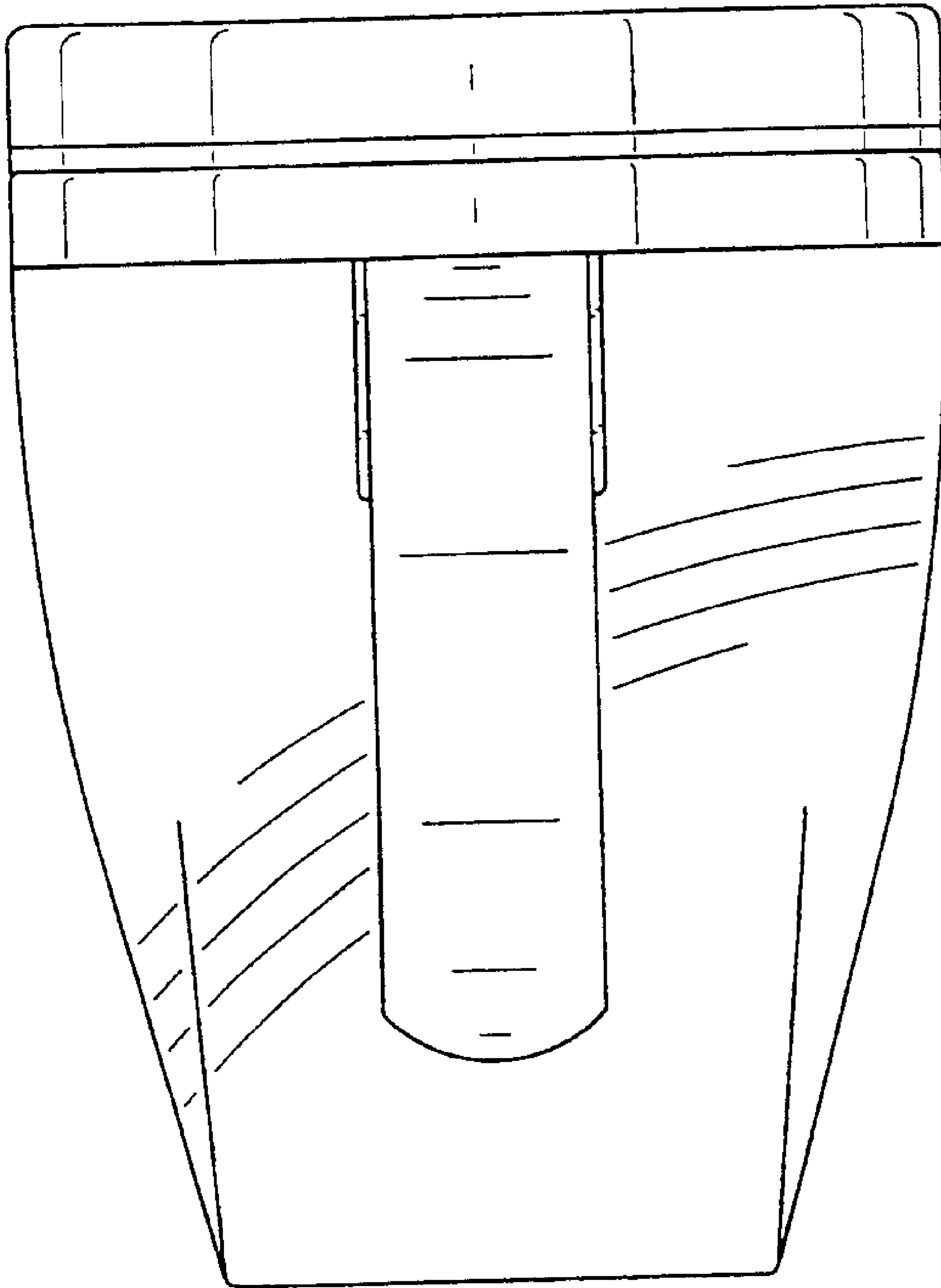

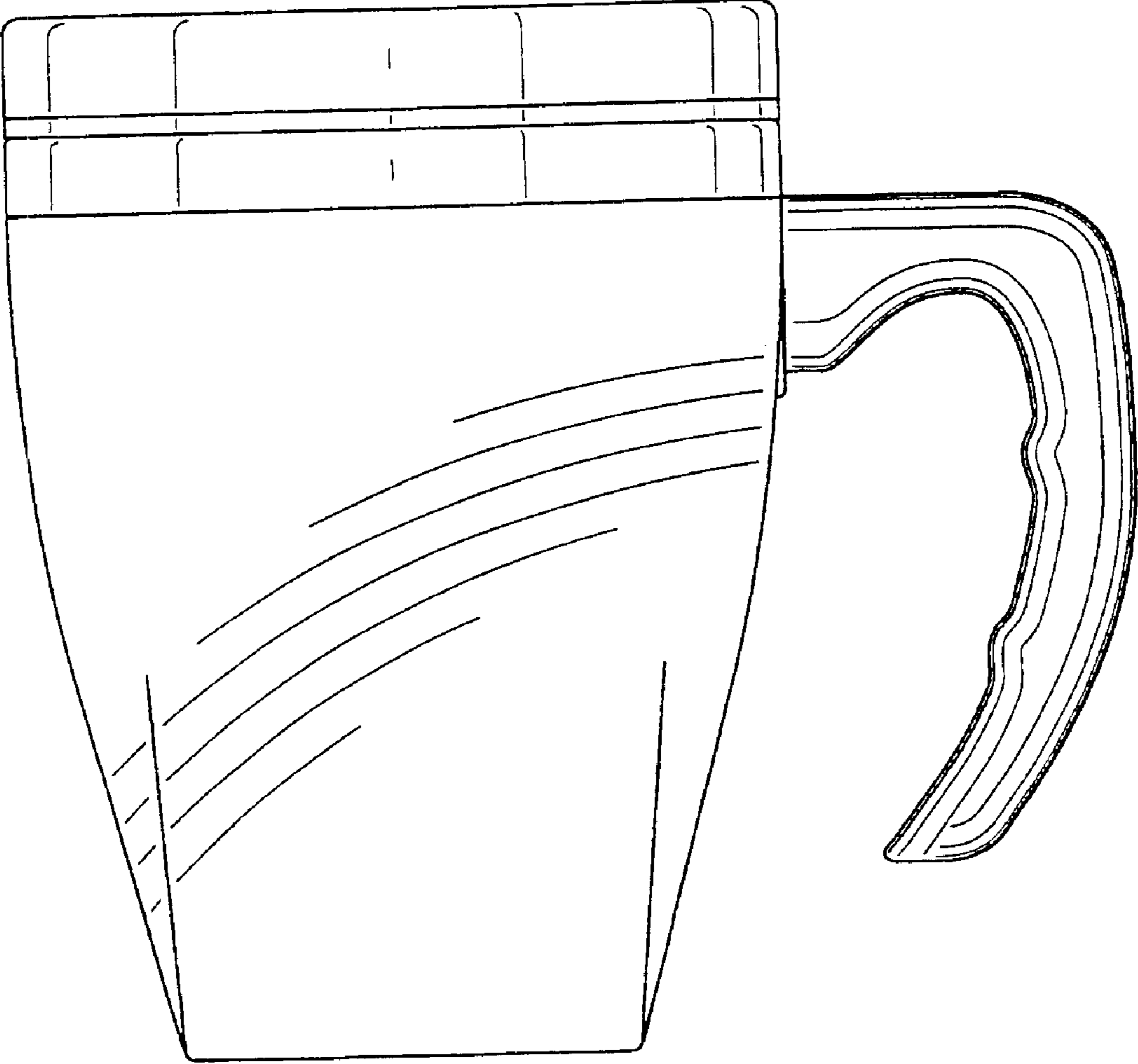

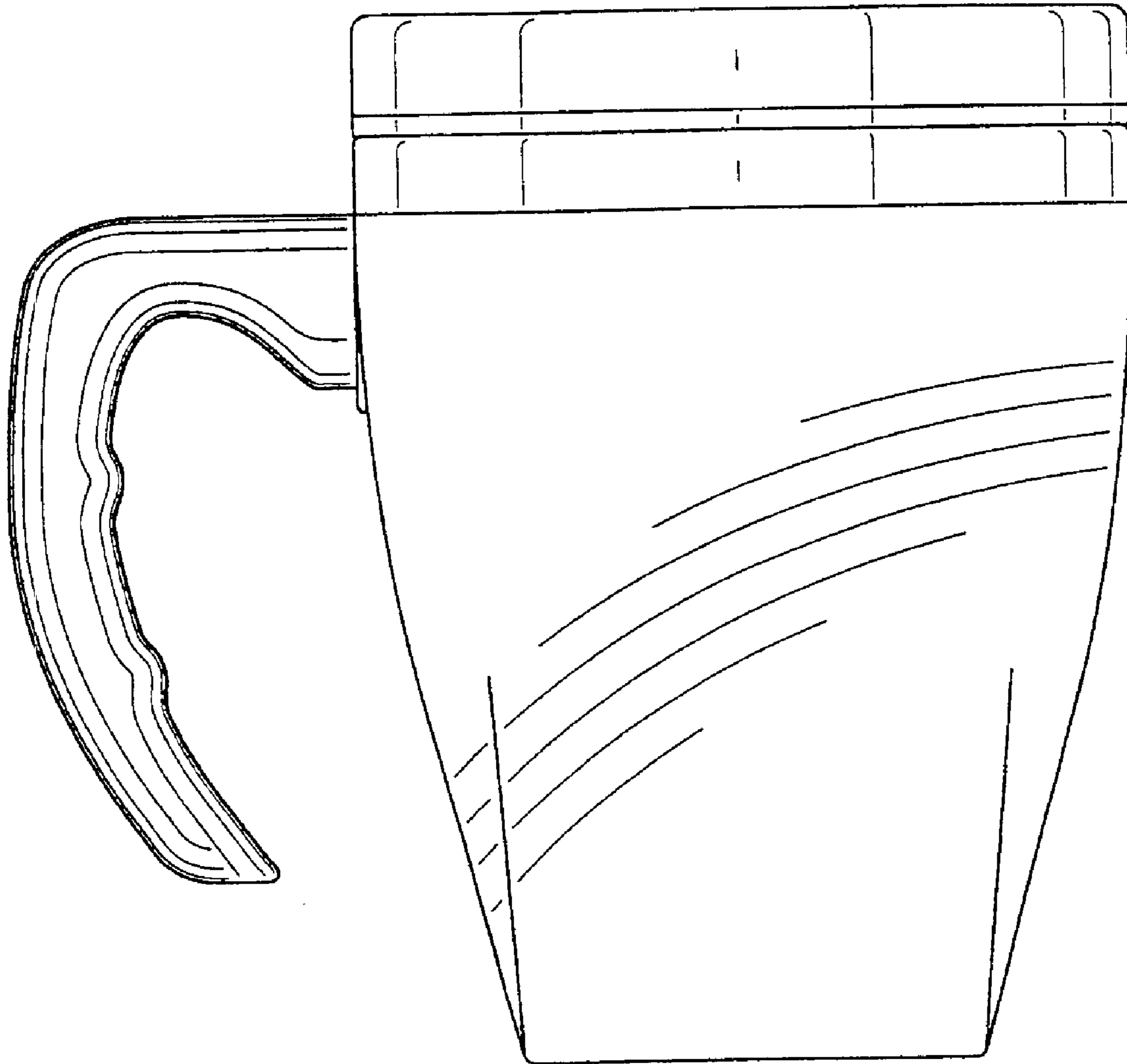

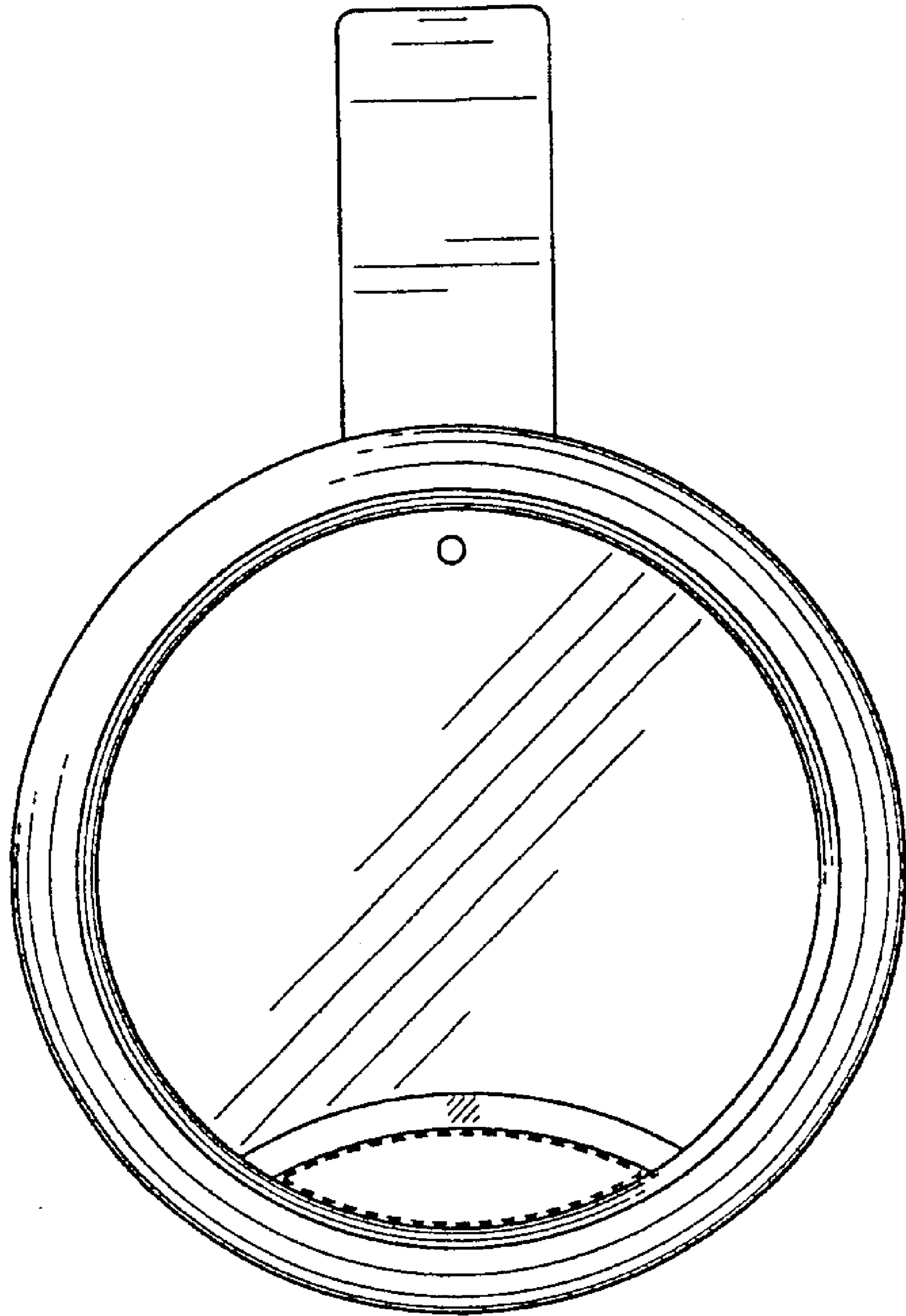

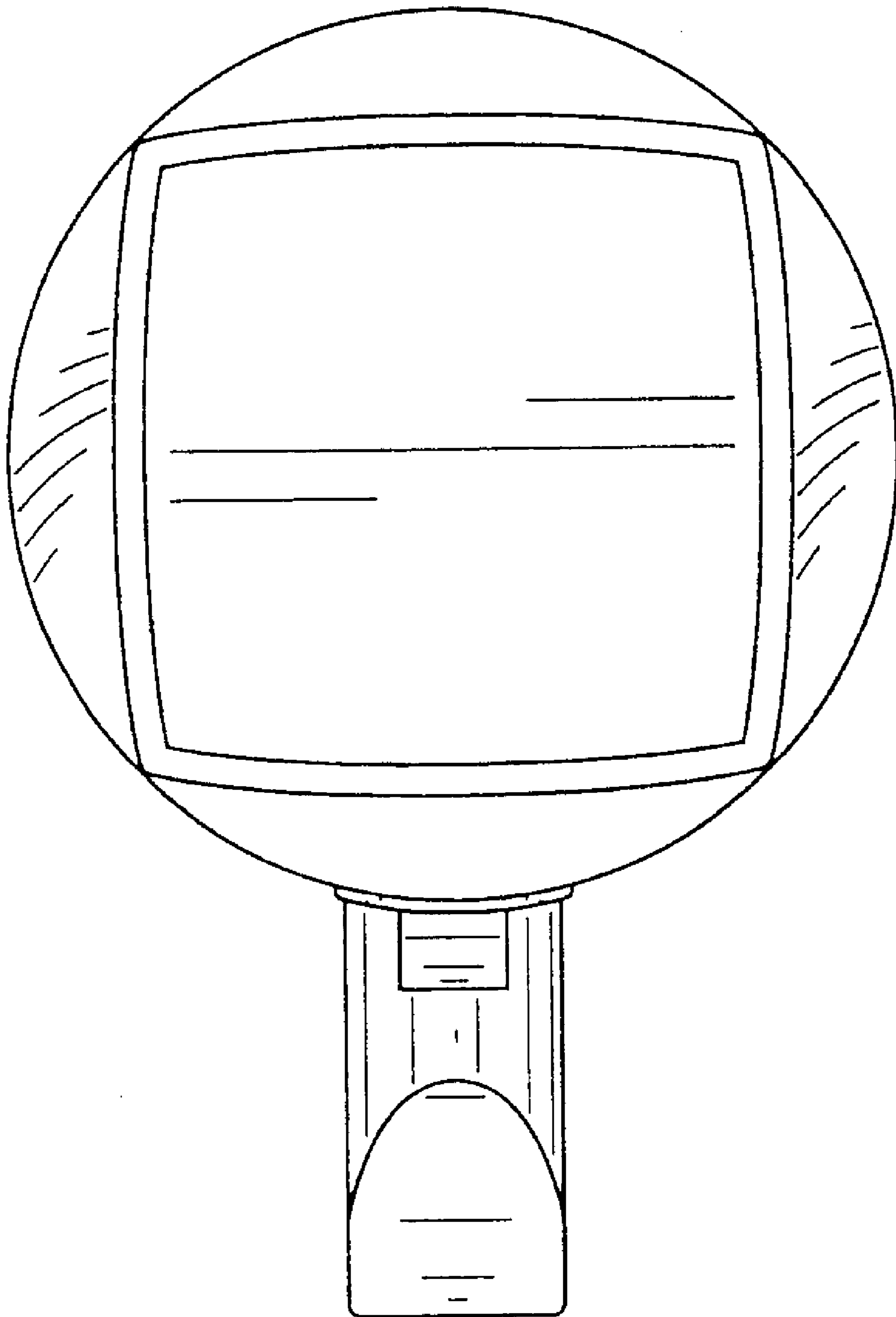
