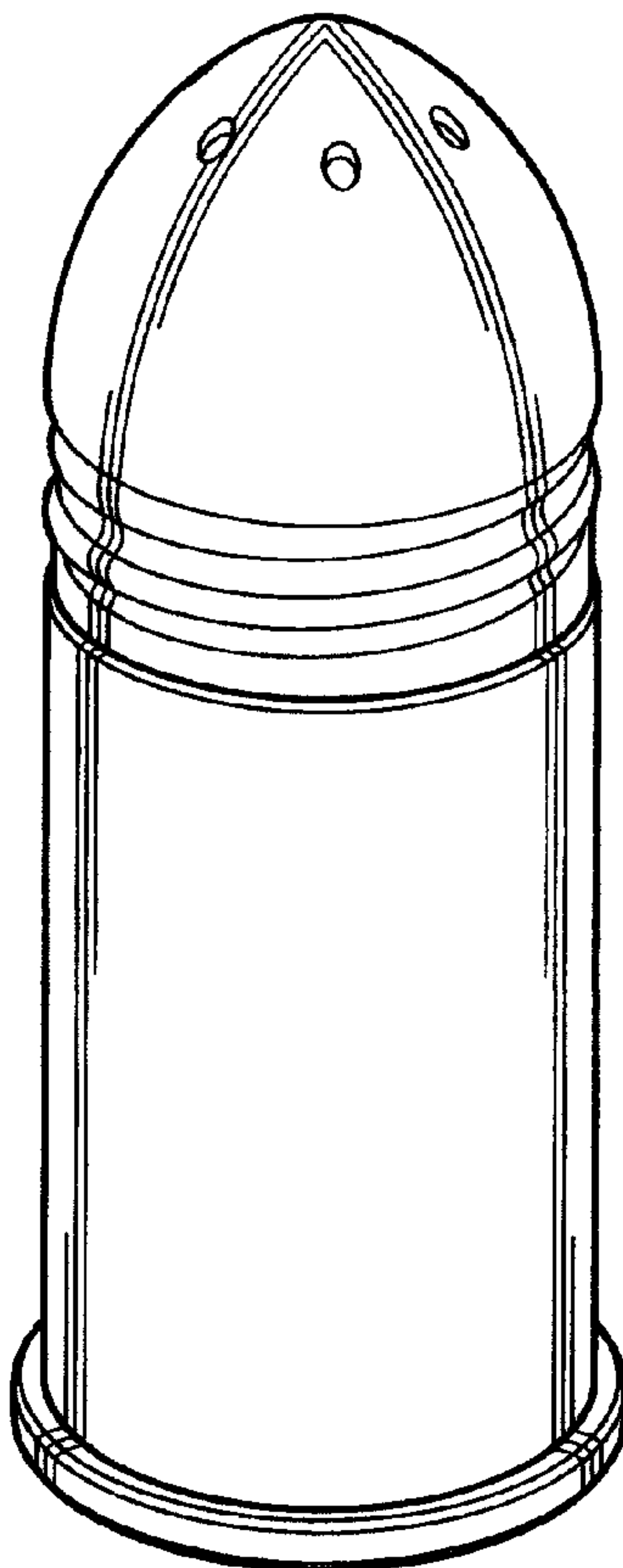

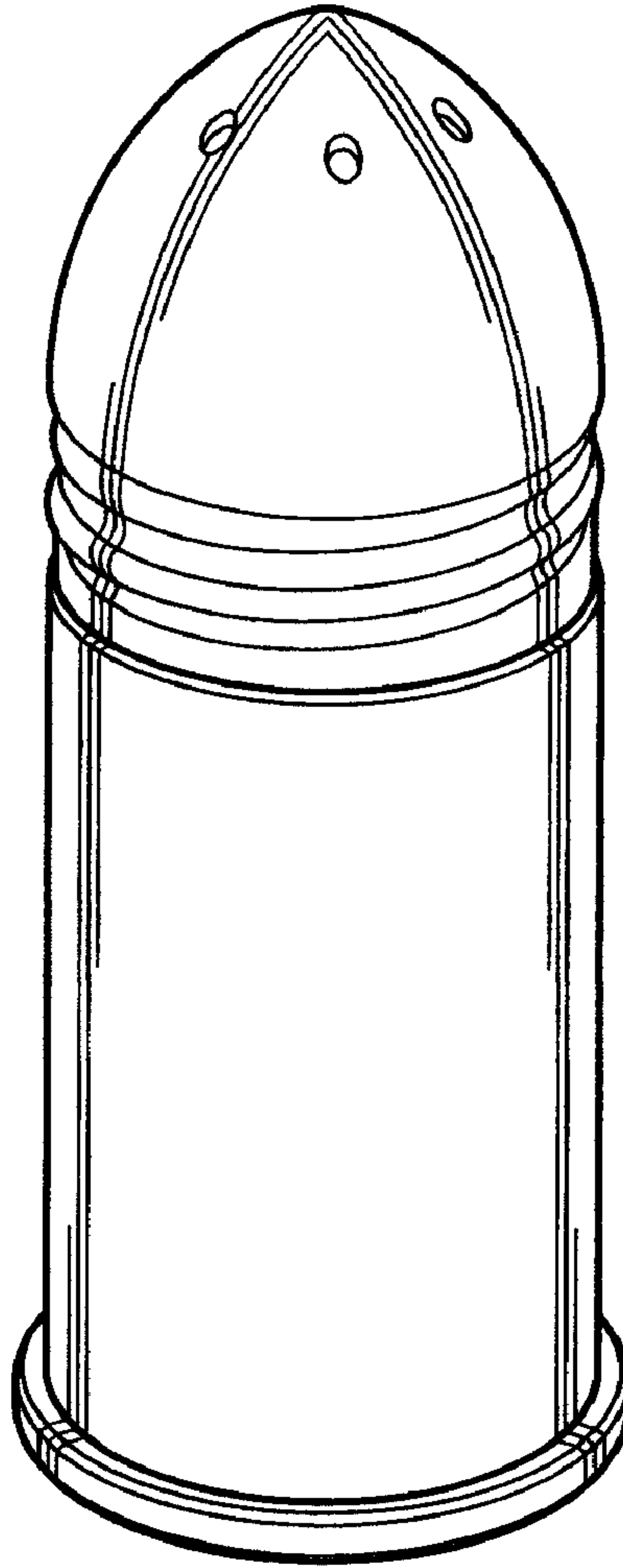
The ornamental design for a salt shaker, as shown and described.

**DESCRIPTION**

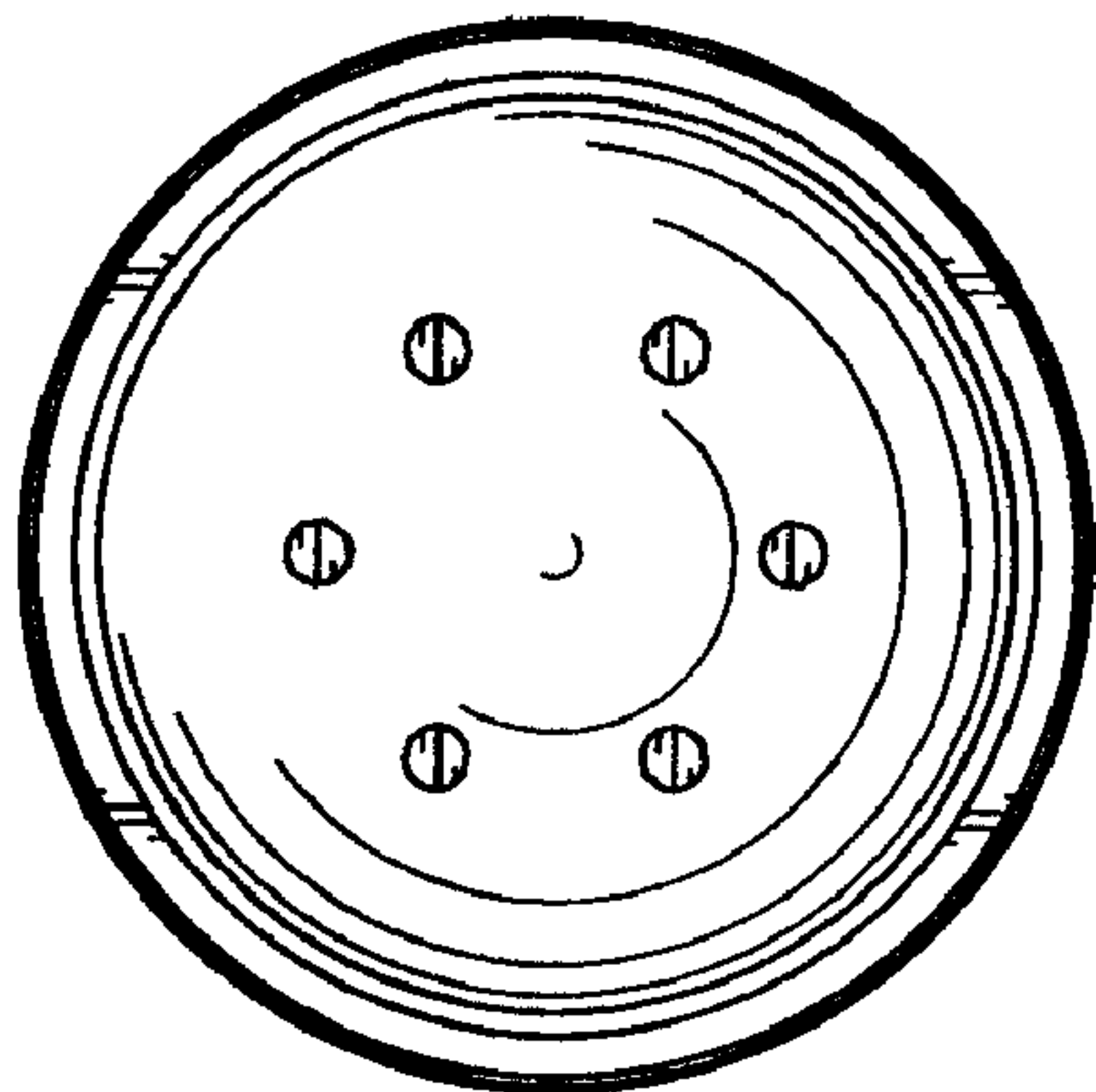
FIG. 1 is a front perspective view of a salt shaker showing my new design,

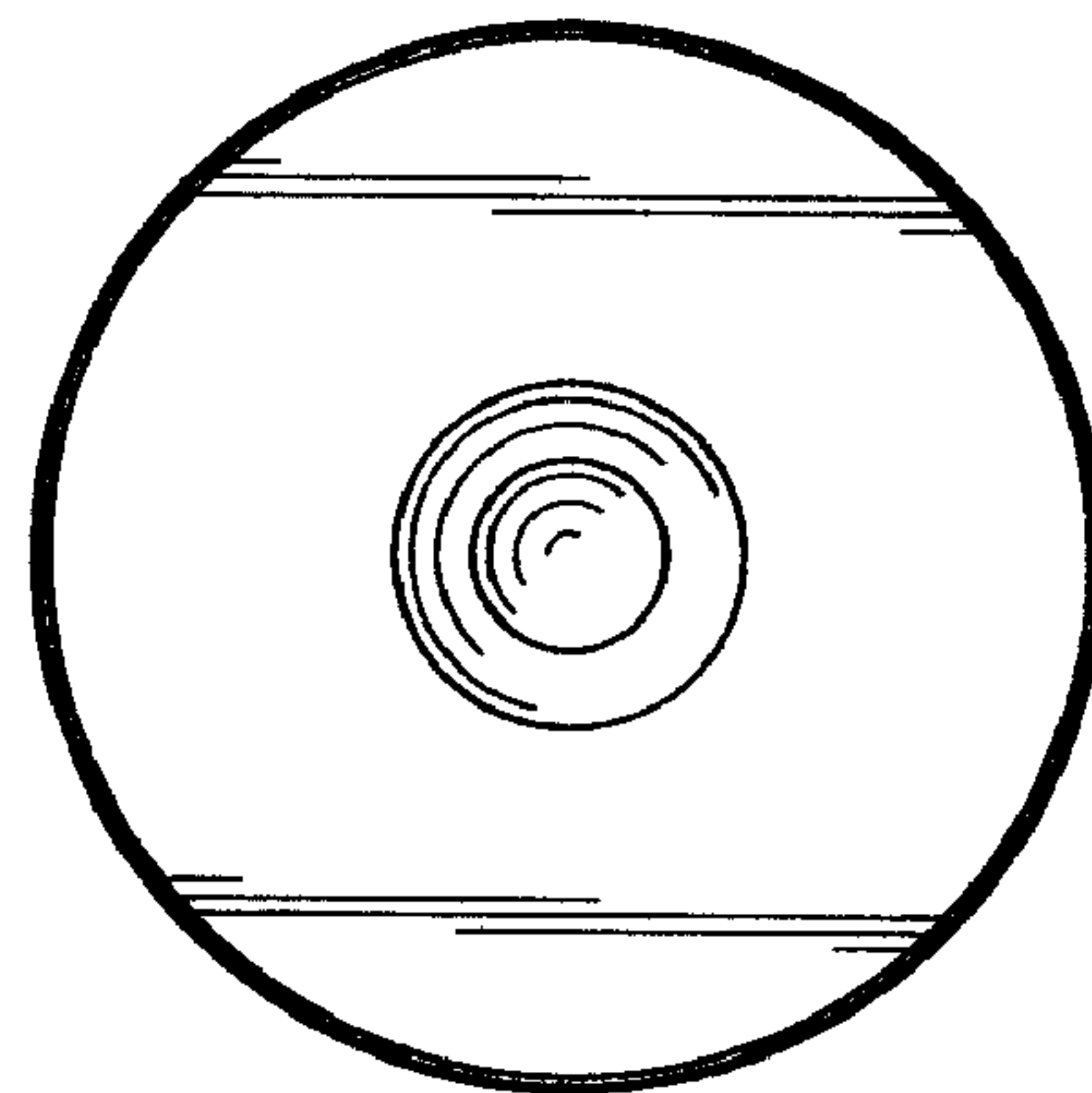




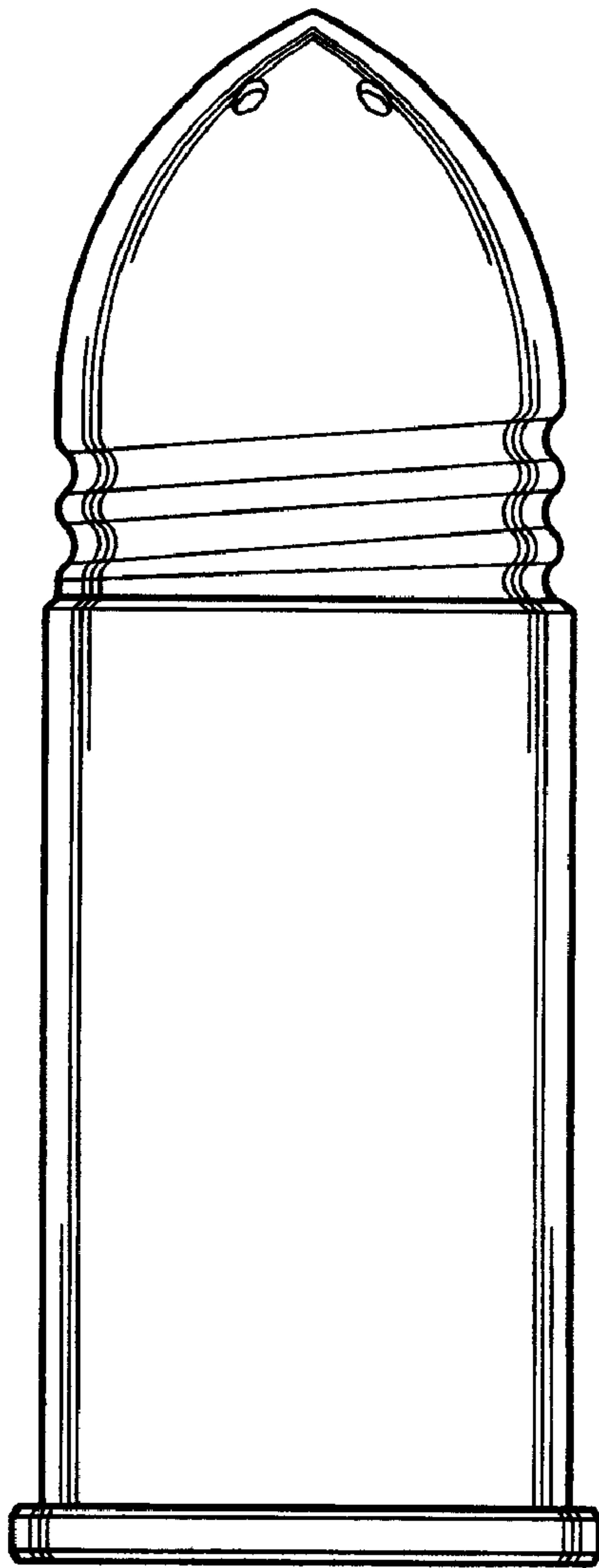

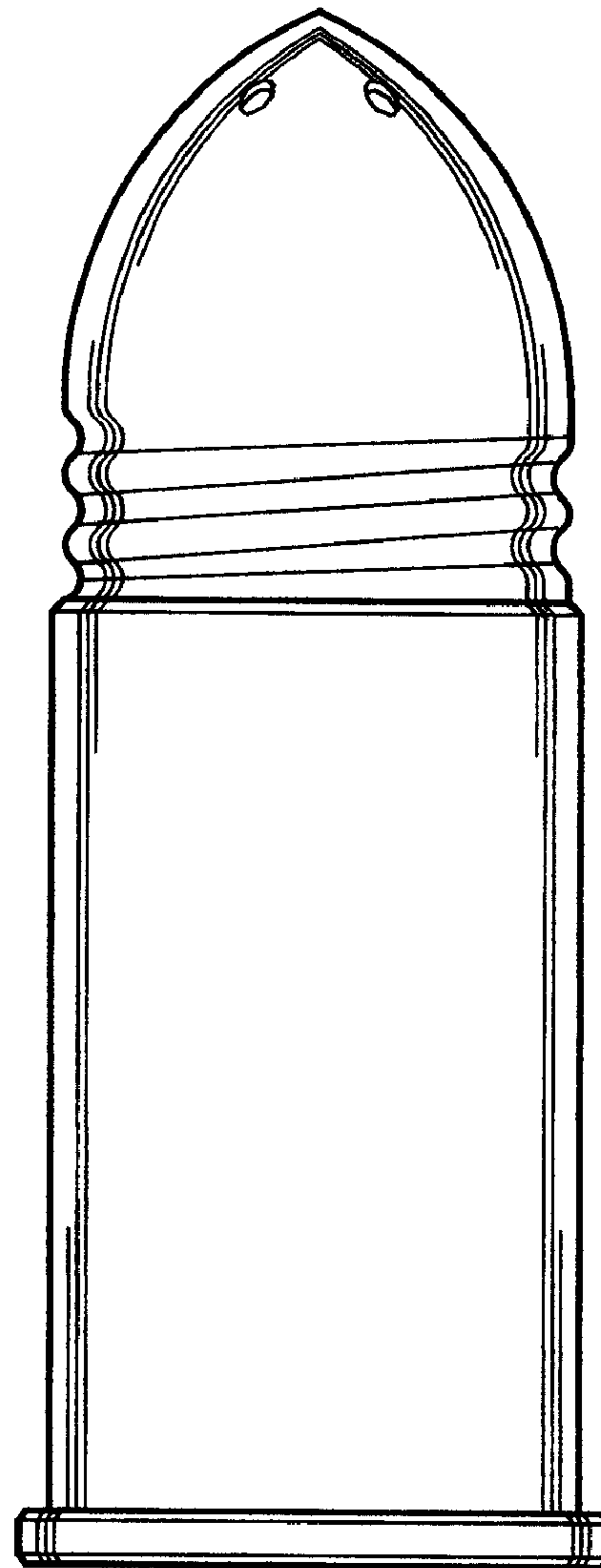

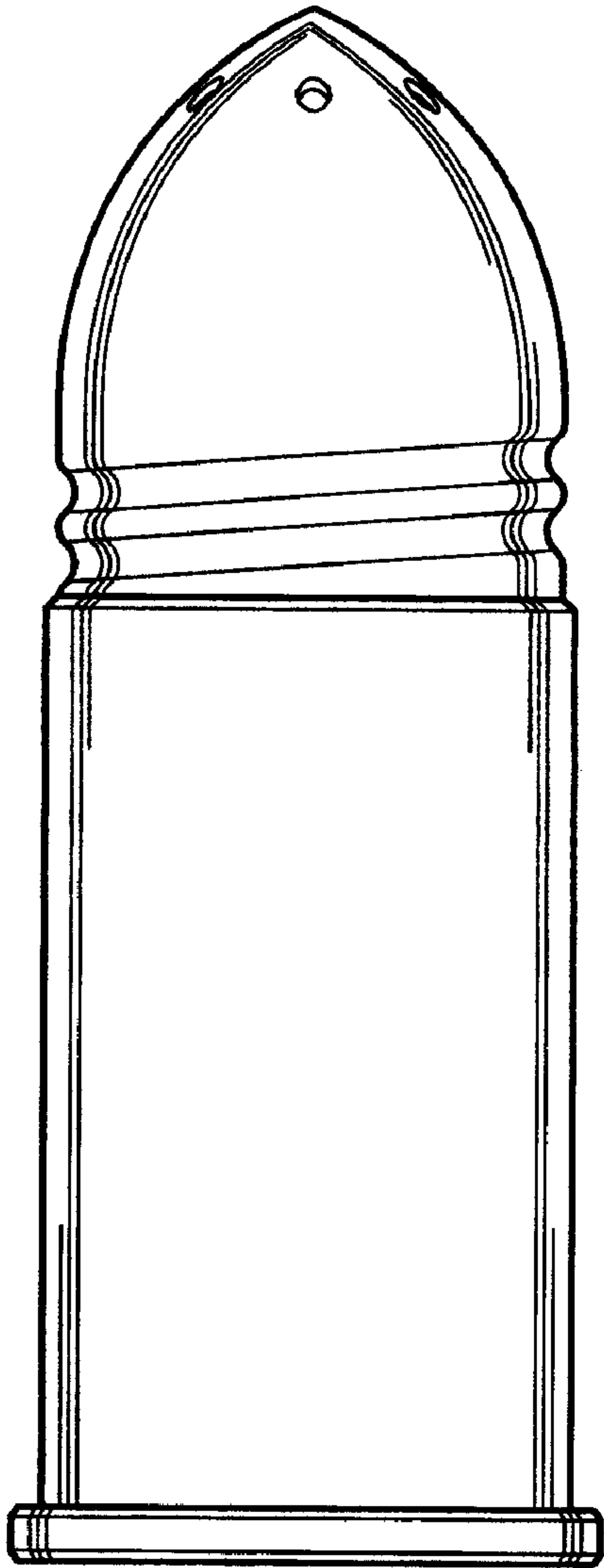

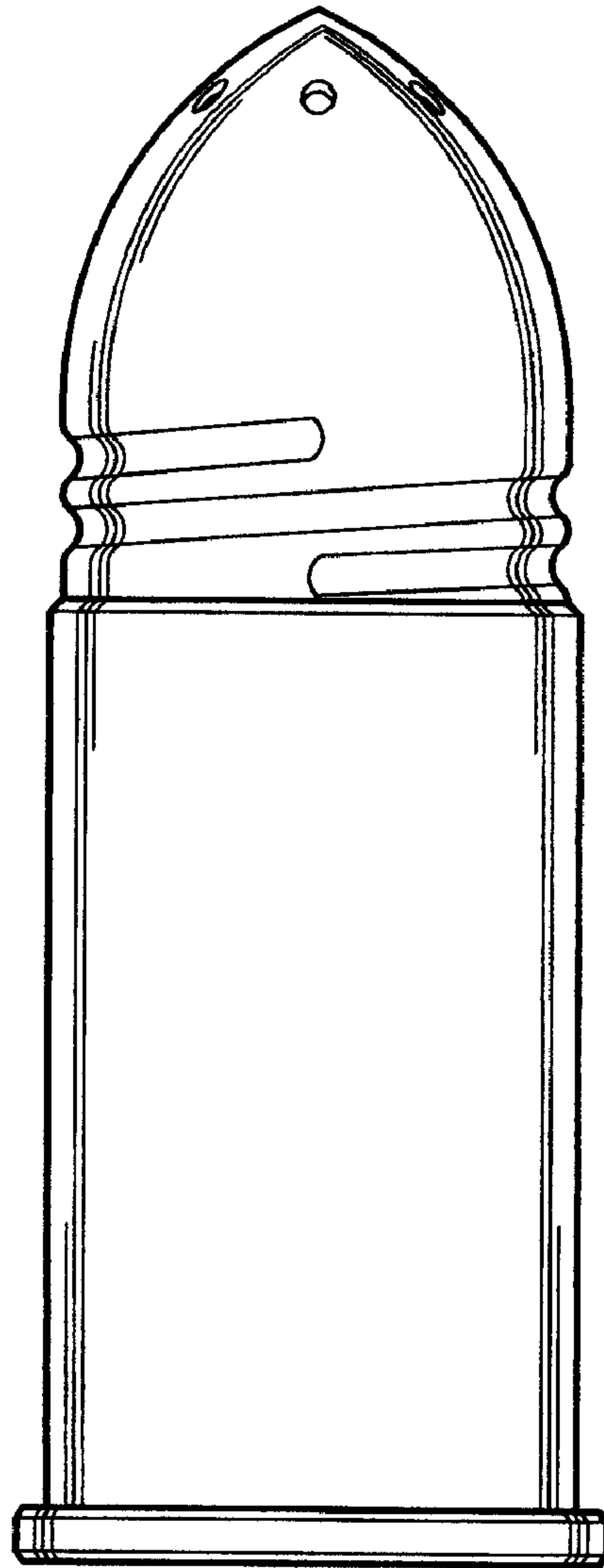
