**DESCRIPTION**

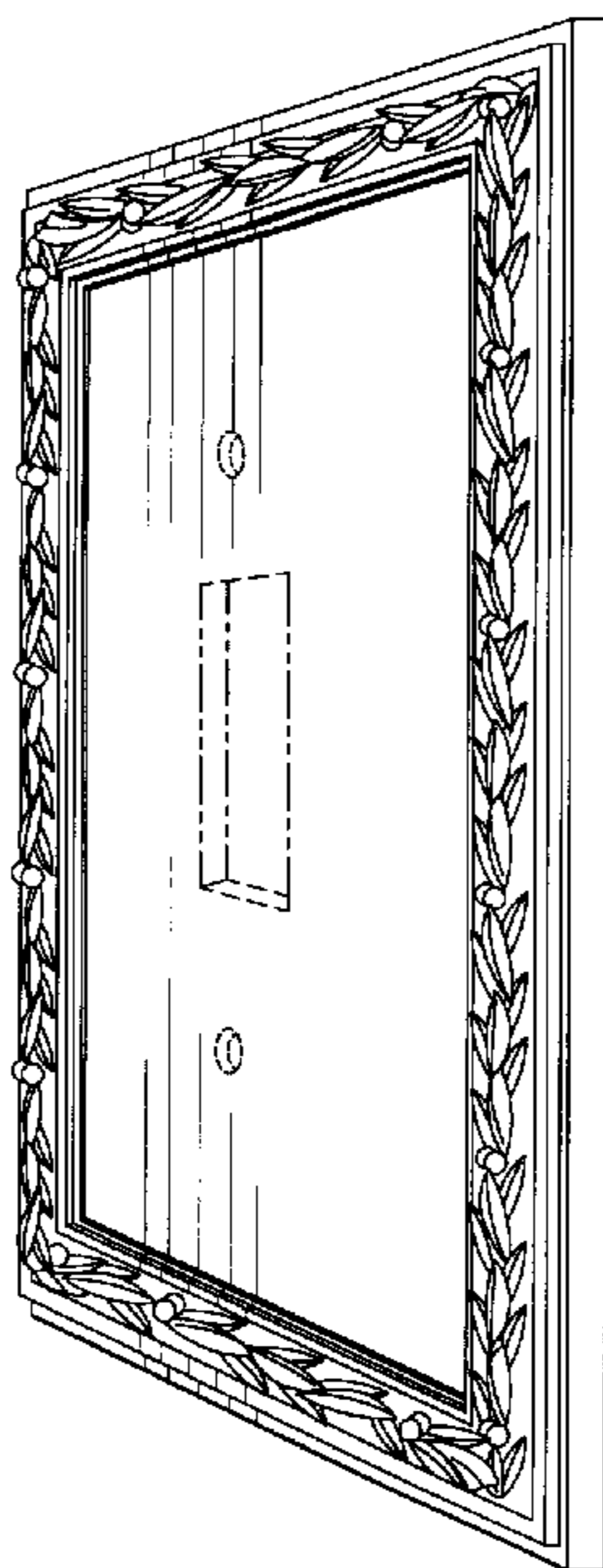
FIG. 1 is a perspective view of a first embodiment of a wall plate showing my new design;

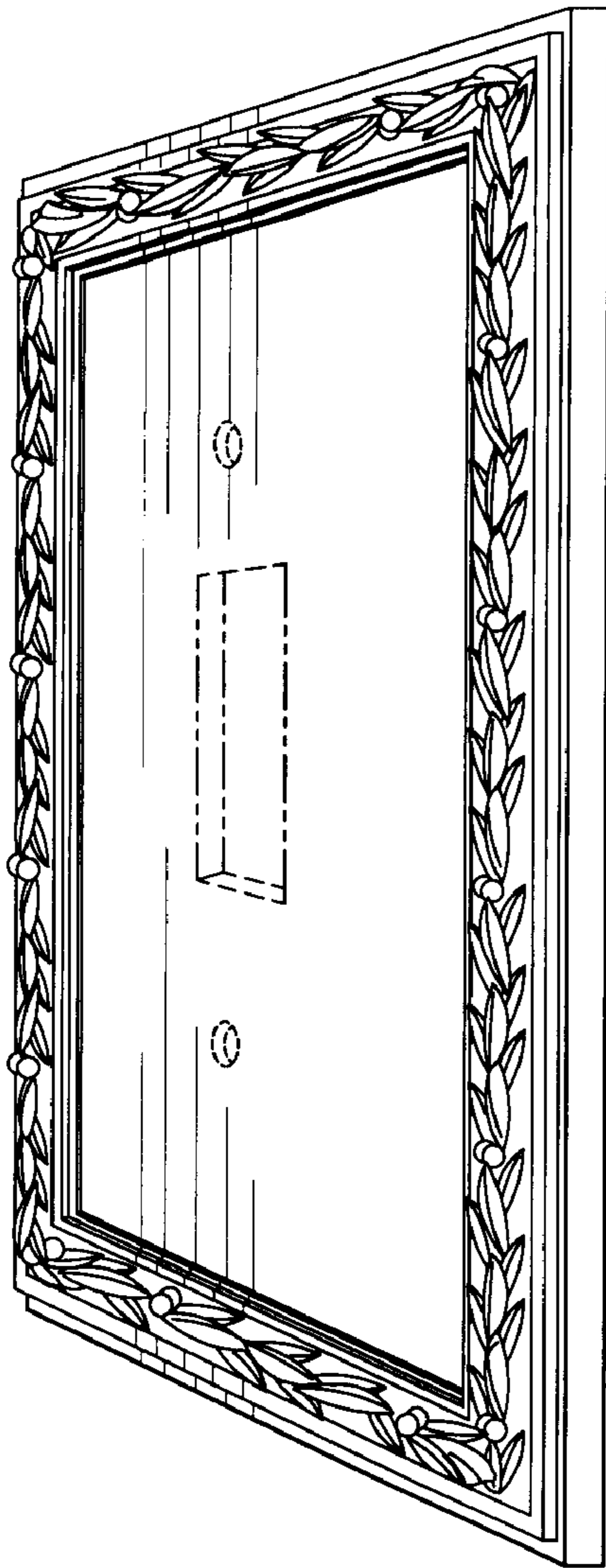

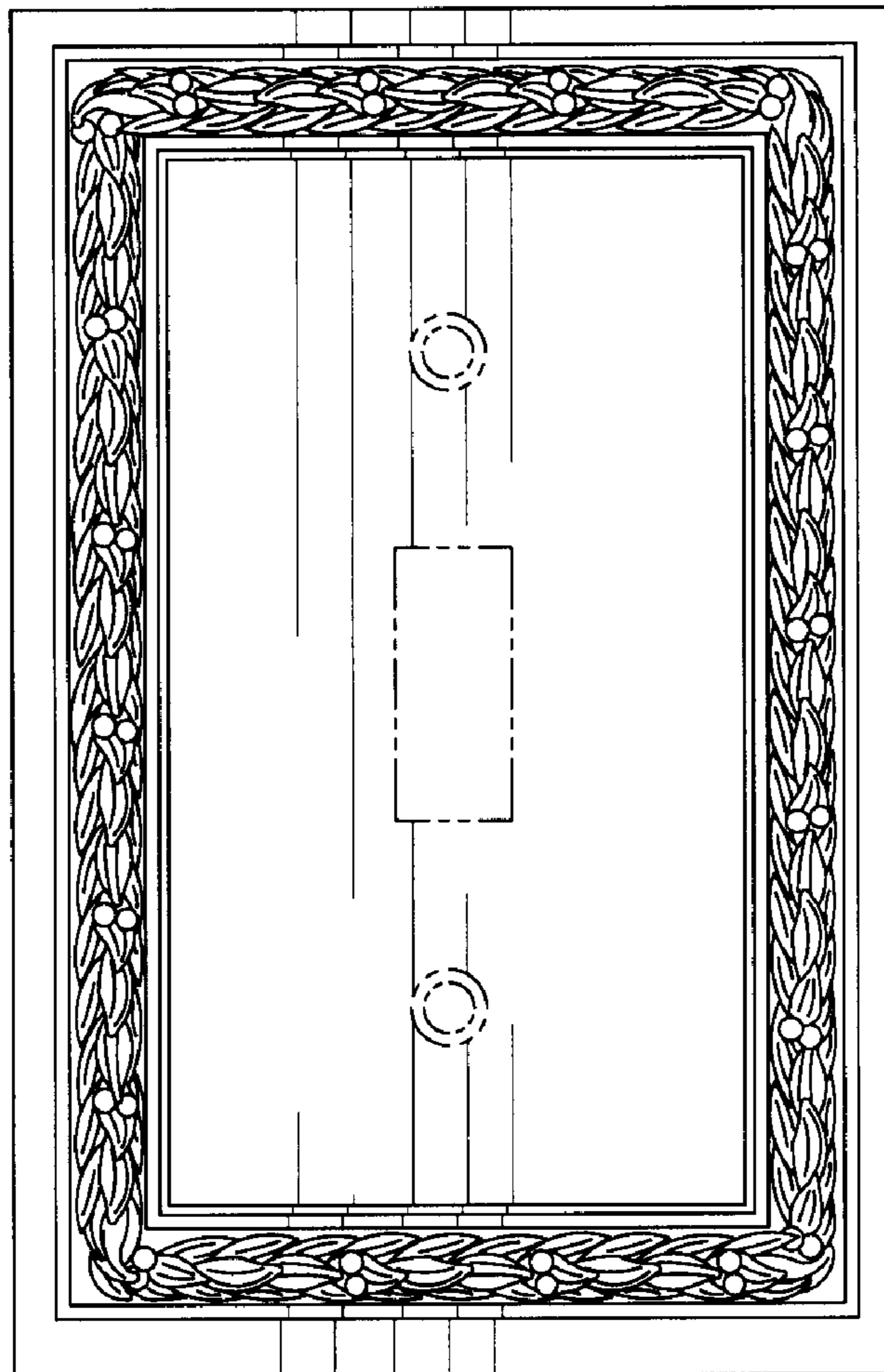

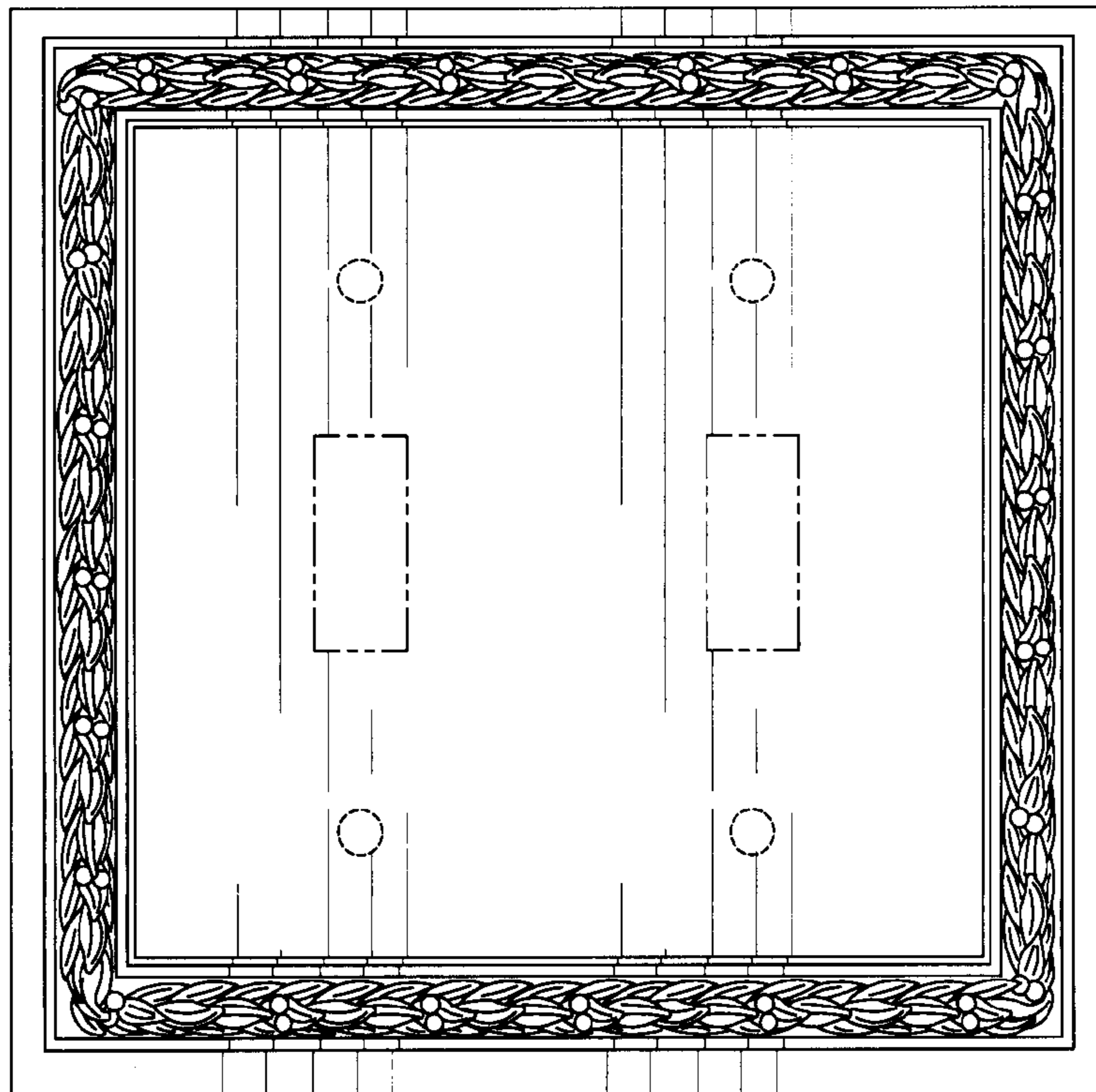
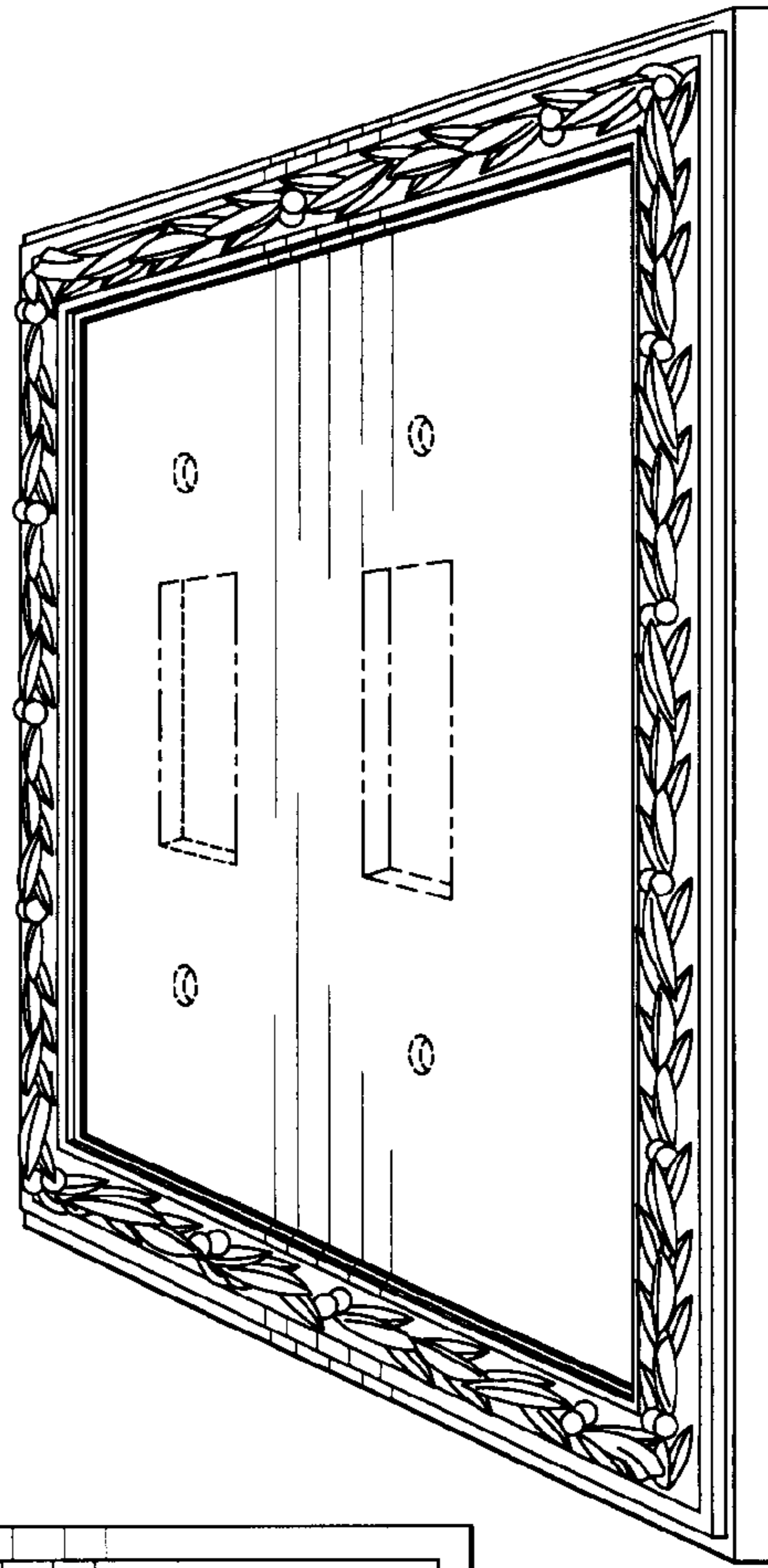

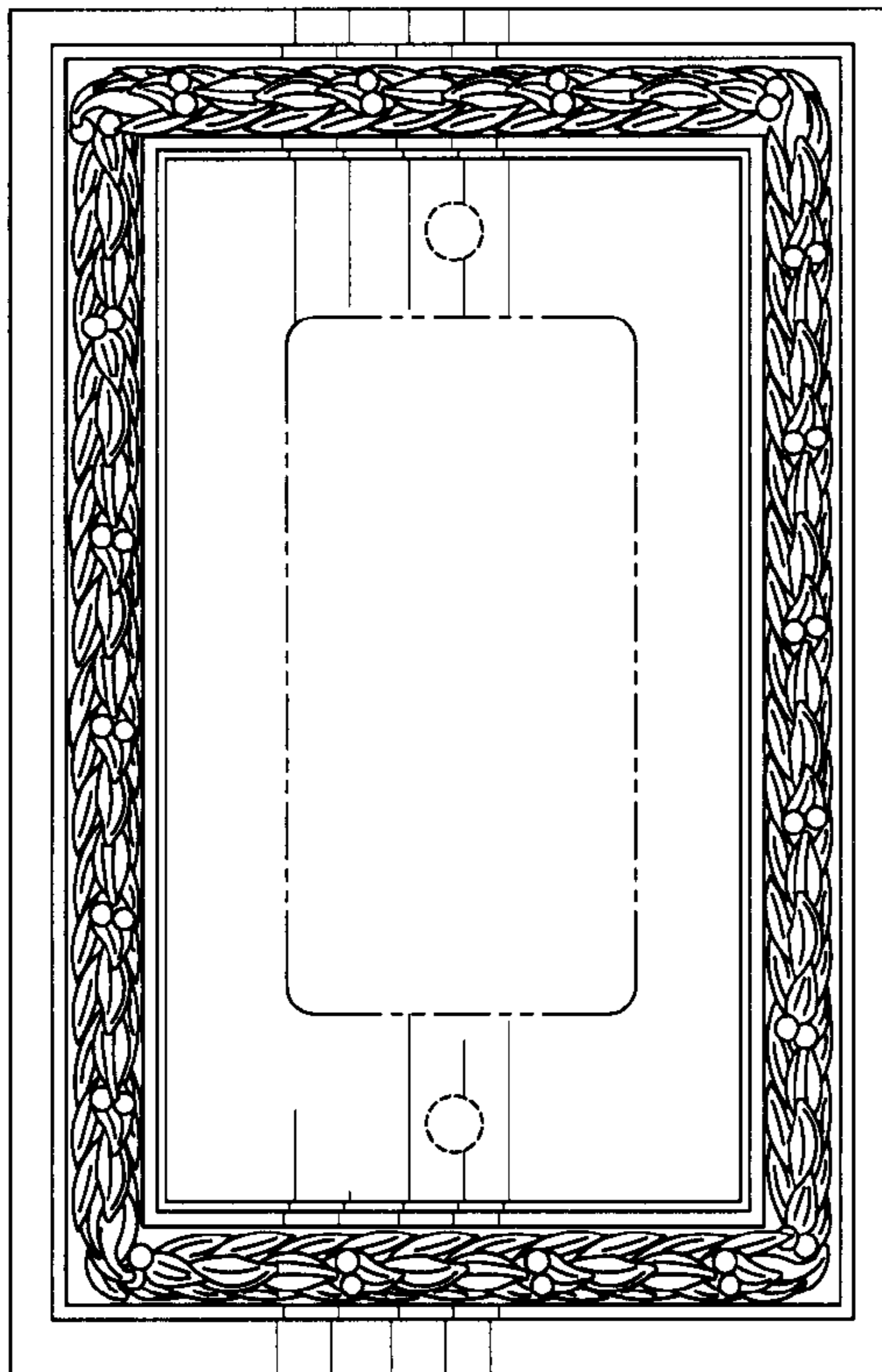
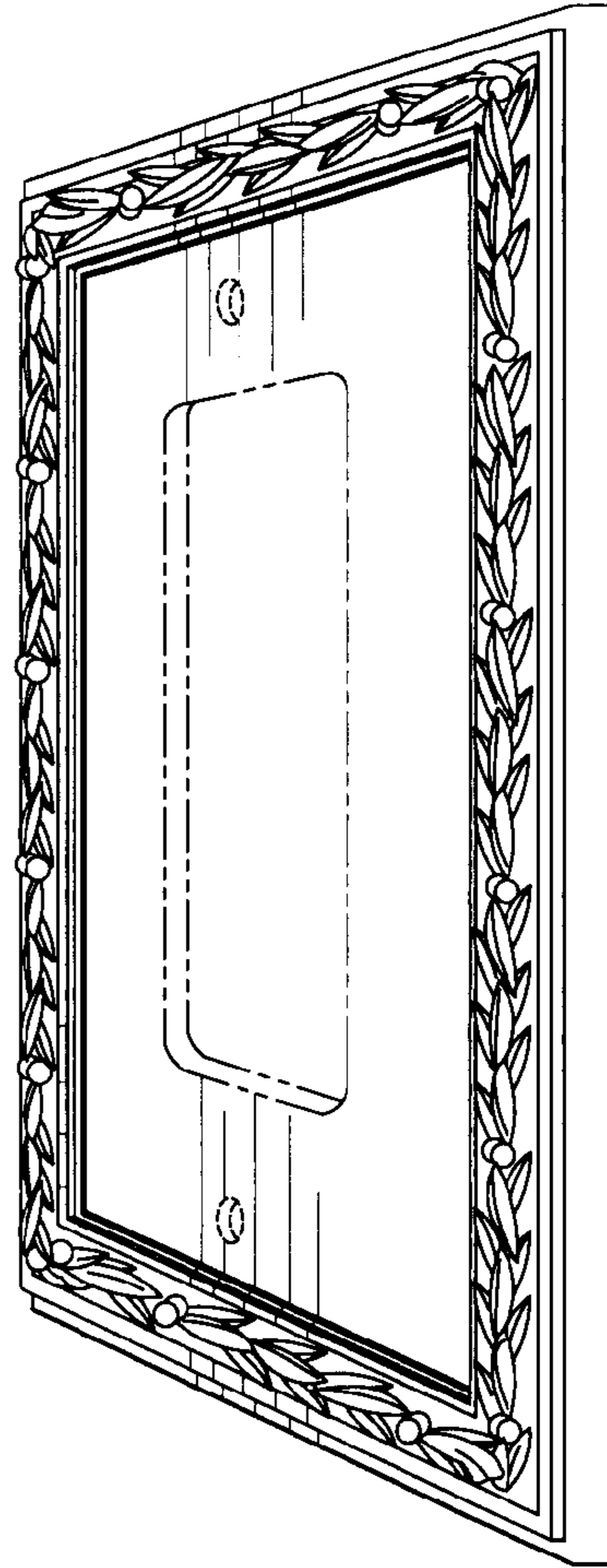

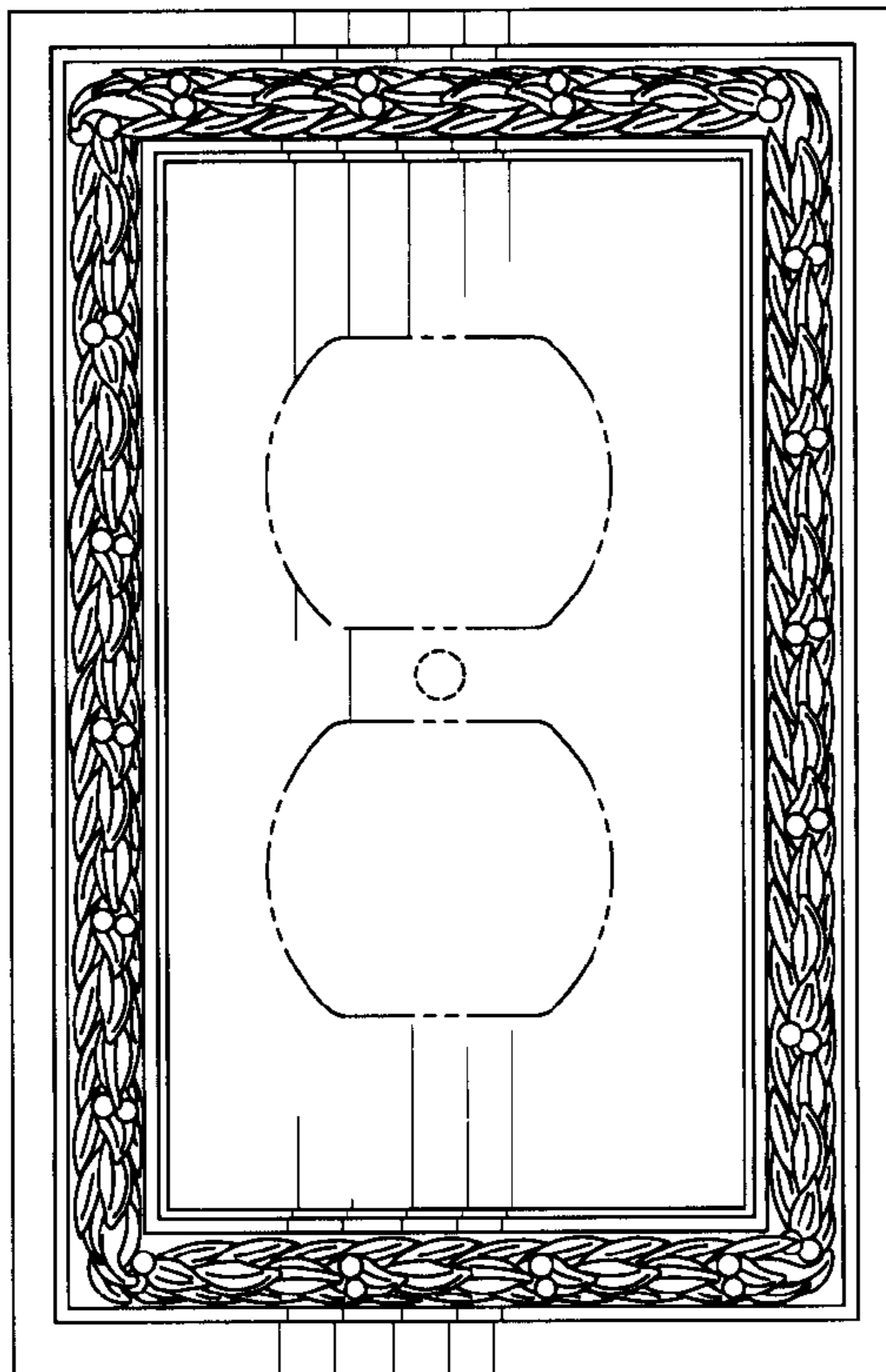
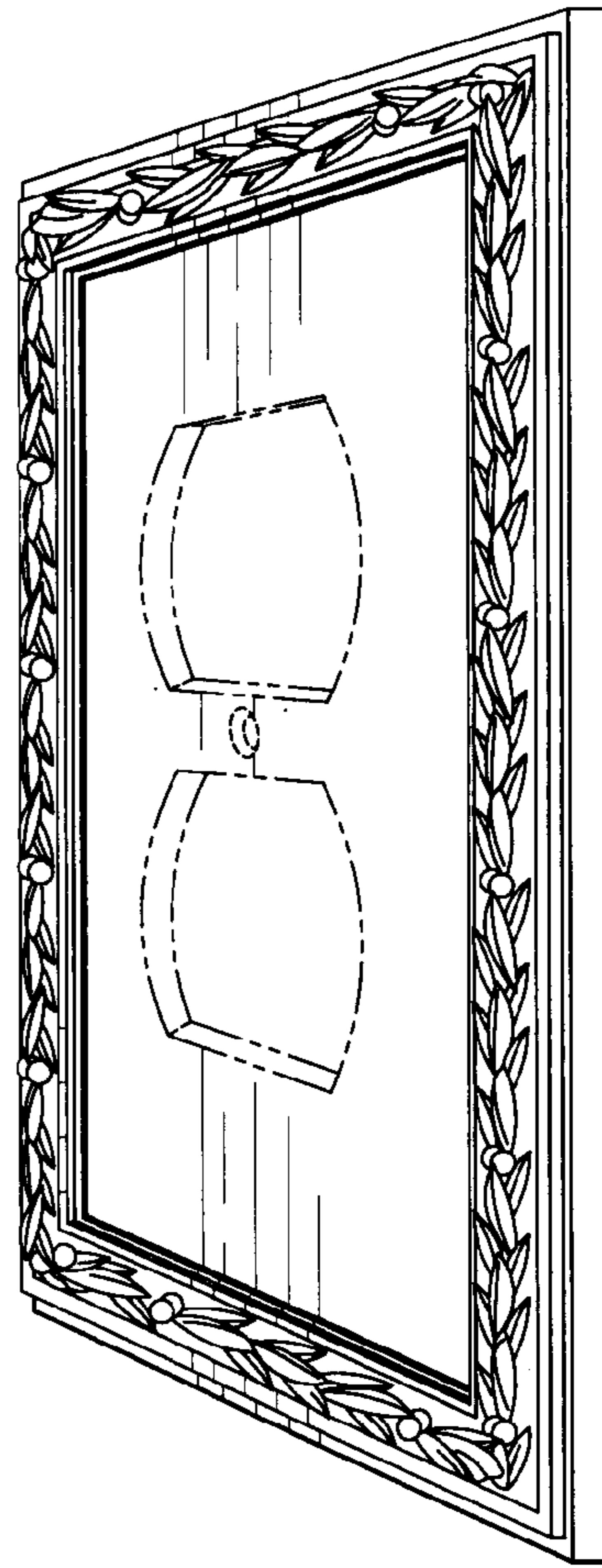
