FIG. 1 is a front isometric view of a closure showing our new design;

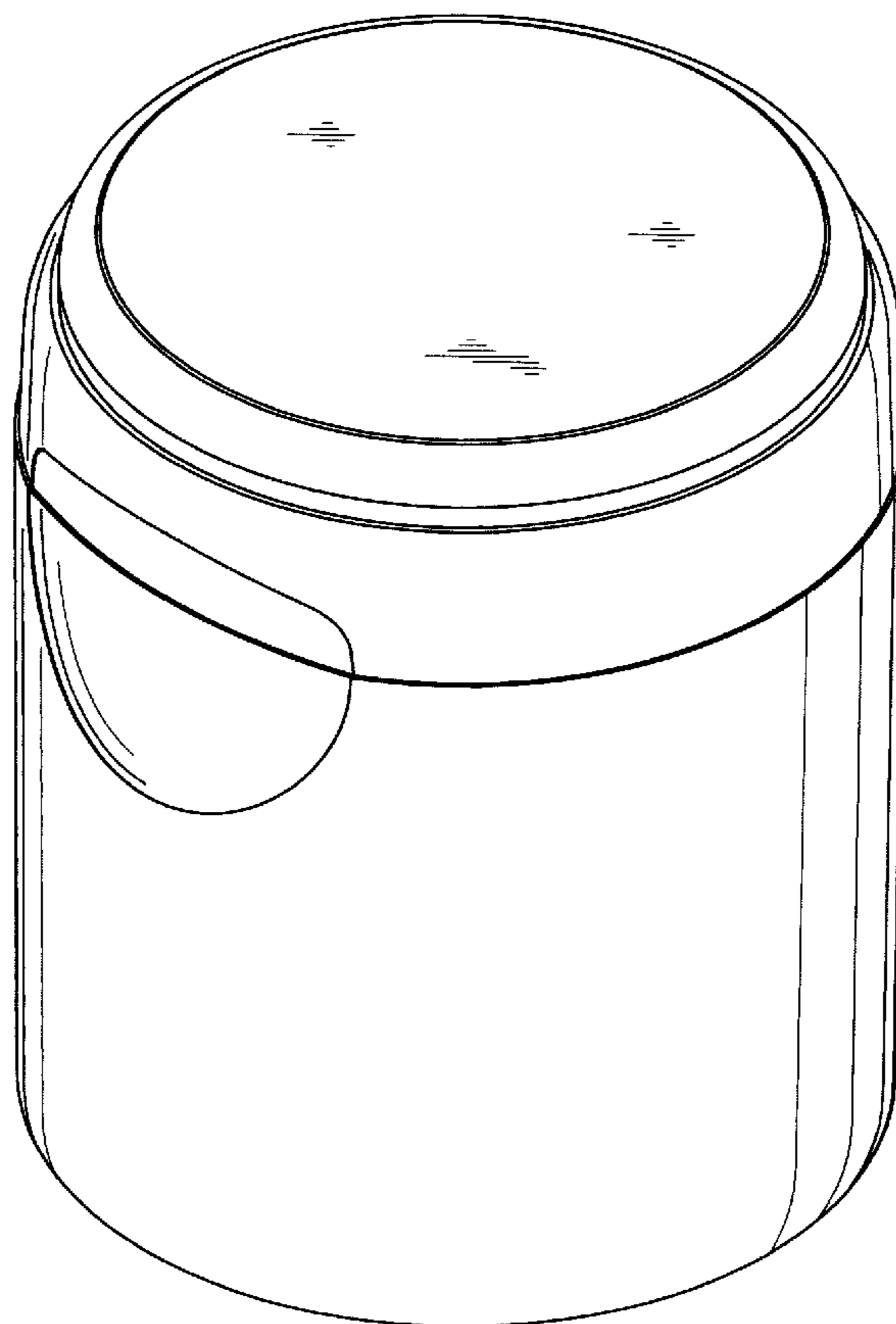
FIG. 2 is a top view thereof;

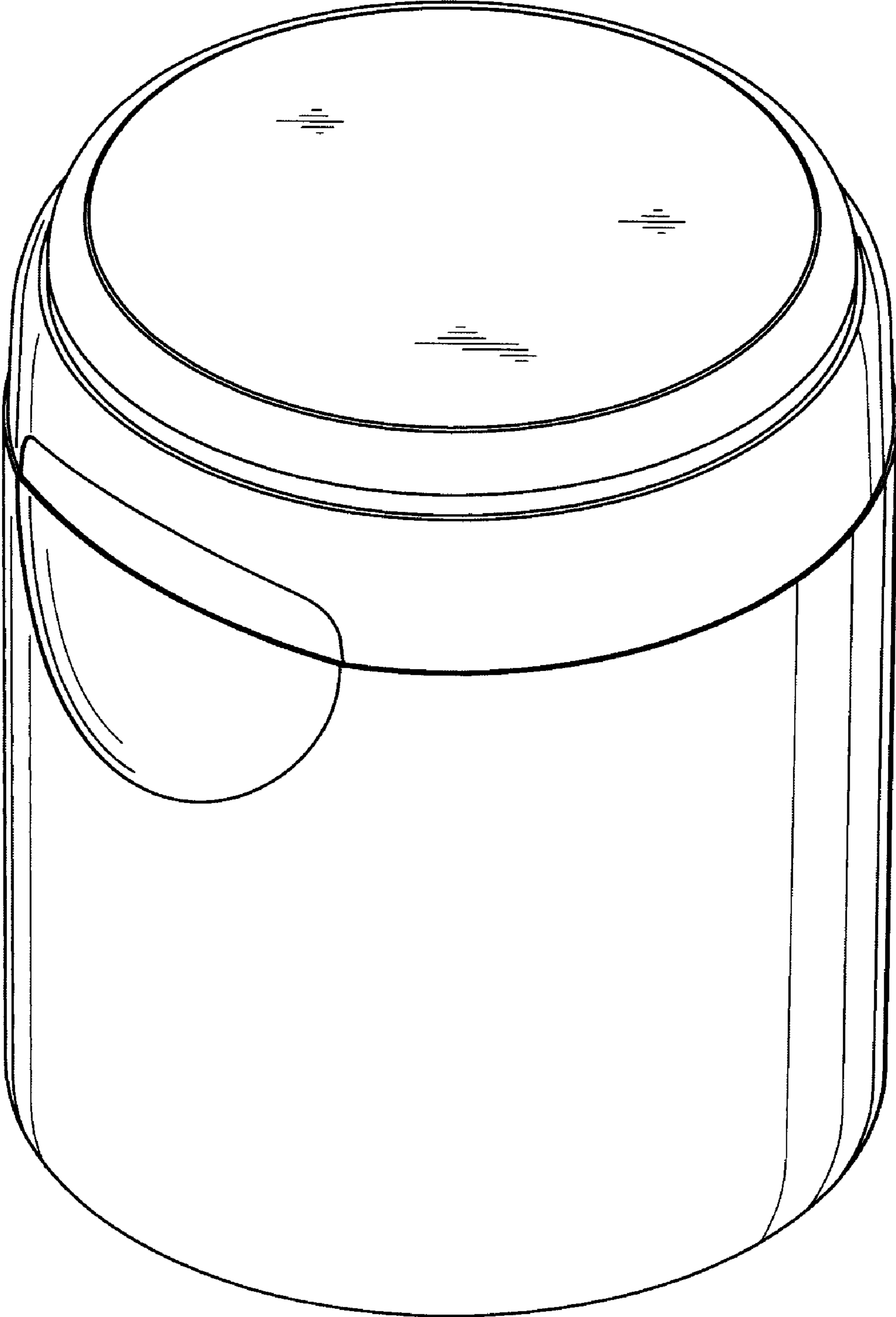

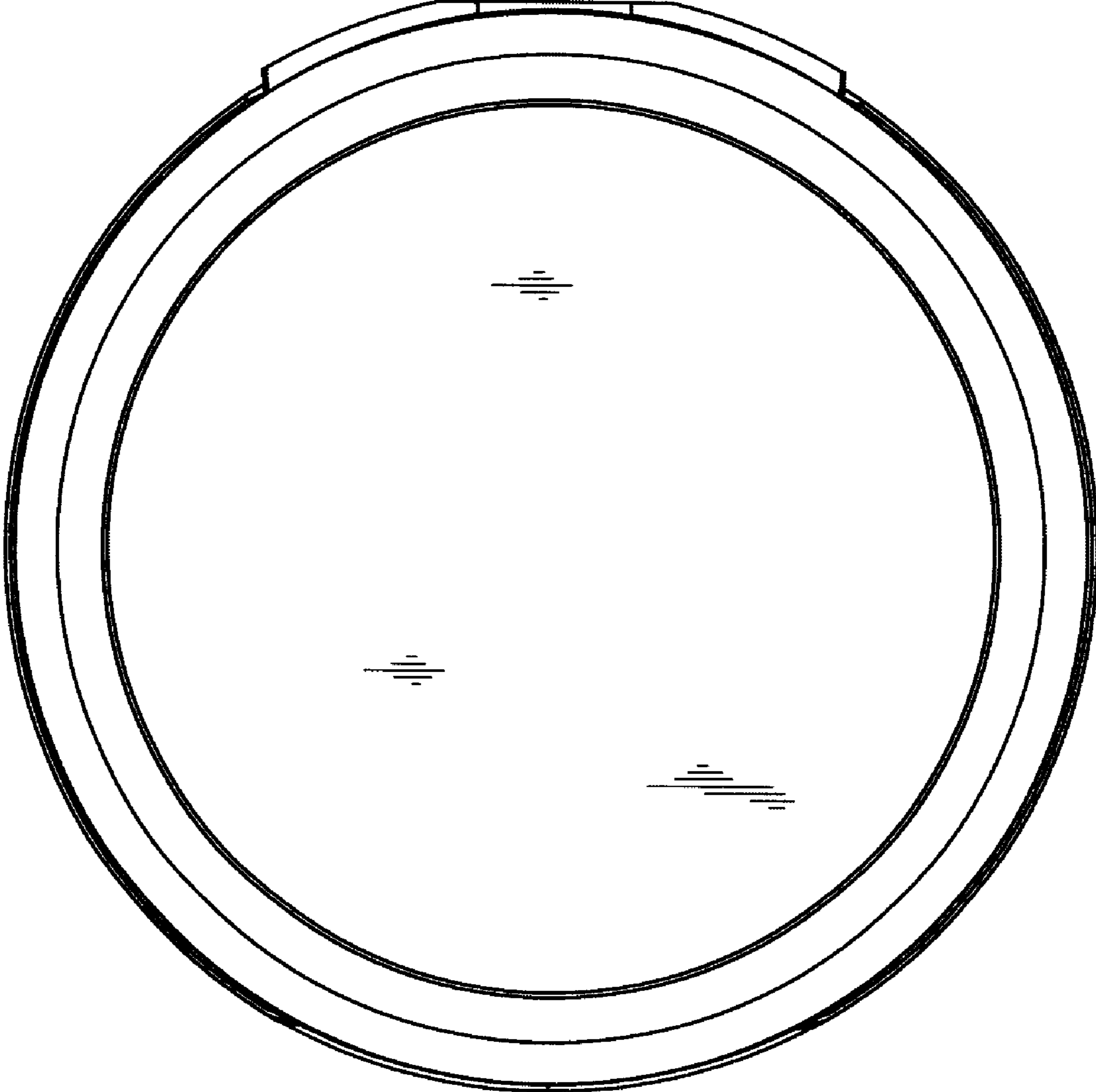

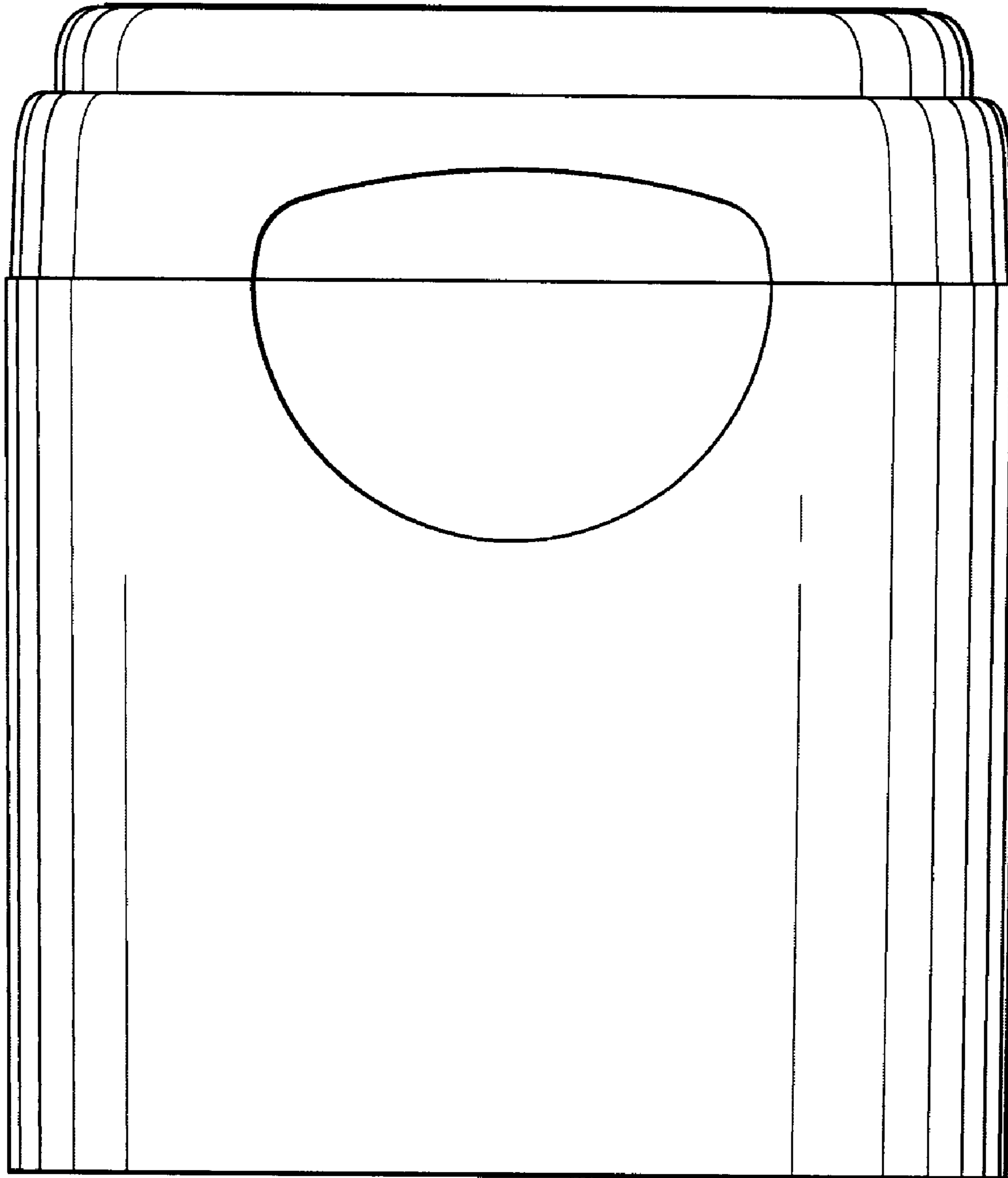

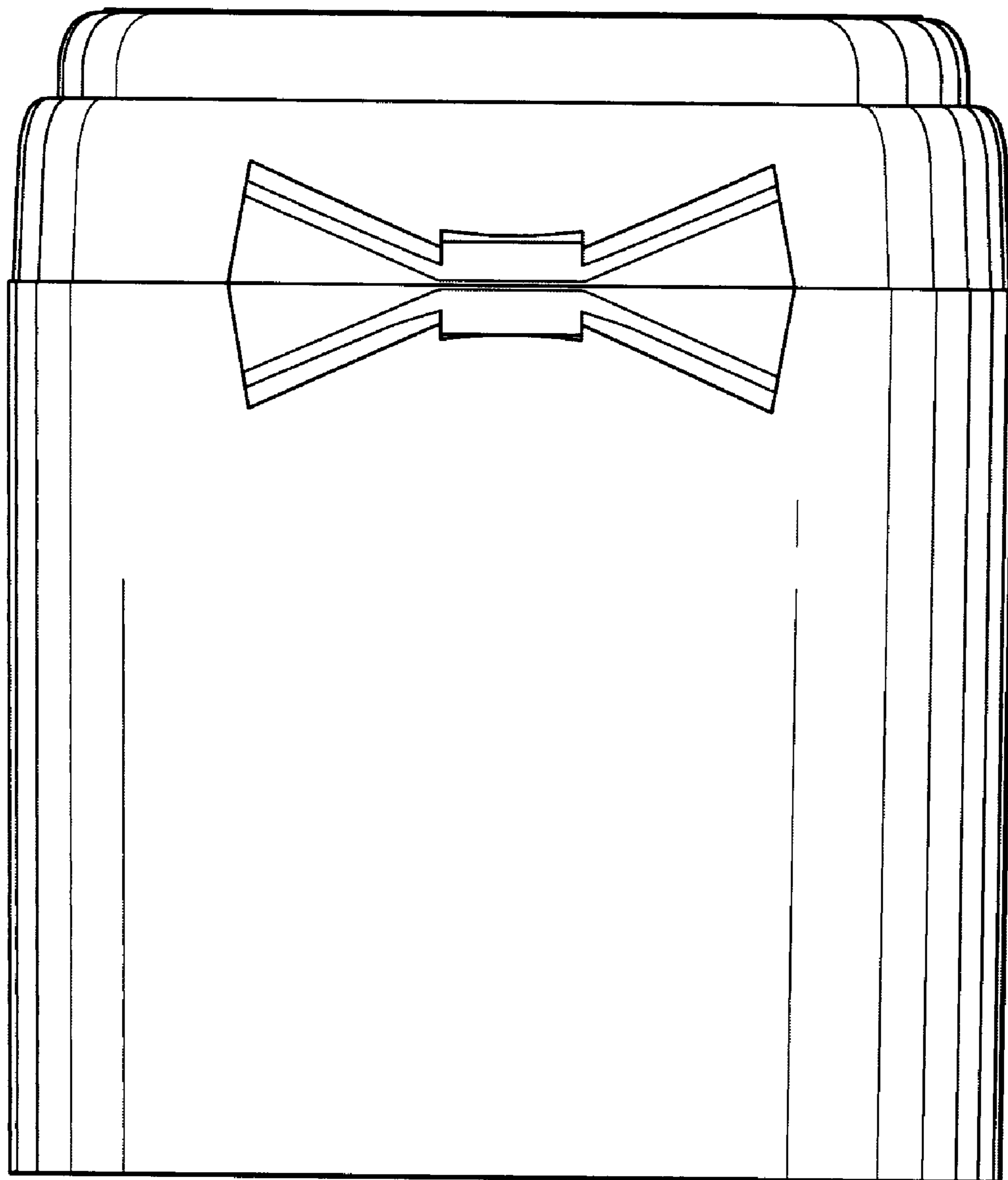

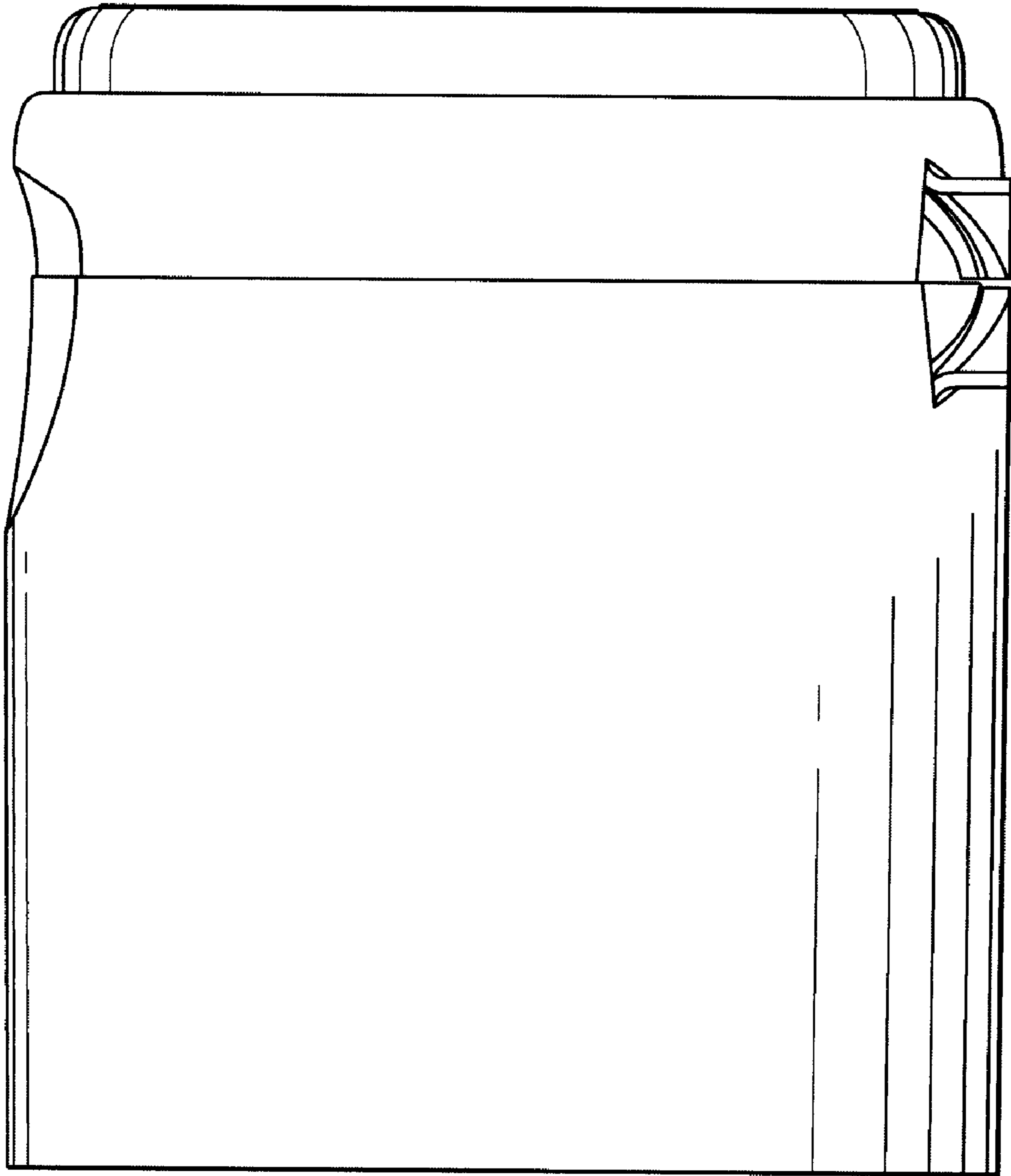
