DESCRIPTION

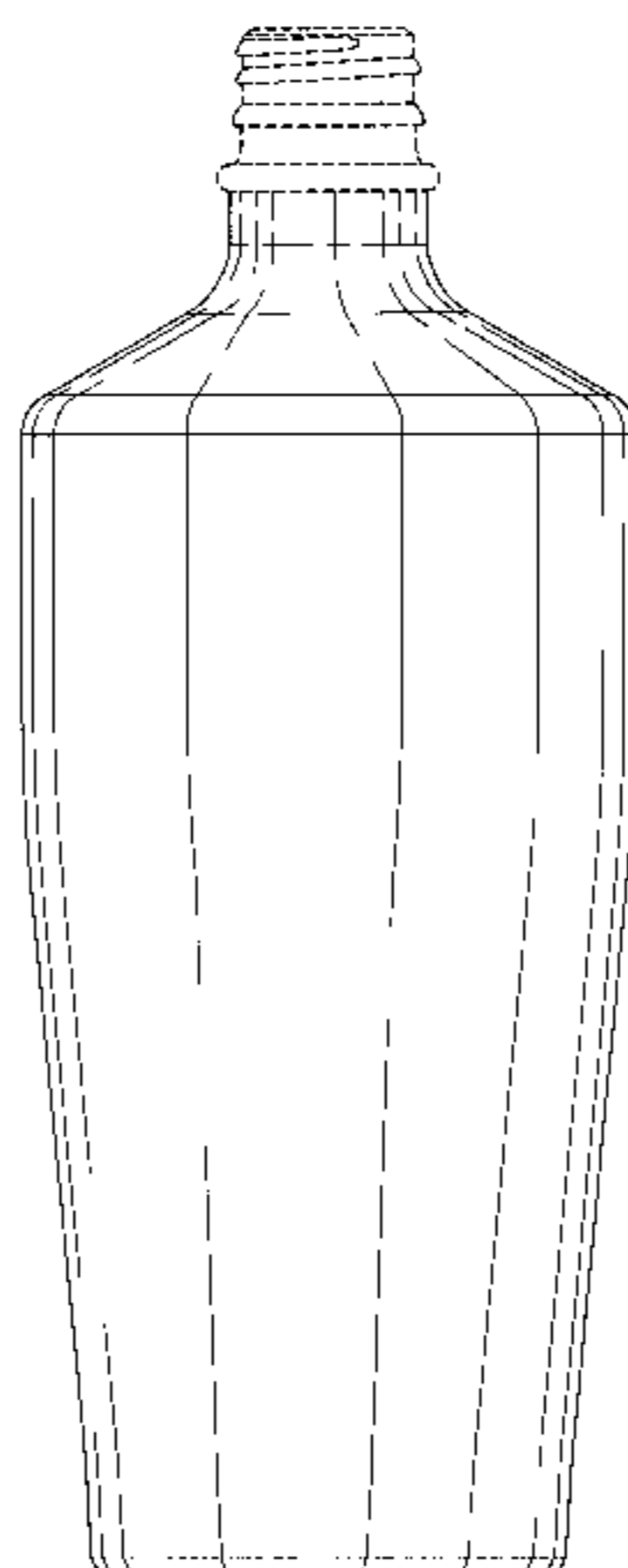
FIG. 1 is a front elevational view of a bottle according to the teachings of the invention;

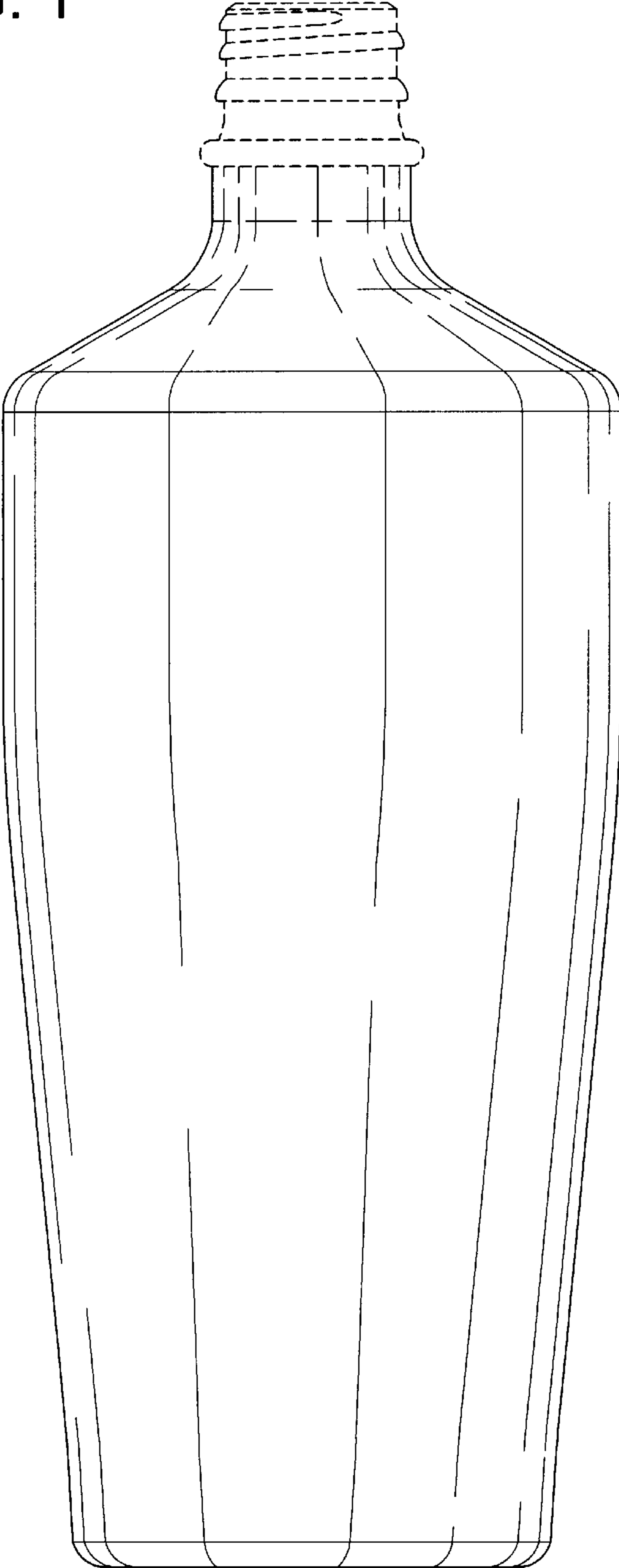

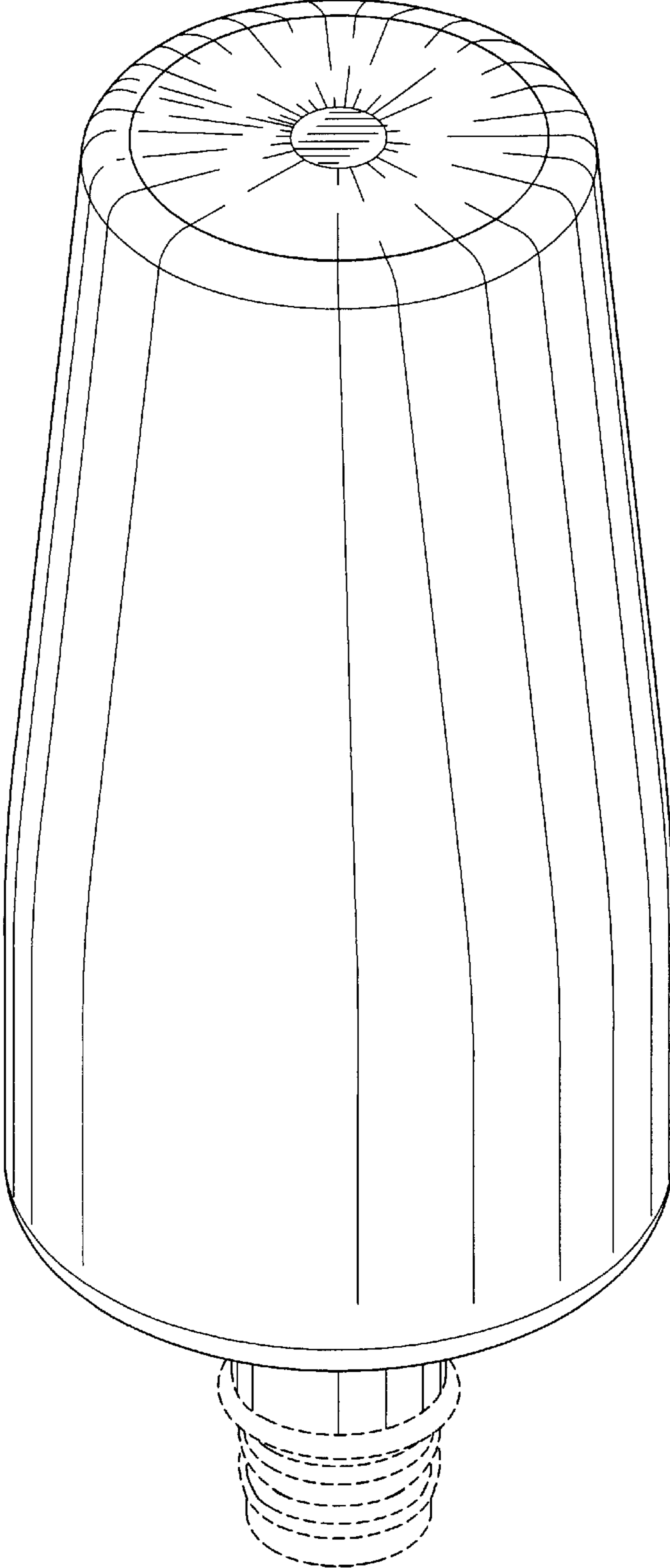

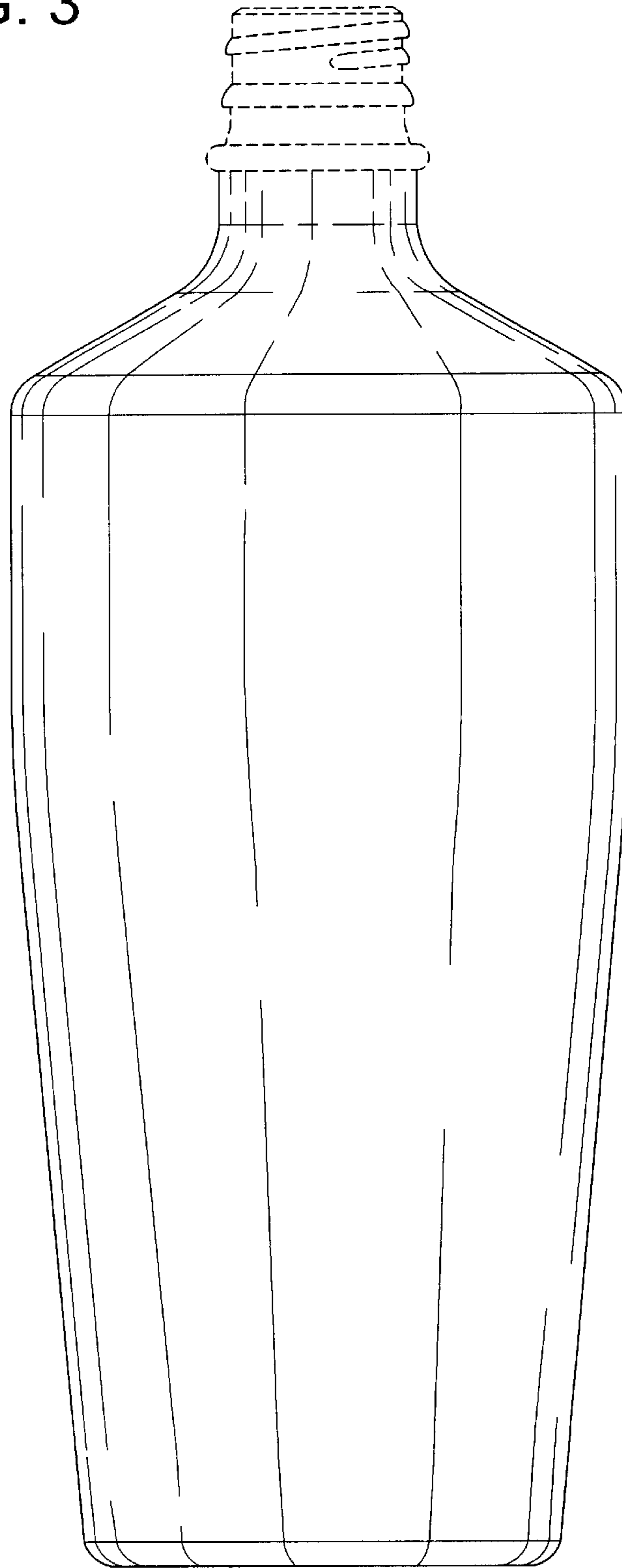

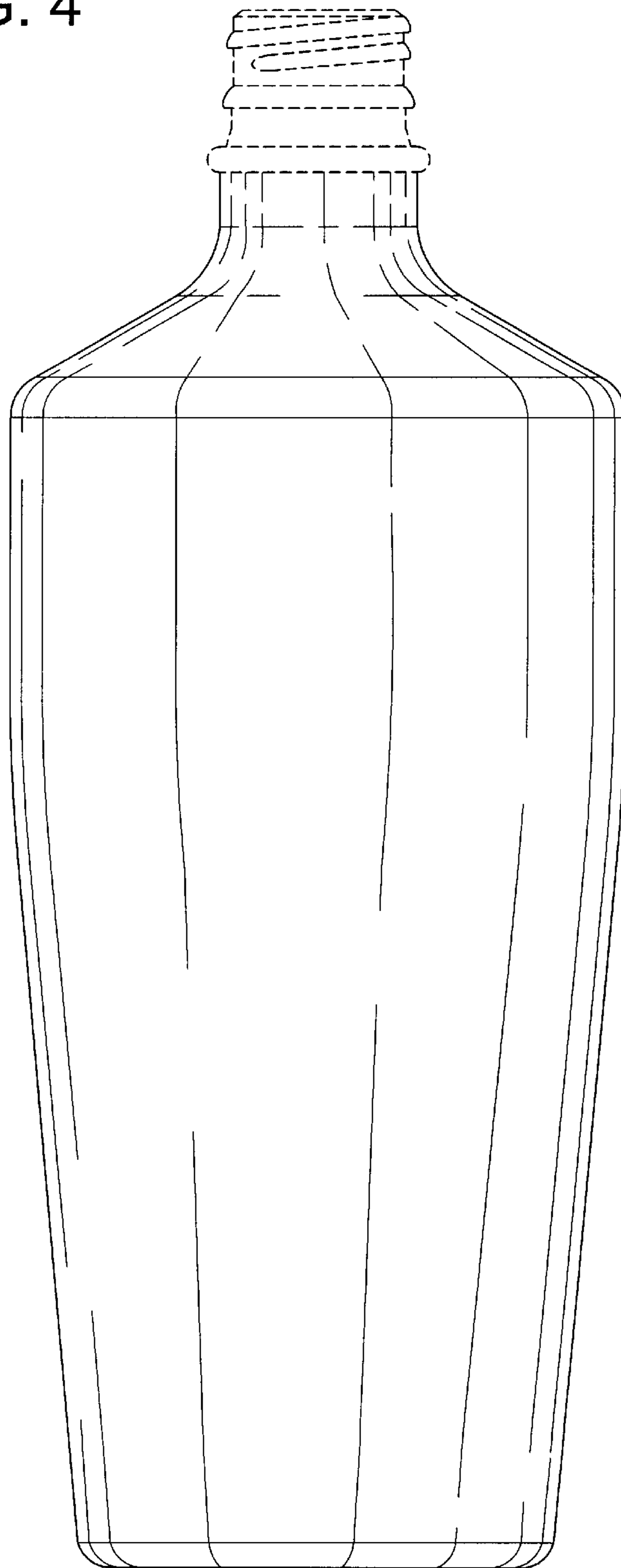

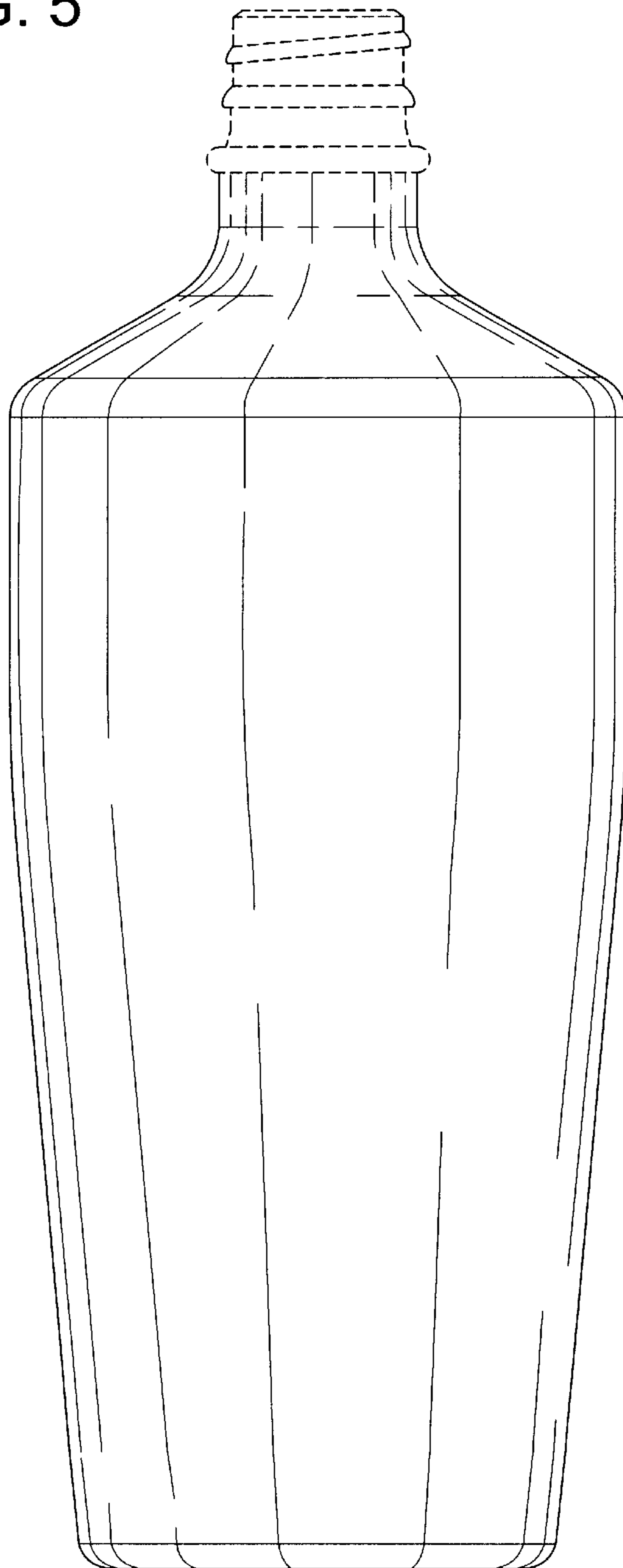

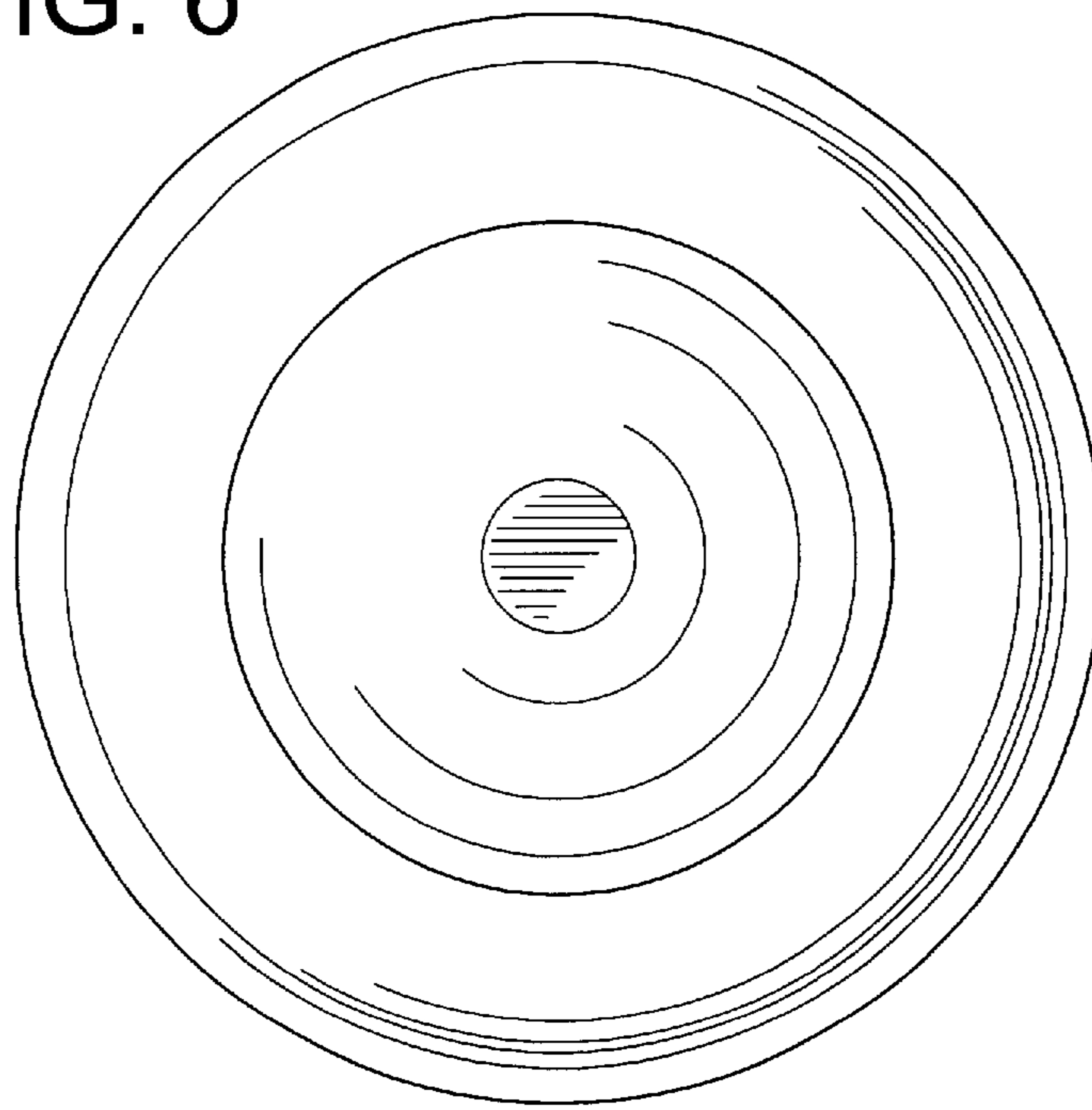
