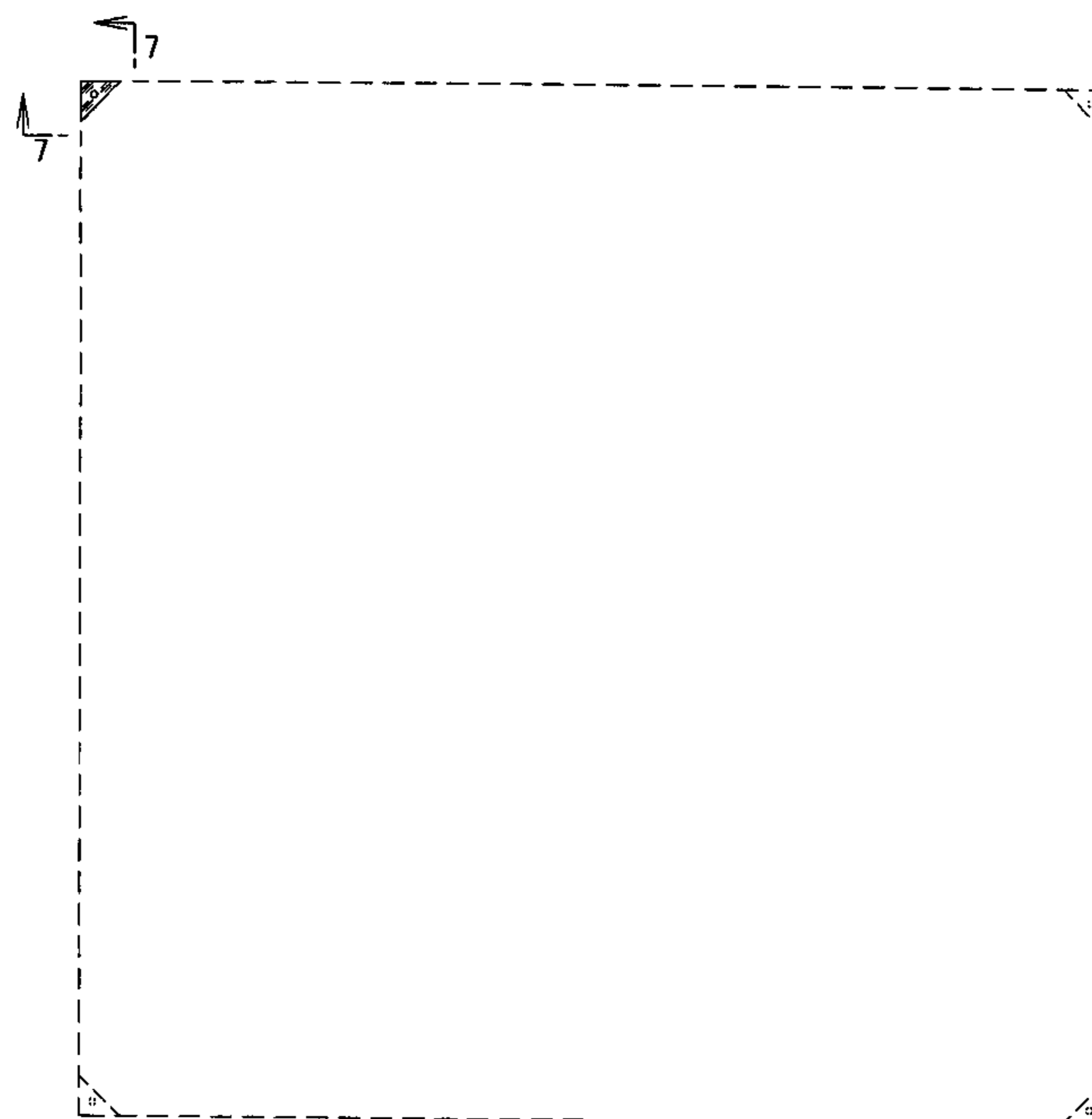
(57) **CLAIM**

The ornamental design for a photomask blank, as shown and
described.

DESCRIPTION

FIG. 1 is a front elevational view of a photomask blank
showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is an enlarged partial front view along line 7—7 in
FIG. 1;
FIG. 8 is a reduced scale front, left side, top perspective view
of the portion shown in FIG. 7; and,
FIG. 9 is a sectional view along line 9—9 in FIG. 7.

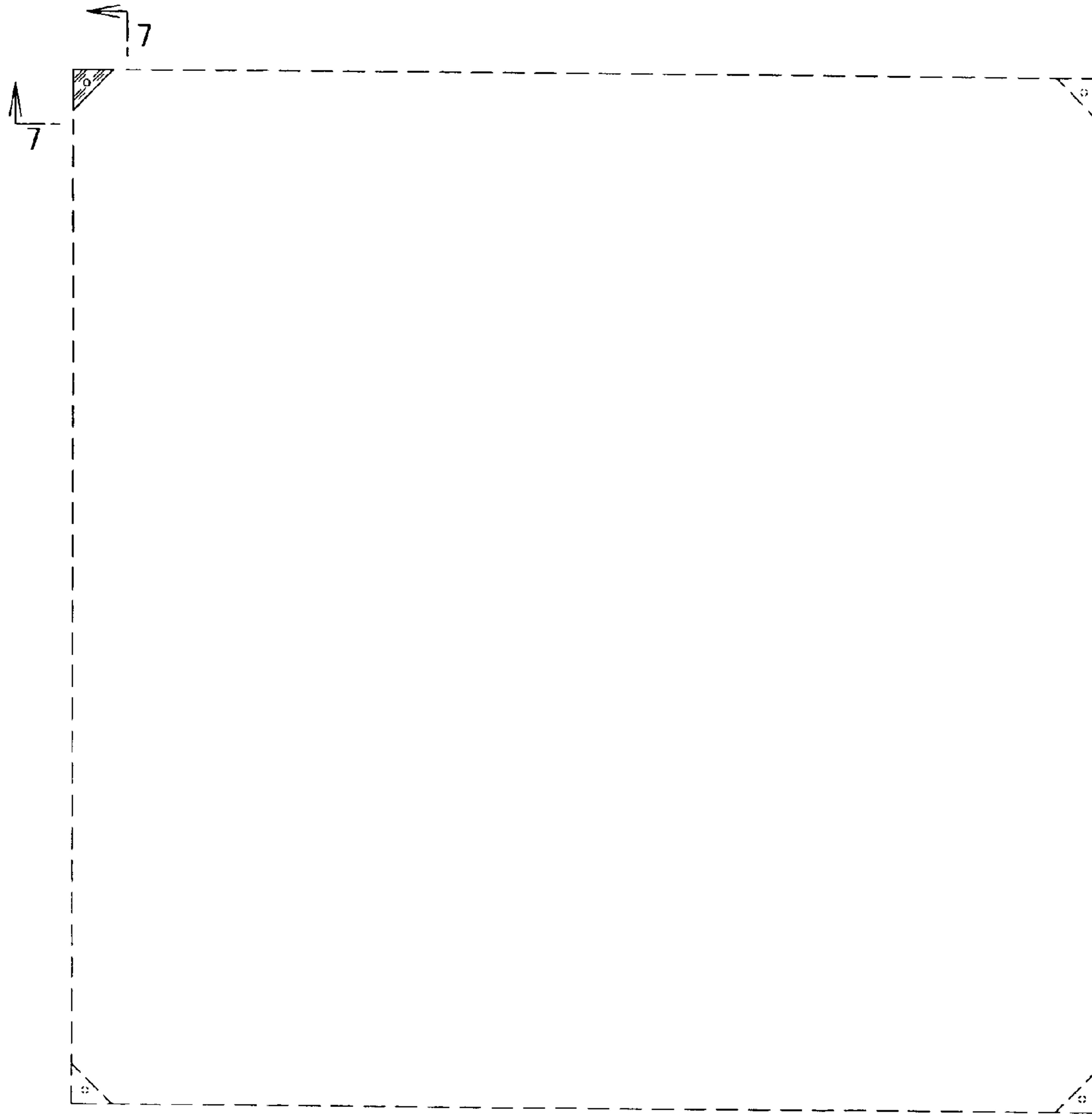

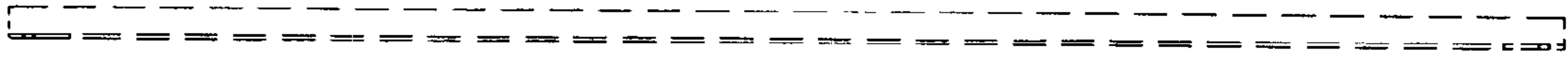

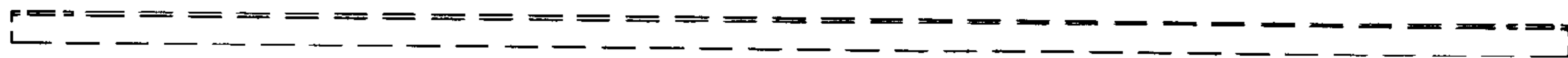

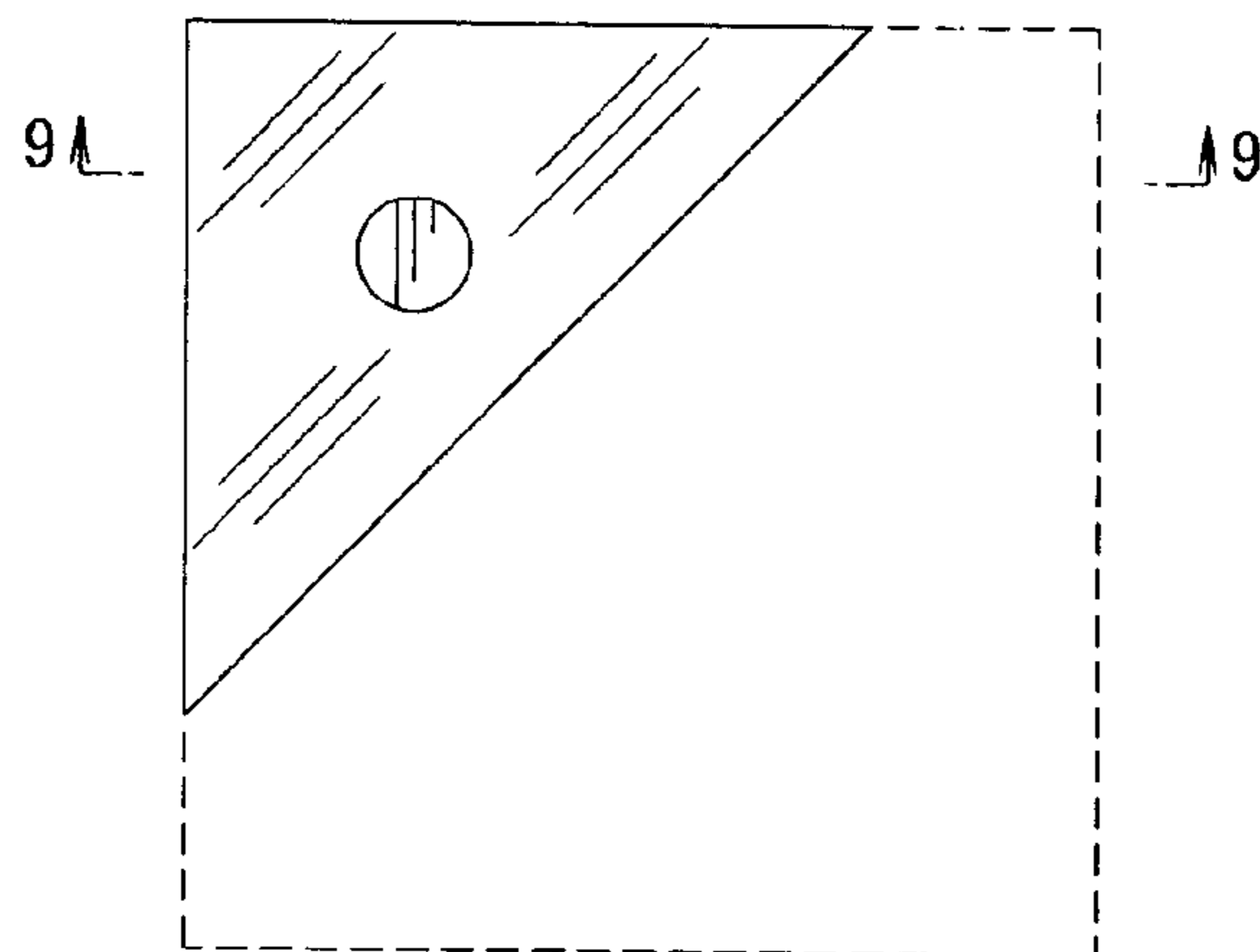

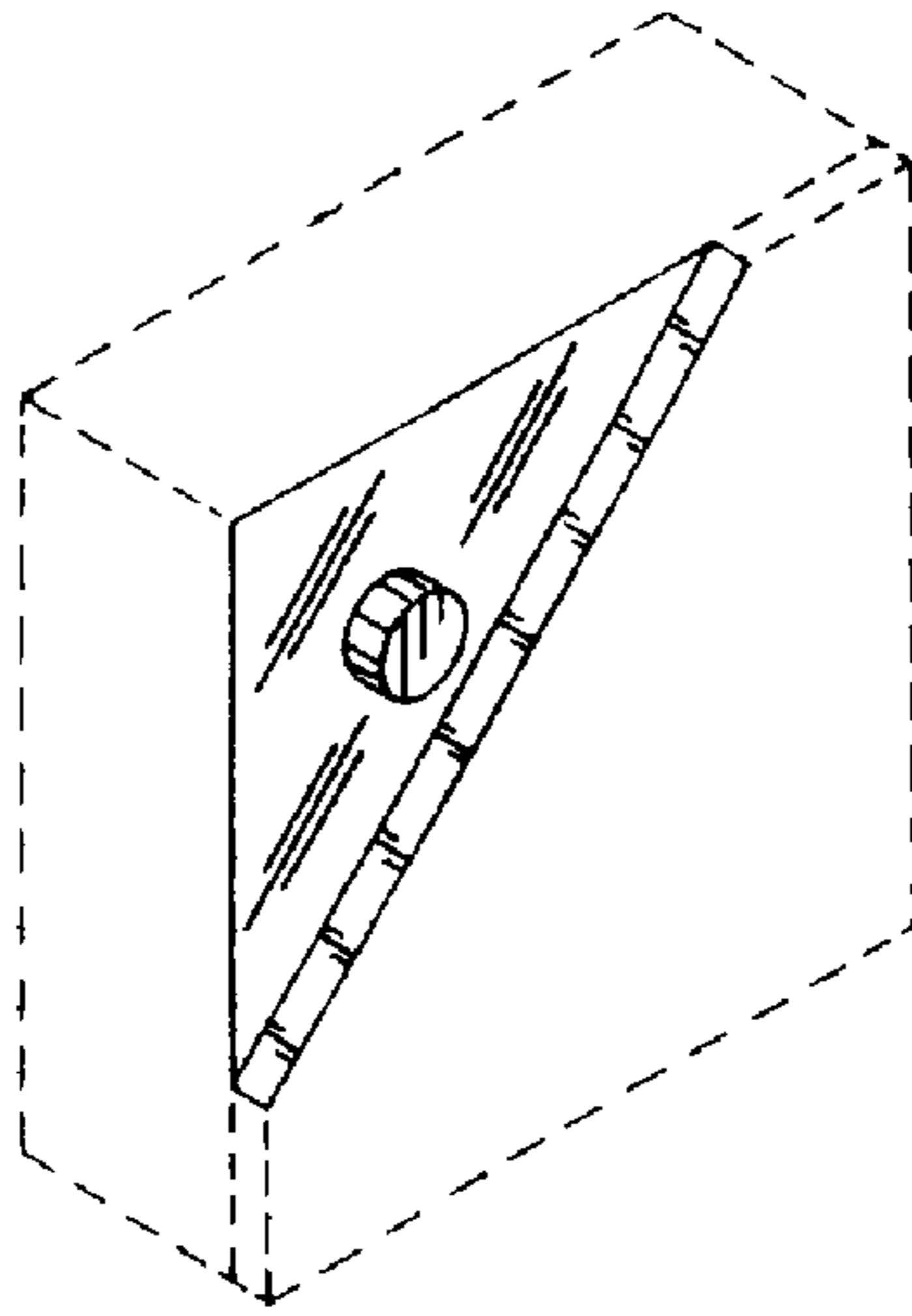

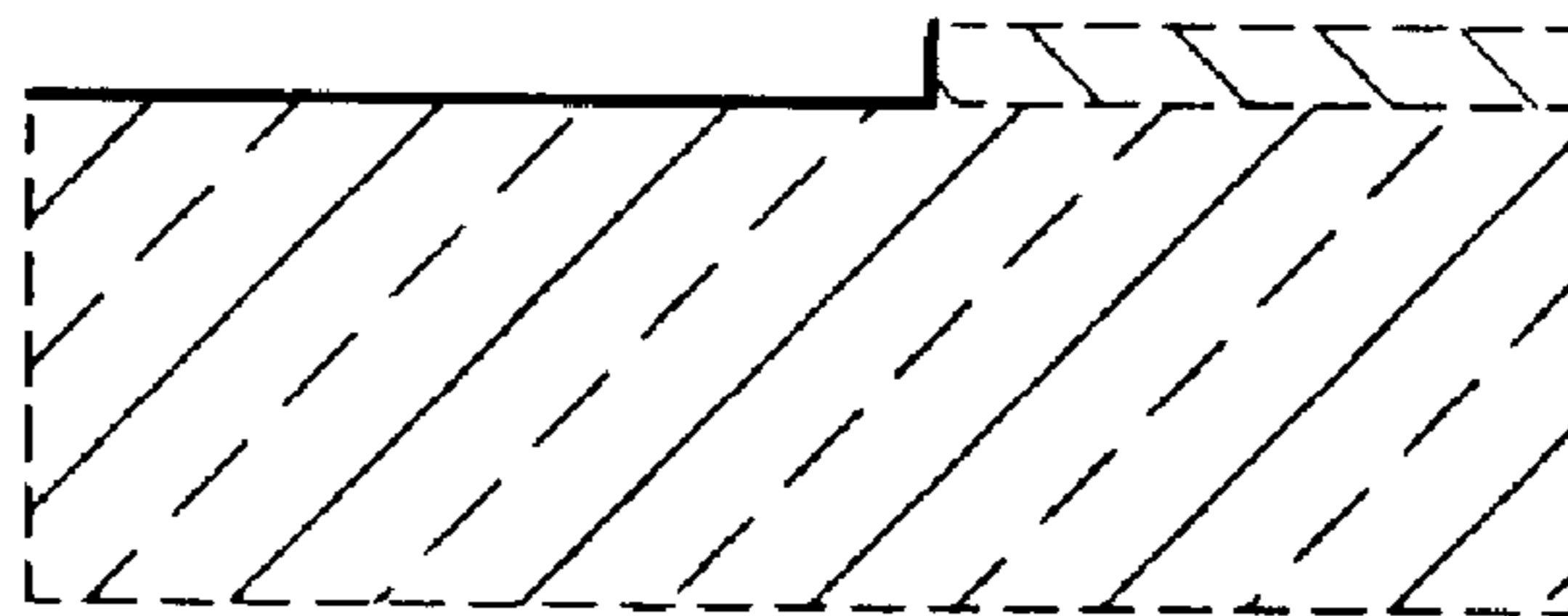
