DESCRIPTION

FIG. 8 is a front, open view thereof;

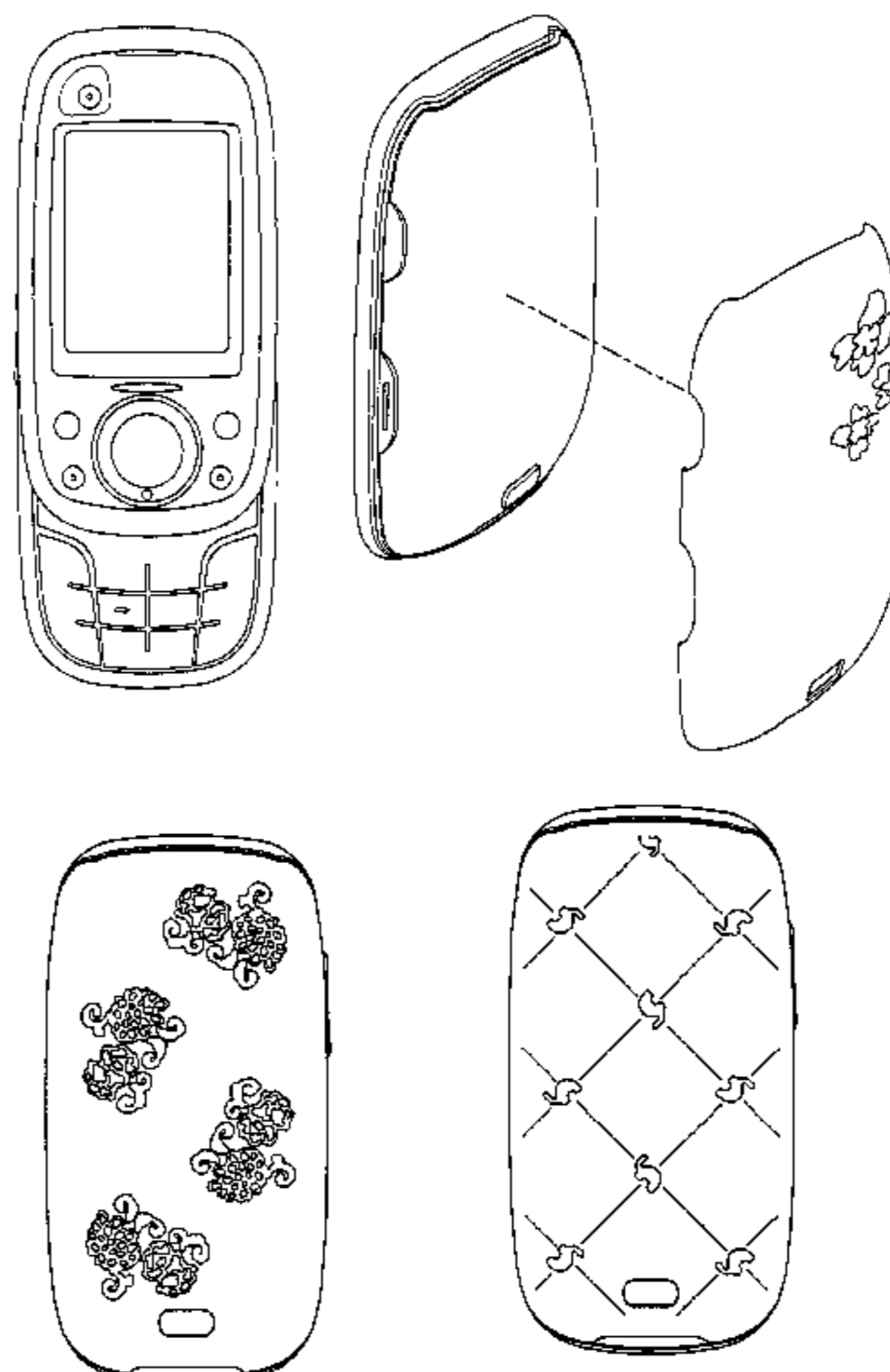
FIG. 9 is a rear, open view thereof;

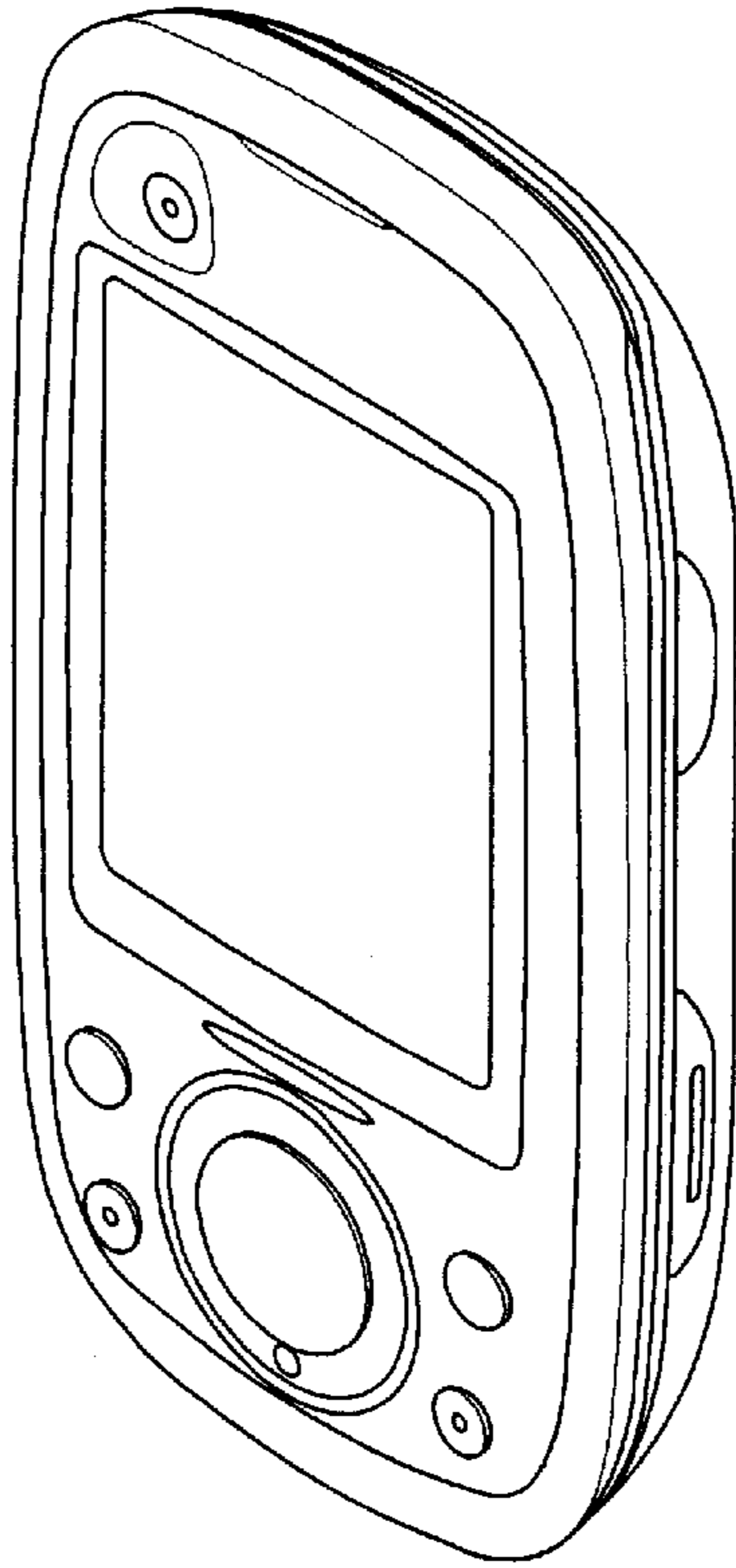

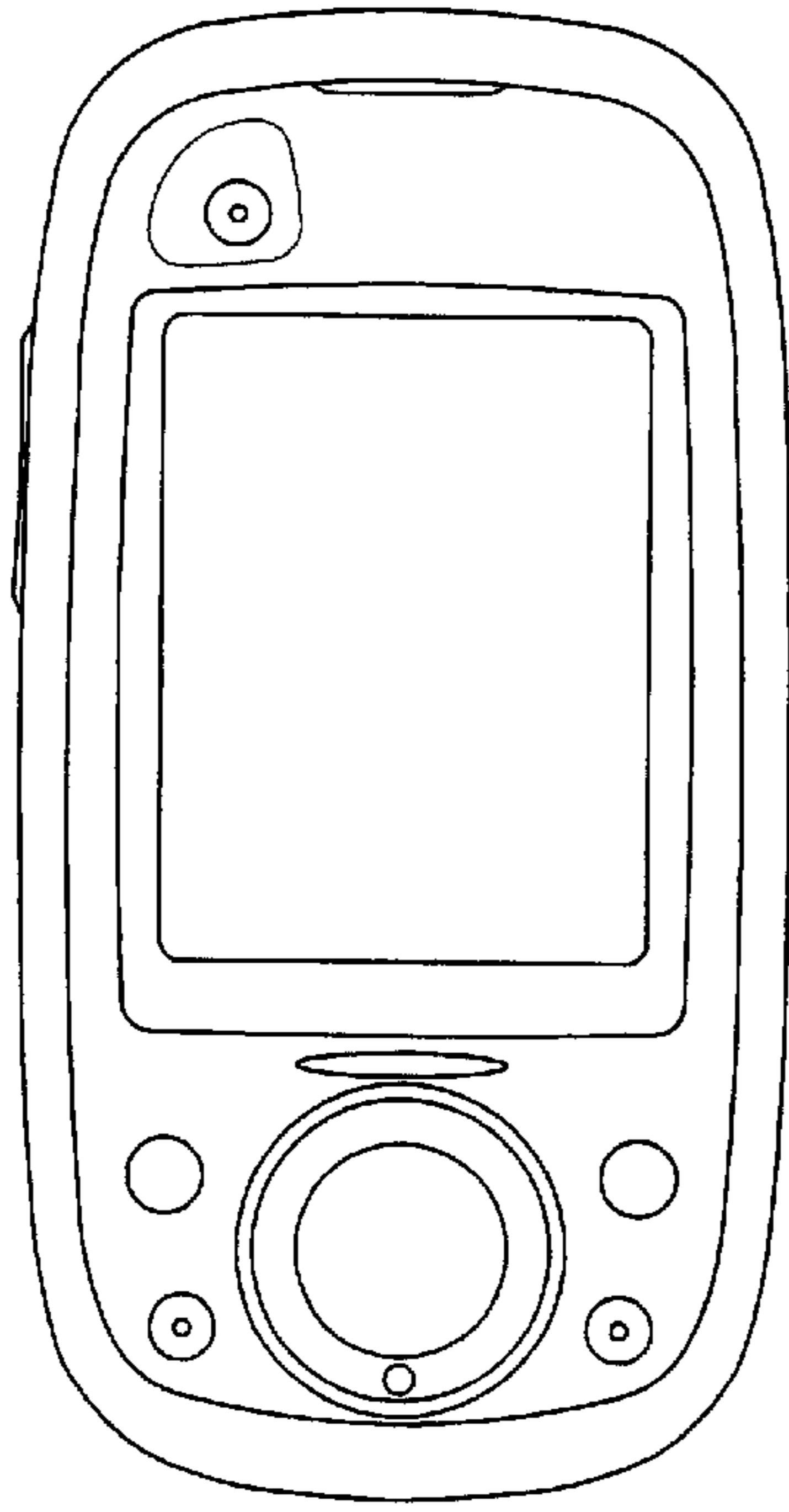

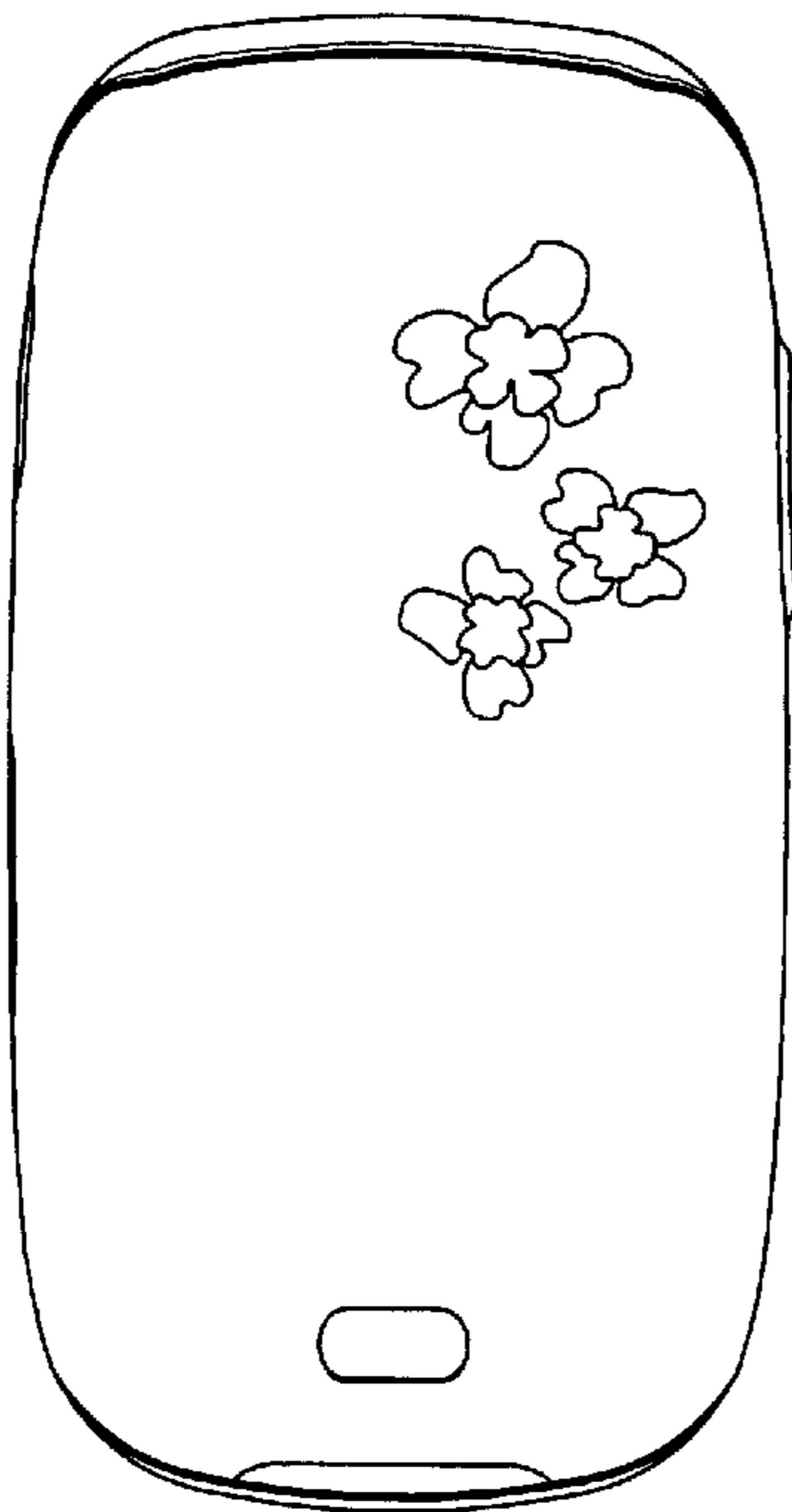

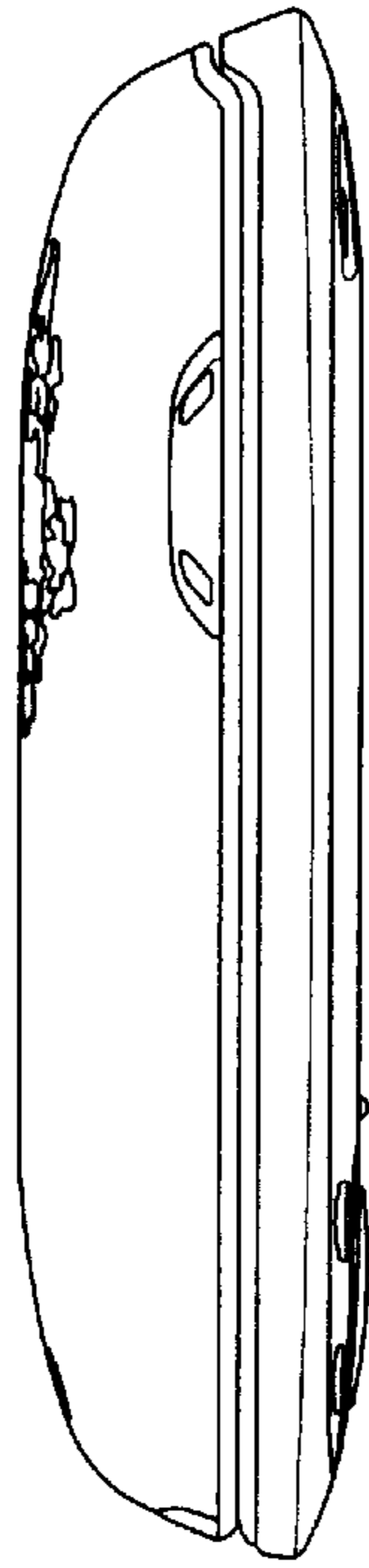

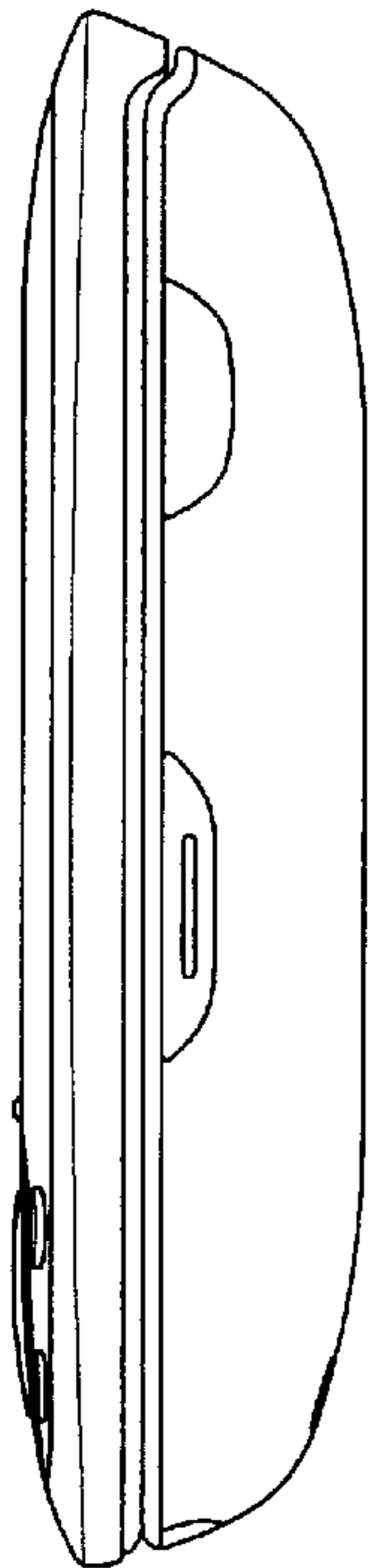

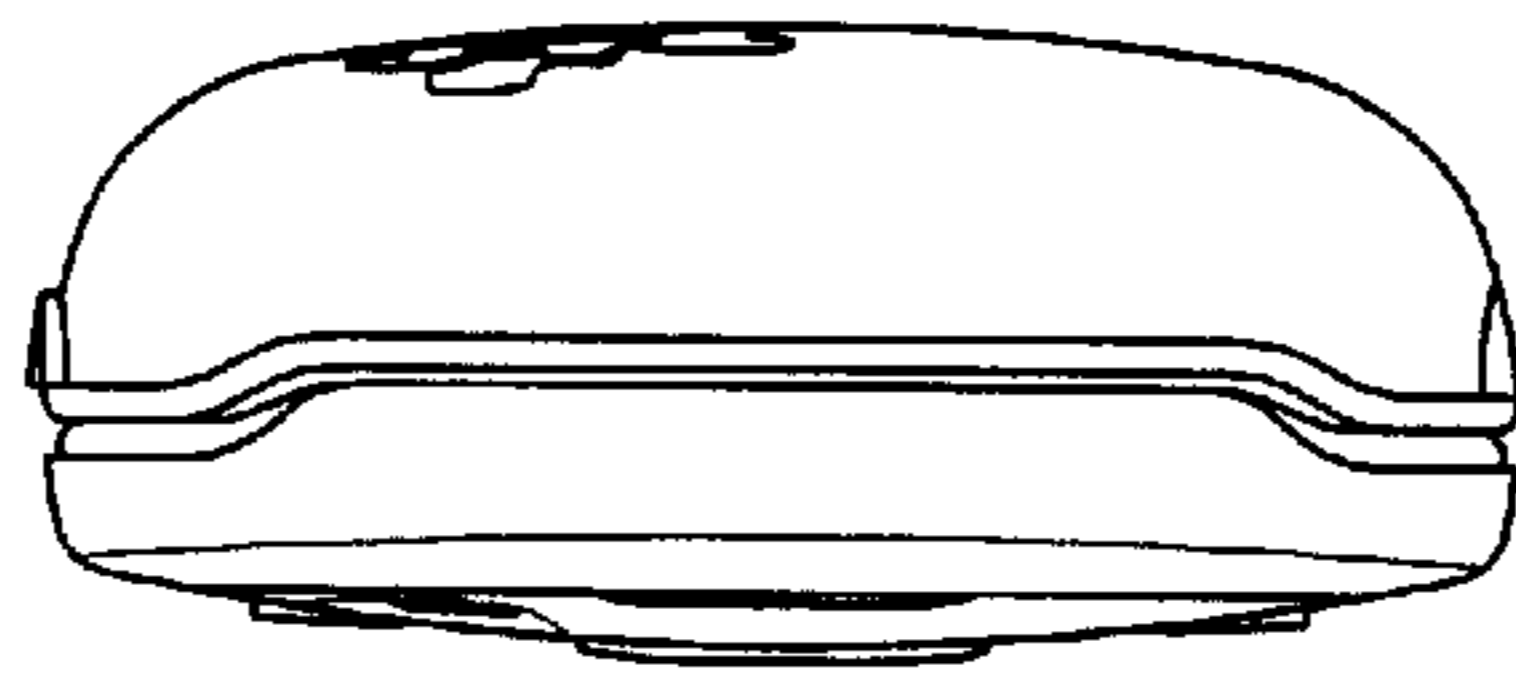

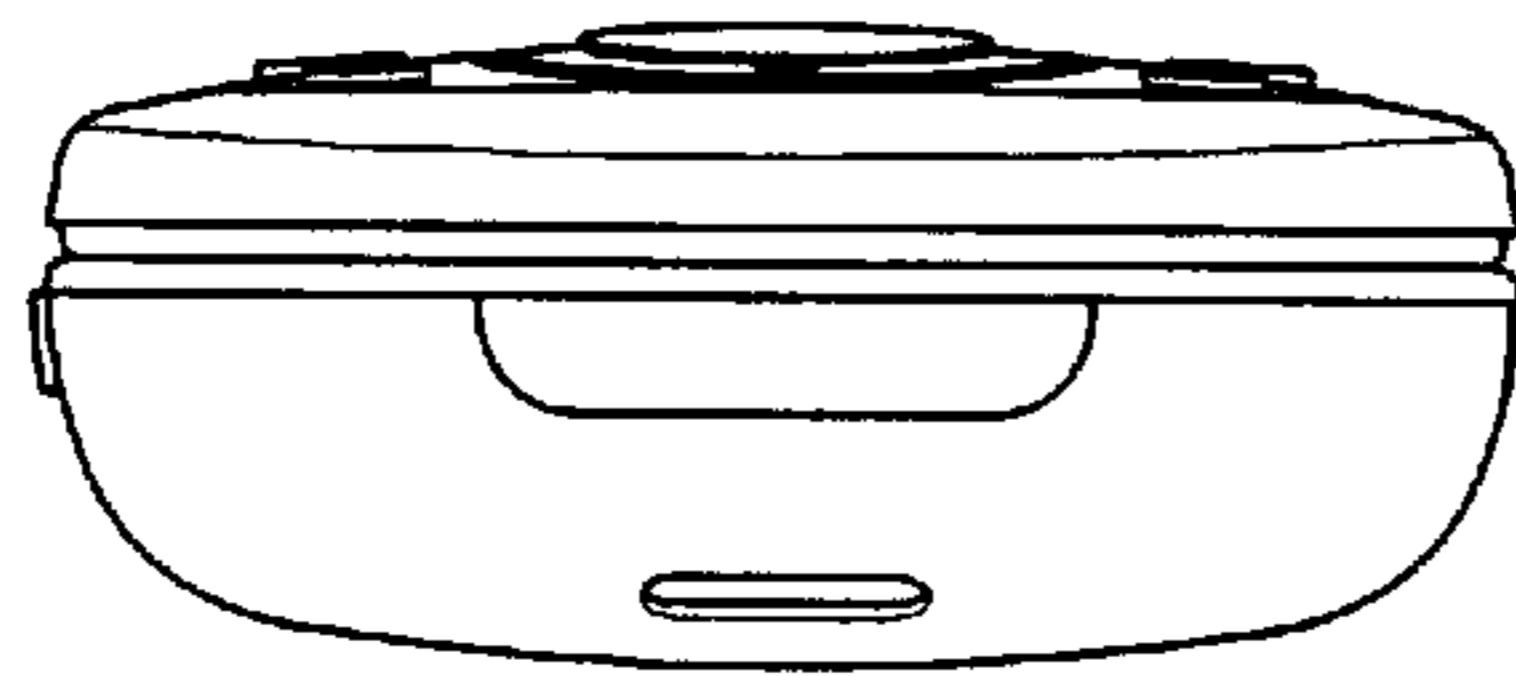

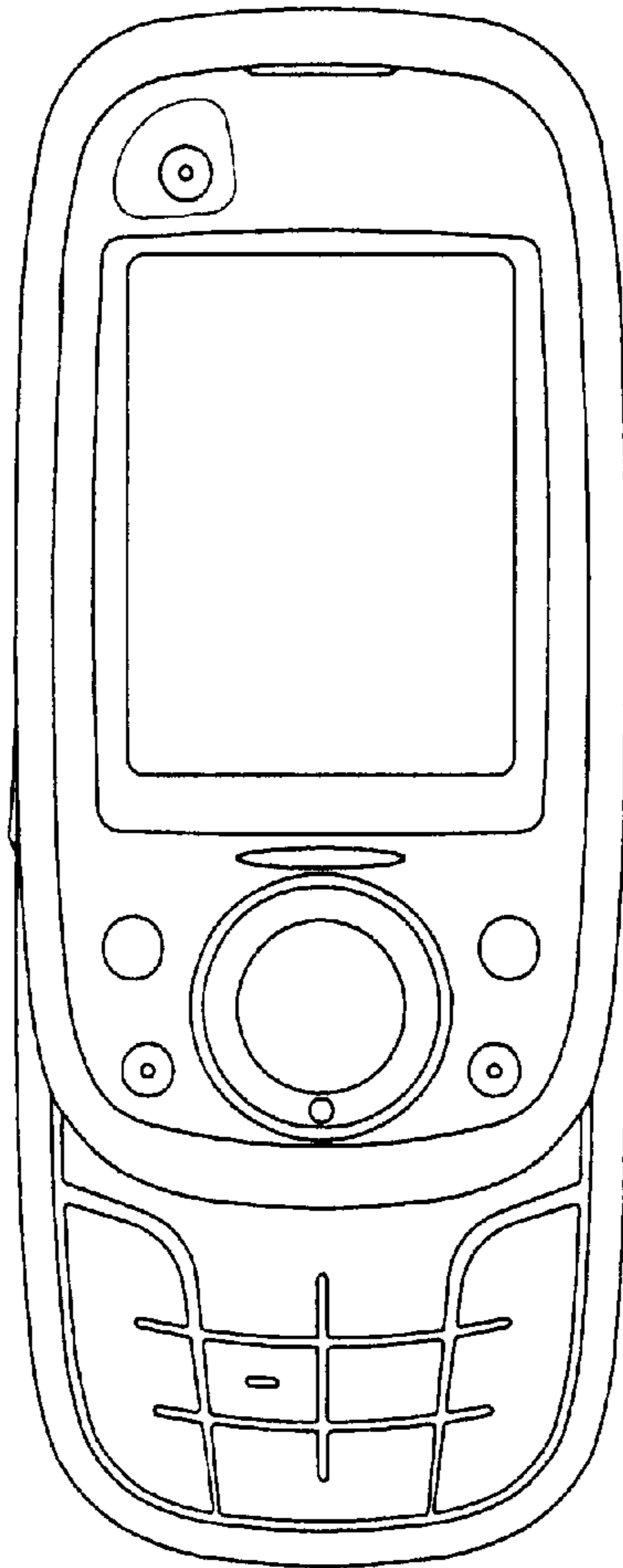

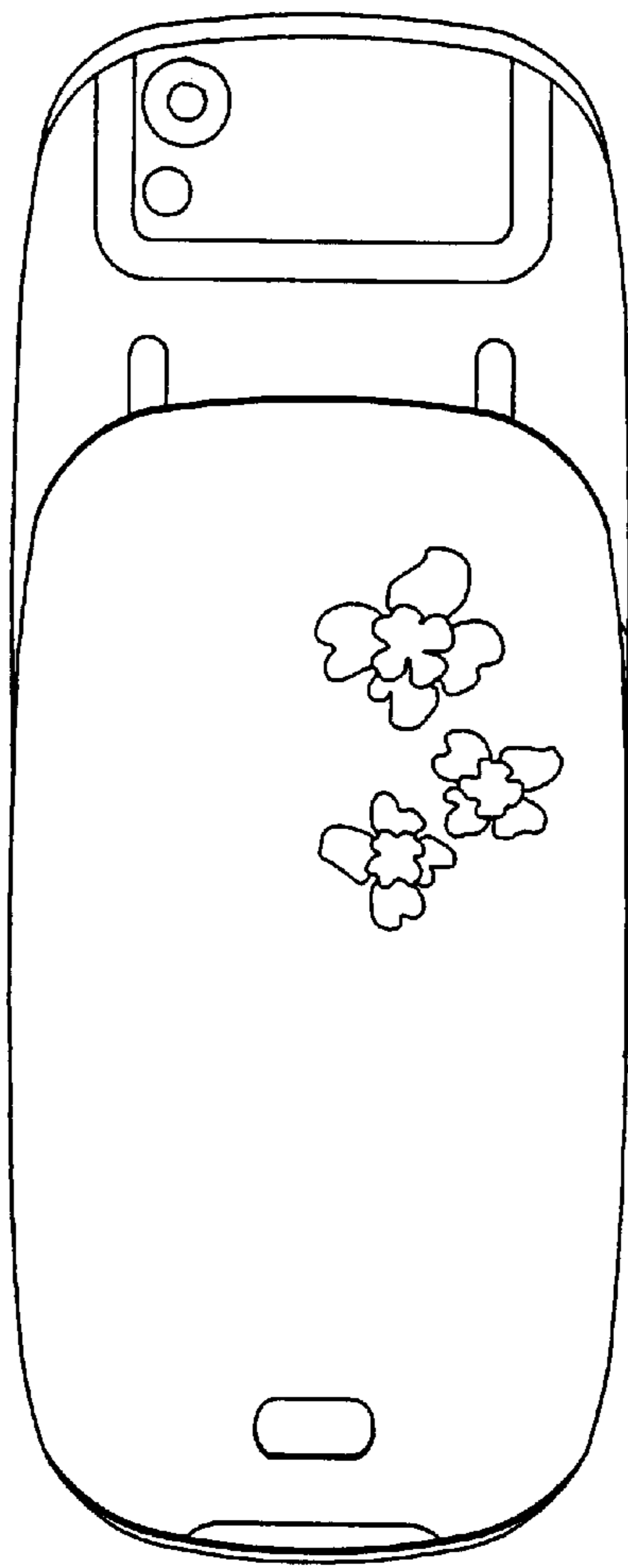

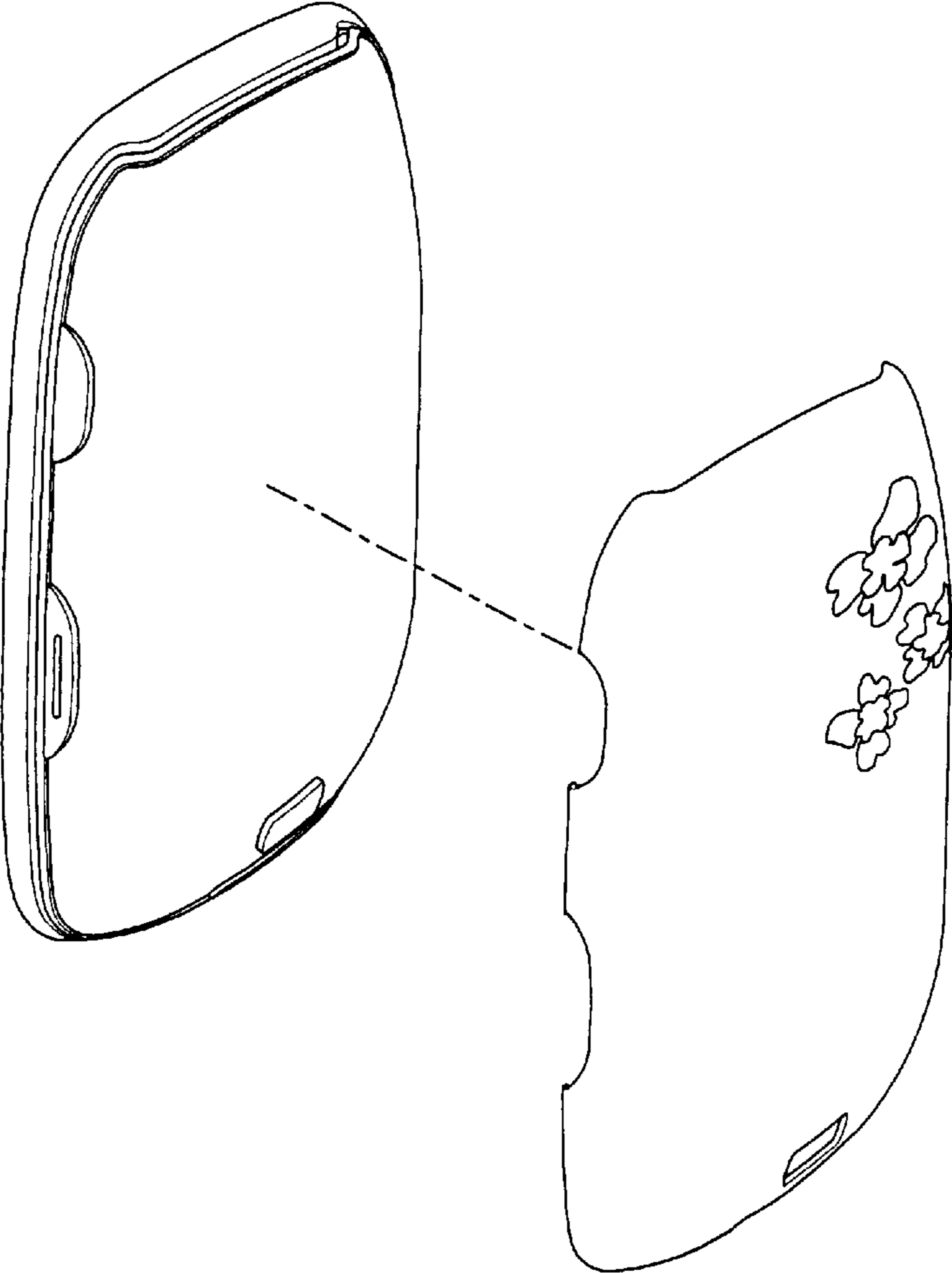

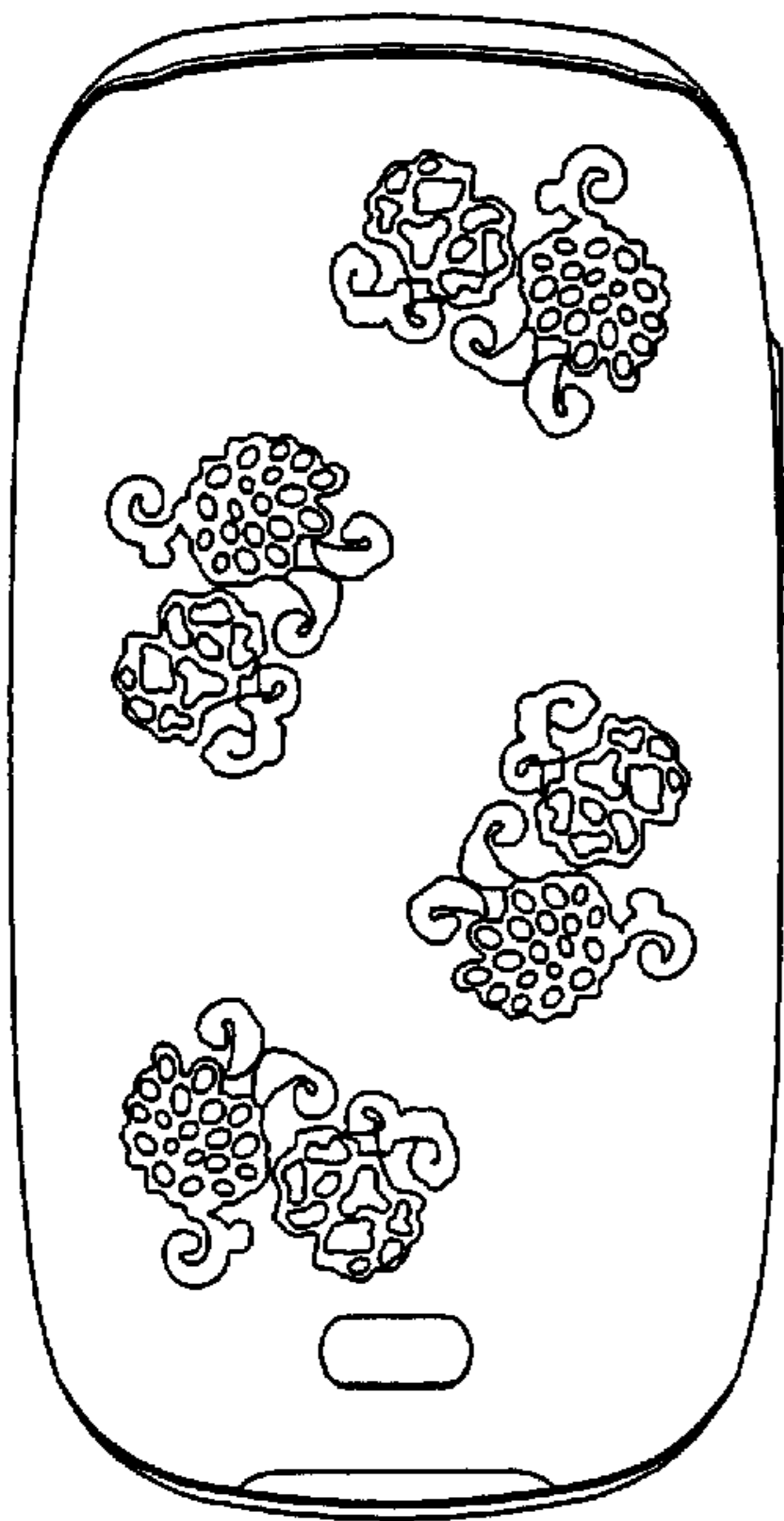

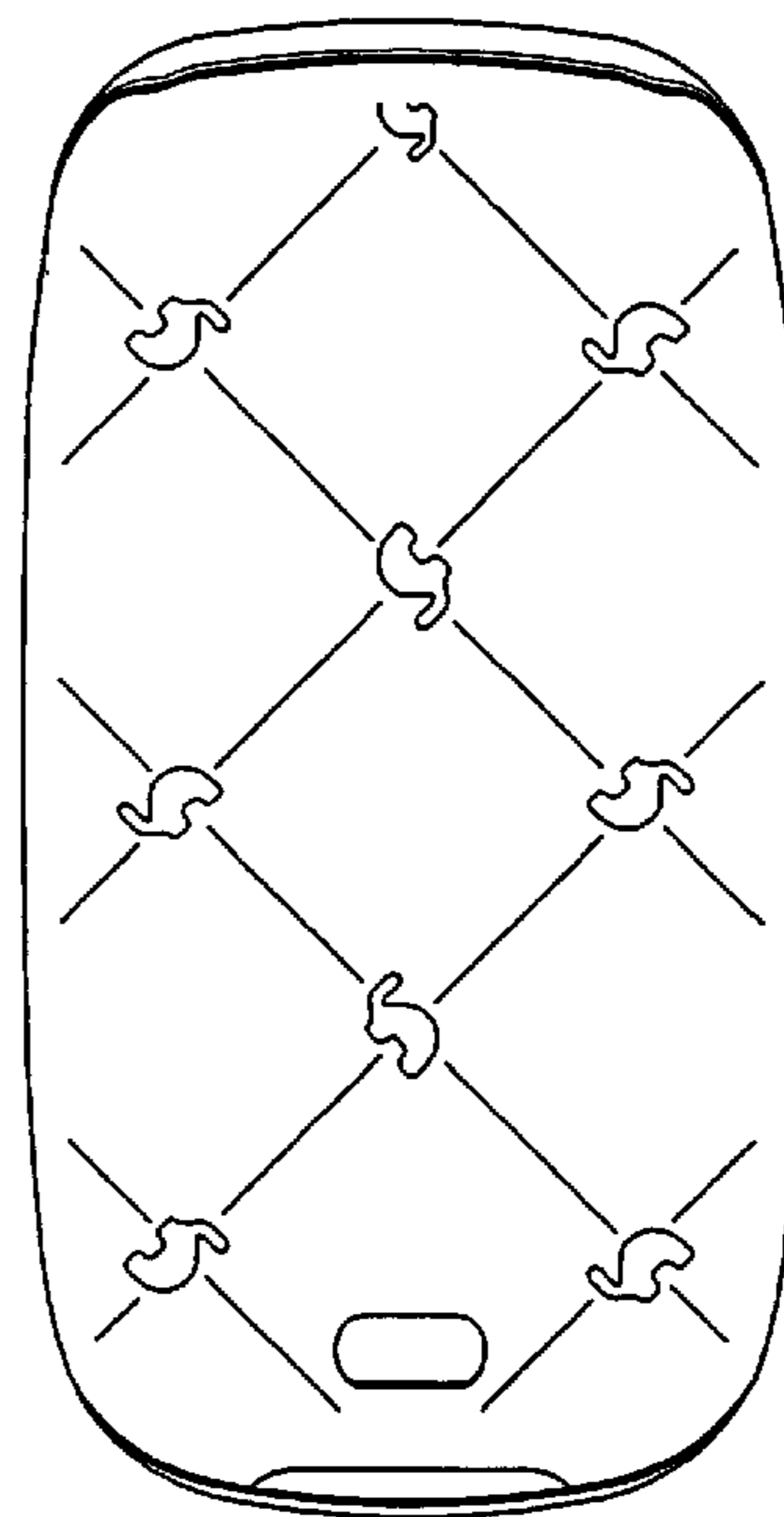
