The ornamental design for glasses, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of glasses in accordance with the invention;

FIG. 2 is a front left perspective view of the glasses depicted in FIG. 1;

FIG. 3 is a rear left perspective view of the glasses depicted in FIG. 1;

FIG. 4 is a front elevational view of the glasses depicted in FIG. 1.

FIG. 5 is a rear elevational view of the glasses depicted in FIG. 1.

FIG. 6 is a left-hand side elevational view of the glasses depicted in FIG. 1;

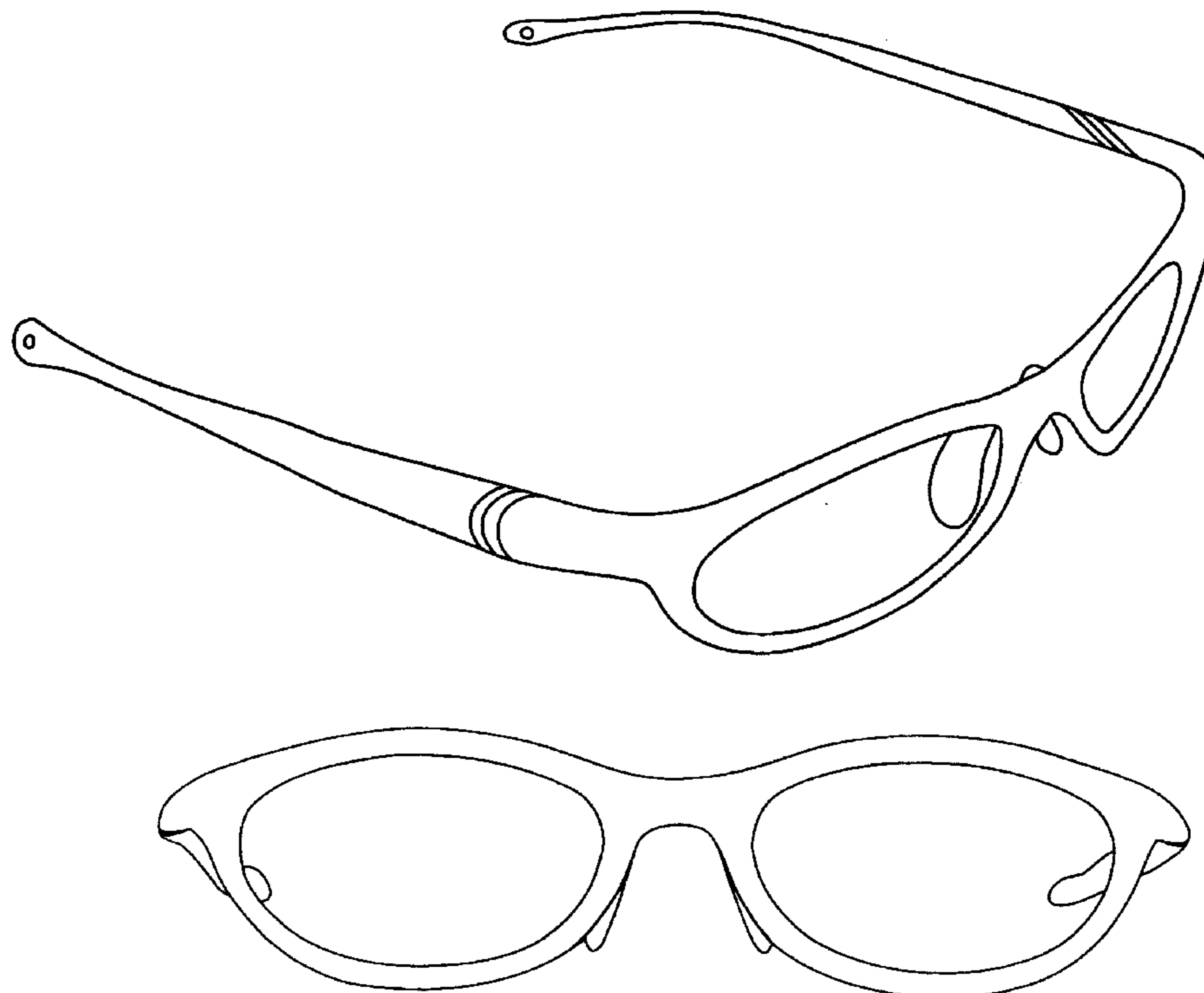
FIG. 7 is a right-hand side elevational view of the glasses depicted in FIG. 1;

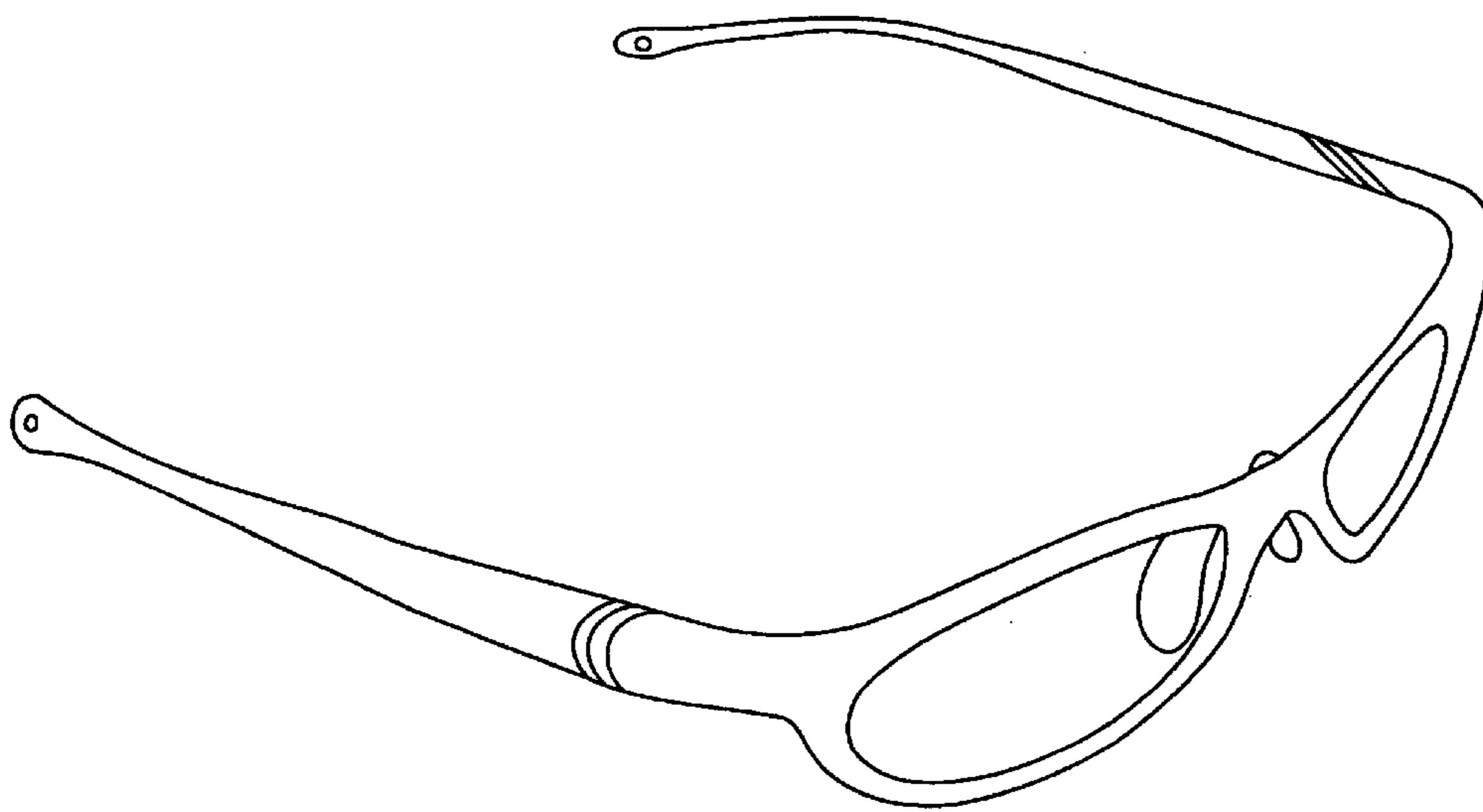

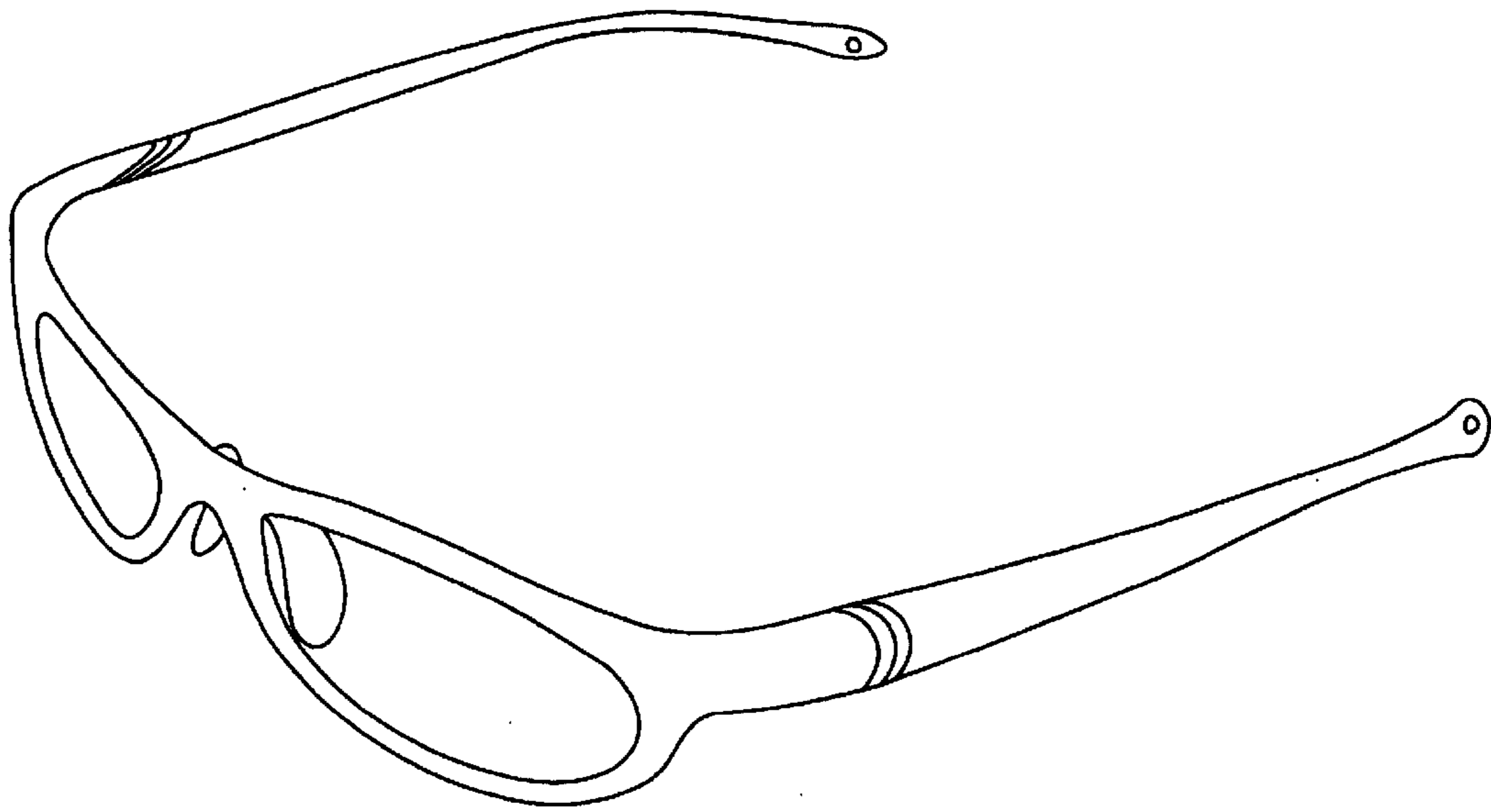

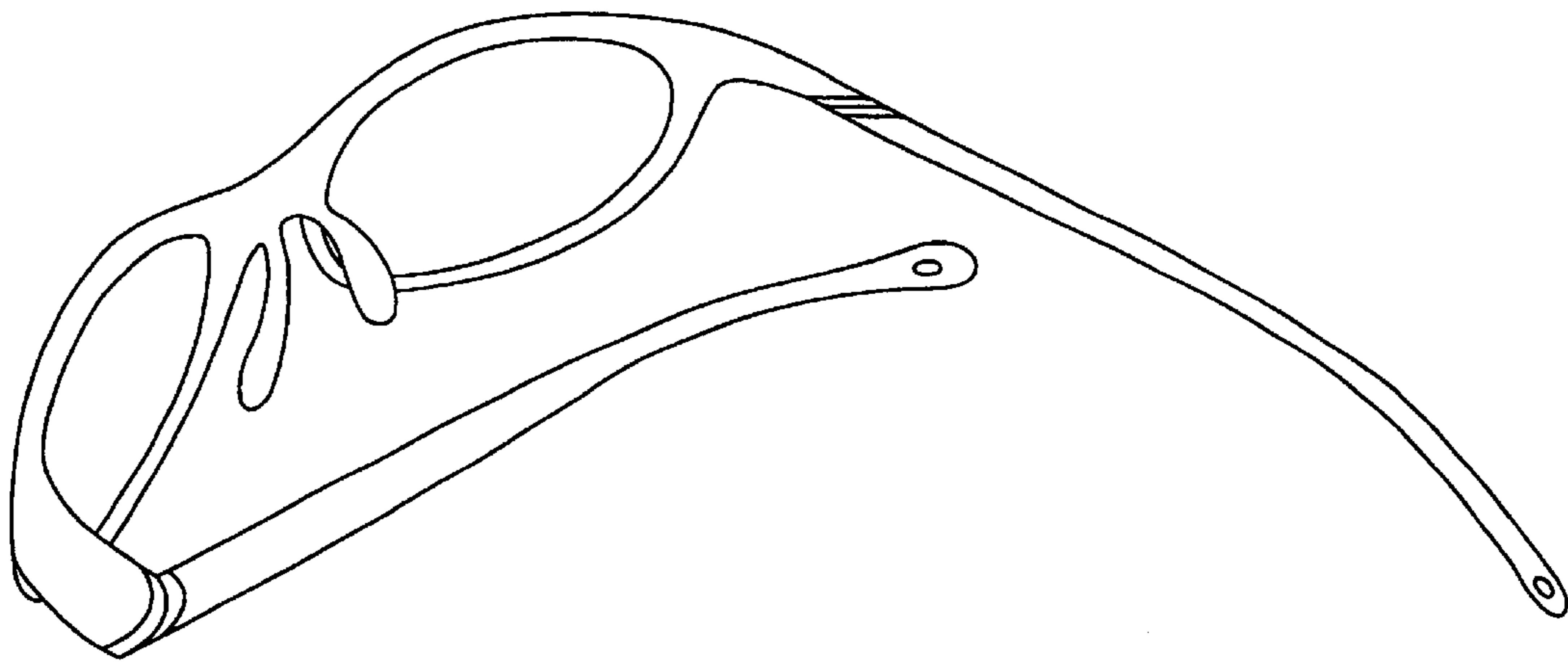

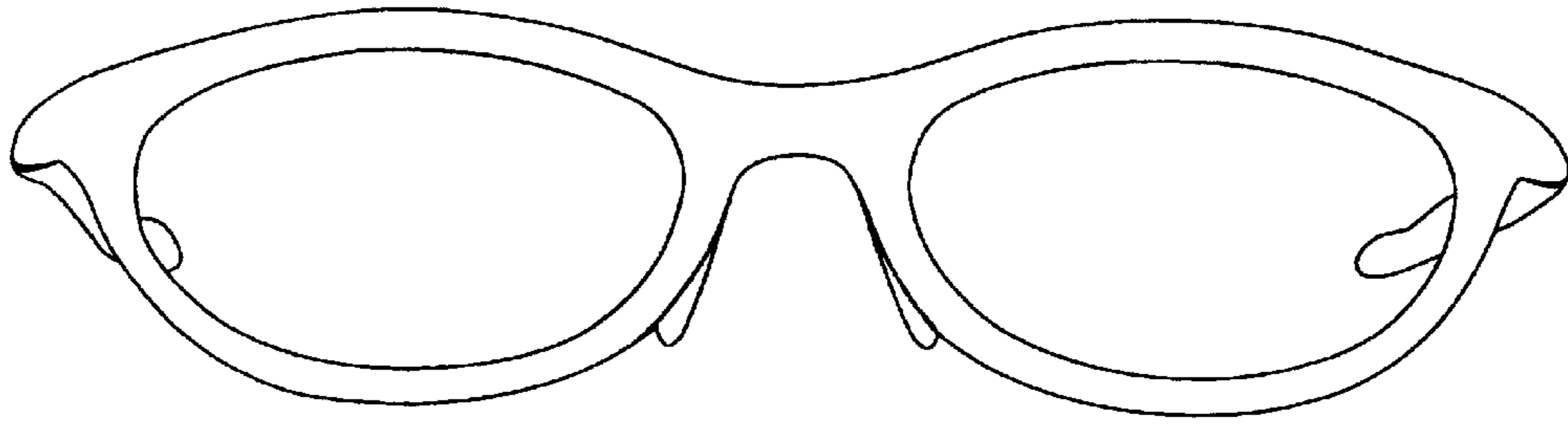

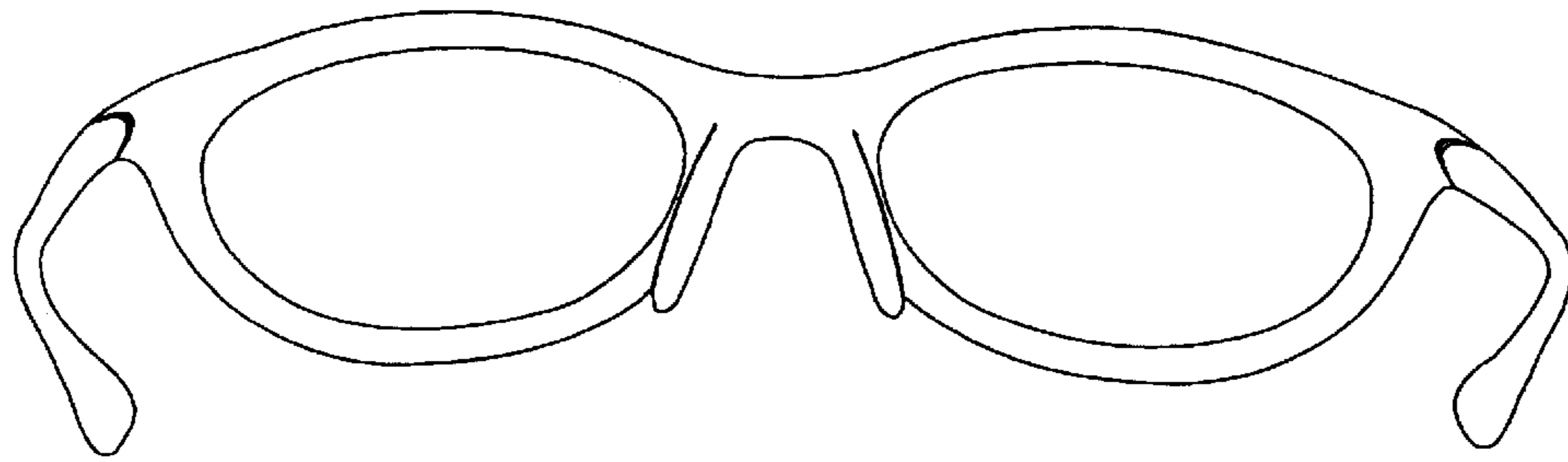

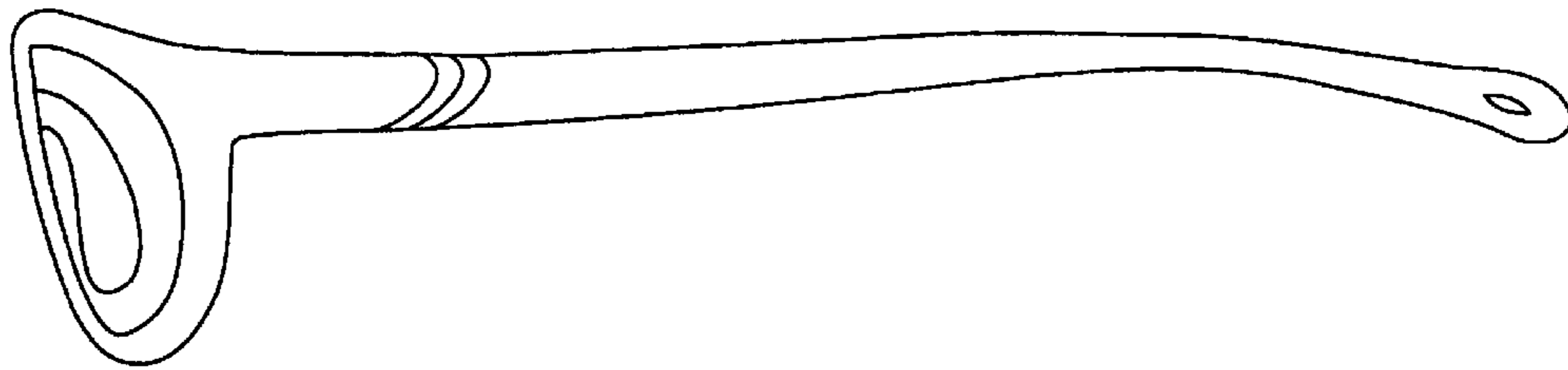

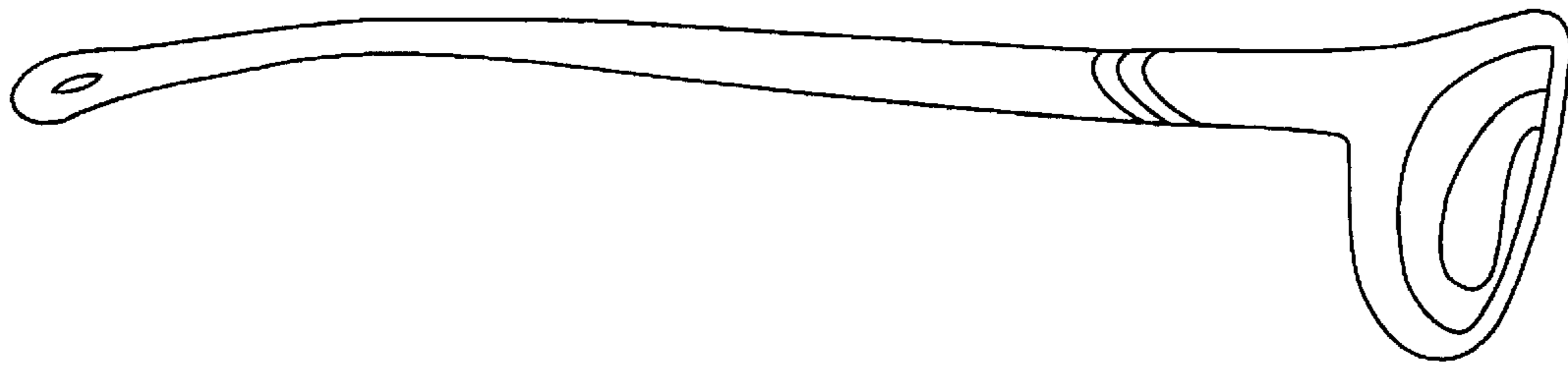

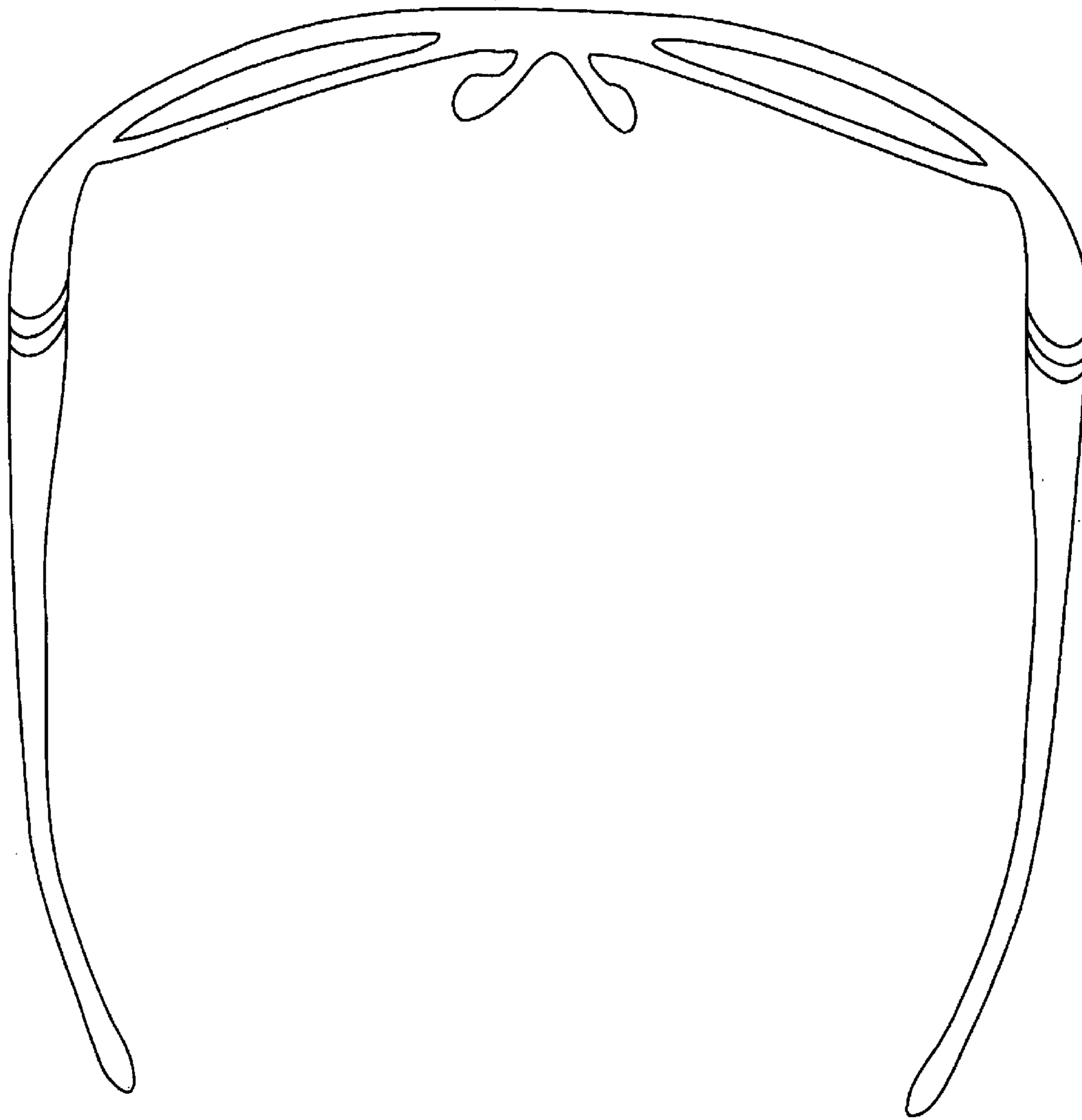

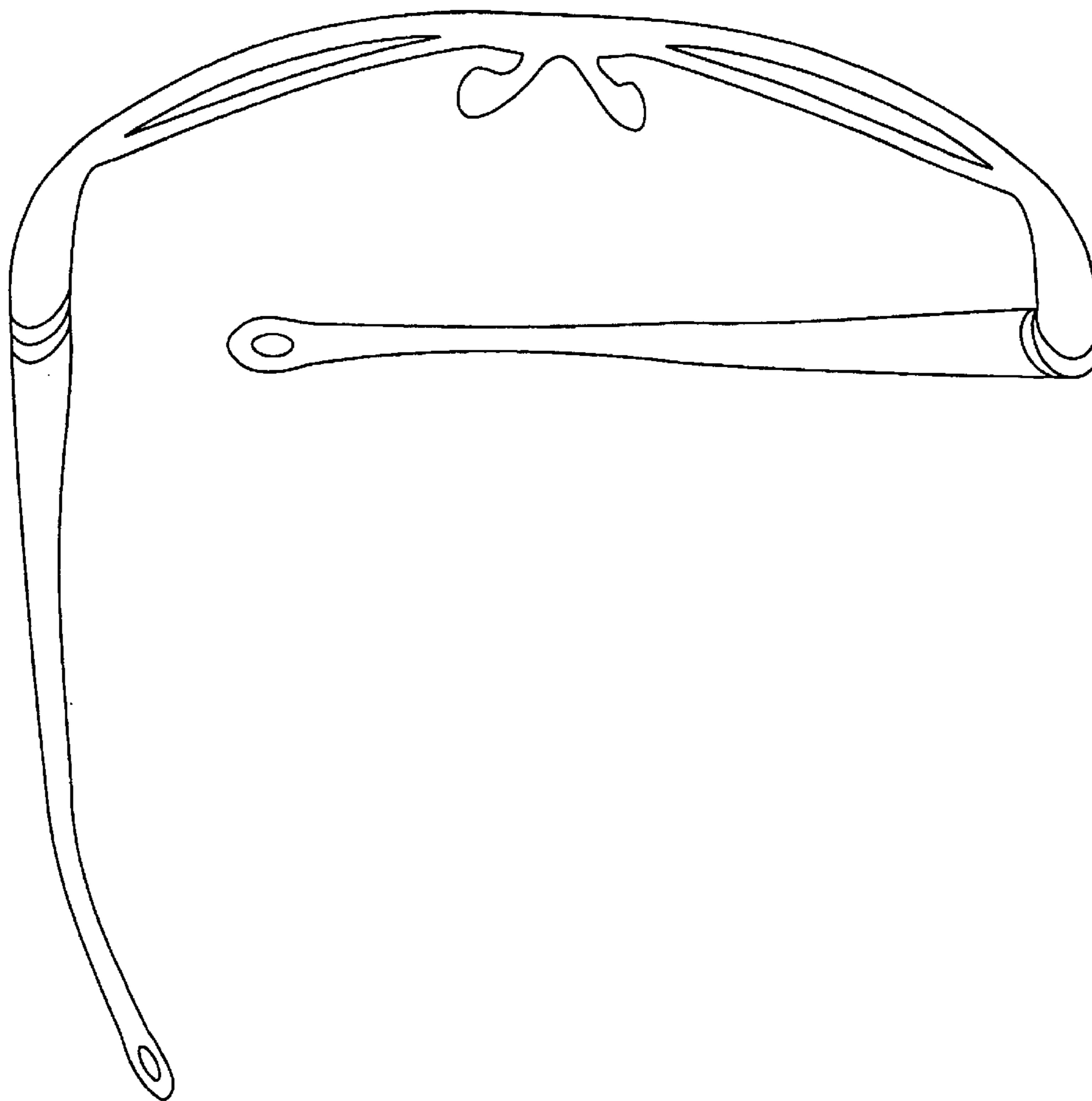

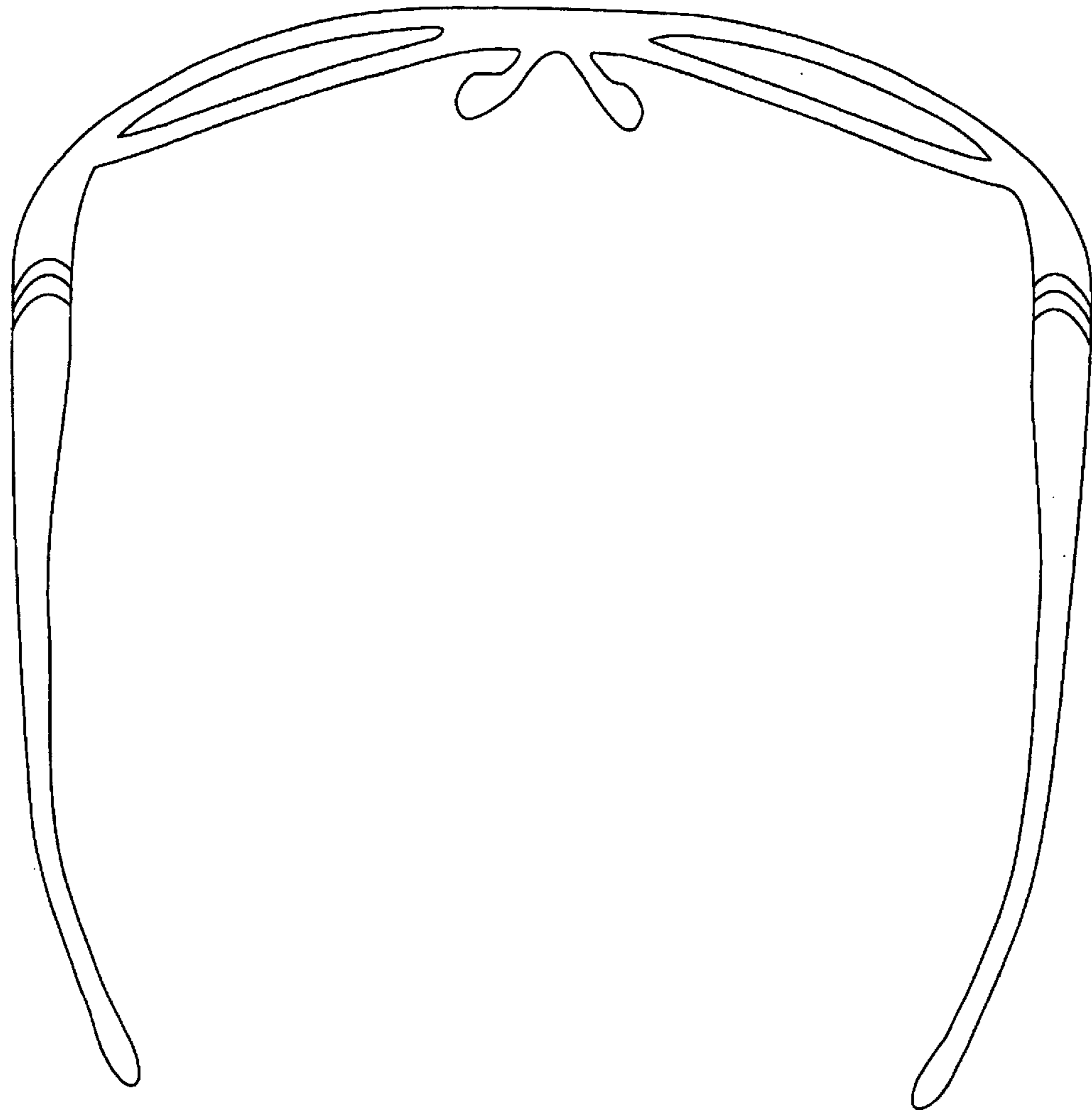
