FIG. 1 is a front perspective view of a sillcock handle of the new design;

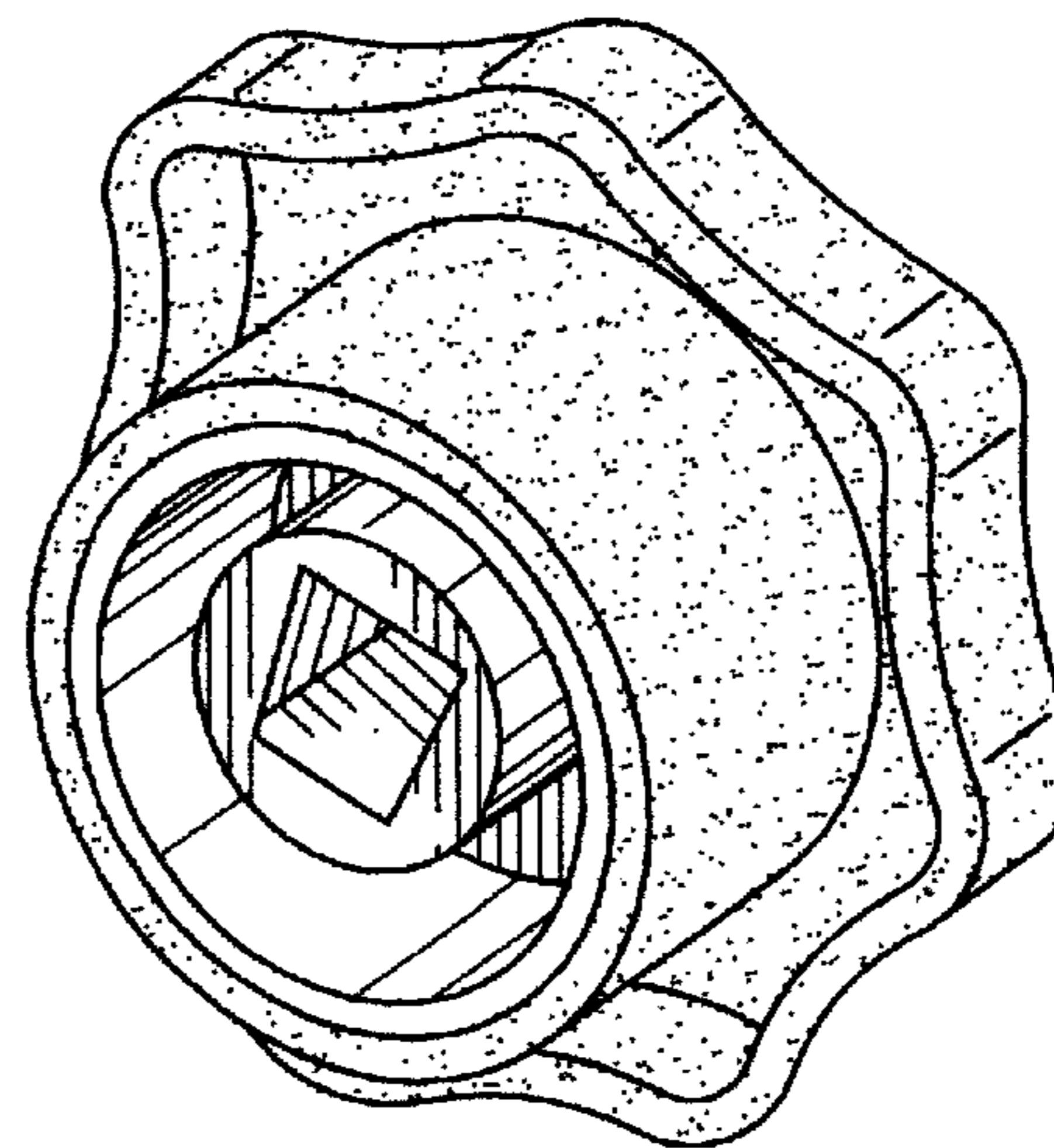
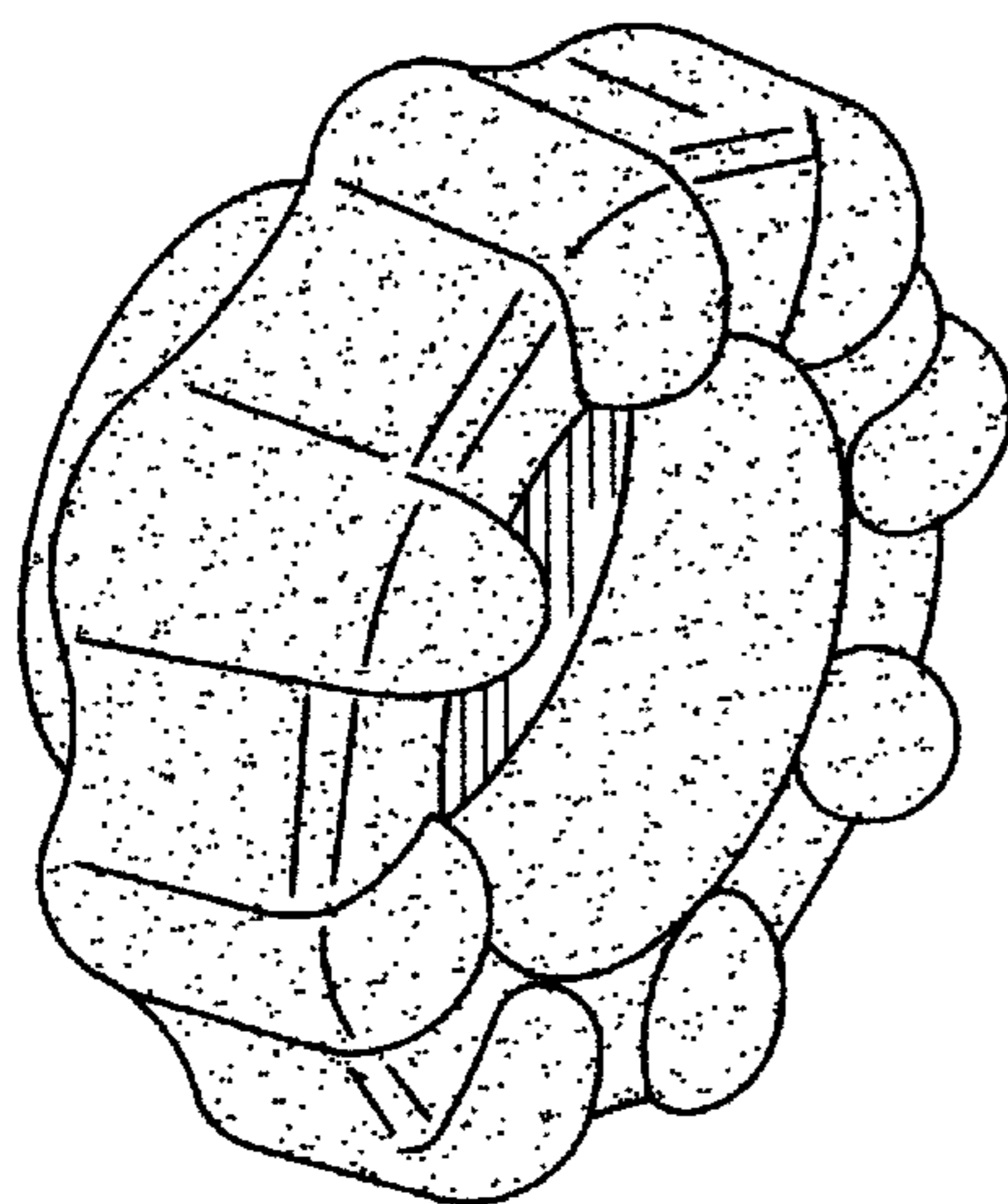
FIG. 2 is a rear perspective view of the handle of the new design;

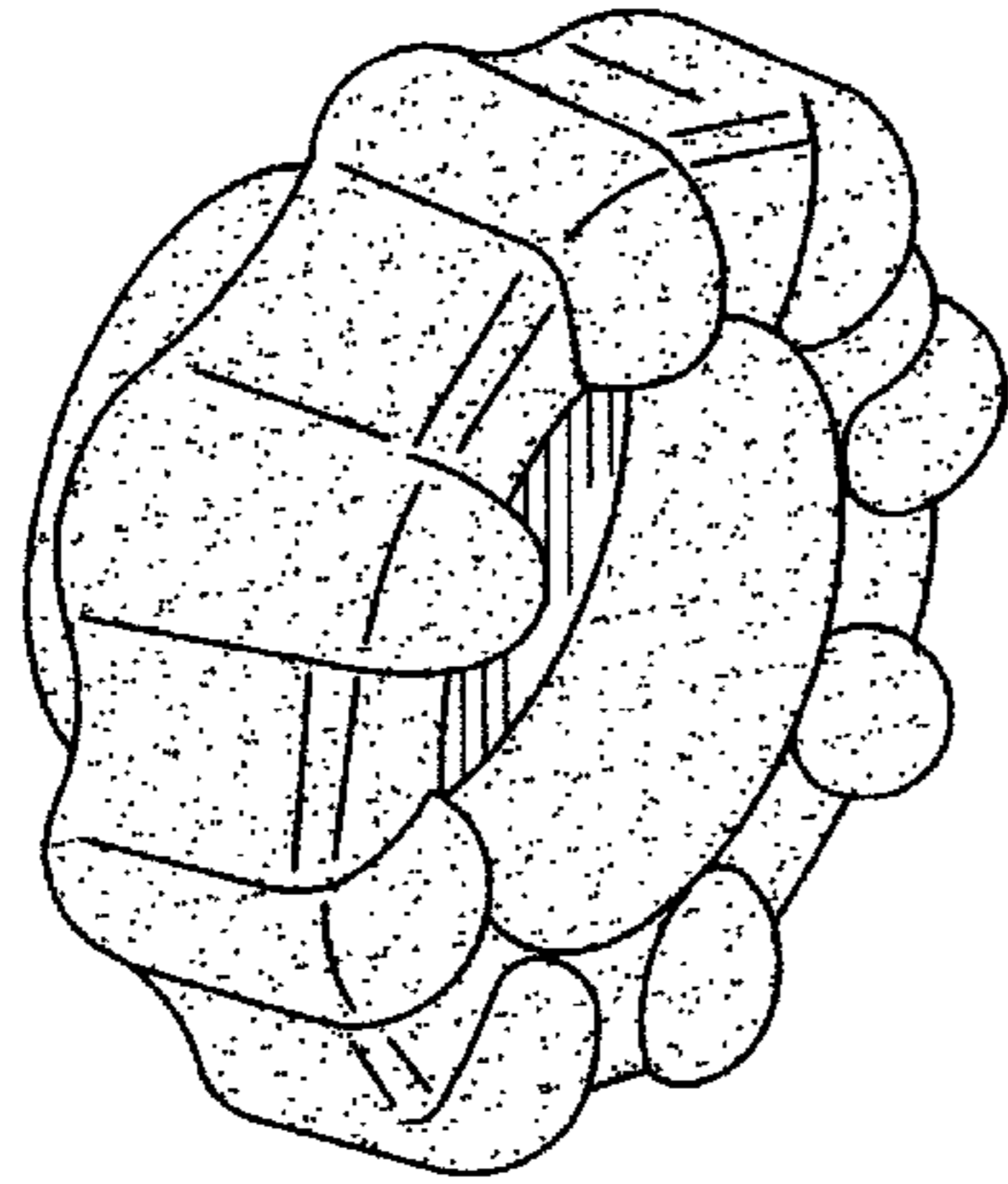

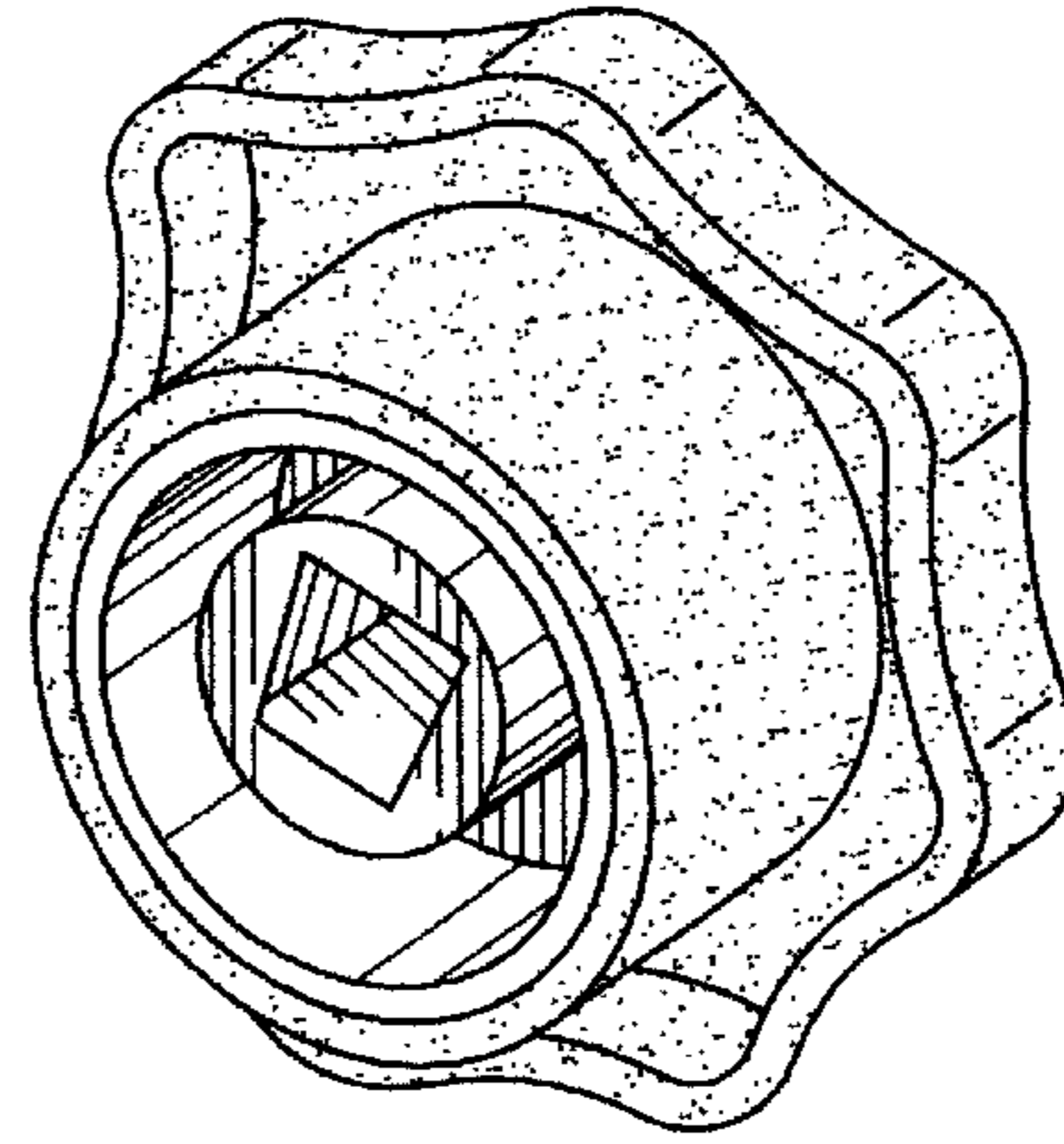

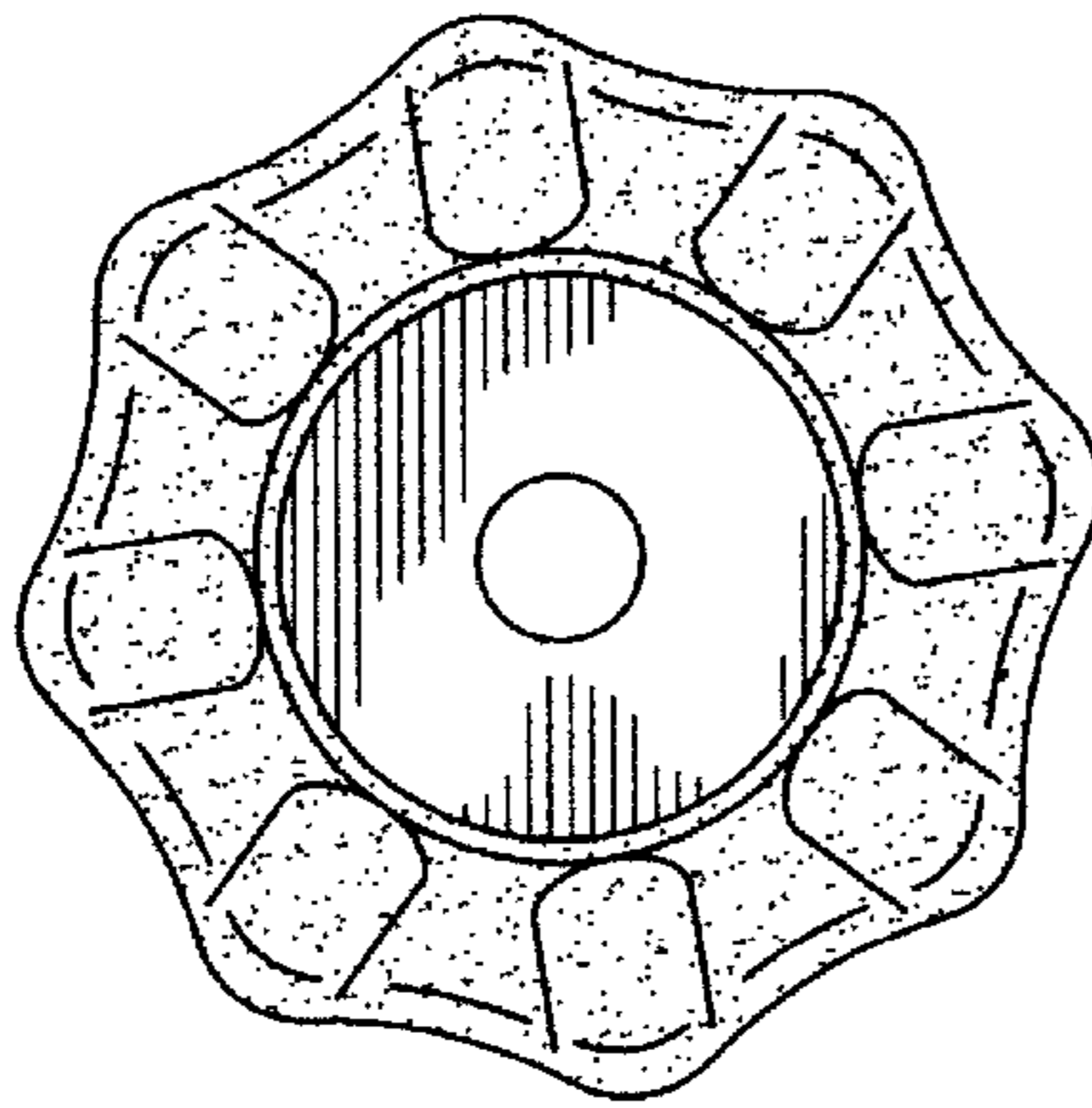

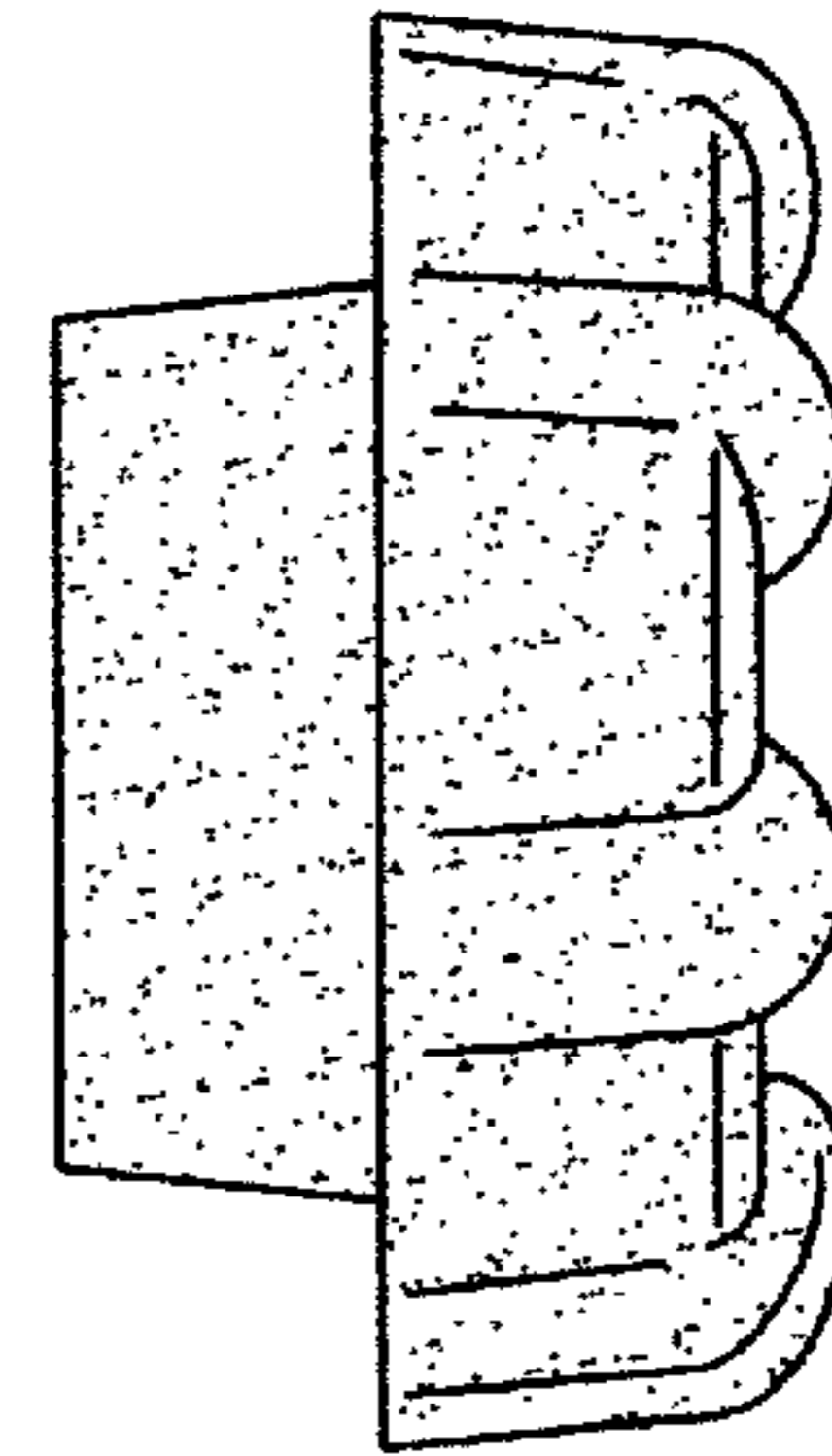

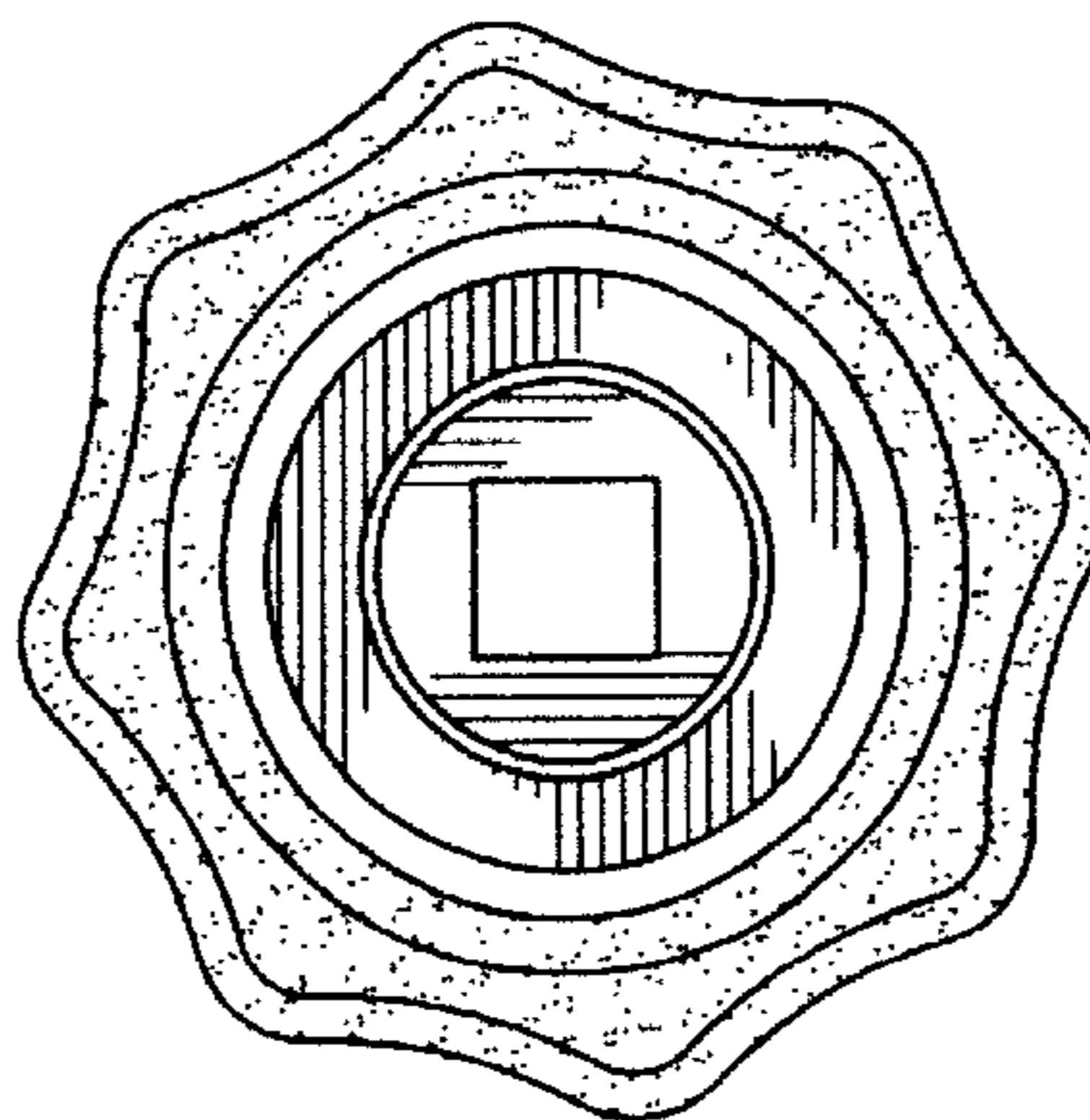
