FIG. 1 is a top view of the claimed design;

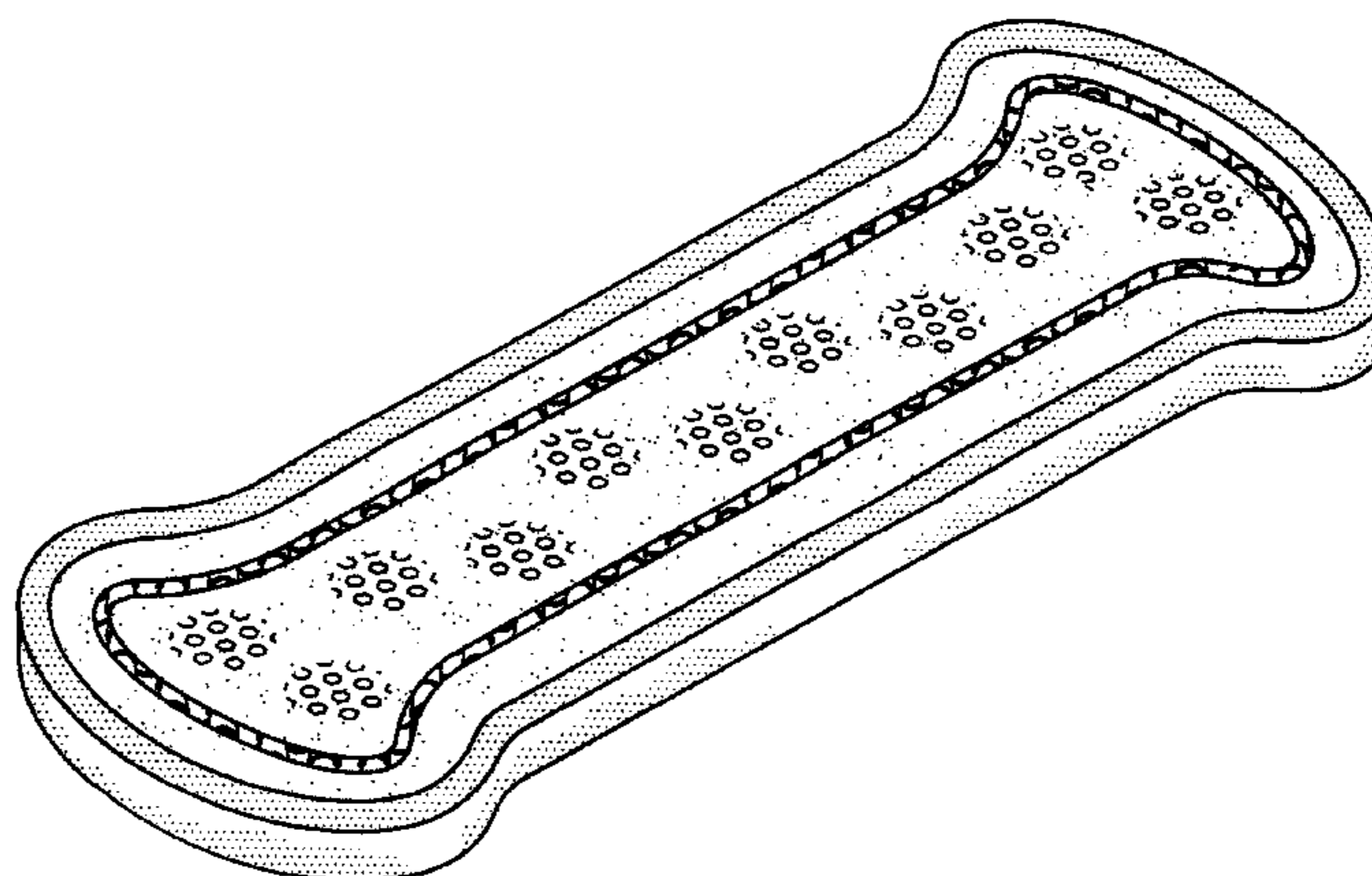
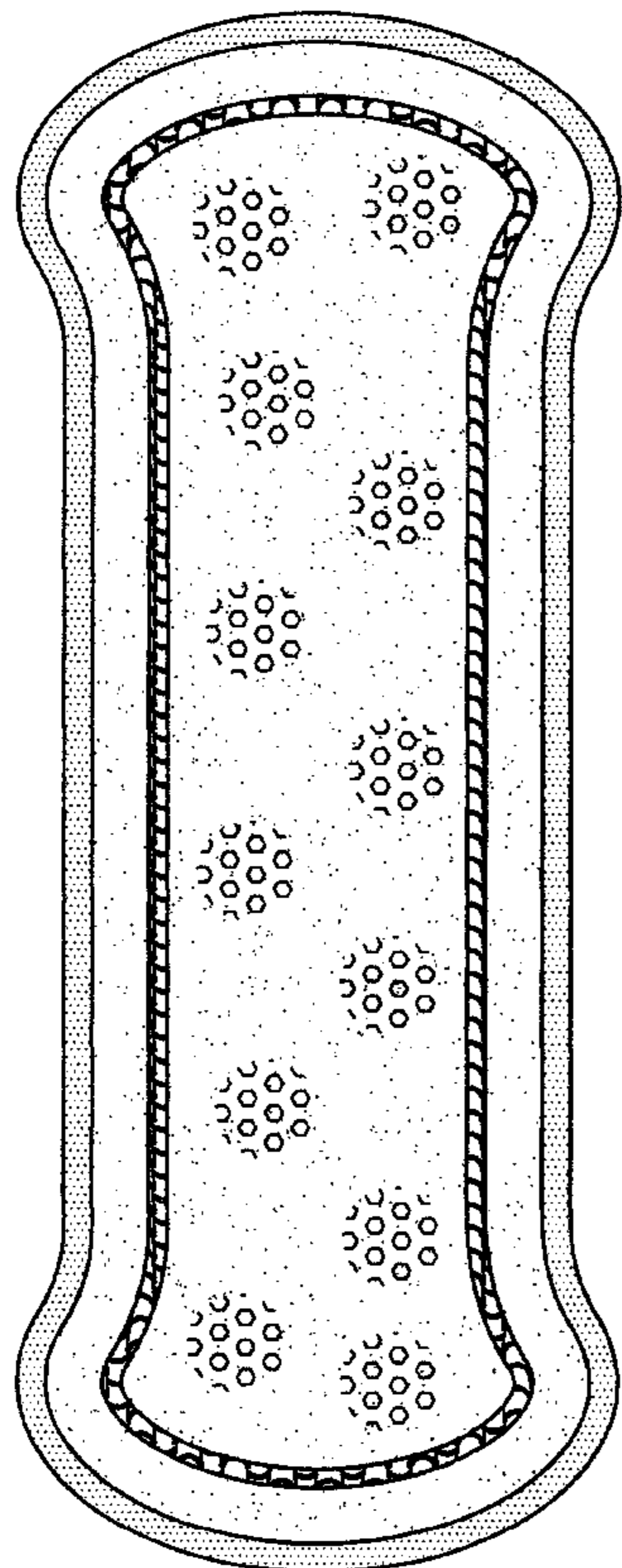
FIG. 2 is a bottom view thereof;

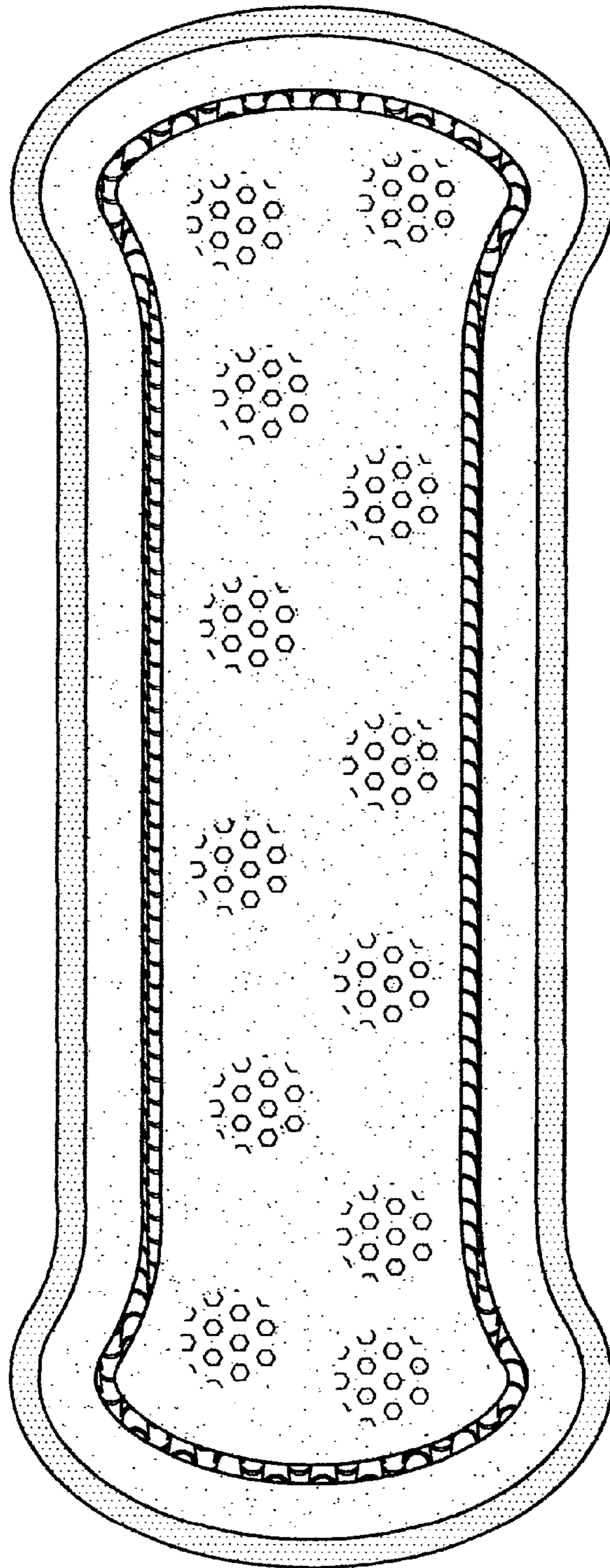

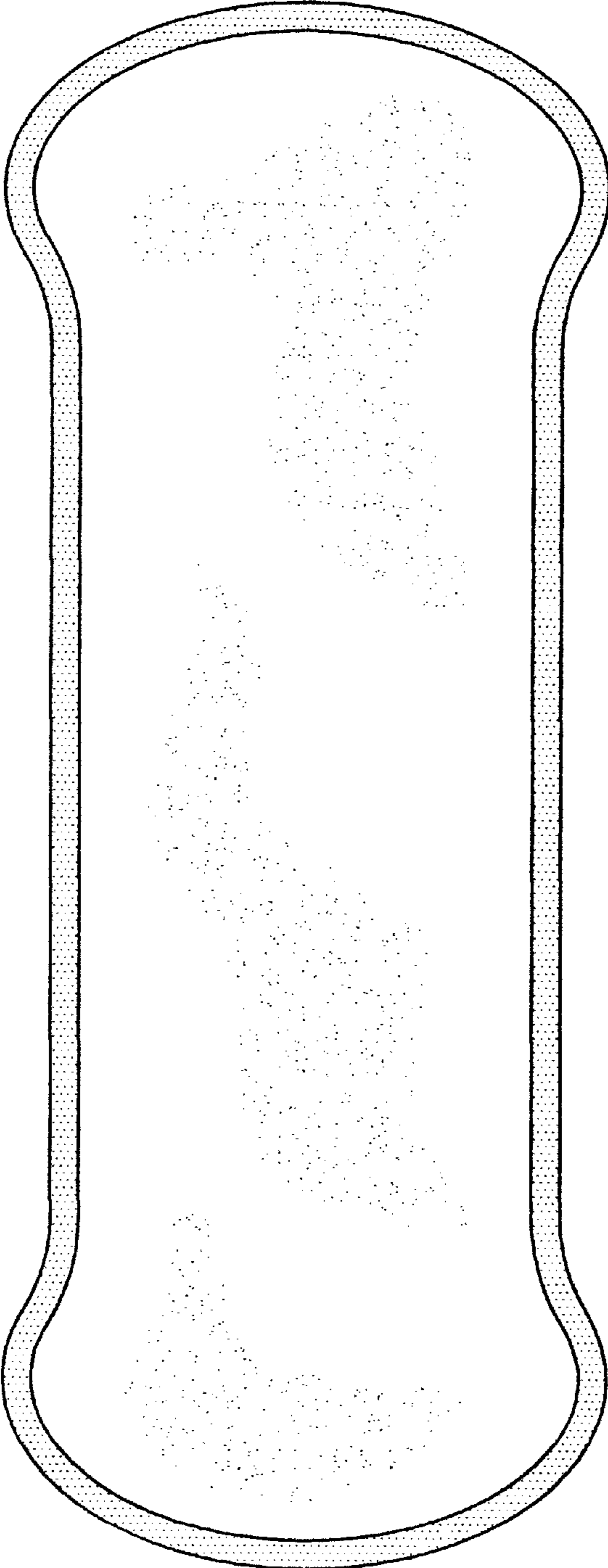

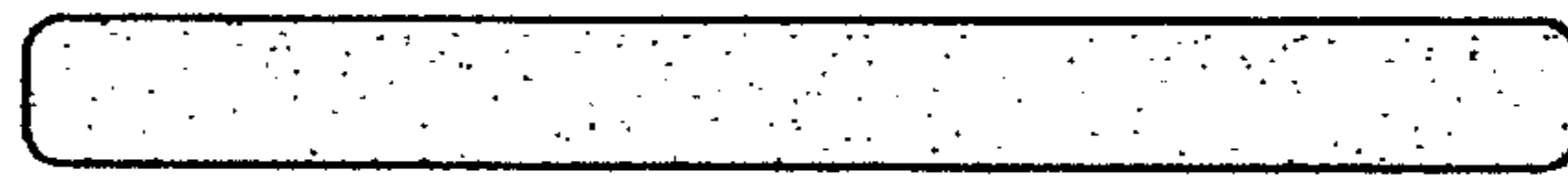

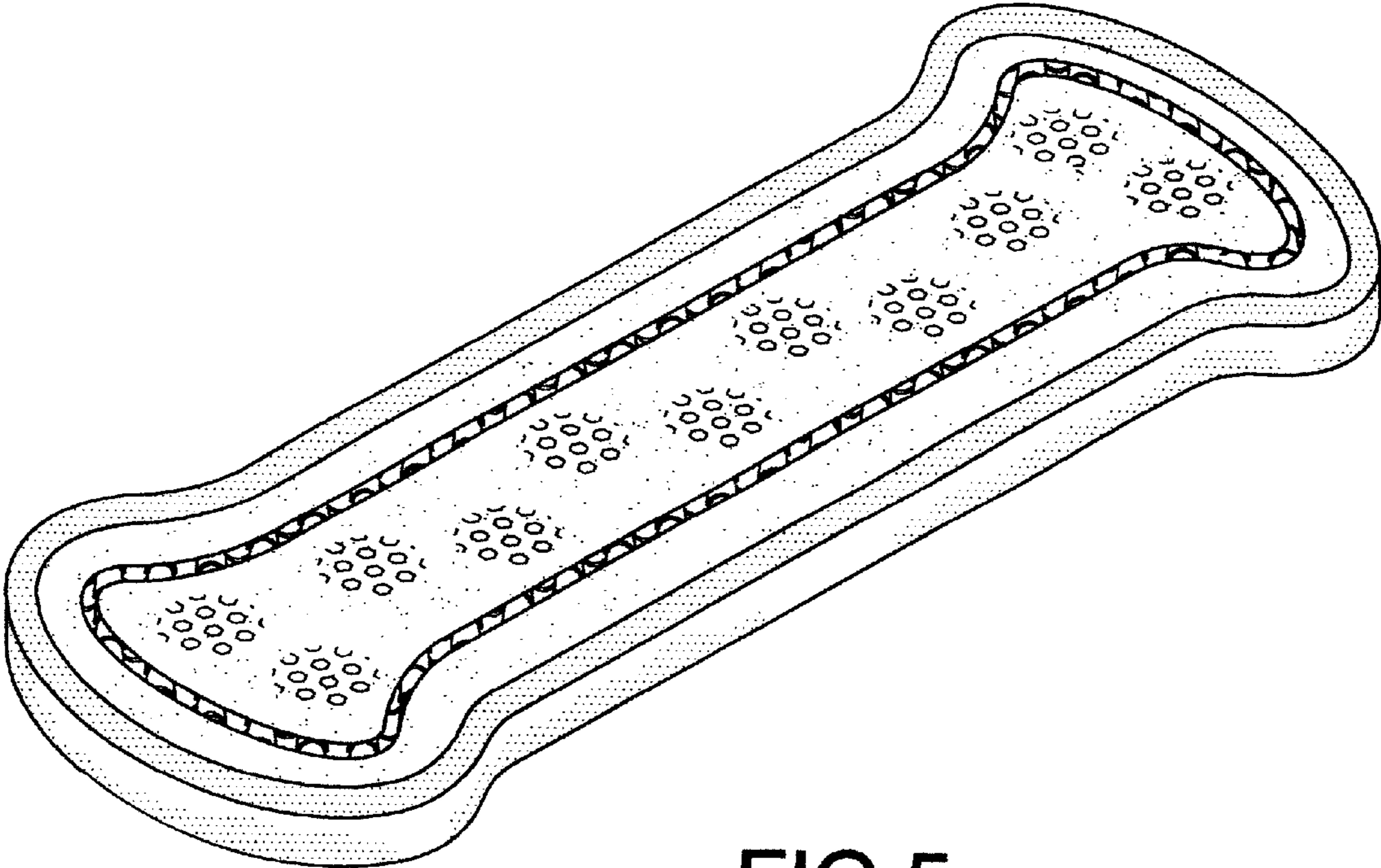
