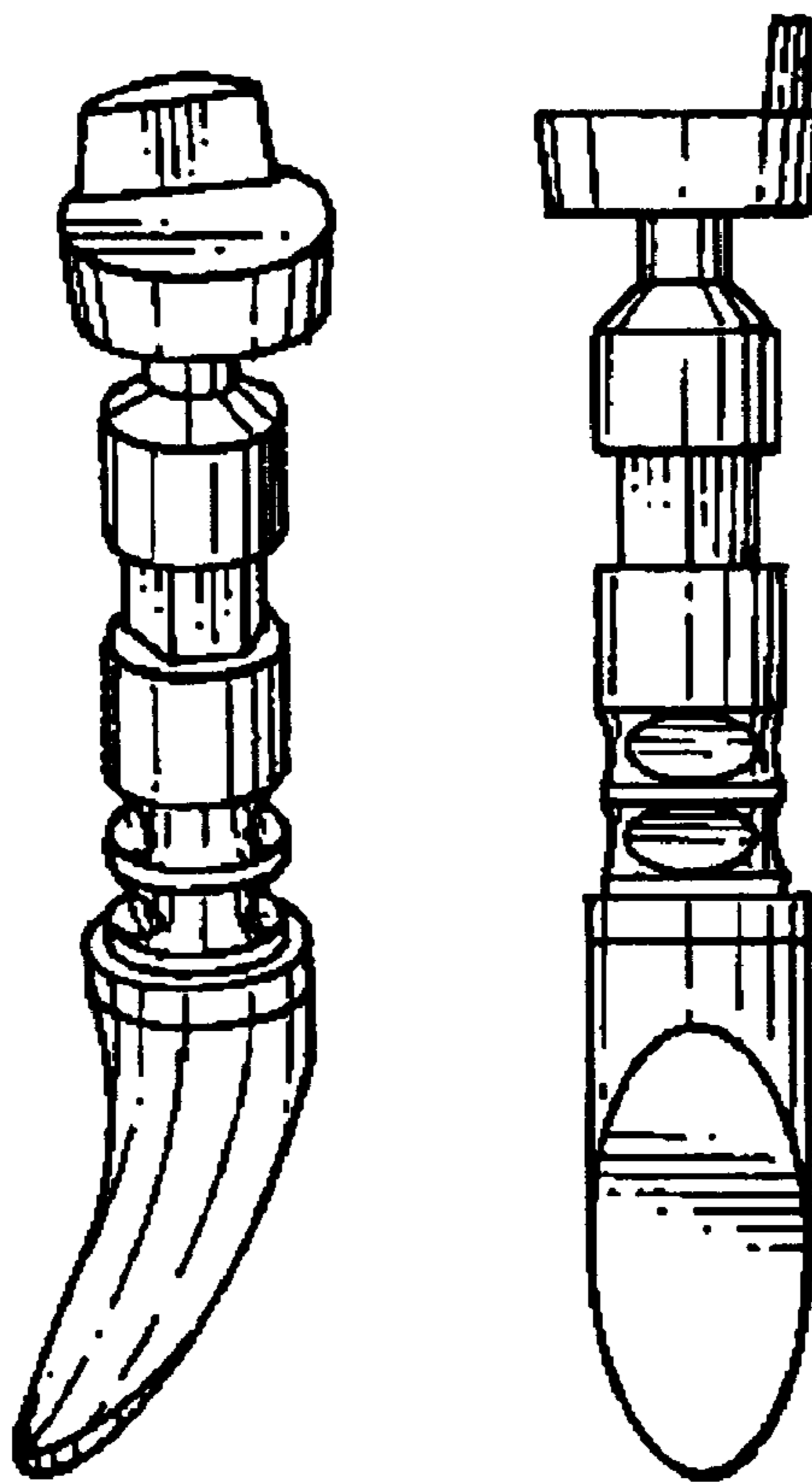

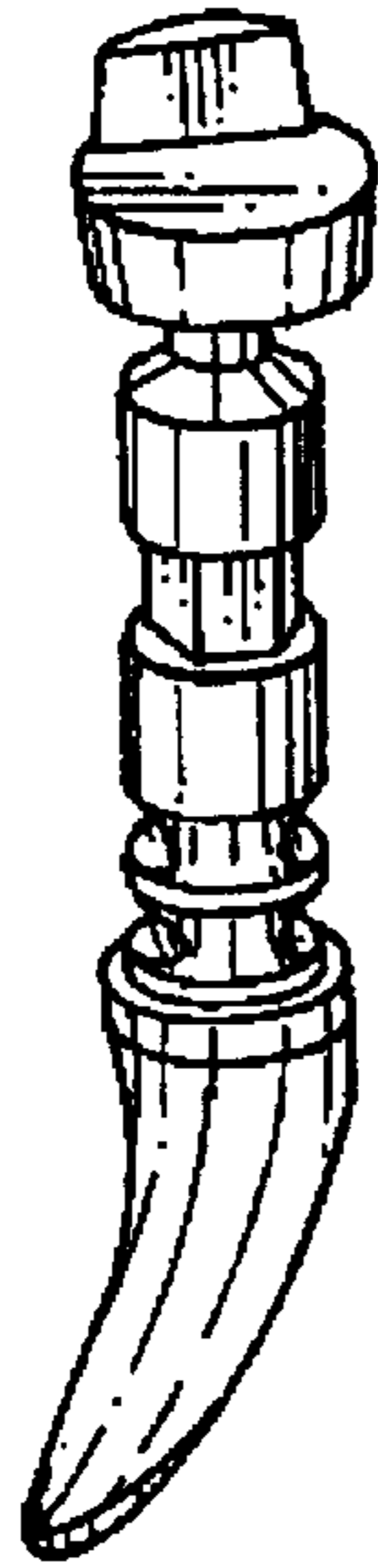
The ornamental design for a flexing cosmetic applicator, as shown and described.

**DESCRIPTION**

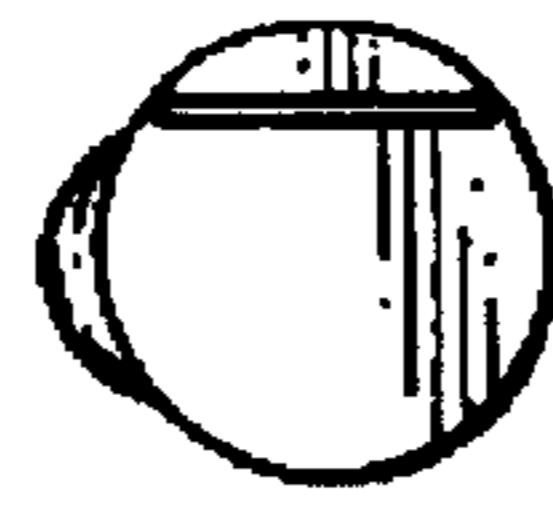

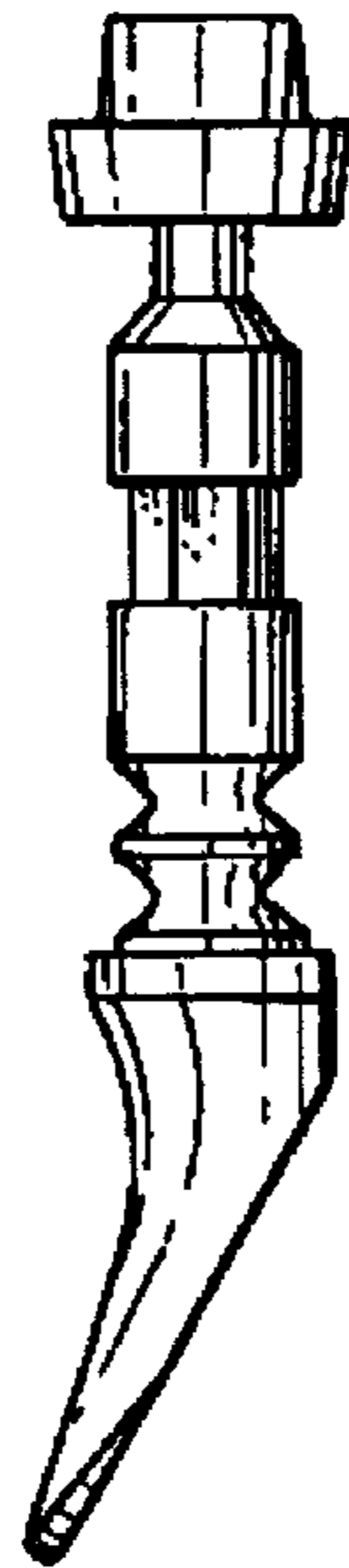




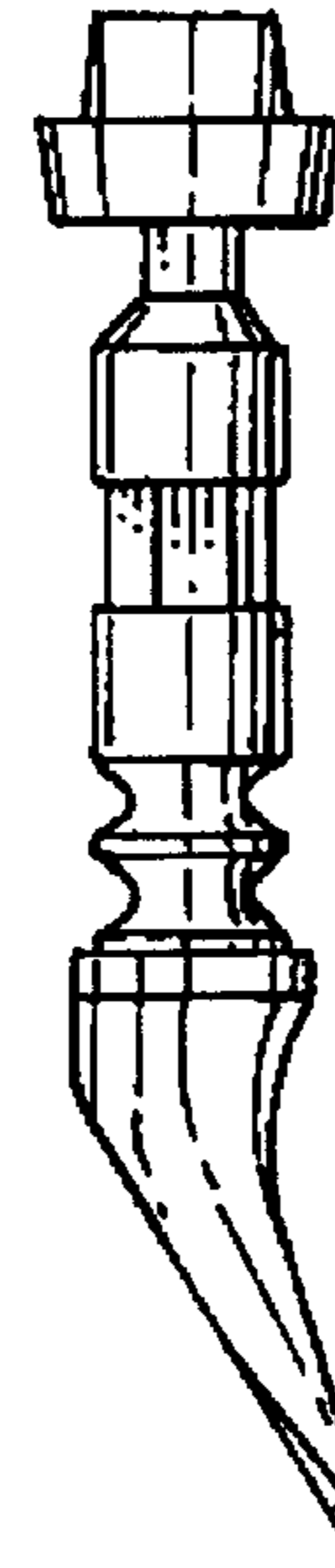

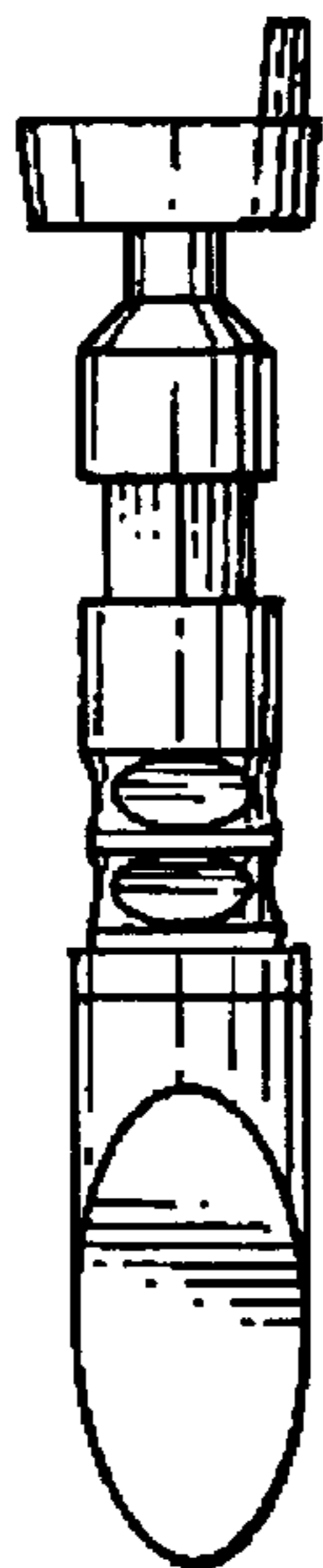

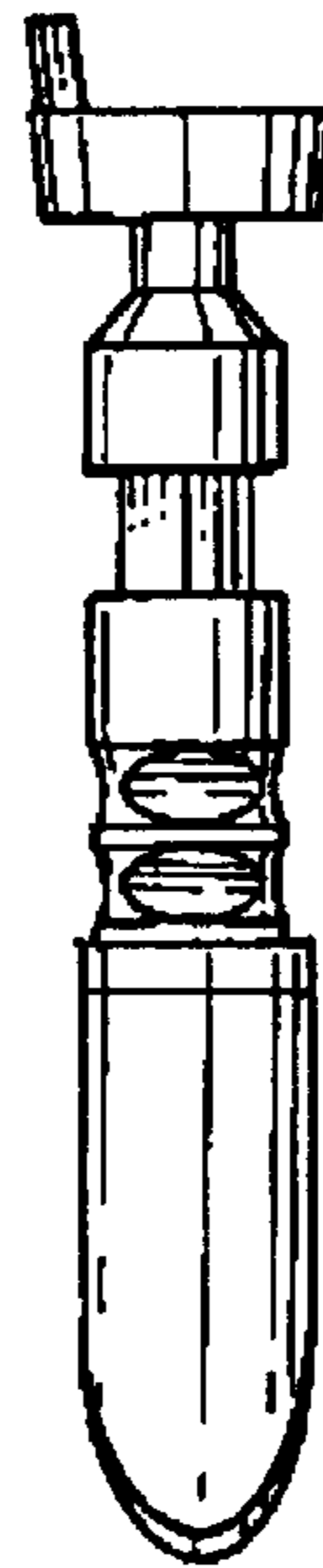
