FIG. 4 is a front elevation view thereof.

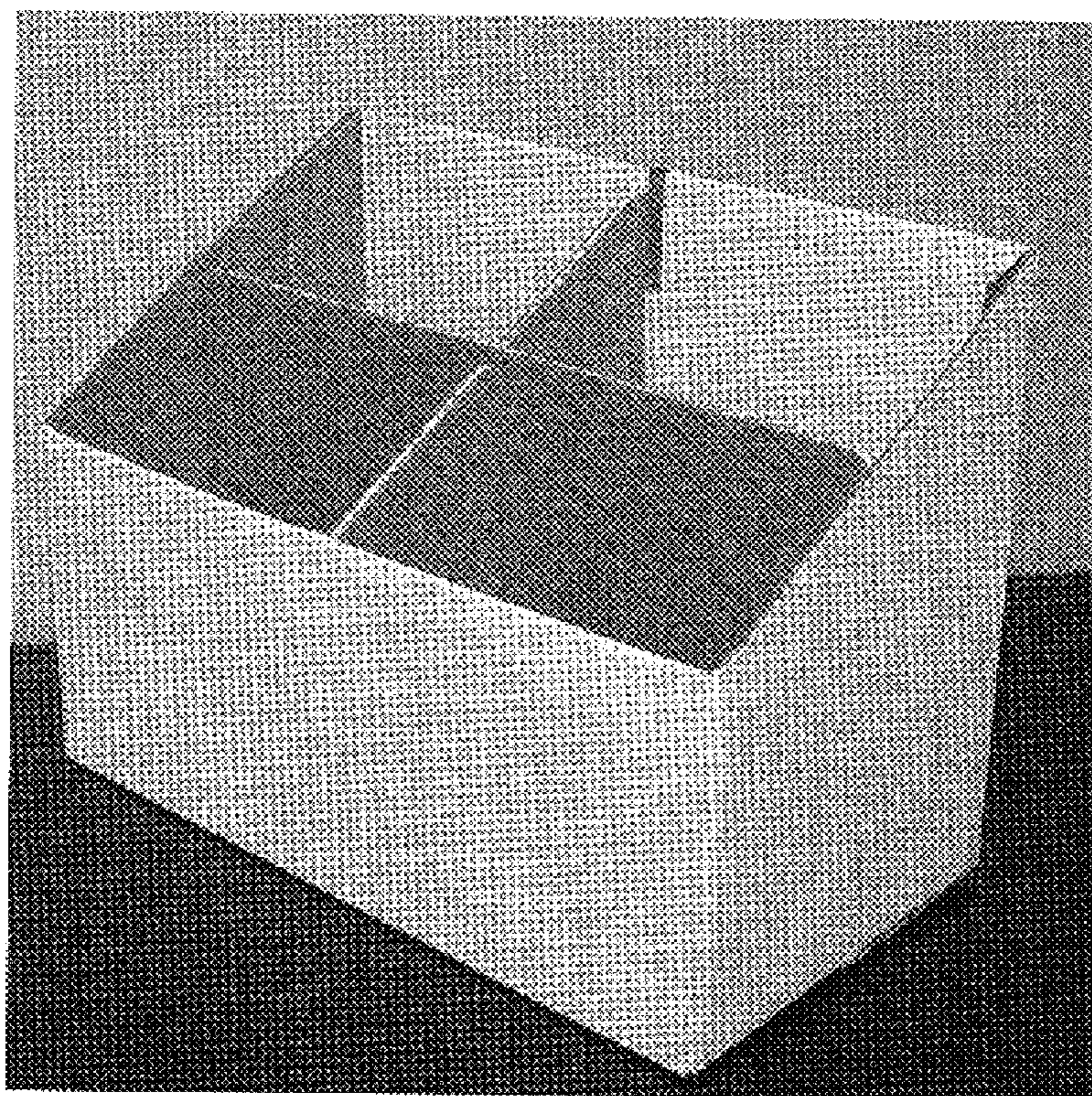
FIG. 5 is a rear elevation view thereof.

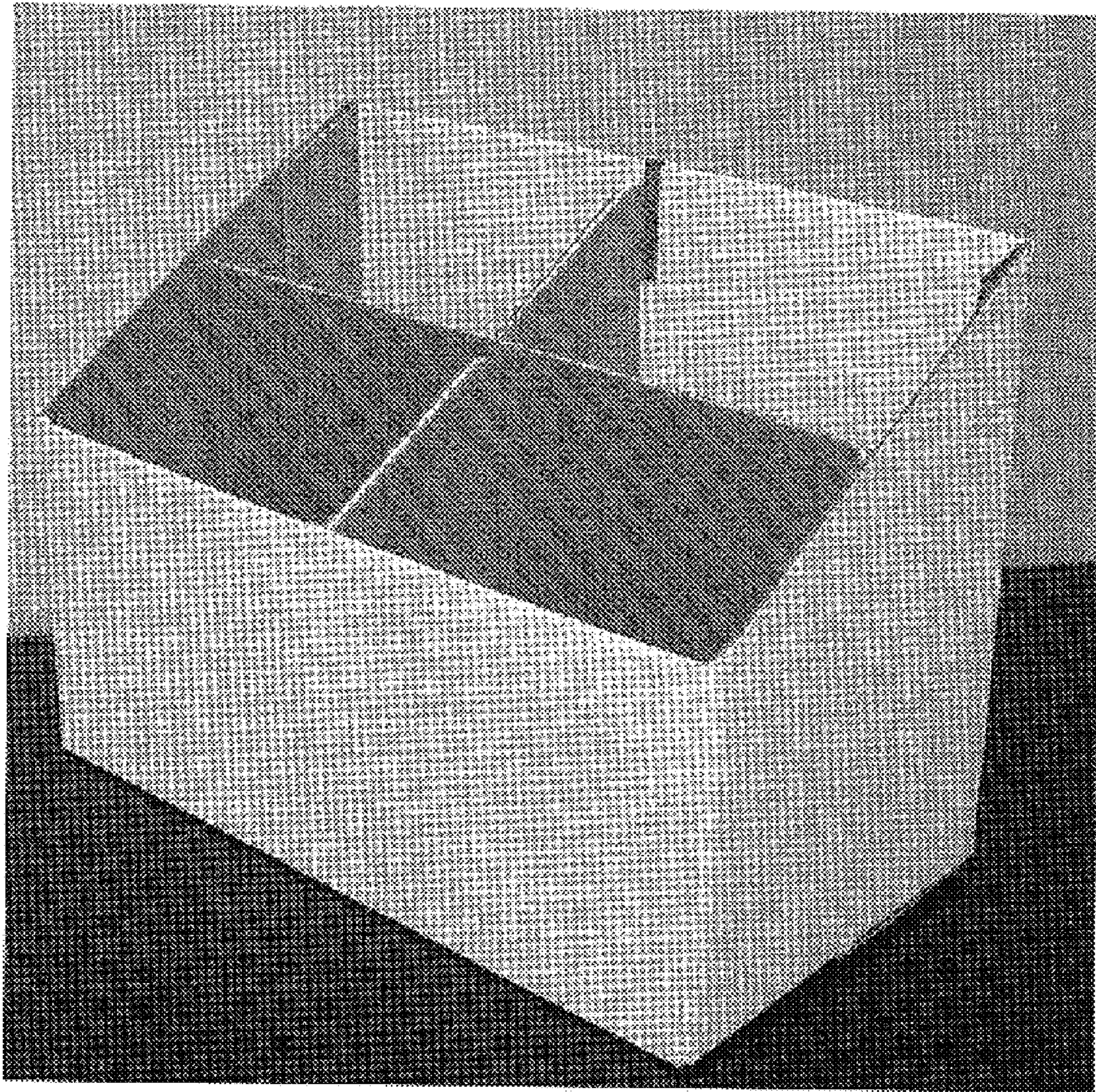

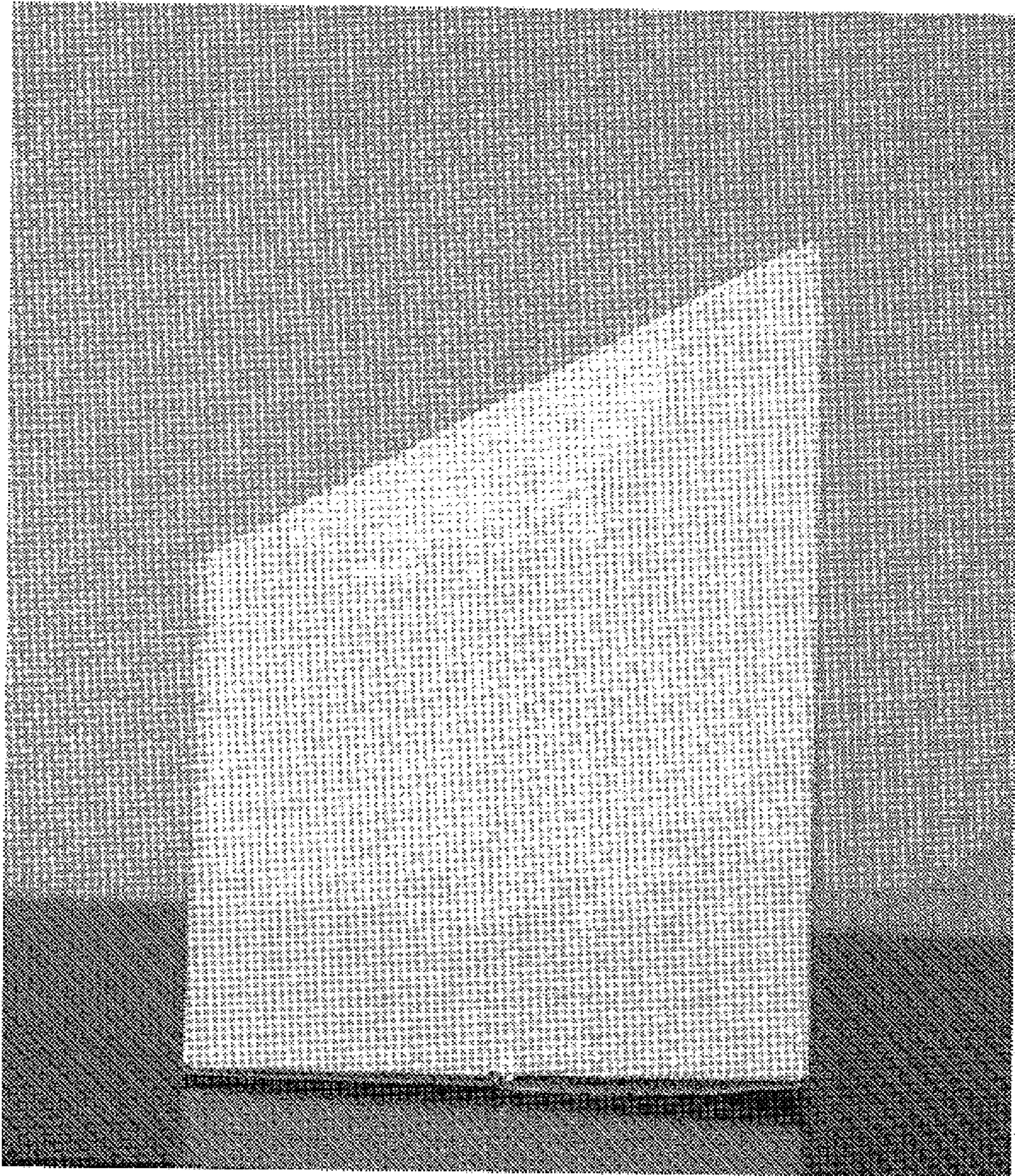

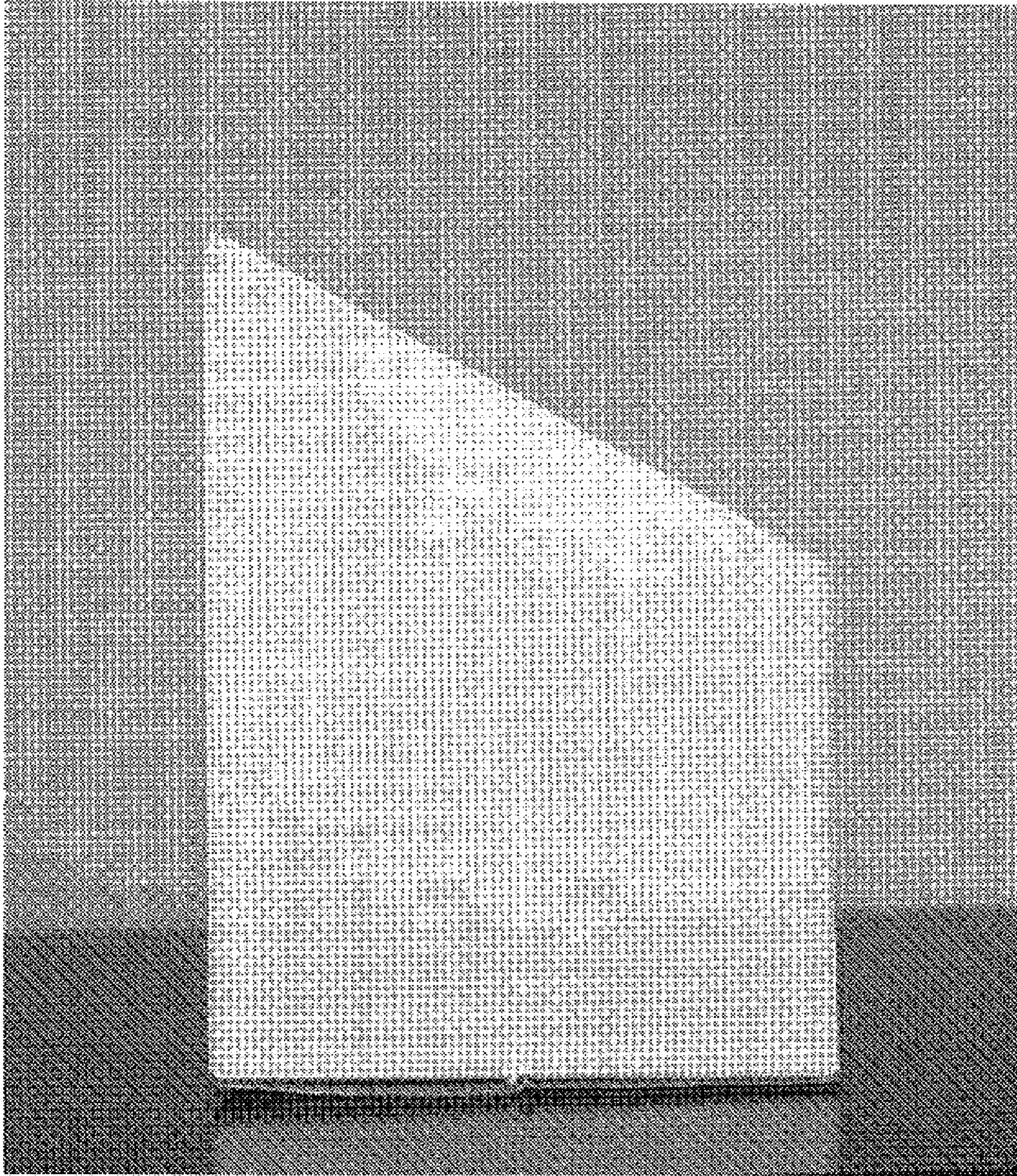

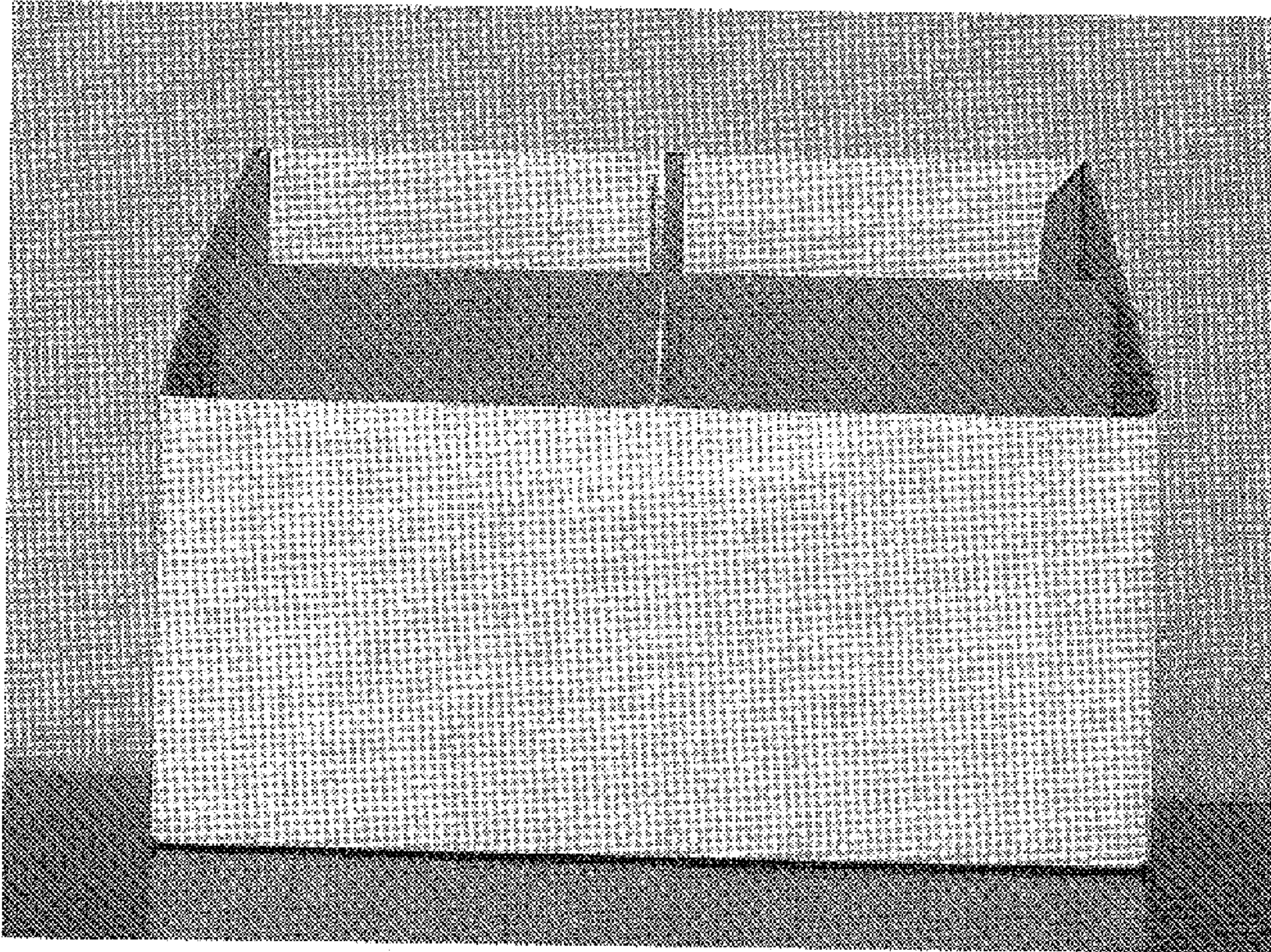

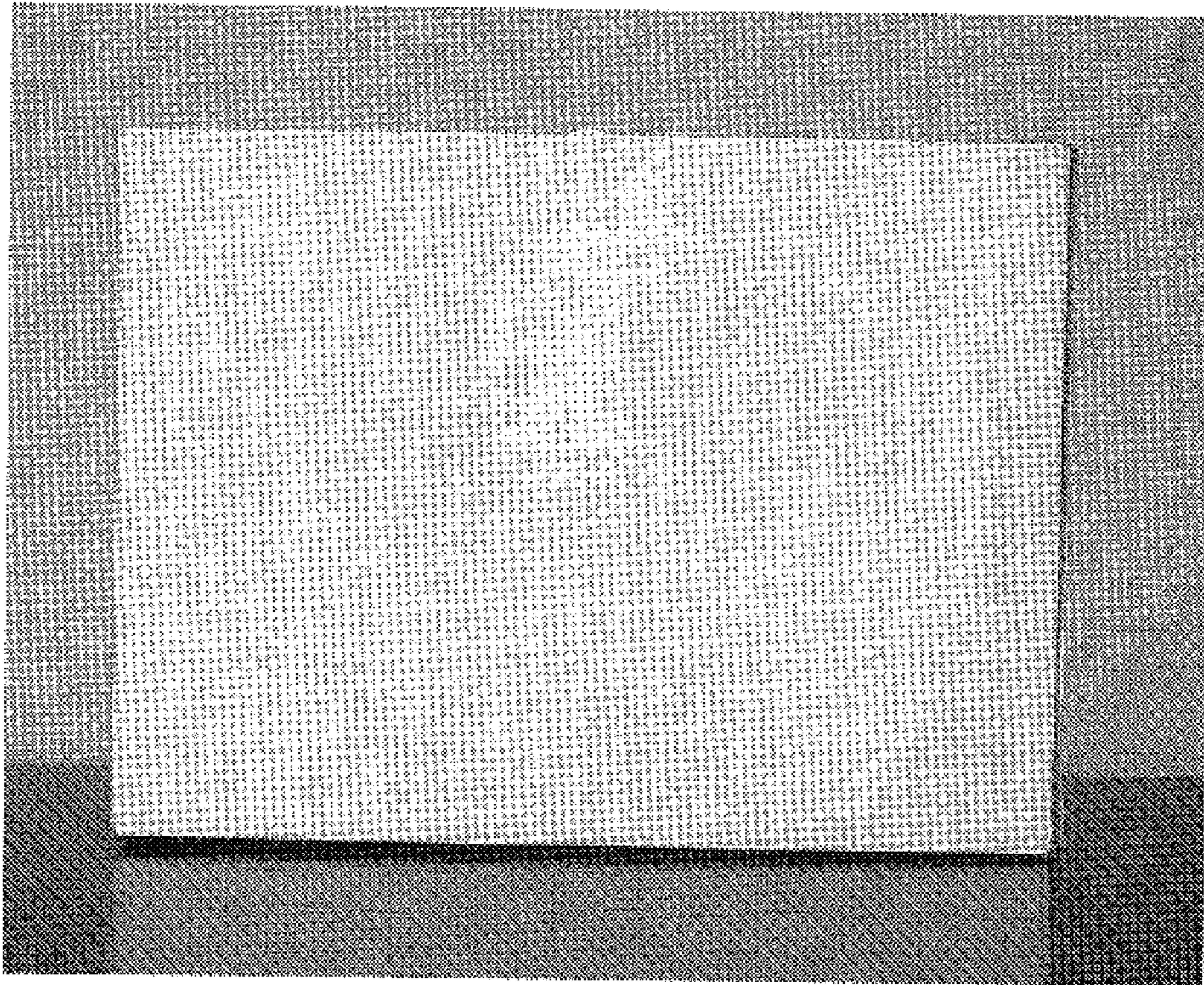

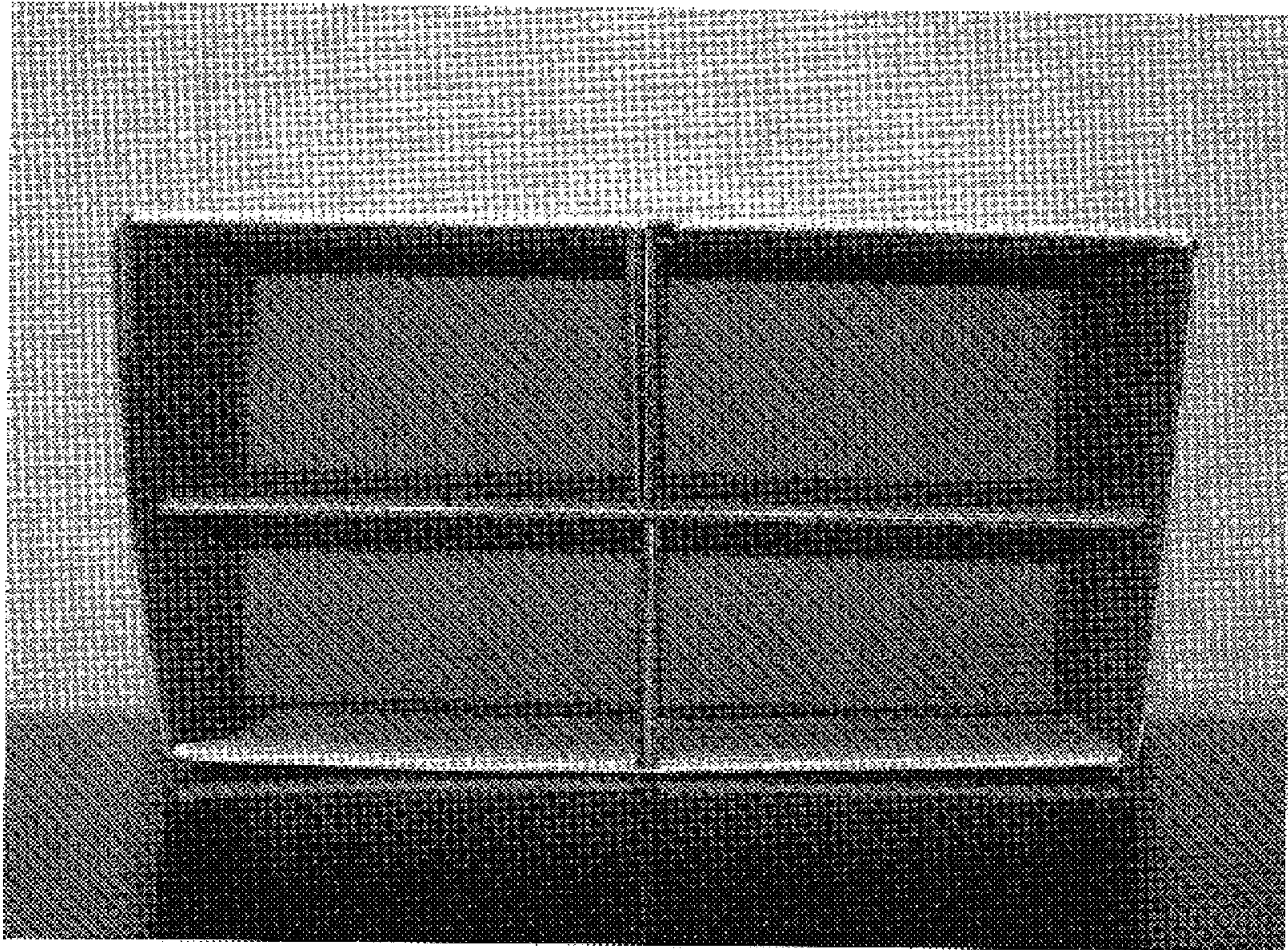

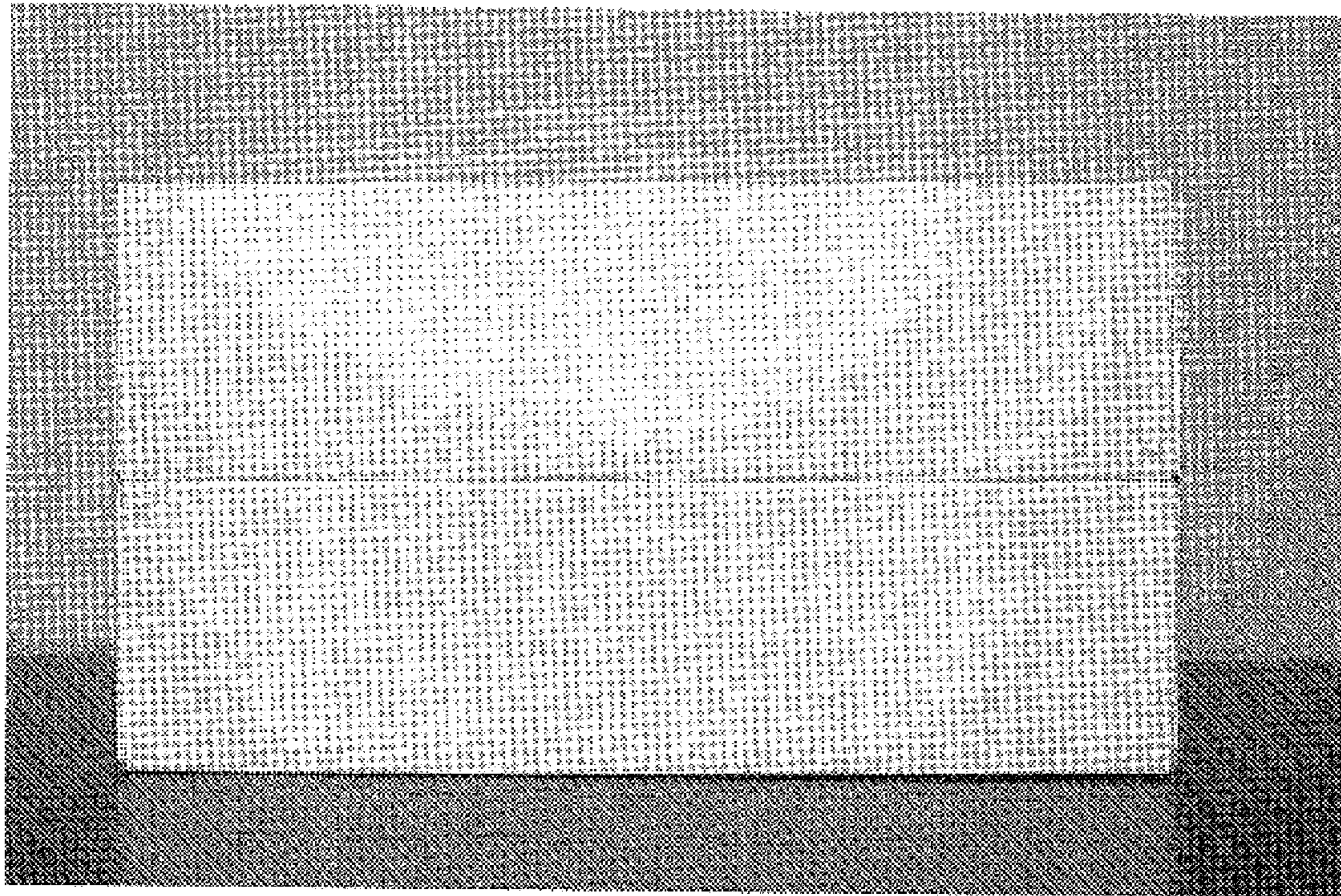

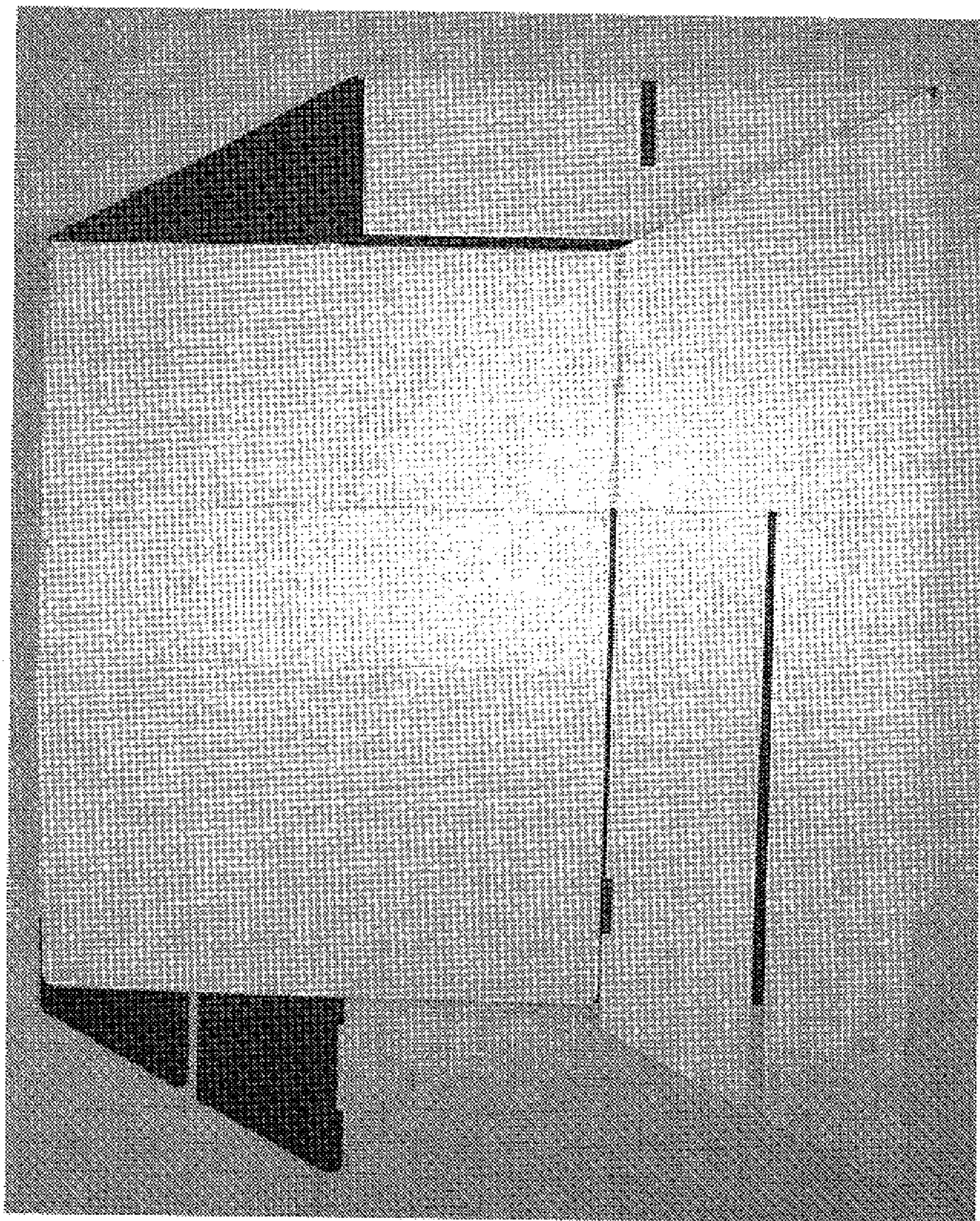
