FIG. 3 is a top plan view thereof;

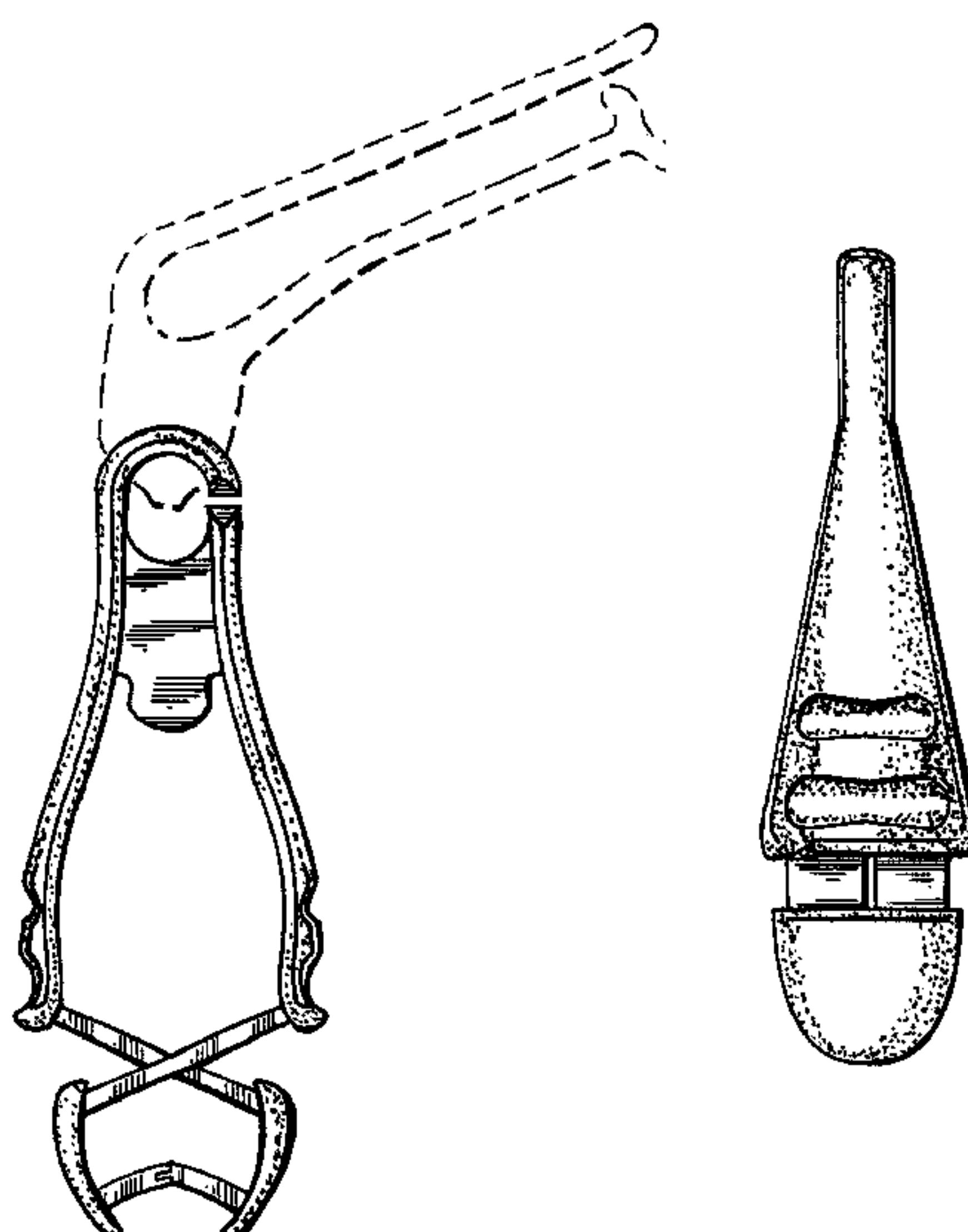
FIG. 4 is a top plan view thereof shown in use interlinked with another different clip;

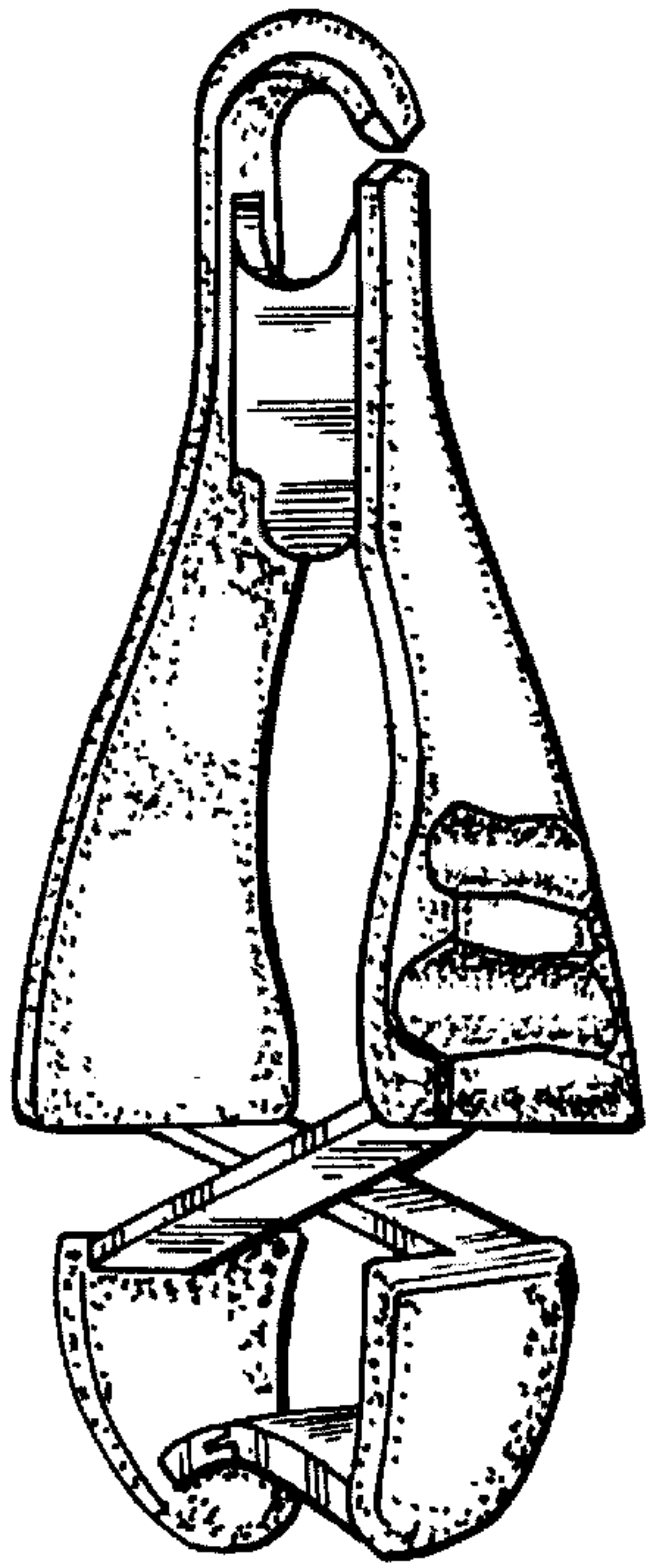
FIG. 5 is a rear elevational view thereof; and,

FIG. 6 is a front elevational view thereof.

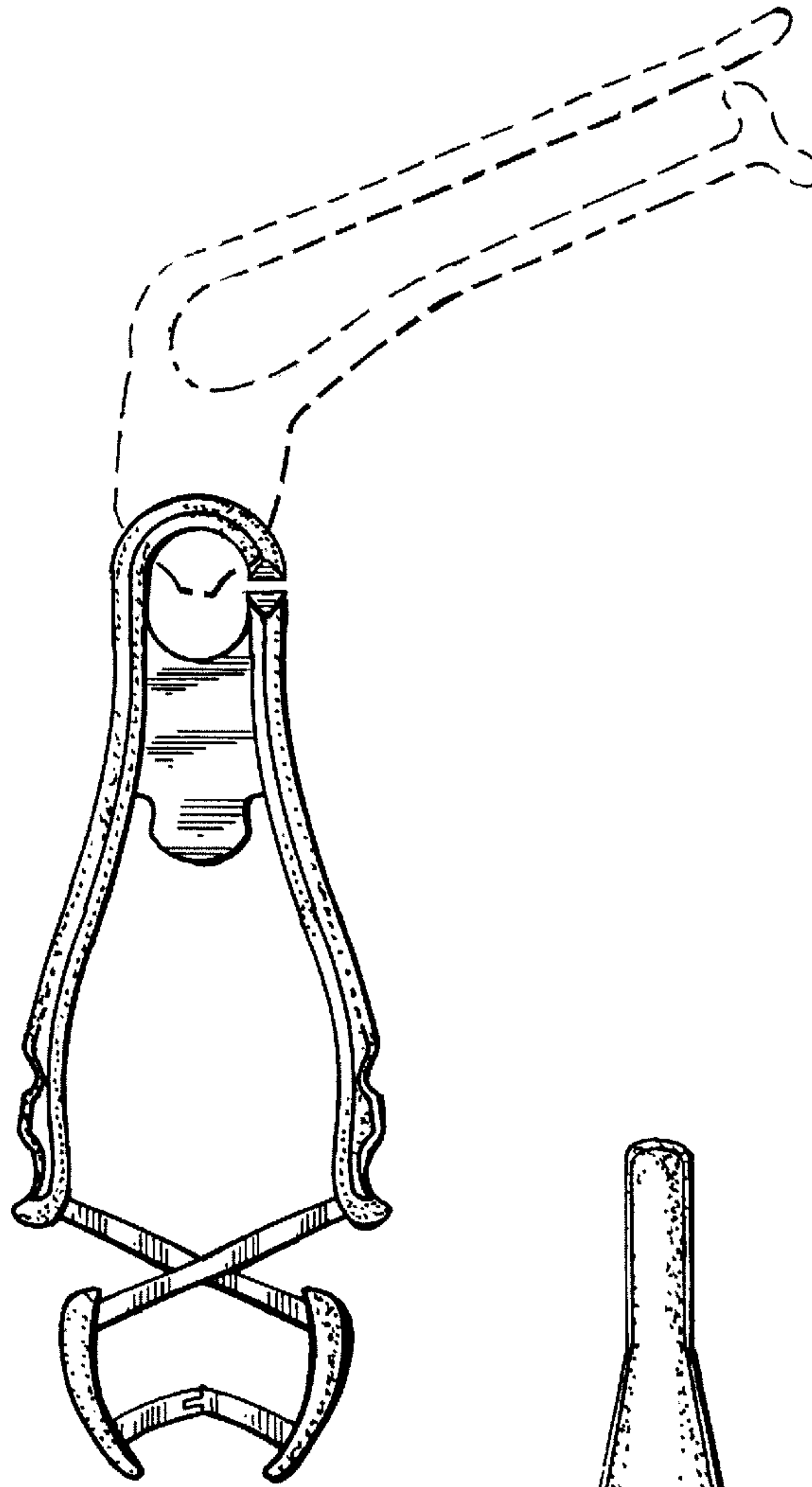
The broken line showing of another different clip in FIGS. 2 and 4 is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

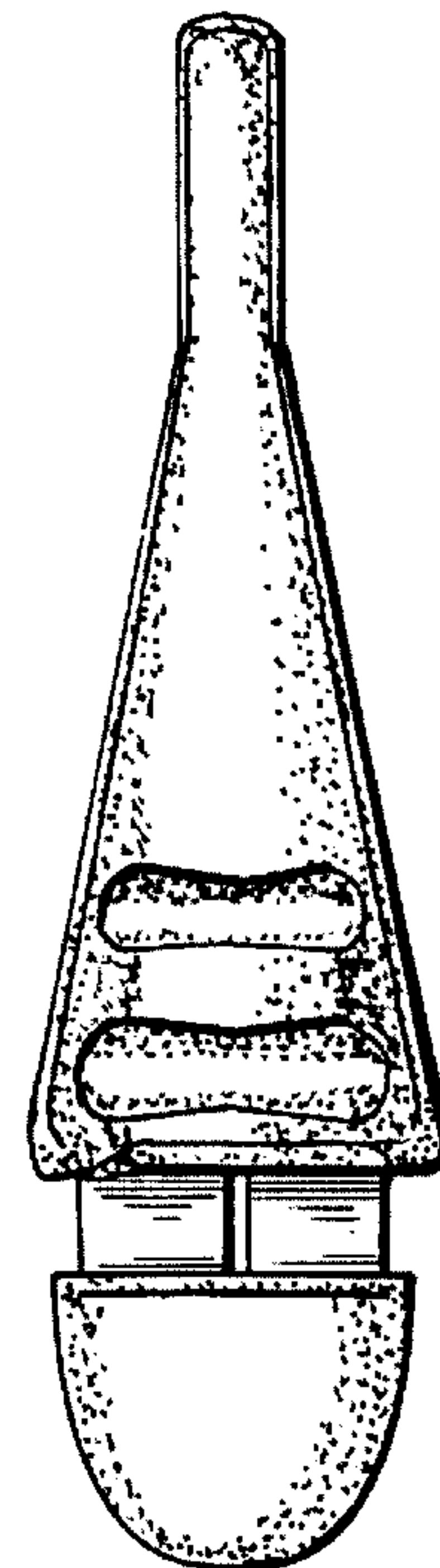




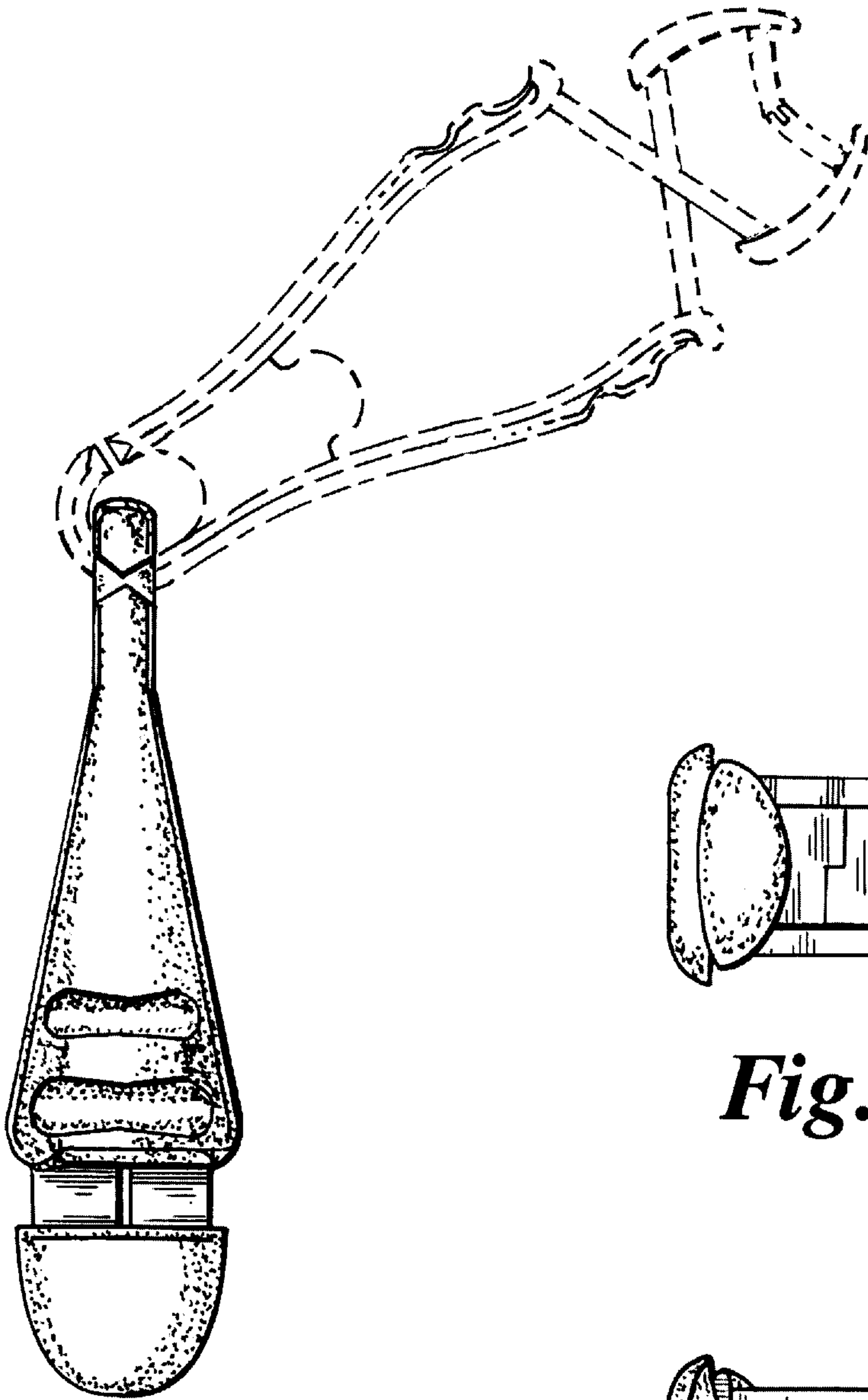

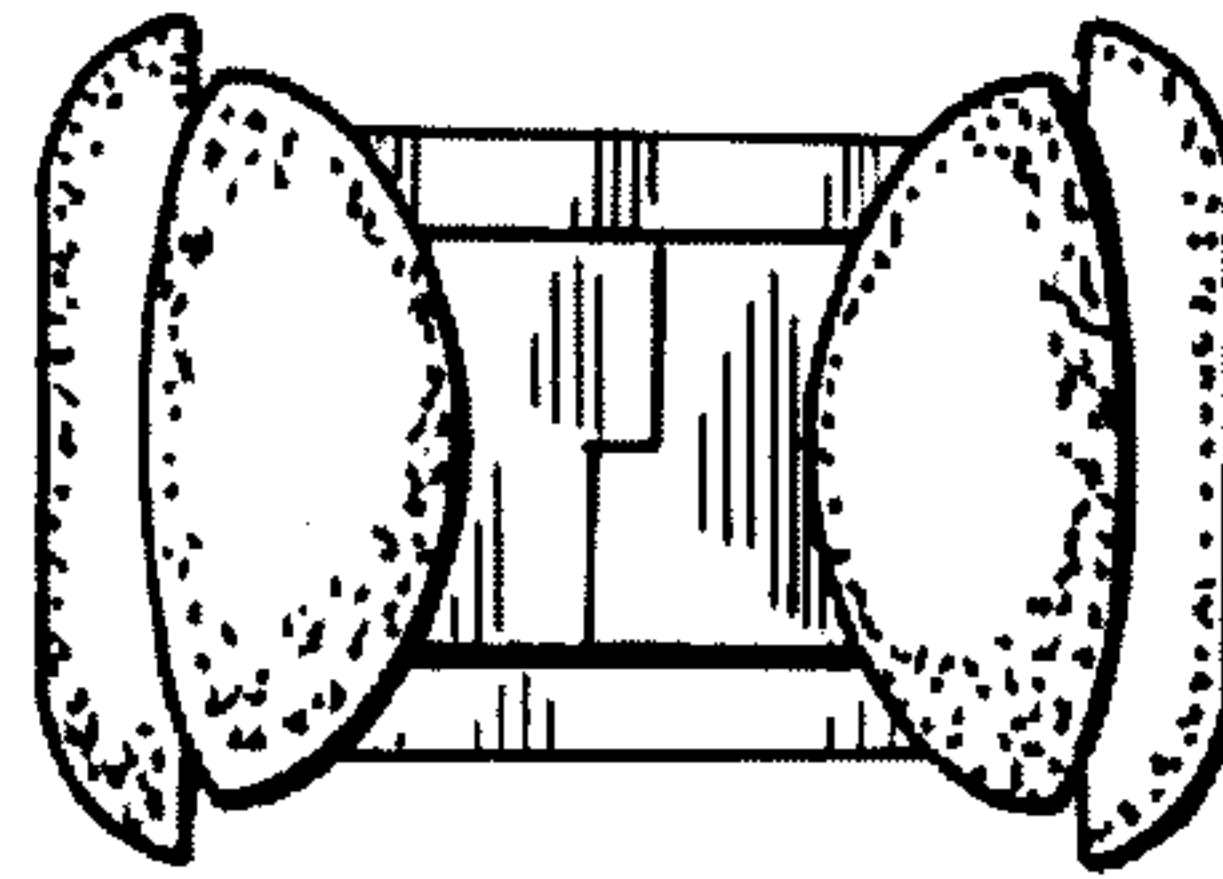

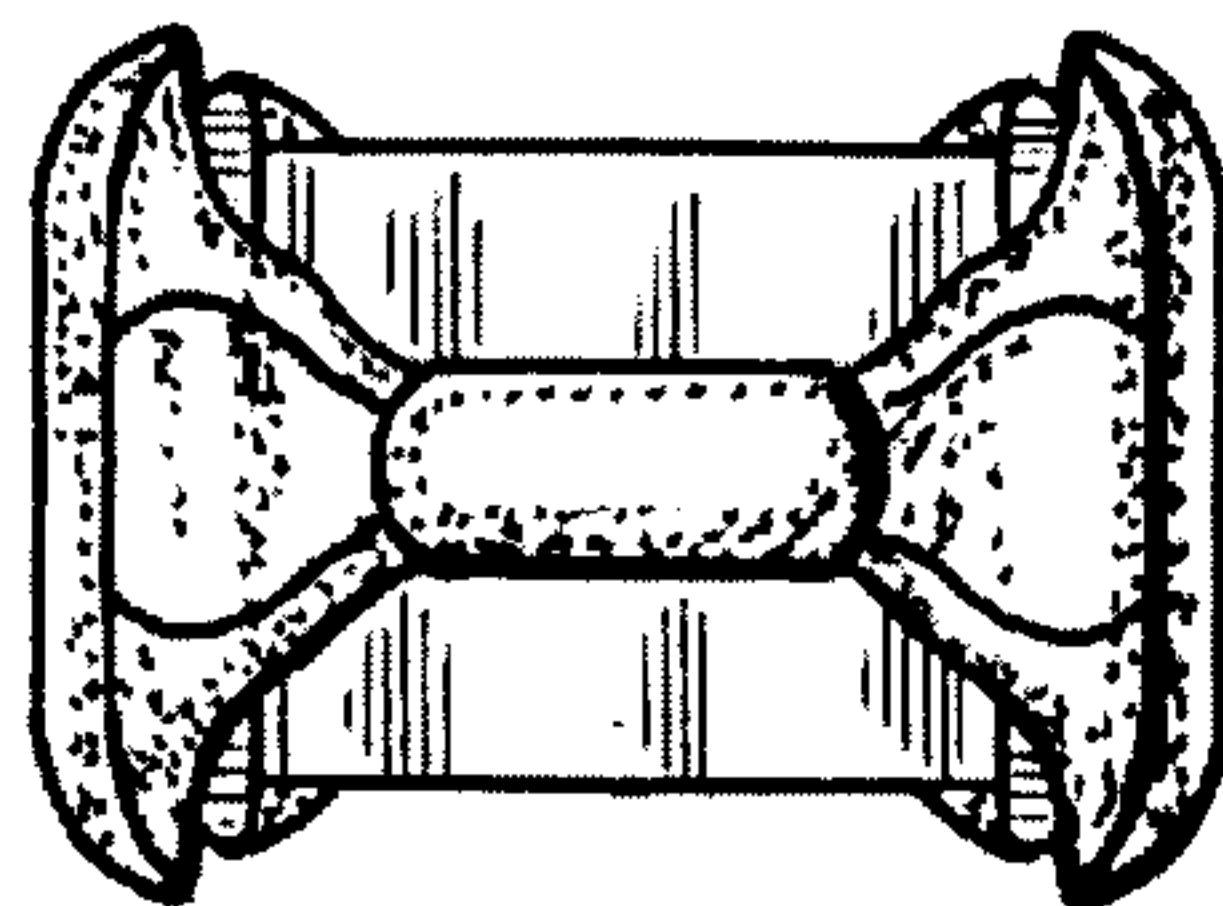
