(57) **CLAIM**

The ornamental design for a fragrance bottle, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a first embodiment of a new design for a fragrance bottle;

FIG. 2 is a front elevation view of the fragrance bottle shown in FIG. 1;

FIG. 3 is a rear elevation view of the fragrance bottle shown in FIG. 1;

FIG. 4 is a right side elevation view of the fragrance bottle shown in FIG. 1;

FIG. 5 is a left side elevation view of the fragrance bottle shown in FIG. 1;

FIG. 6 is a top plan view of the fragrance bottle shown in FIG. 1;

FIG. 7 is a bottom plan view of the fragrance bottle shown in FIG. 1;

FIG. 8 is a top, front and right side perspective view of a second embodiment of a new design for a fragrance bottle;

FIG. 9 is a front elevation view of the fragrance bottle shown in FIG. 8;

FIG. 10 is a rear elevation view of the fragrance bottle shown in FIG. 8;

FIG. 11 is a right side elevation view of the fragrance bottle shown in FIG. 8;

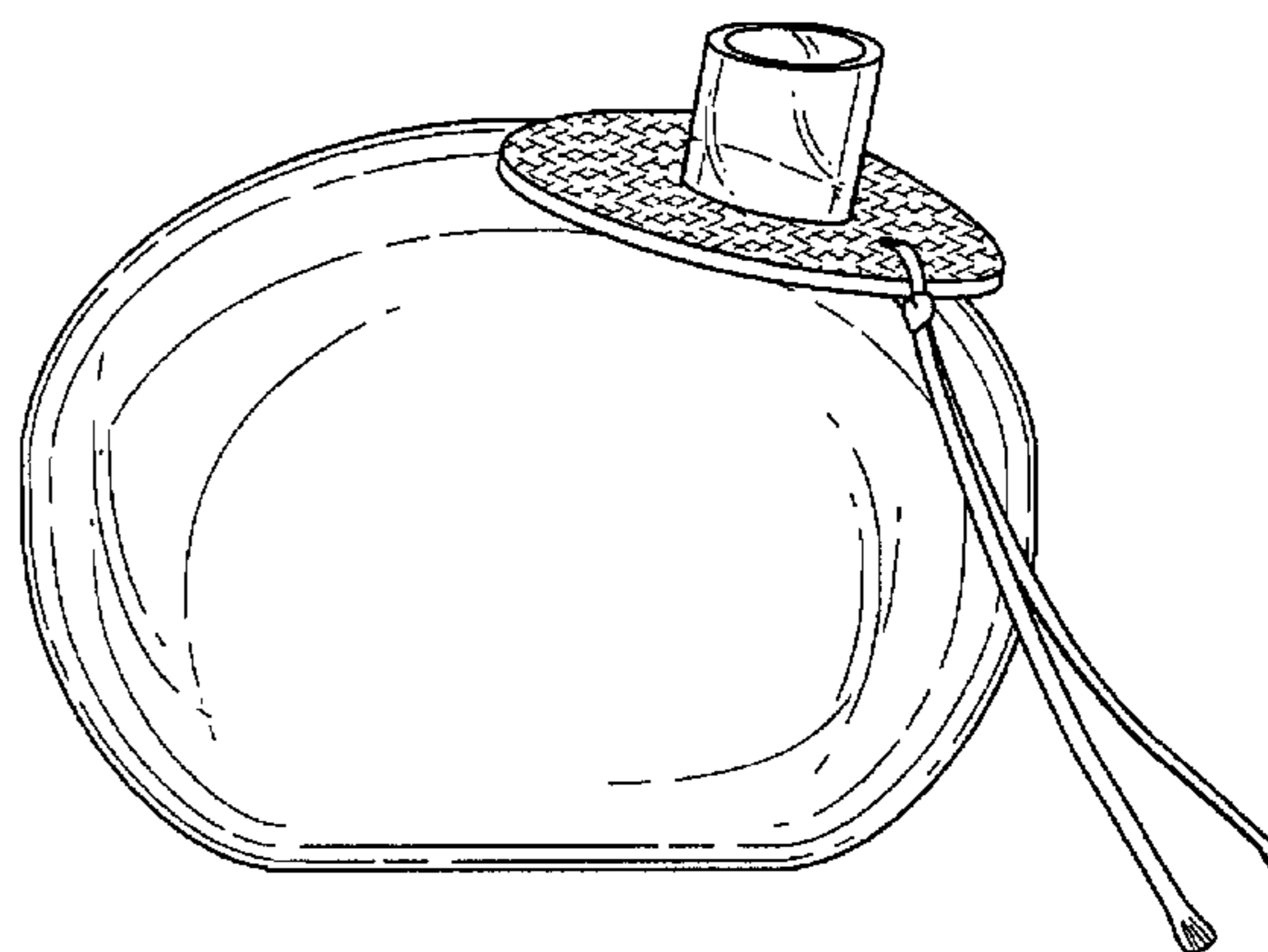
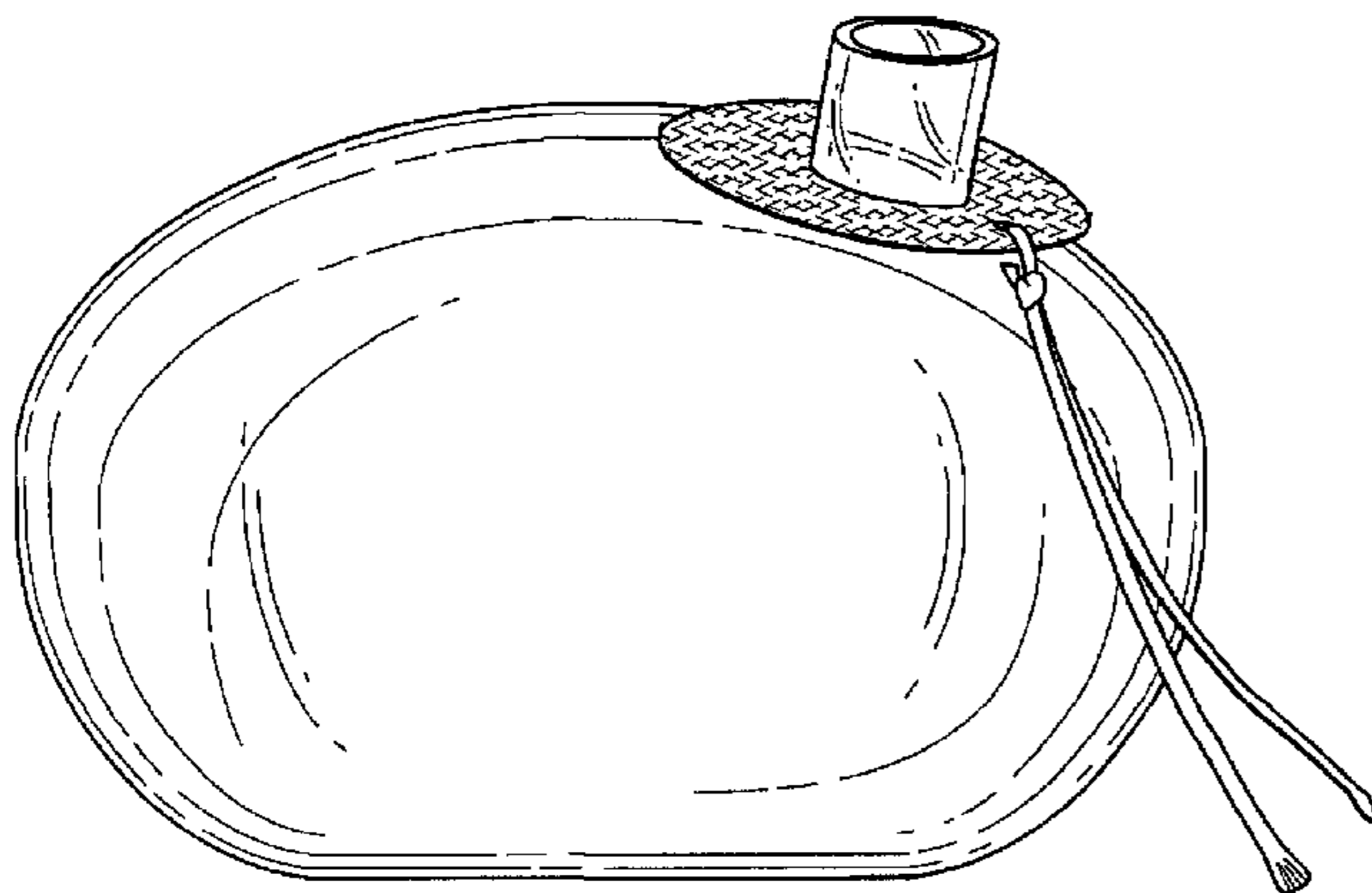
FIG. 12 is a left side elevation view of the fragrance bottle shown in FIG. 8;

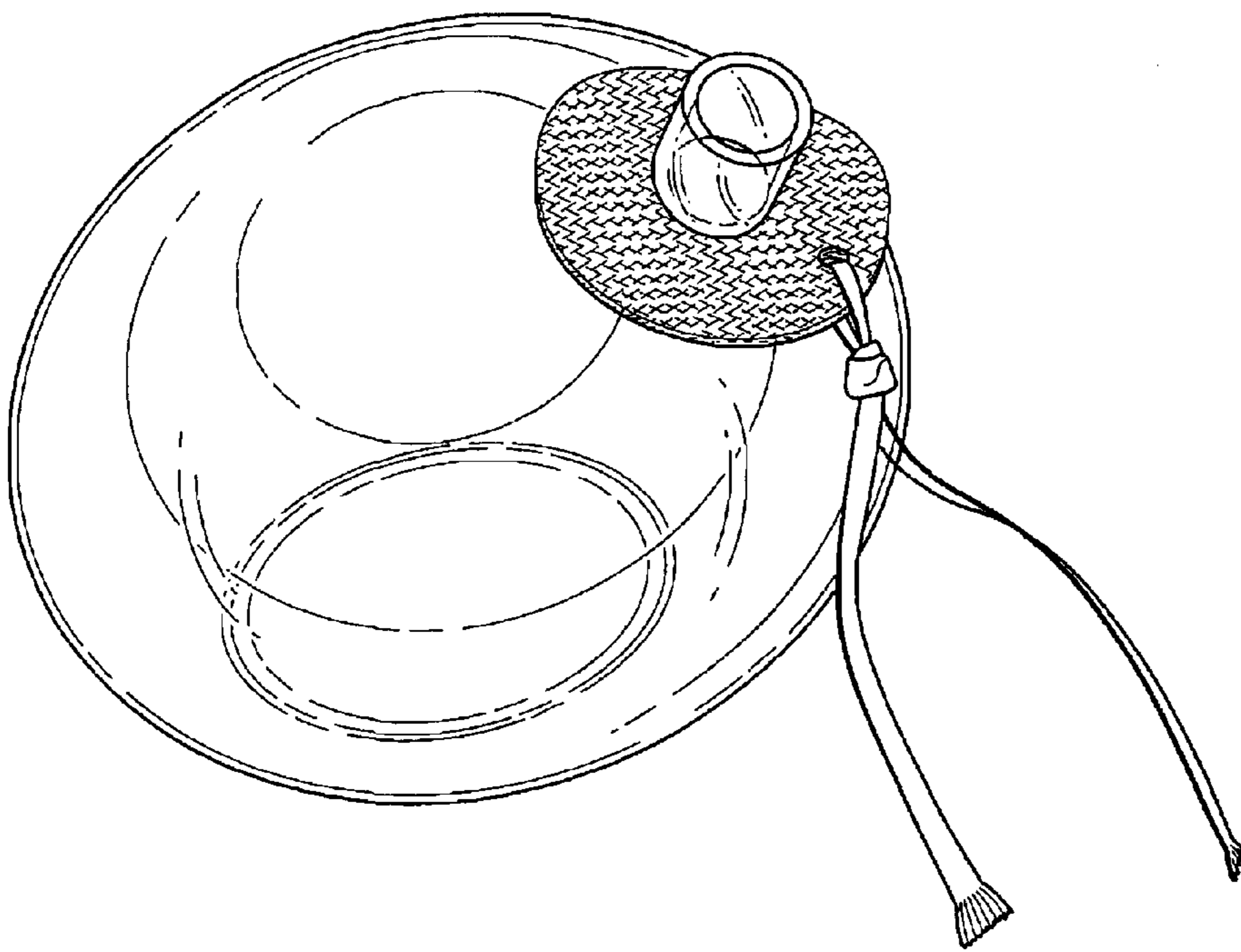

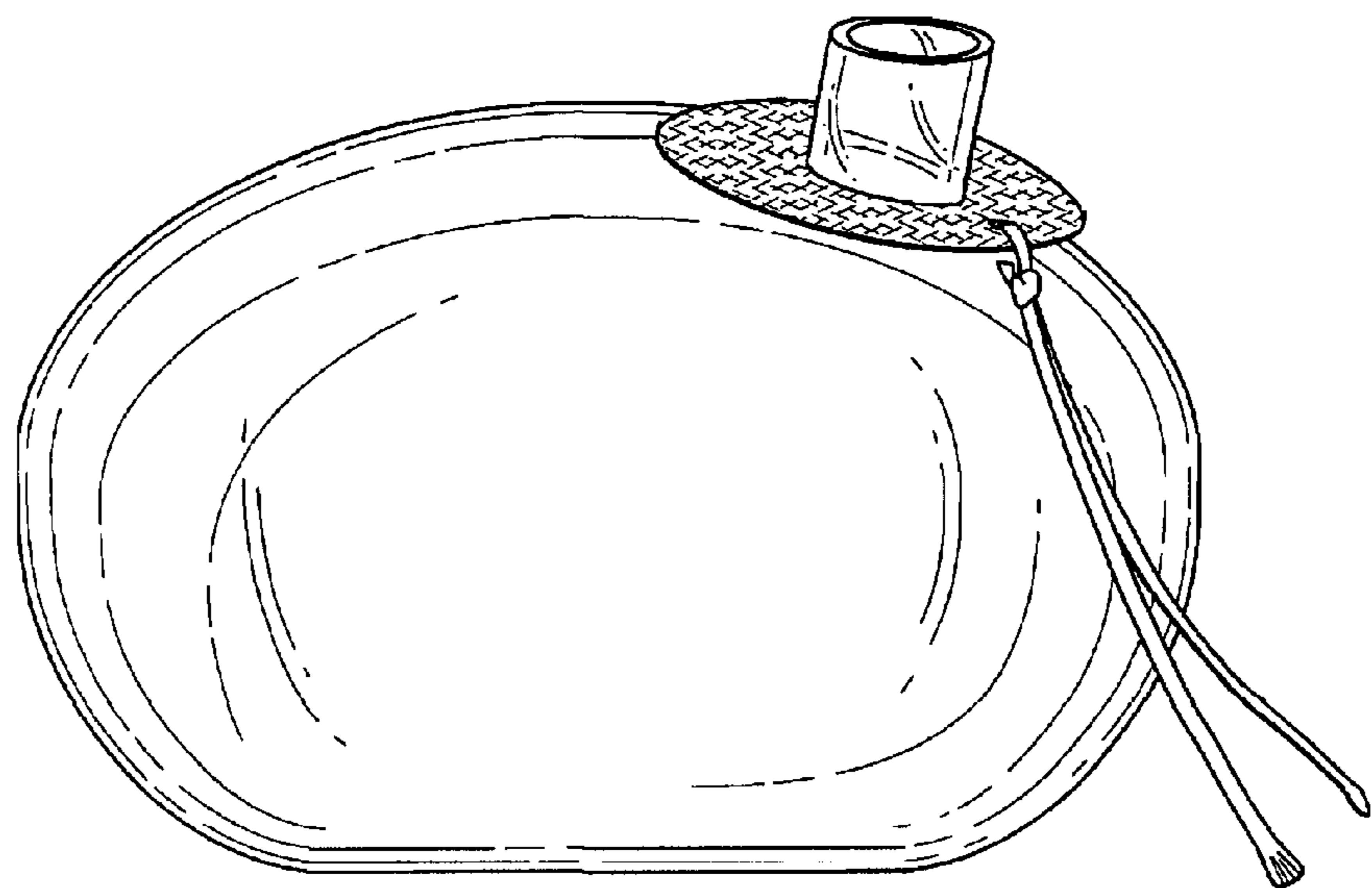

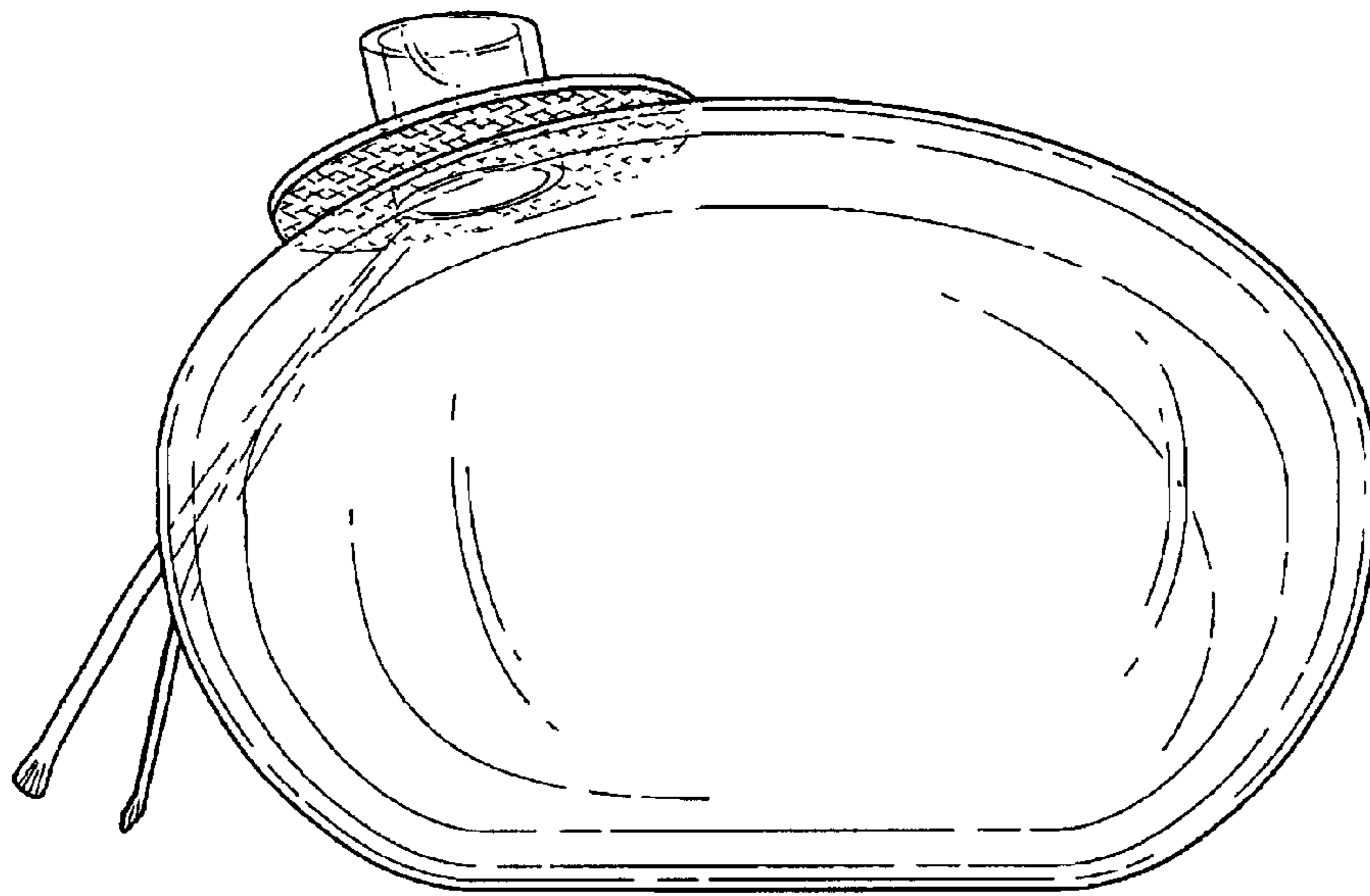

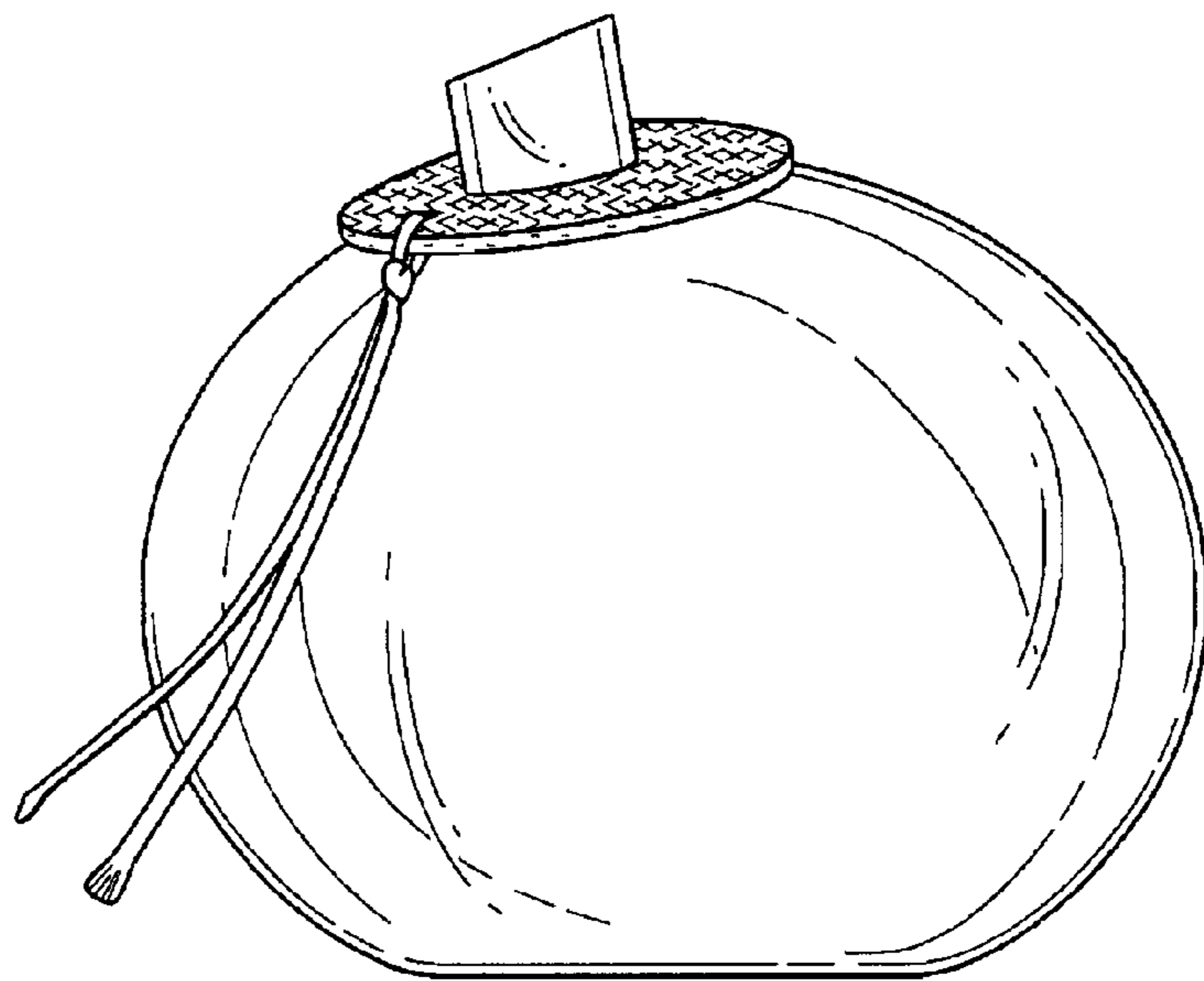

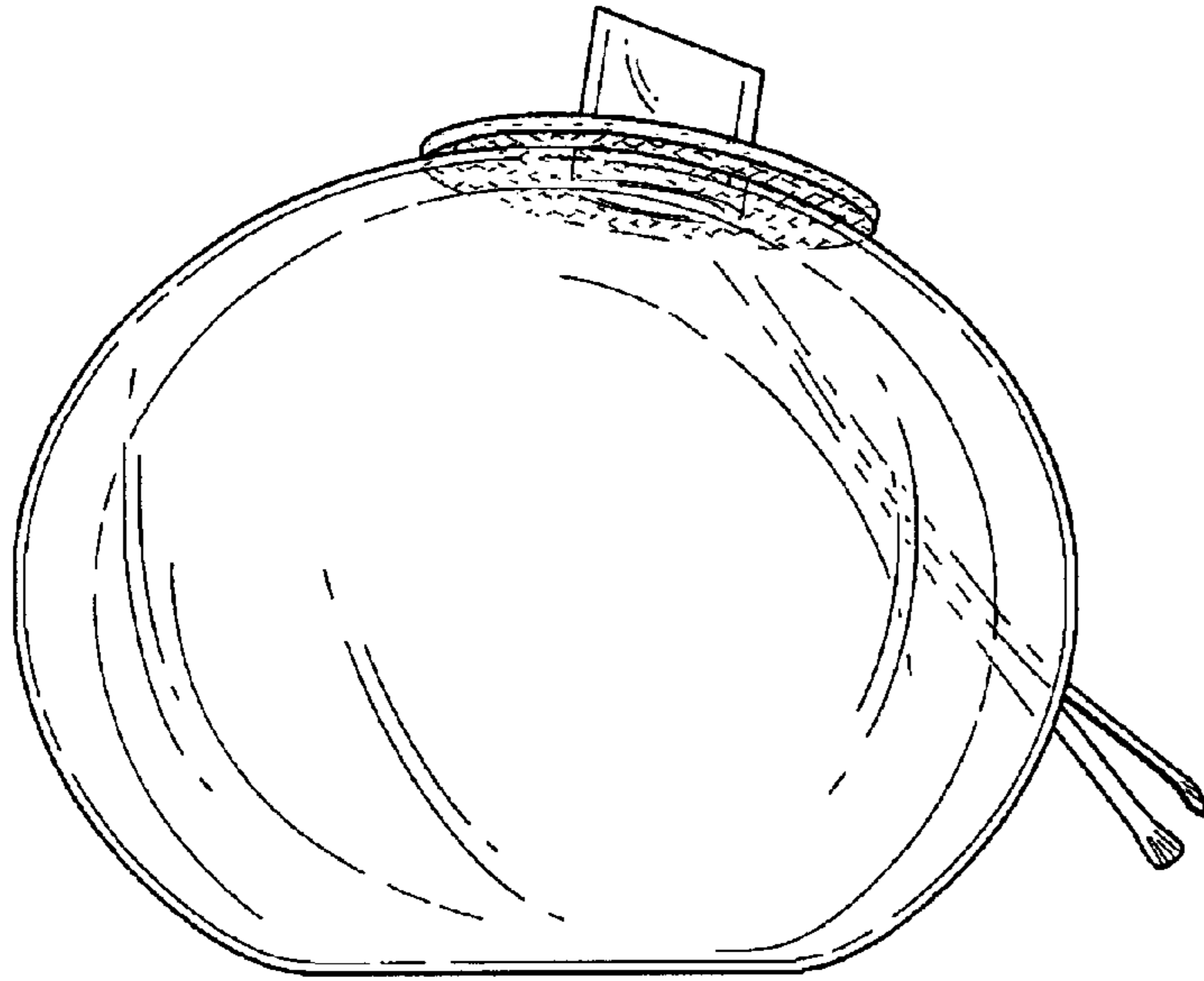

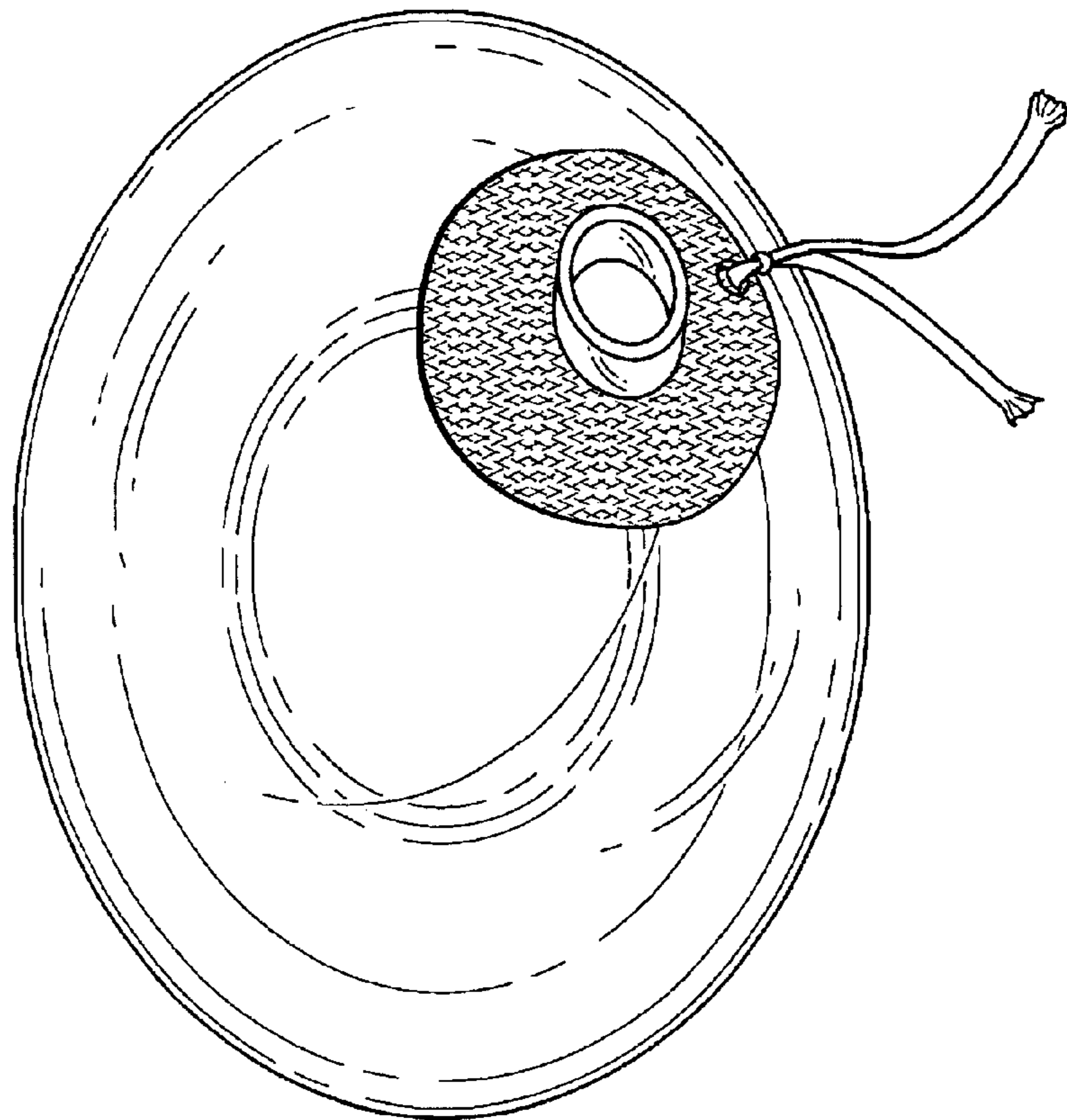

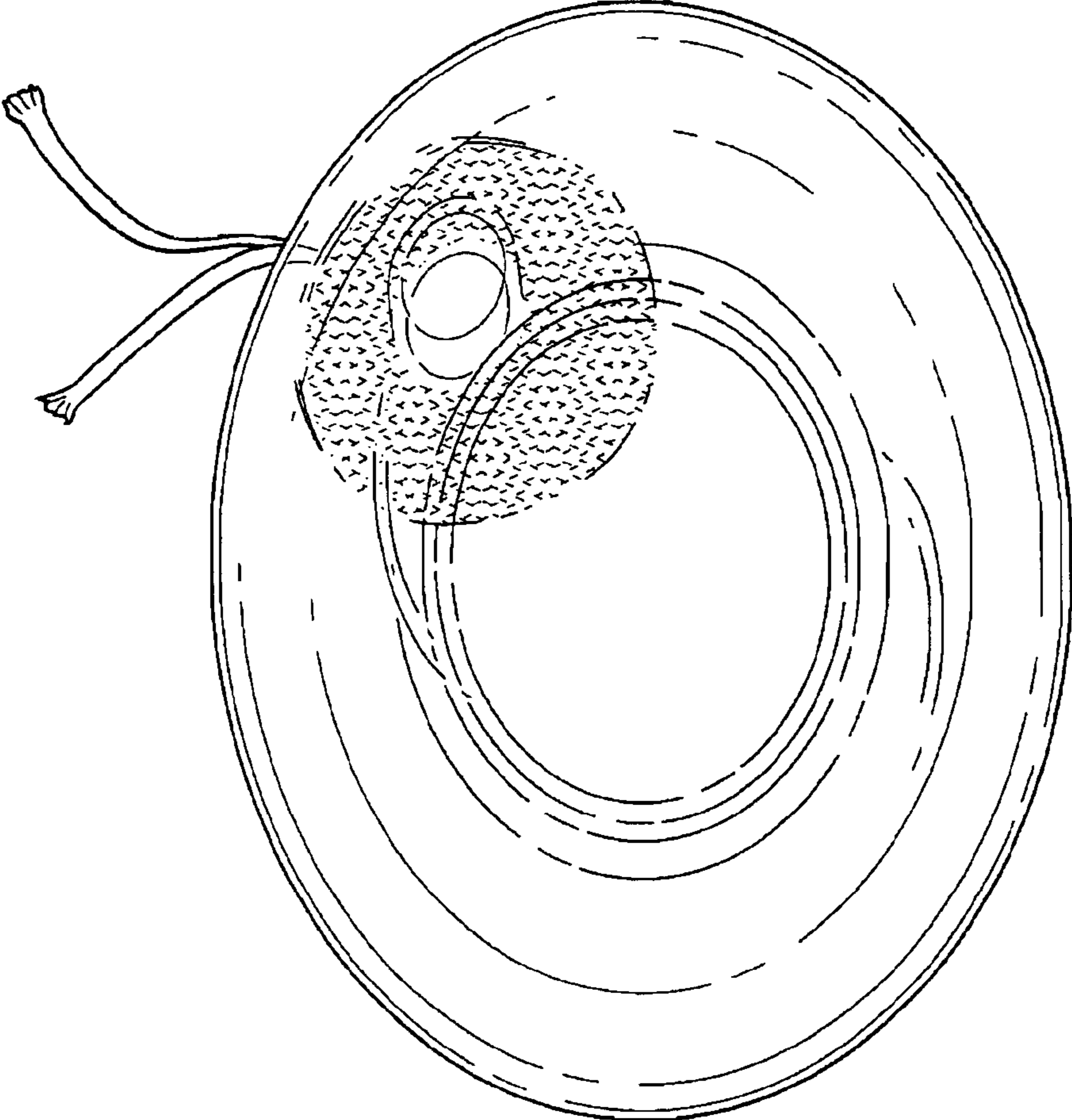

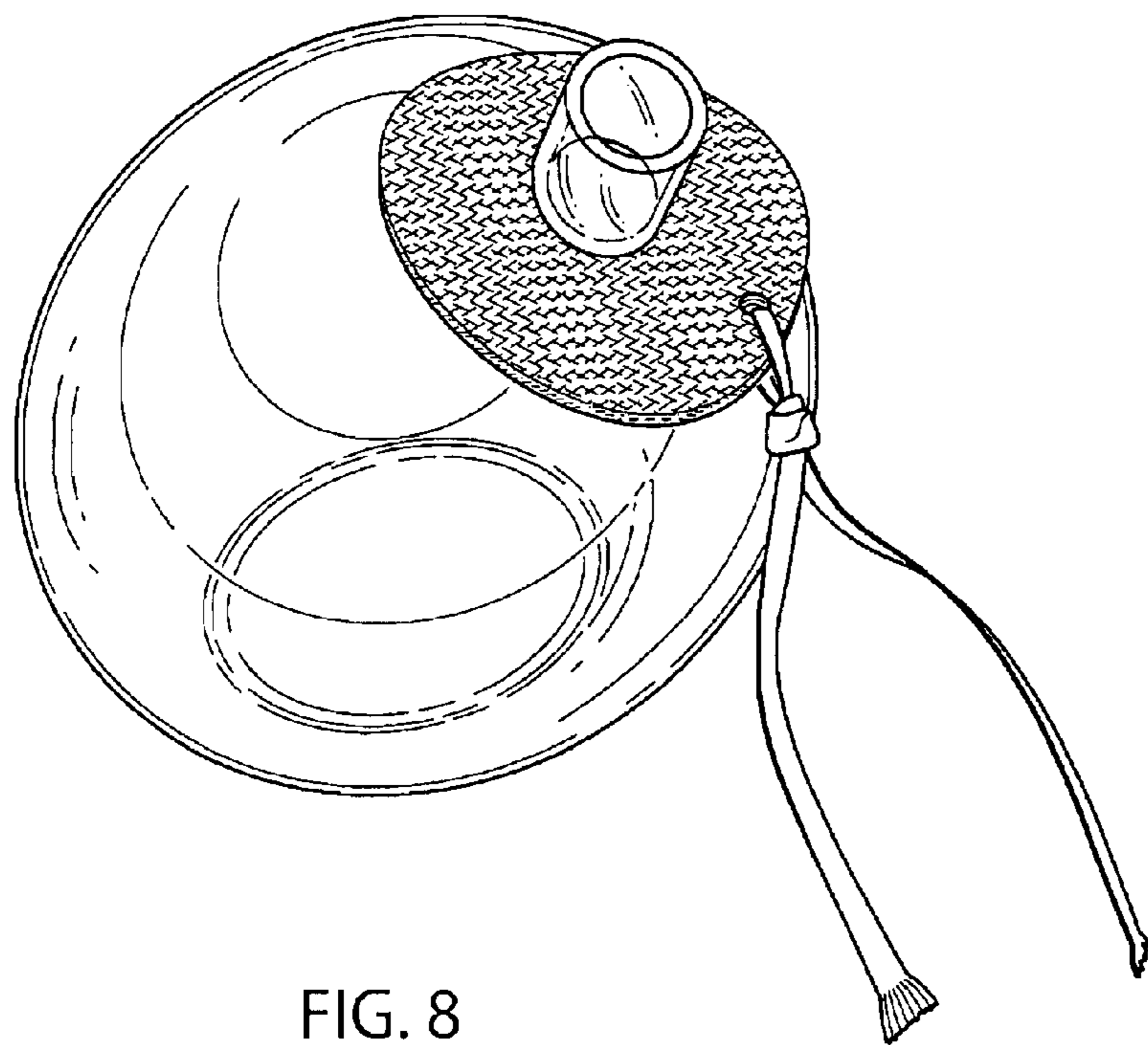

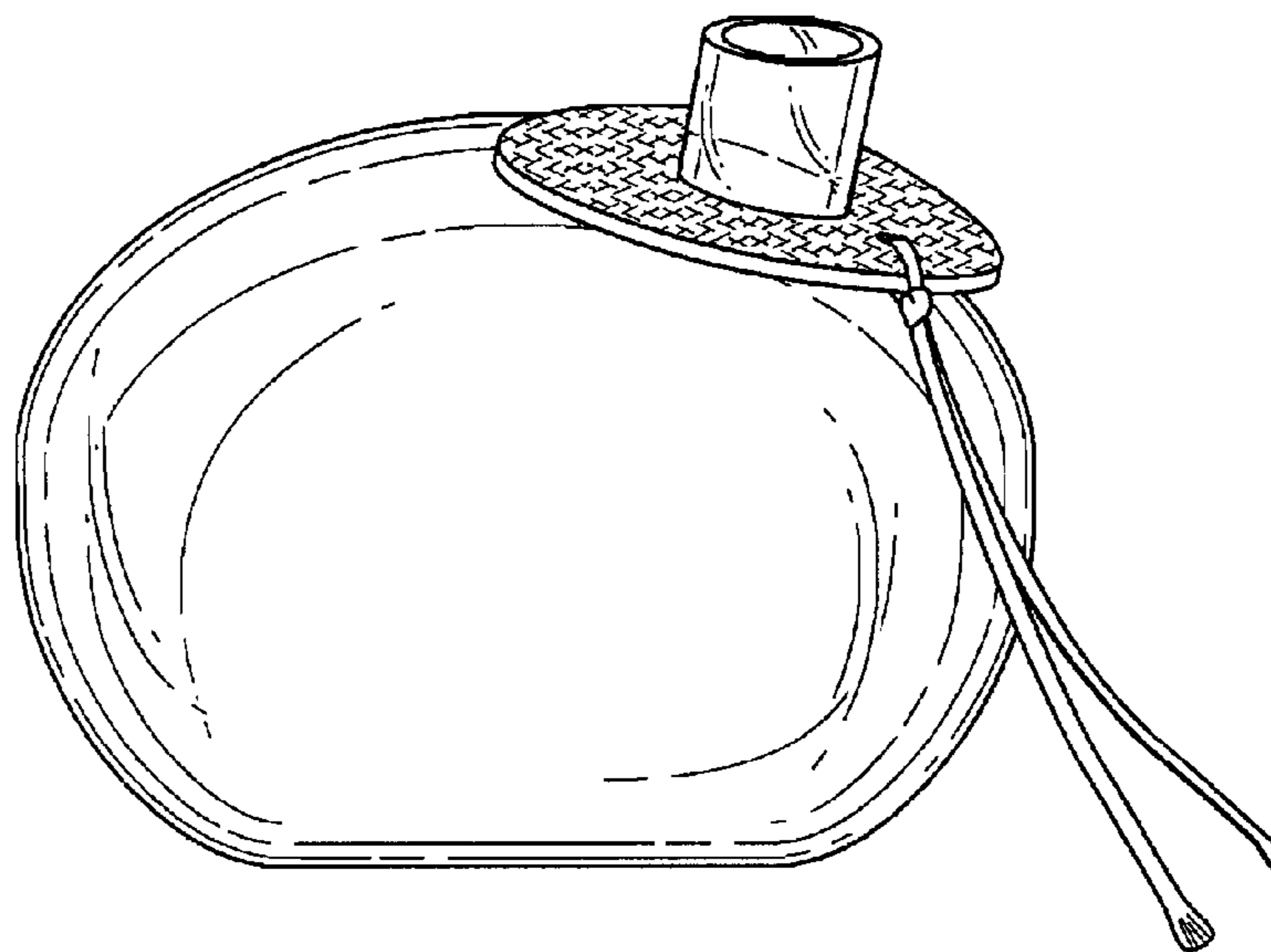

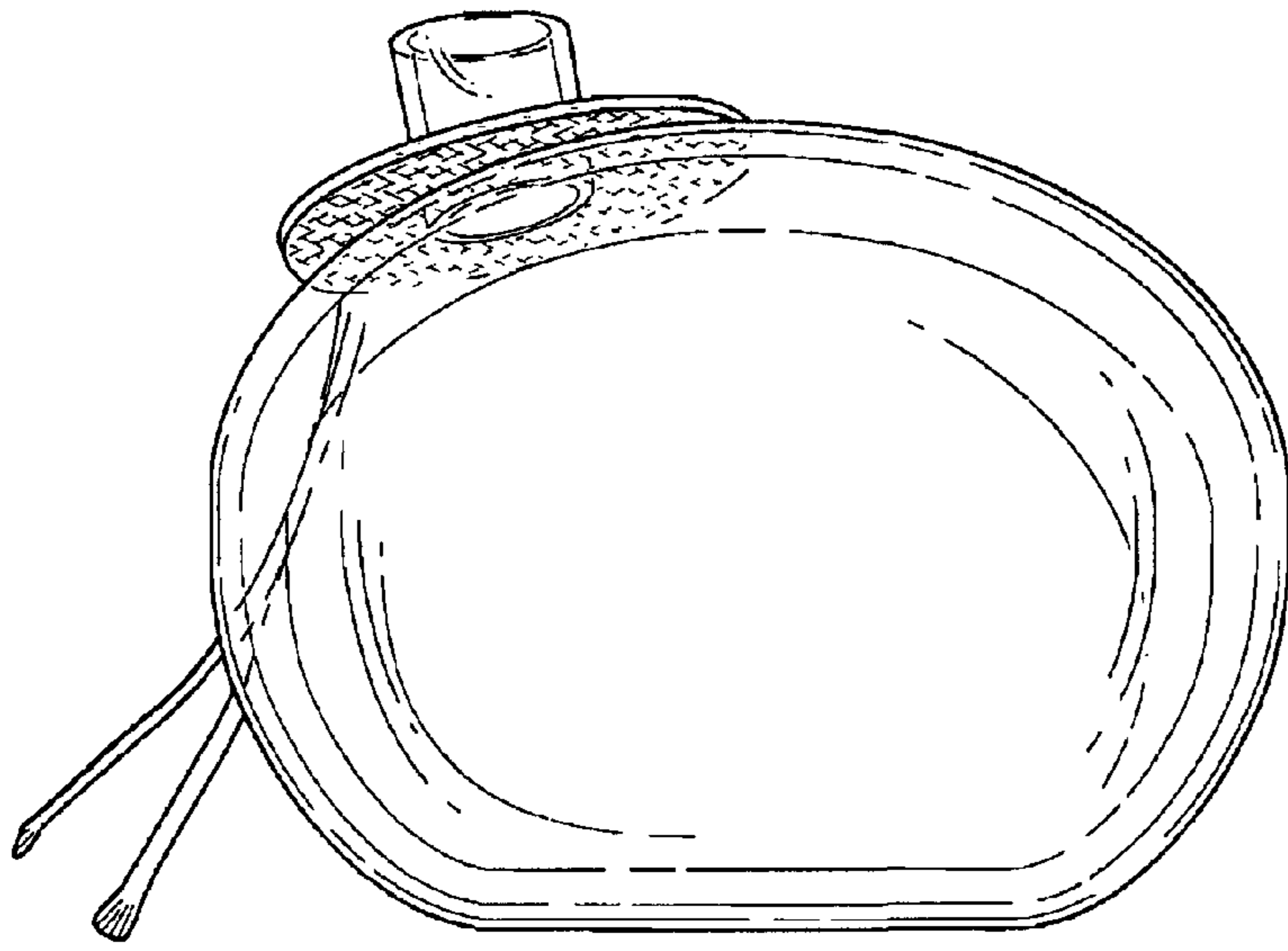

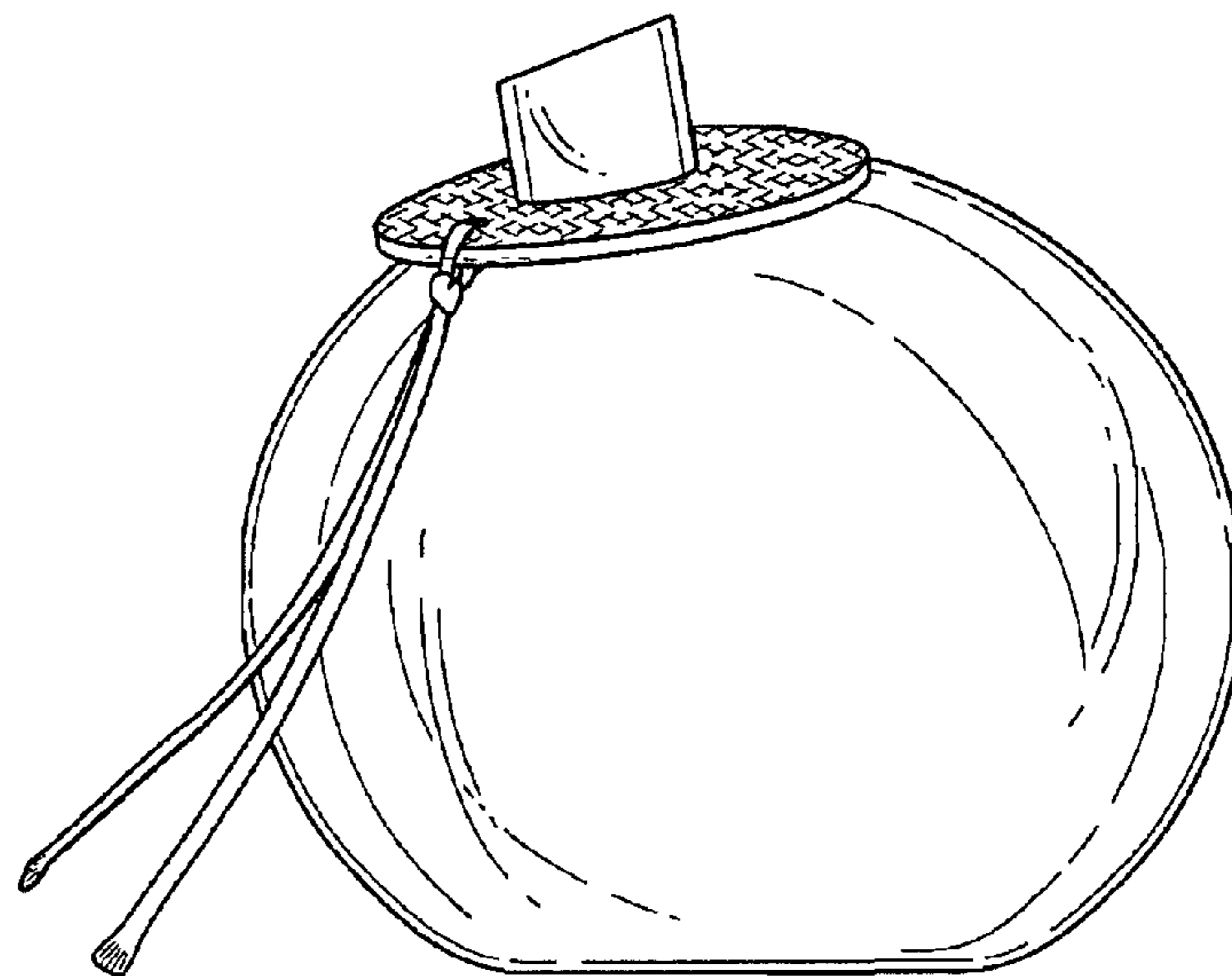

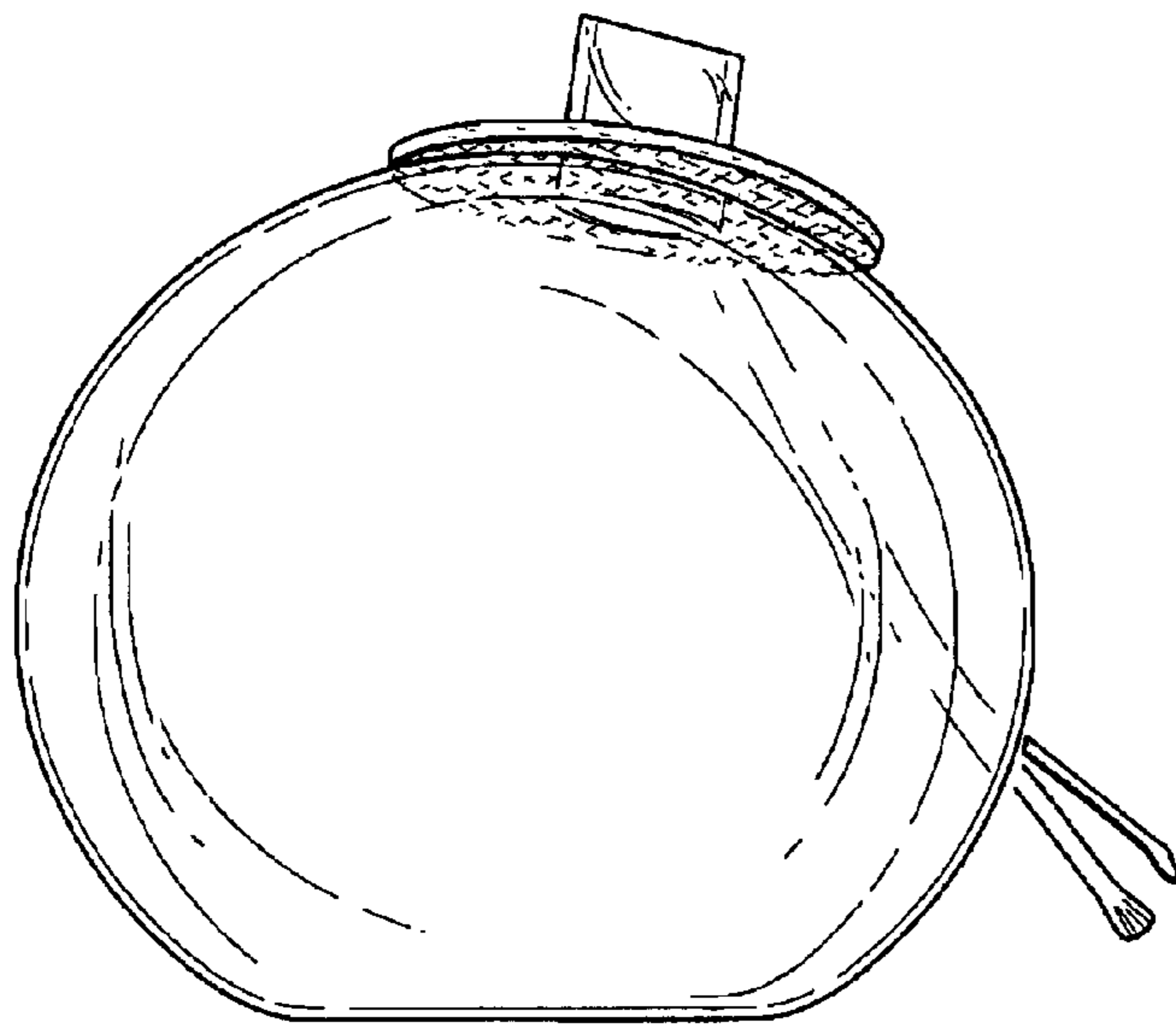

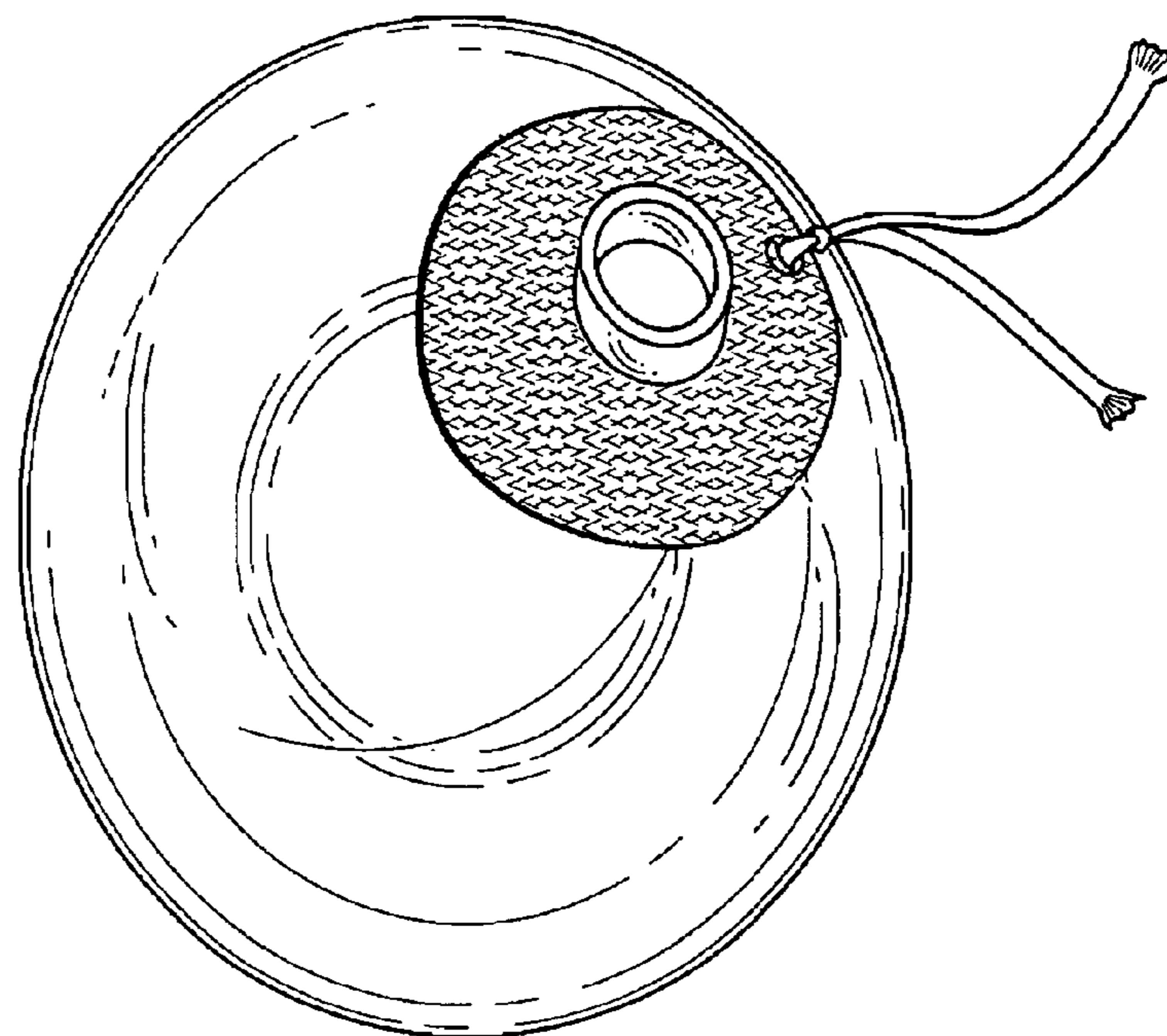

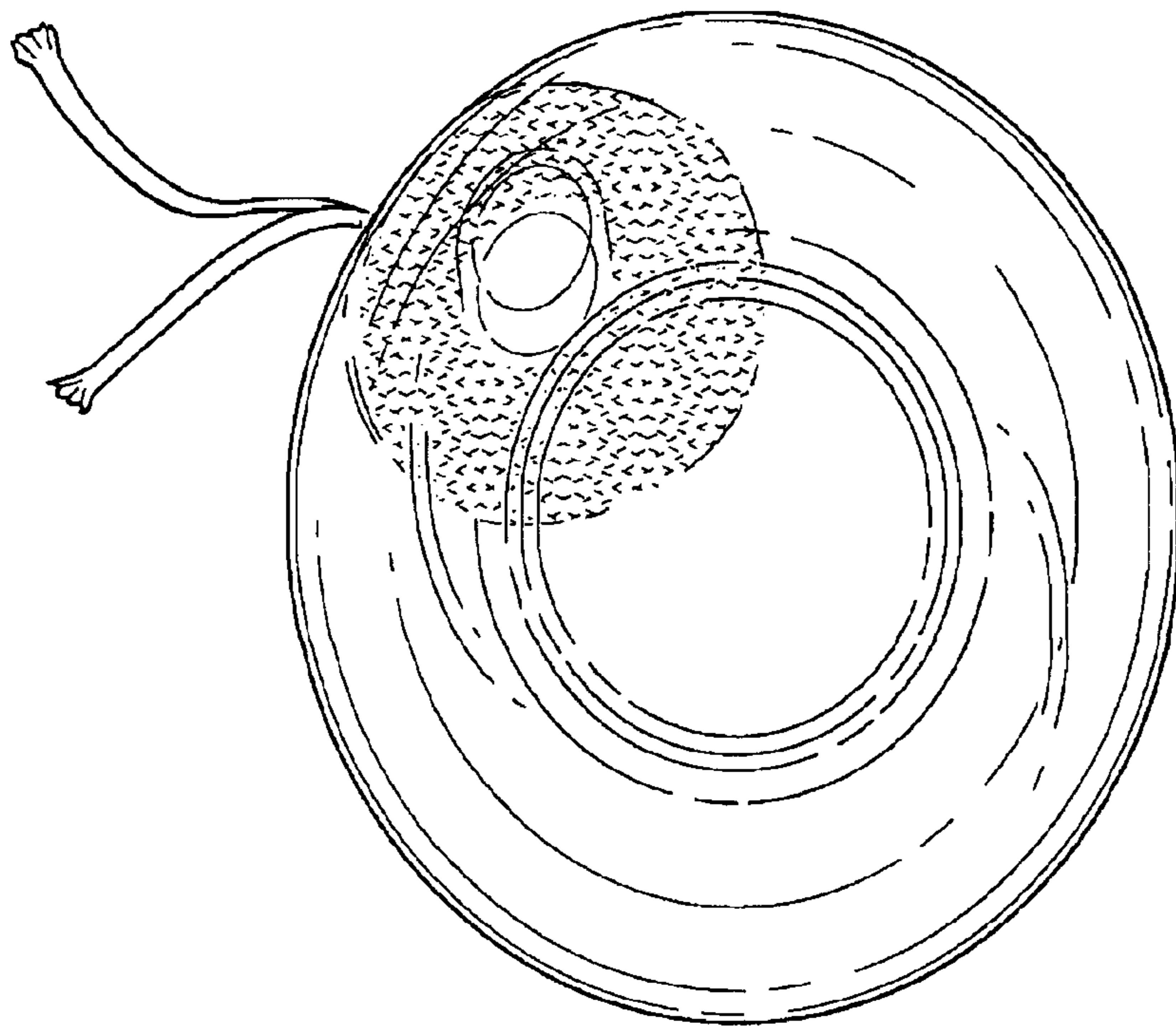
