We claim the ornamental design for a bottle, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a bottle, according to the present invention;

FIG. 2 is a left side elevational view of the bottle of FIG. 1;

FIG. 3 is a right side elevational view of the bottle of FIG. 1;

FIG. 4 is a front elevational view of the bottle of FIG. 1;

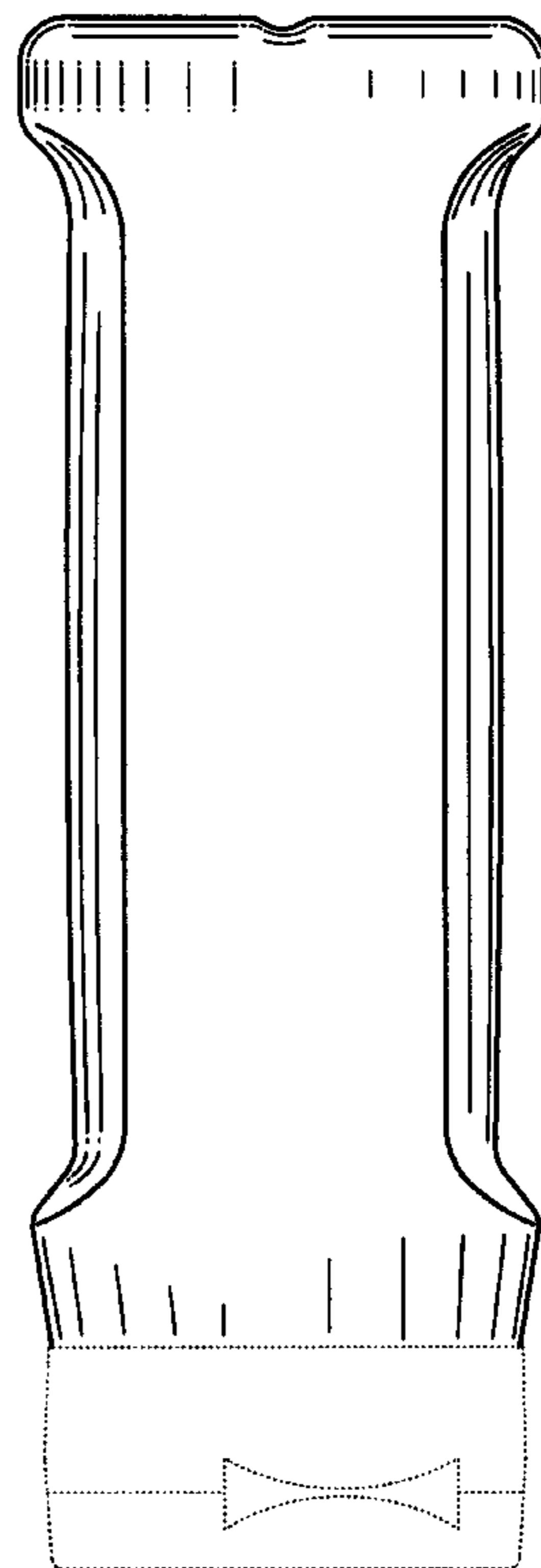
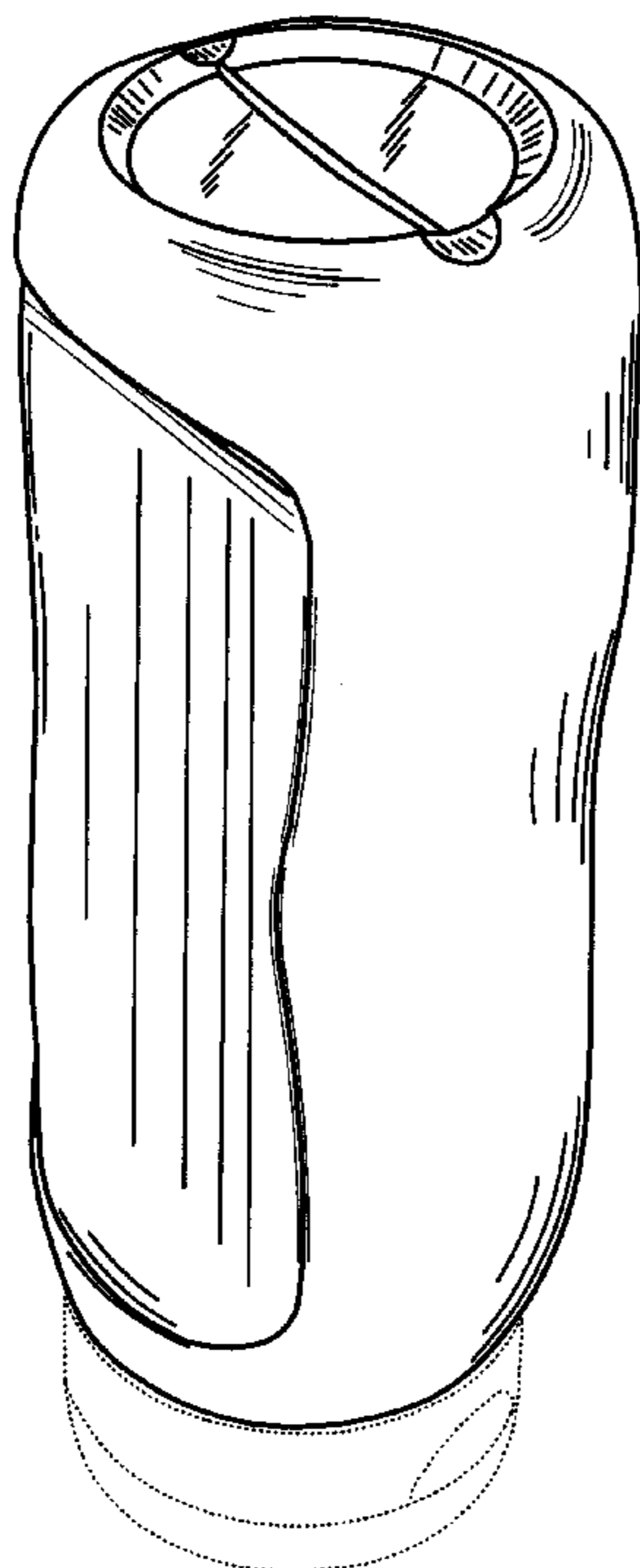
FIG. 5 is a rear elevational view of the bottle of FIG. 1;

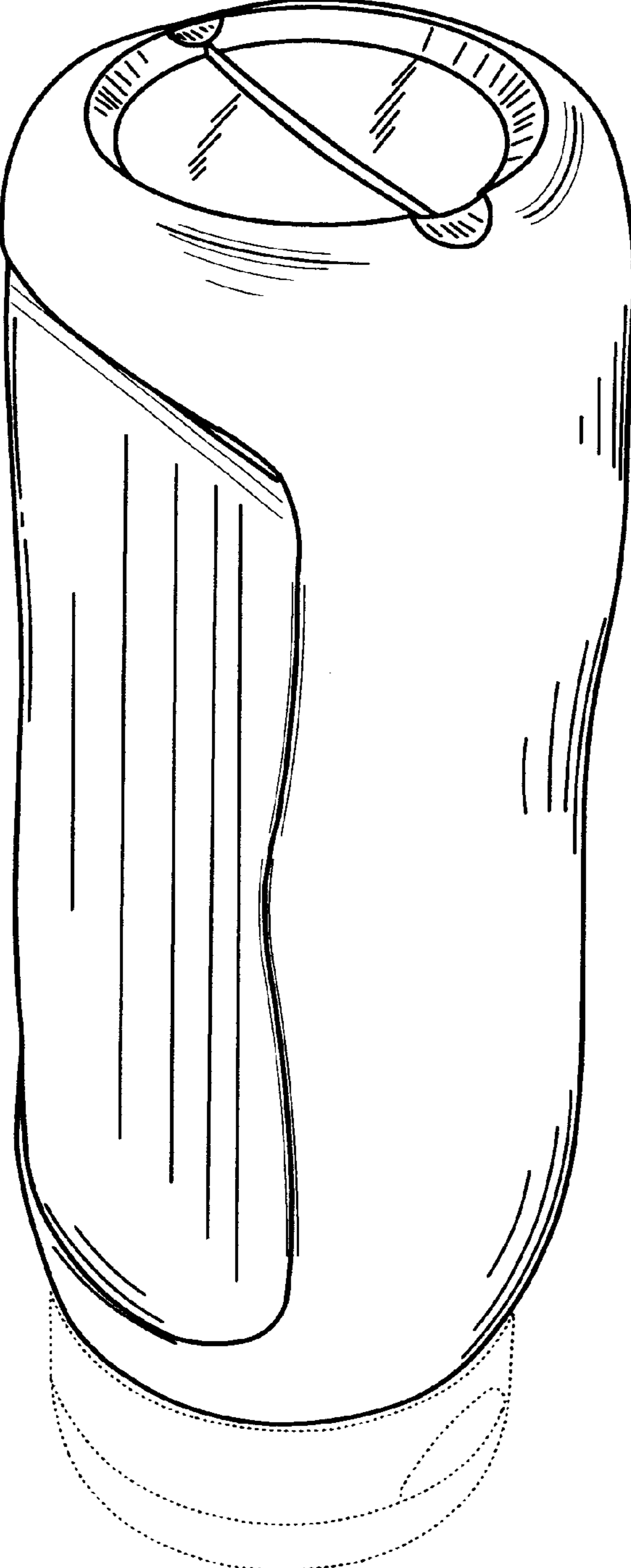

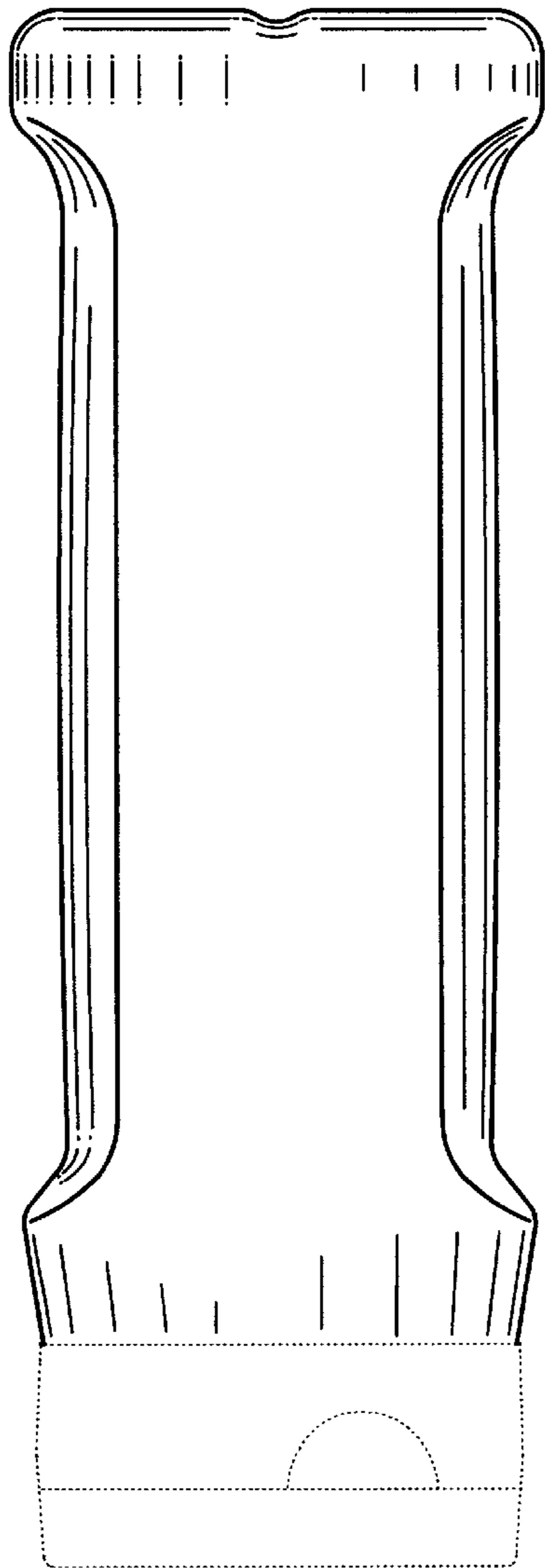

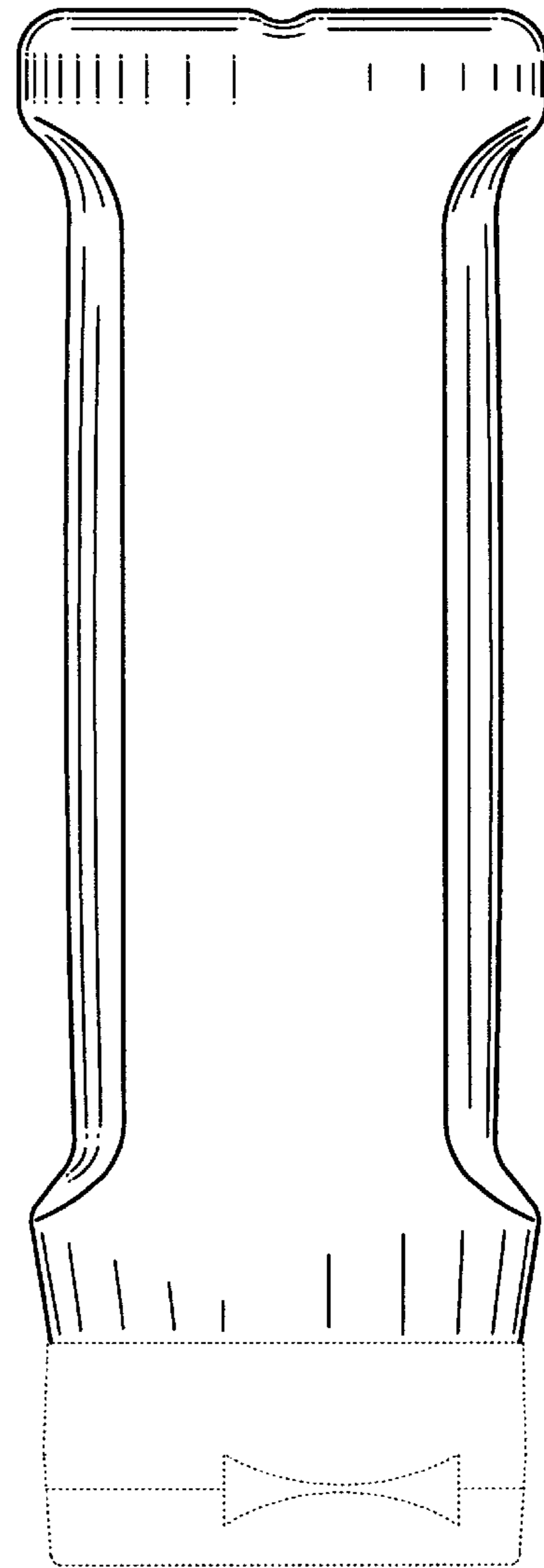

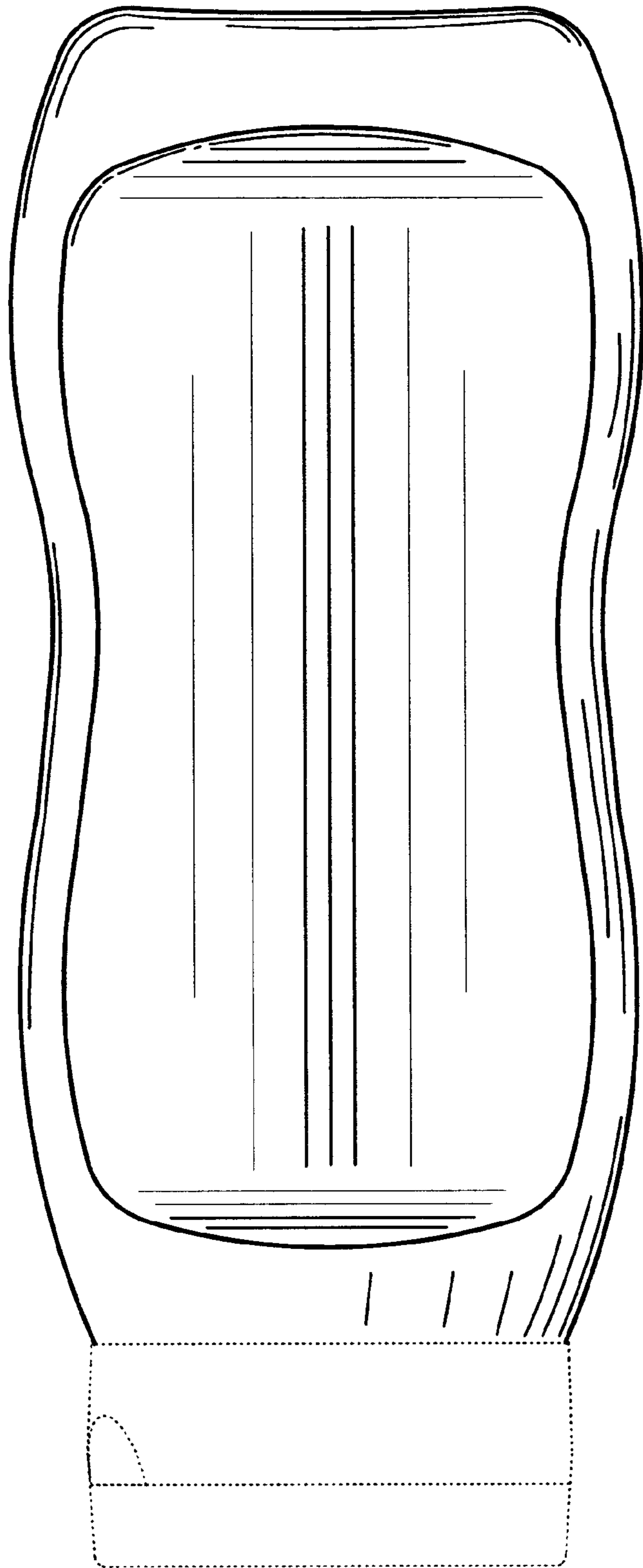

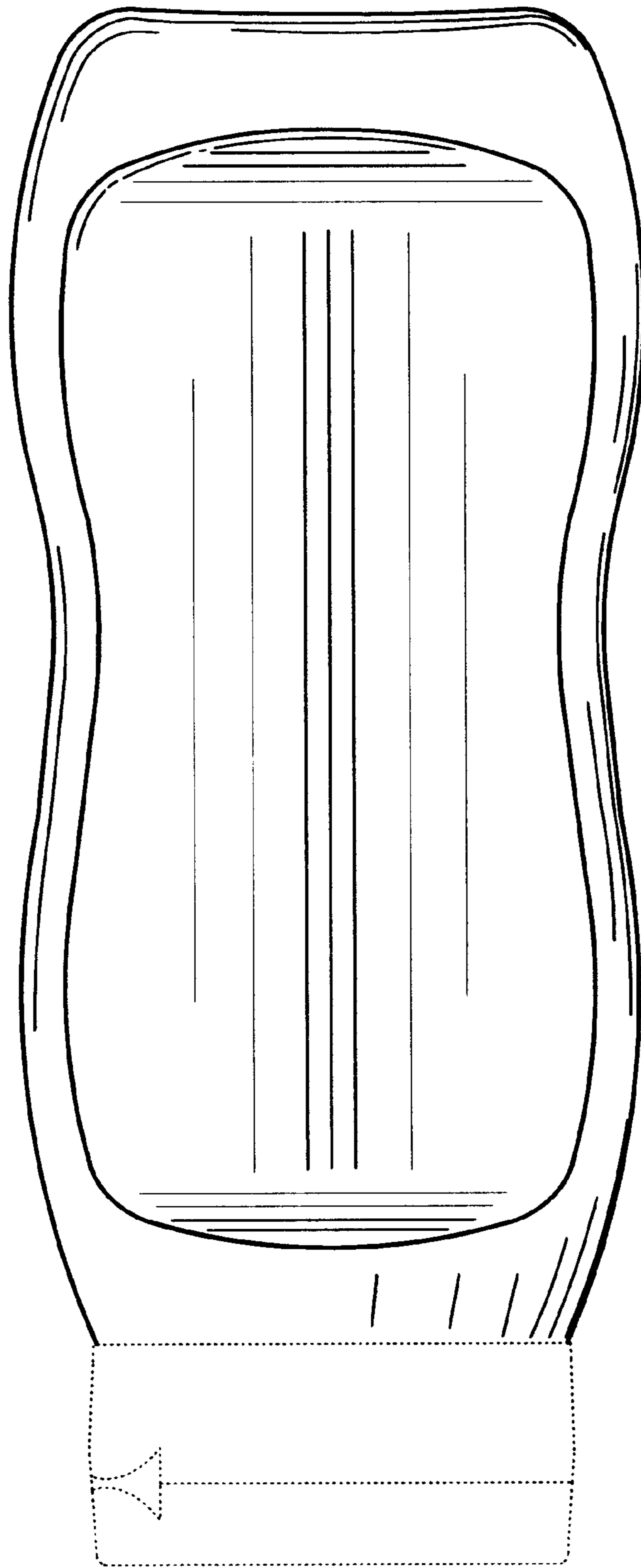

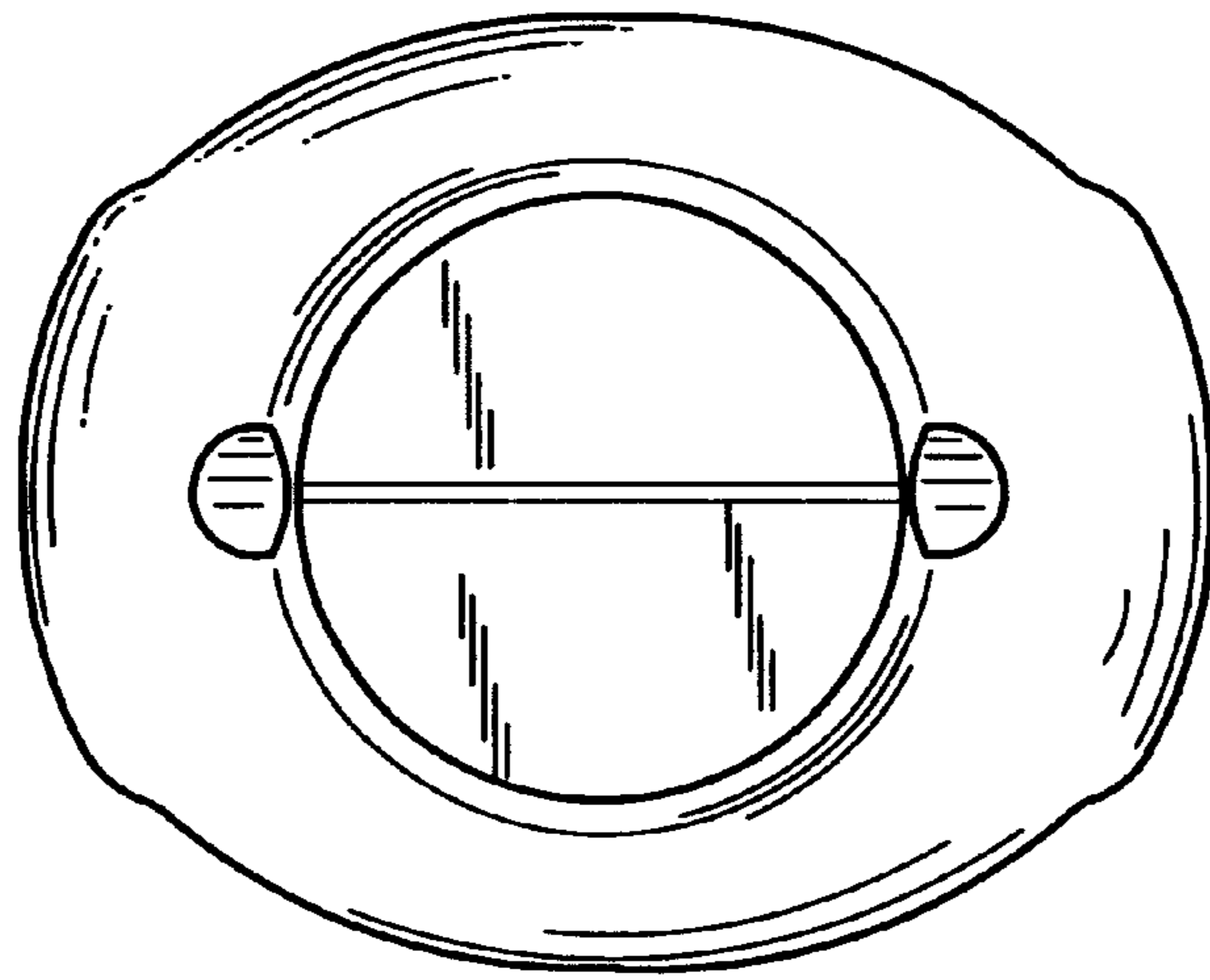

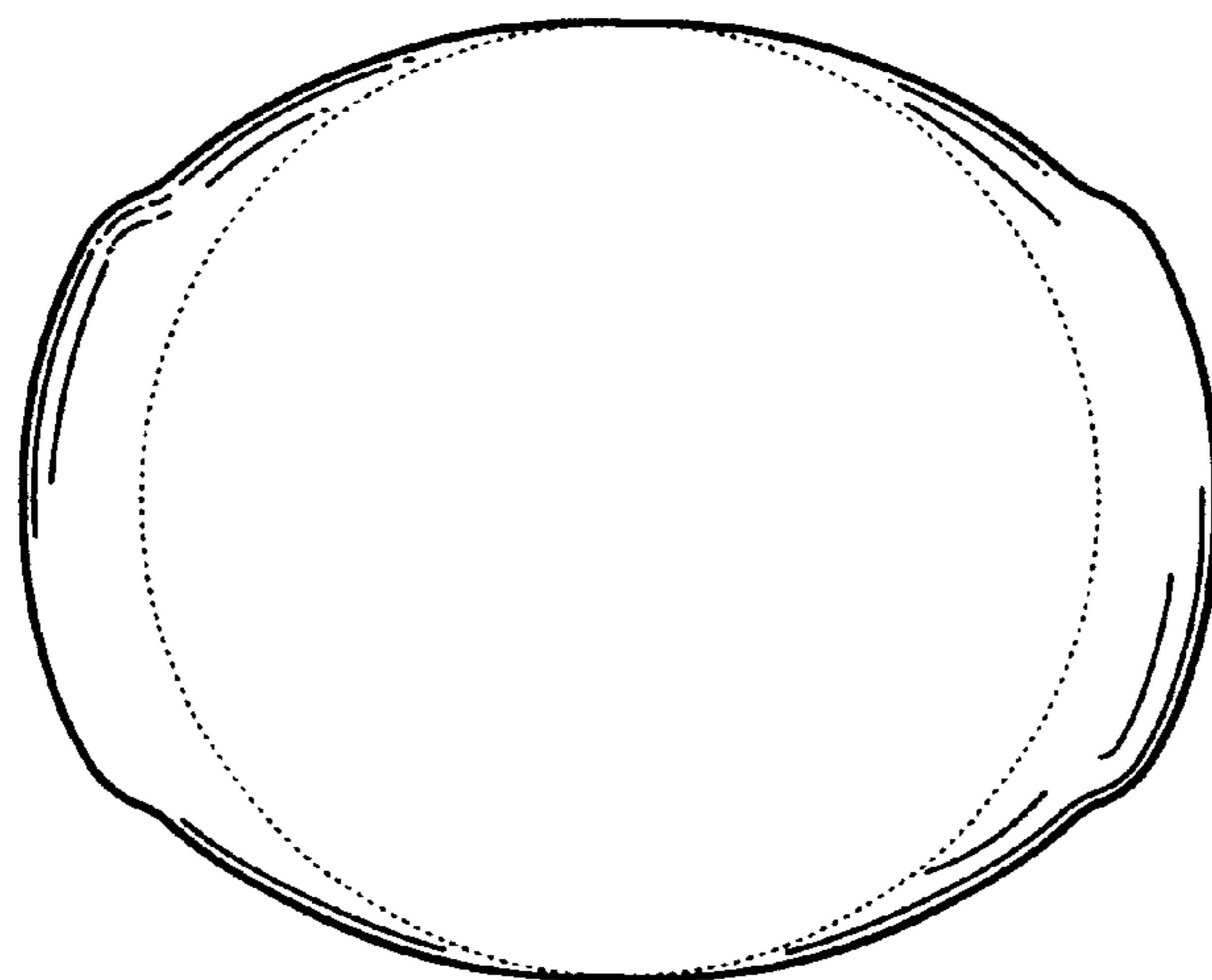
