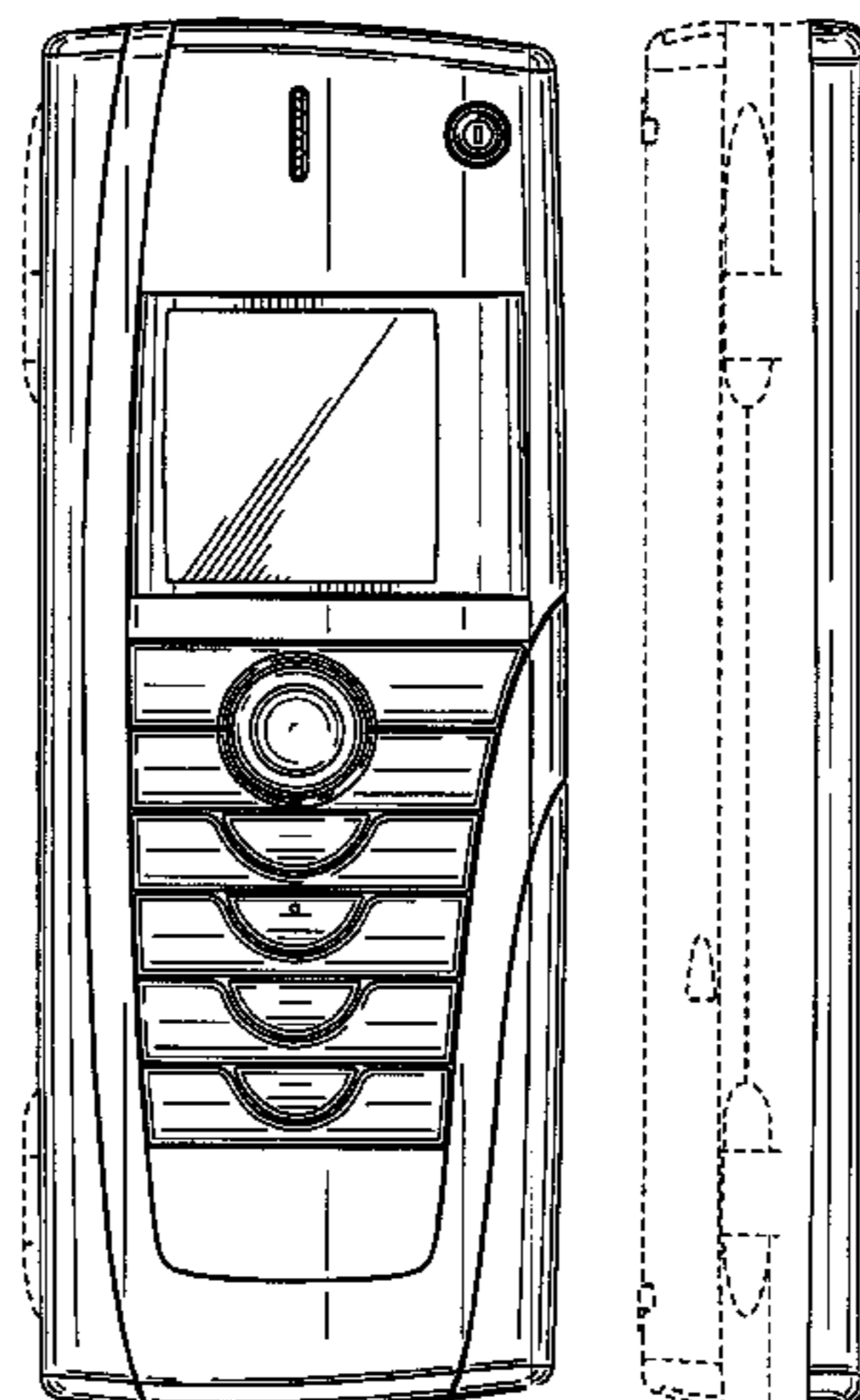
(57) **CLAIM**

The ornamental design for a front cover portion of a communicator, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a front cover portion of a communicator showing my new design;
 FIG. 2 is a right side view thereof;
 FIG. 3 is a front view thereof;
 FIG. 4 is a left side view thereof;
 FIG. 5 is a top plan view thereof; and,
 FIG. 6 is a perspective front view thereof.
 The broken line showing of the remainder of the communicator in FIGS. 1-6 is for illustrative purposes only and forms no part of the claimed design.

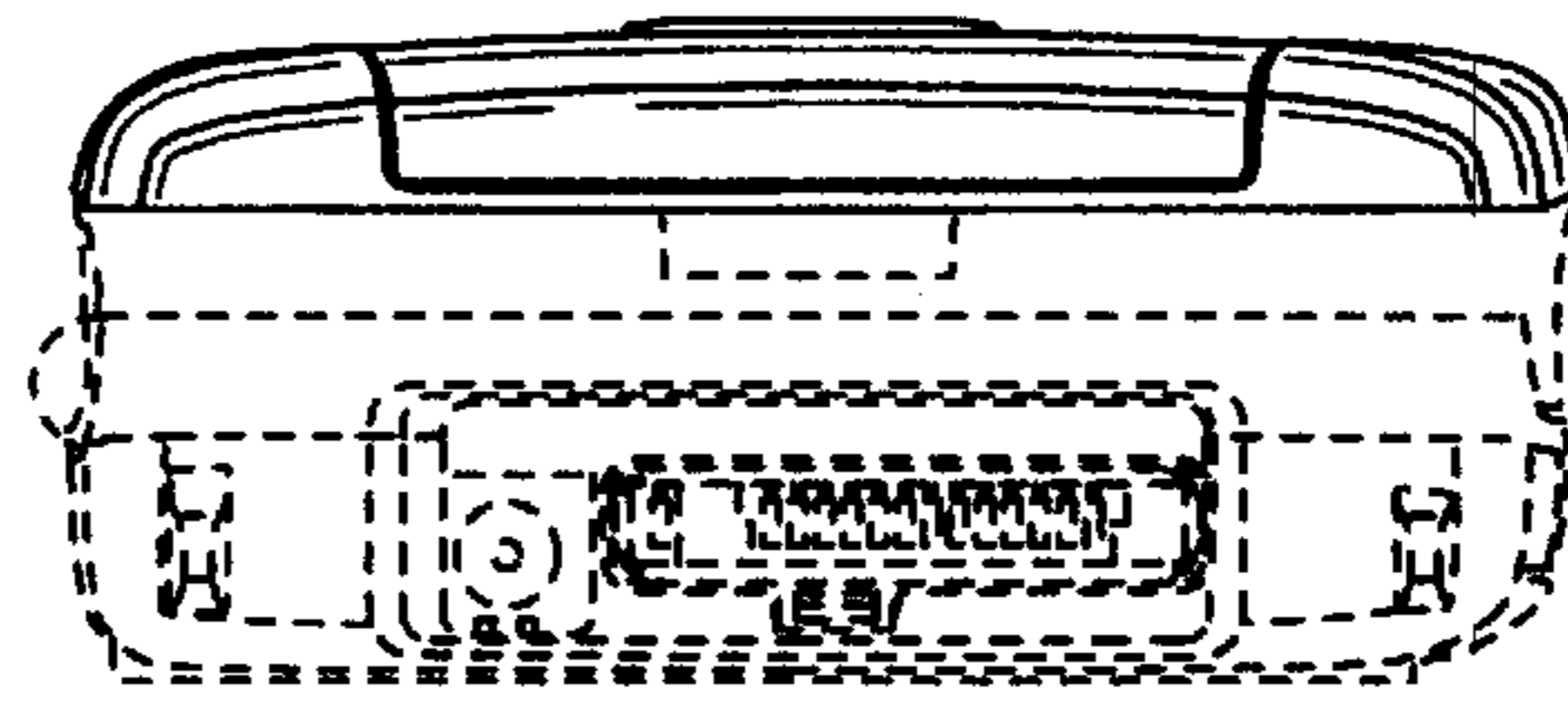

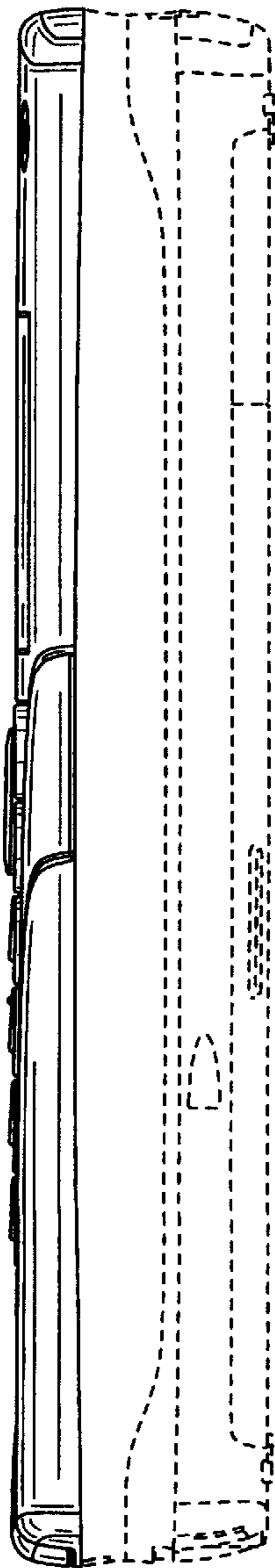

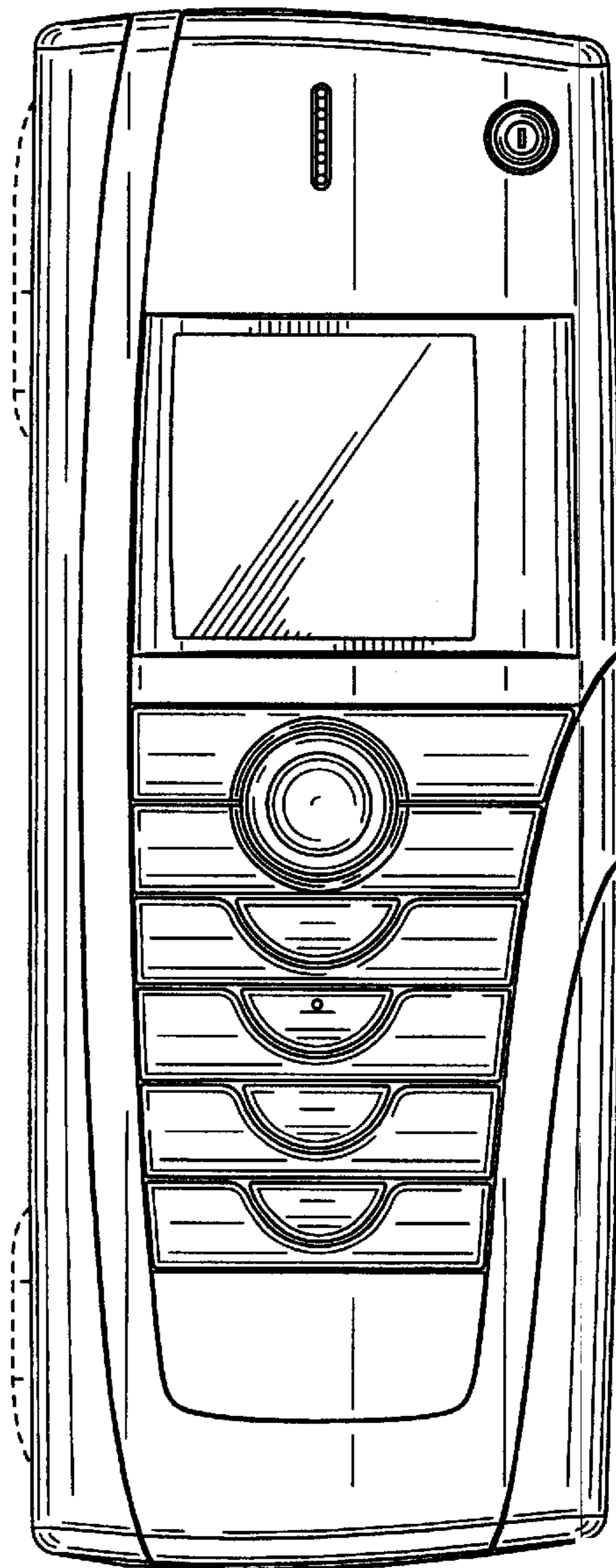

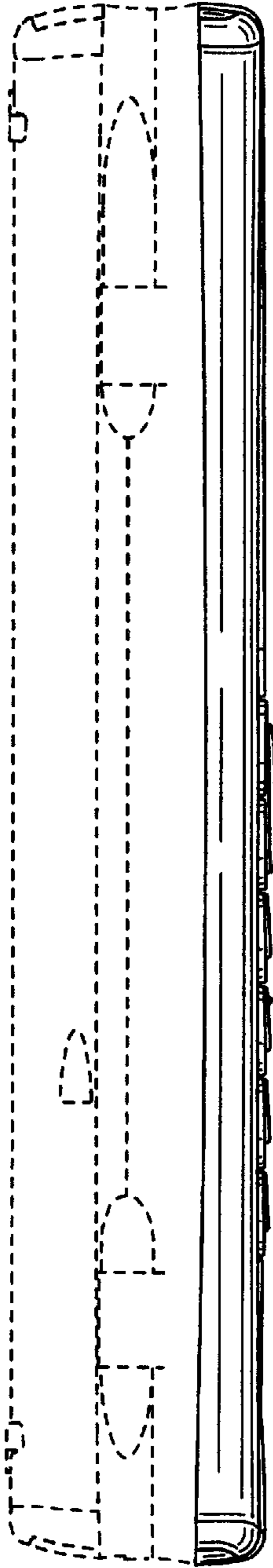

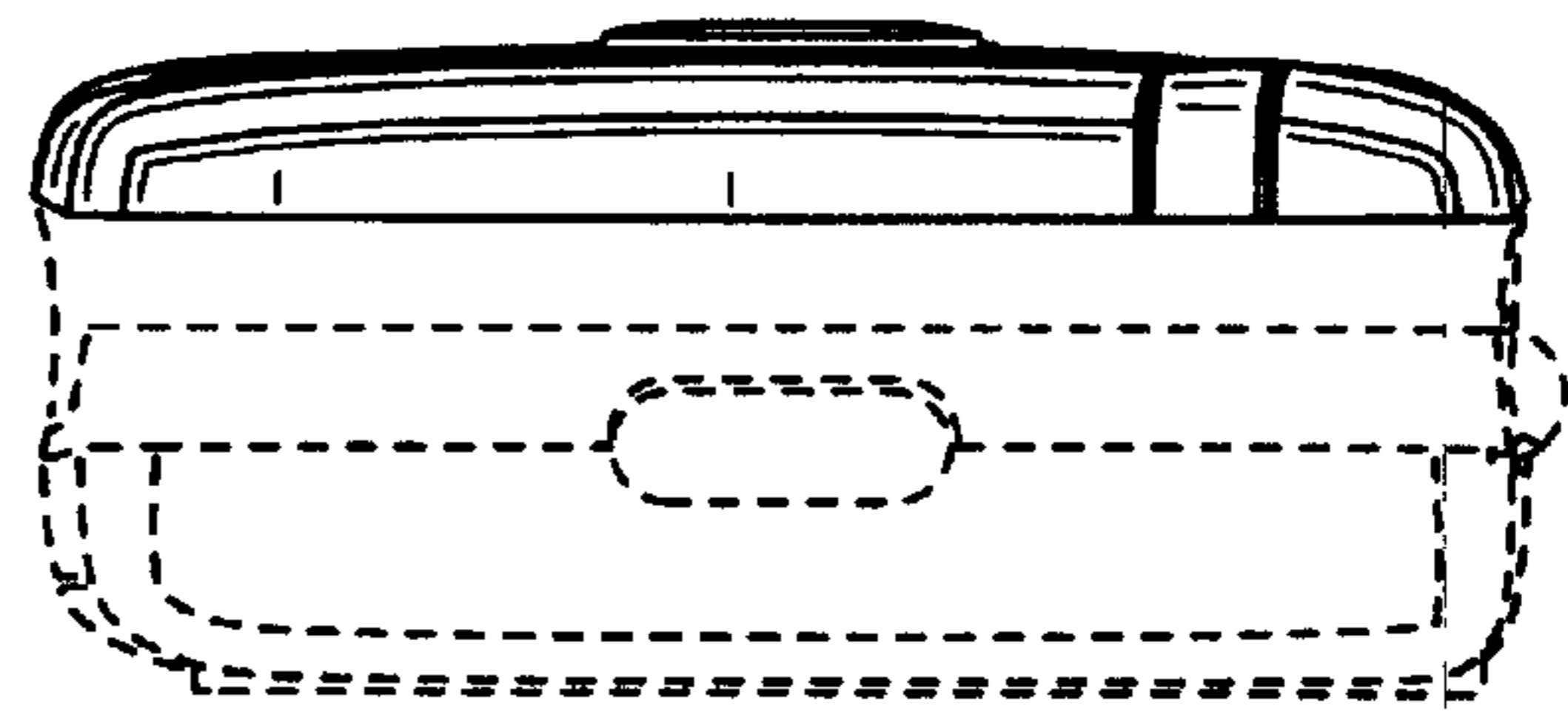

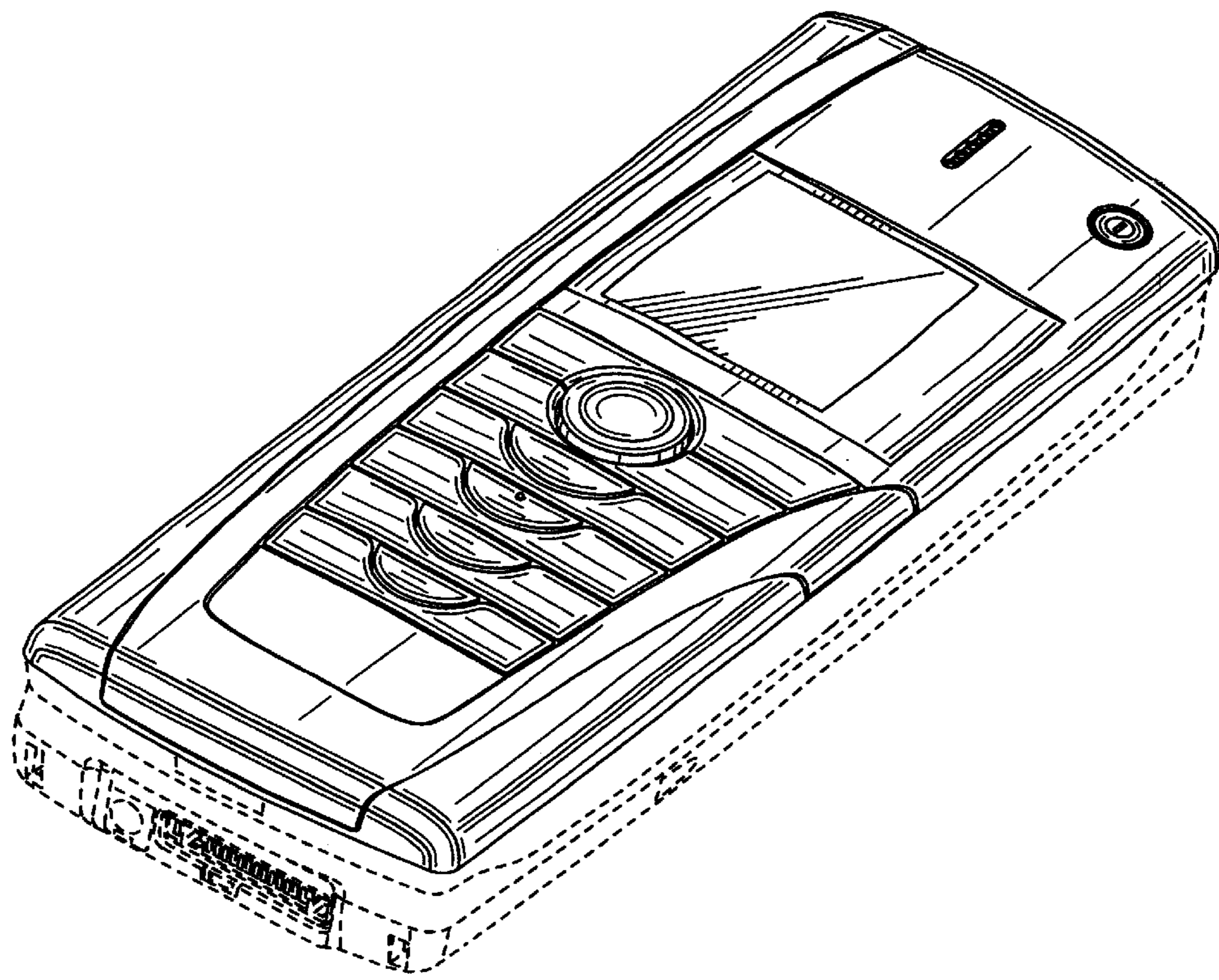
