FIG. 1 is a perspective view of a toy construction set element of the present invention;

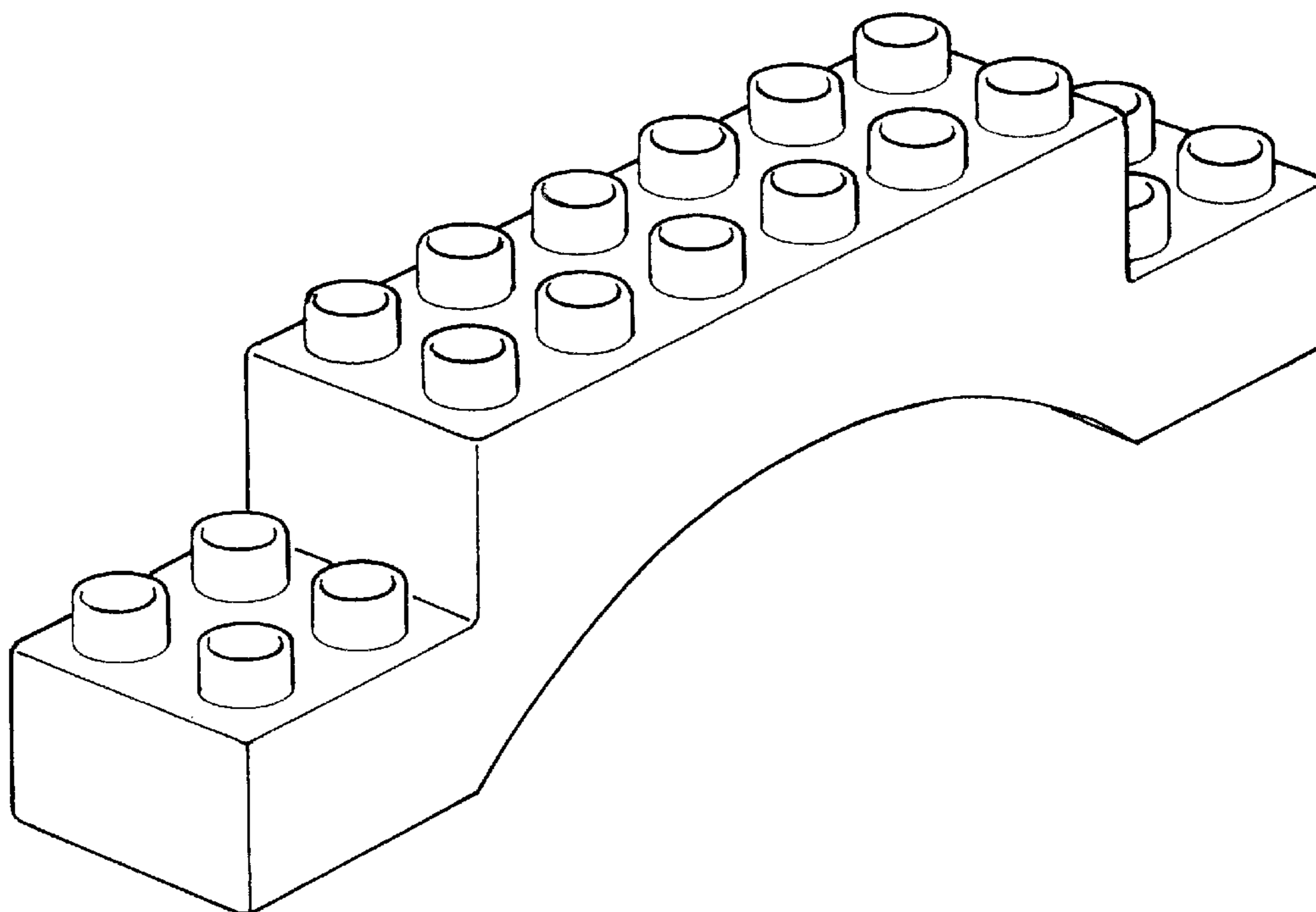
FIG. 2 is a front view thereof, the rear being identical;

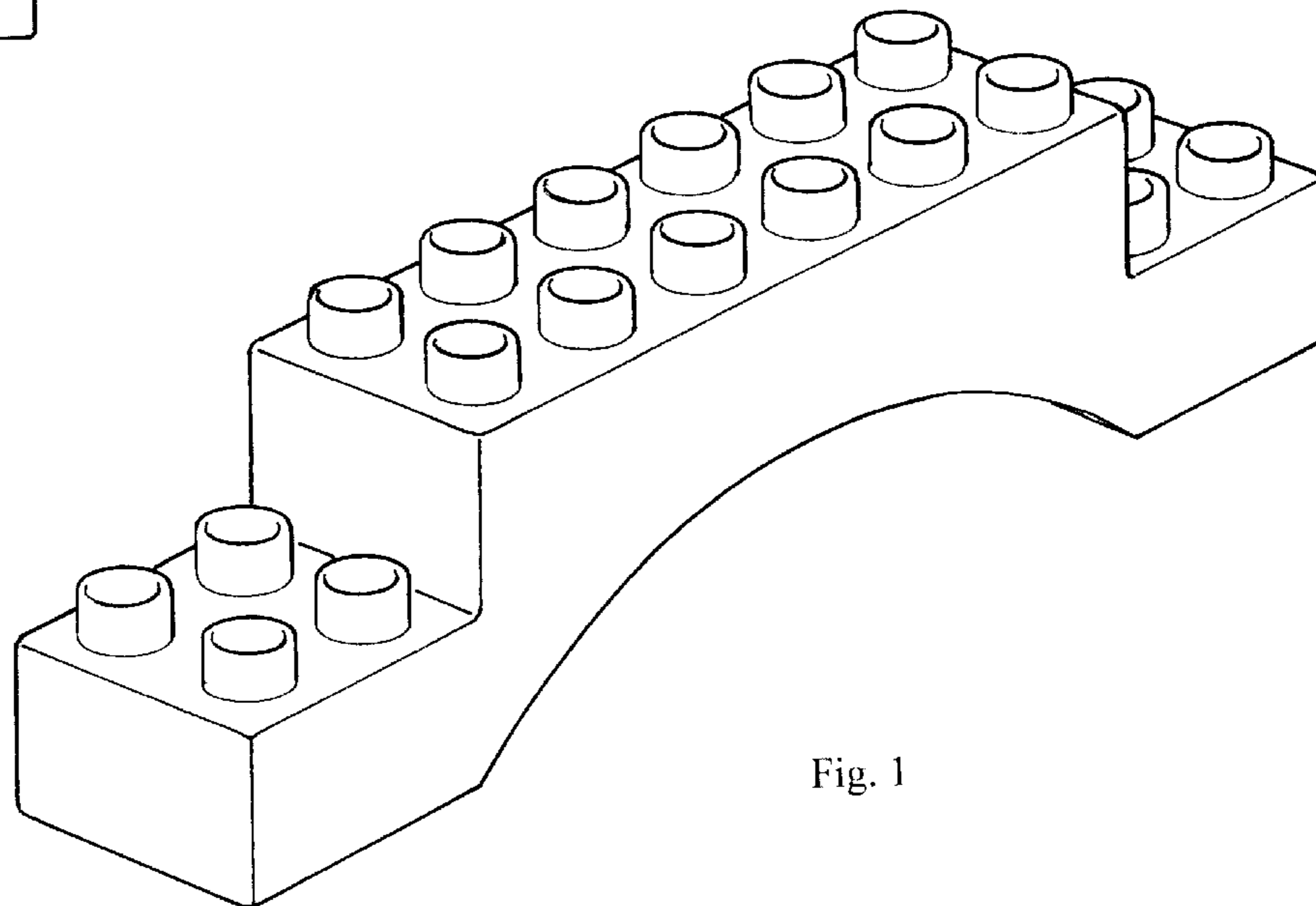
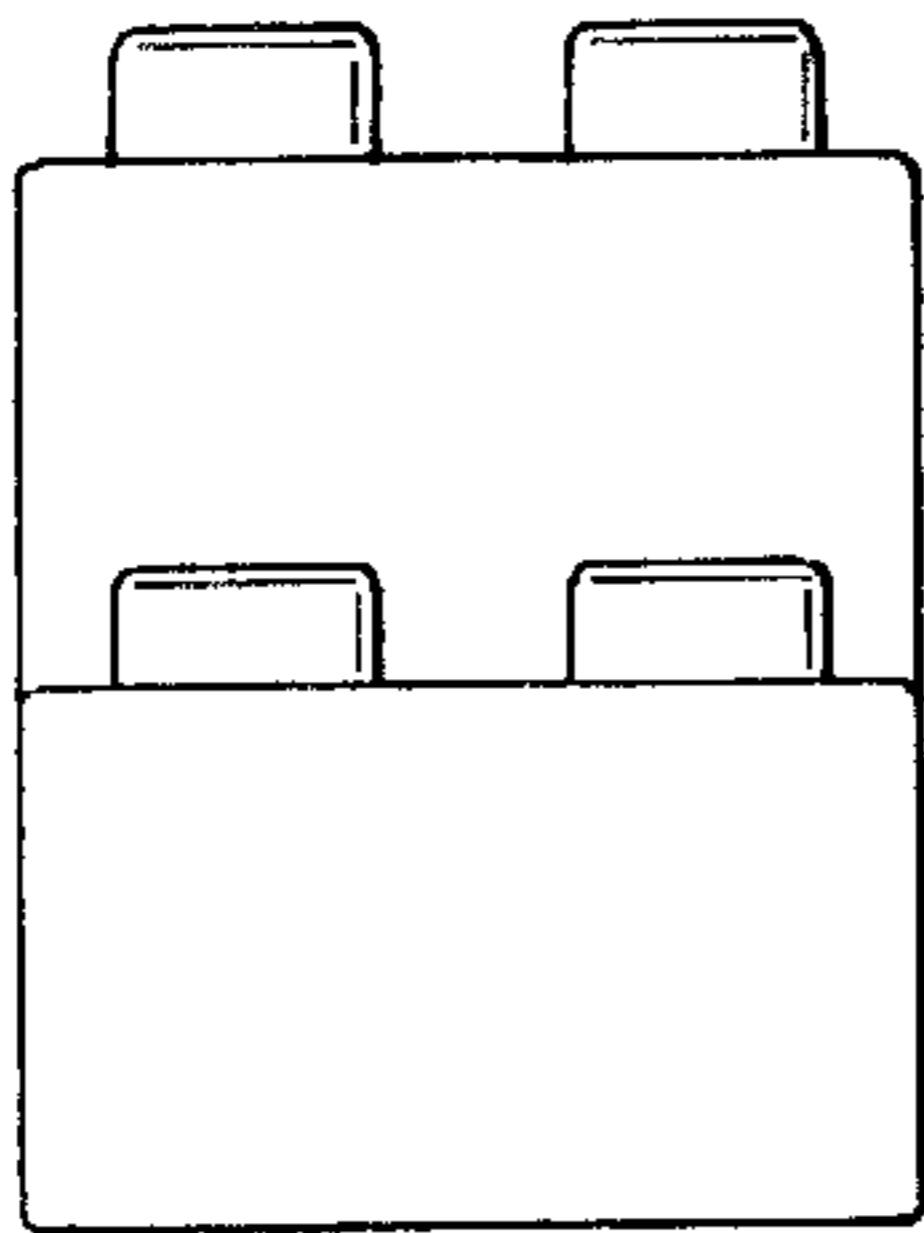
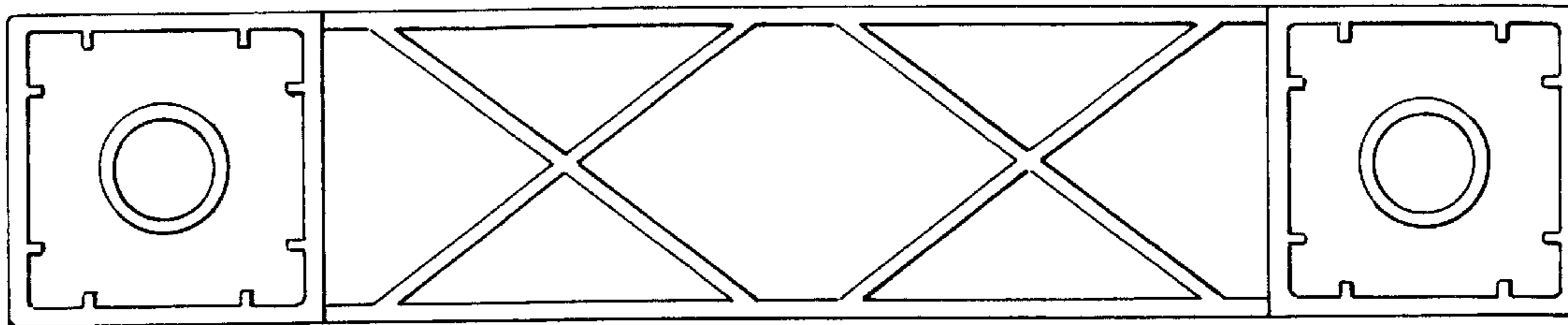
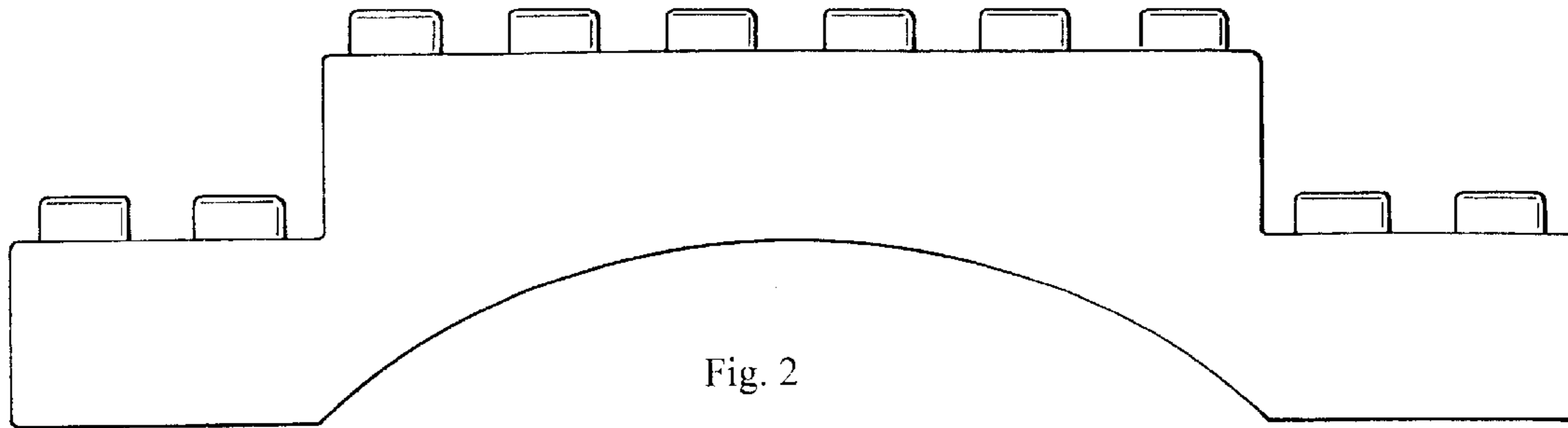
FIG. 3 is a right side view thereof, the left side being identical;

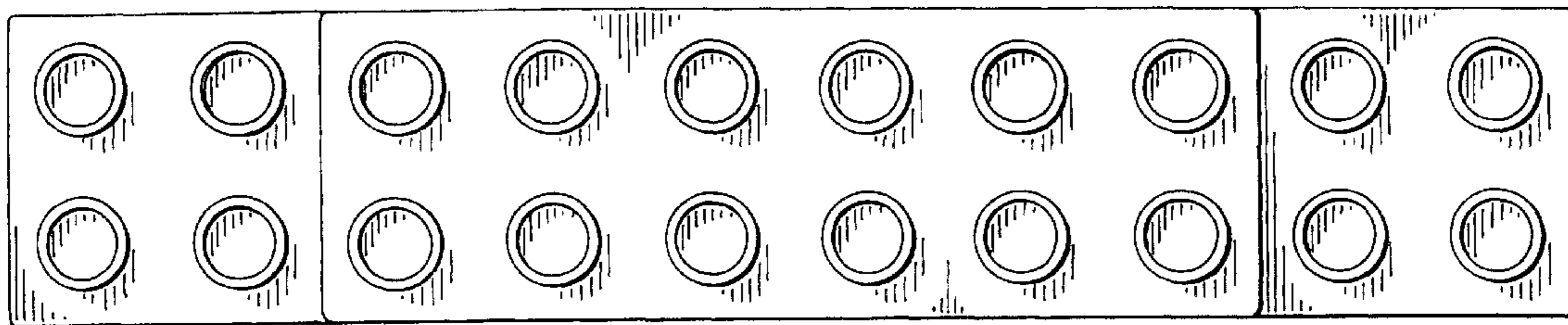
