DESCRIPTION

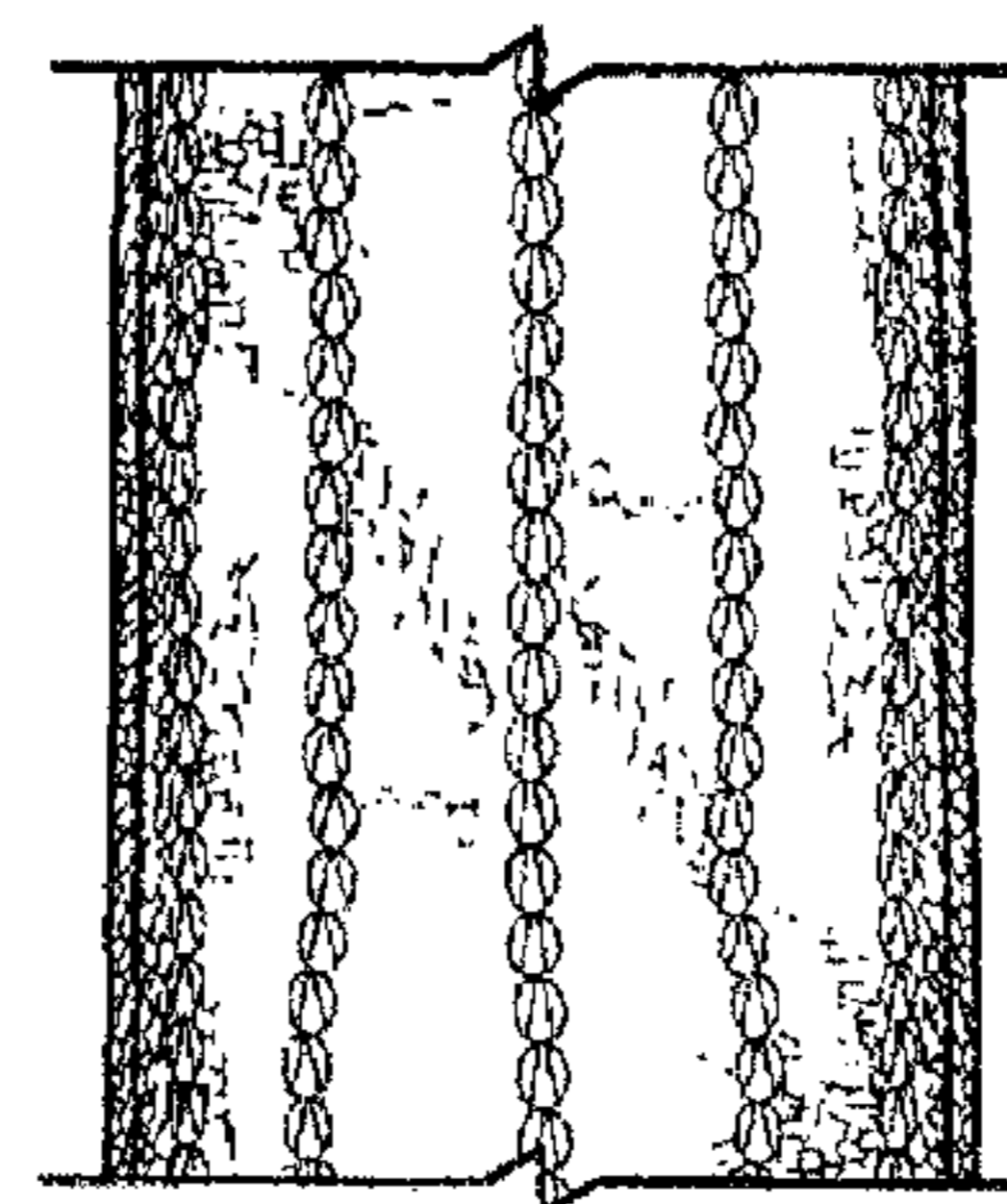
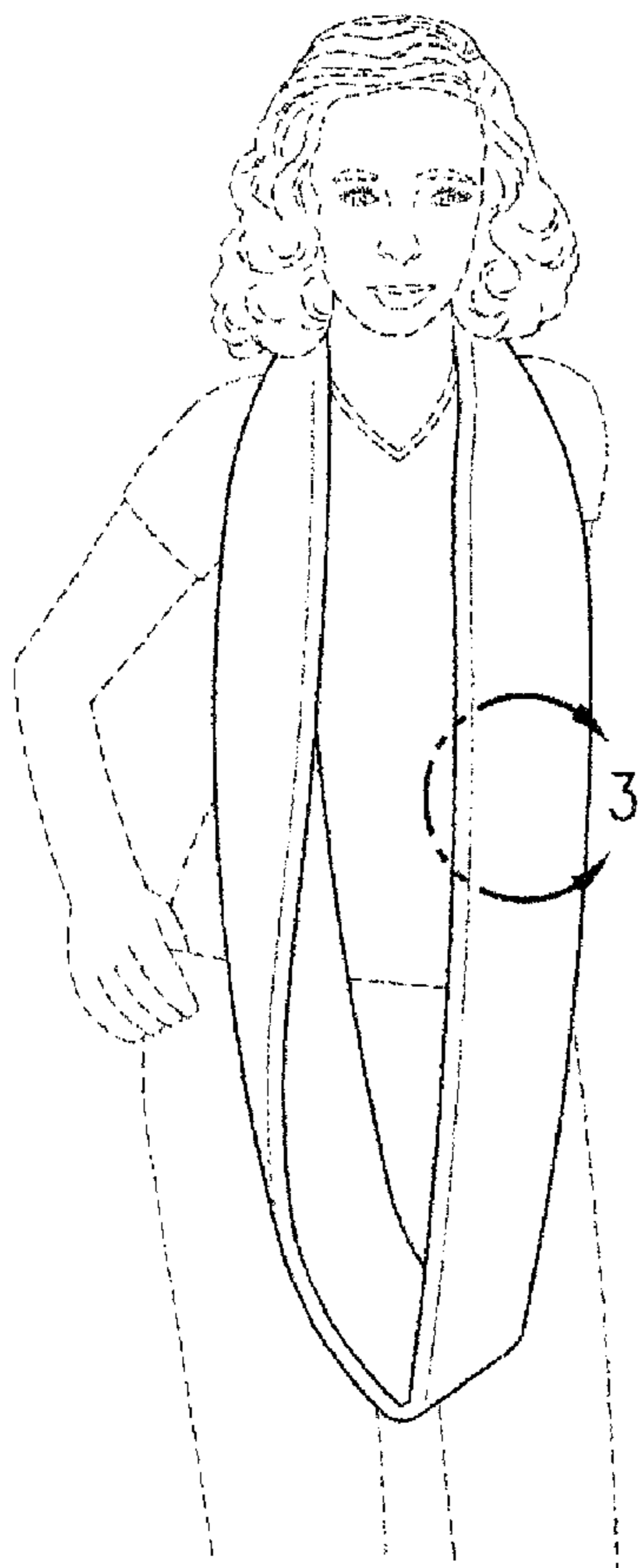
FIG. 1 is a front perspective view of a mobius strip clothing showing my new design;

FIG. 2 is a front perspective view thereof; and,

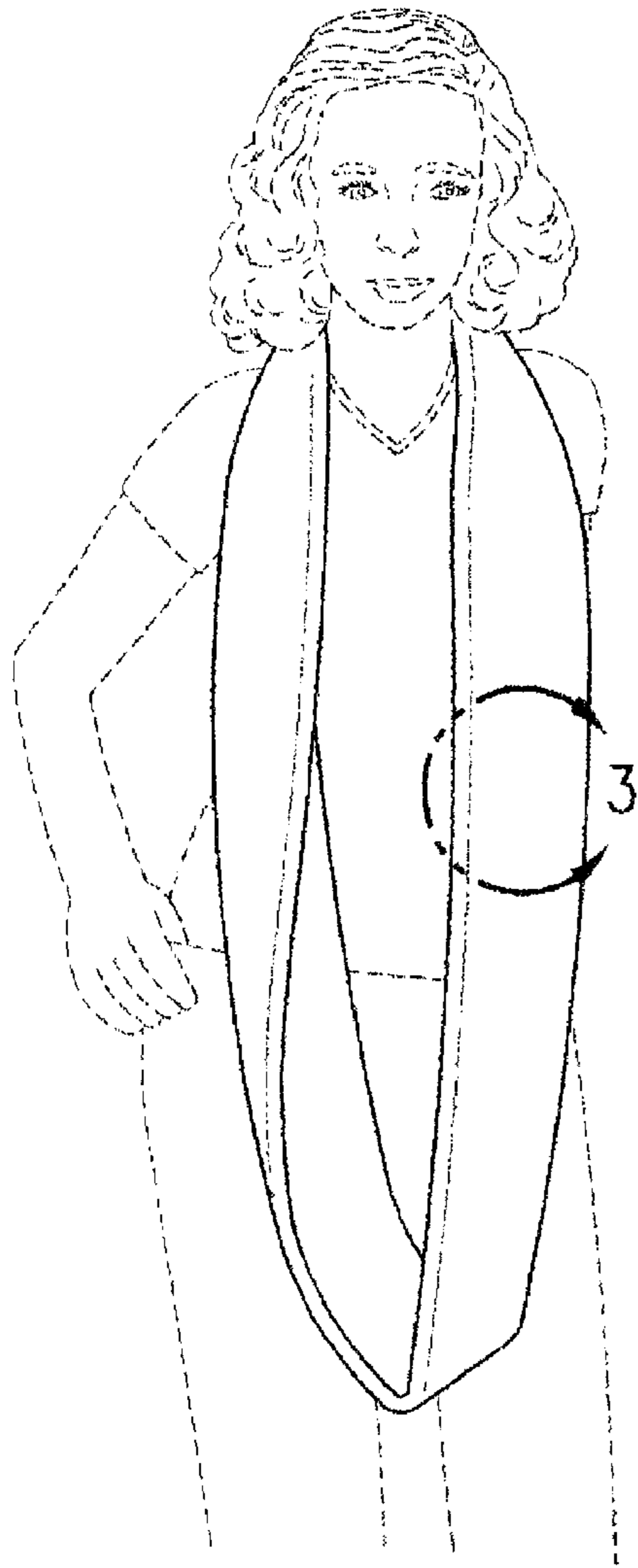

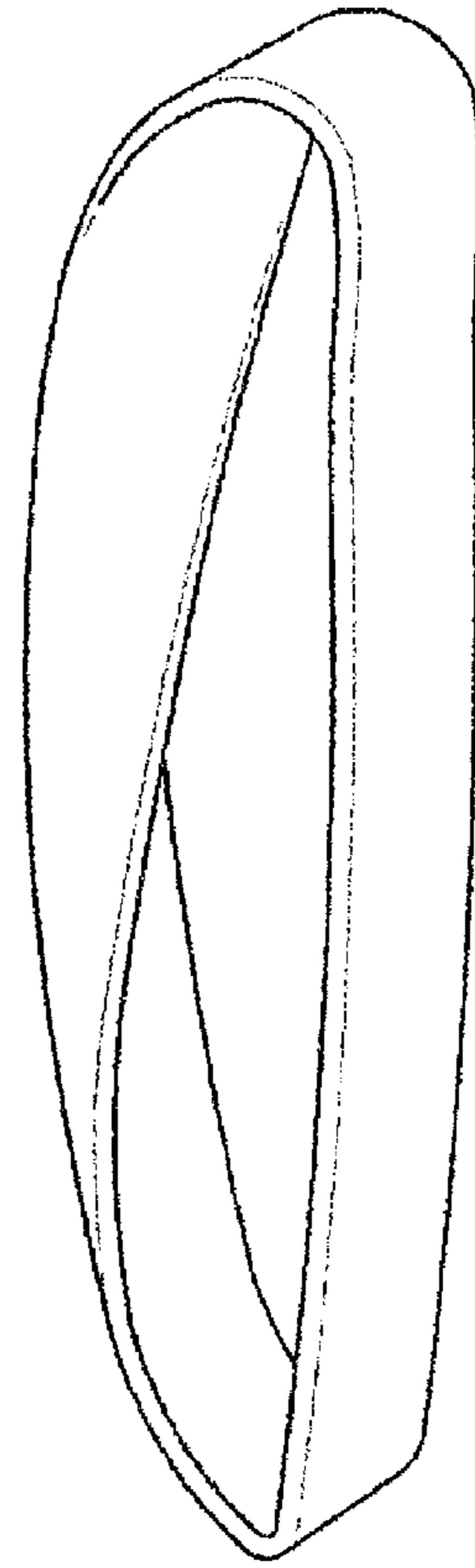

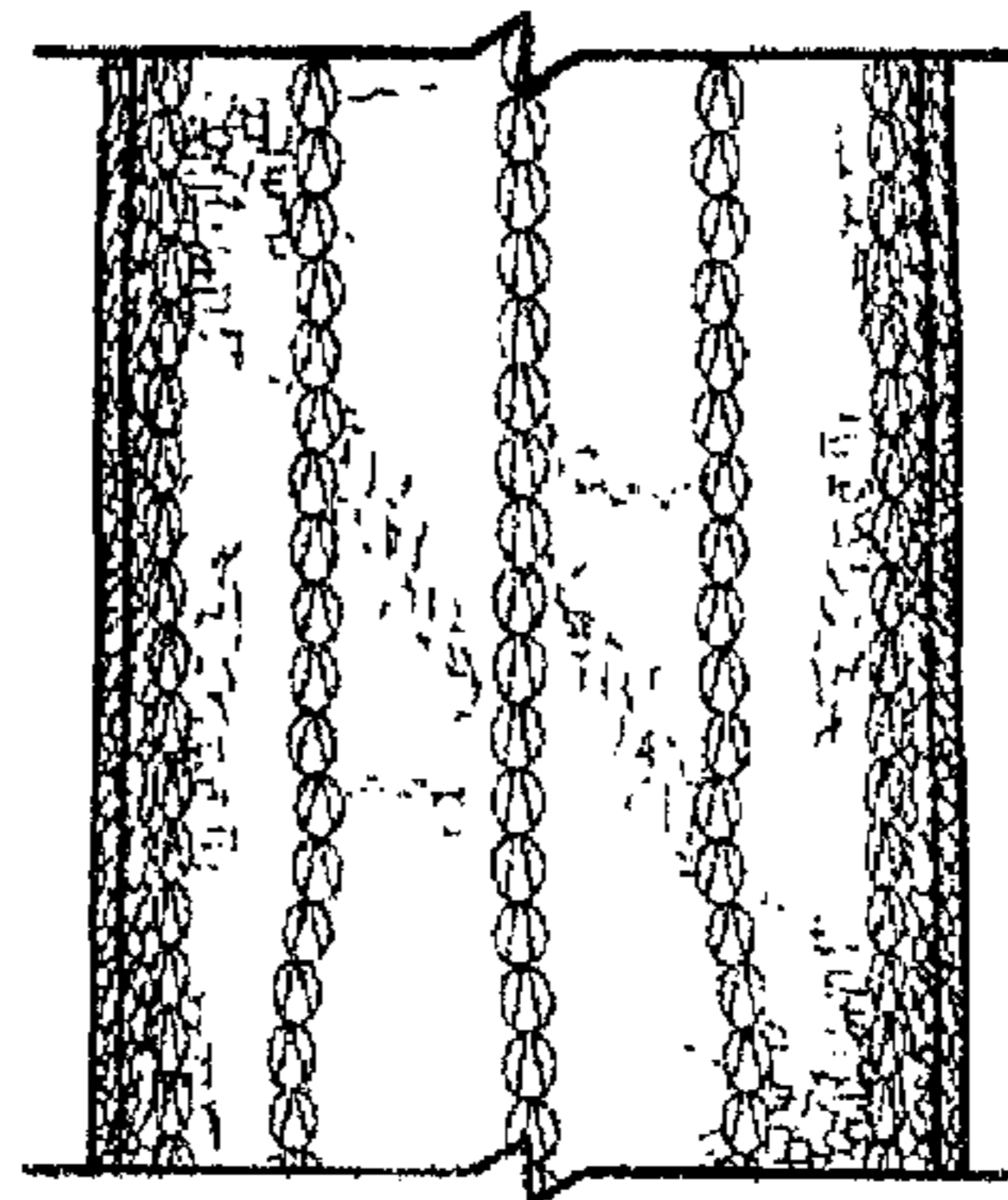
