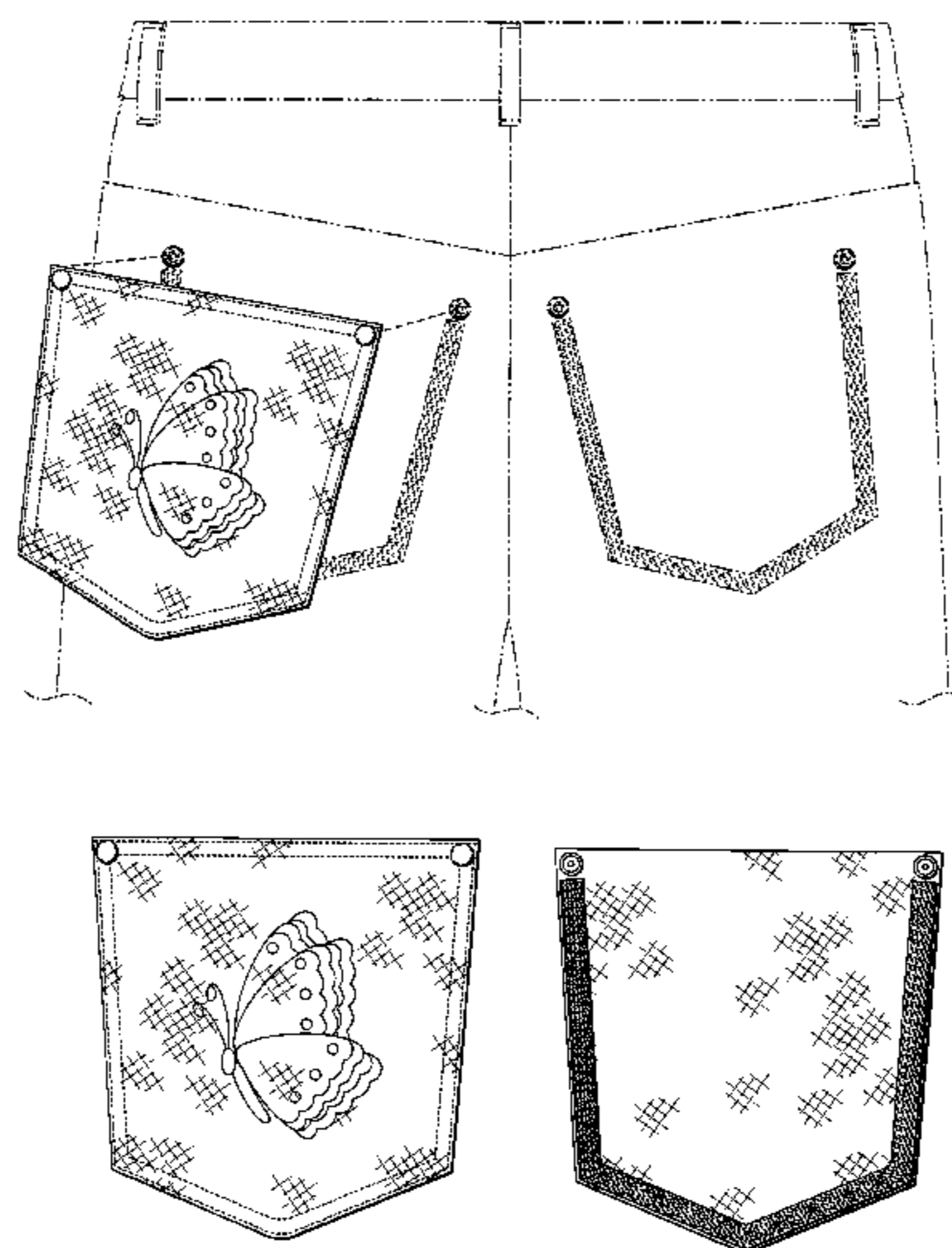
(57) **CLAIM**

The ornamental design for a “detachable pocket for pants,”
as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a detachable pocket for pants,
showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof, the right side
elevational view being a mirror image thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.
The broken line showing of a pair of pants is for illustrative
purposes only and forms no part of the claimed design.
The broken lines shown on the surface of the pocket in
FIGS. 1 and 2 represent stitching.

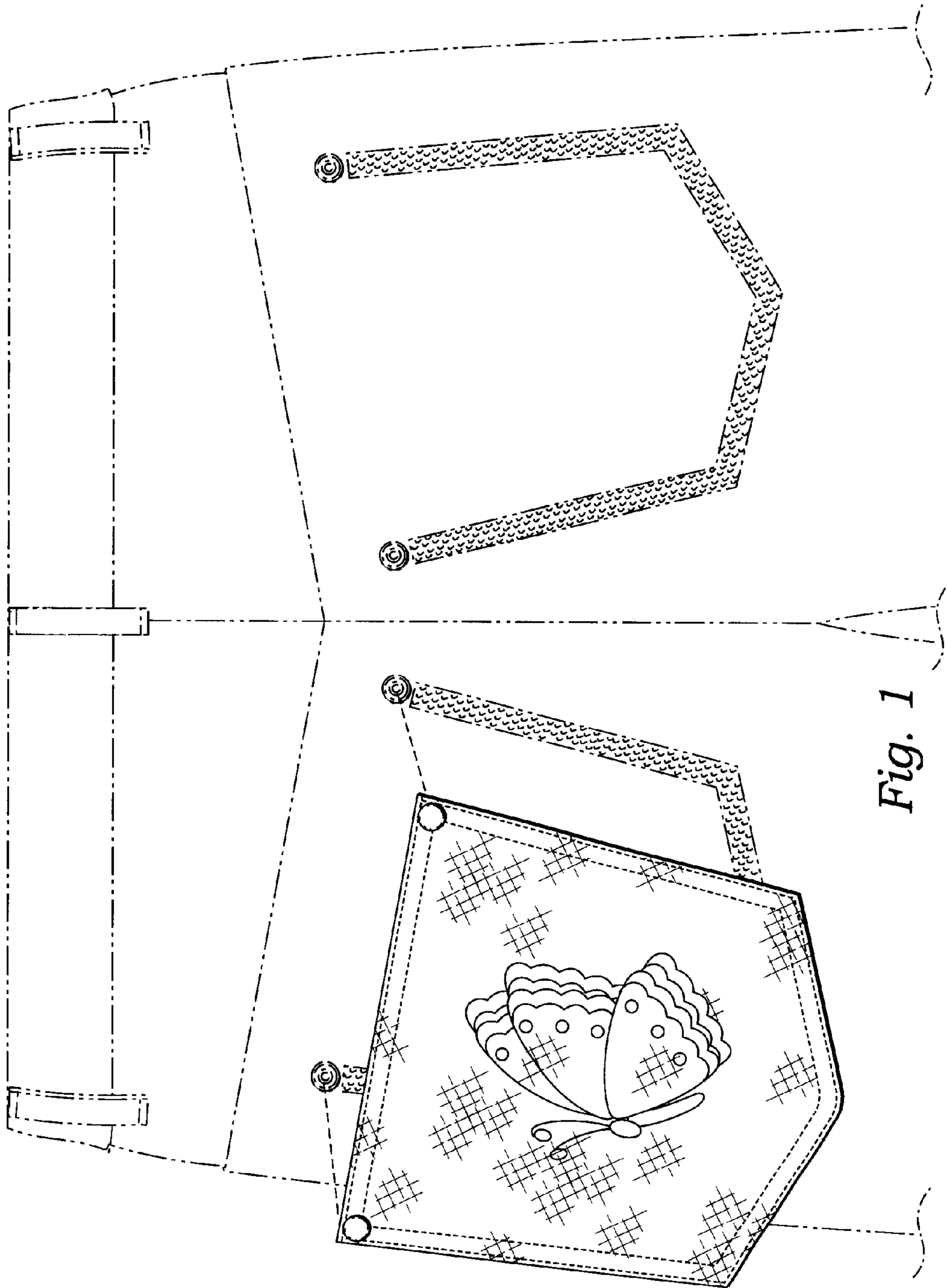

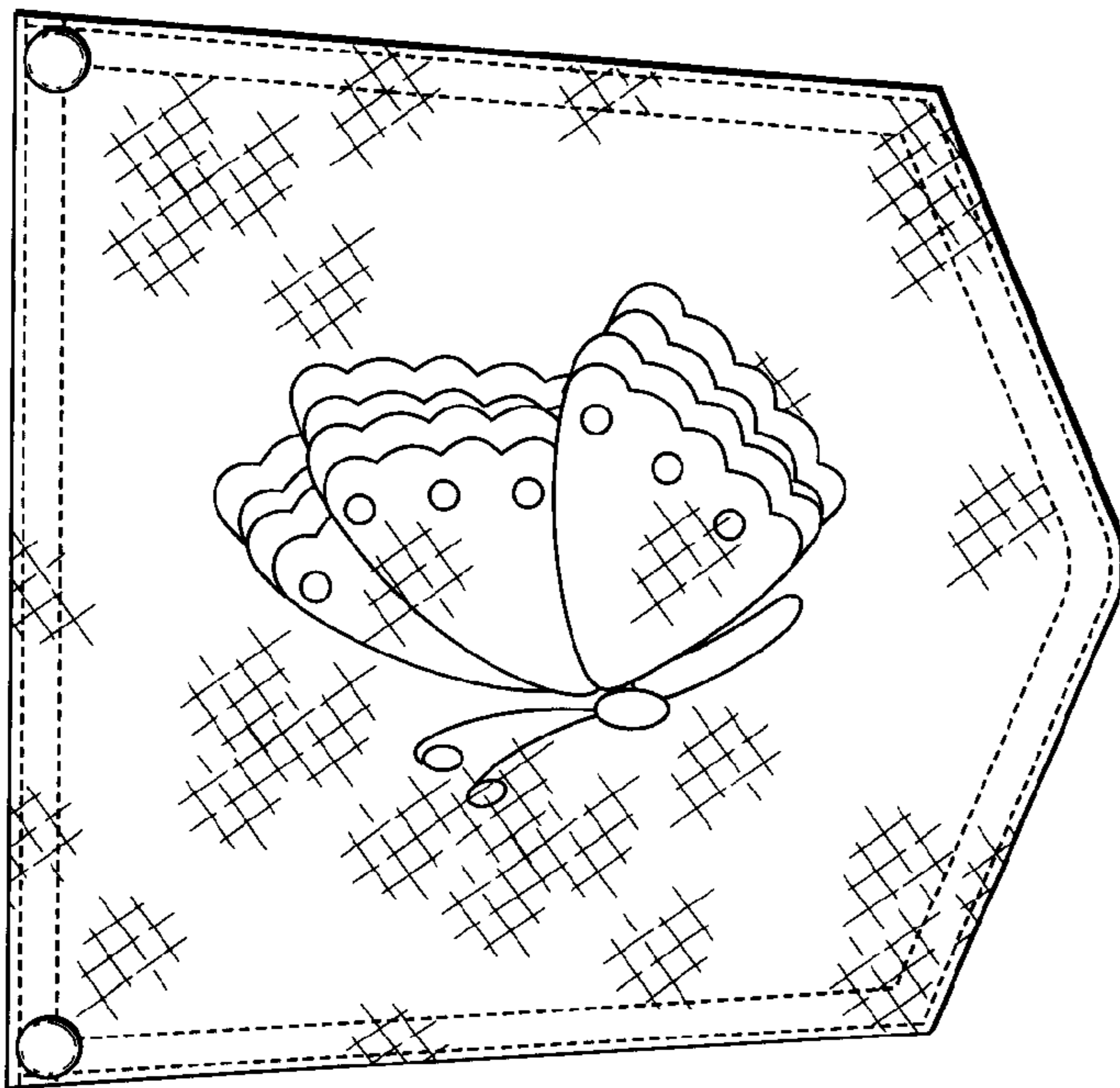

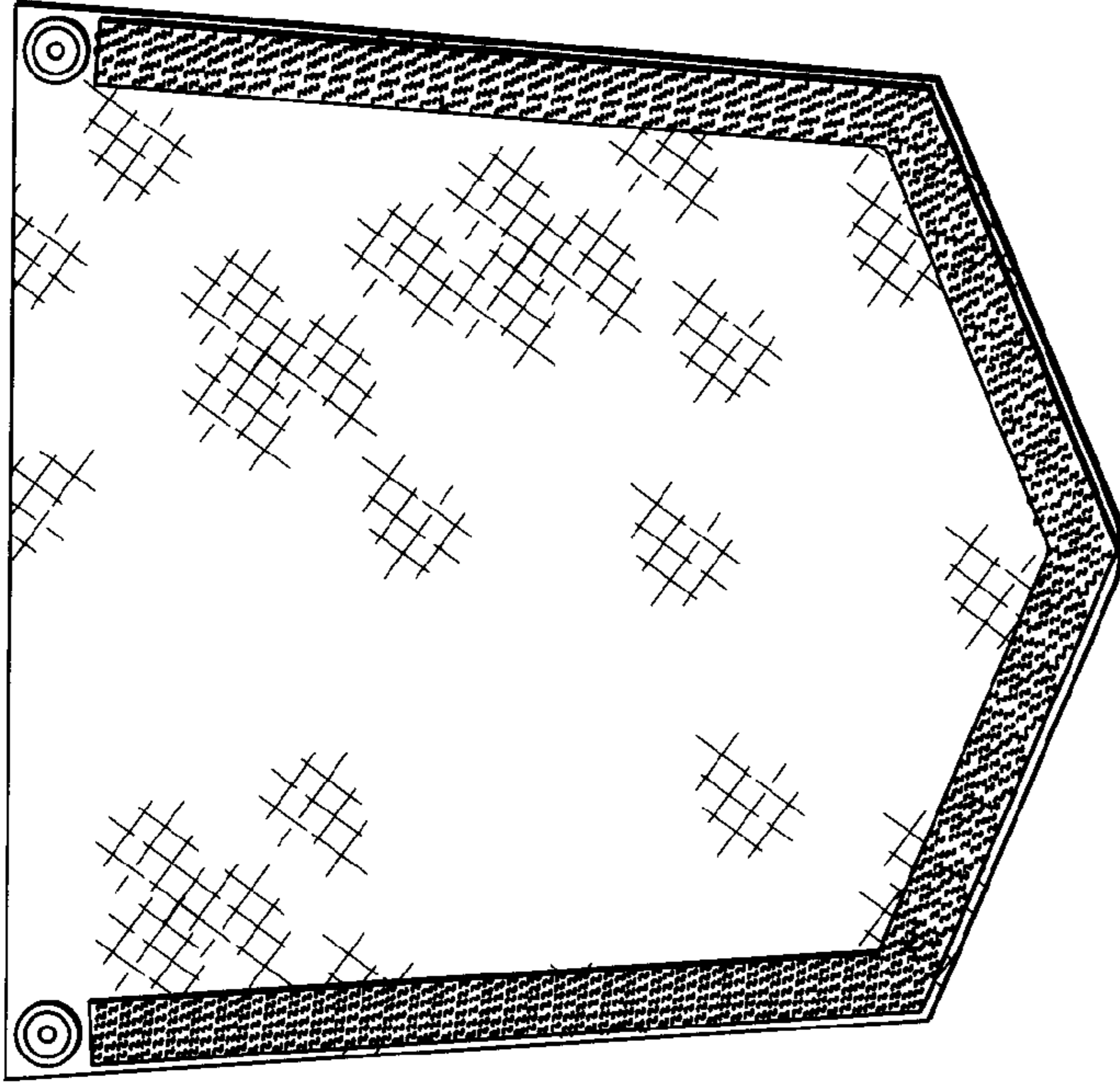

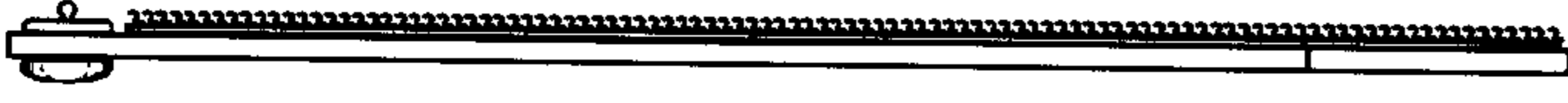

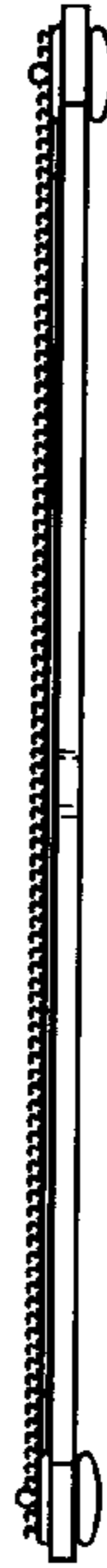
