(57) **CLAIM**

I claim the ornamental design for a gathered bag, as shown
and described.

FIG. 1 is a right side elevational view of a gathered bag in
a substantially uncompressed state. The left side elevational
view being a mirror image thereof.

FIG. 2 is a right side elevational view of a gathered bag in
a partially compressed state. The left side elevational view
being a mirror image thereof.

FIG. 3 is a right side elevational view of a gathered bag in
a substantially compressed state. The left side elevational
view being a mirror image thereof.

FIG. 4 is a right side perspective view of the bag in FIG. 1,
shown in a cinched condition, the left side view being a
mirror image thereof.

FIG. 5 is a right side perspective view of the bag in FIG. 2,
shown in a cinched condition, the left side view being a
mirror image thereof.

FIG. 6 is a right side perspective view of the bag in FIG. 3,
shown in a cinched condition, the left side view being a
mirror image thereof.

FIG. 7 is a front elevational view of the bag in FIG. 1 the
back elevational view being a mirror image thereof.

FIG. 8 is a front elevational view of the bag in FIG. 2 the
back elevational view being a mirror image thereof.

FIG. 9 is a front elevational view of the bag in FIG. 3 the
back elevational view being a mirror image thereof.

FIG. 10 is a front elevational view of the gathered bag in
FIG. 4 the back elevational view being a mirror image
thereof.

FIG. 11 is a front elevational view of the gathered bag in
FIG. 5 the back elevational view being a mirror image
thereof.

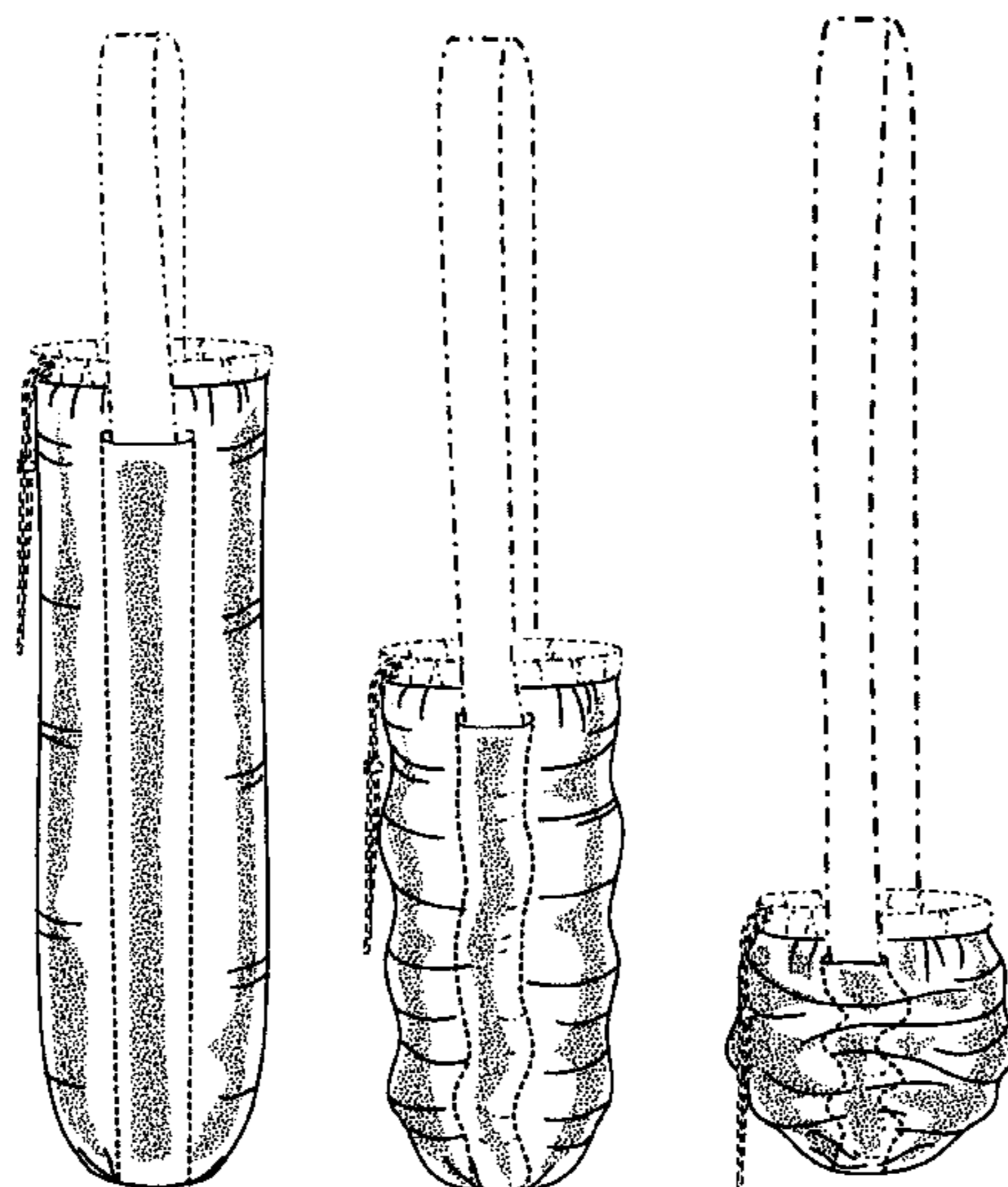
FIG. 12 is a front elevational view of the gathered bag in

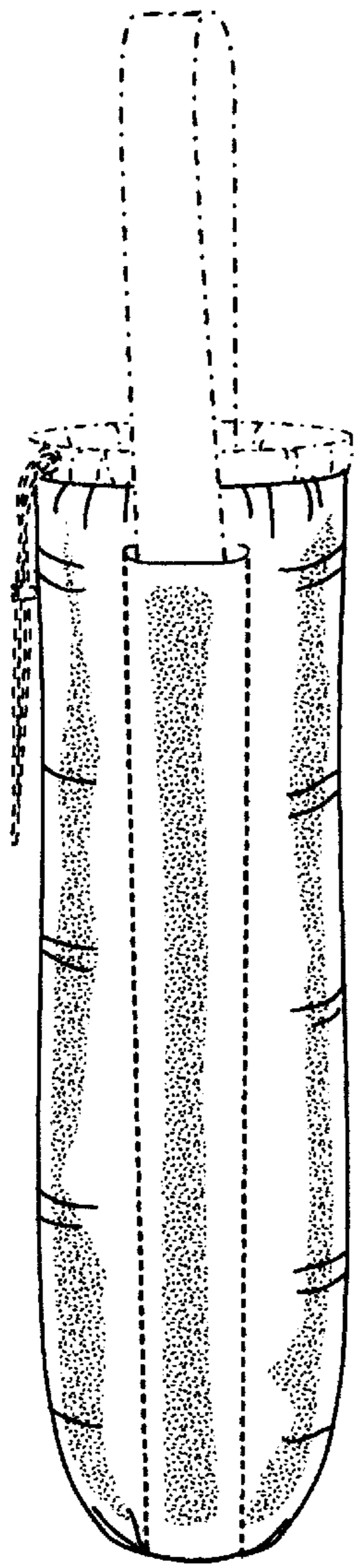

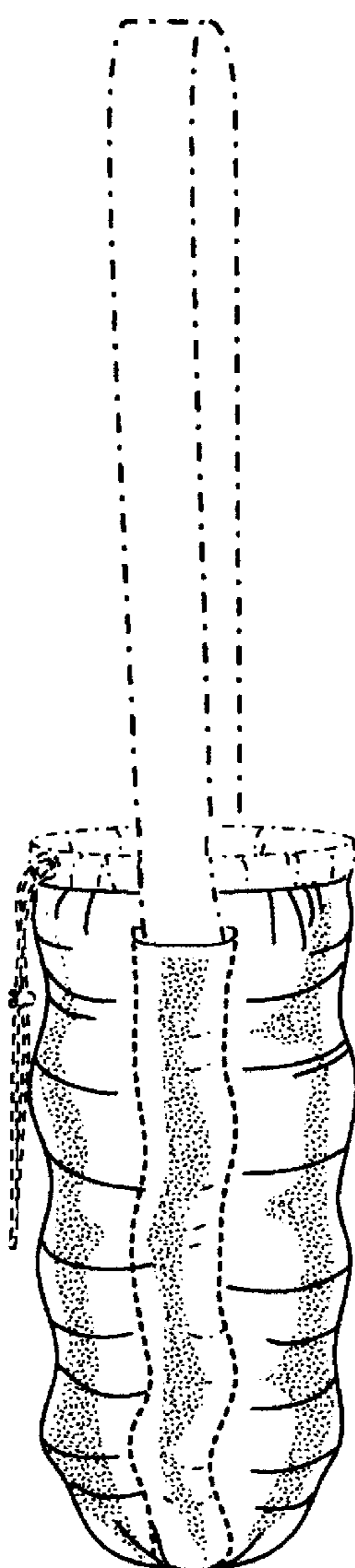

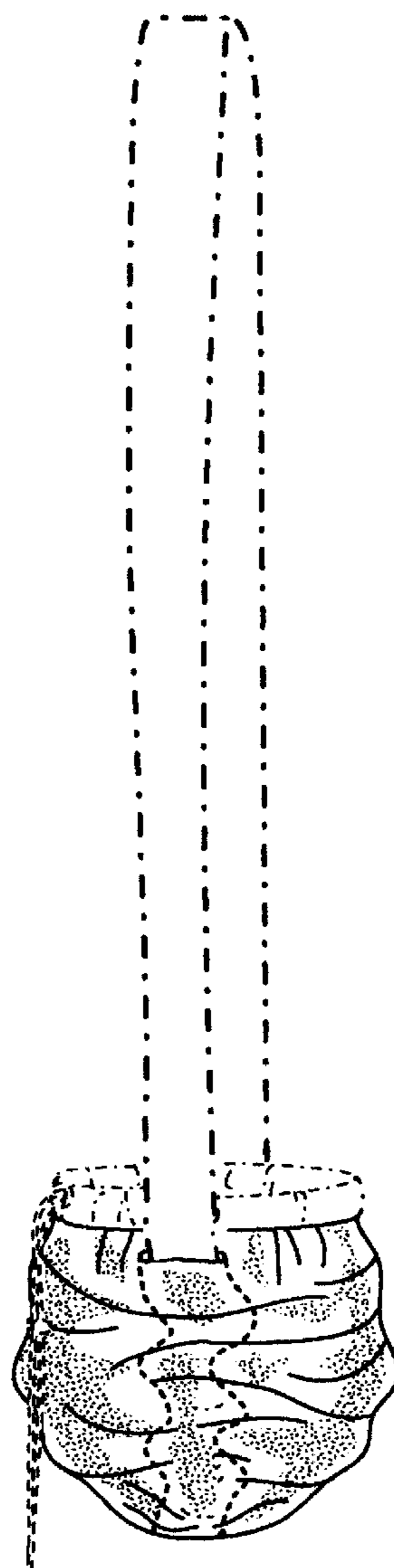

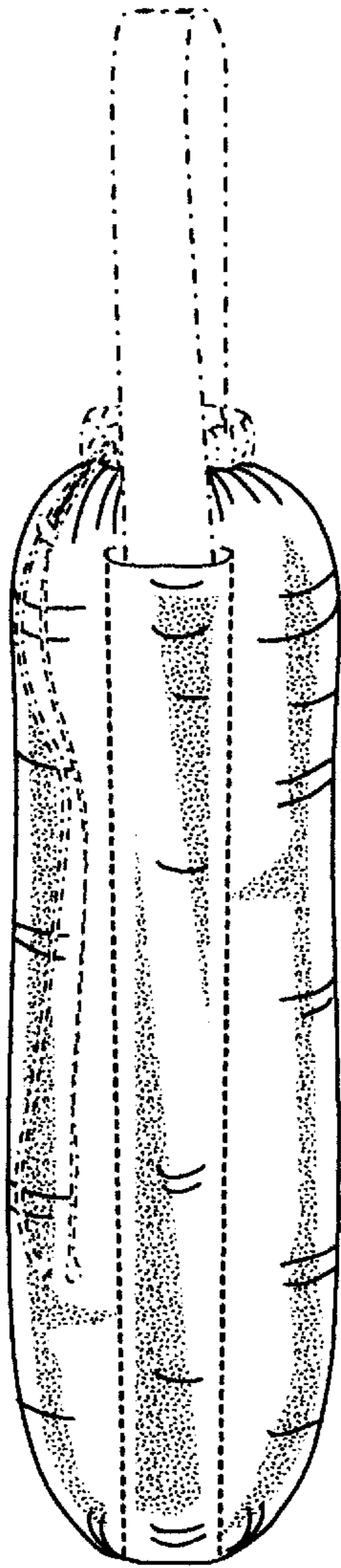

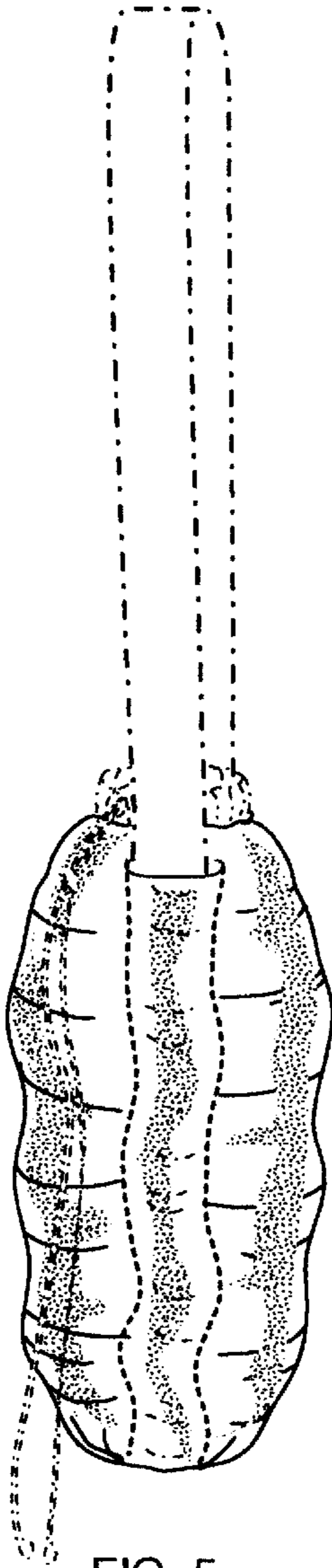

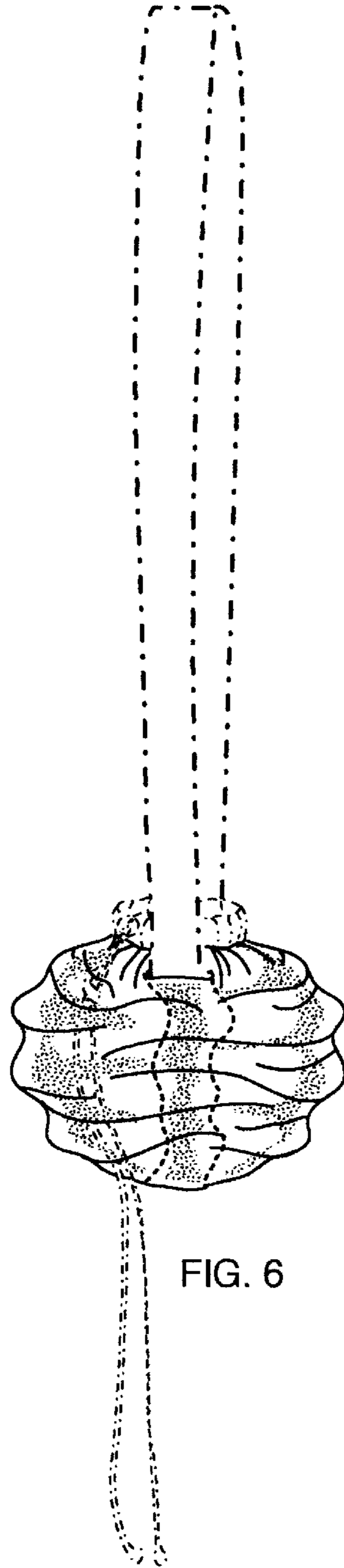

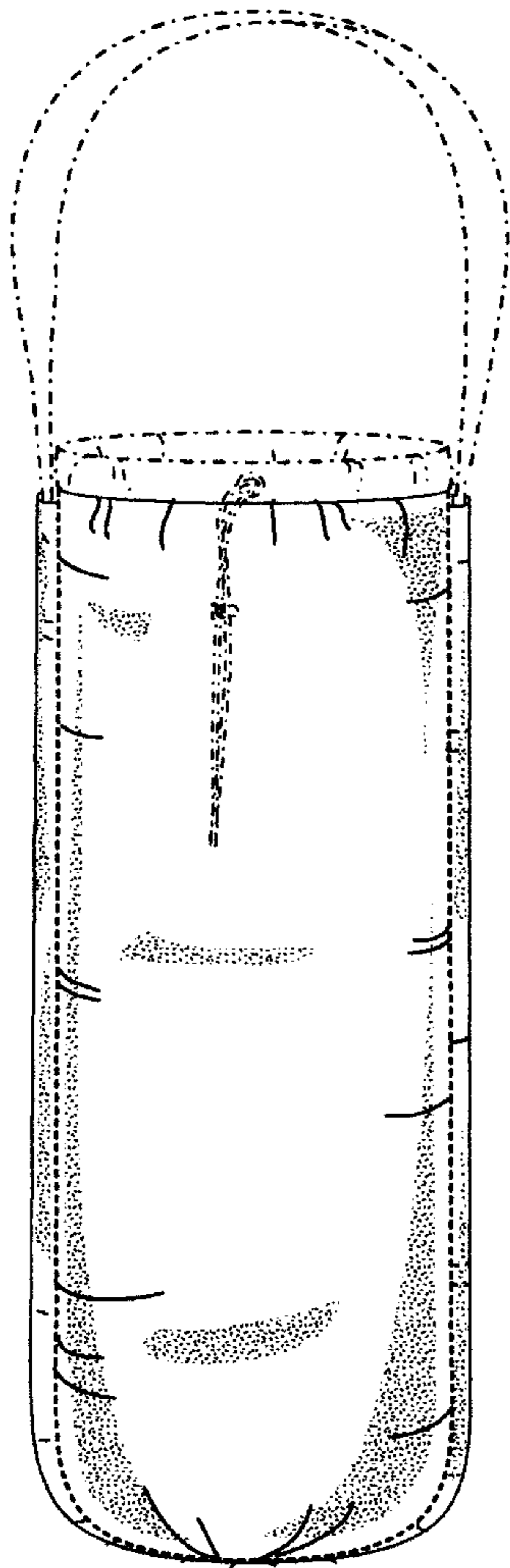

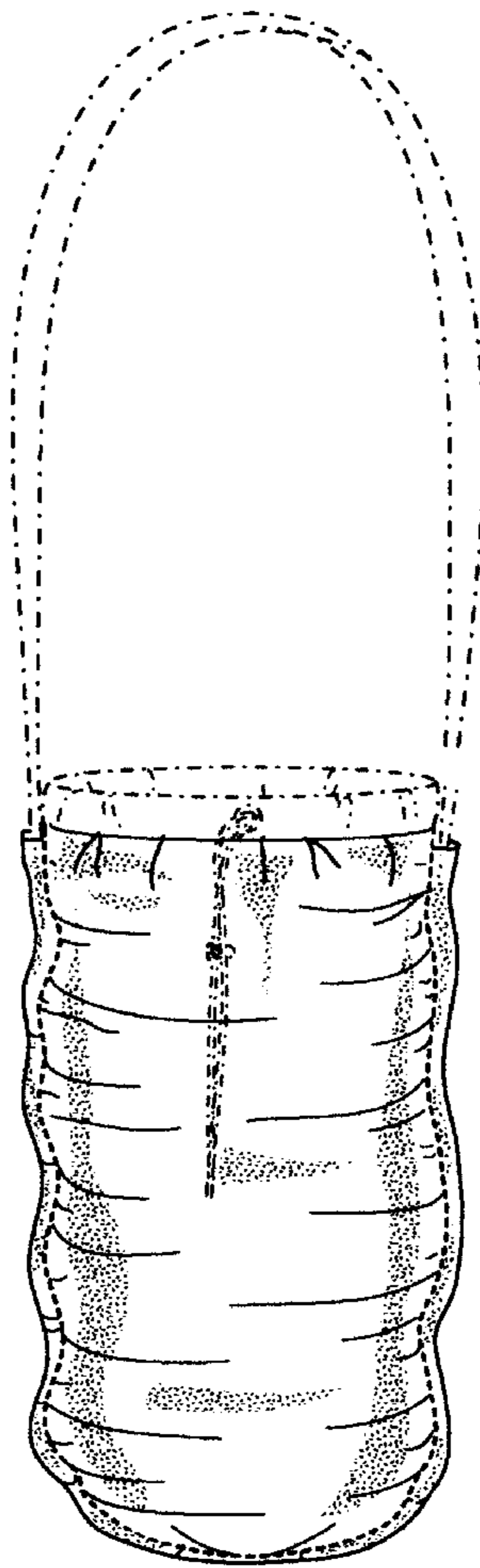

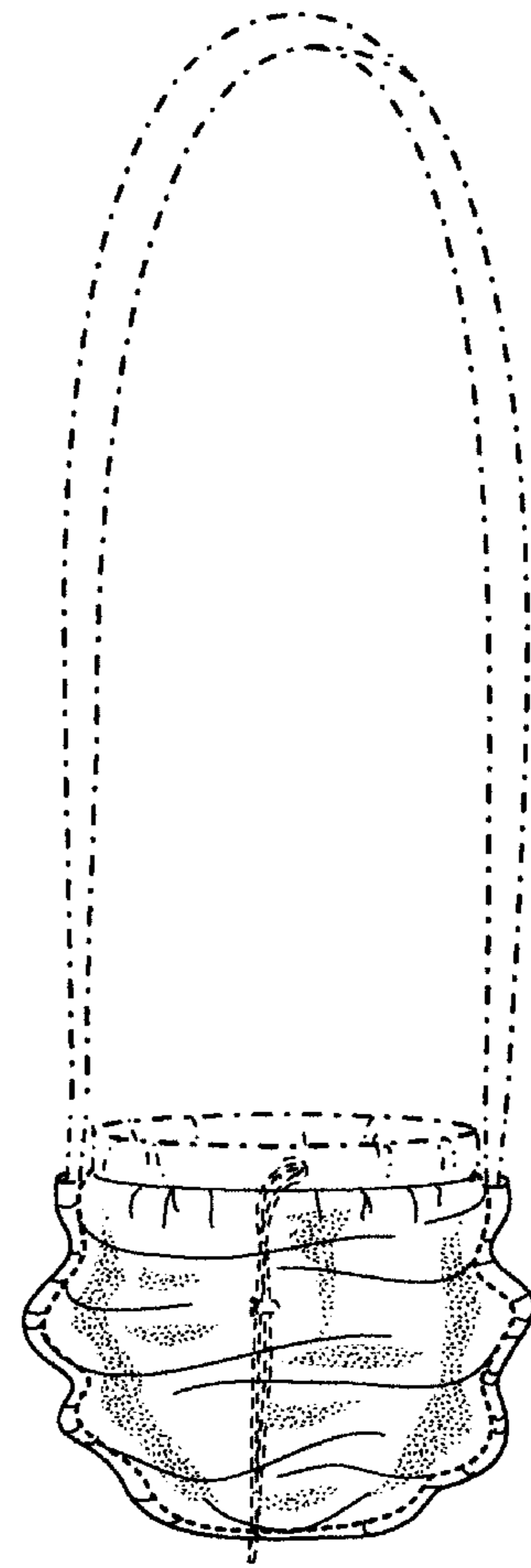

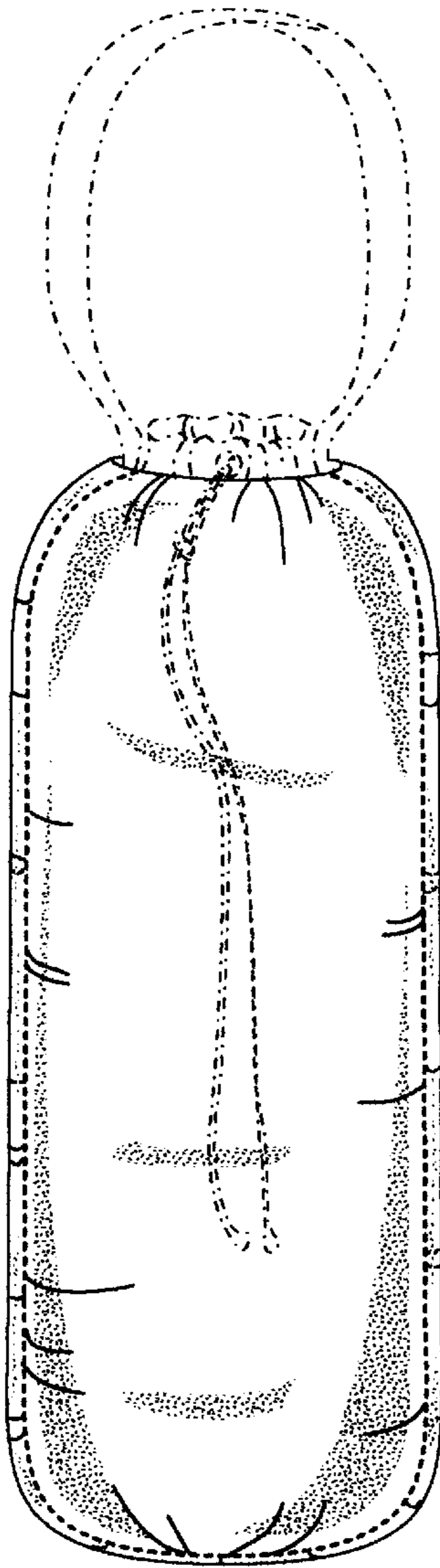

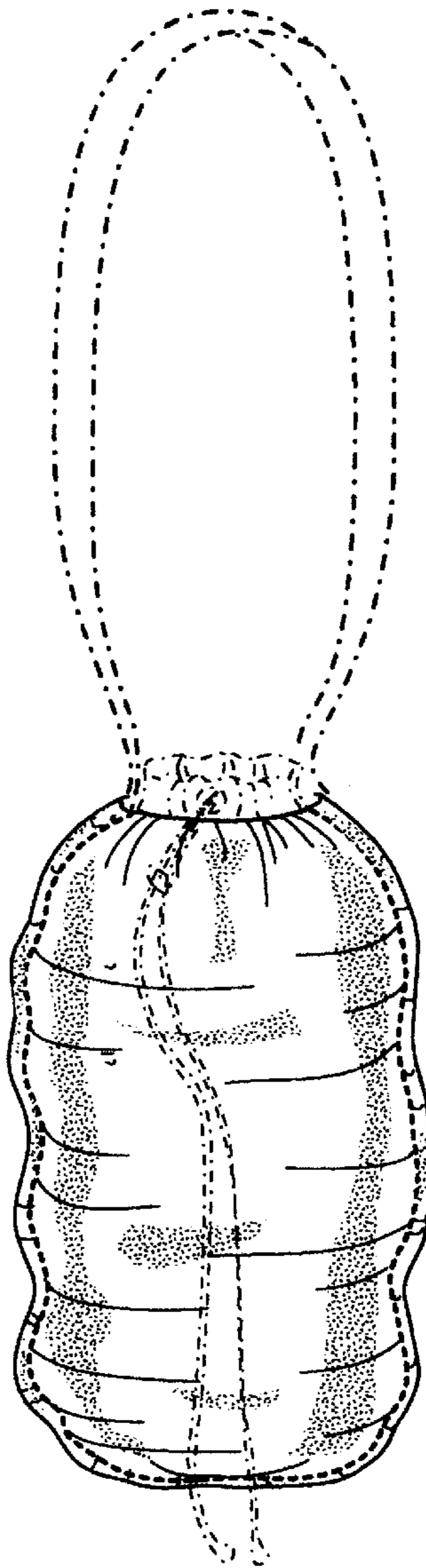

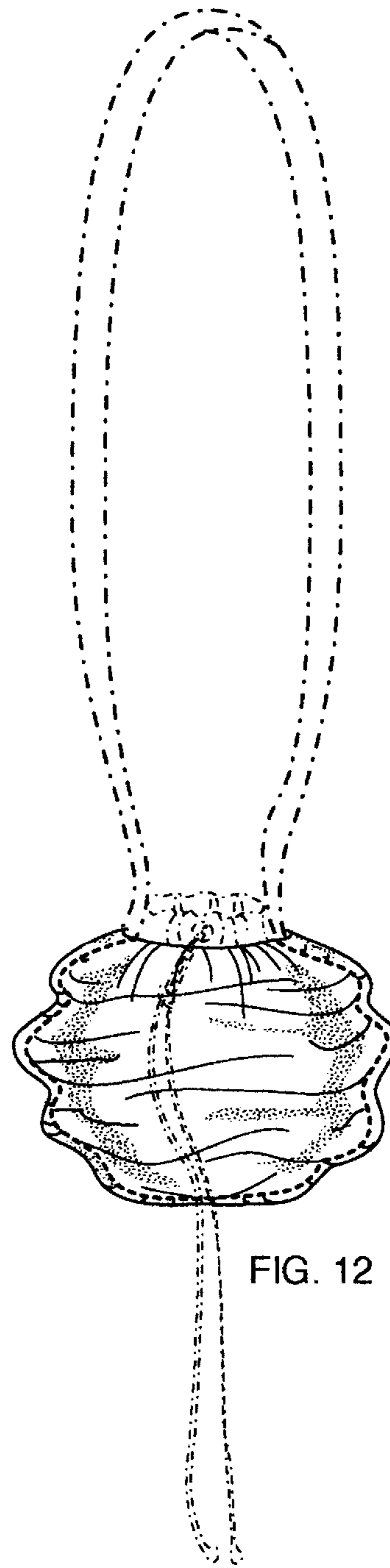
