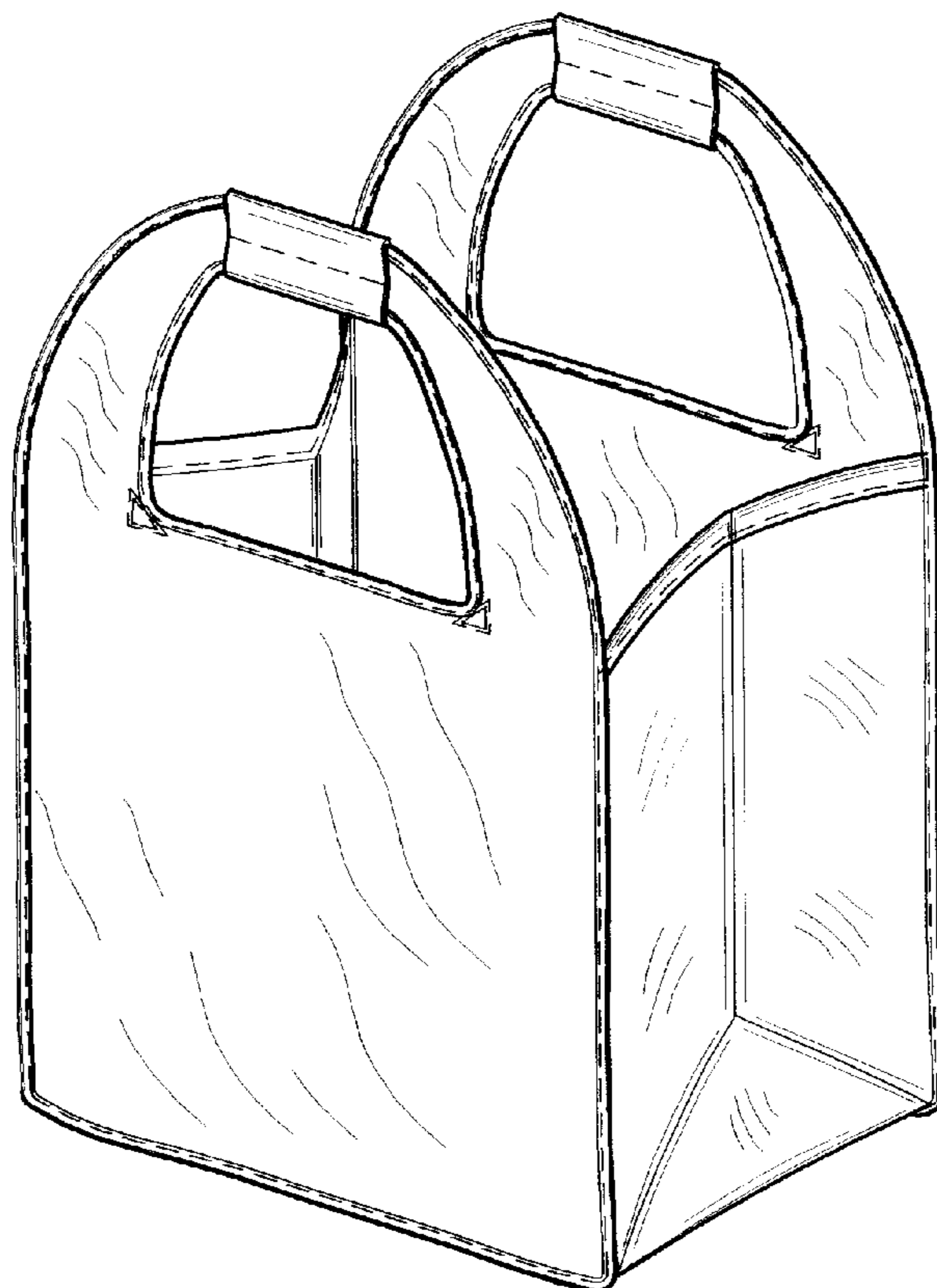
(57) **CLAIM**

The ornamental design for a bag, as shown.

DESCRIPTION

FIG. 1 is a right hand side perspective view of the bag;
FIG. 2 is a left hand side perspective view of the bag;
FIG. 3 is a front elevation view of the bag;
FIG. 4 is a rear elevation view of the bag;
FIG. 5 is a view of a bottom side of the bag;
FIG. 6 is a plan view looking into the bag from above the
bag;
FIG. 7 is a left hand elevation view of the bag; and,
FIG. 8 is a right hand elevation view of the bag.
The broken lines shown in the figures represent conventional
stitching.

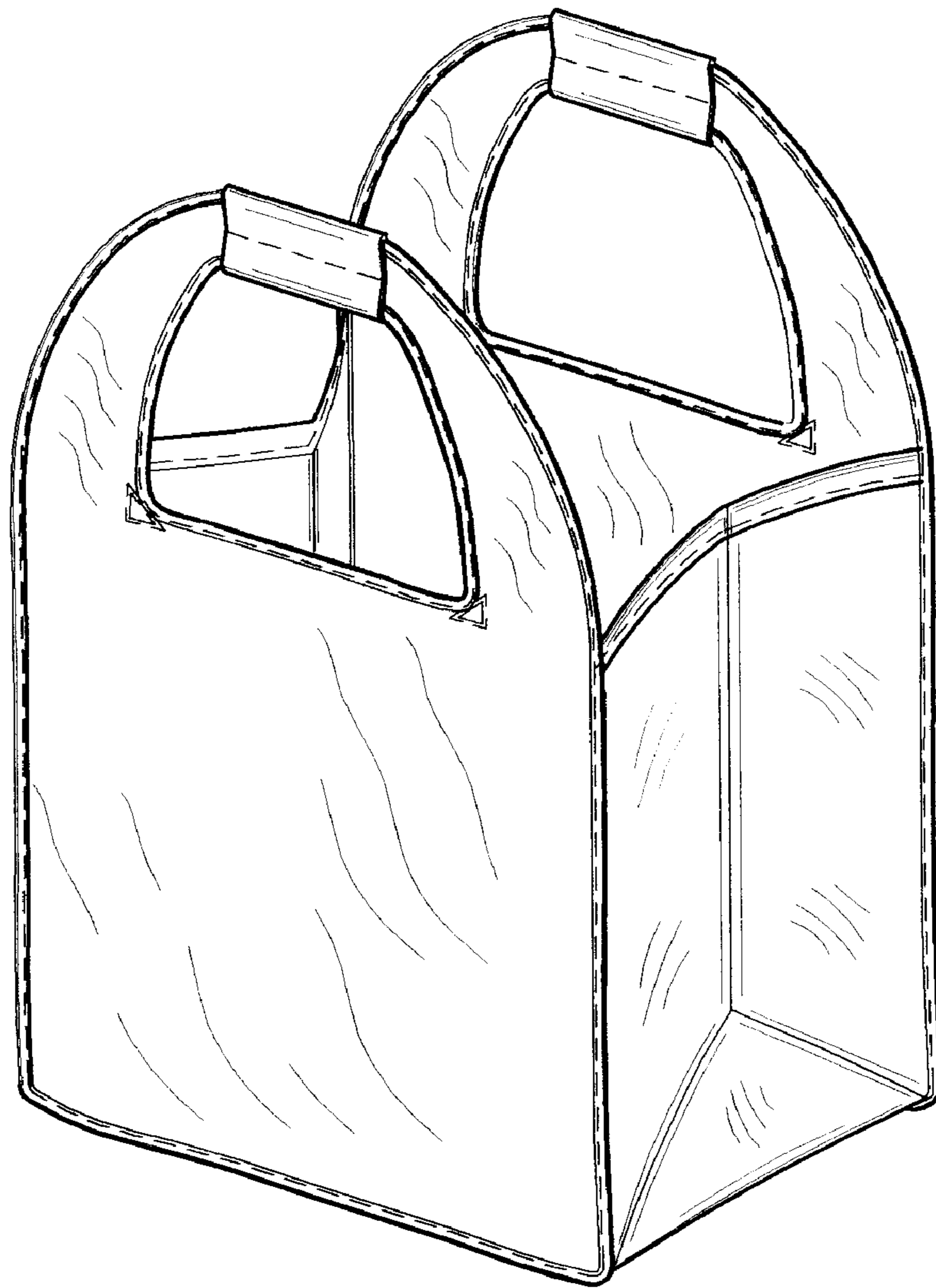

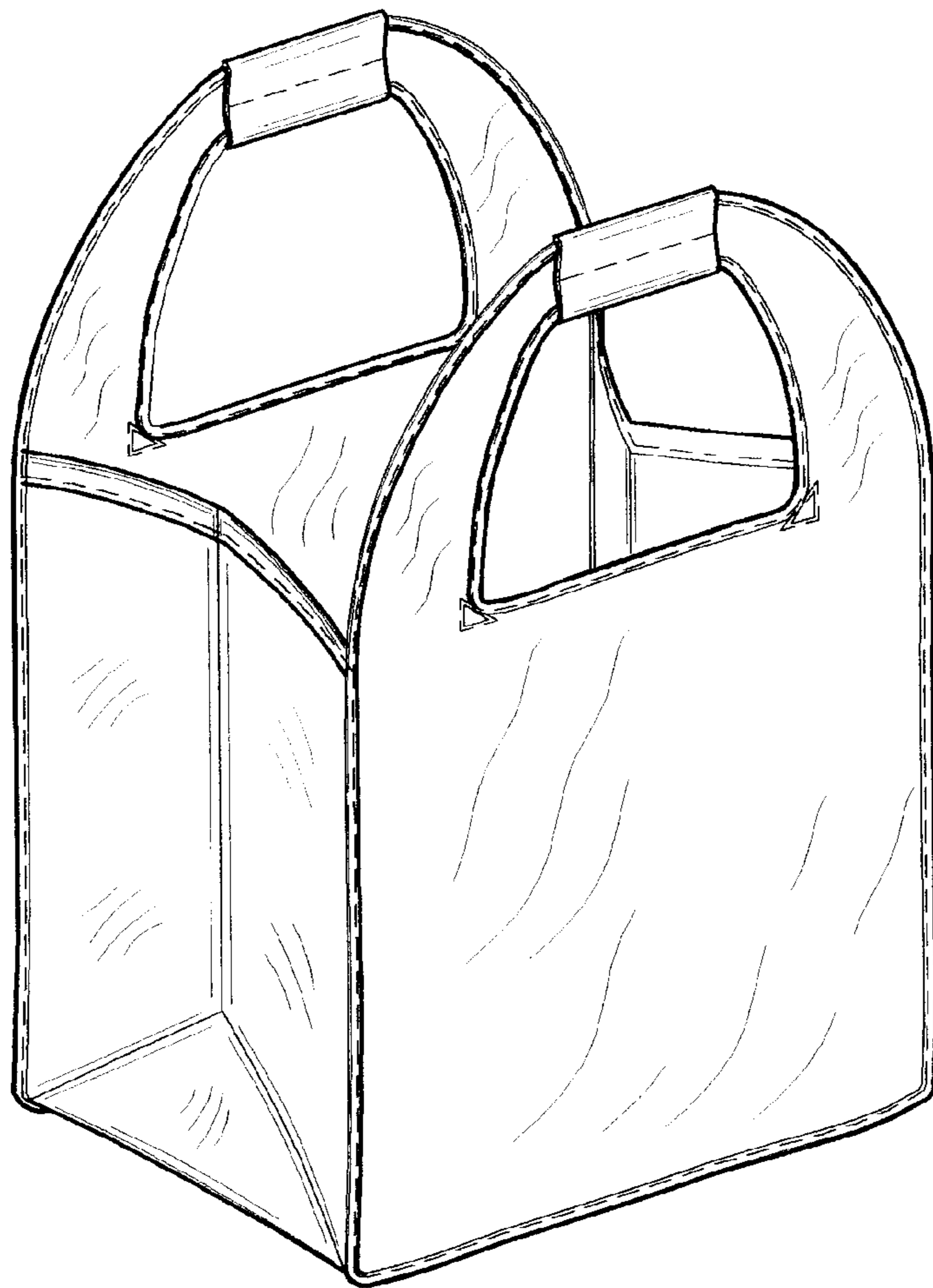

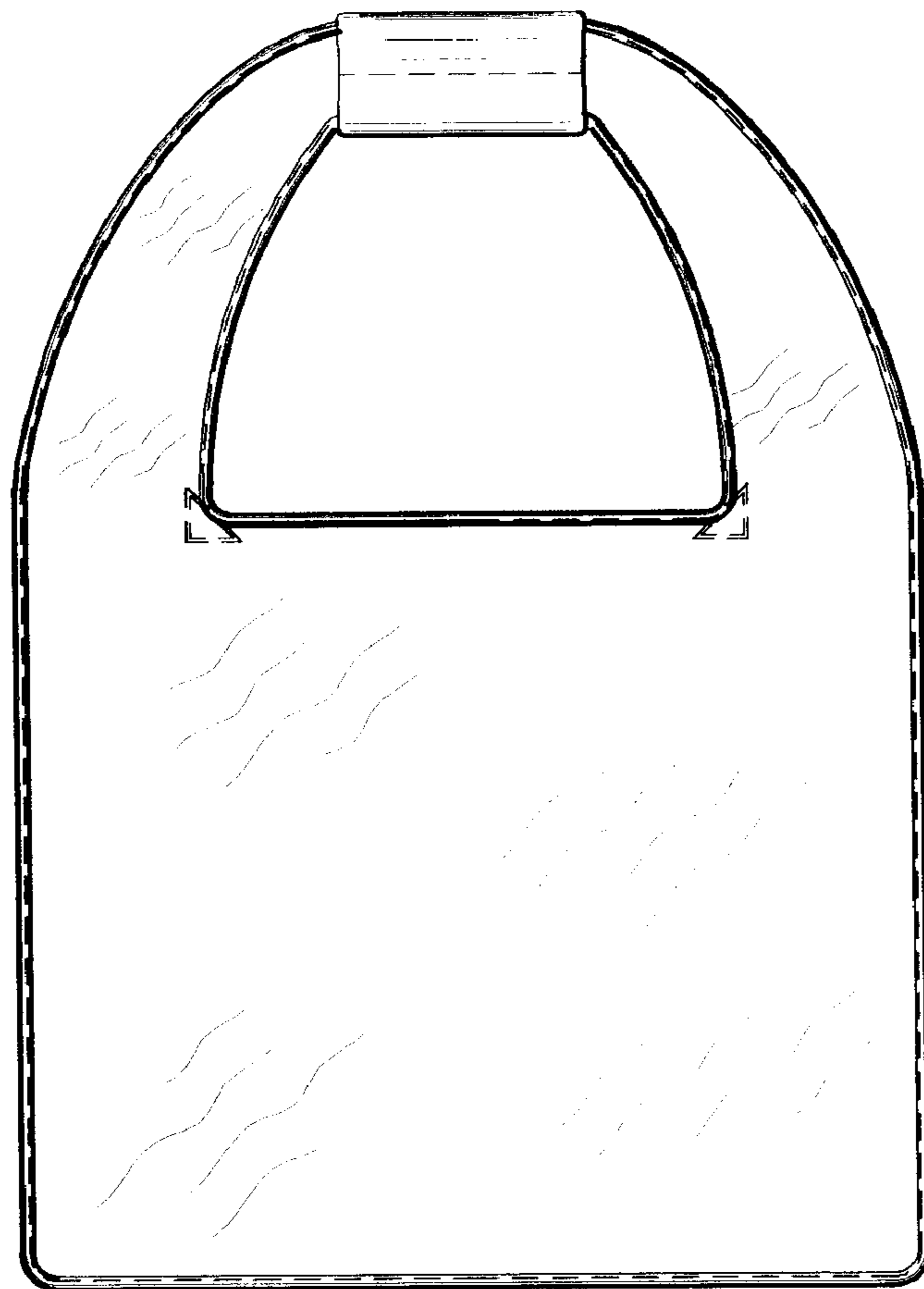

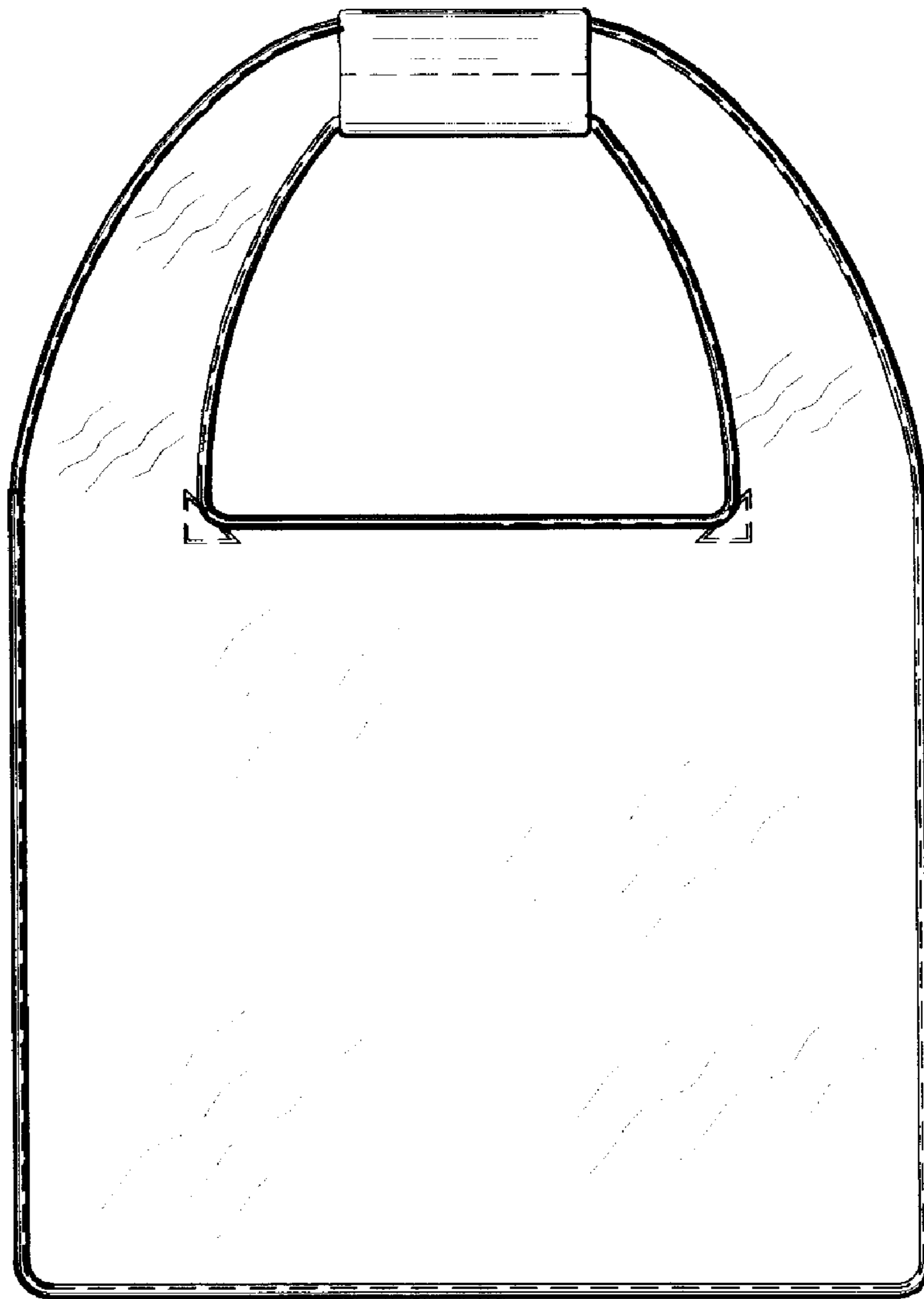

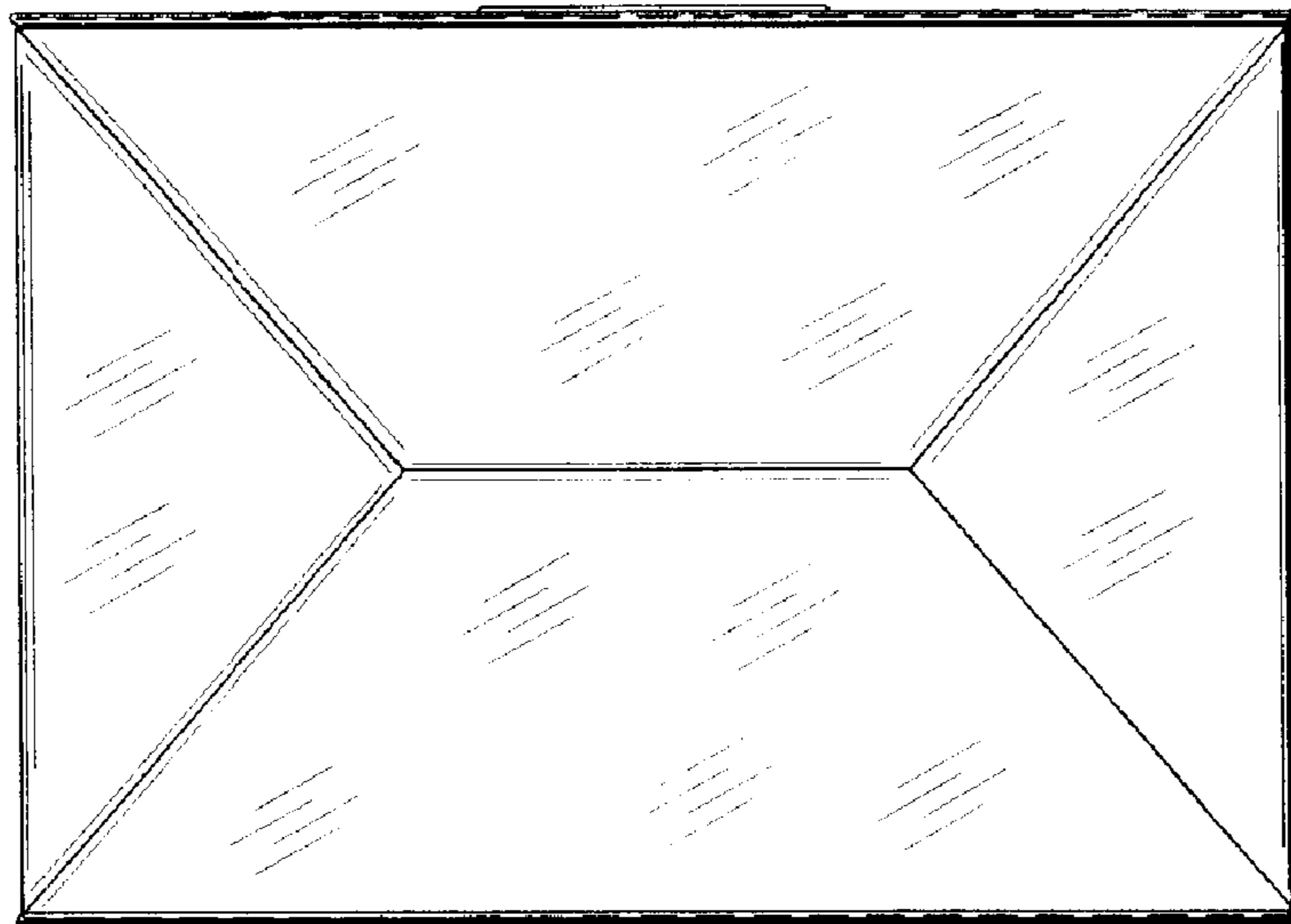

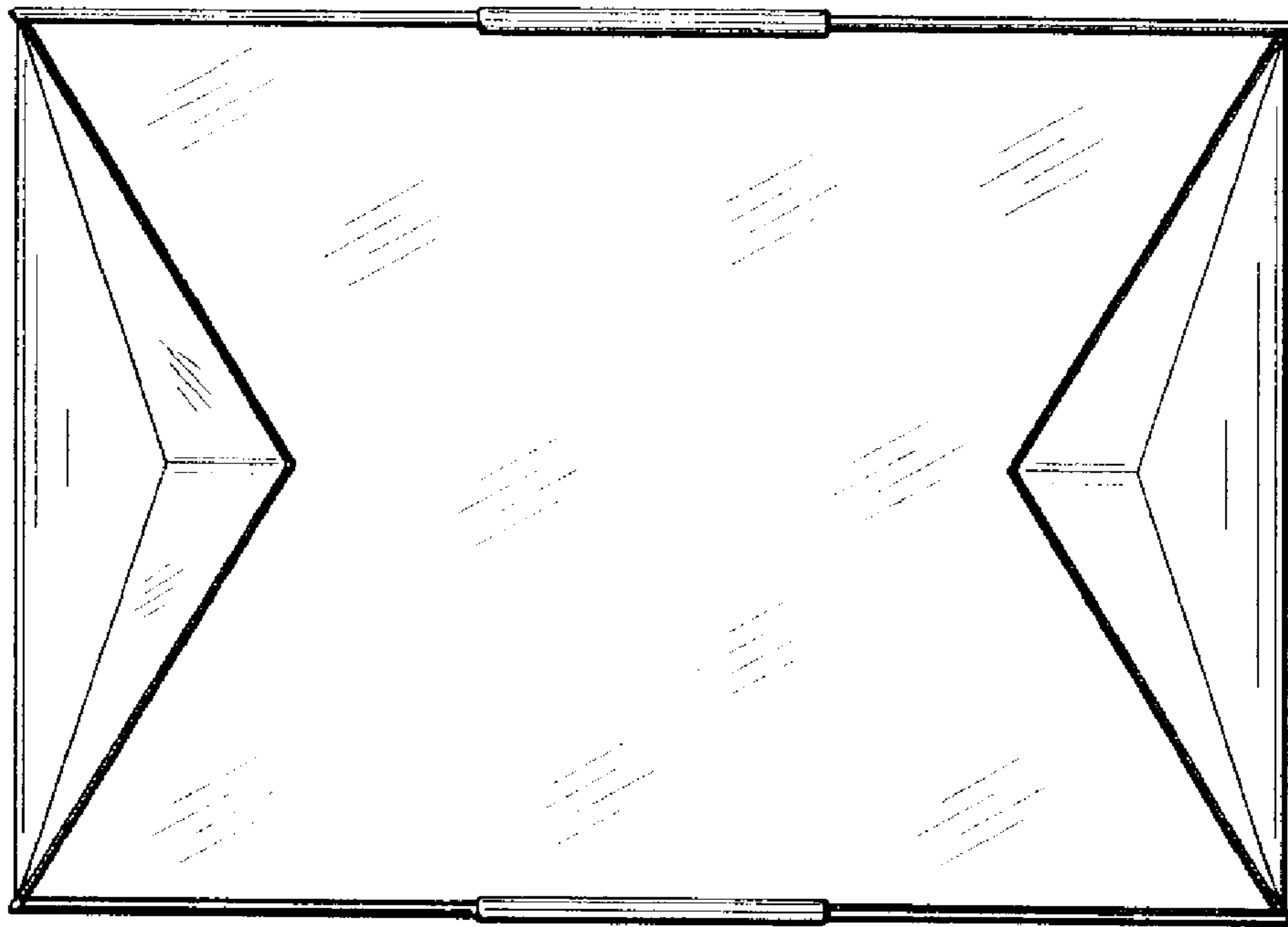

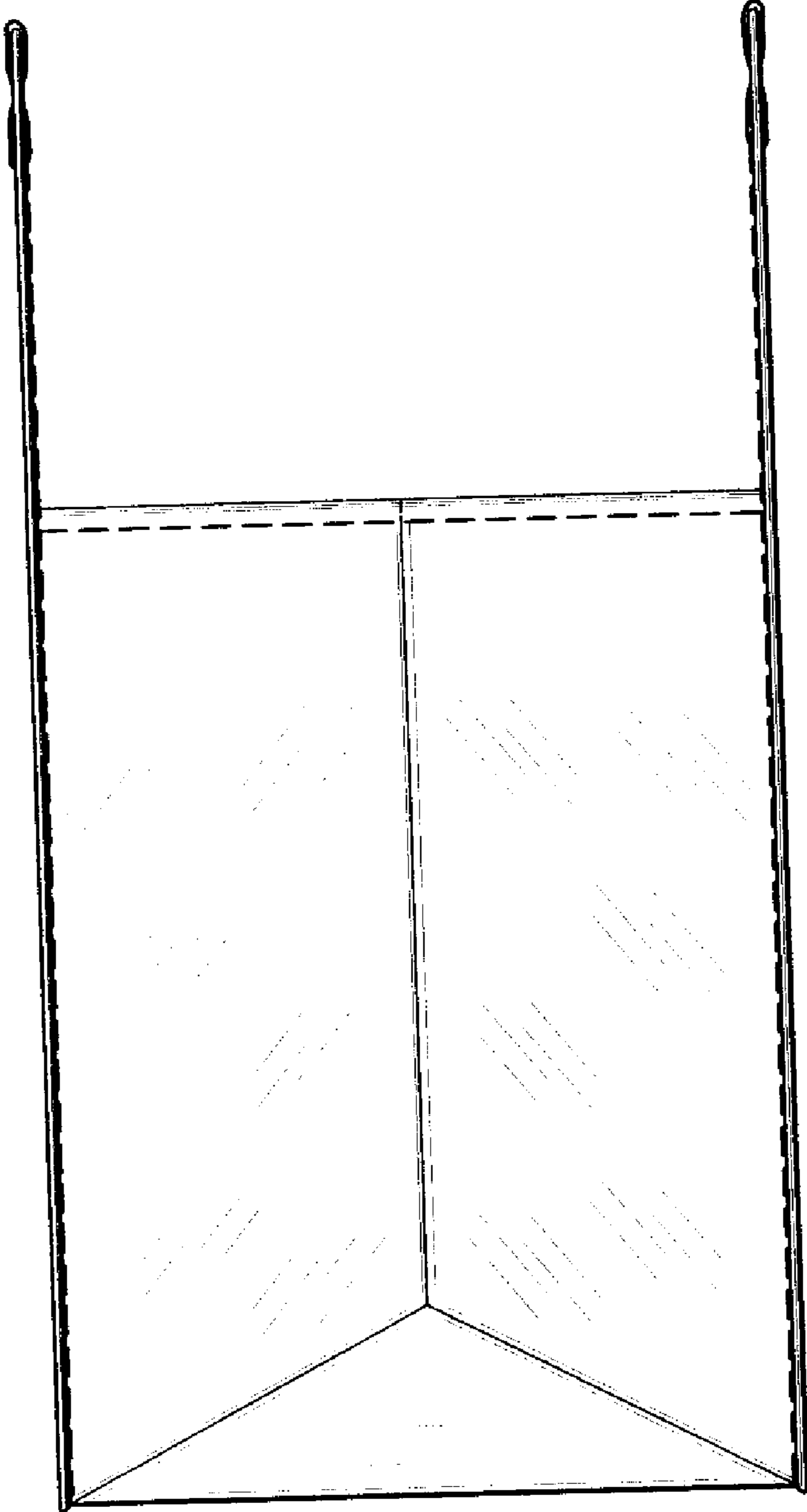

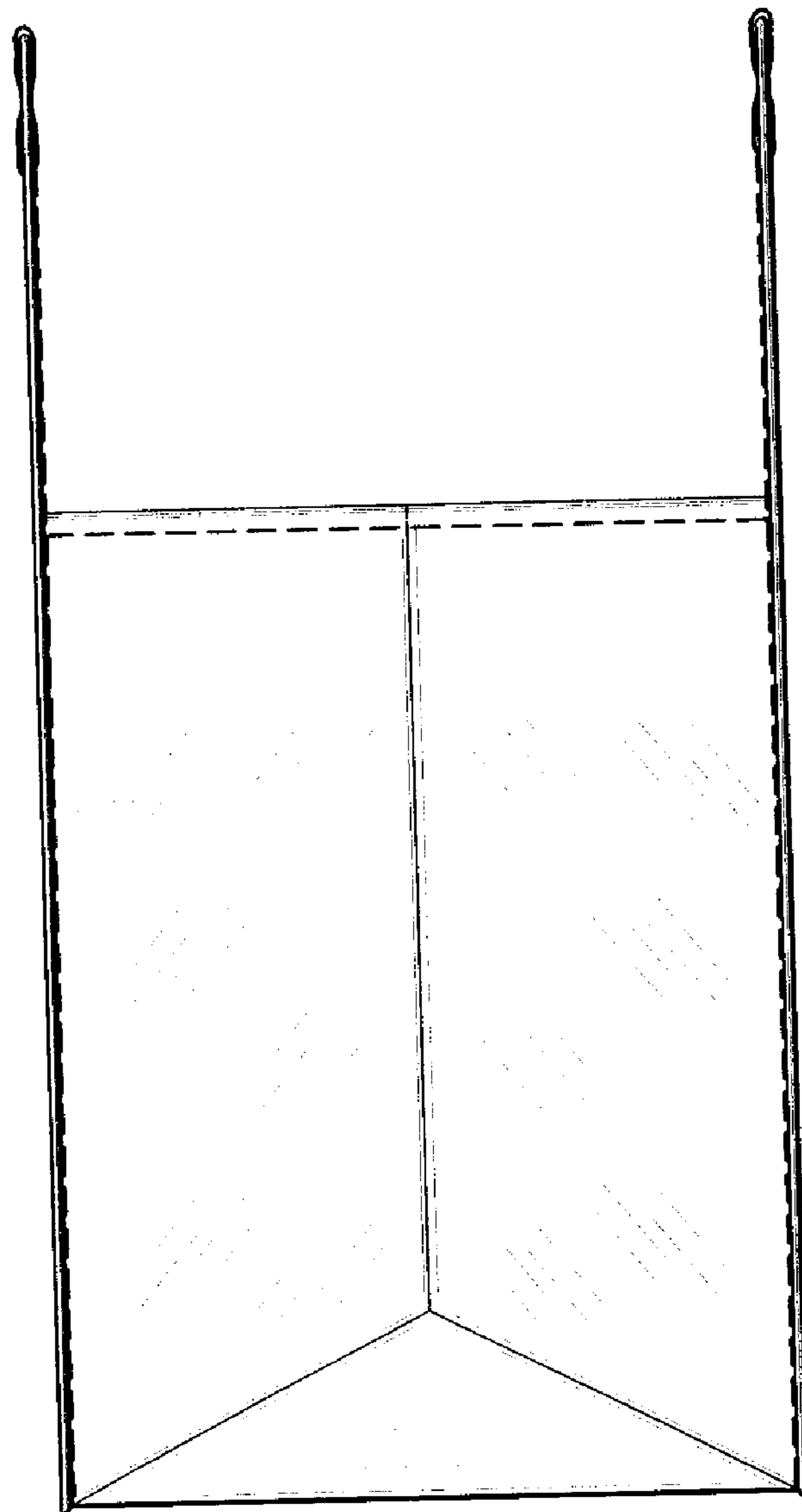
