FIG. 6 is a top view of the design according to the invention.

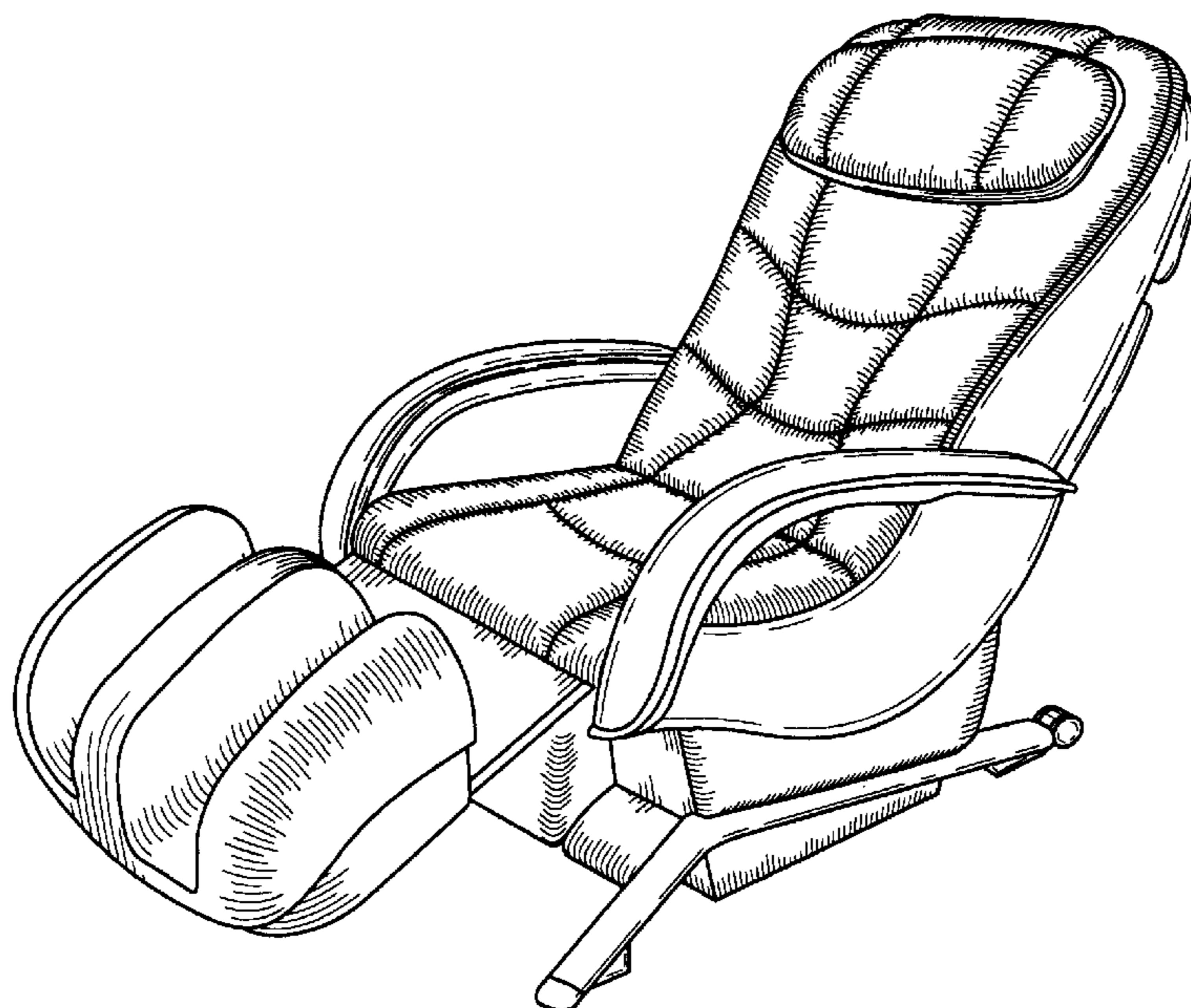
FIG. 7 is a right side view in an alternative position of the design according to the invention.

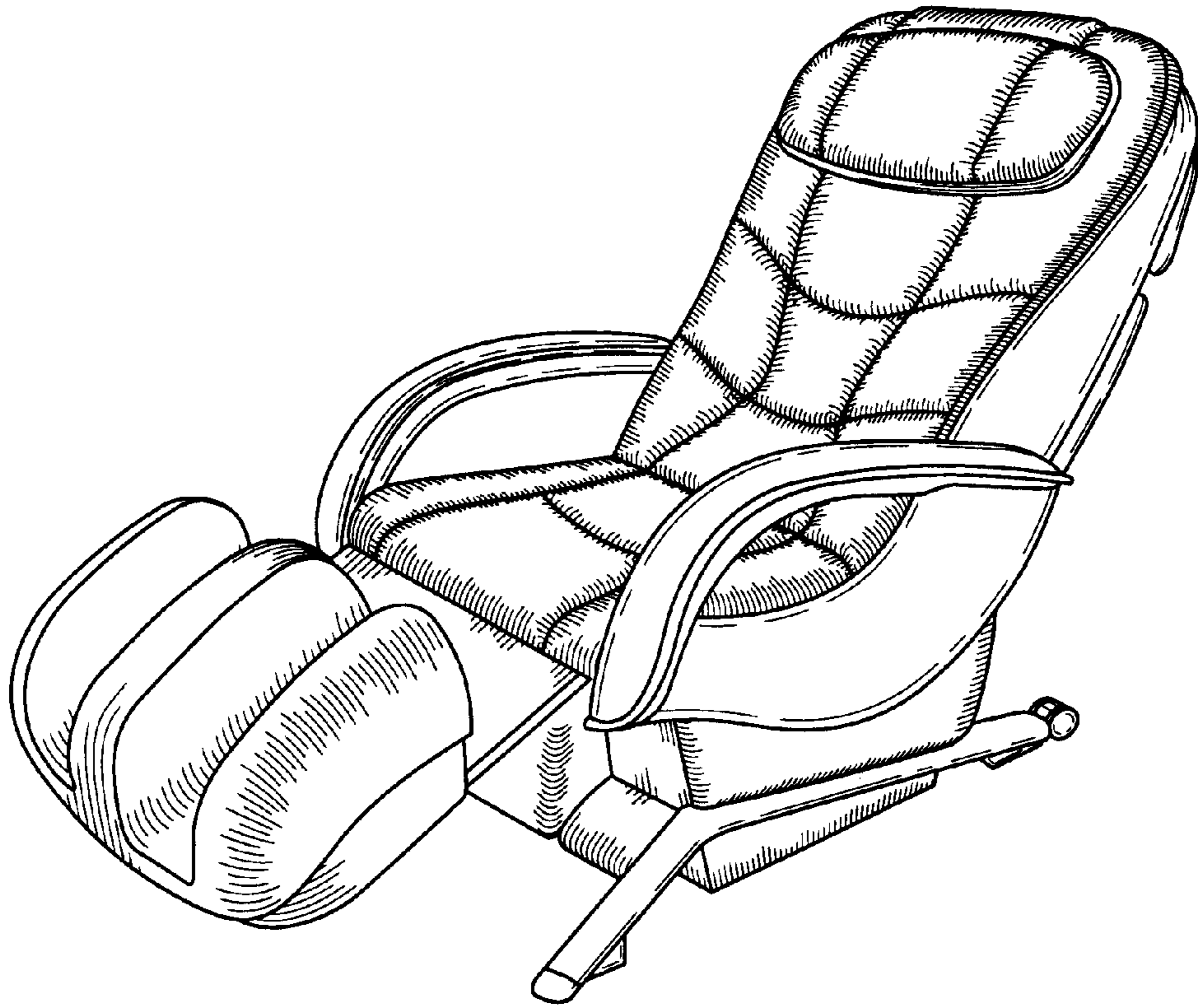
FIG. 8 is a right side view in an alternative position of the design according to the invention; and,

FIG. 9 is a right side view in an alternative position of the design according to the invention.

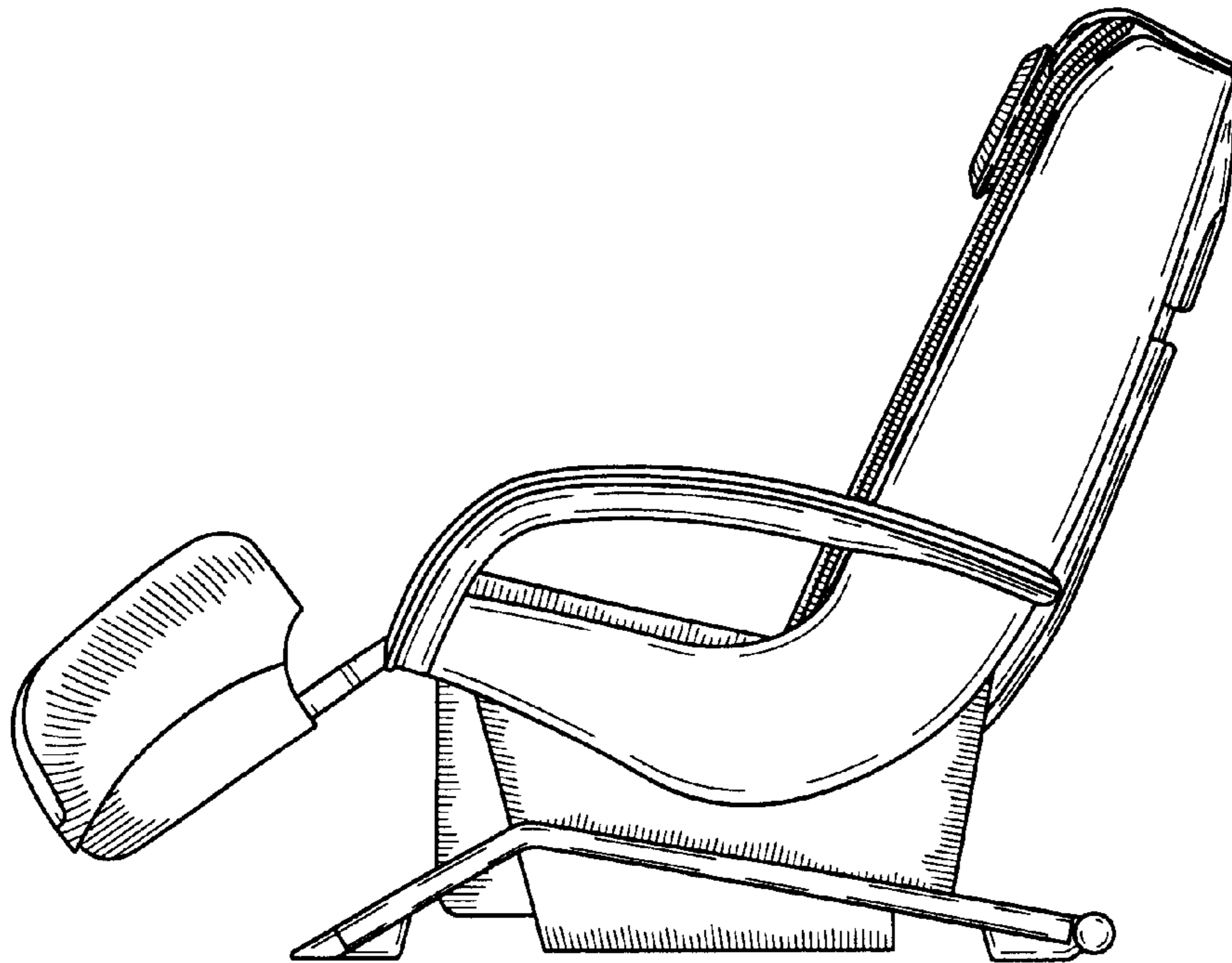
The left side view is a mirror image of the right side view.

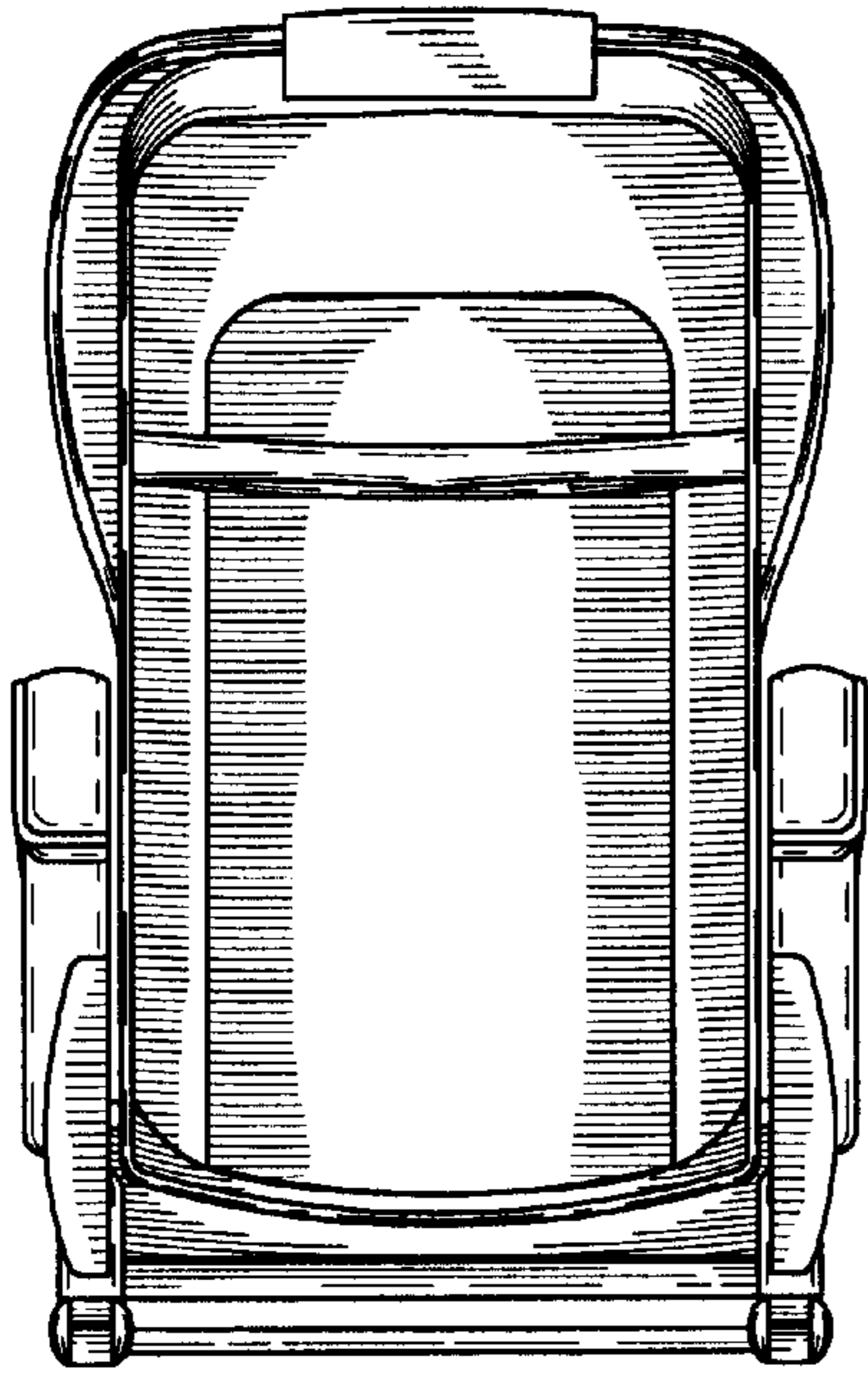




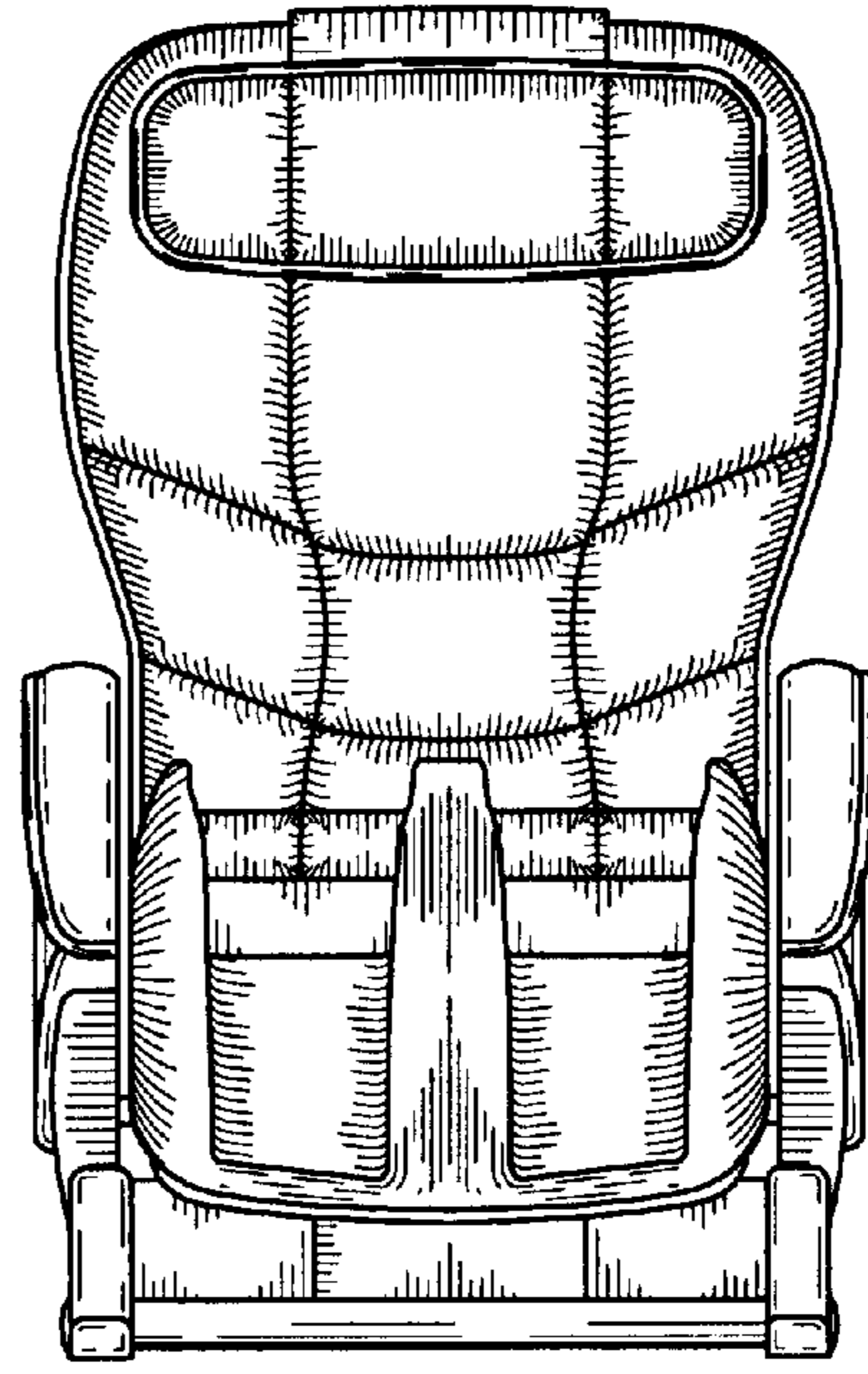

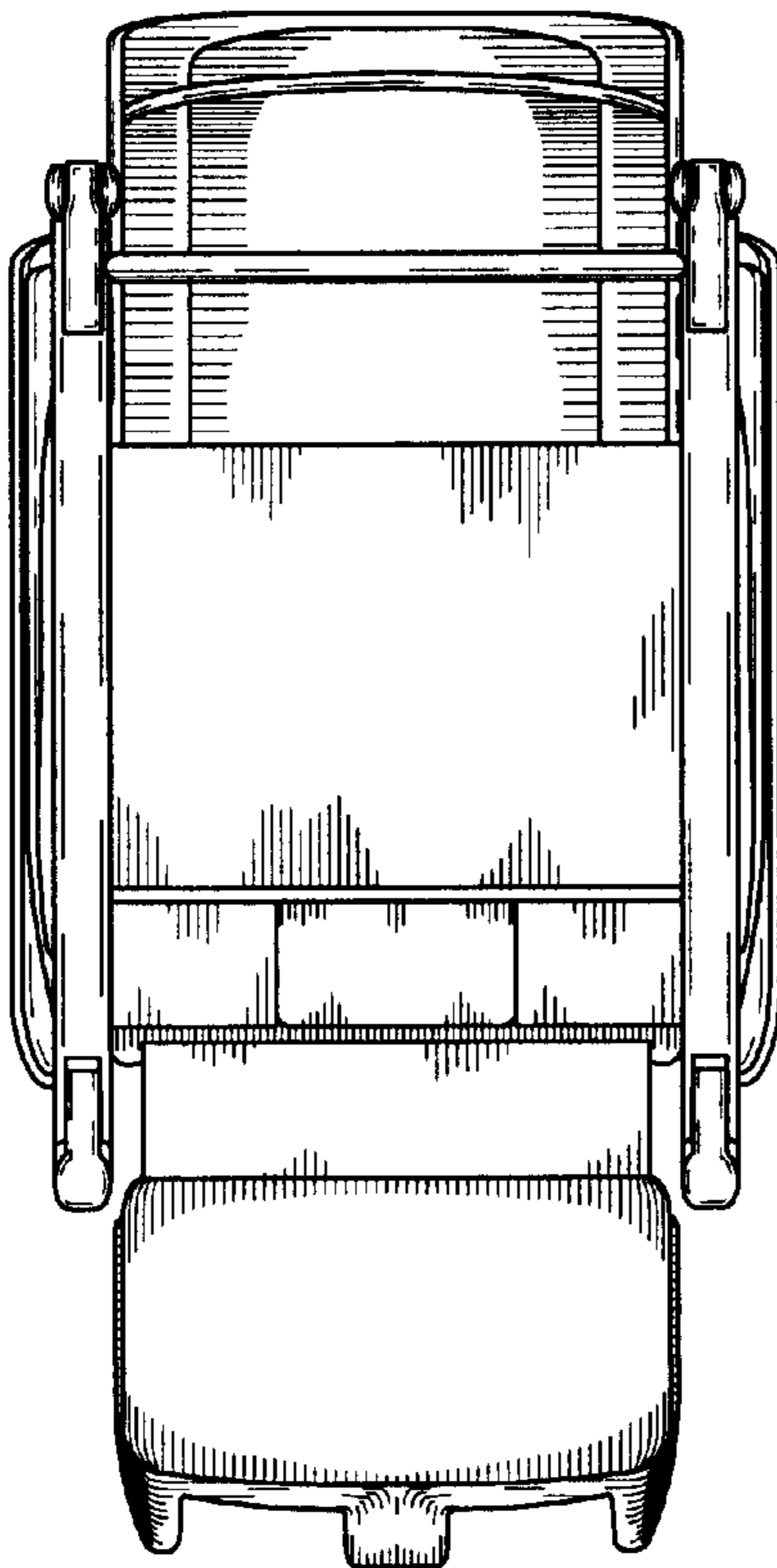

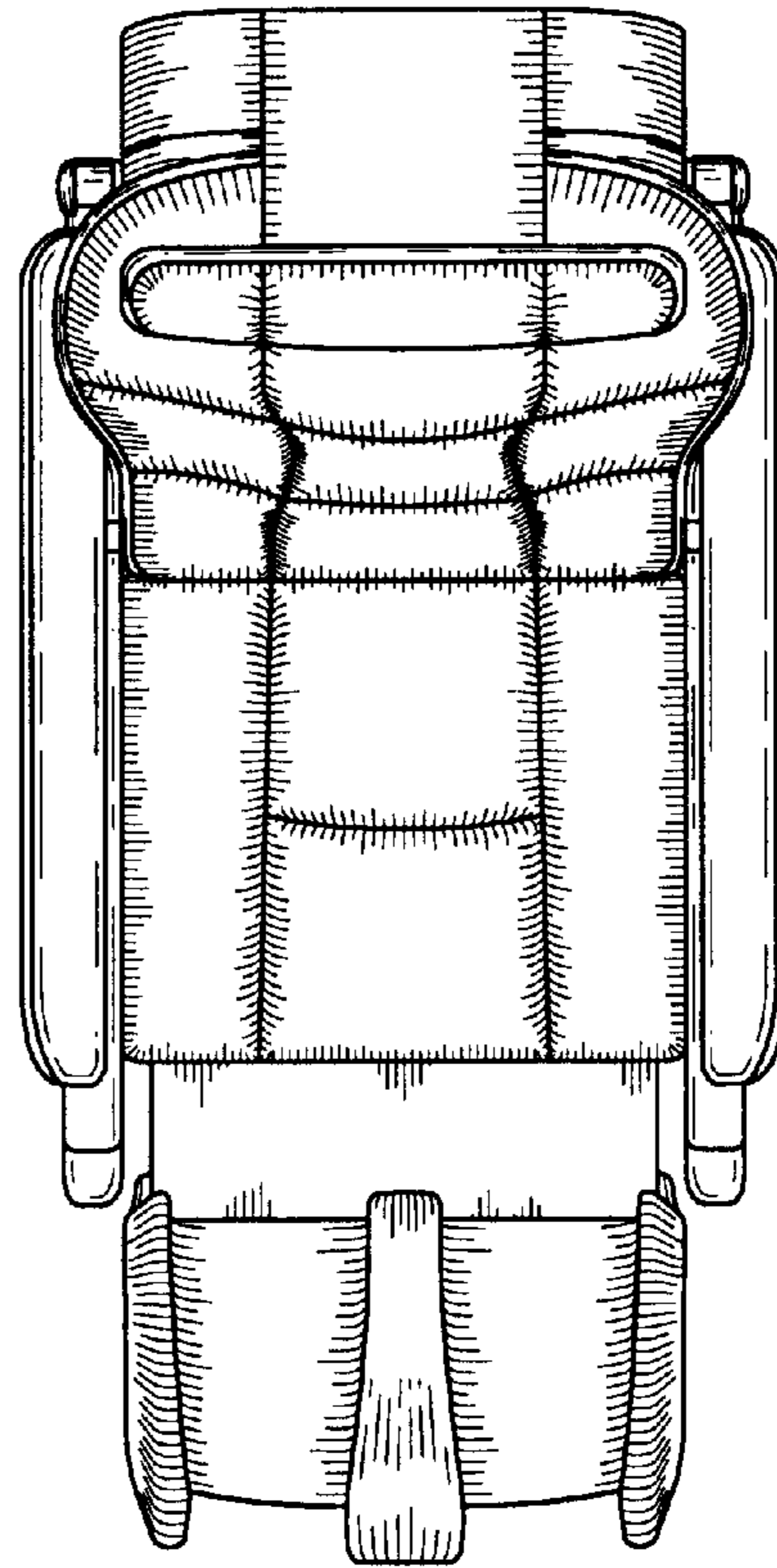

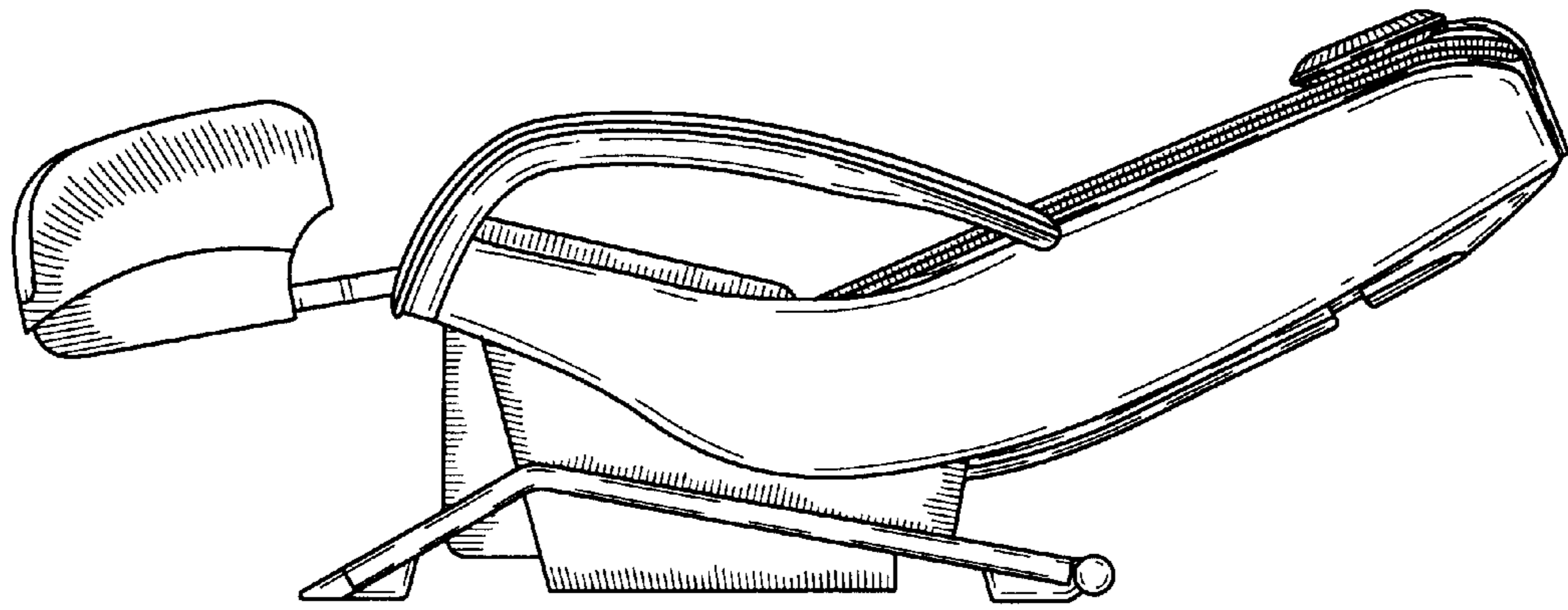

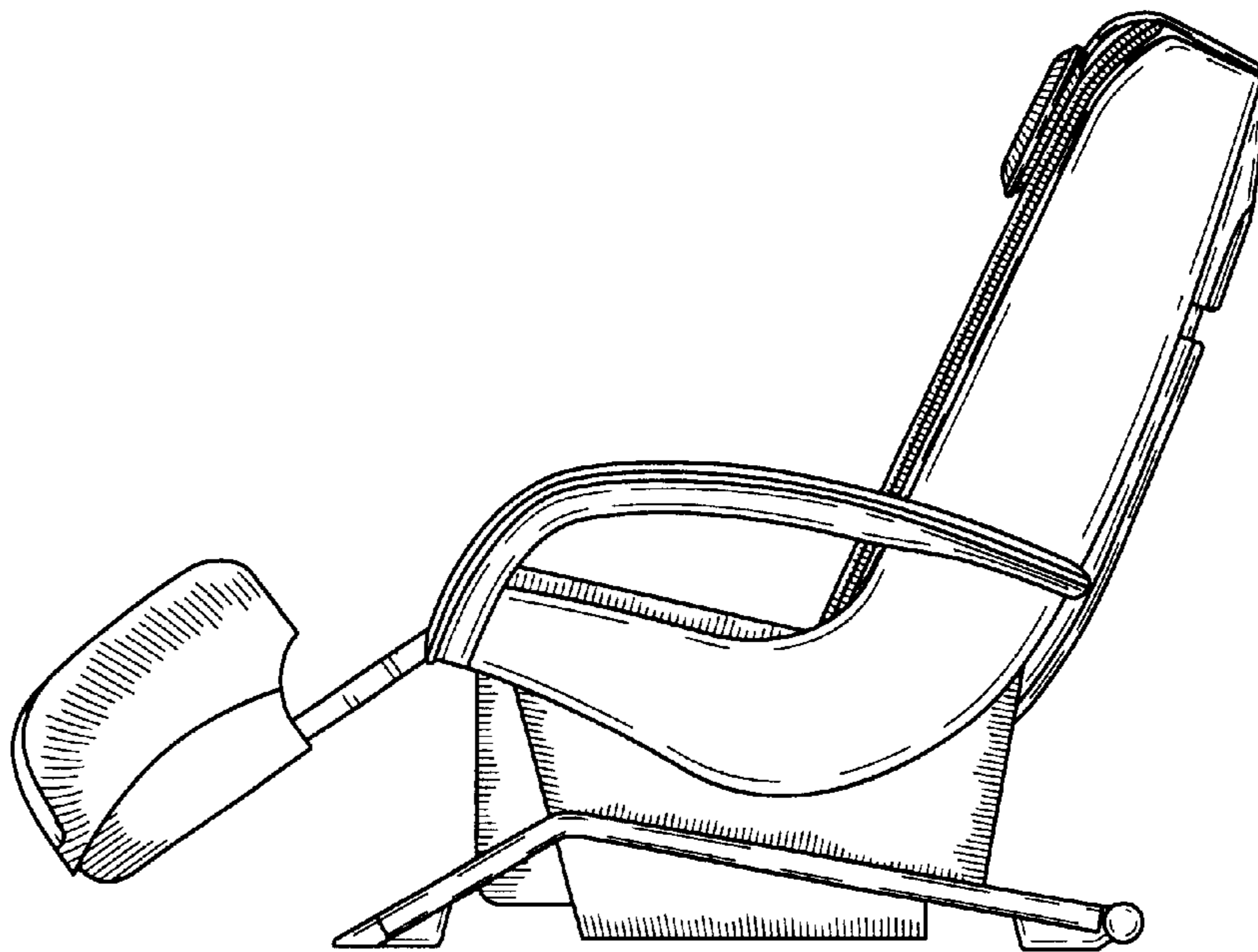

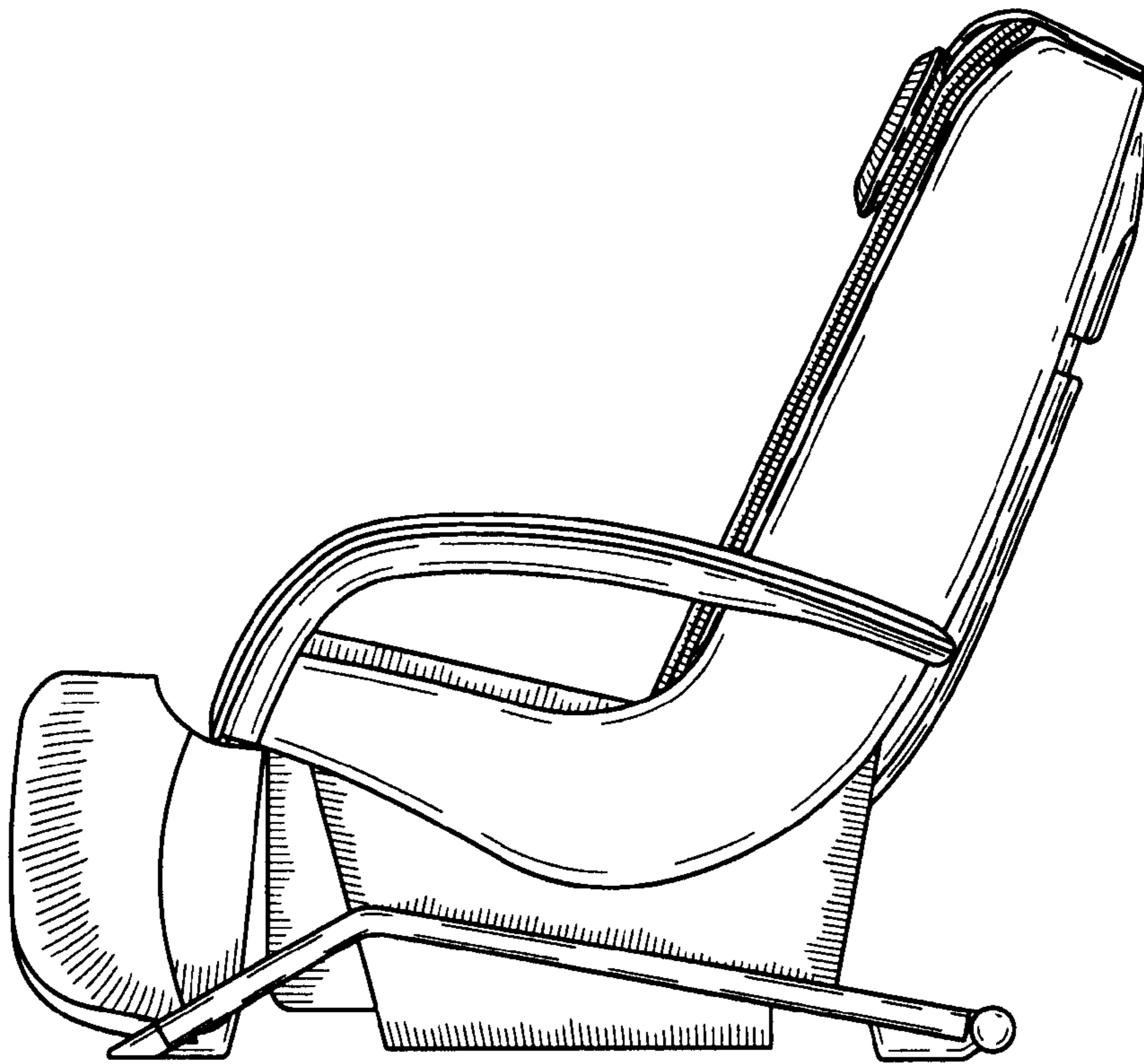
