(57) **CLAIM**

We claim the ornamental design for a seat and backrest for a chair, as shown and described.

**DESCRIPTION**

FIG. 1 is a left, front perspective view of a seat and backrest for a chair embodying our new design.

FIG. 2 is a front elevational view thereof.

FIG. 3 is a rear elevational view thereof.

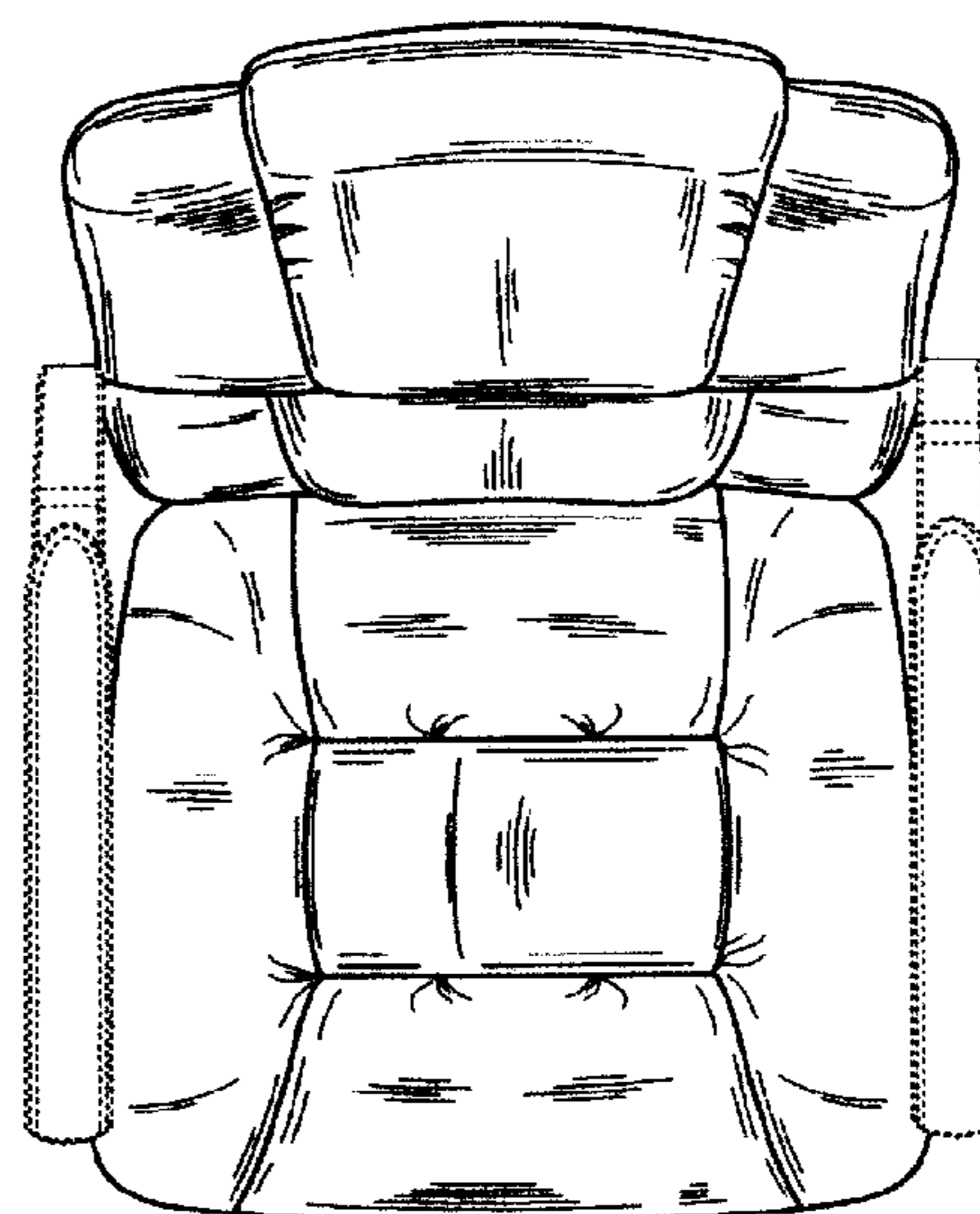
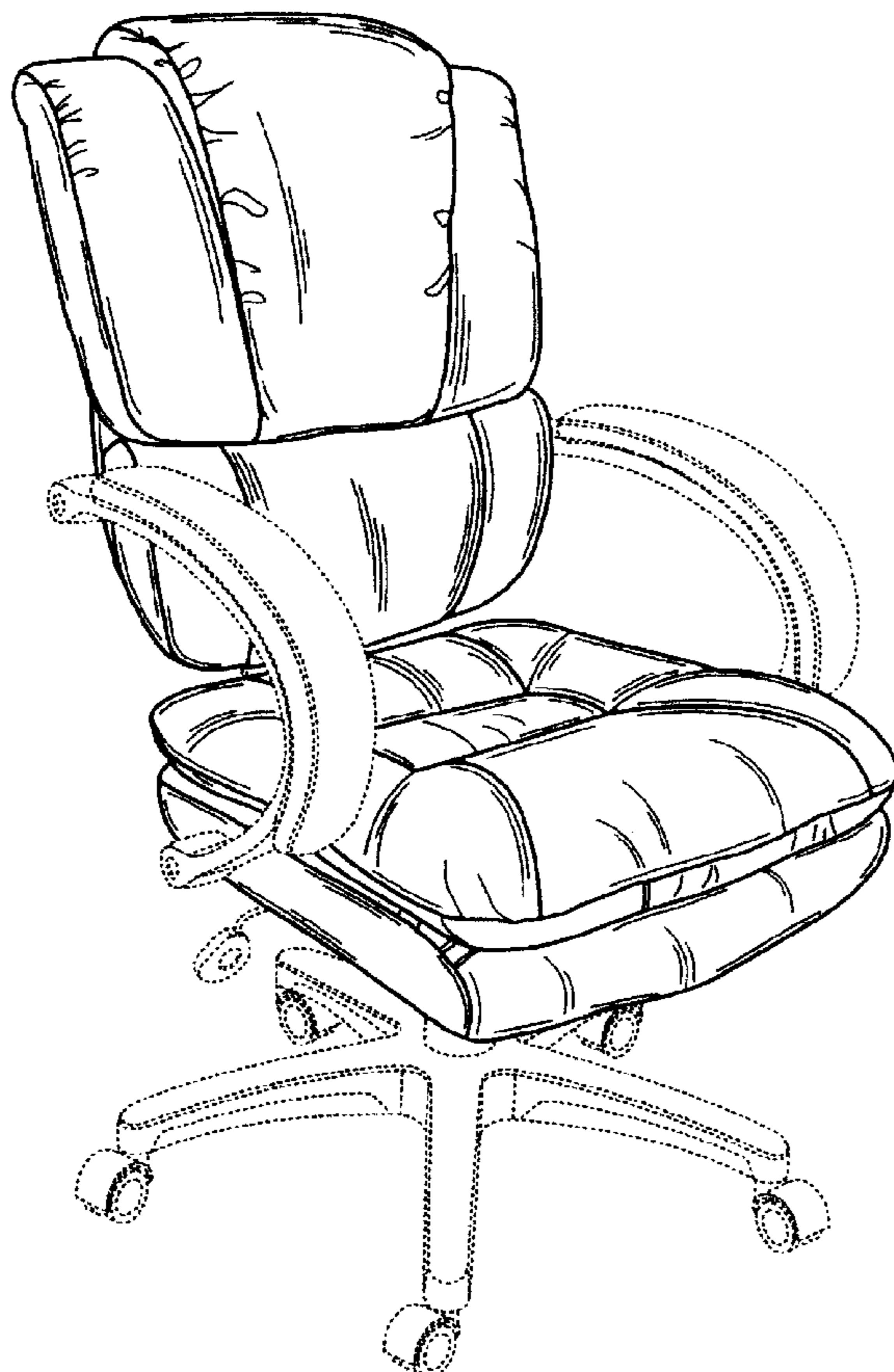
FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image thereof.

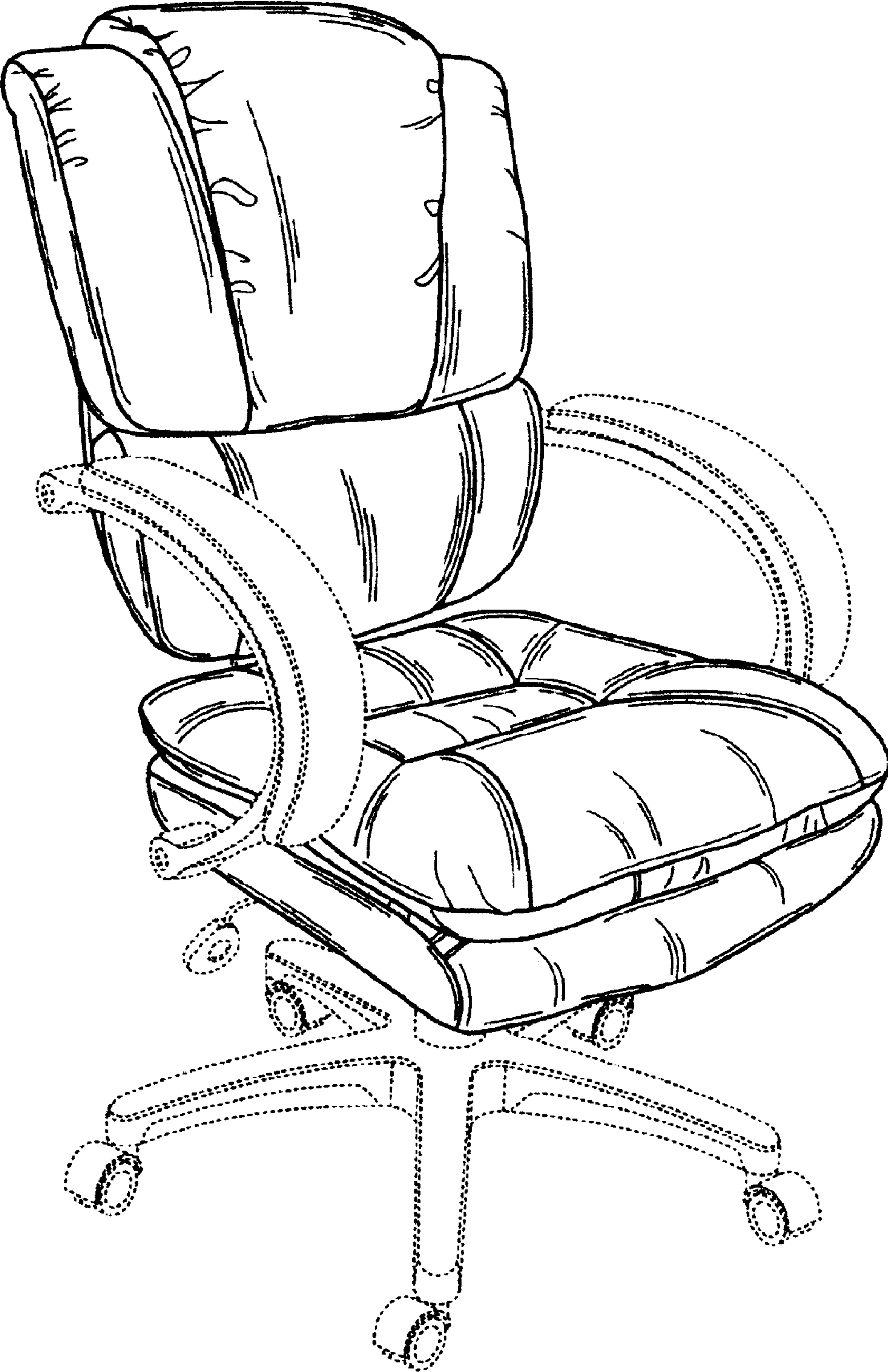
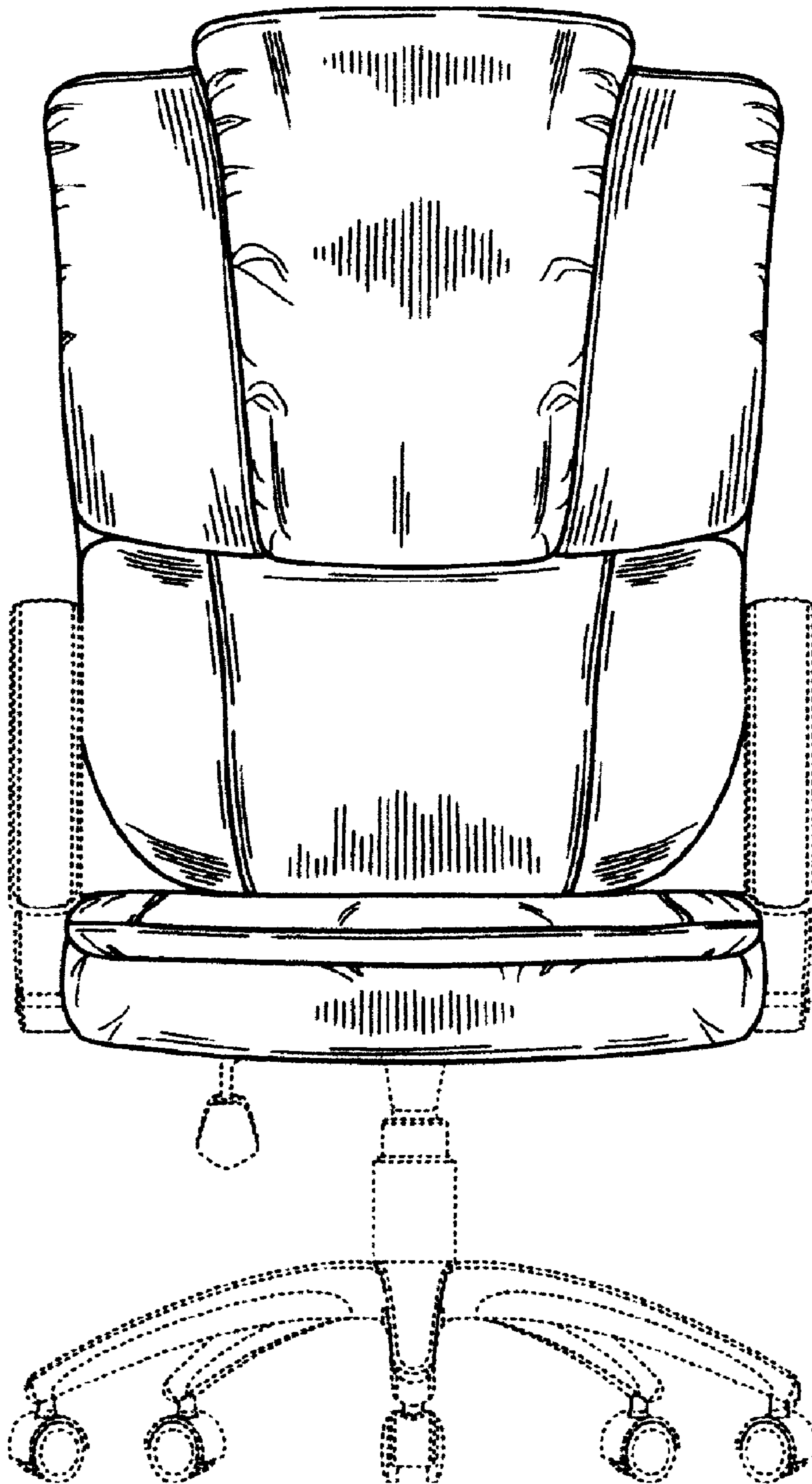
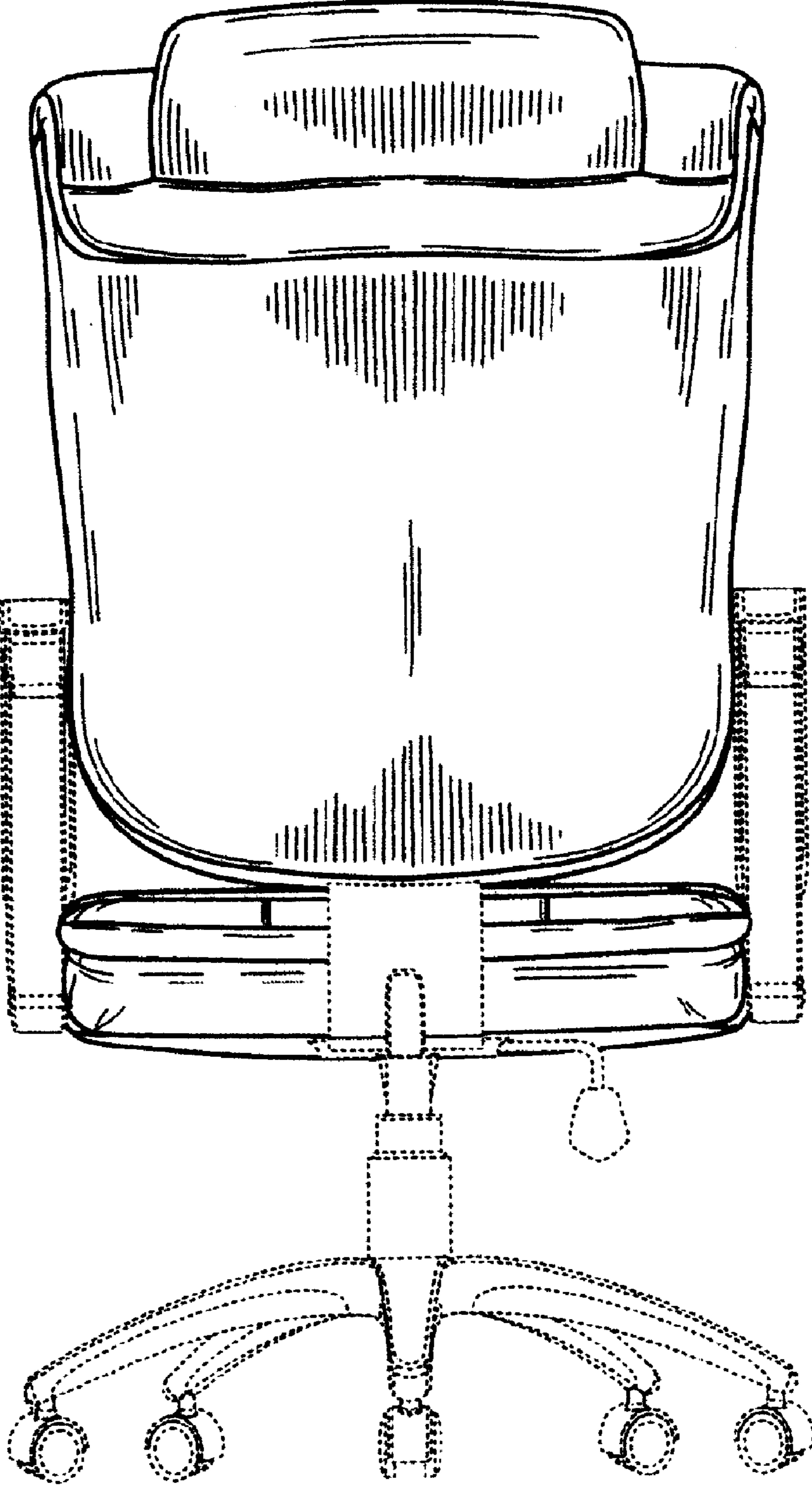


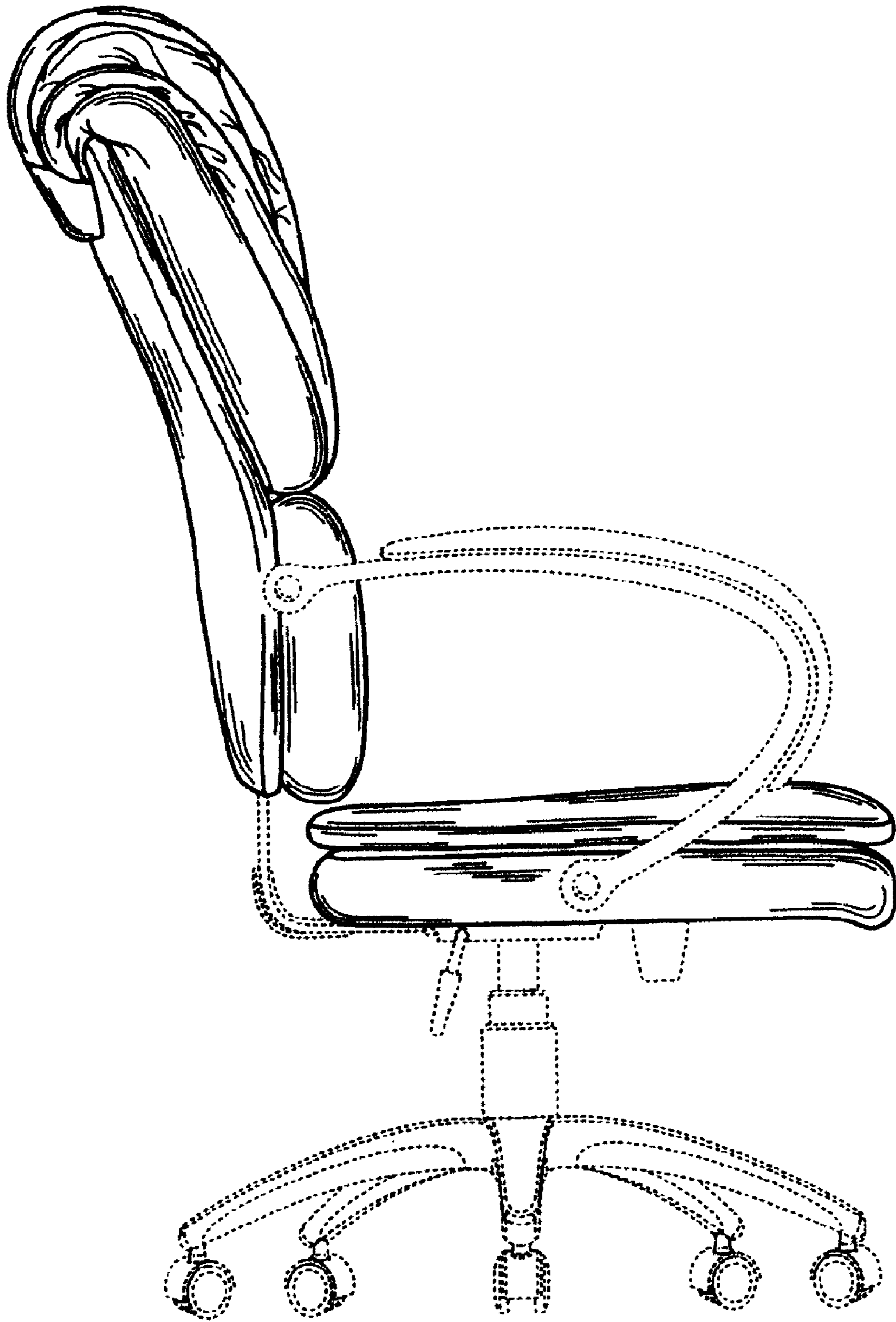

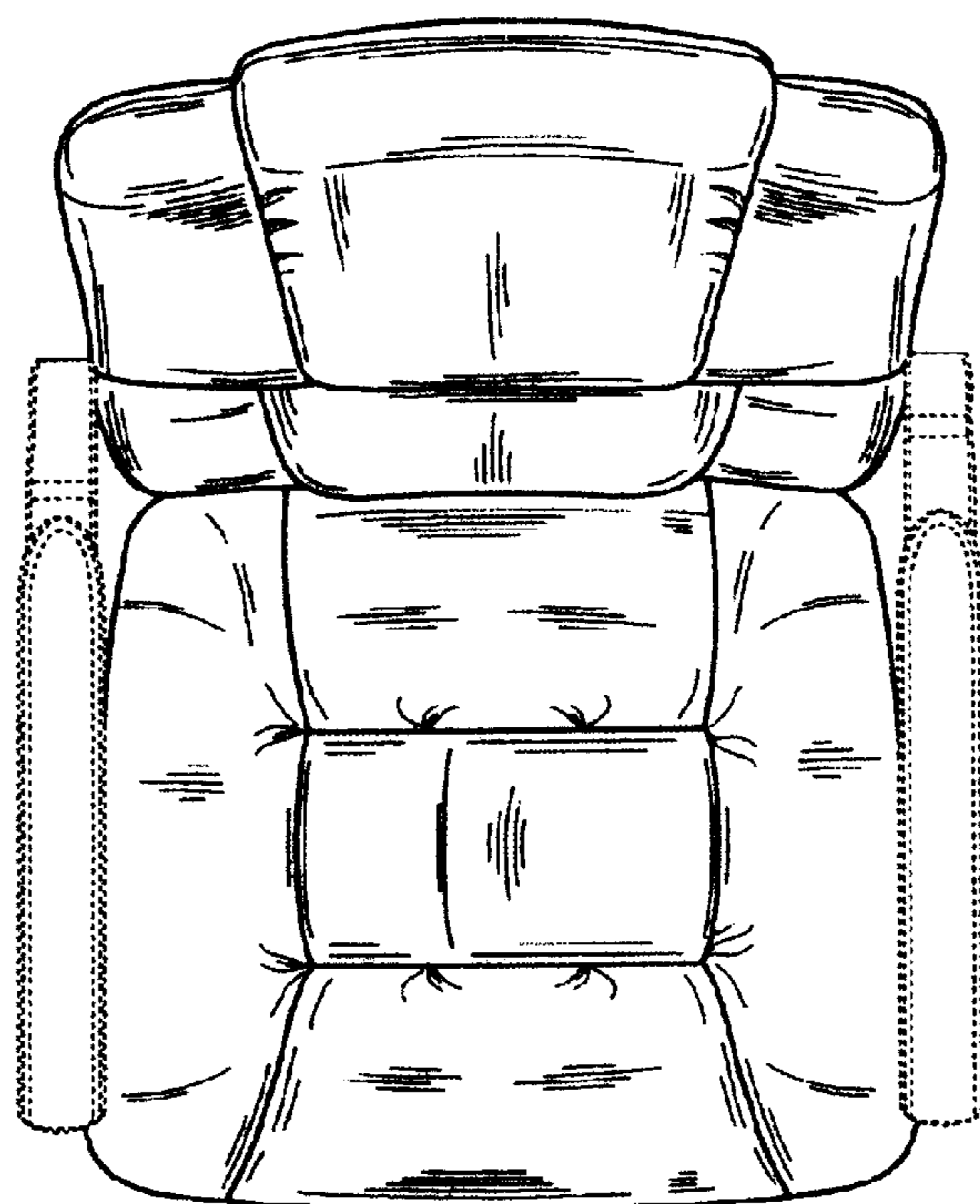

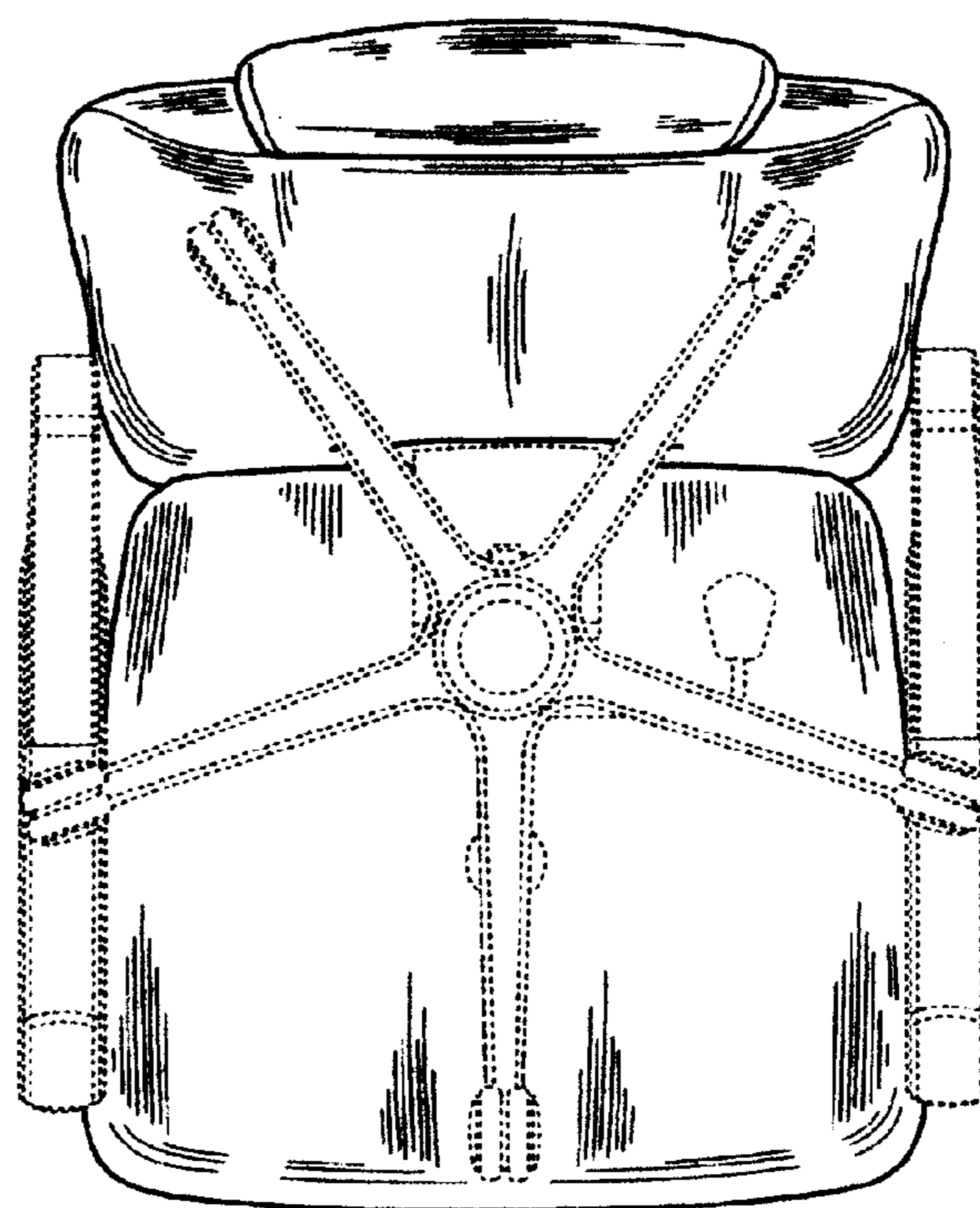
