(57) **CLAIM**

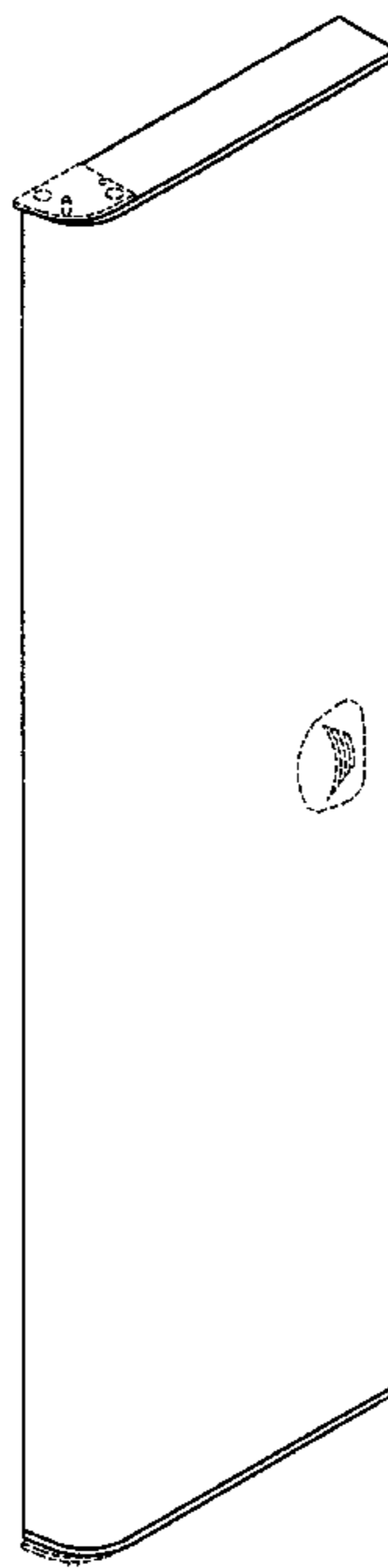
The ornamental design for a door, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the door of the new design; FIG. 2 is a front view of the door of FIG. 1; FIG. 3 is a top view of the door of FIG. 1; FIG. 4 is a side view of the door of FIG. 1; FIG. 5 is a back view of the door of FIG. 1; FIG. 6 is a side view of the door of FIG. 1; FIG. 7 is a bottom view of the door of FIG. 1; FIG. 8 is a perspective view of a second embodiment of the door of the new design; FIG. 9 is a front view of the door of FIG. 8; FIG. 10 is a top view of the door of FIG. 8; FIG. 11 is a side view of the door of FIG. 8; FIG. 12 is a back view of the door of FIG. 8; FIG. 13 is a side view of the door of FIG. 8; and, FIG. 14 is a bottom view of the door of FIG. 8.

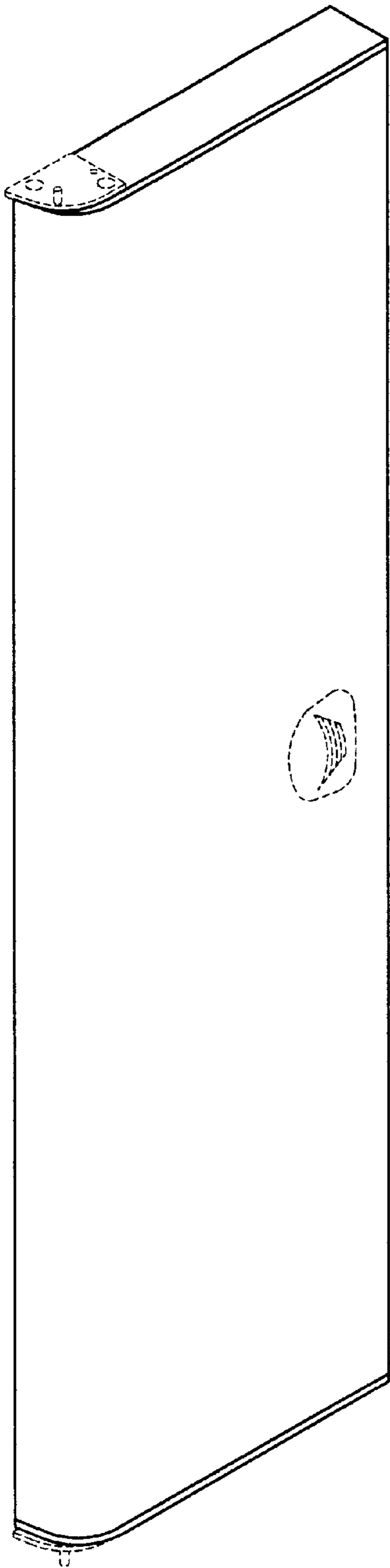

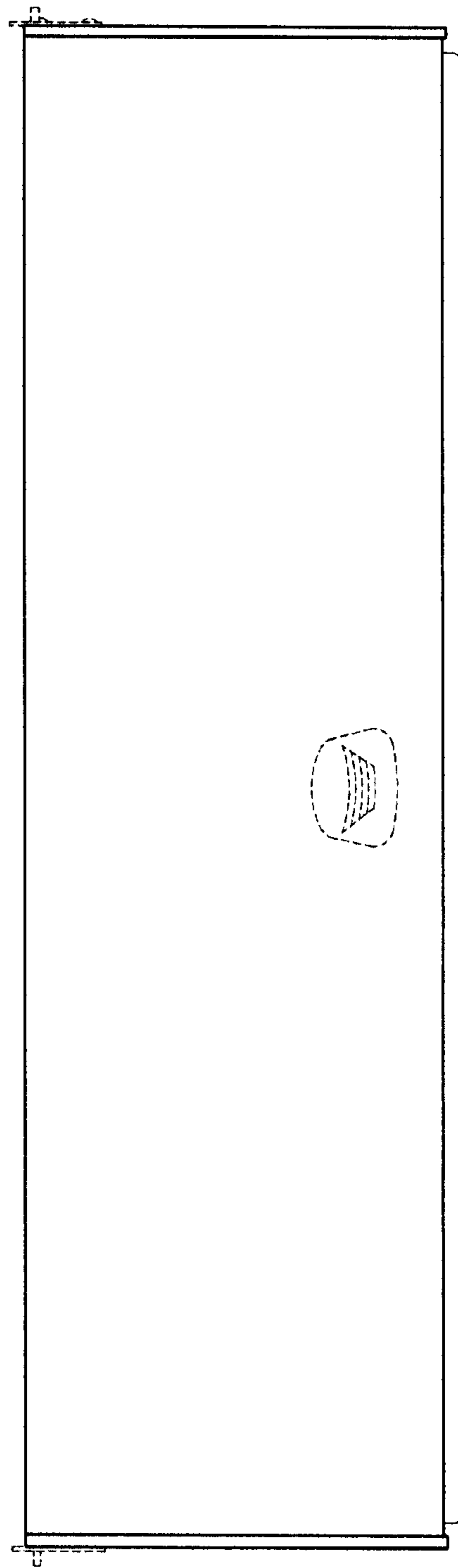

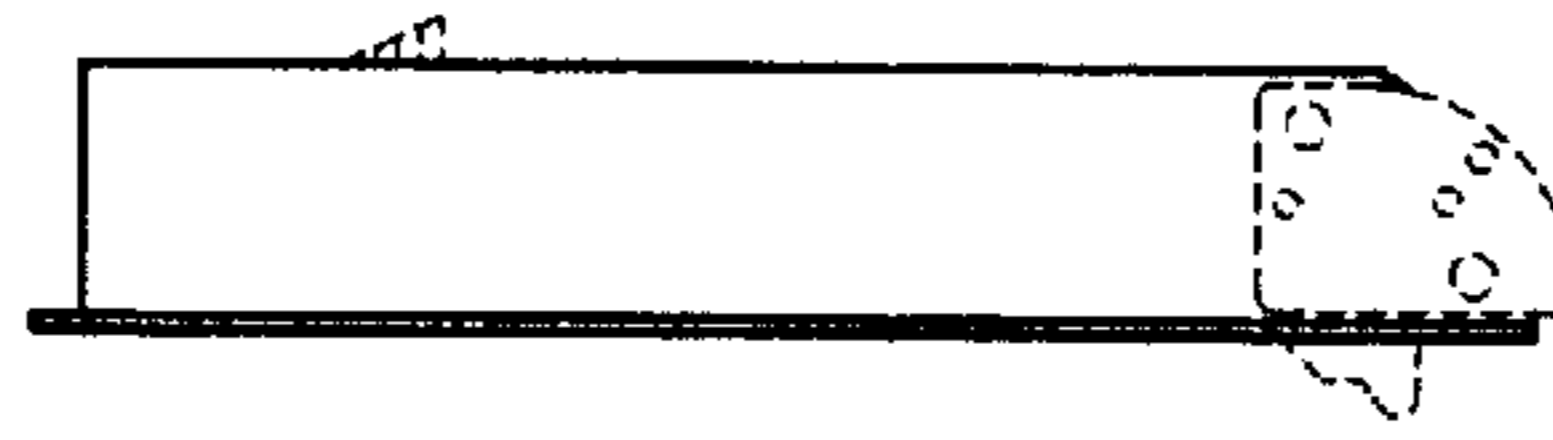

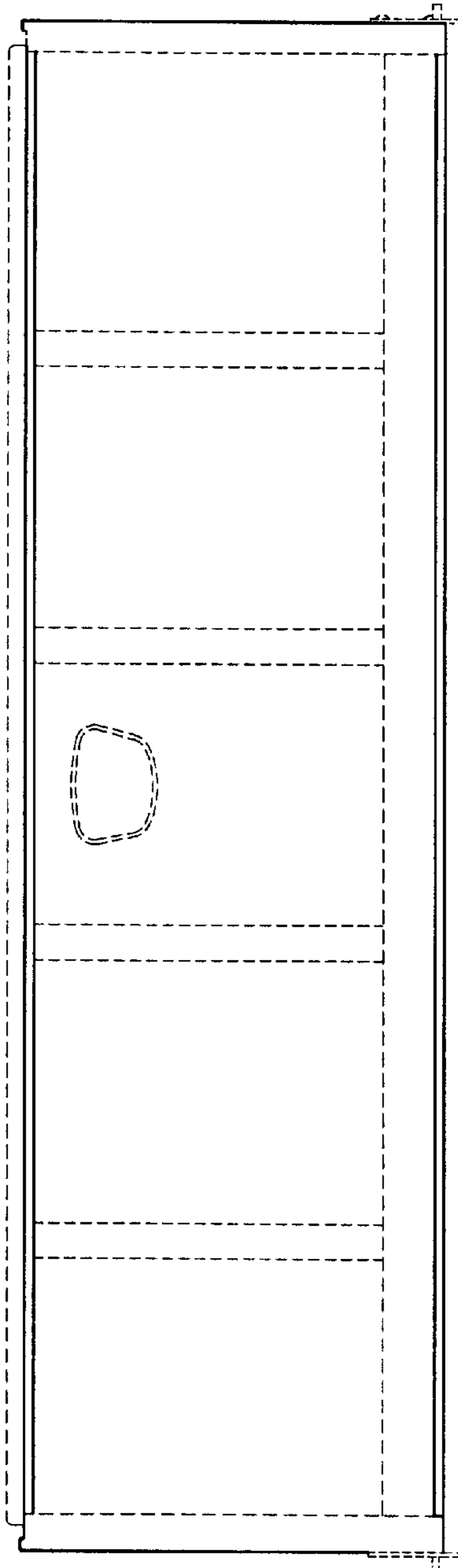

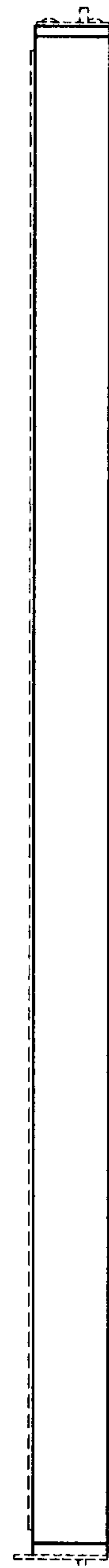
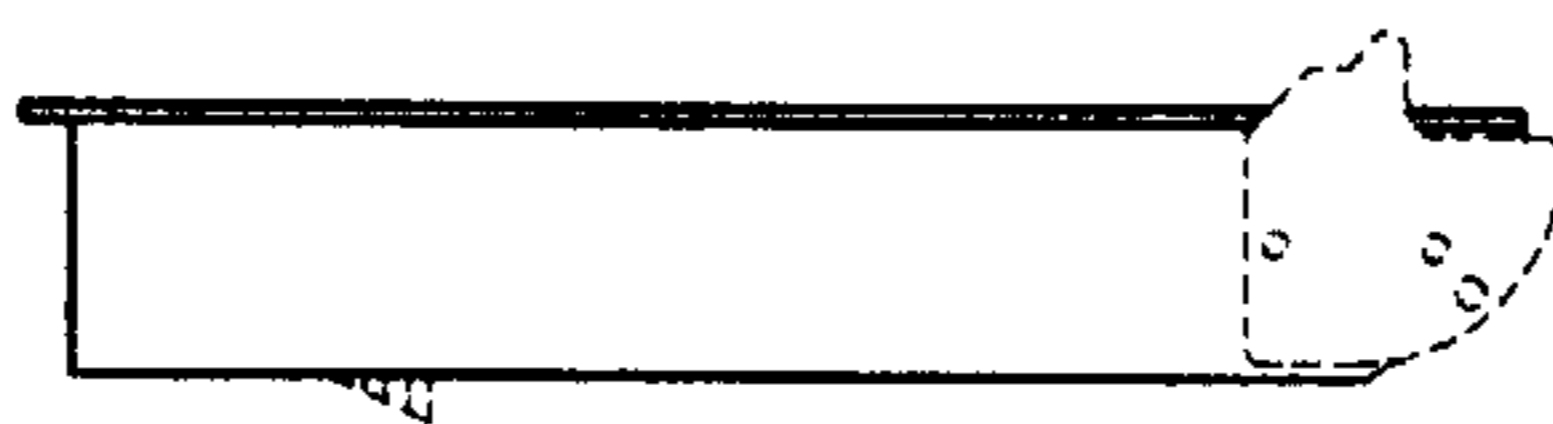

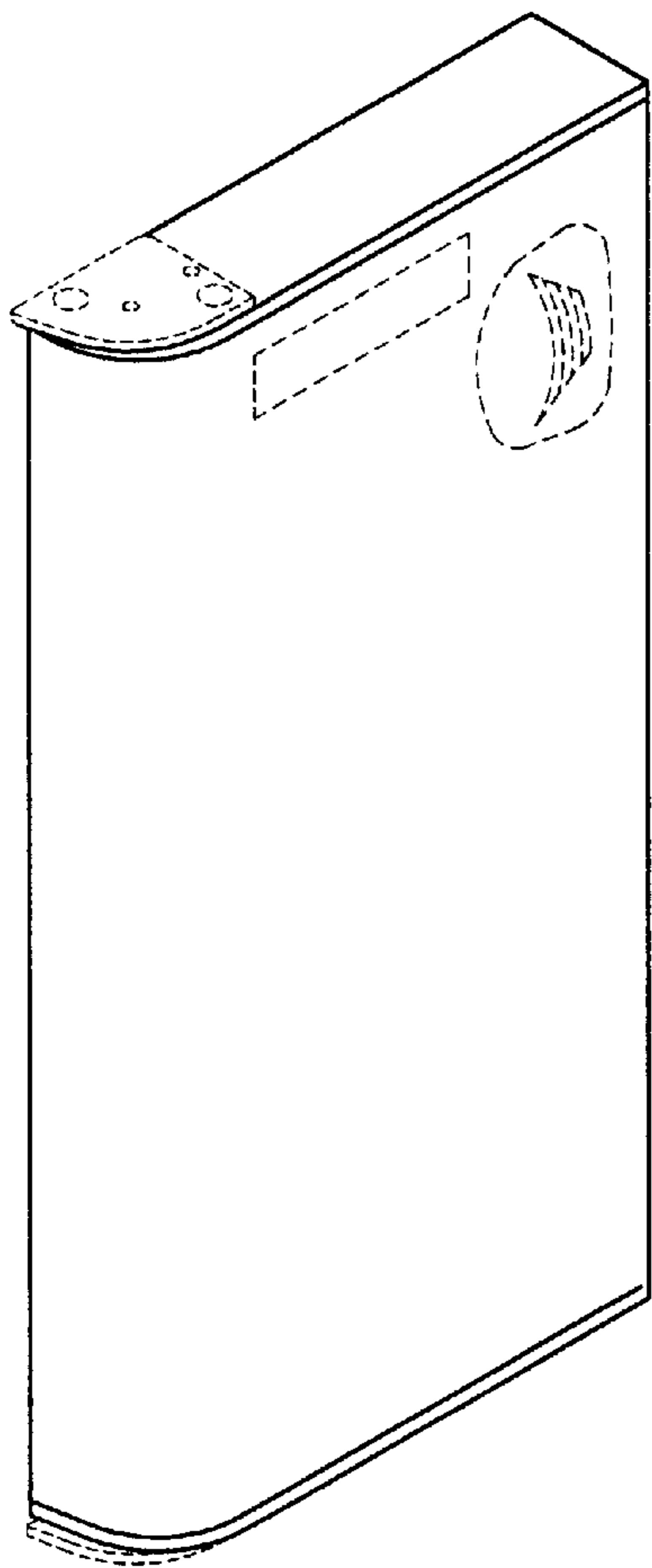

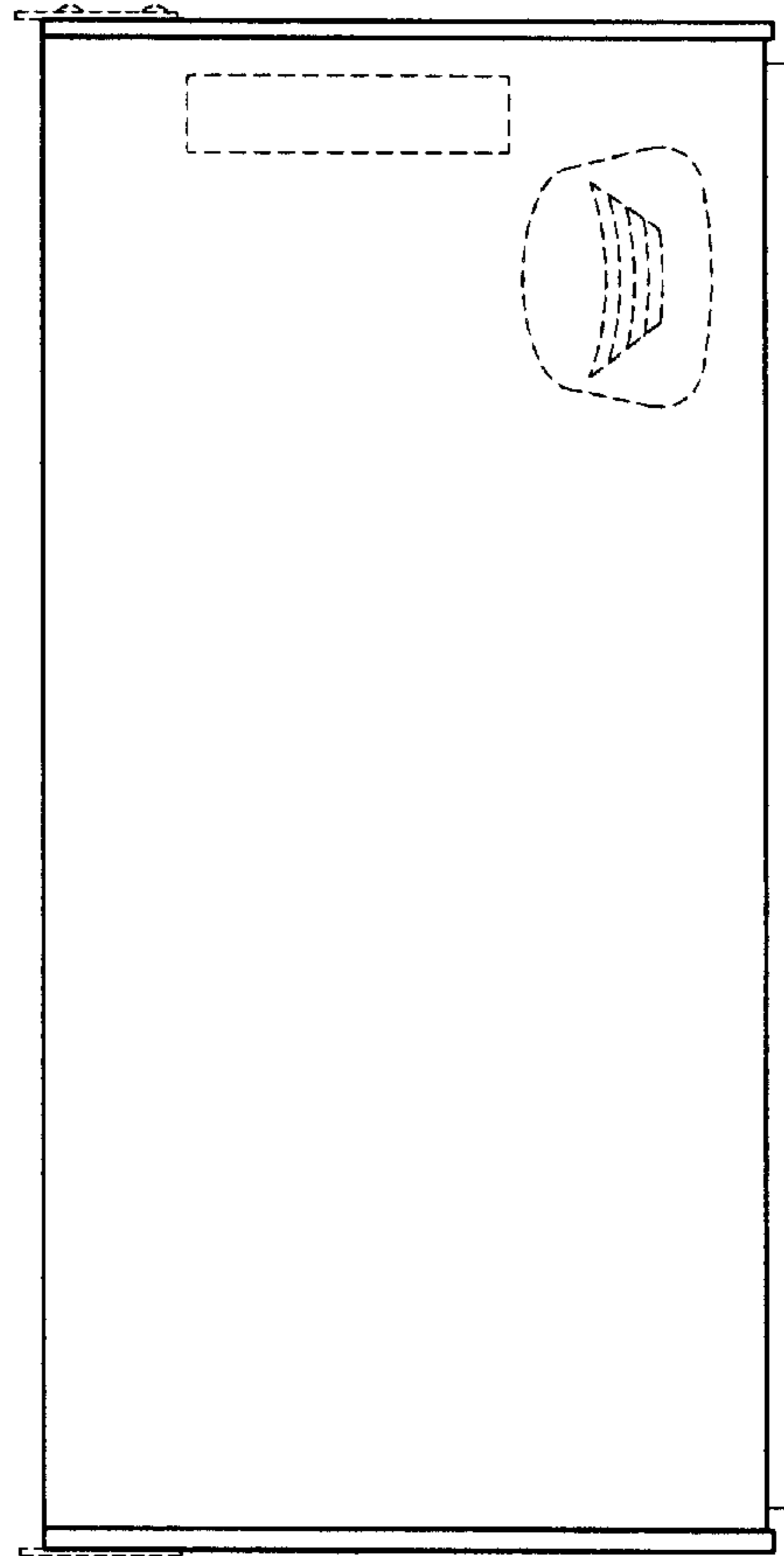

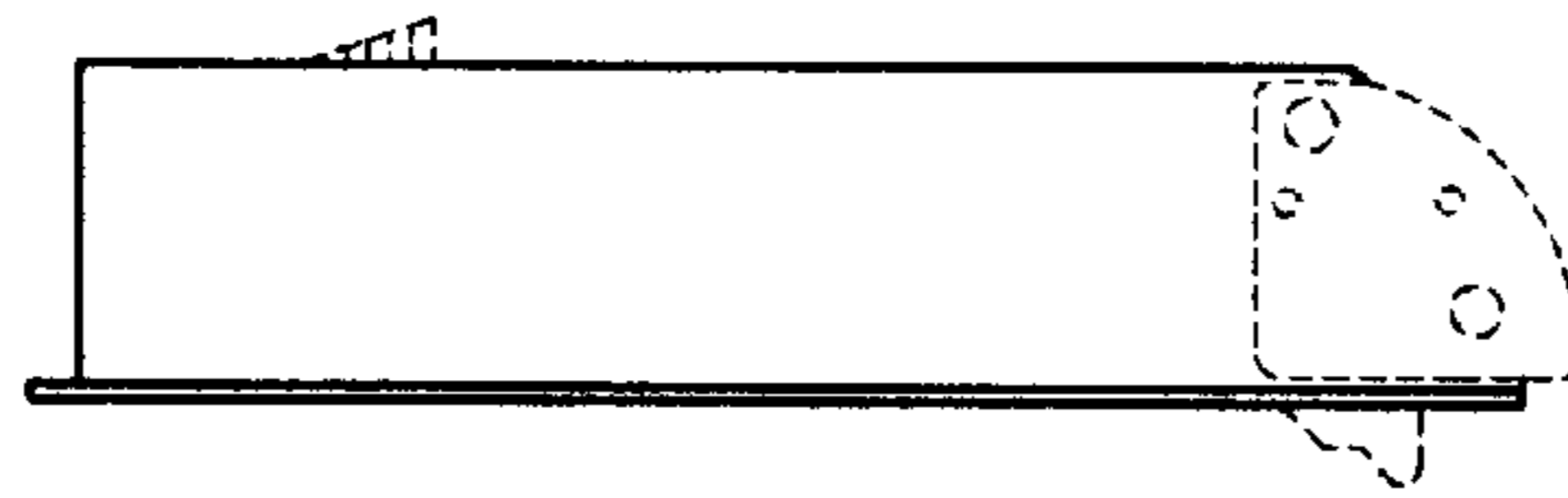

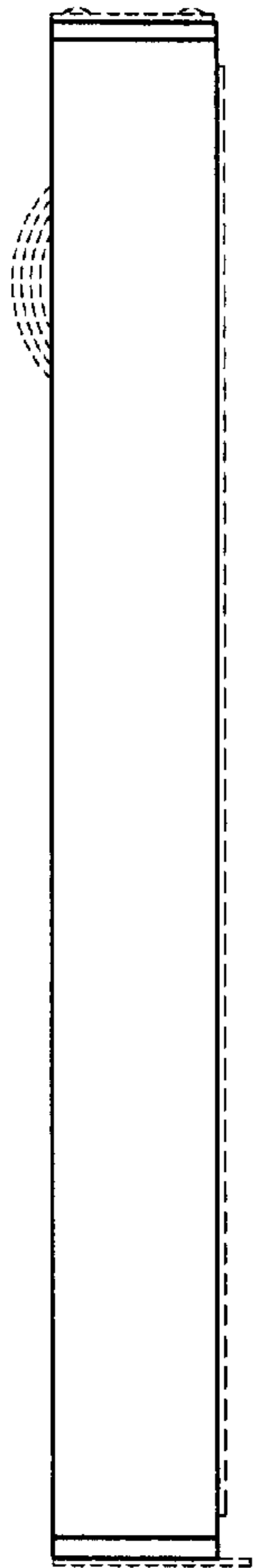

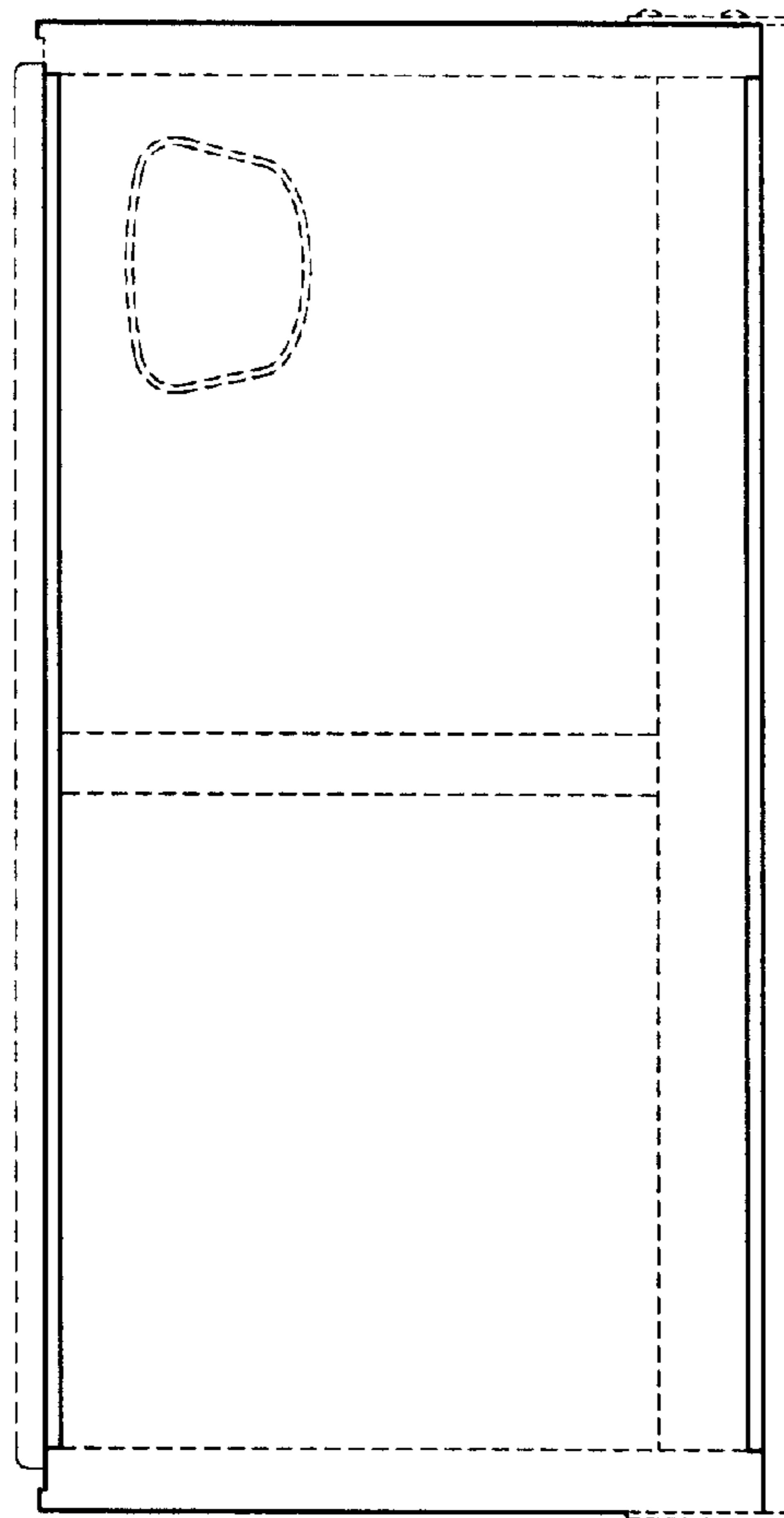

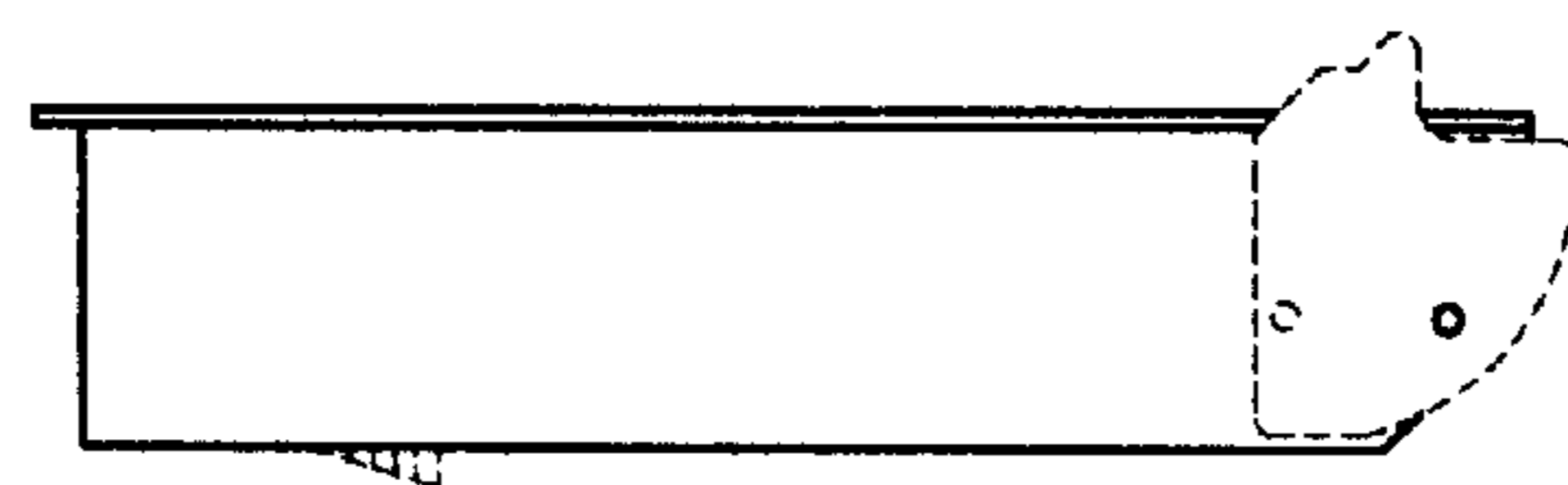
