(57) **CLAIM**

The ornamental design for a plate, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a plate according to the present design;

FIG. 2 is a front elevational view thereof taken along line 2—2 of FIG. 1;

FIG. 3 is a right side elevational view thereof taken along line 3—3 of FIG. 1;

FIG. 4 is a rear elevational view thereof taken along line 4—4 of FIG. 1;

FIG. 5 is a left side elevational view thereof taken along line 5—5 of FIG. 1;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a cross-sectional view thereof taken along line 7—7 of FIG. 1;

FIG. 8 is a cross-sectional view thereof taken along line 8—8 of FIG. 1; and,

FIG. 9 is an environmental top plan view thereof.

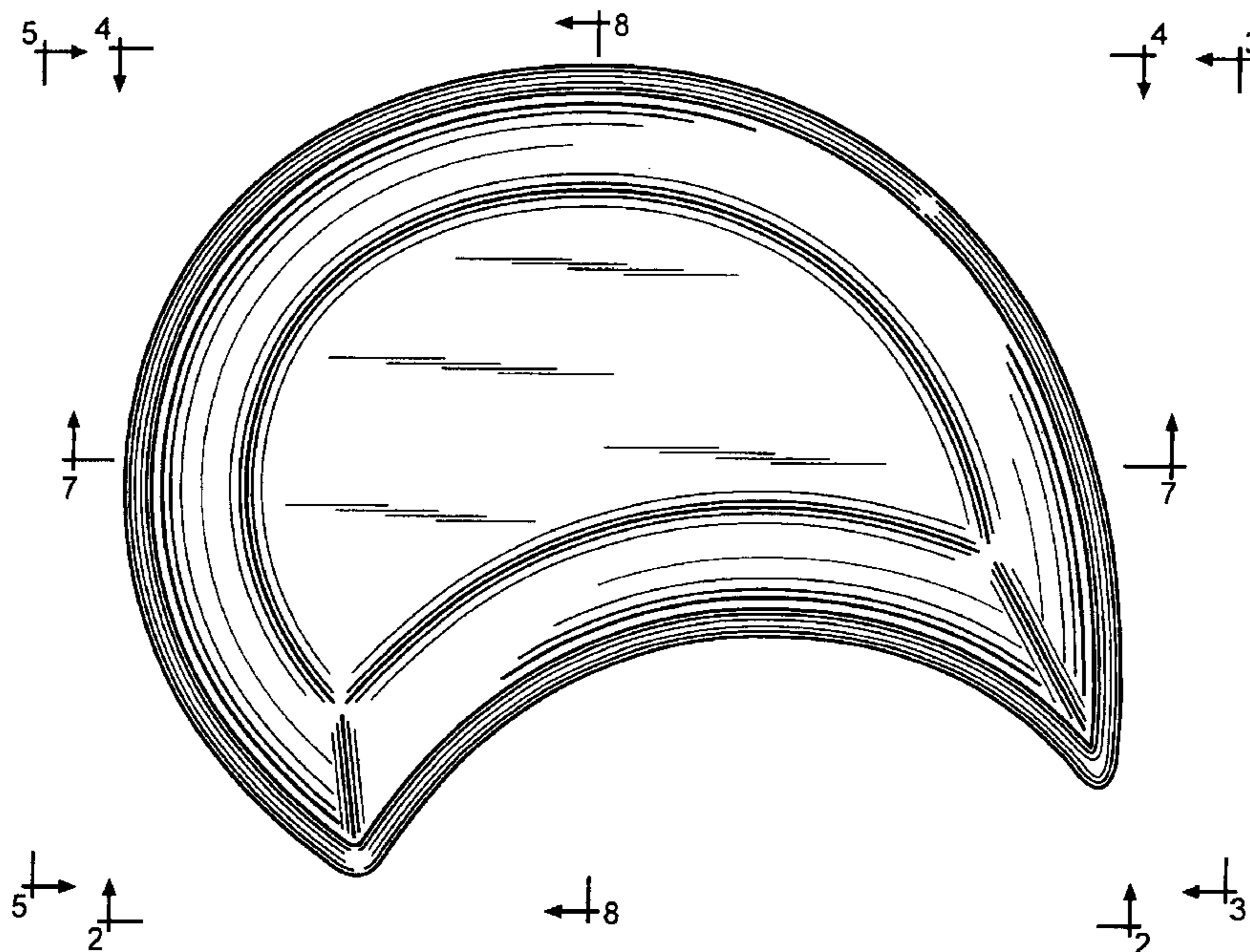
The broken line showing of three other plates is included for the purpose of illustrating how the claimed design would appear when positioned with other like plates and forms no part of the claimed design.

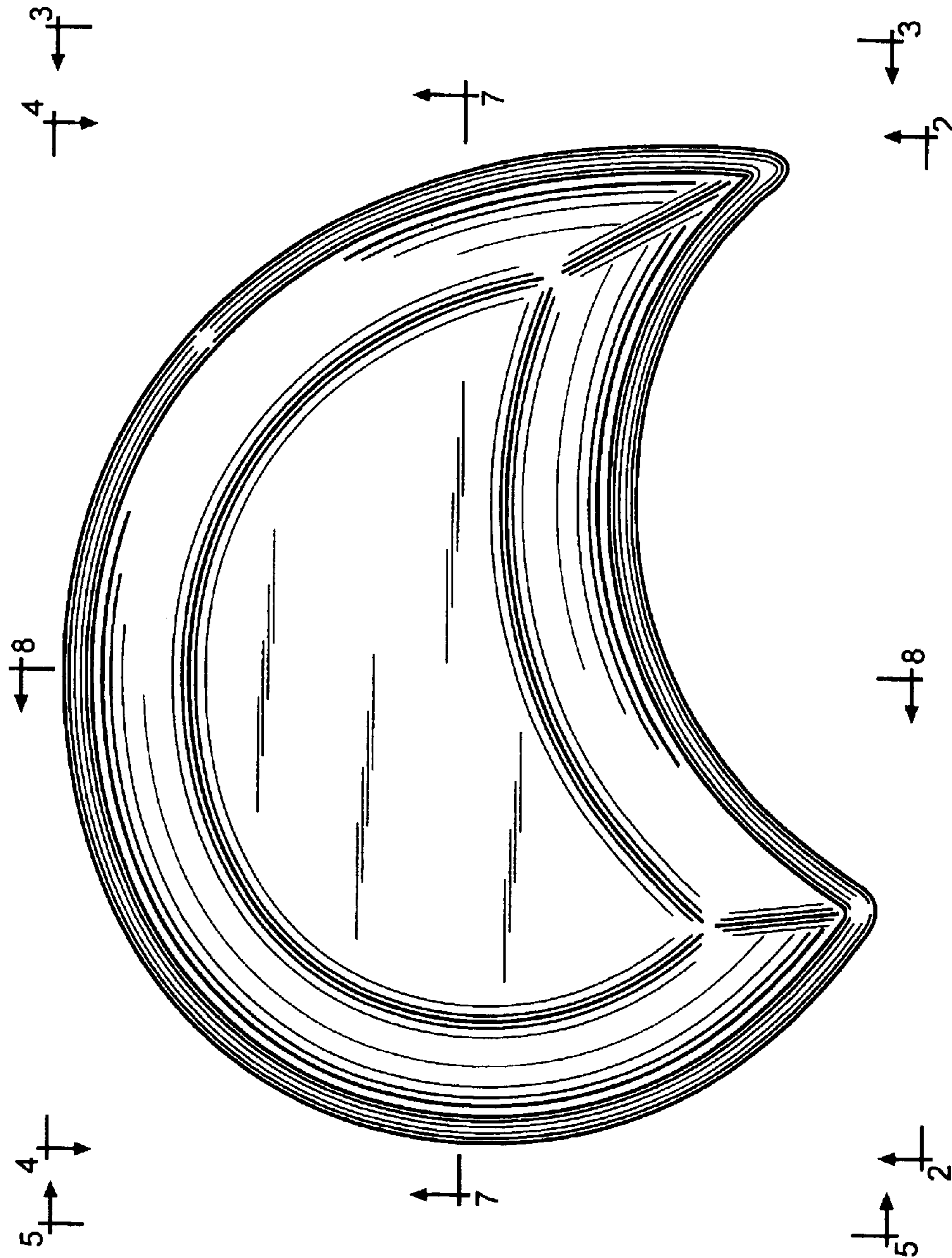

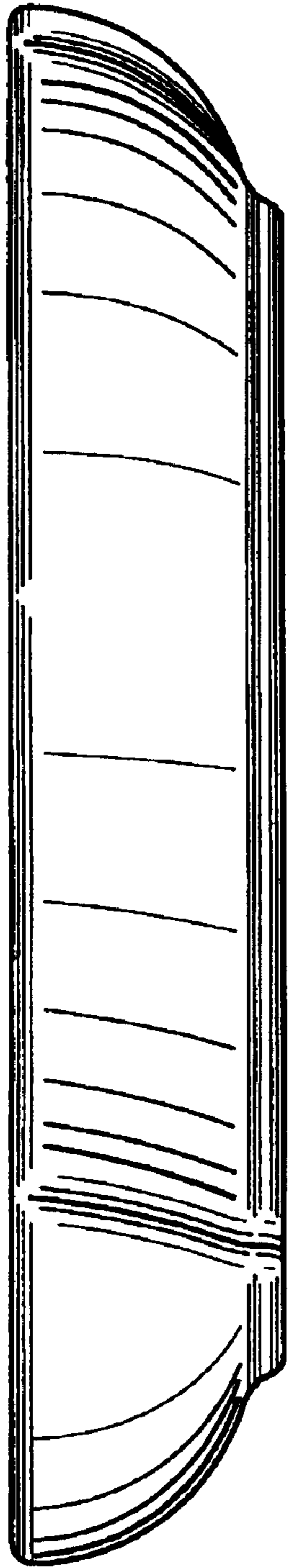

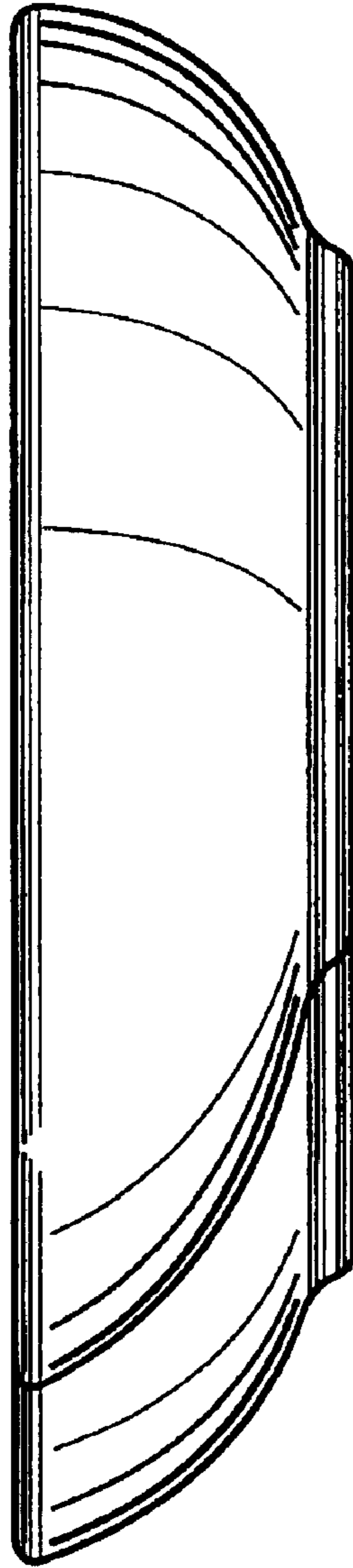

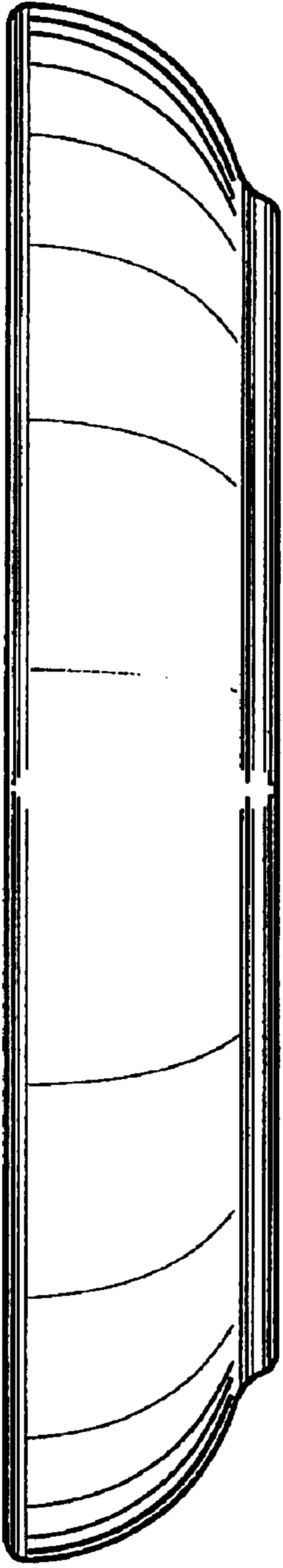

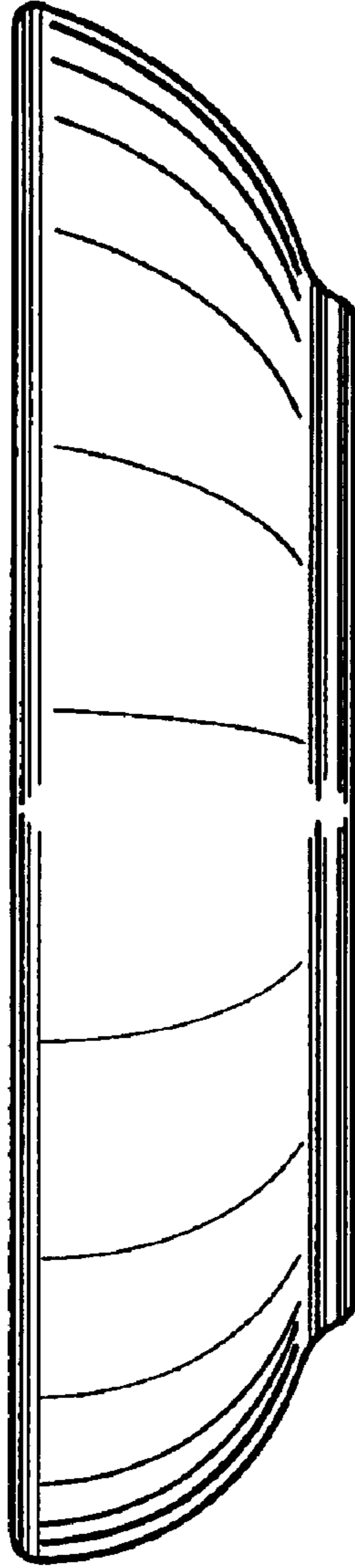

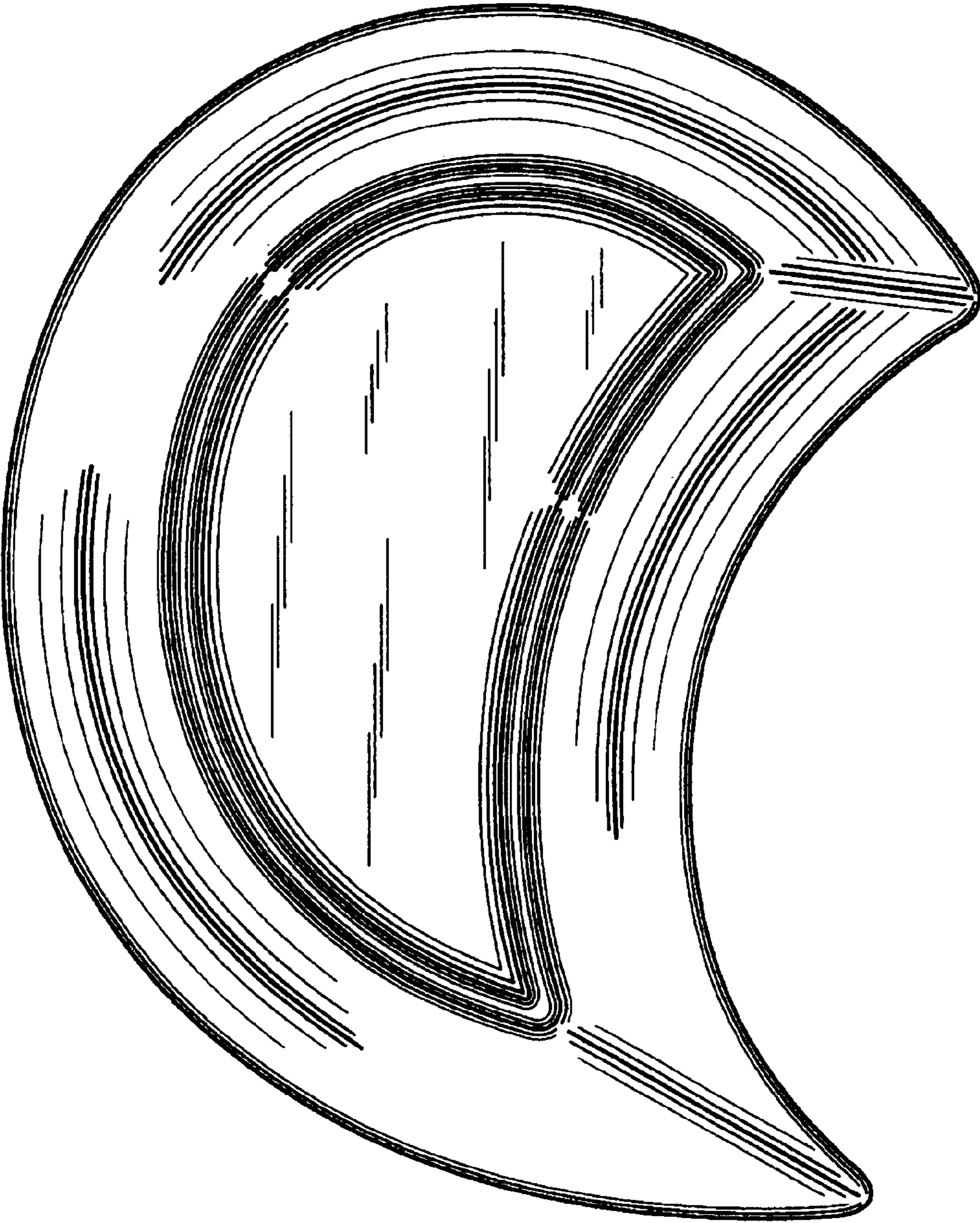

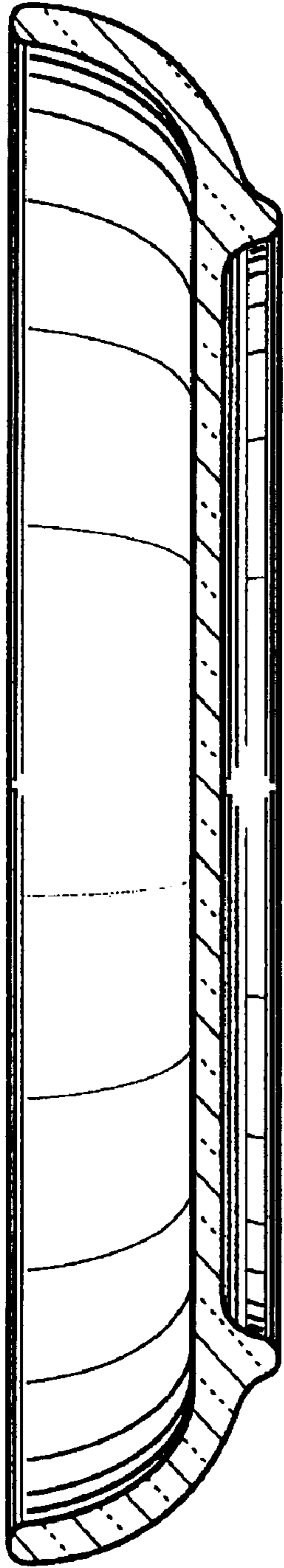

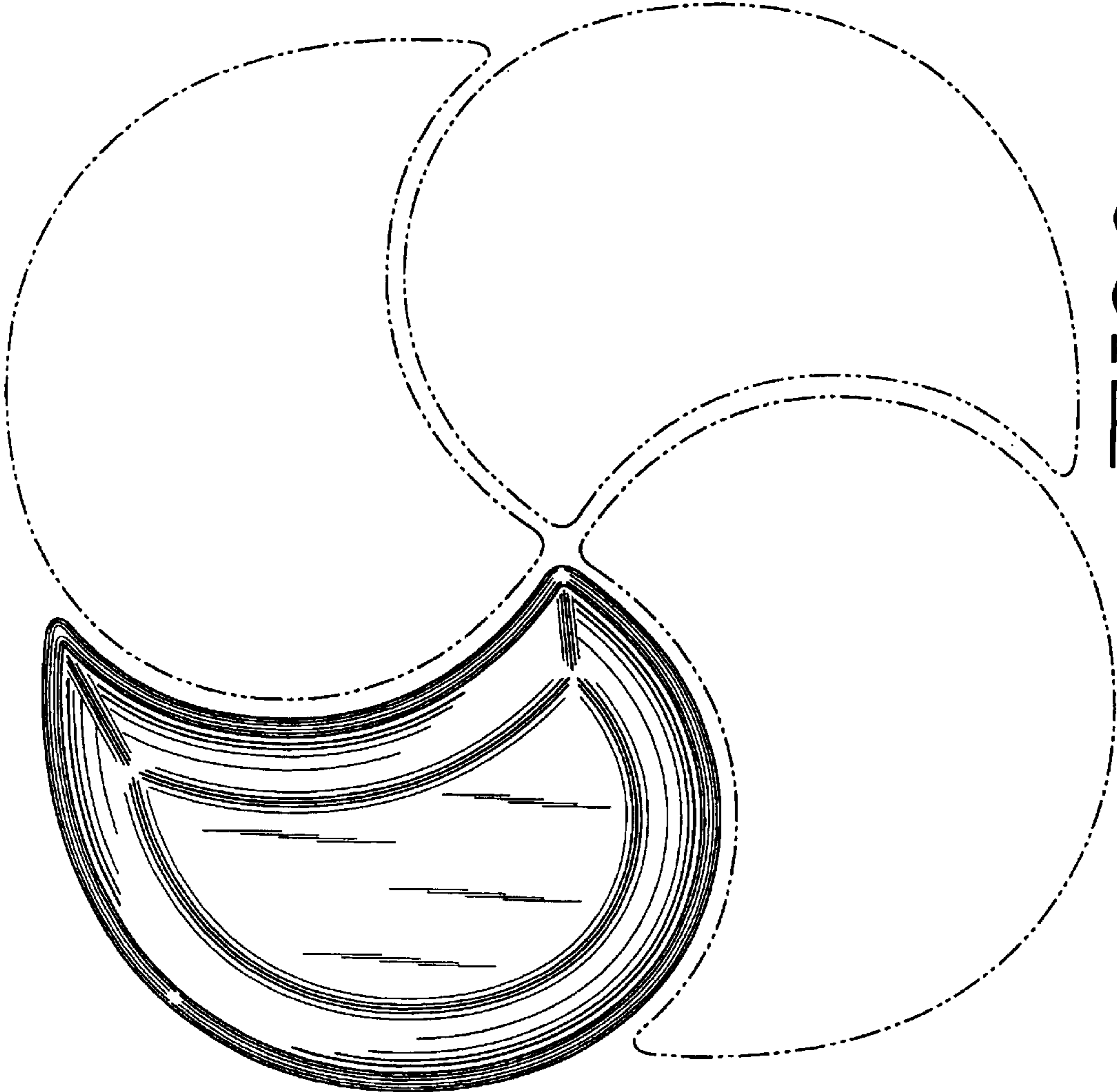
