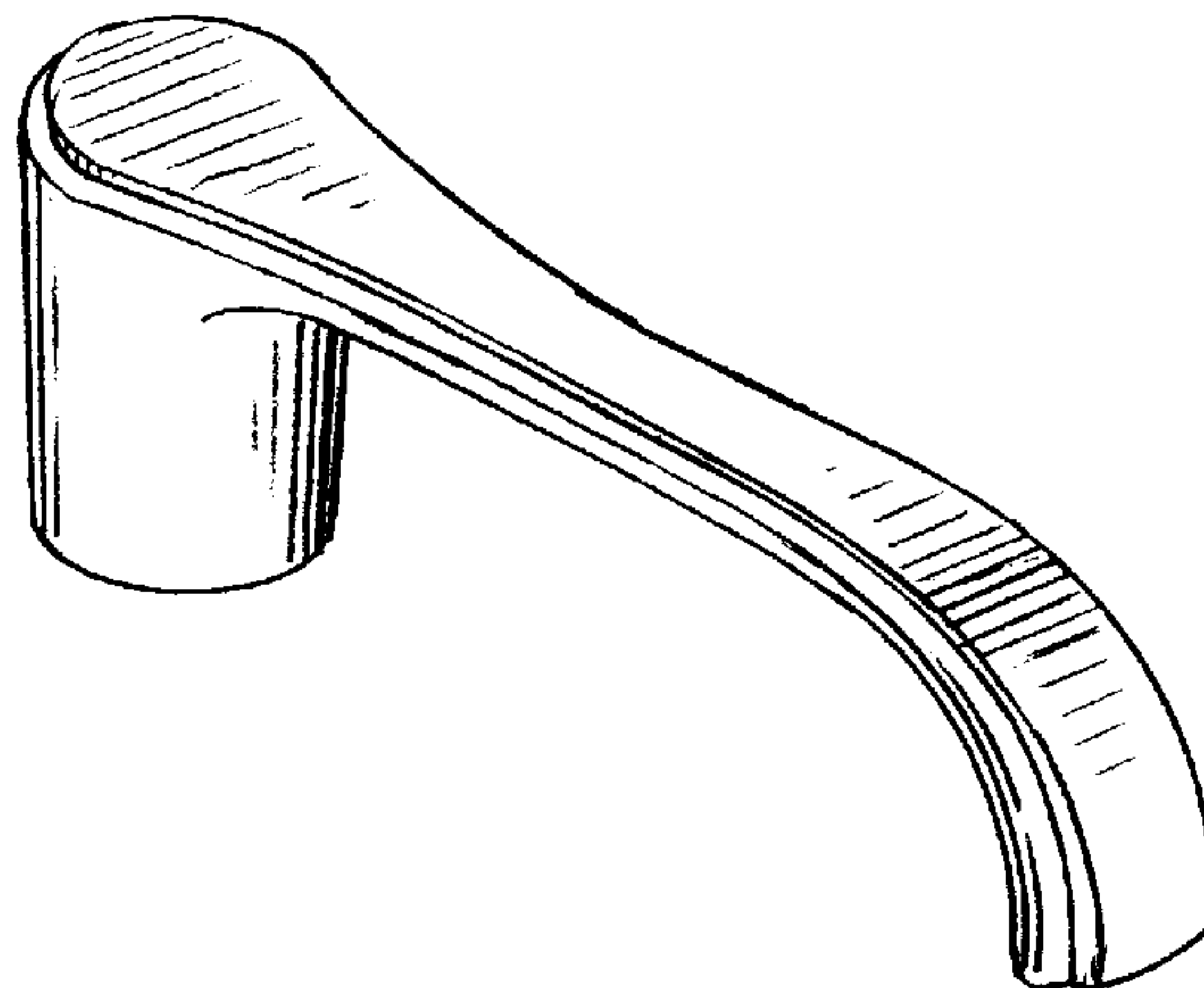
(57) **CLAIM**

described.

**DESCRIPTION**

FIG. 1 is a perspective view of a door lever showing the new  
design for a door lever;  
FIG. 2 is a left side elevation view of FIG. 1;  
FIG. 3 is a front elevation view of FIG. 1;  
FIG. 4 is a top elevation view of FIG. 1;  
FIG. 5 is a rear elevation view of FIG. 1; and,  
FIG. 6 is a bottom elevation view of FIG. 1.

purposes only and forms no part of the claimed design.

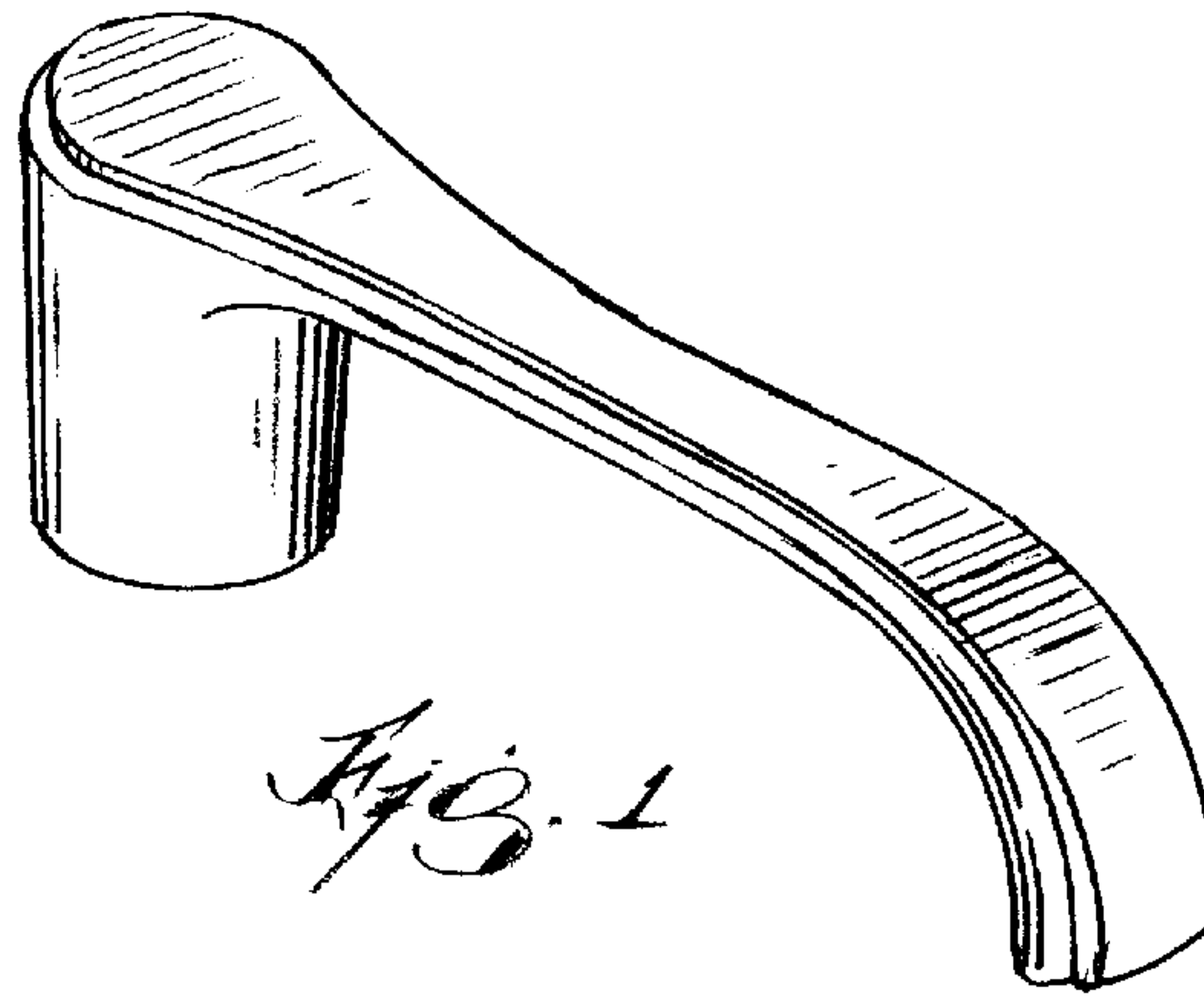

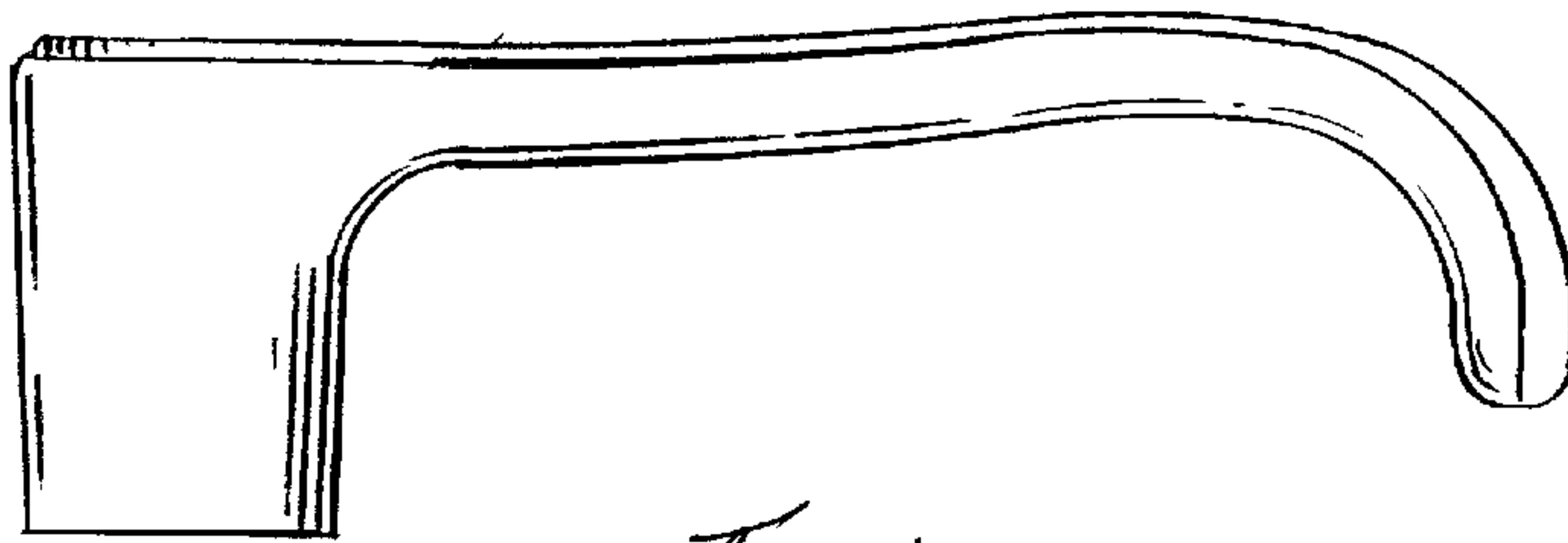

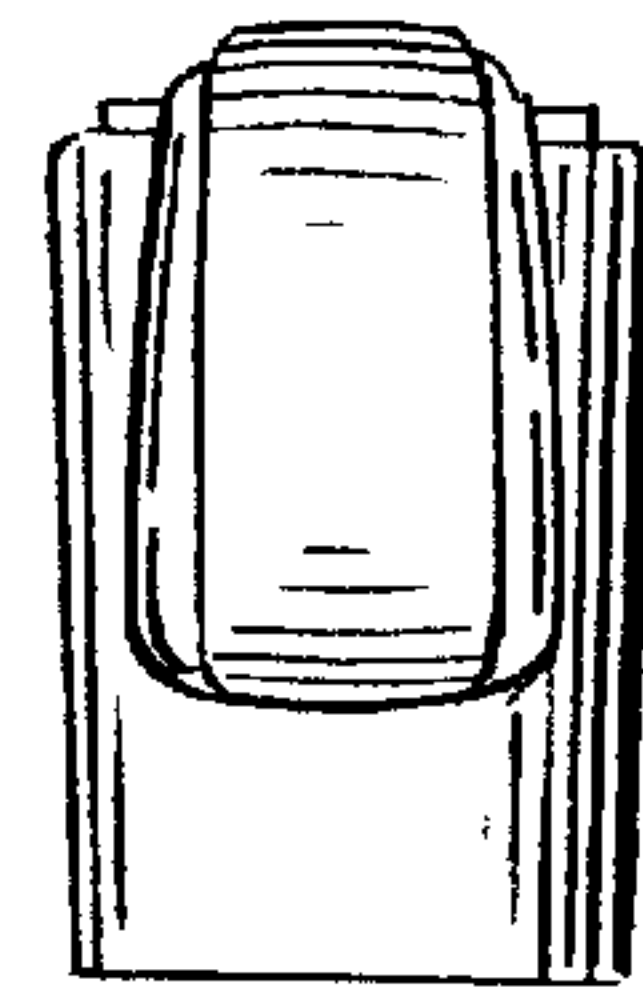




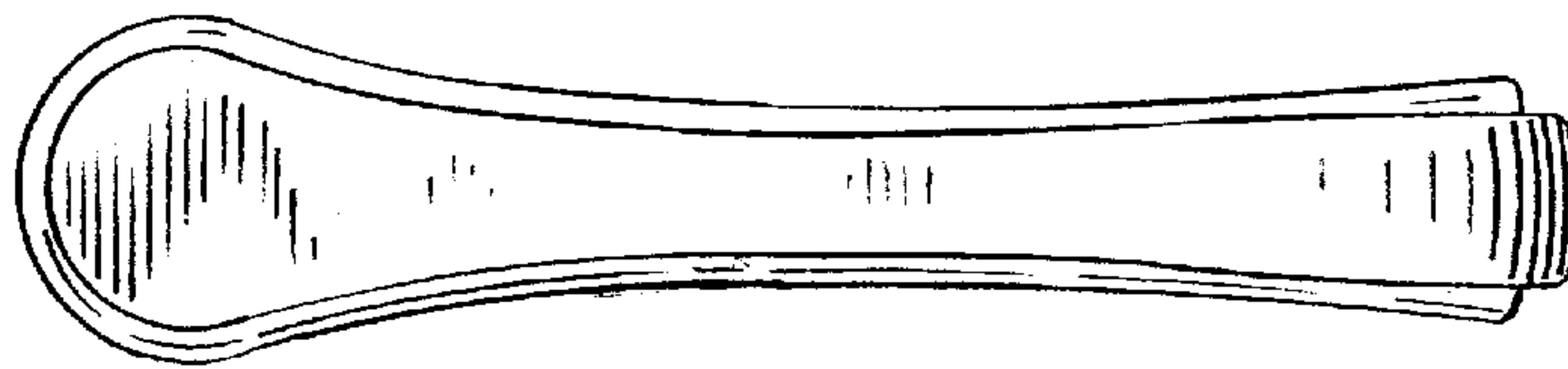

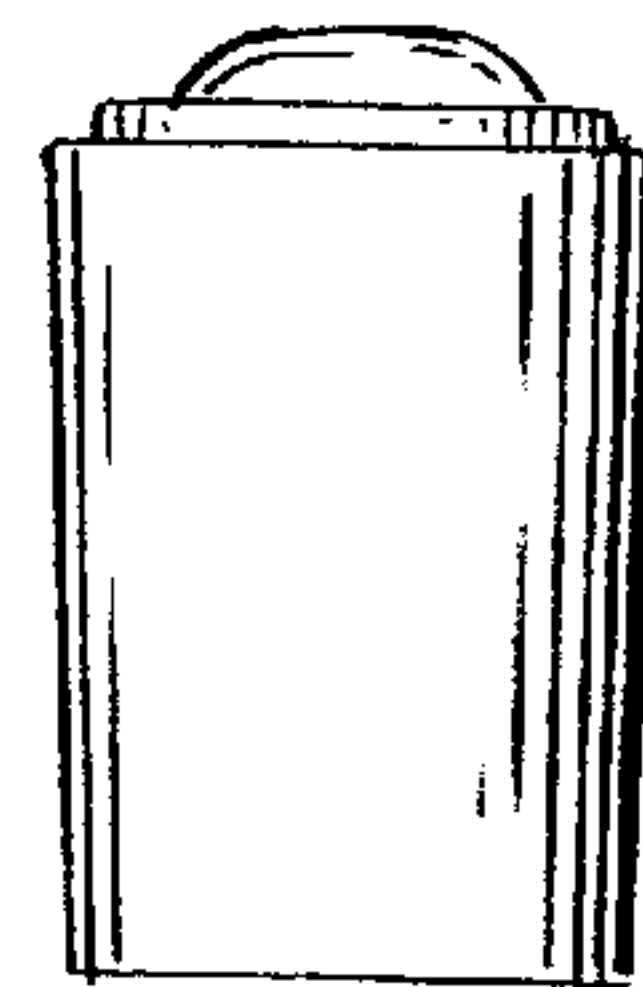

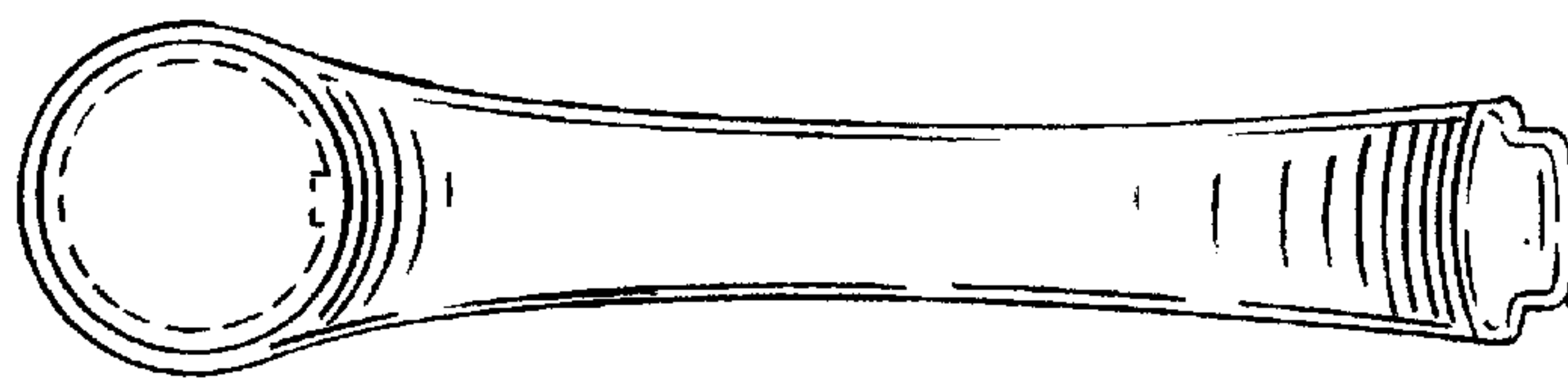
