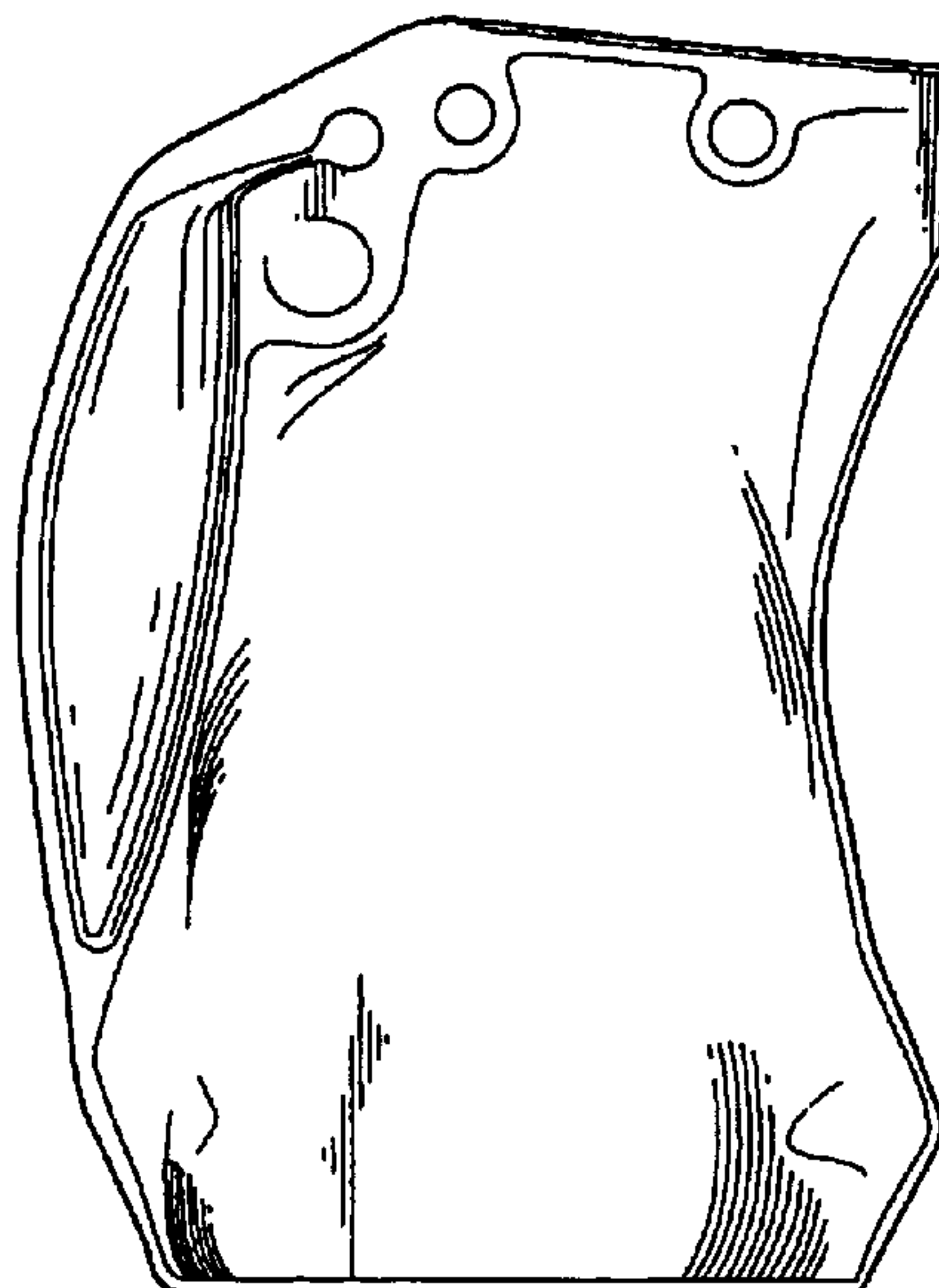
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a rear, left perspective view of a container showing my new design;
FIG. 2 is a front, right perspective view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a bottom plan view thereof;

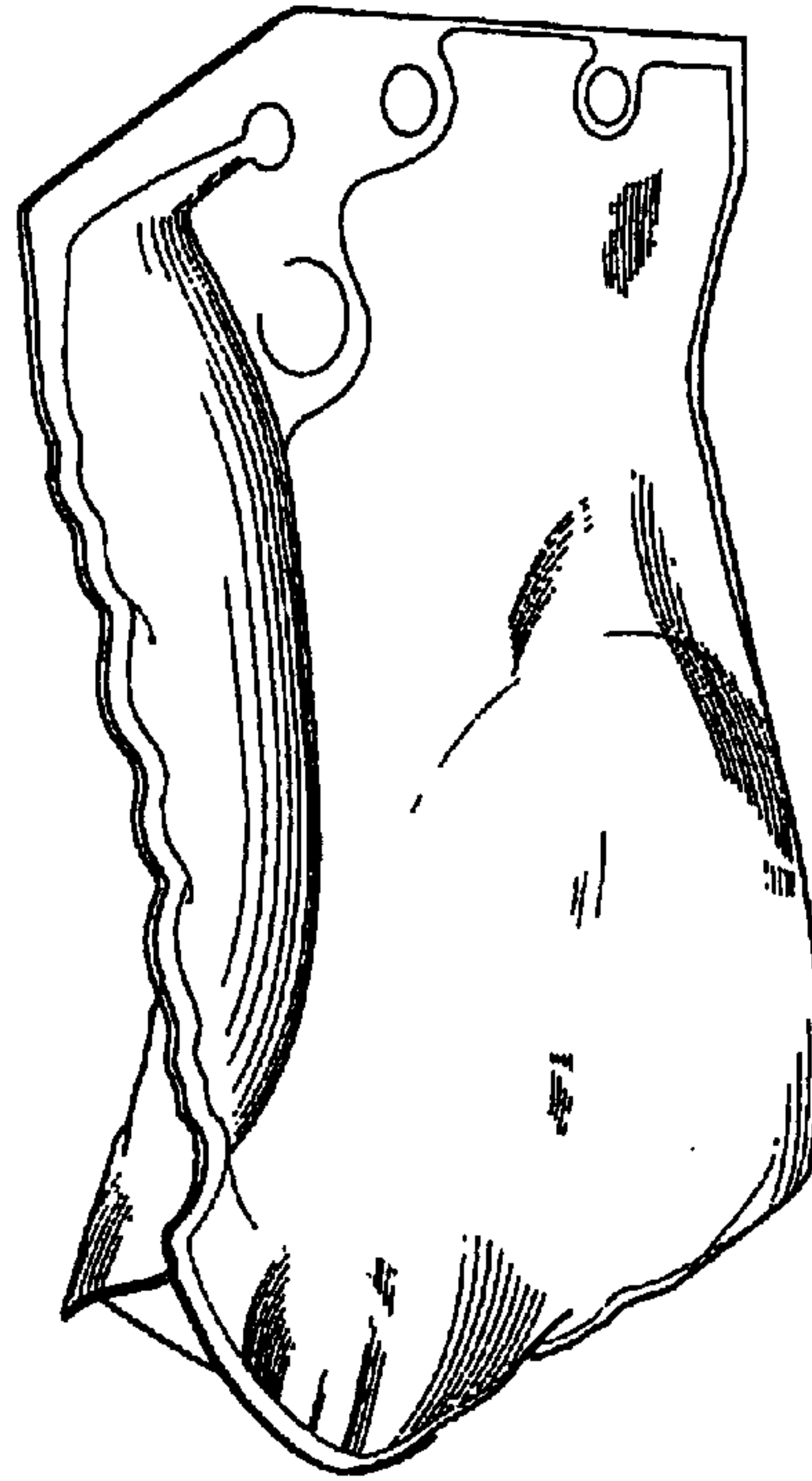

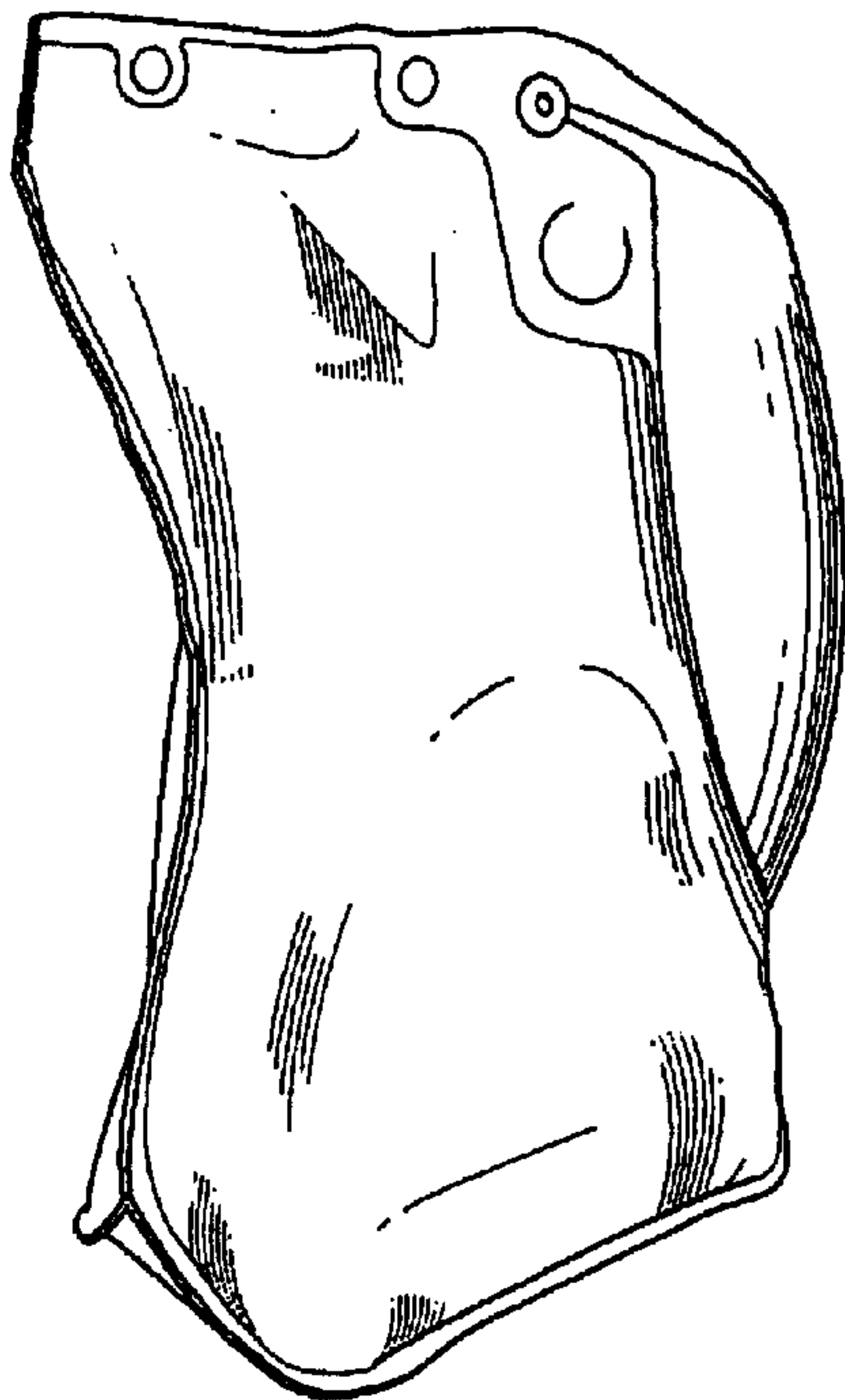

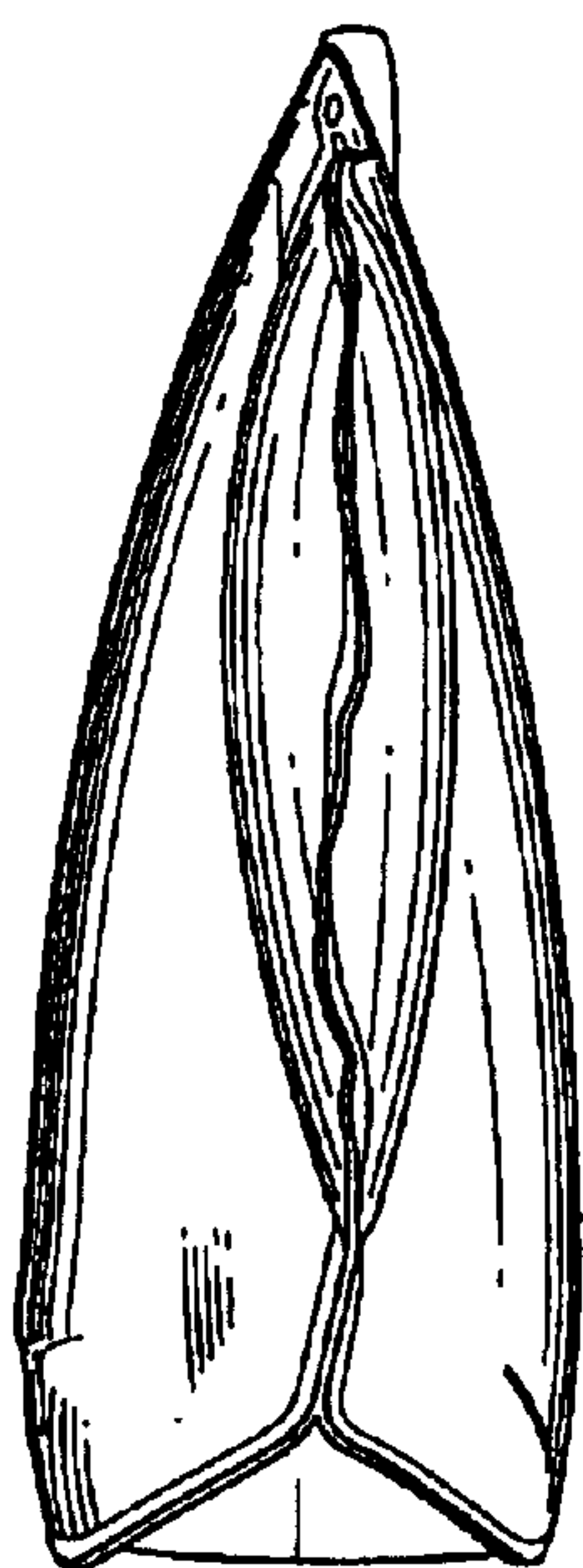

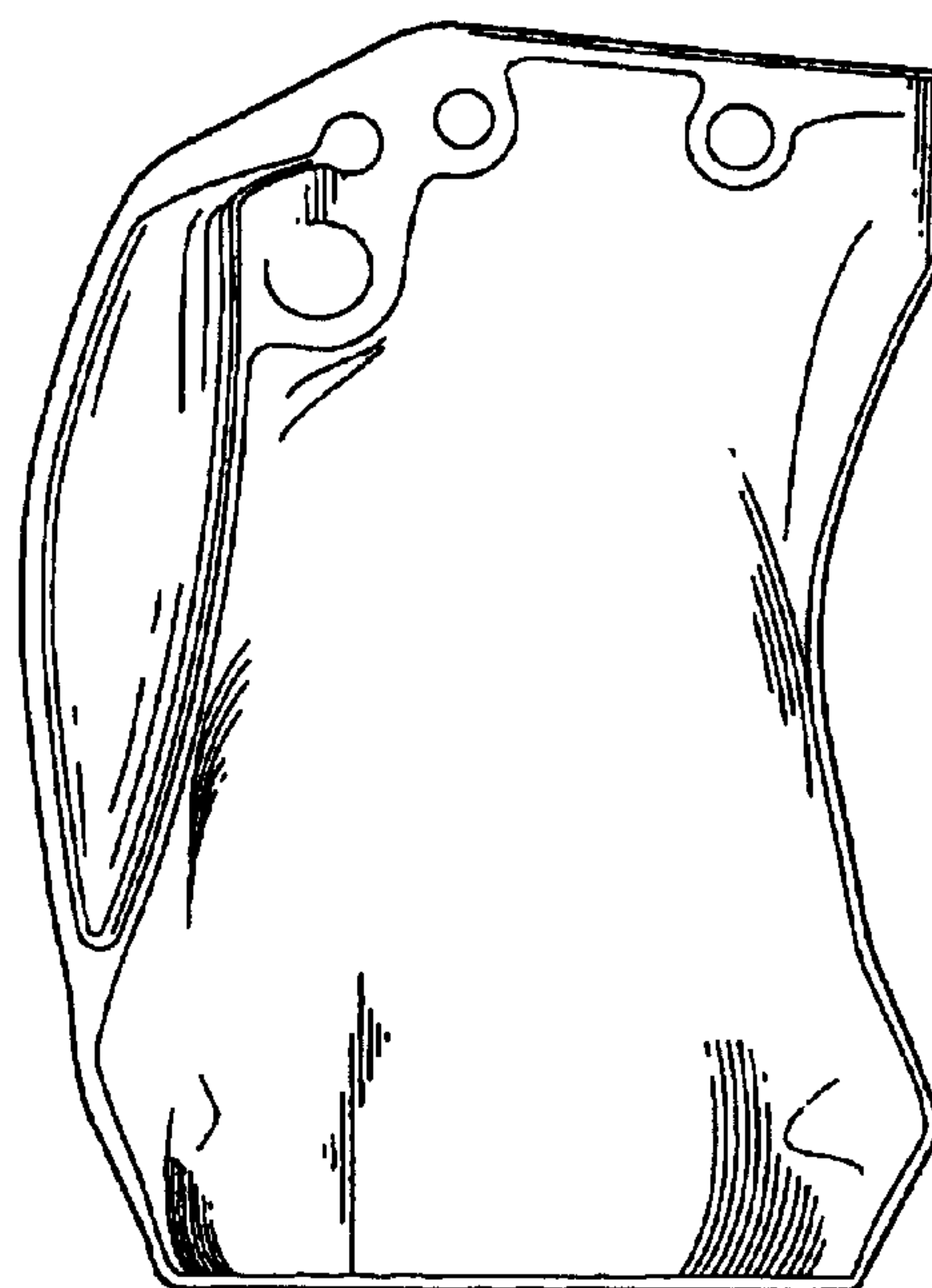

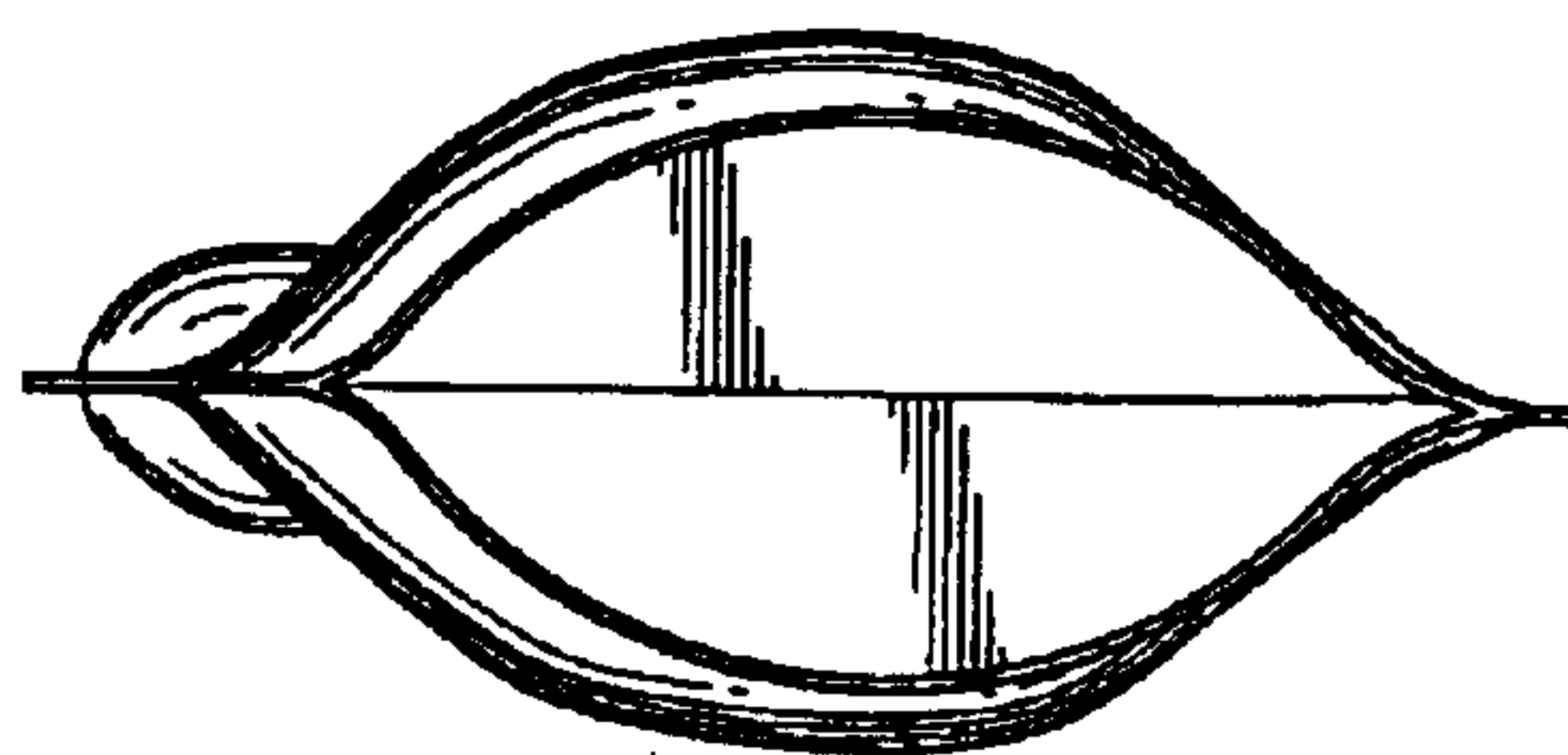

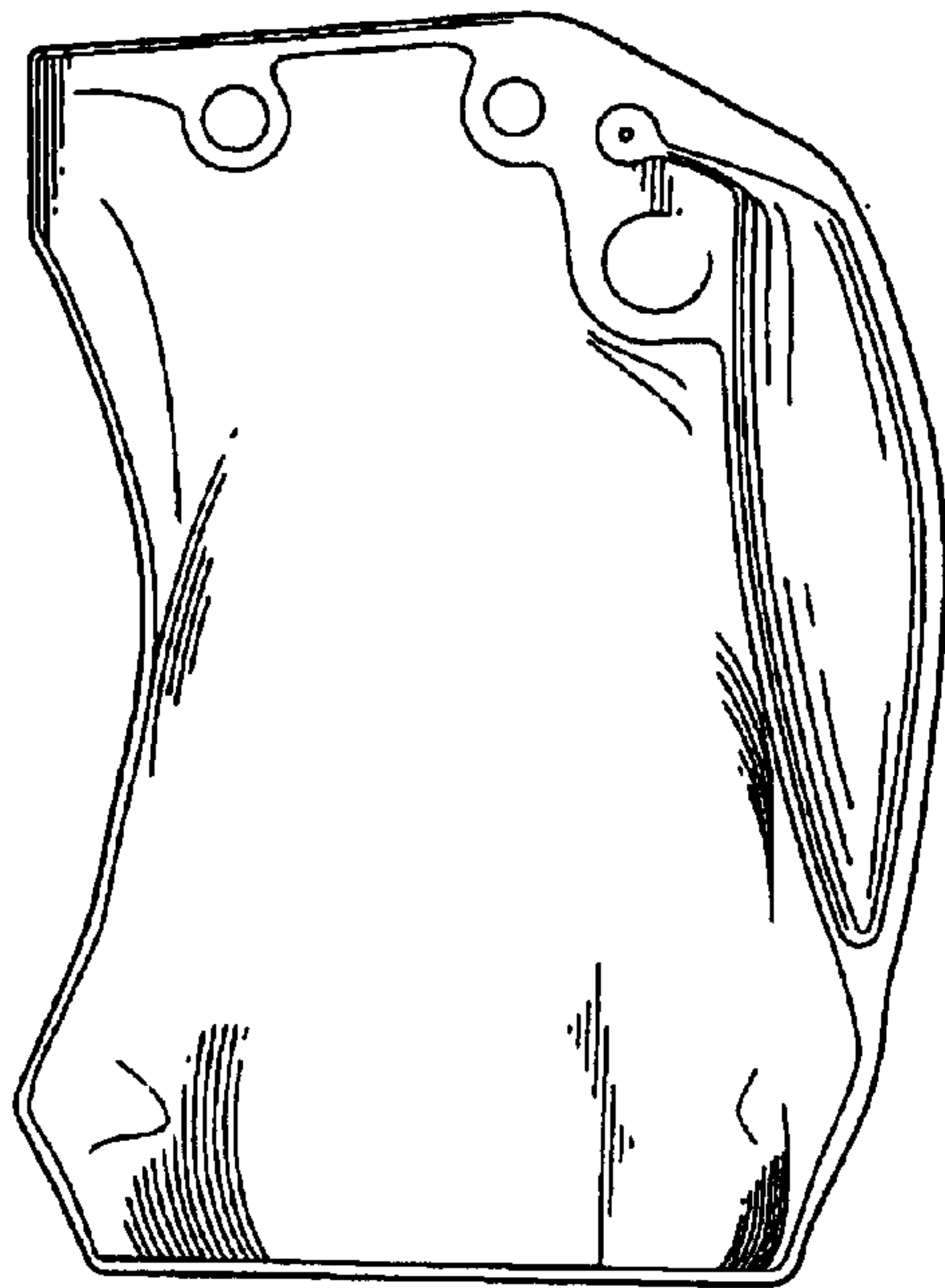

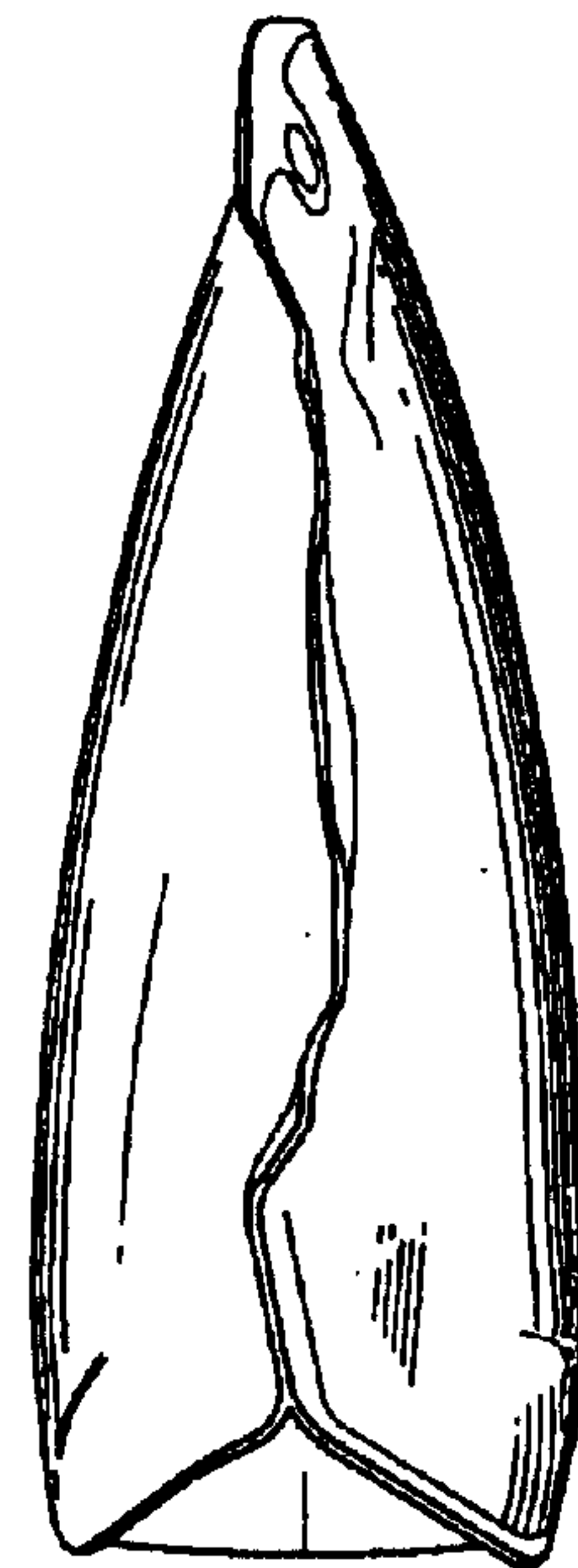

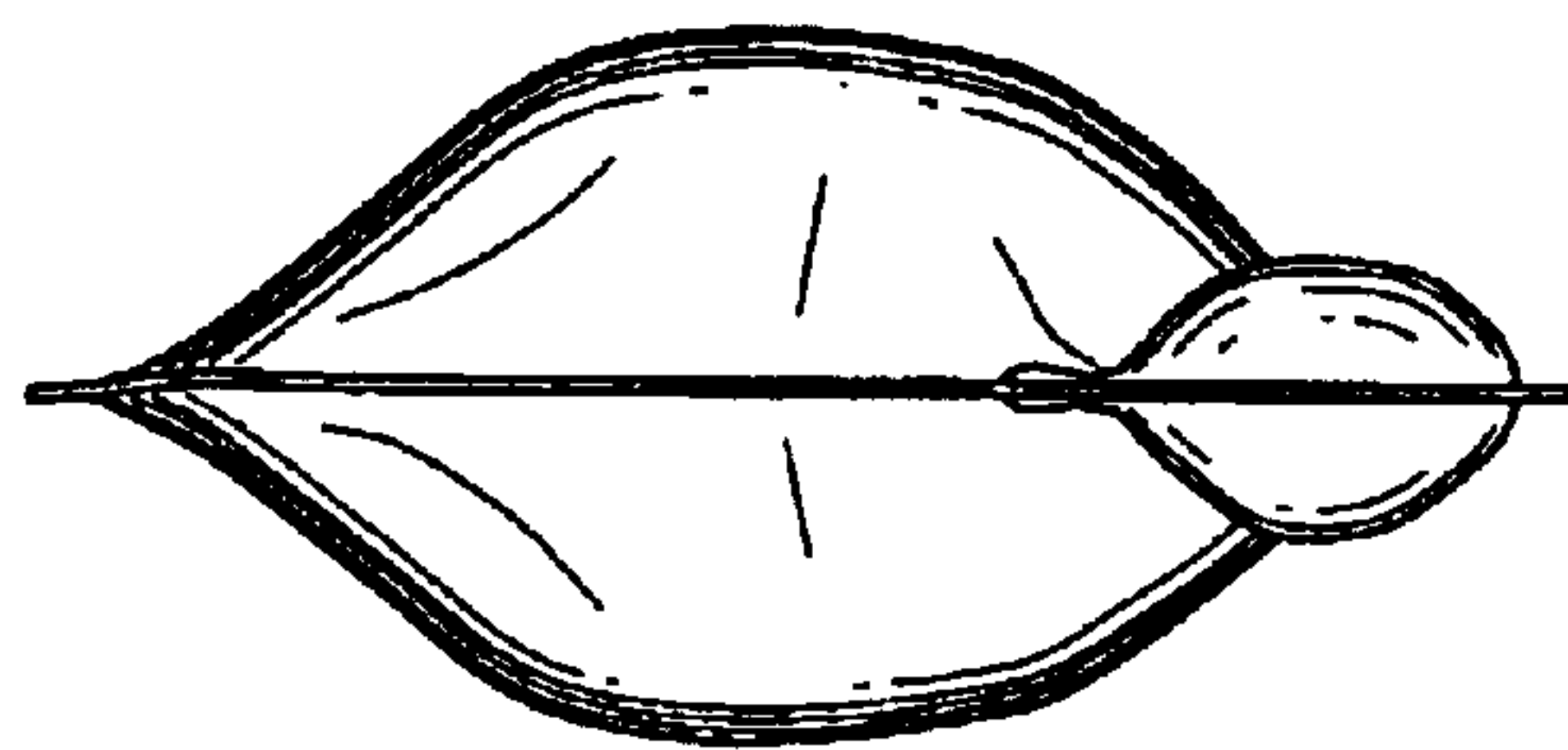

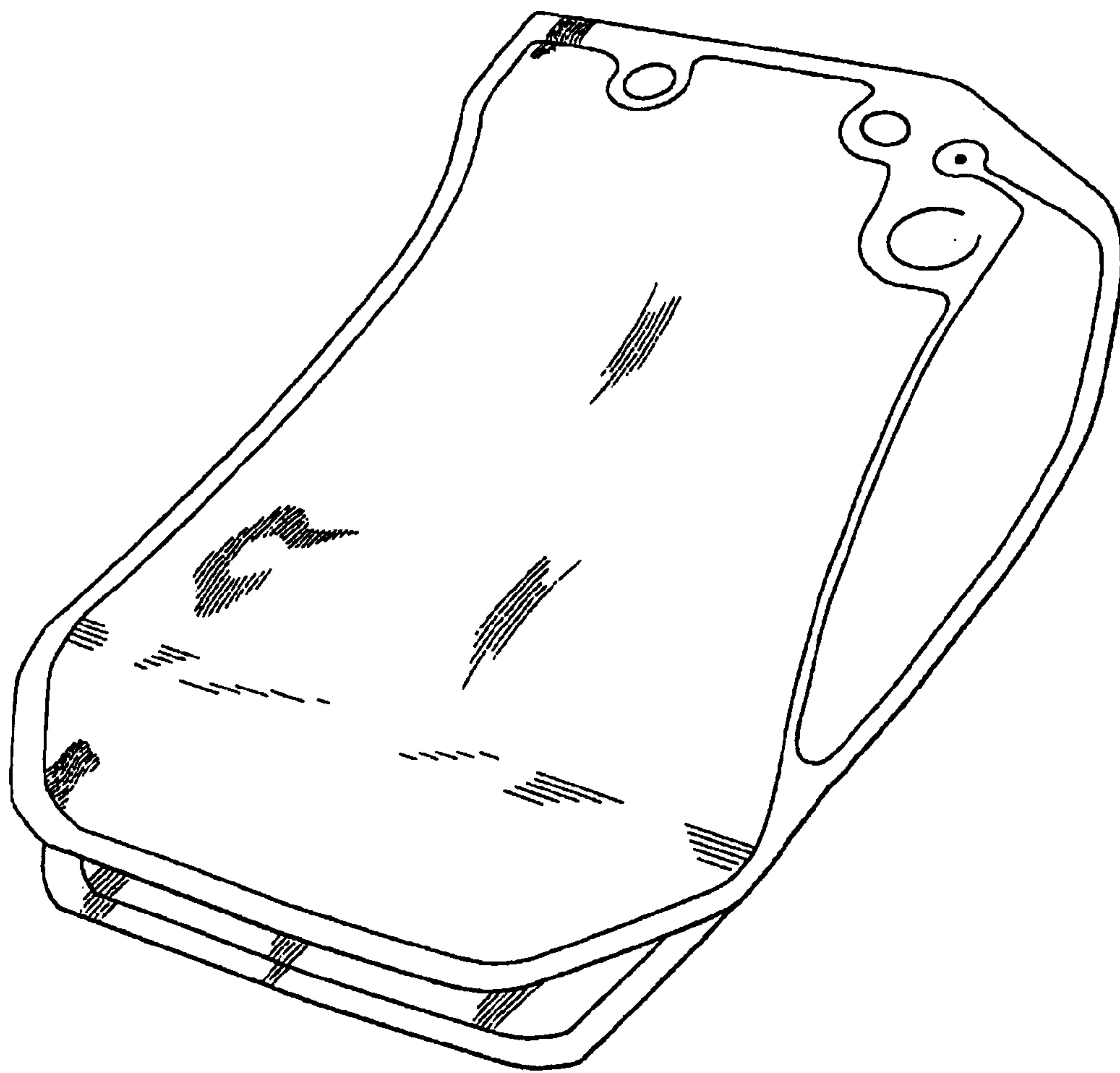

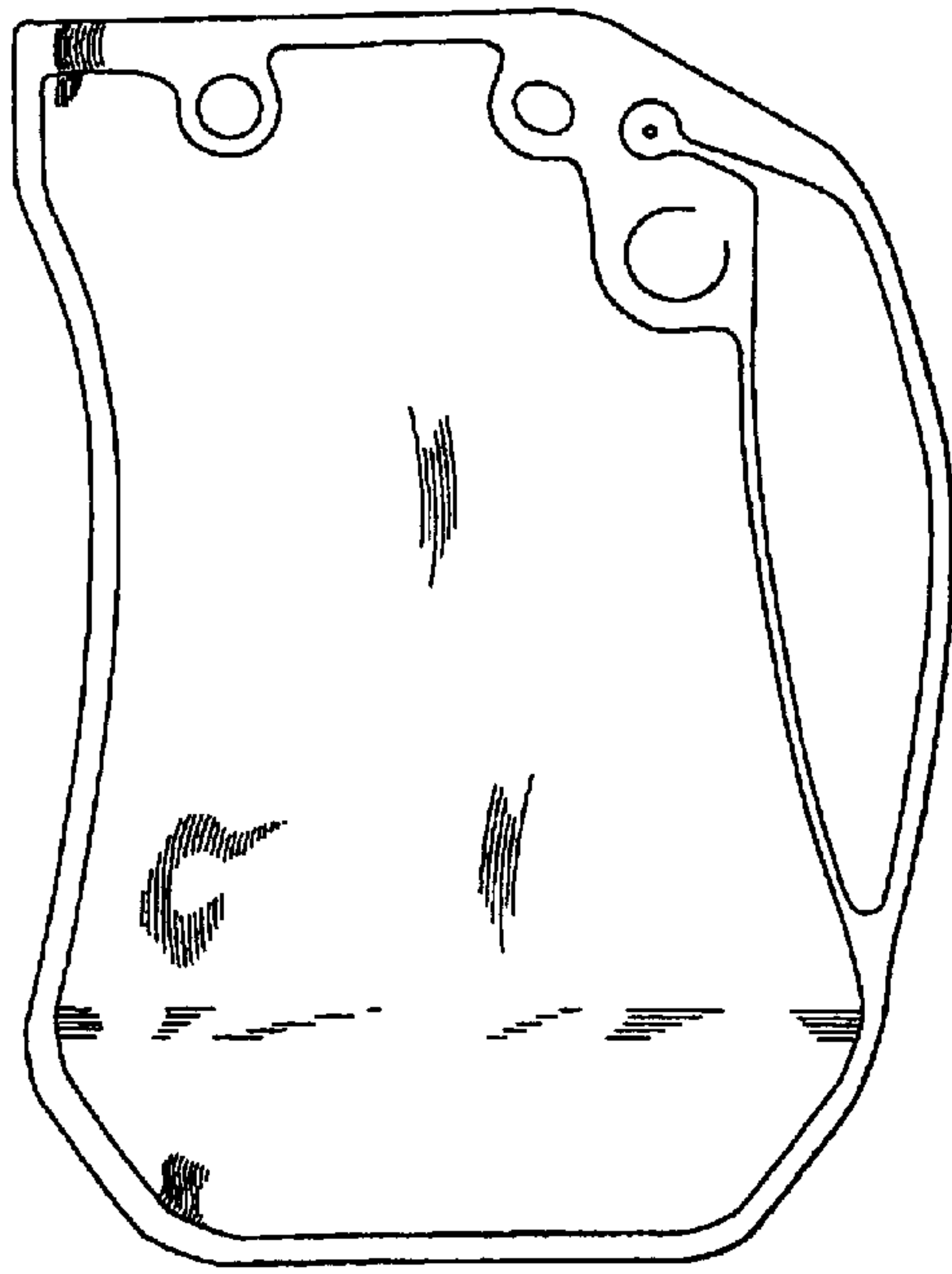

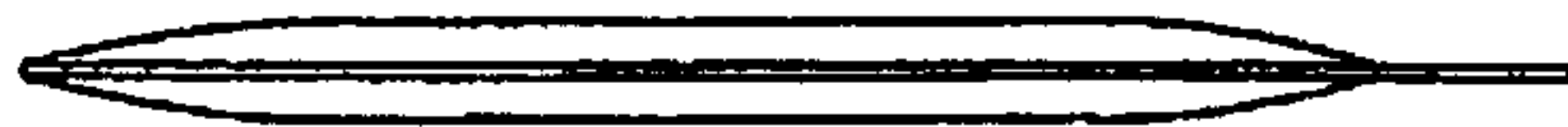

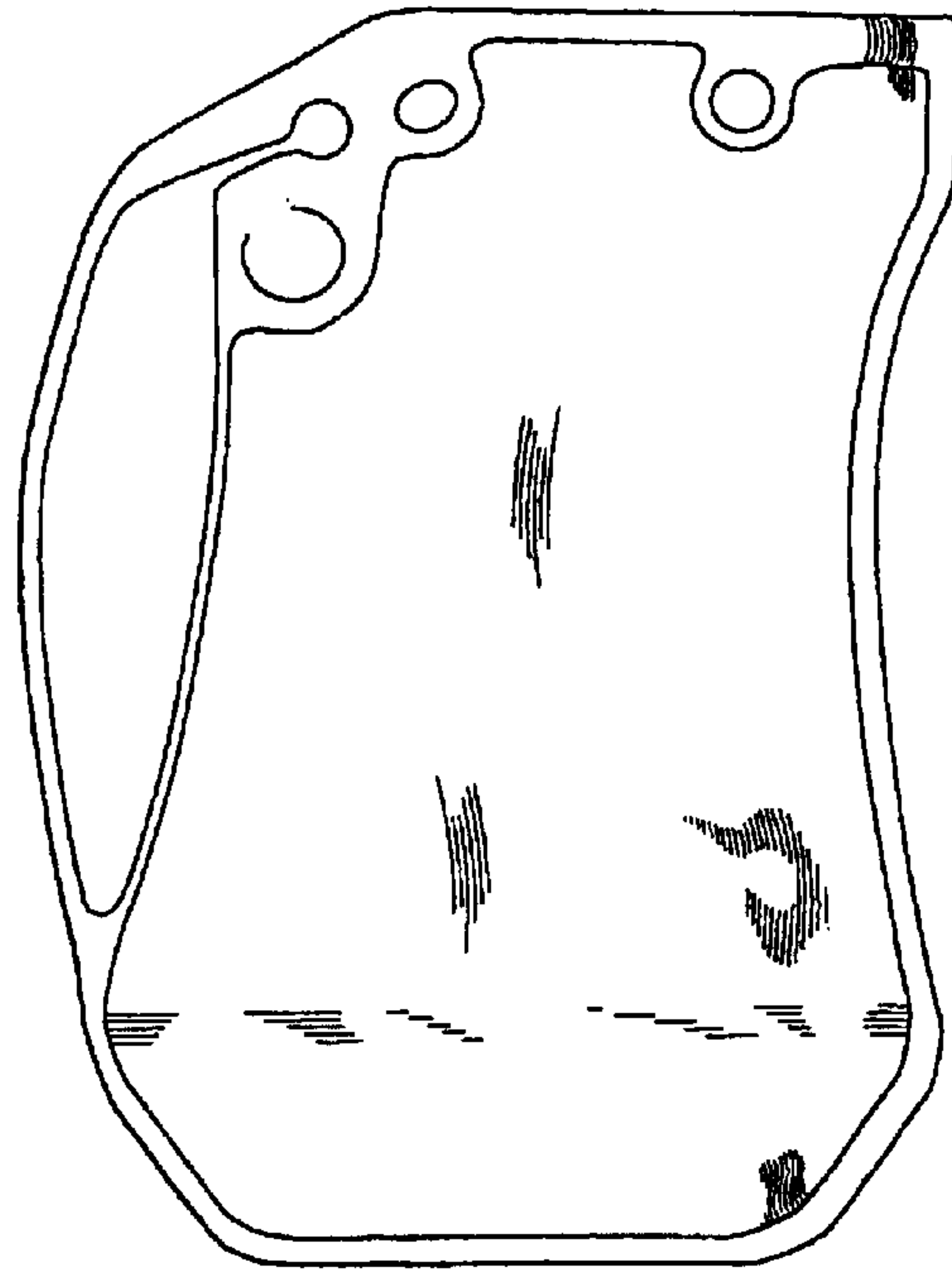
