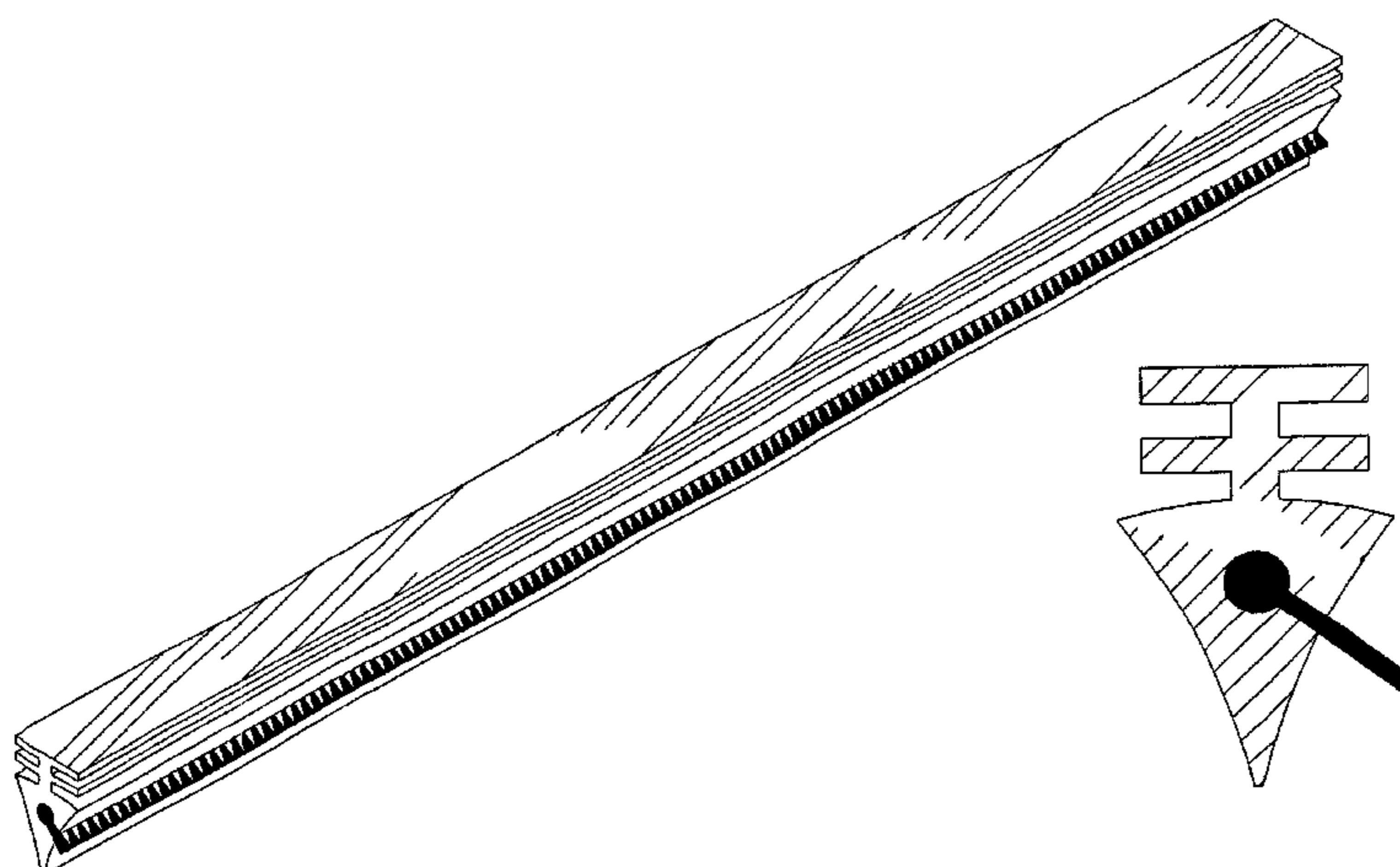
(57) **CLAIM**

The ornamental design for a “windshield wiper,” as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of the “windshield wiper,”
showing my new design;
FIG. 2 is a top elevation view thereof;
FIG. 3 is a bottom elevation view thereof;
FIG. 4 is a front elevation view thereof;
FIG. 5 is a back elevation view thereof; and
FIG. 6 is a right-side elevation view thereof; and,
FIG. 7 is a left-side elevation view thereof.
The windshield wiper is shown on an enlarged scale in
FIGS. 6-7.

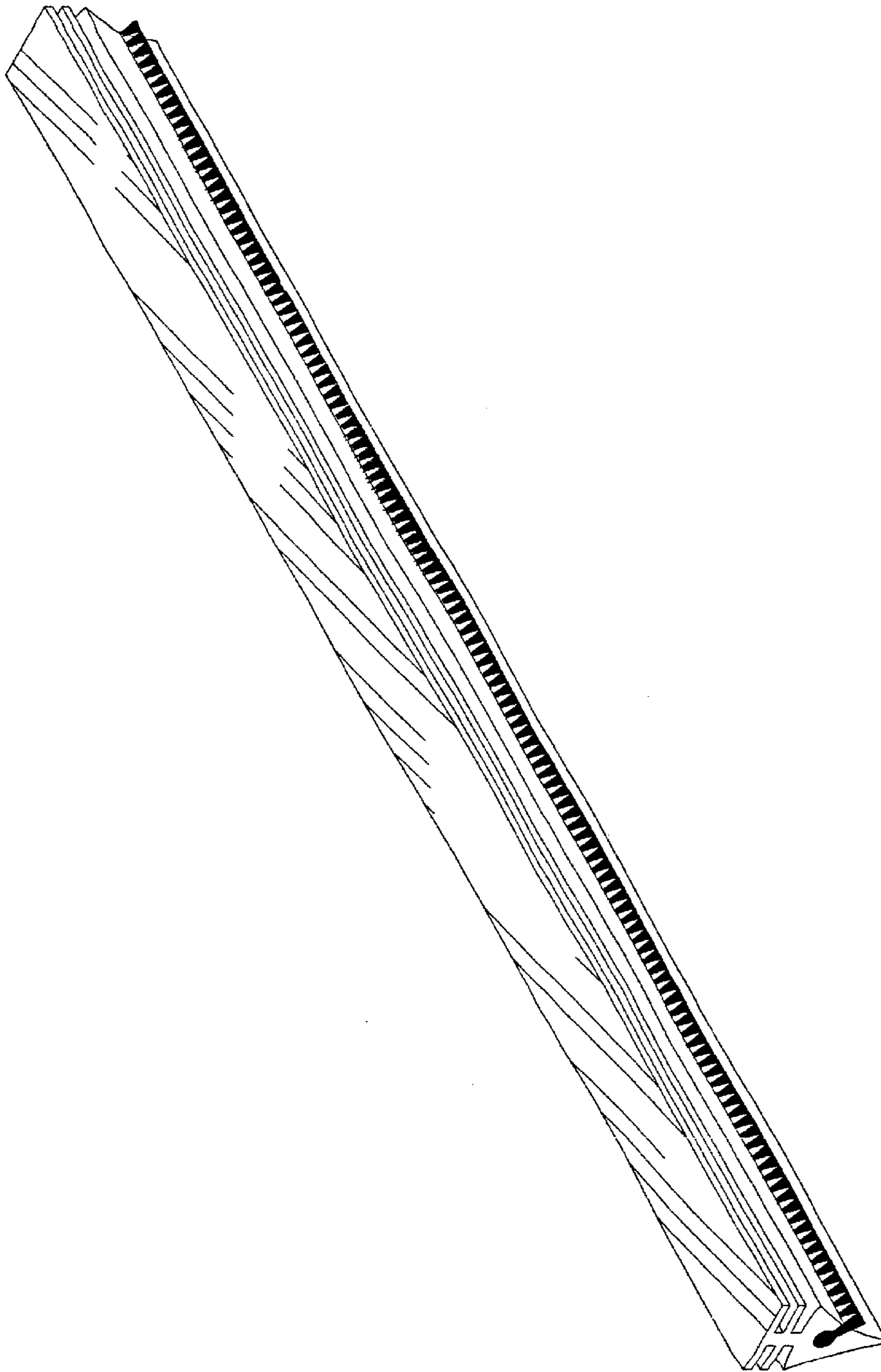

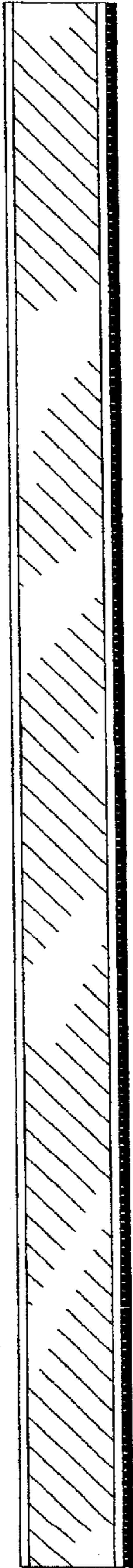

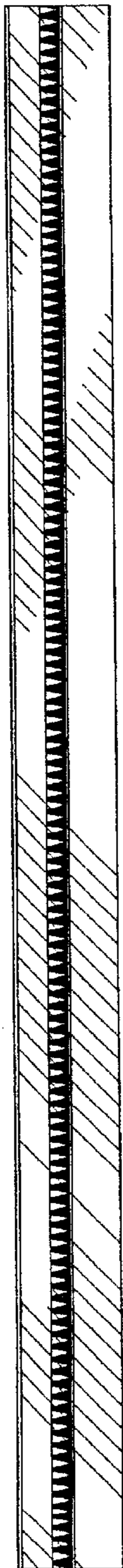

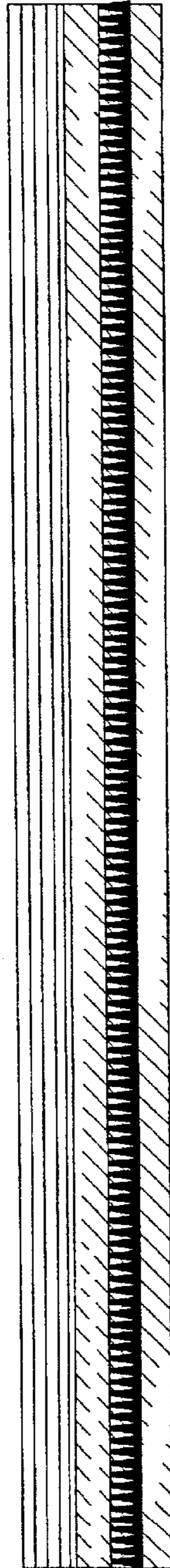

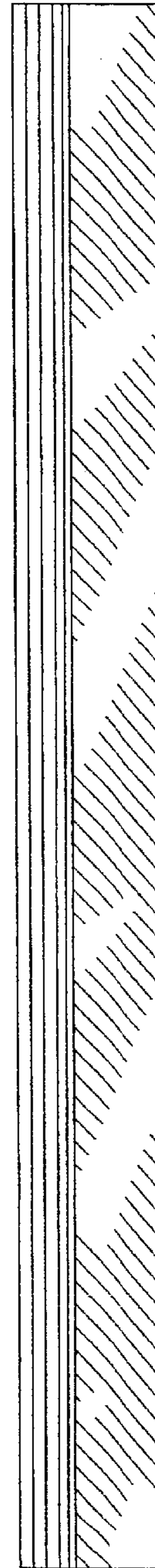

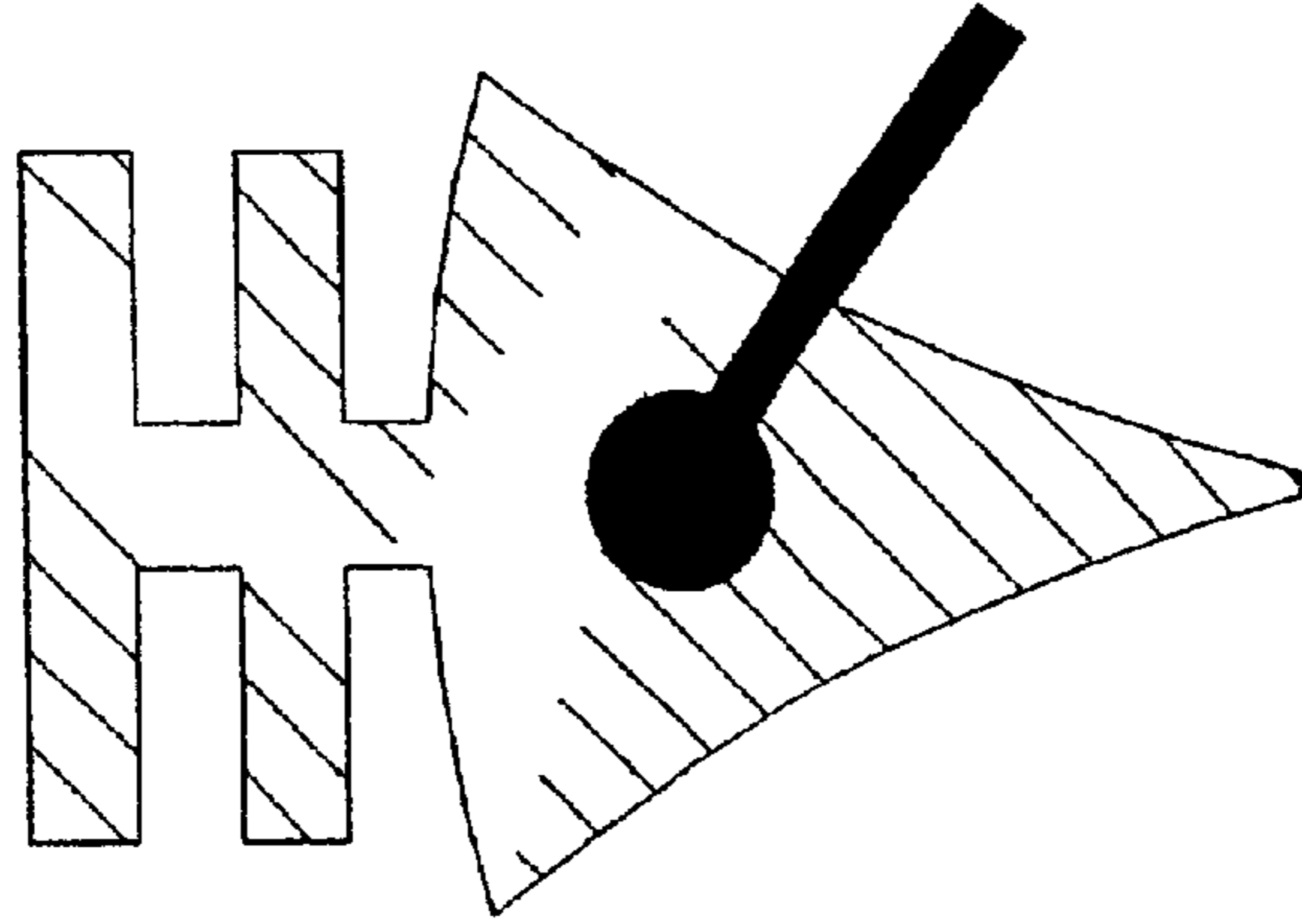

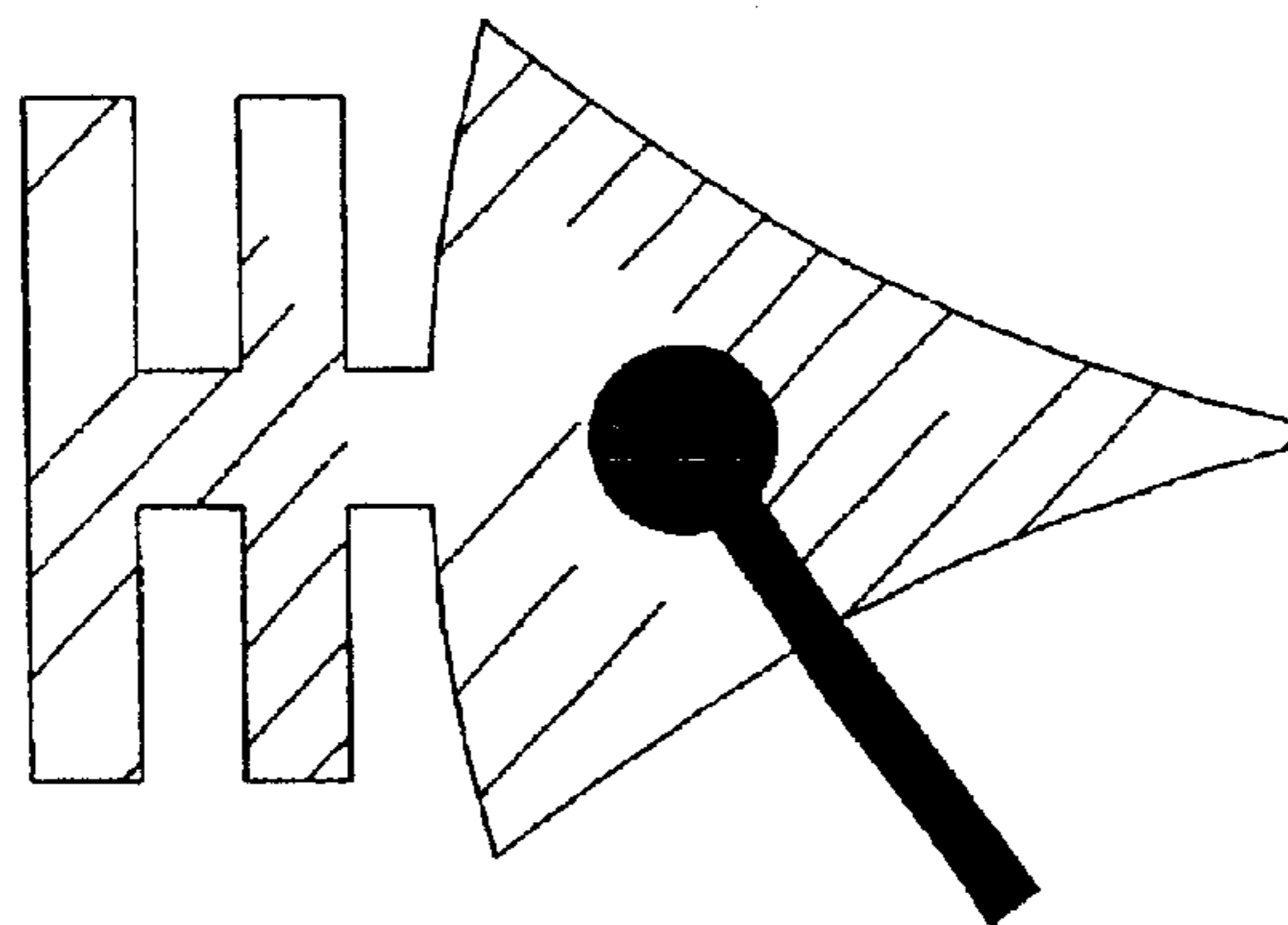
