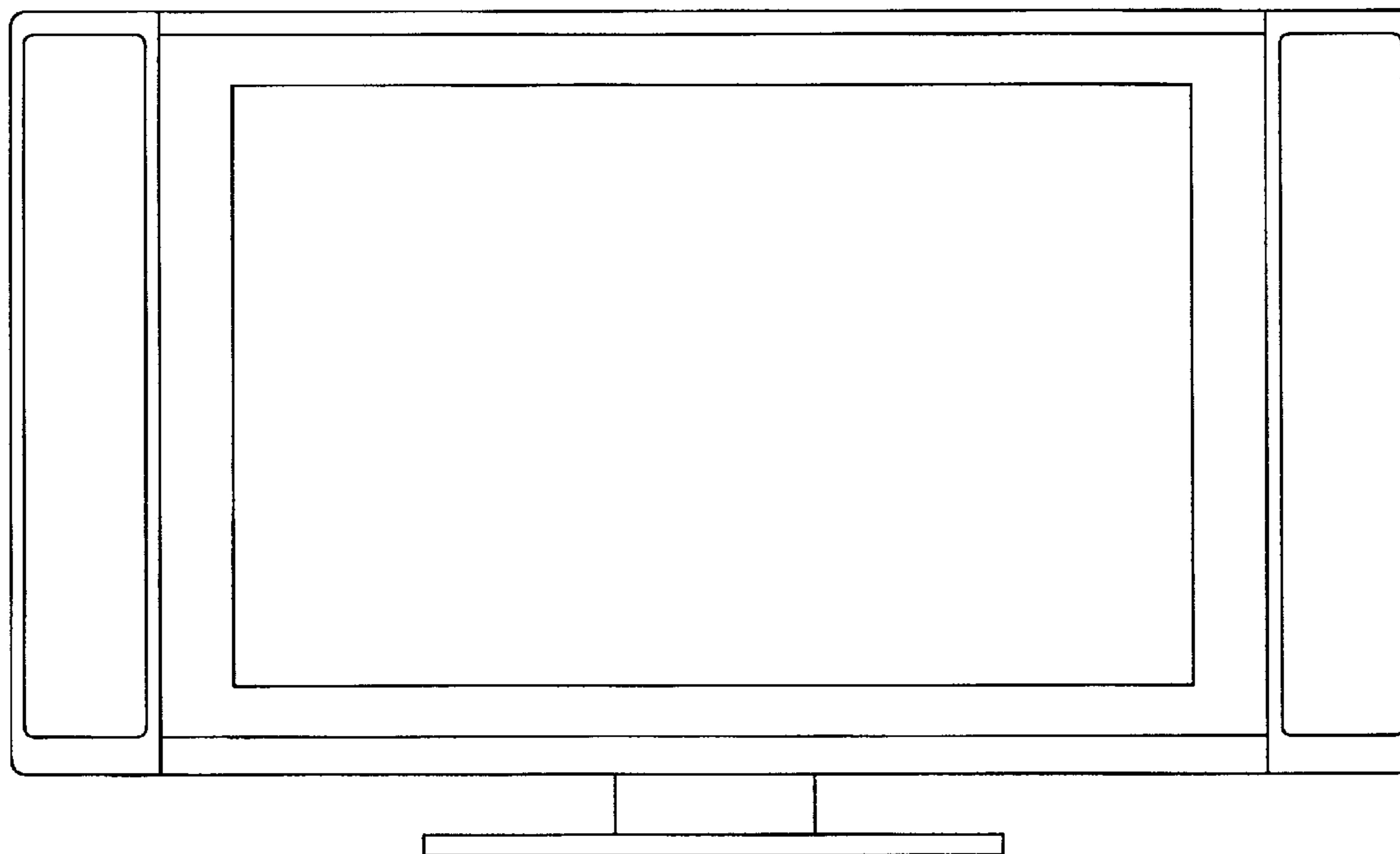
(57) **CLAIM**

We claim an ornamental design for a liquid crystal television receiver including a tuner mounted thereon, as shown and described.

**DESCRIPTION**

FIG. 1 is a FRONT ELEVATIONAL view of a liquid crystal television receiver including a tuner mounted thereon showing our new design;  
FIG. 2 is a TOP PLAN view thereof;  
FIG. 3 is a BOTTOM PLAN view thereof;  
FIG. 4 is a LEFT ELEVATIONAL SIDE view thereof;  
FIG. 5 is a RIGHT ELEVATIONAL SIDE view thereof; and,  
FIG. 6 is a BACK ELEVATIONAL view of the same.

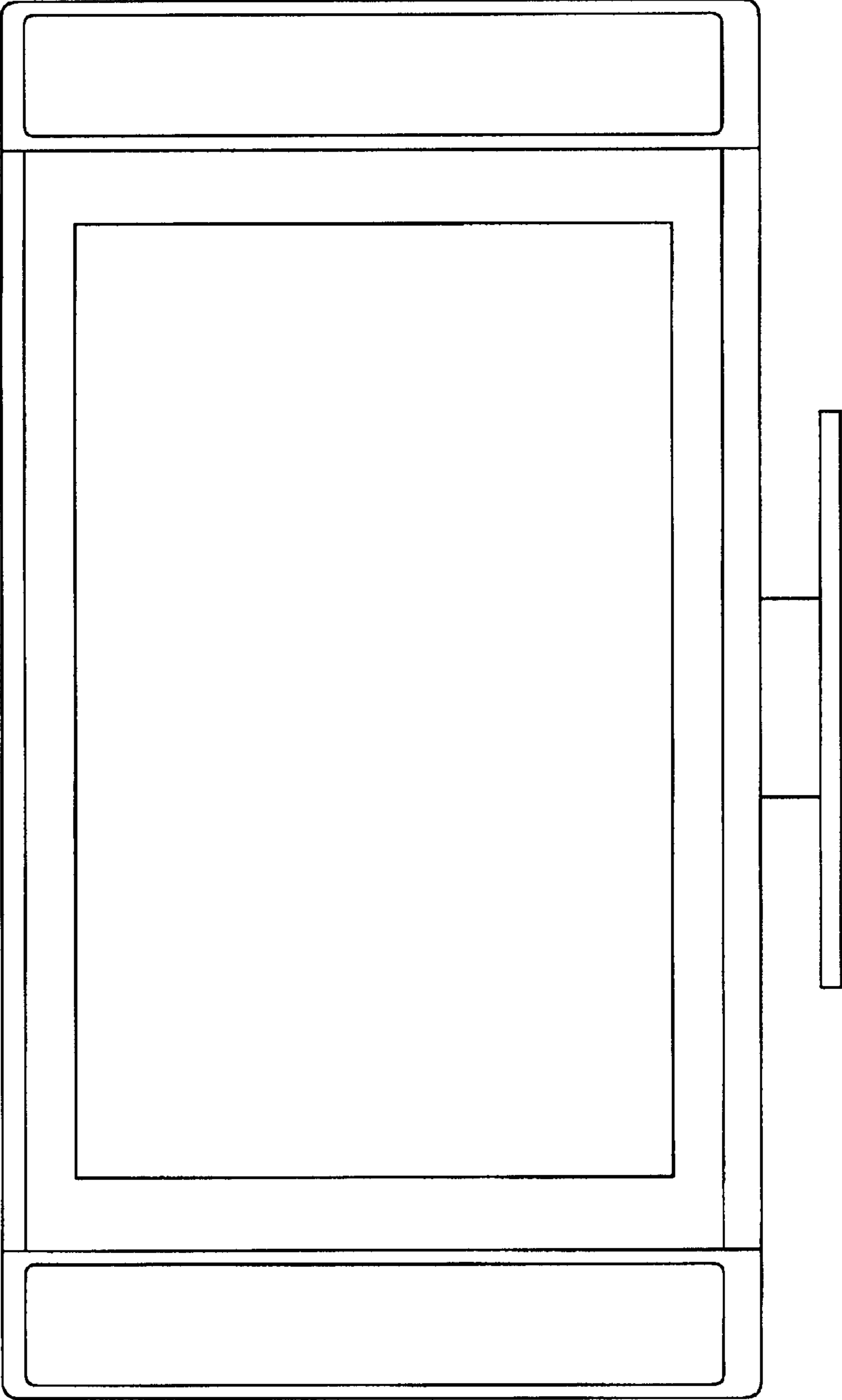

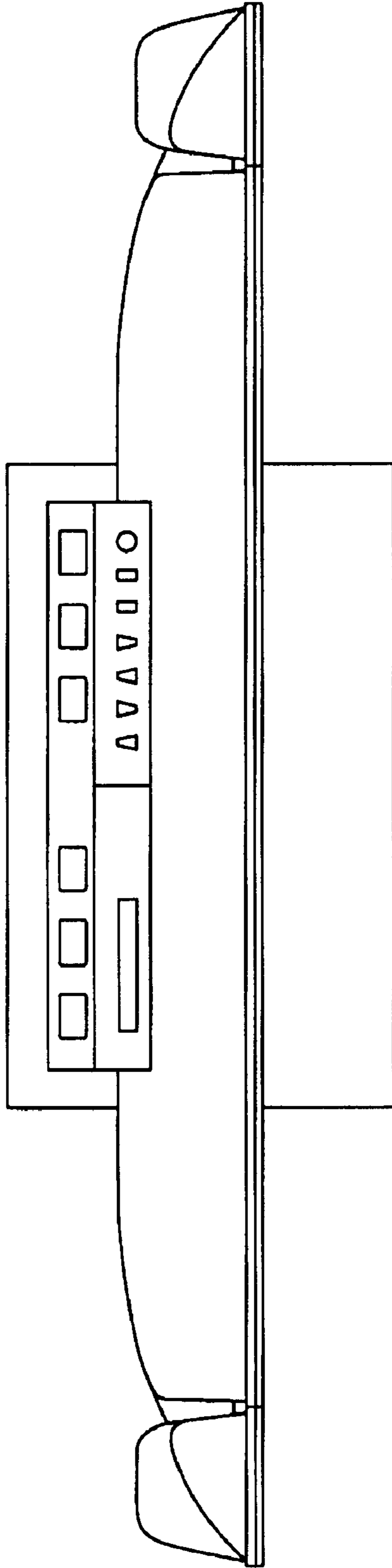

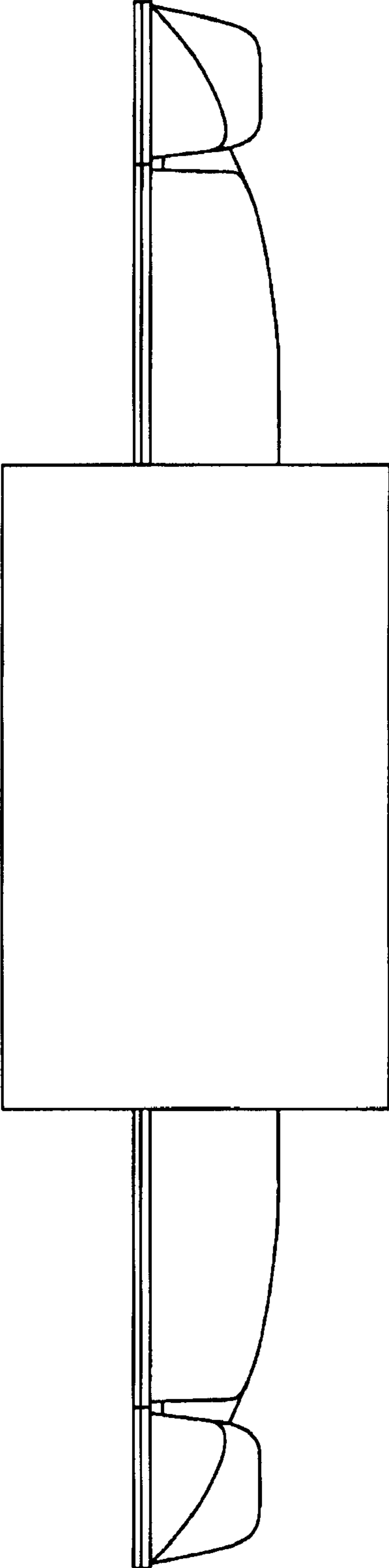

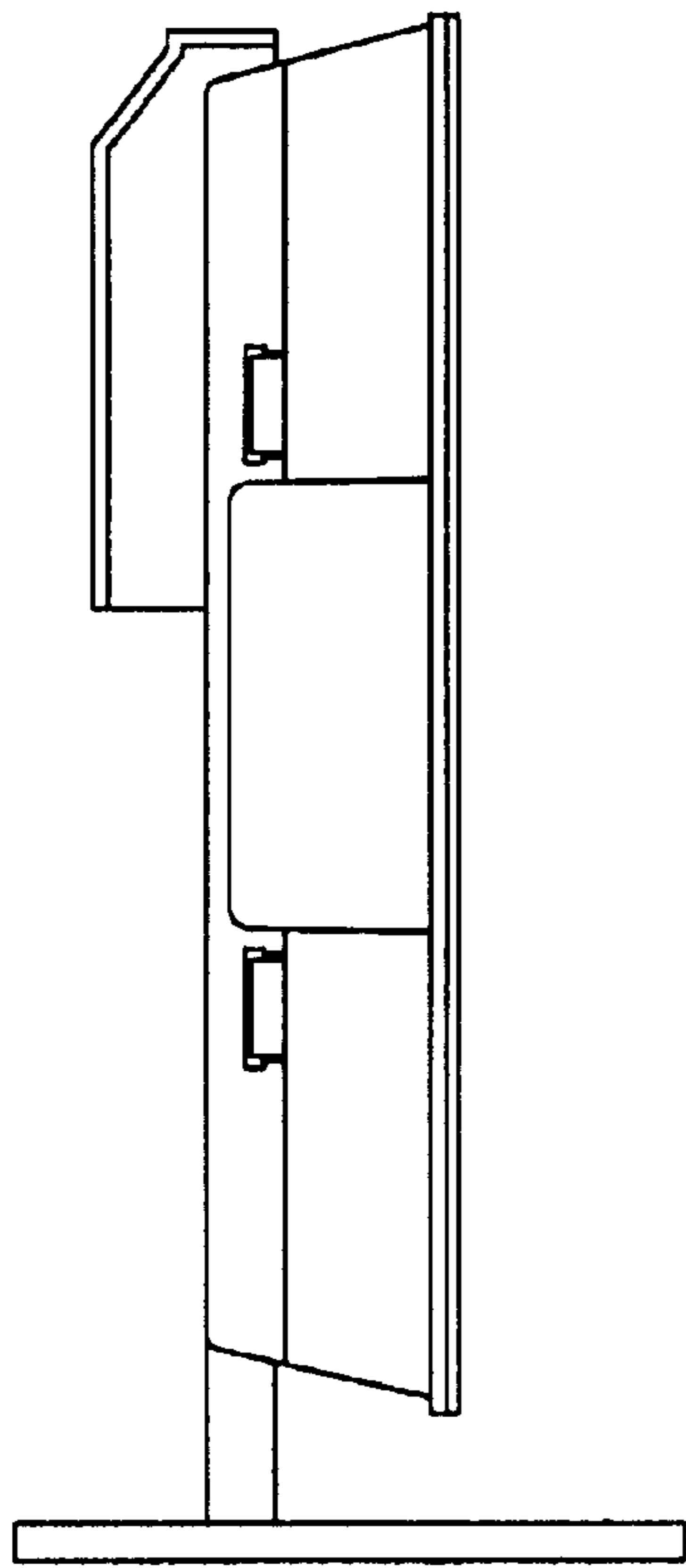

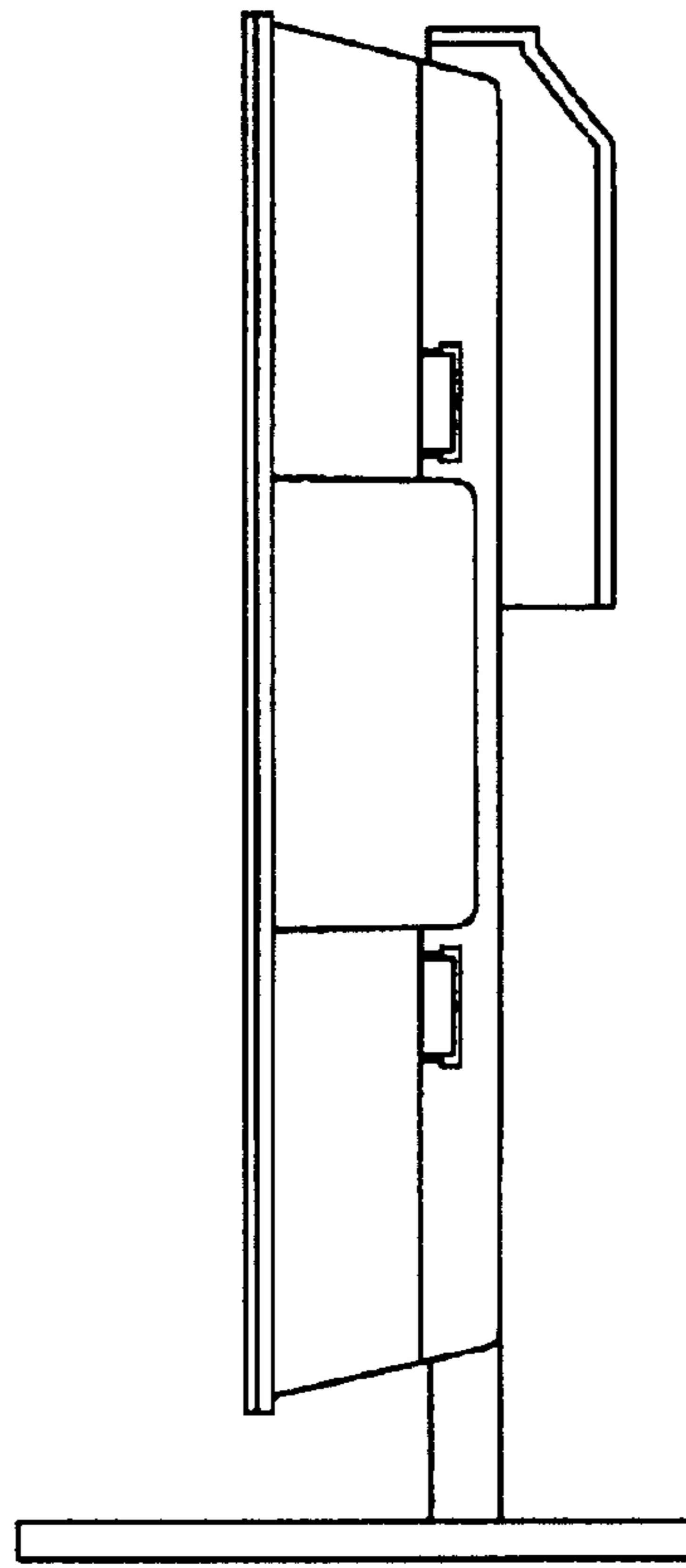

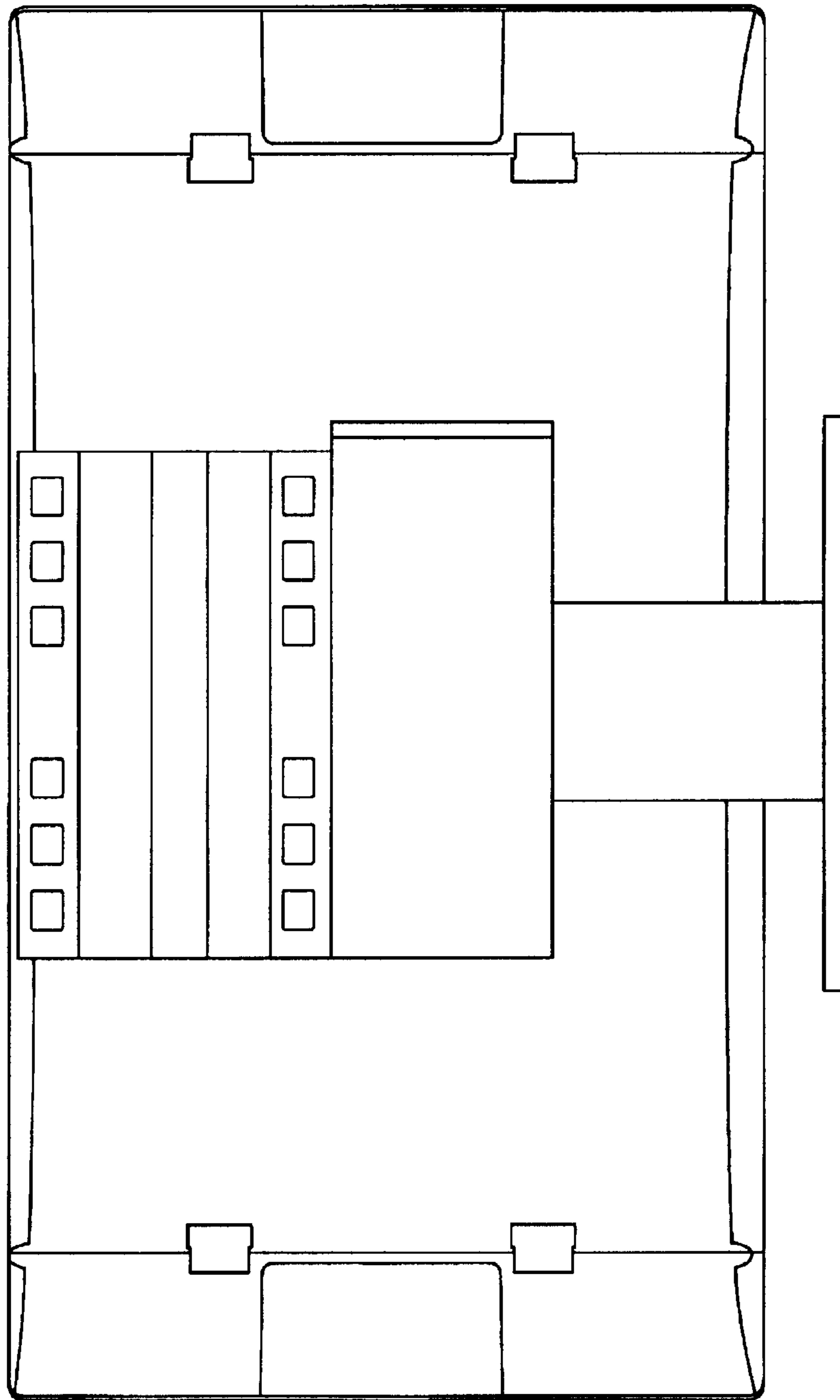
