(57) **CLAIM**

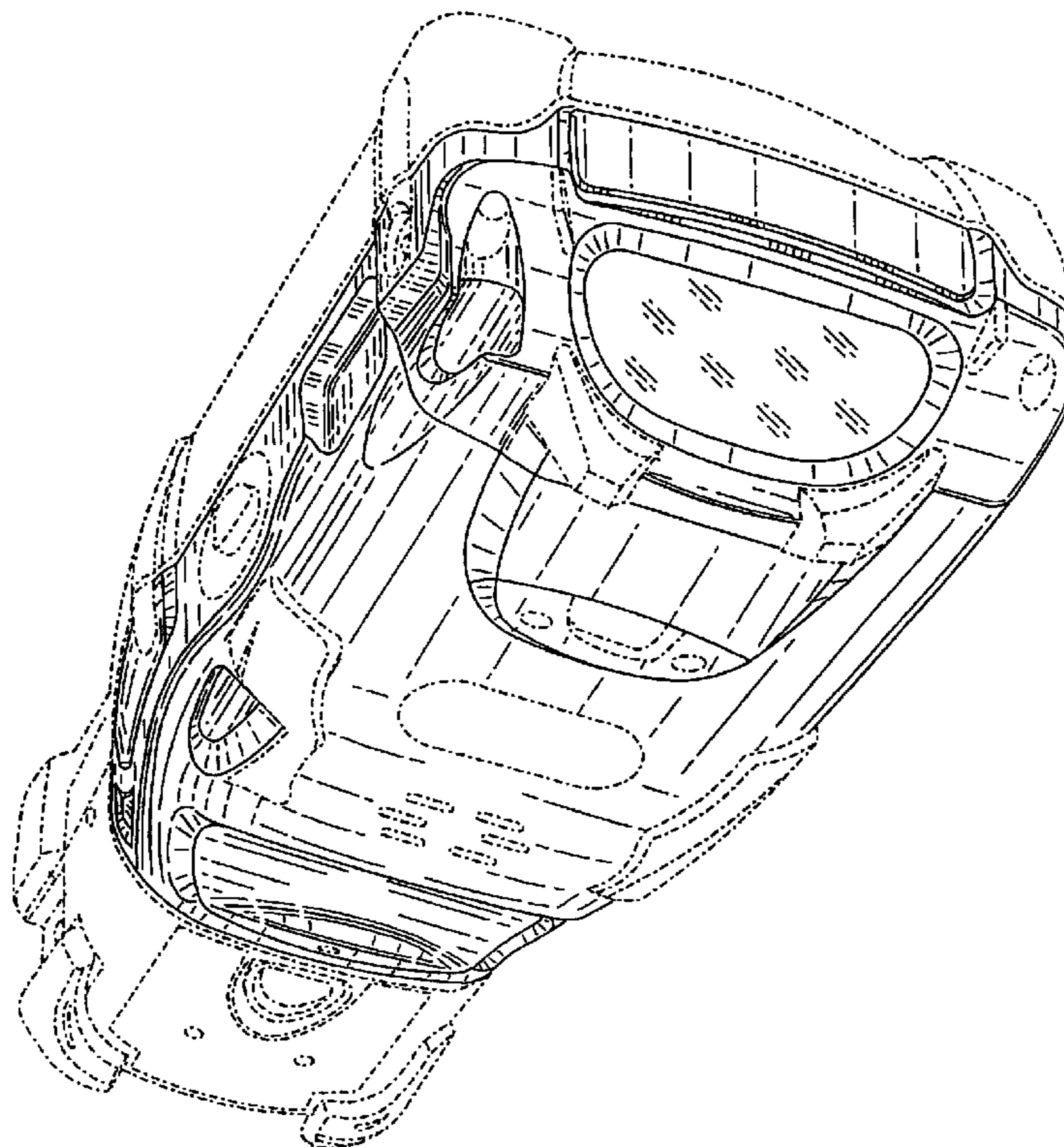
The ornamental design for a bottom portion housing for a mobile device, showing our new design.

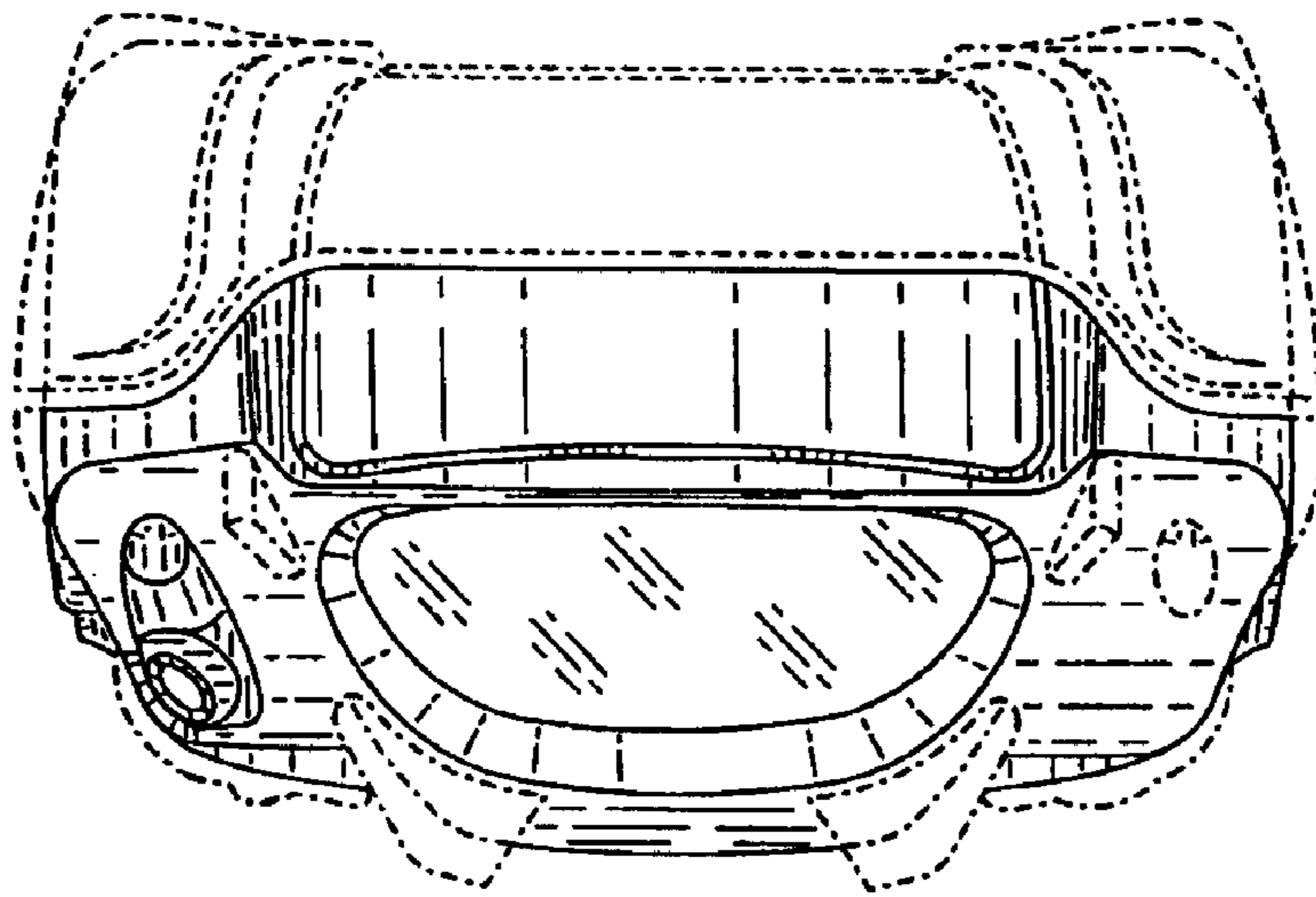

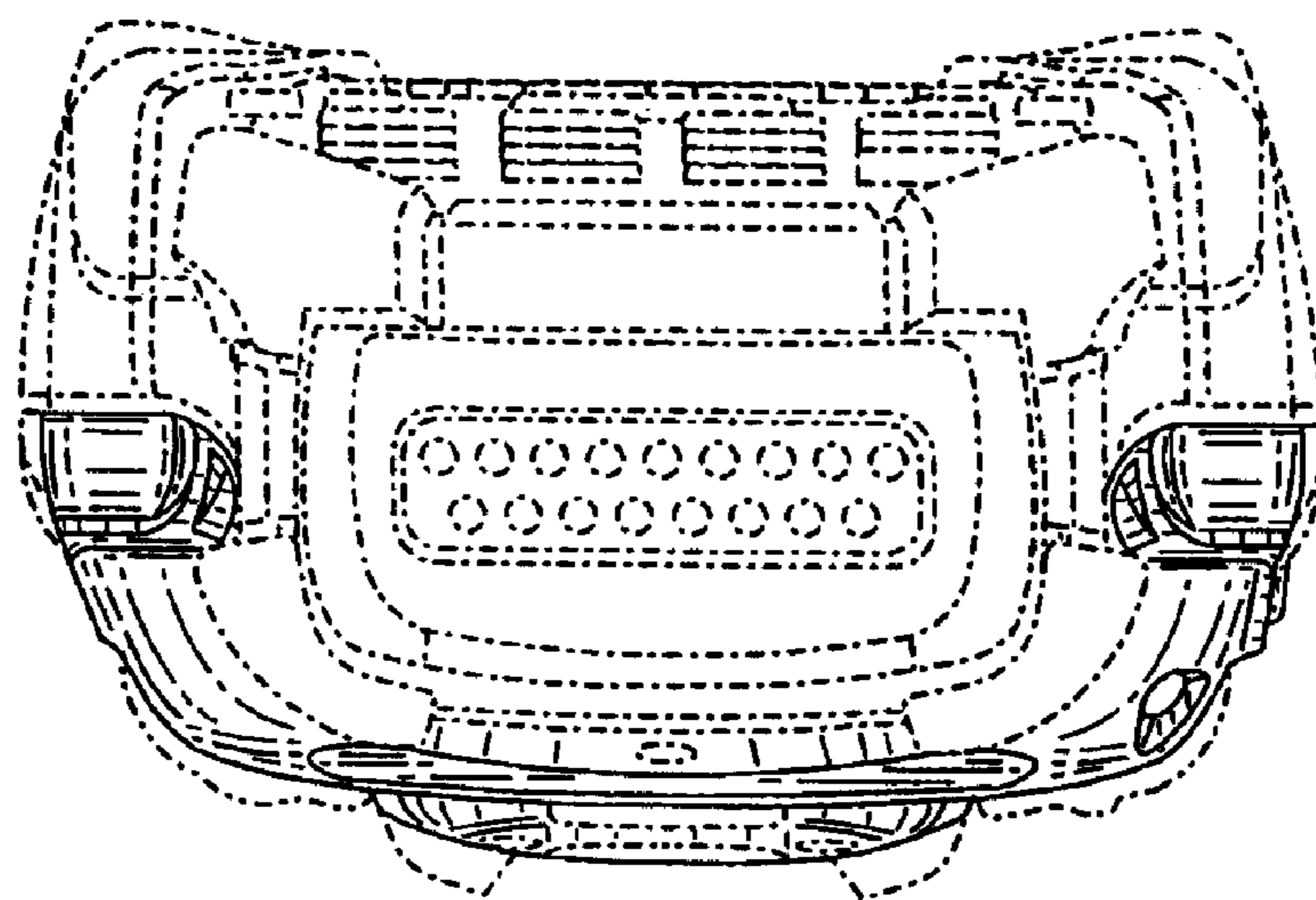

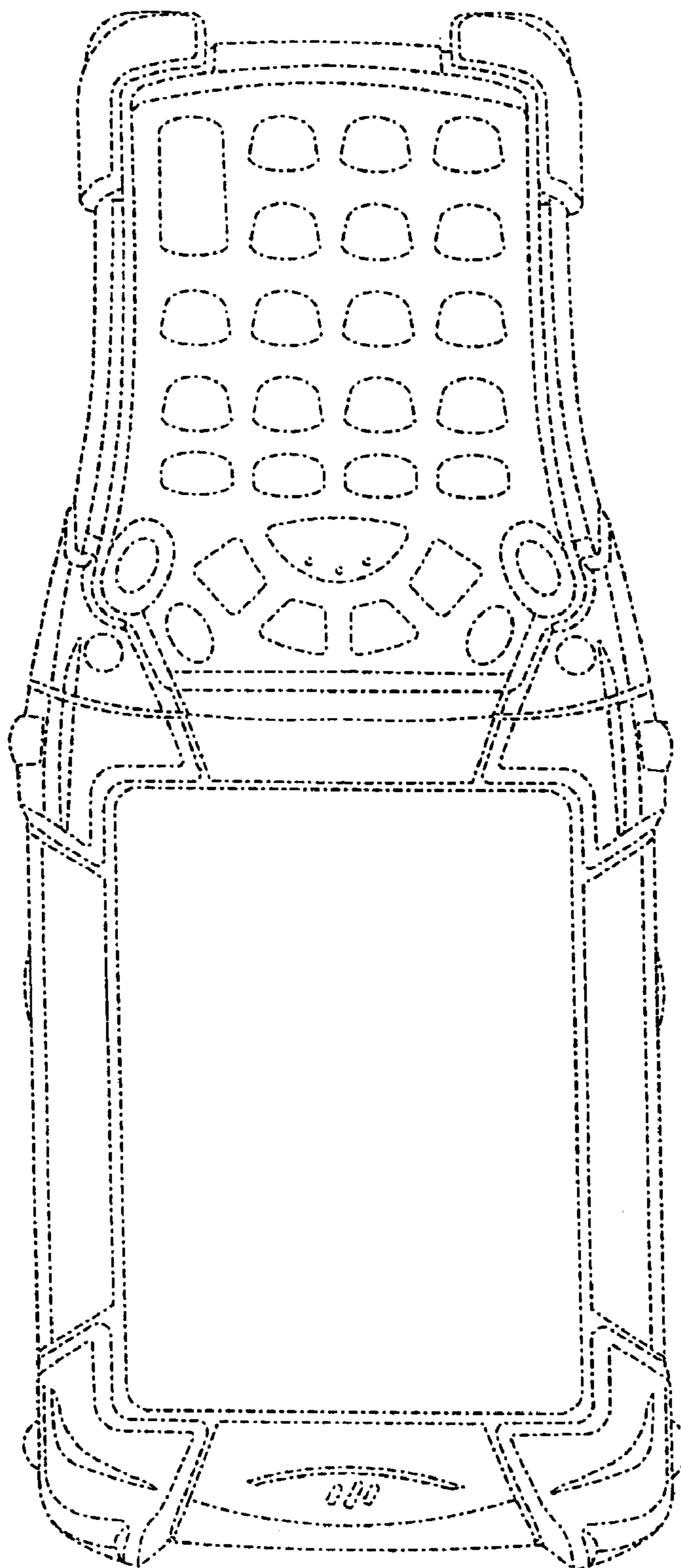

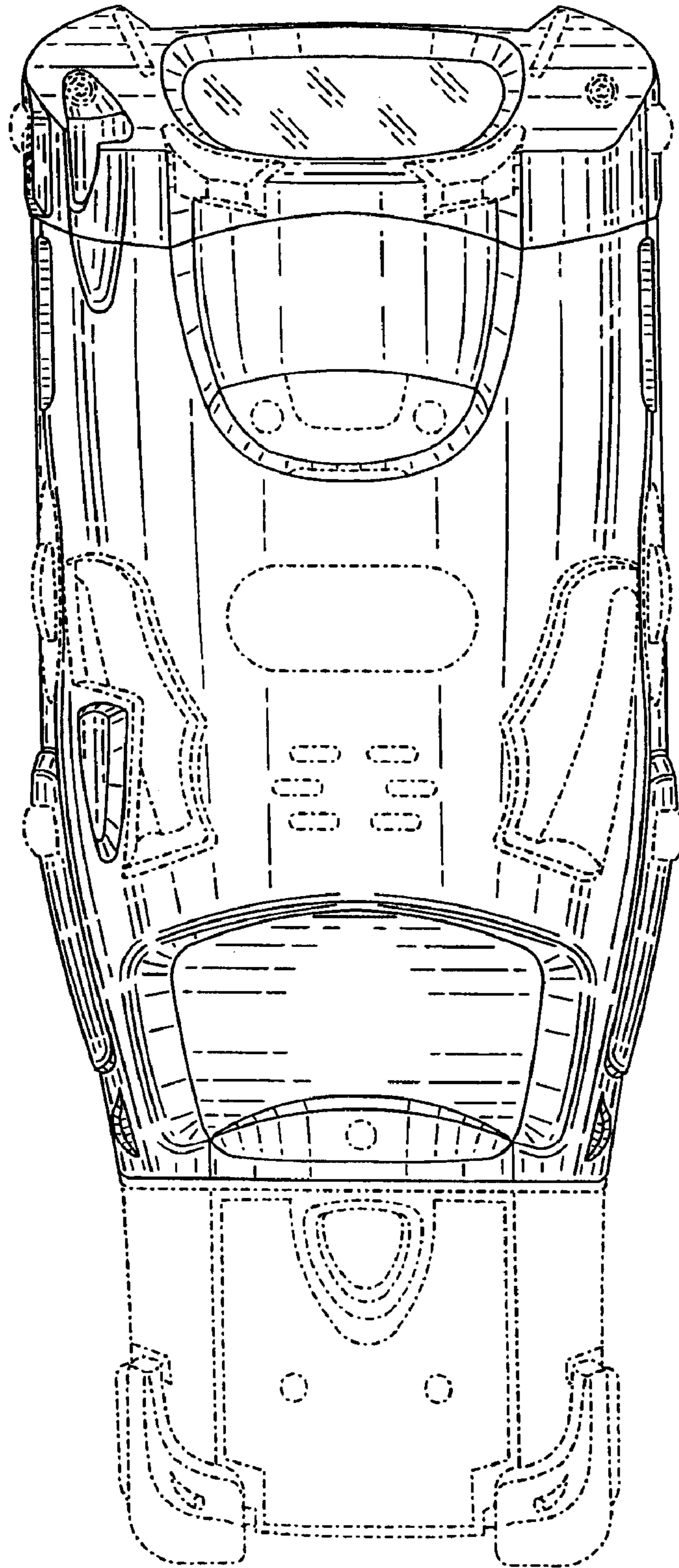

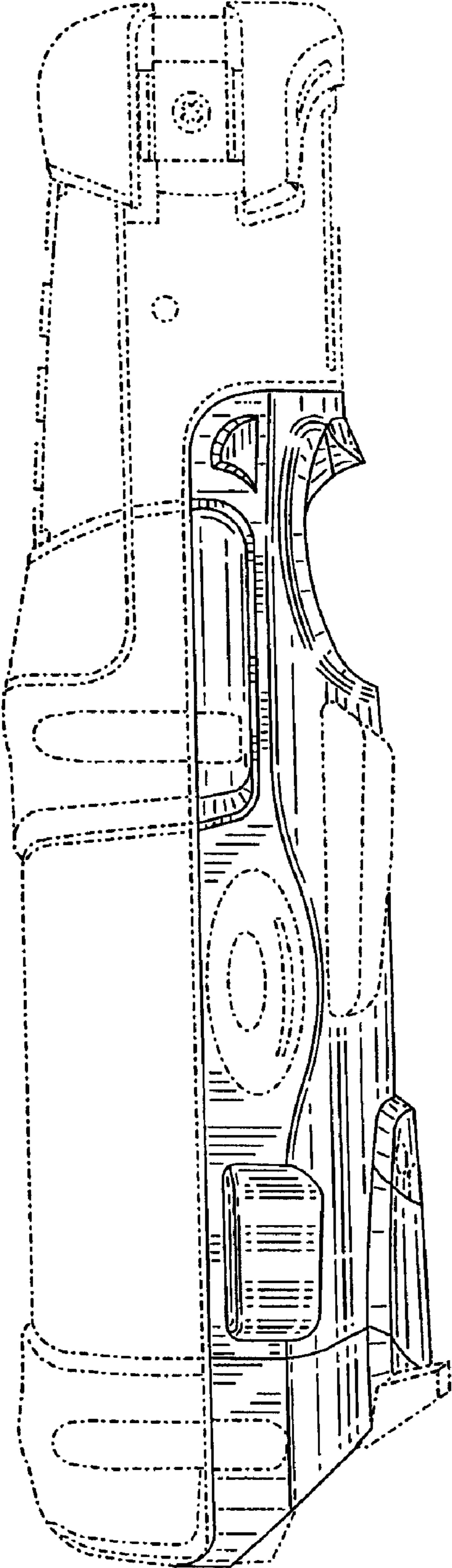

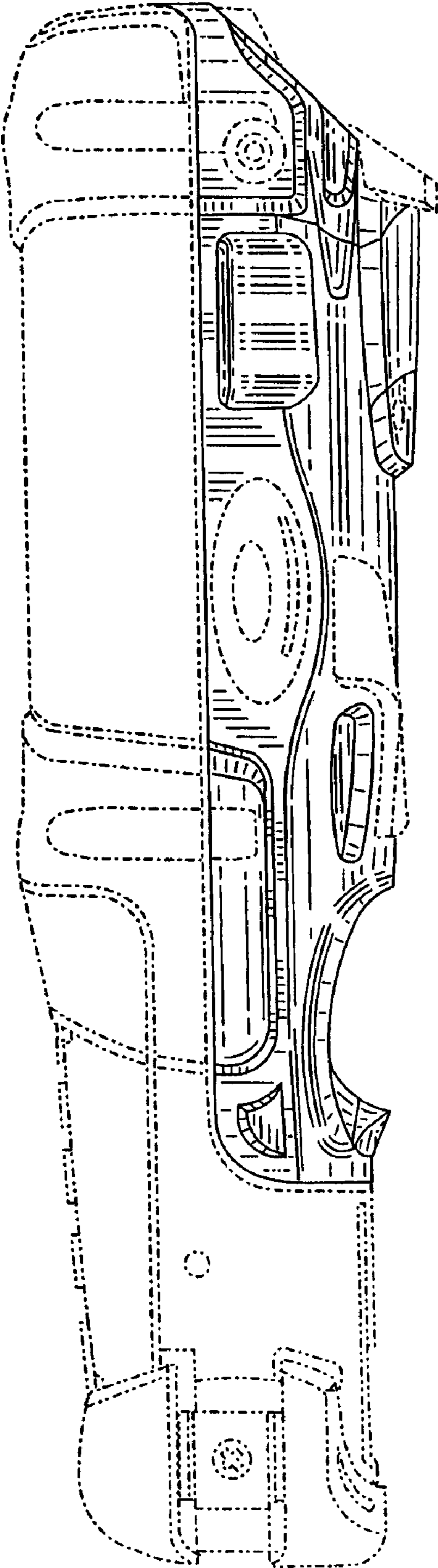

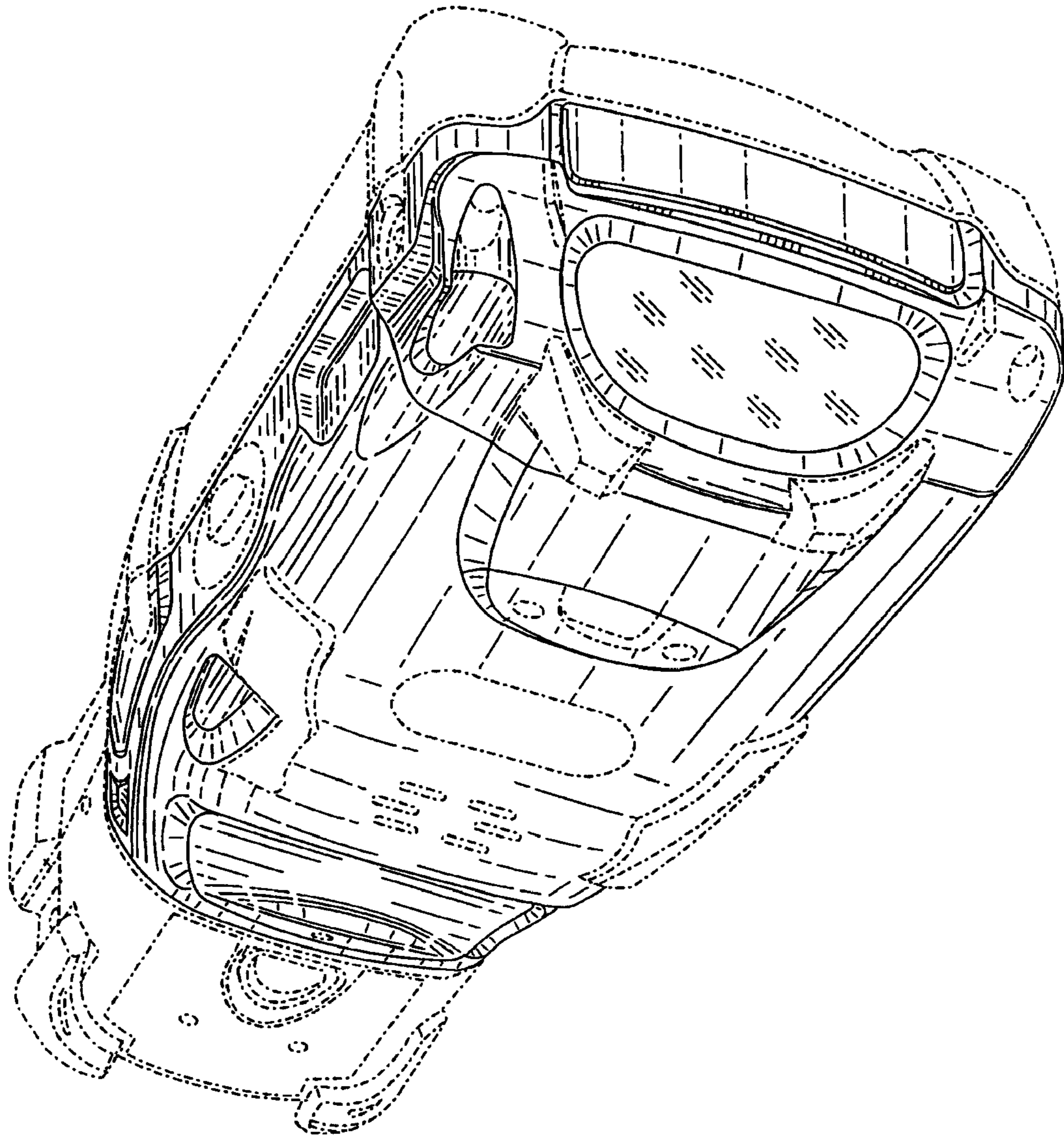
