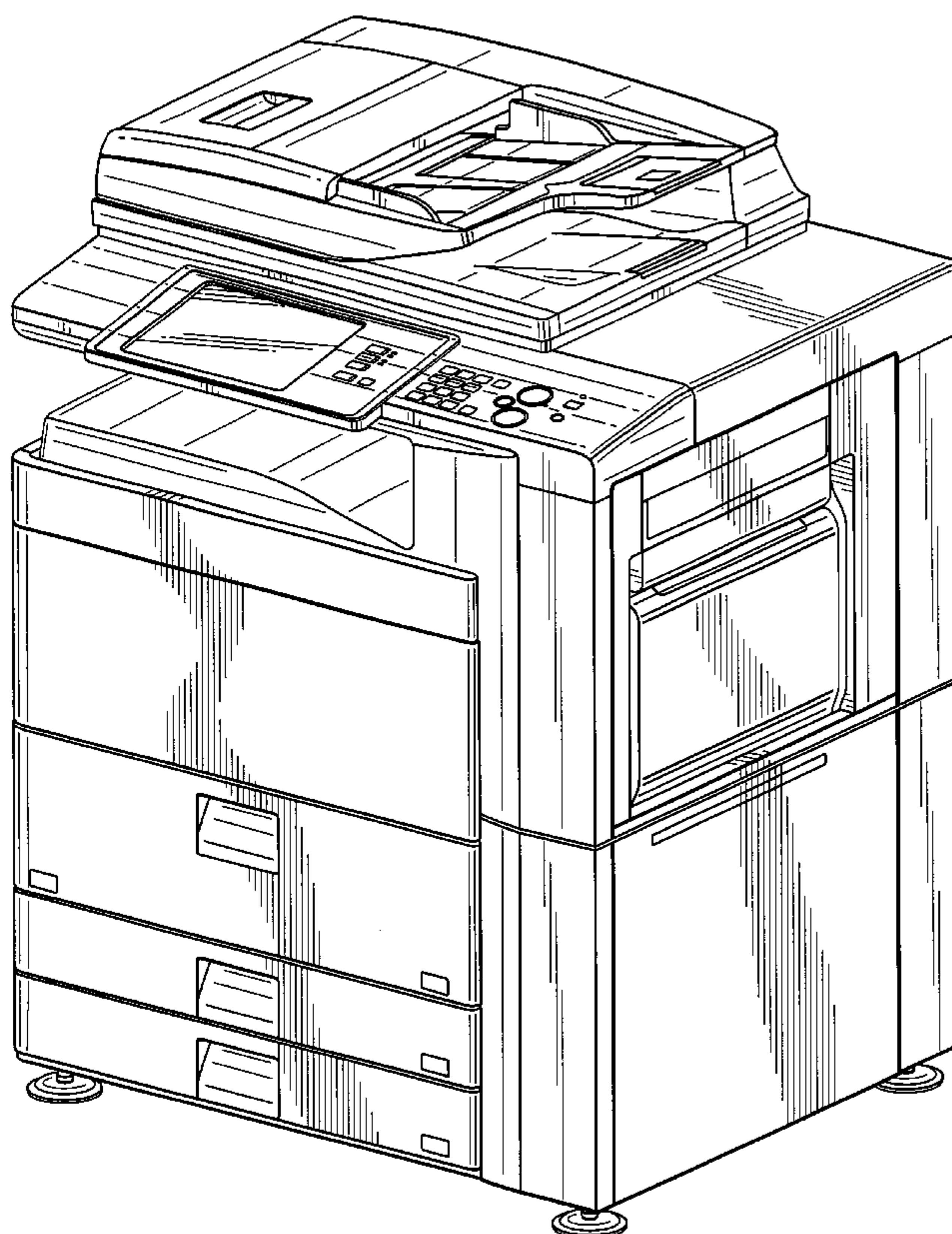
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a copying machine according to our design;
FIG. 2 is a front elevational view thereof;

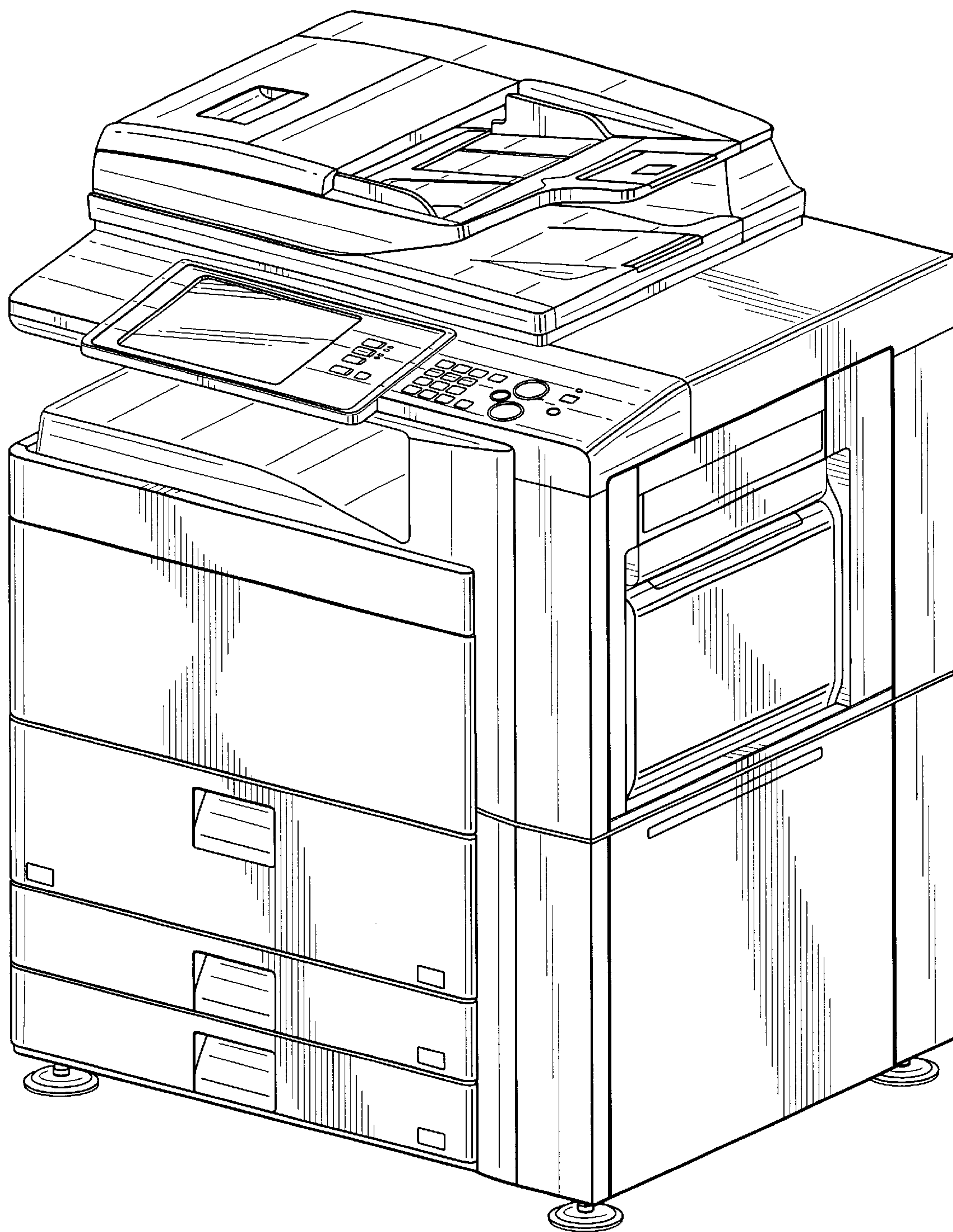

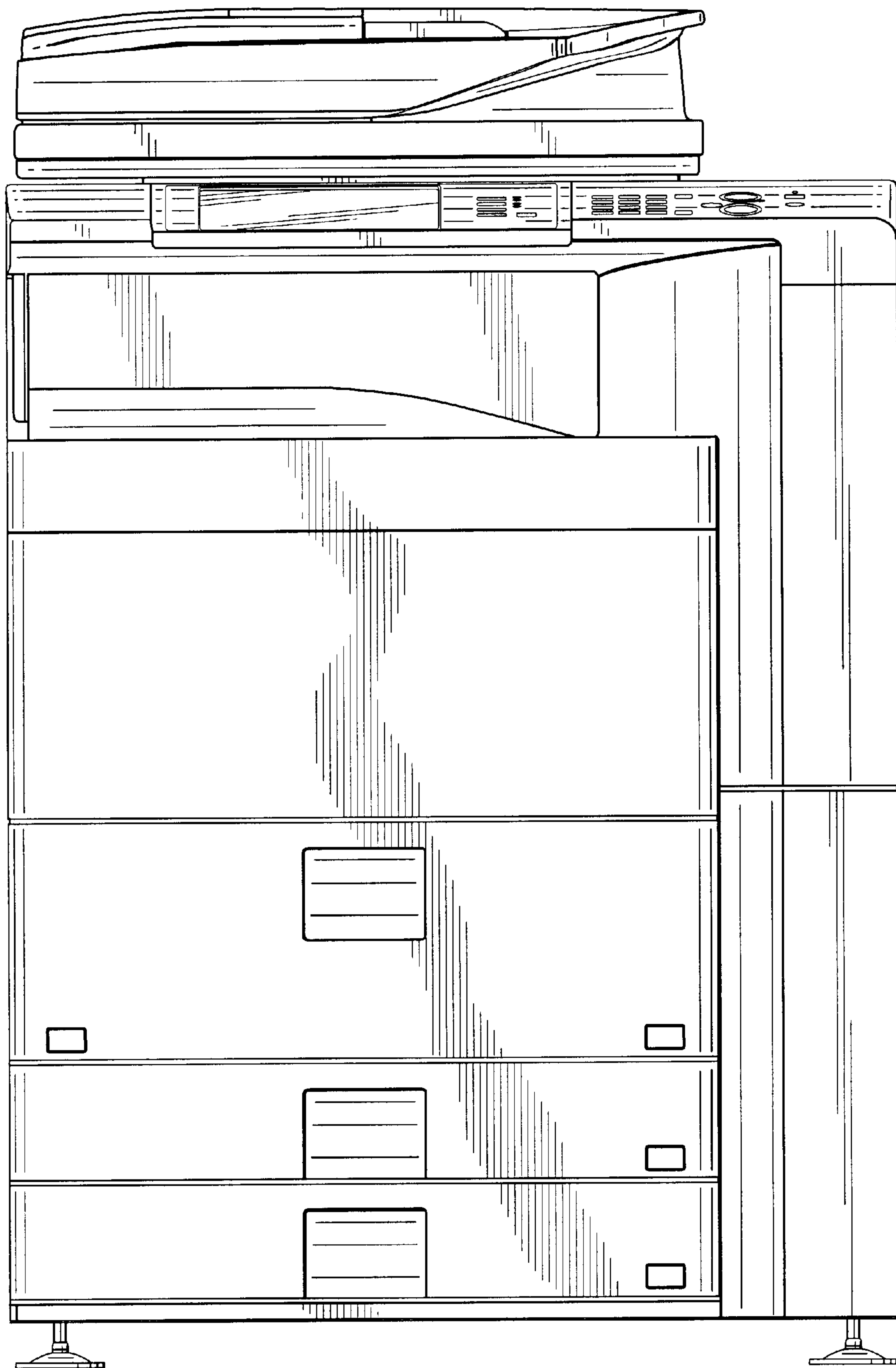

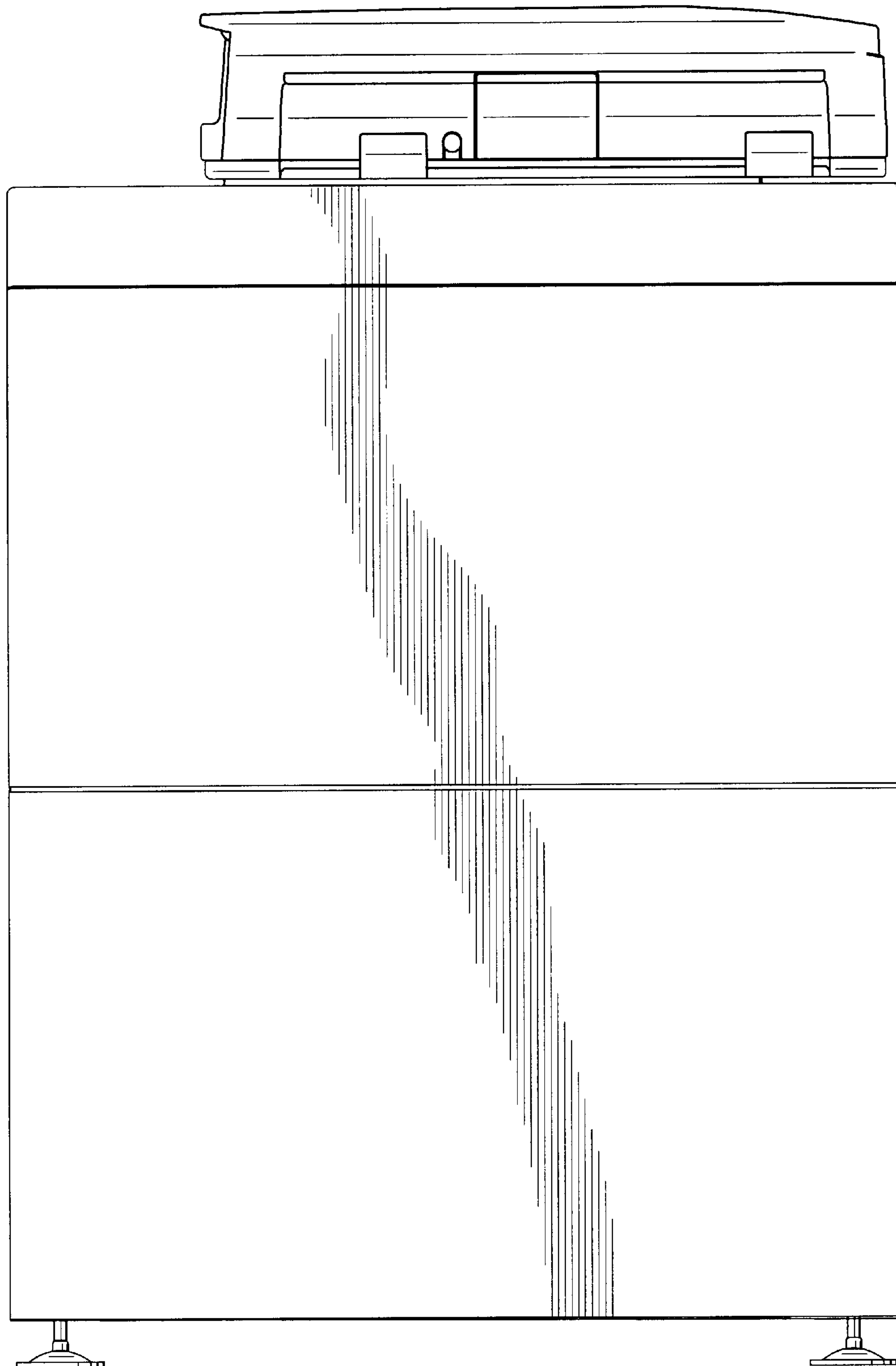

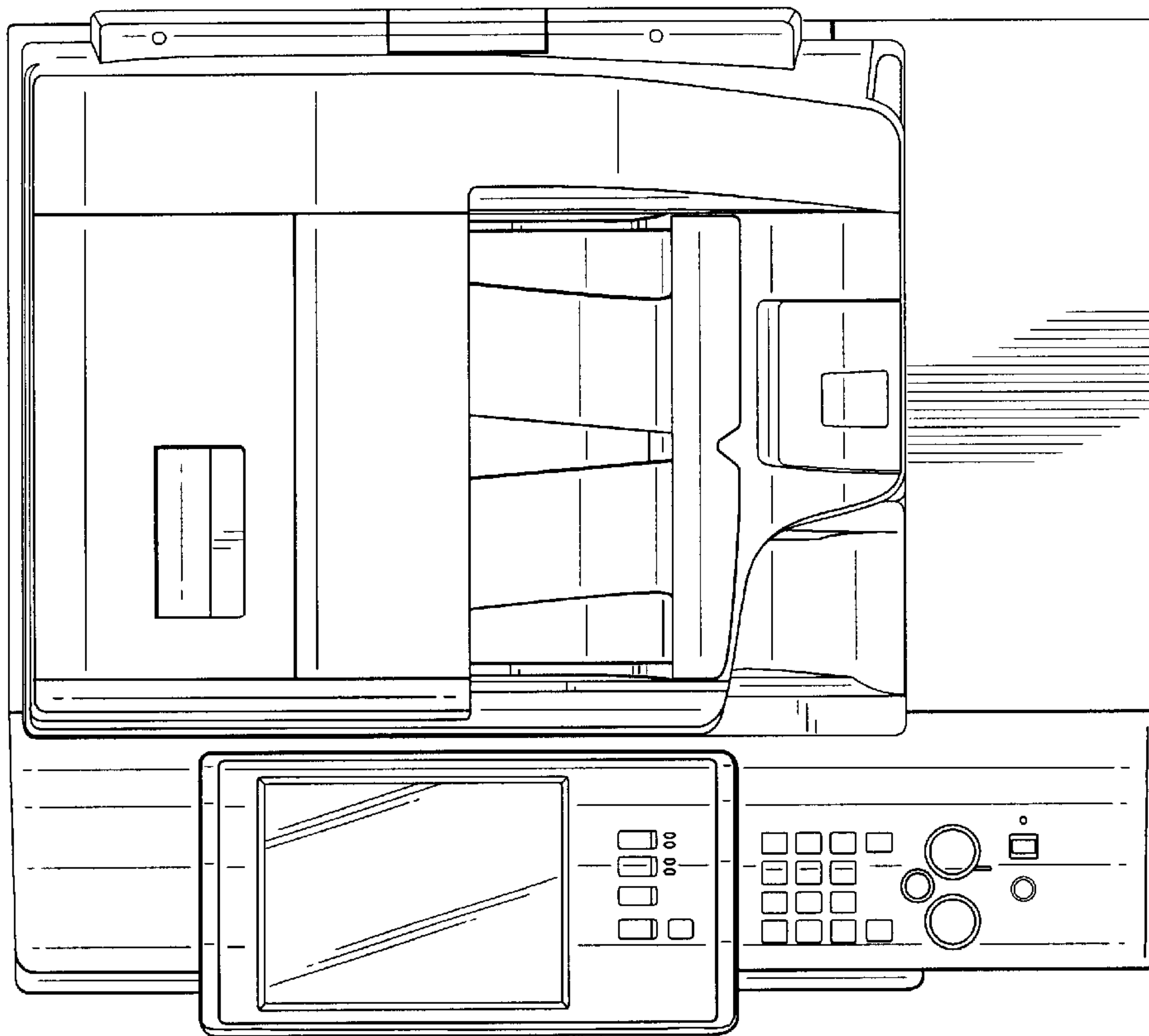

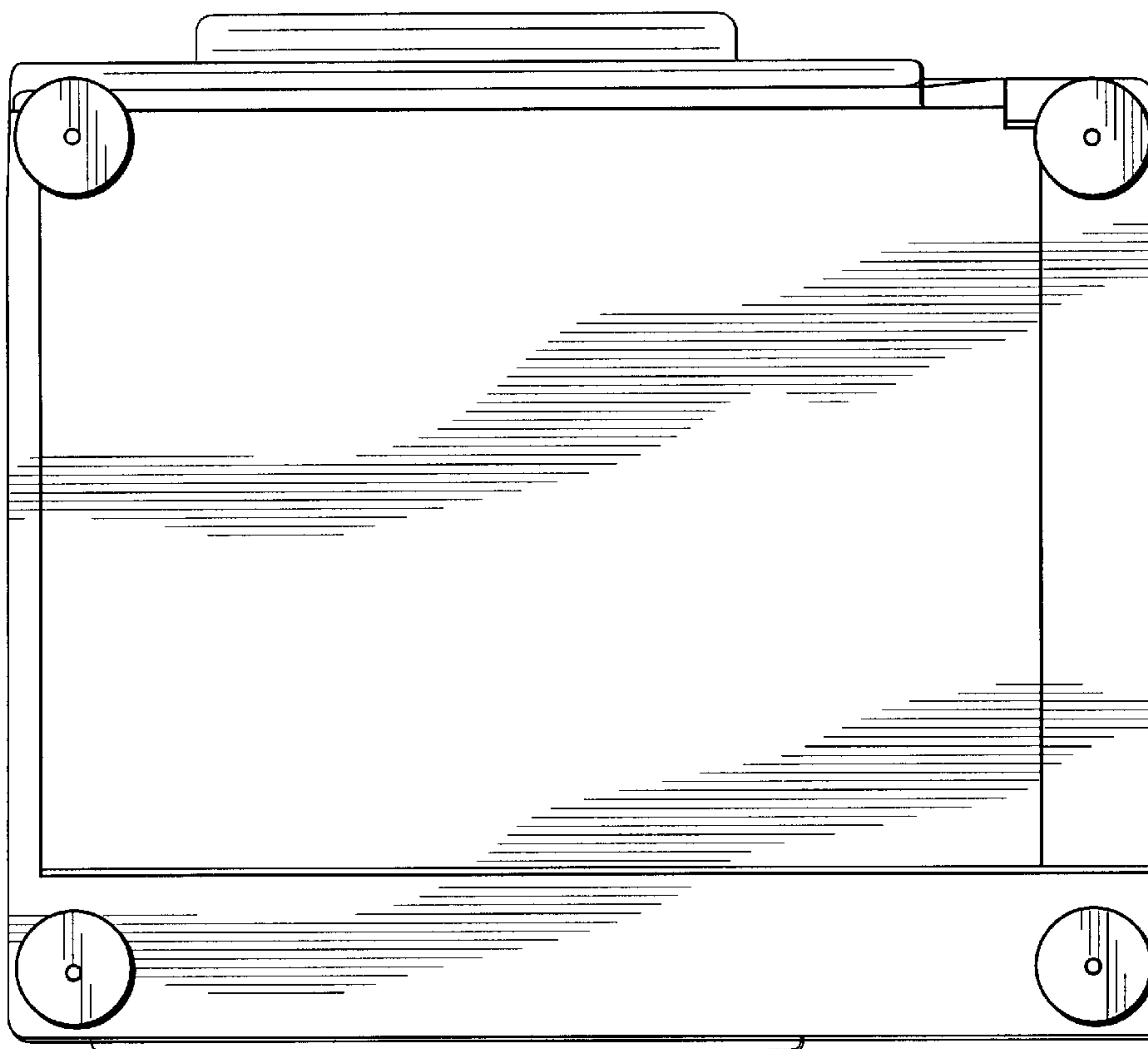

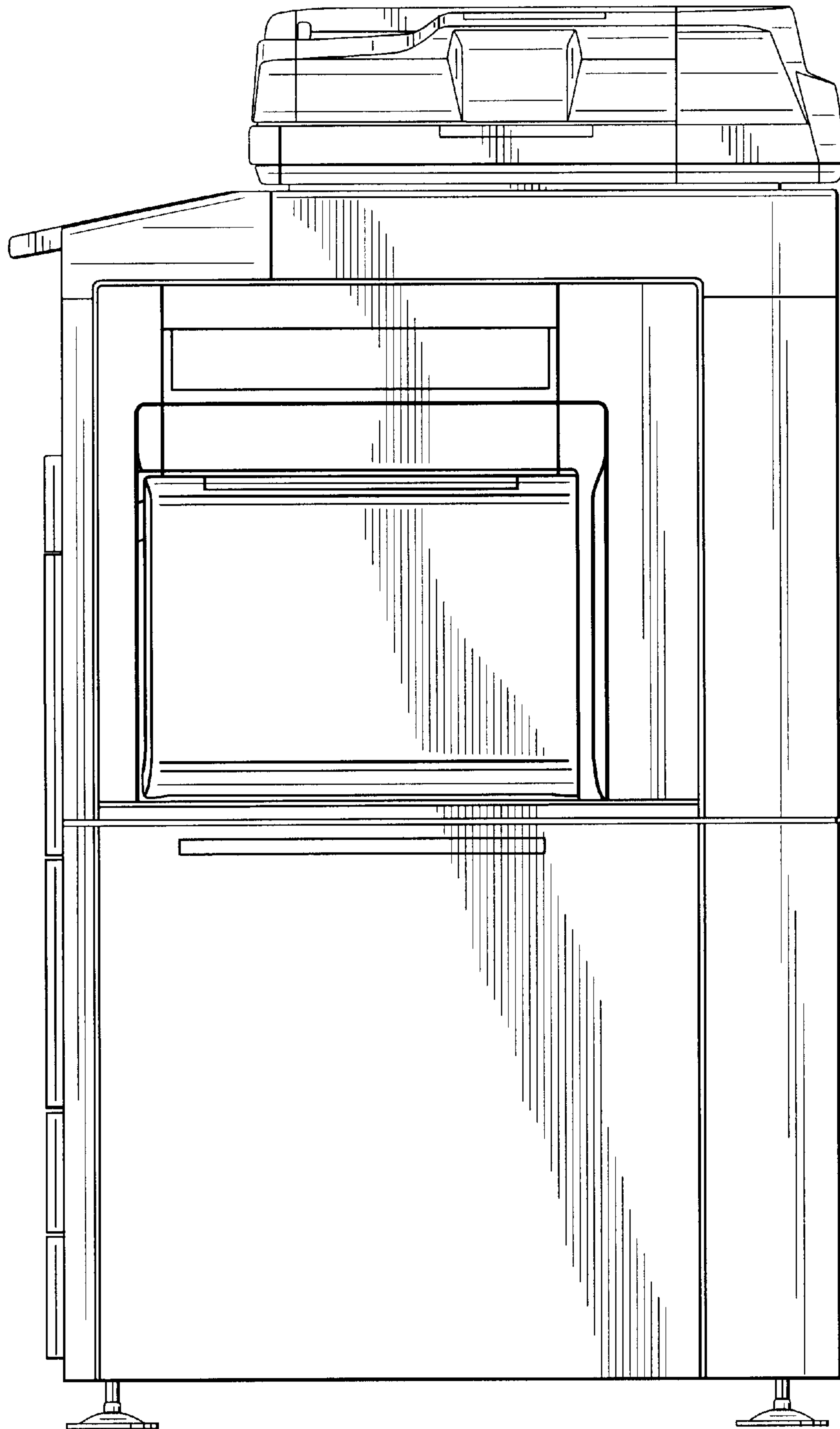

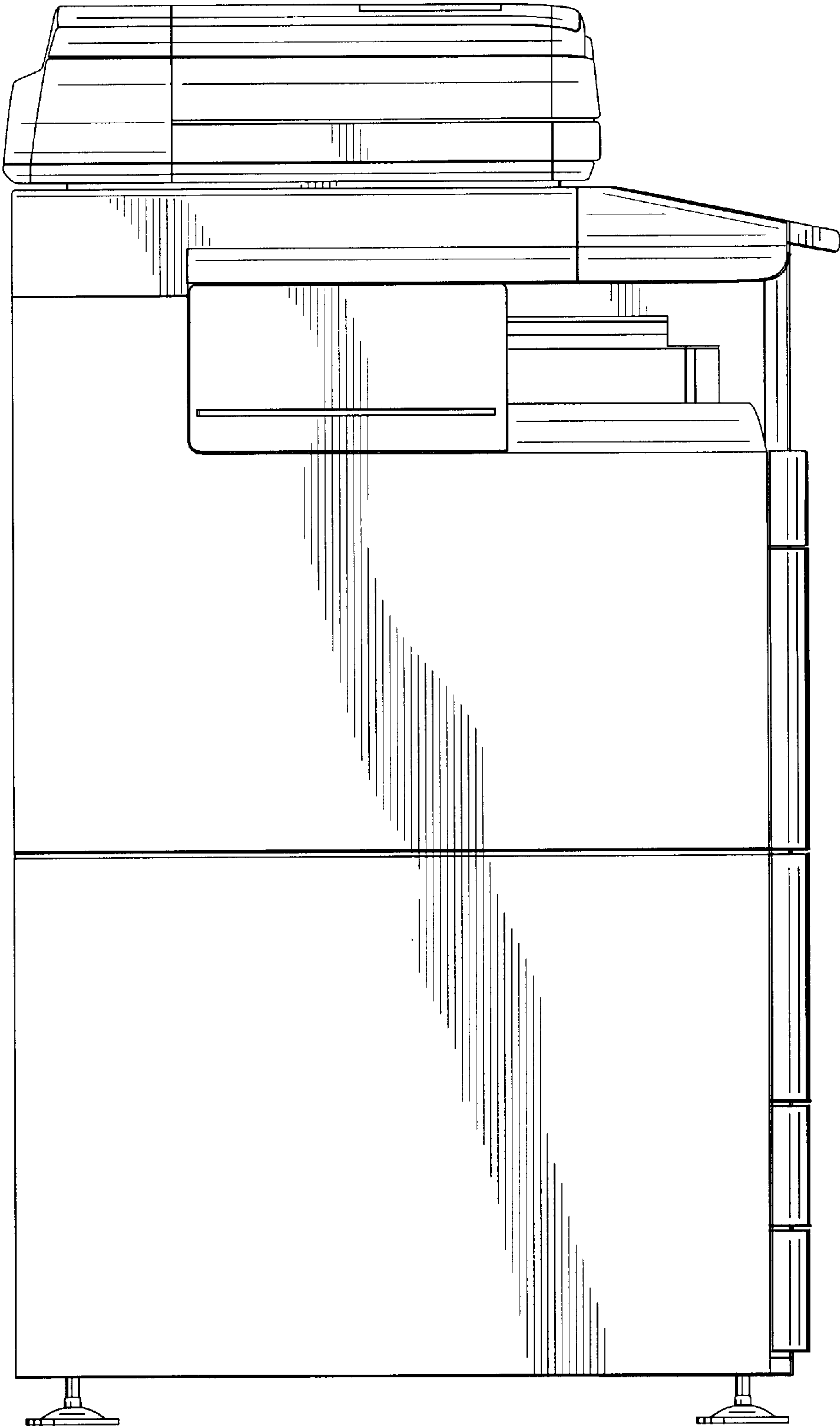
