**DESCRIPTION**

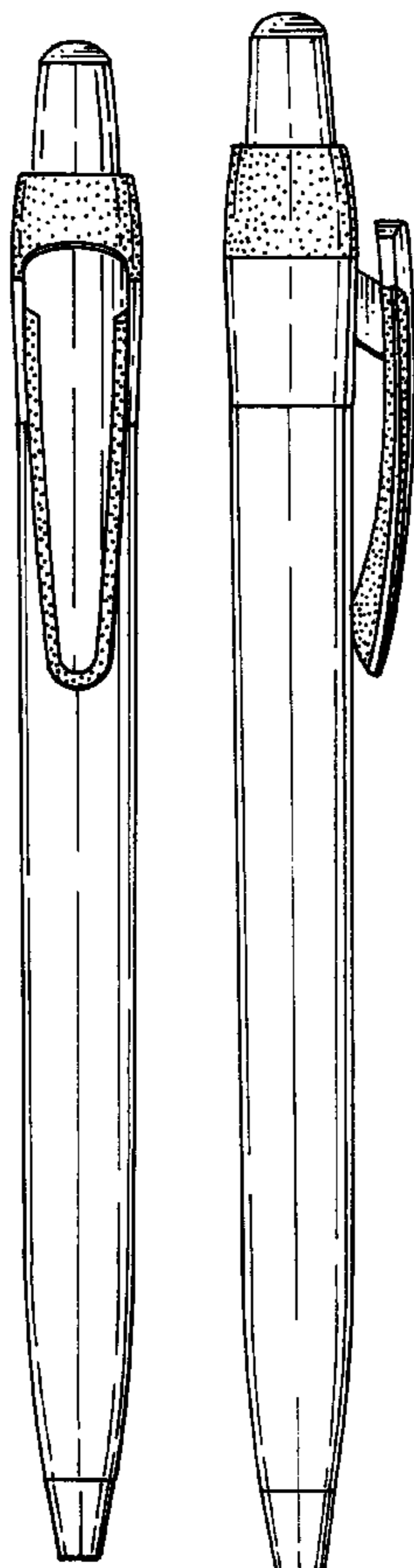
FIG. 1 is a perspective view of a top press retractable pen in accordance with the new design;

 The stipple shading shown in the drawings represents a surface texture.

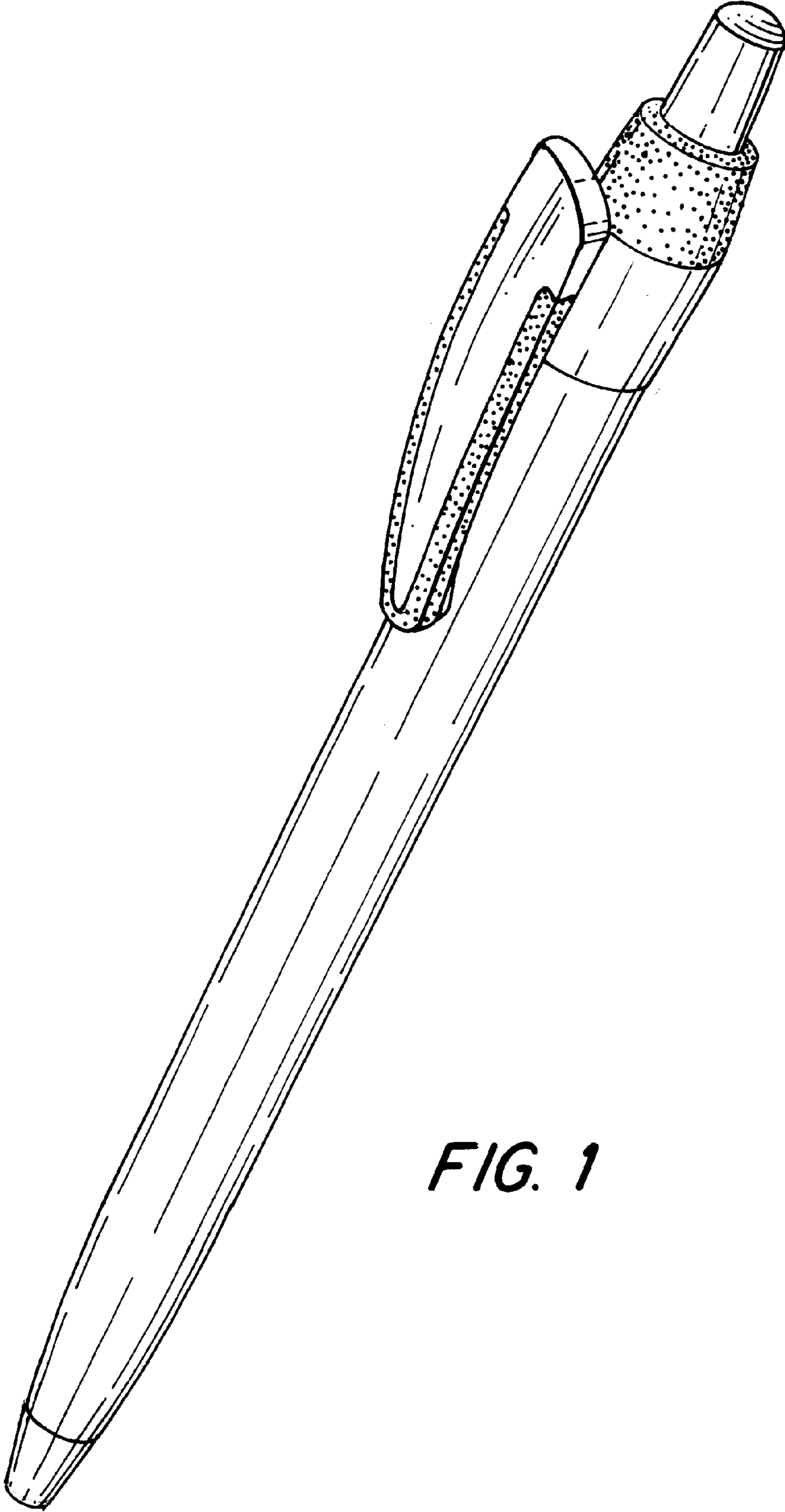

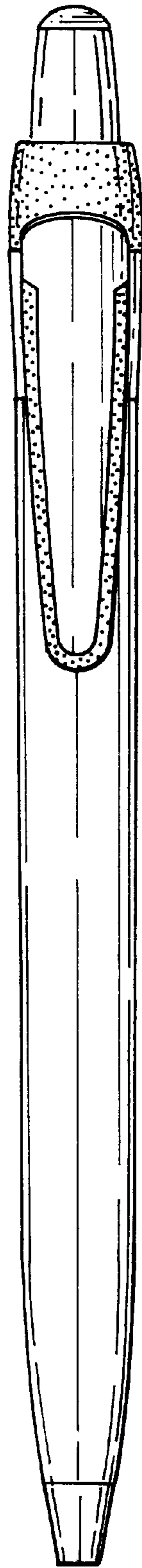

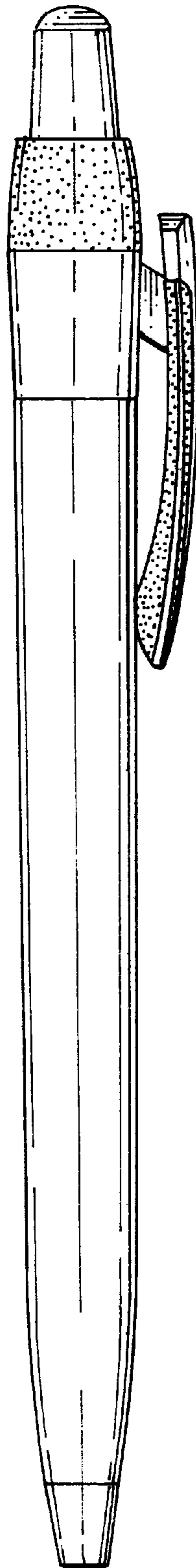




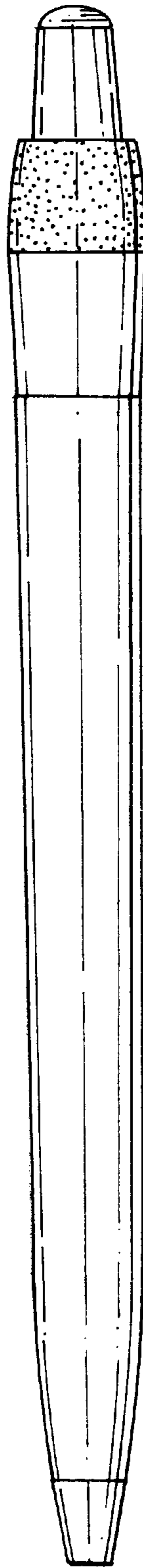

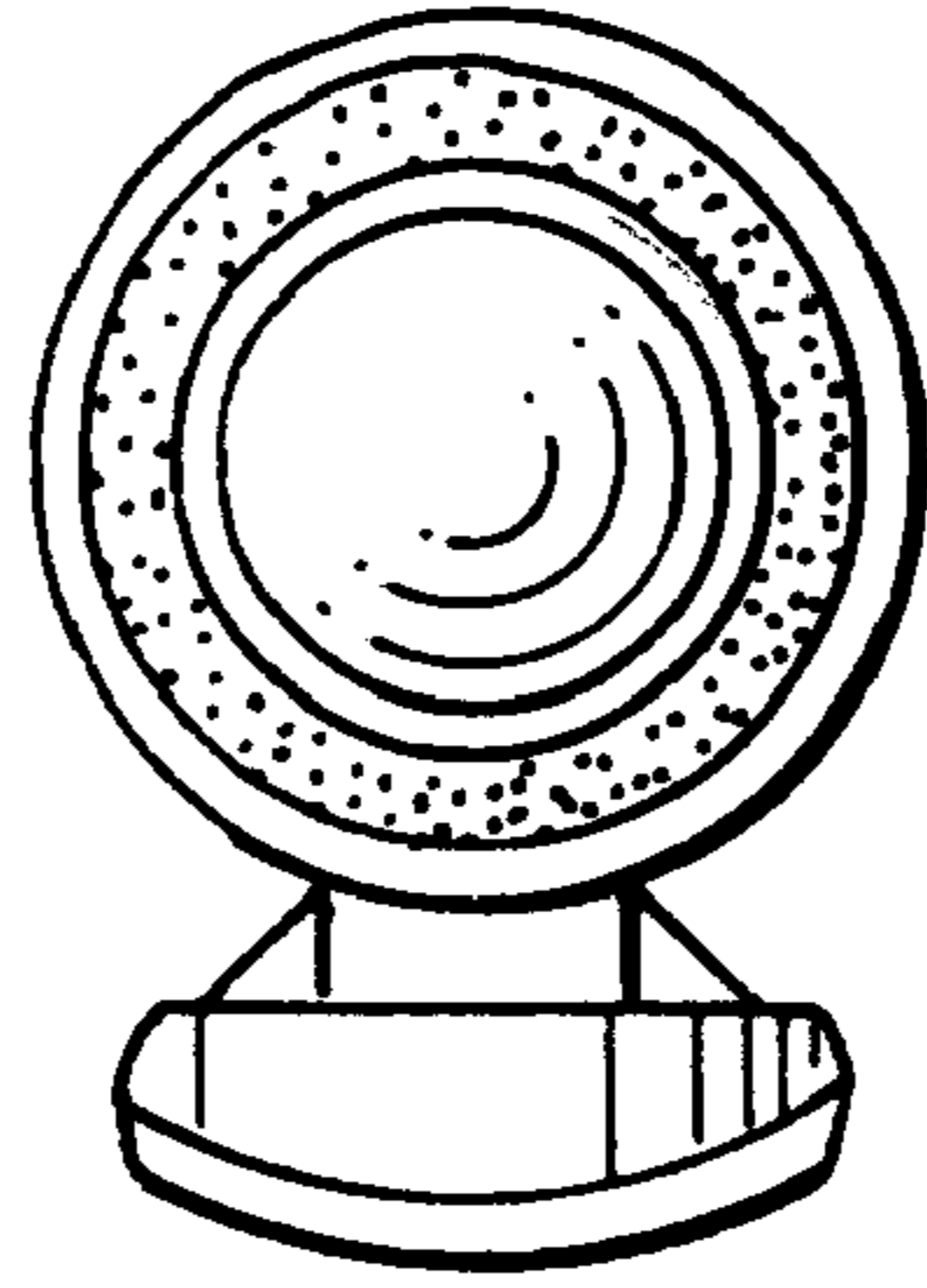

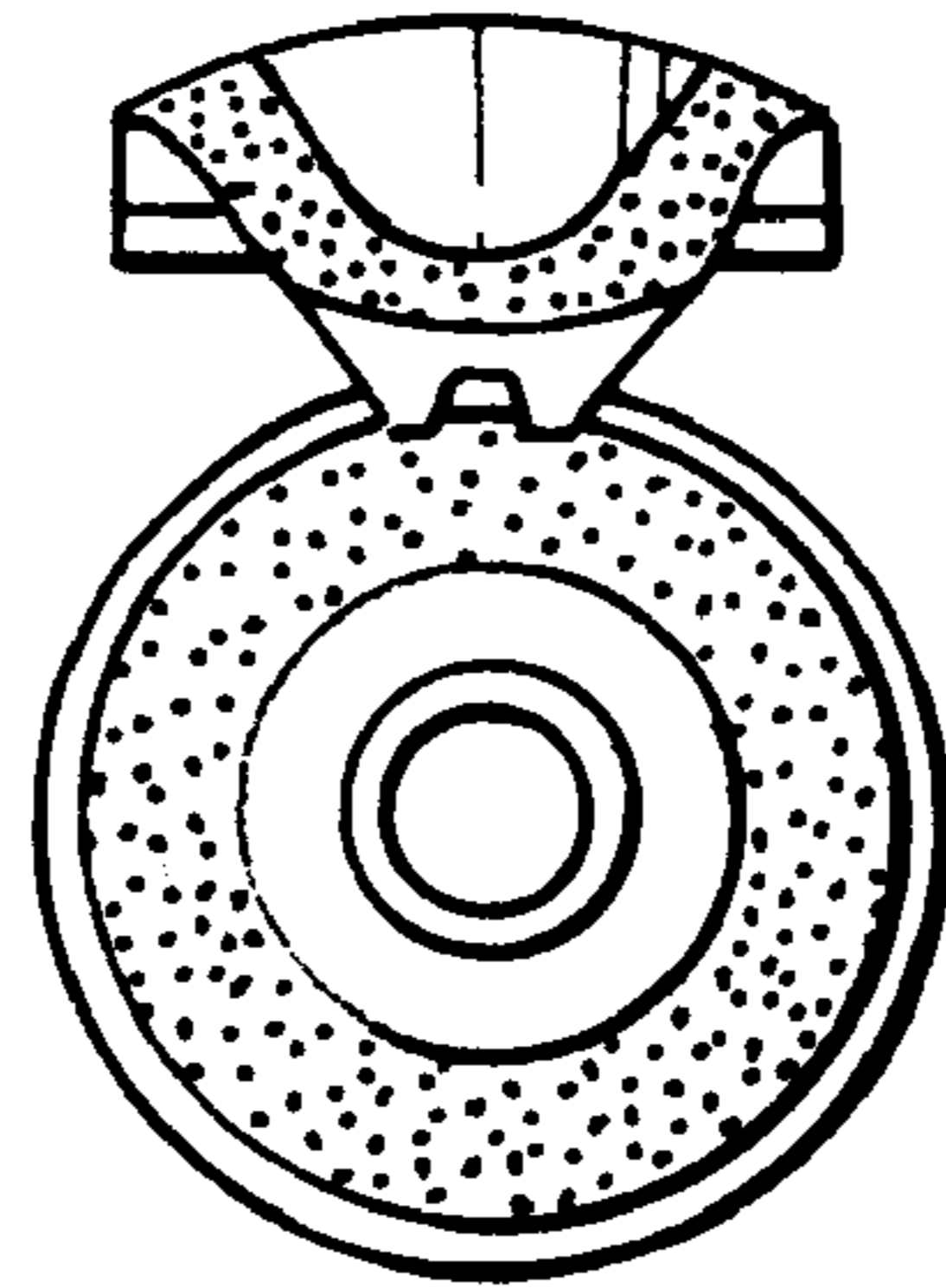
