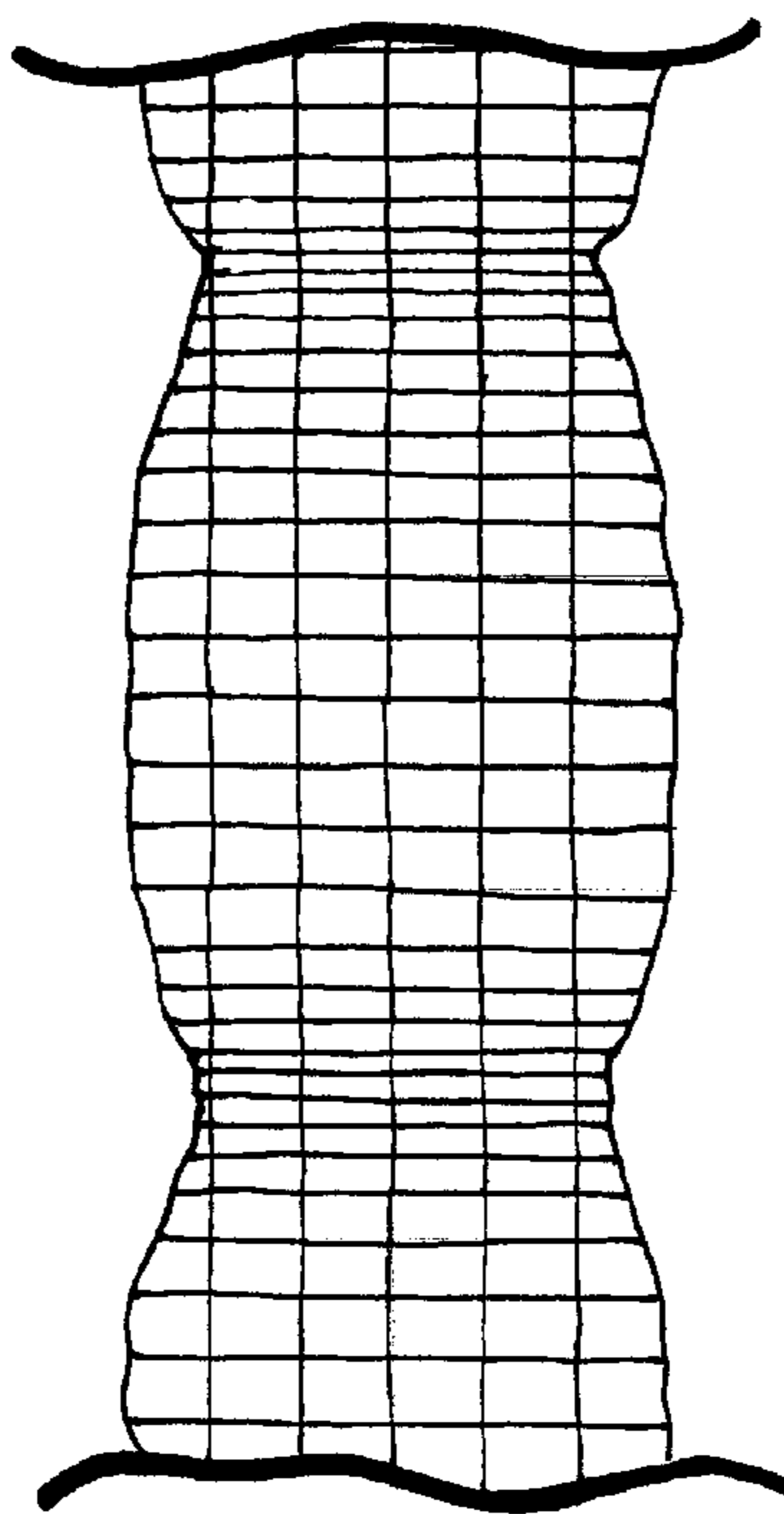
(57) **CLAIM**

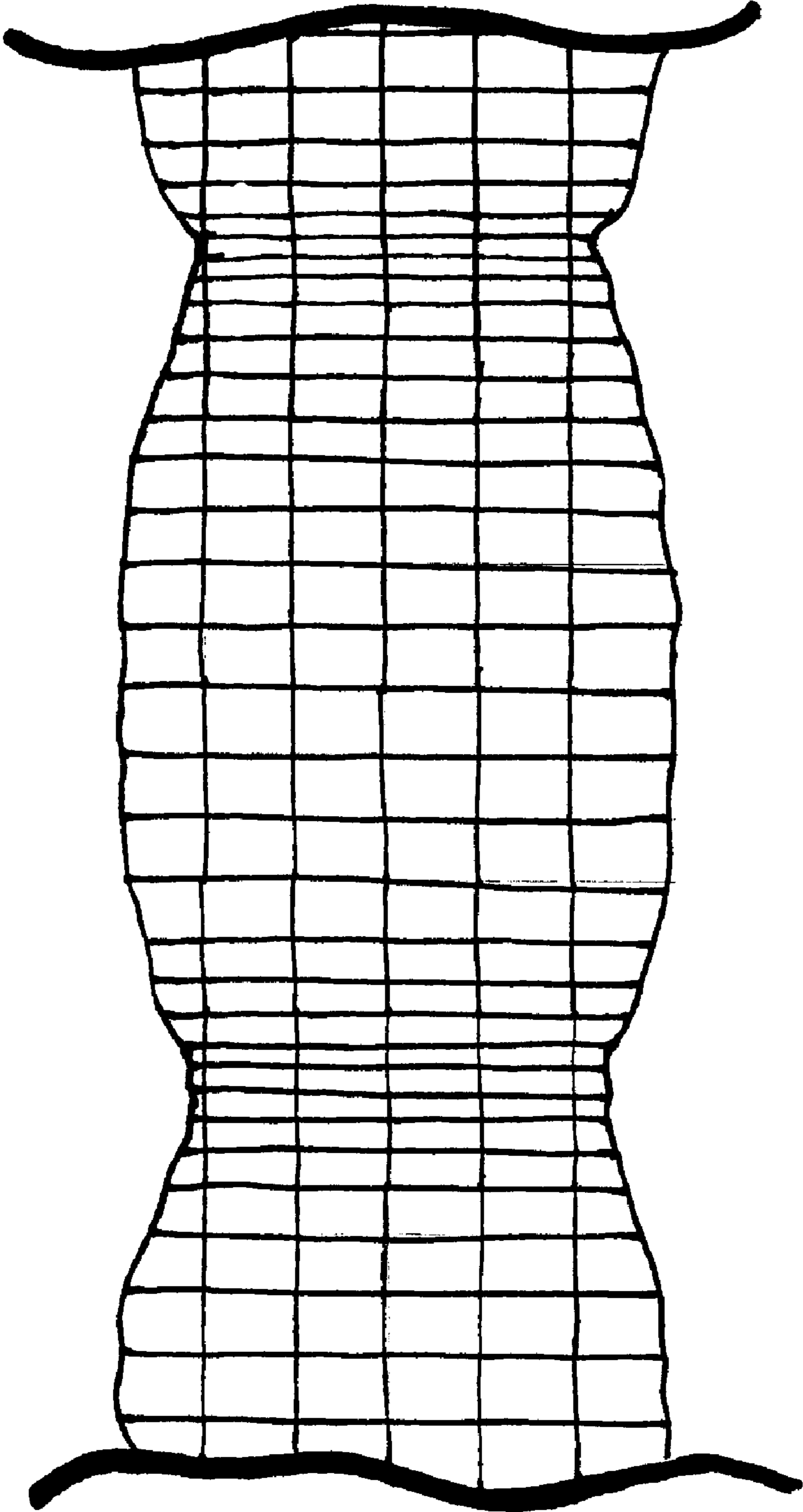
We claim the ornamental design for food casing, as shown and described.
