DESCRIPTION

FIG. 1 is a perspective view of the top, front and right side of a shoe showing my new design;
FIG. 2 is a front elevational view thereof;

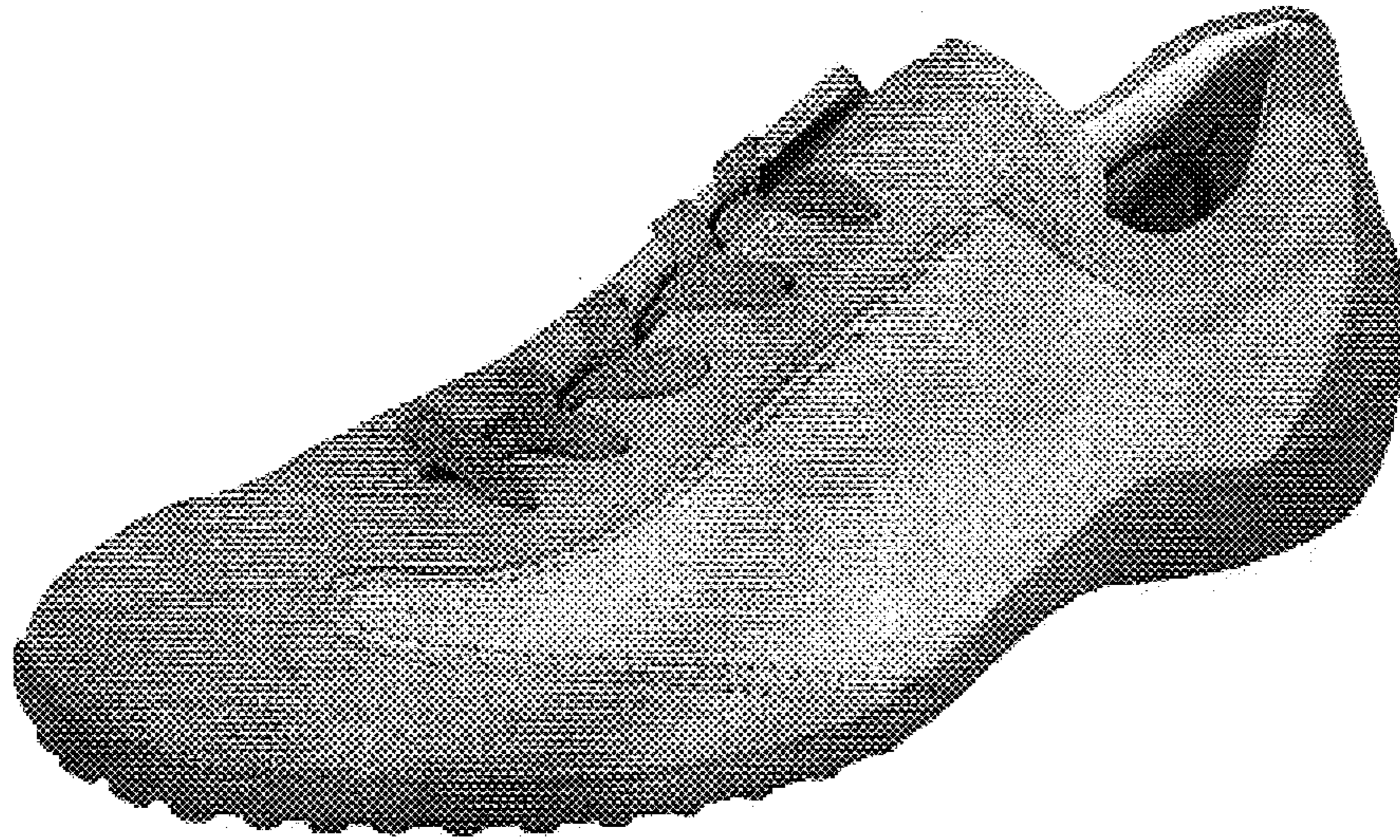

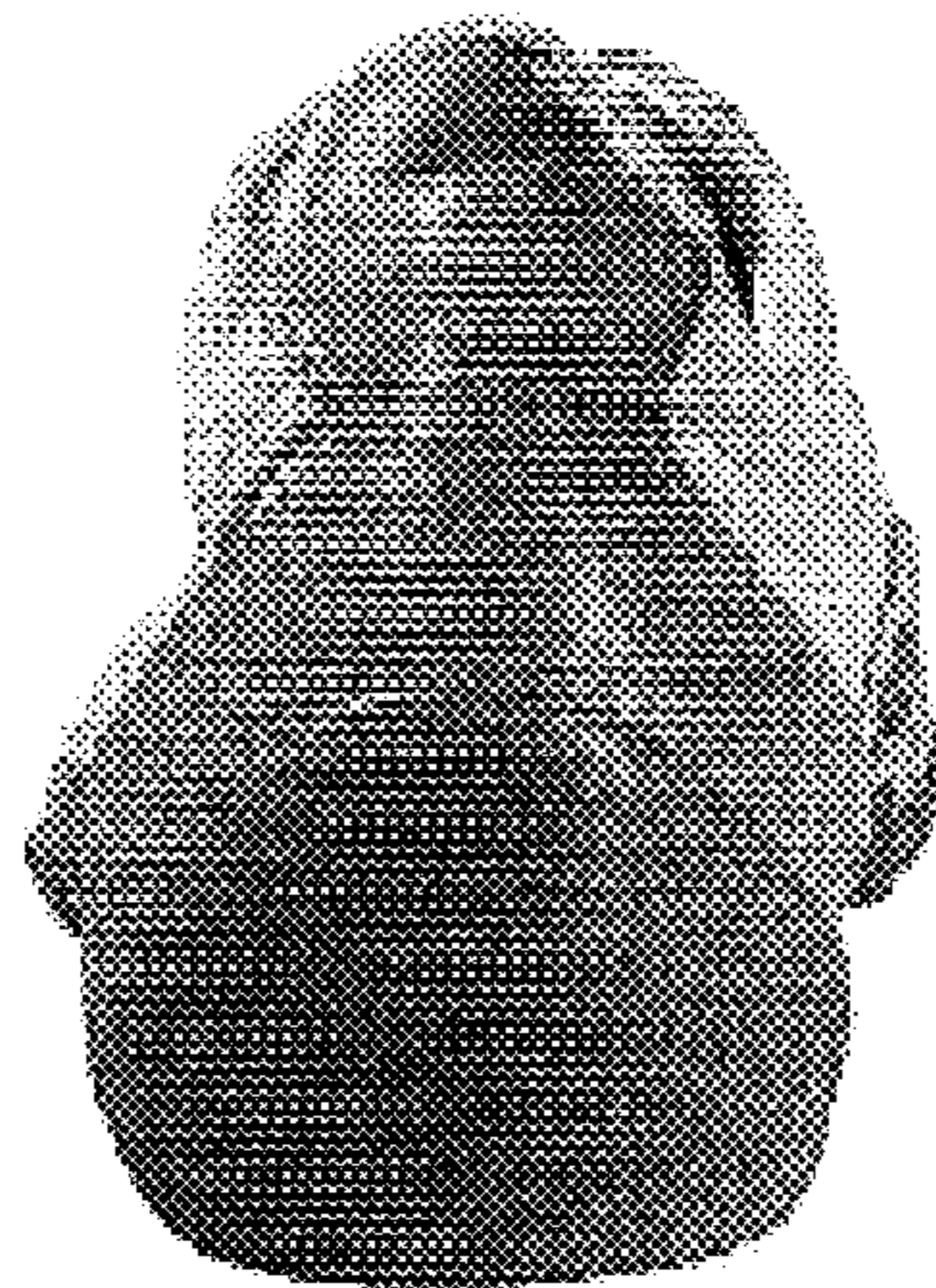

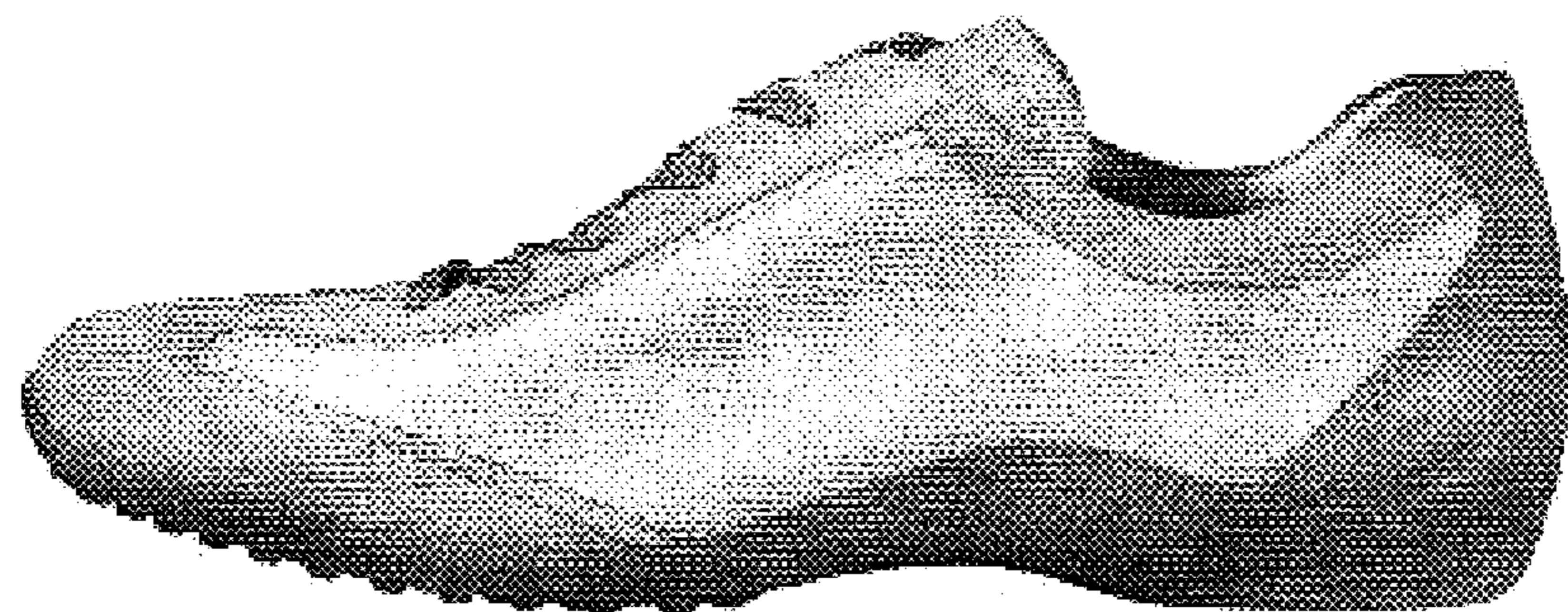

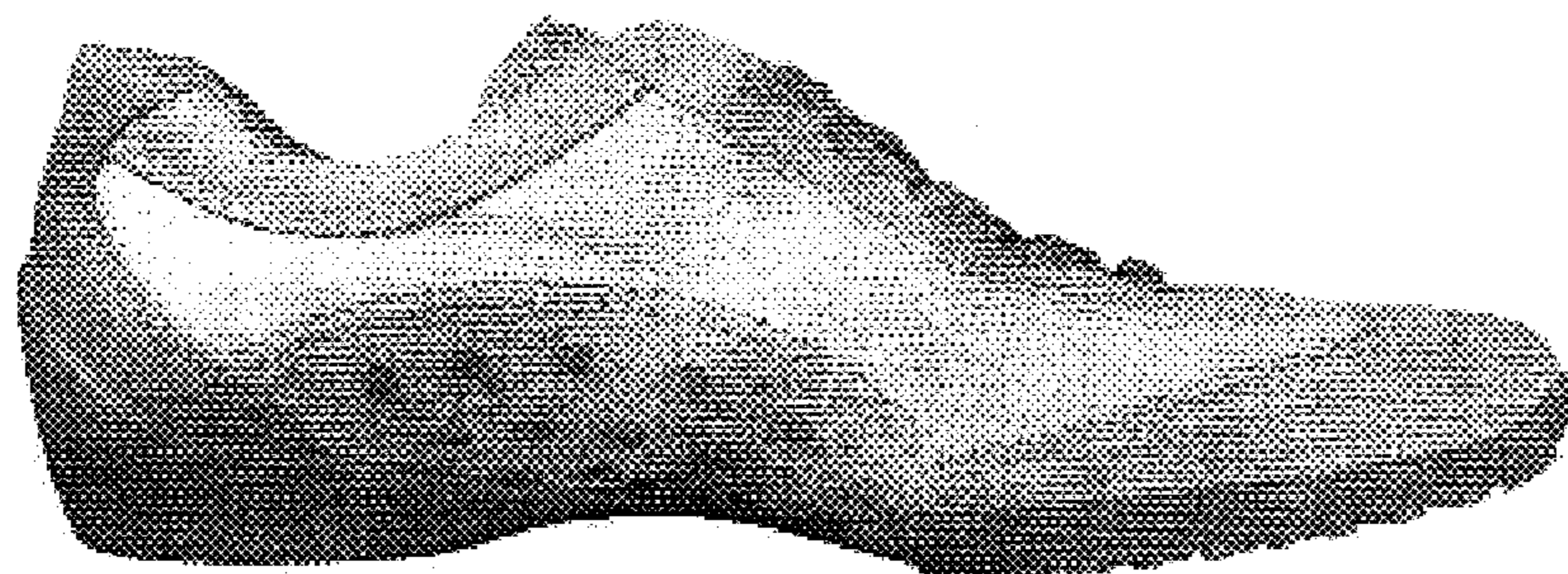

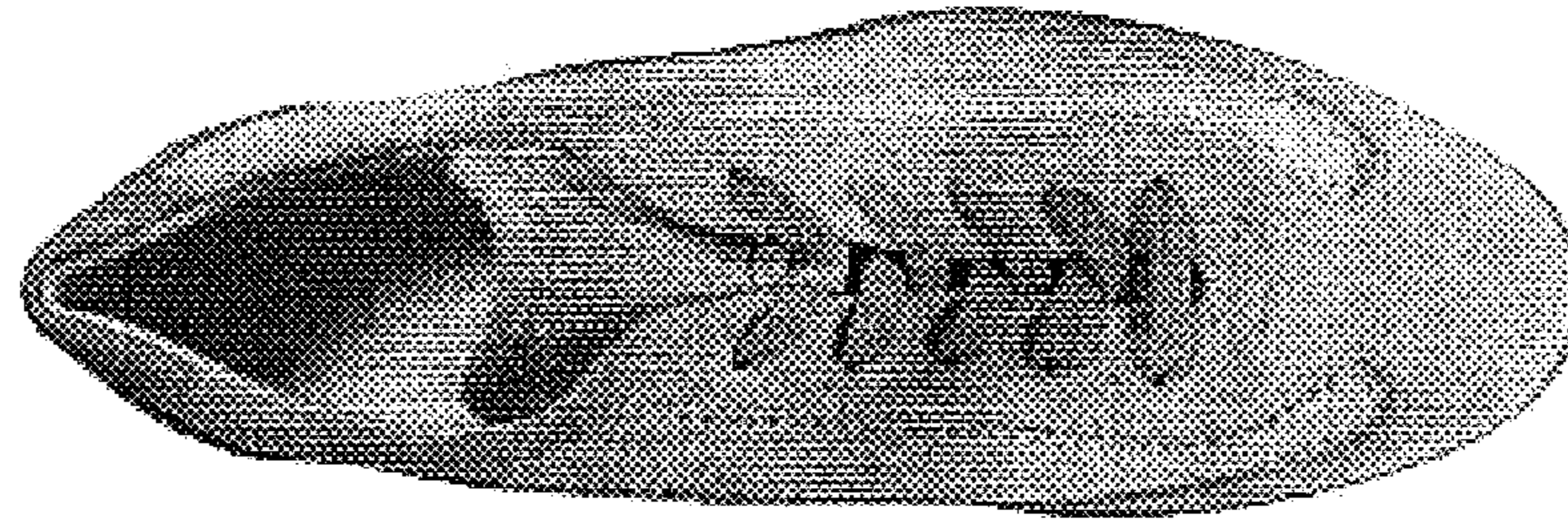

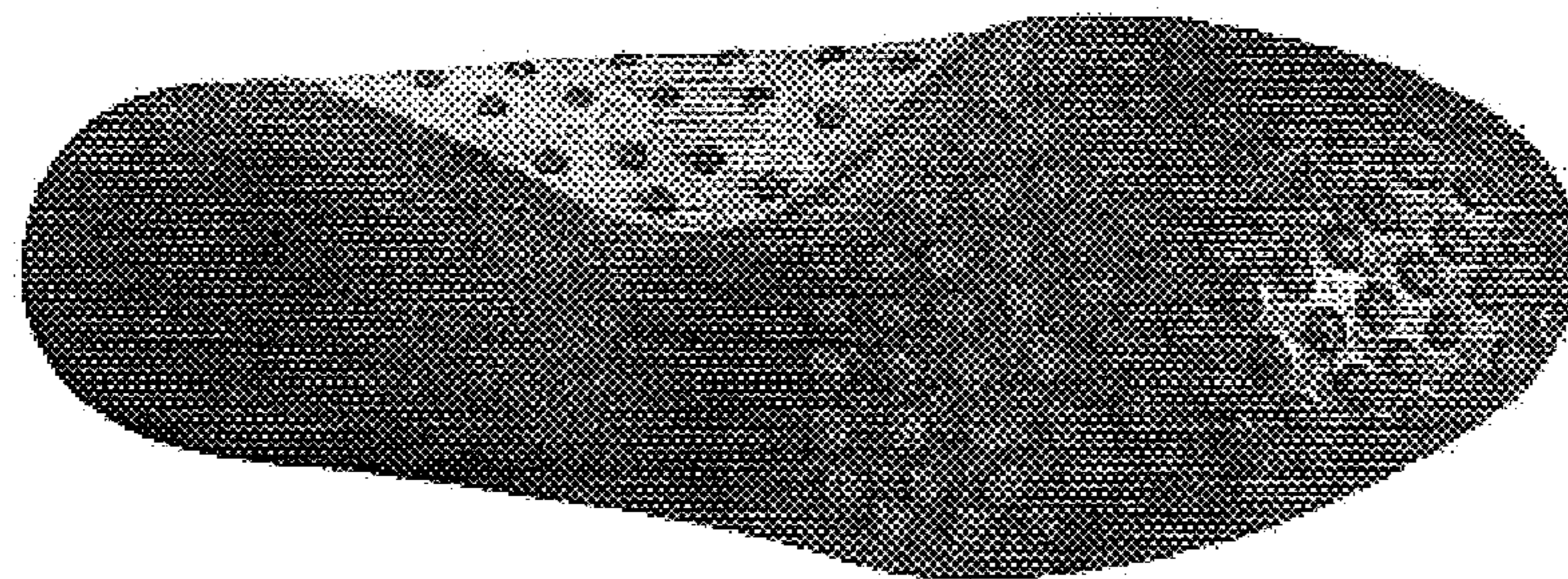
