The ornamental design for footwear upper, as shown and
described.

DESCRIPTION

FIG. 1 is a perspective view of the footwear upper embody-
ing the new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a right side view thereof;

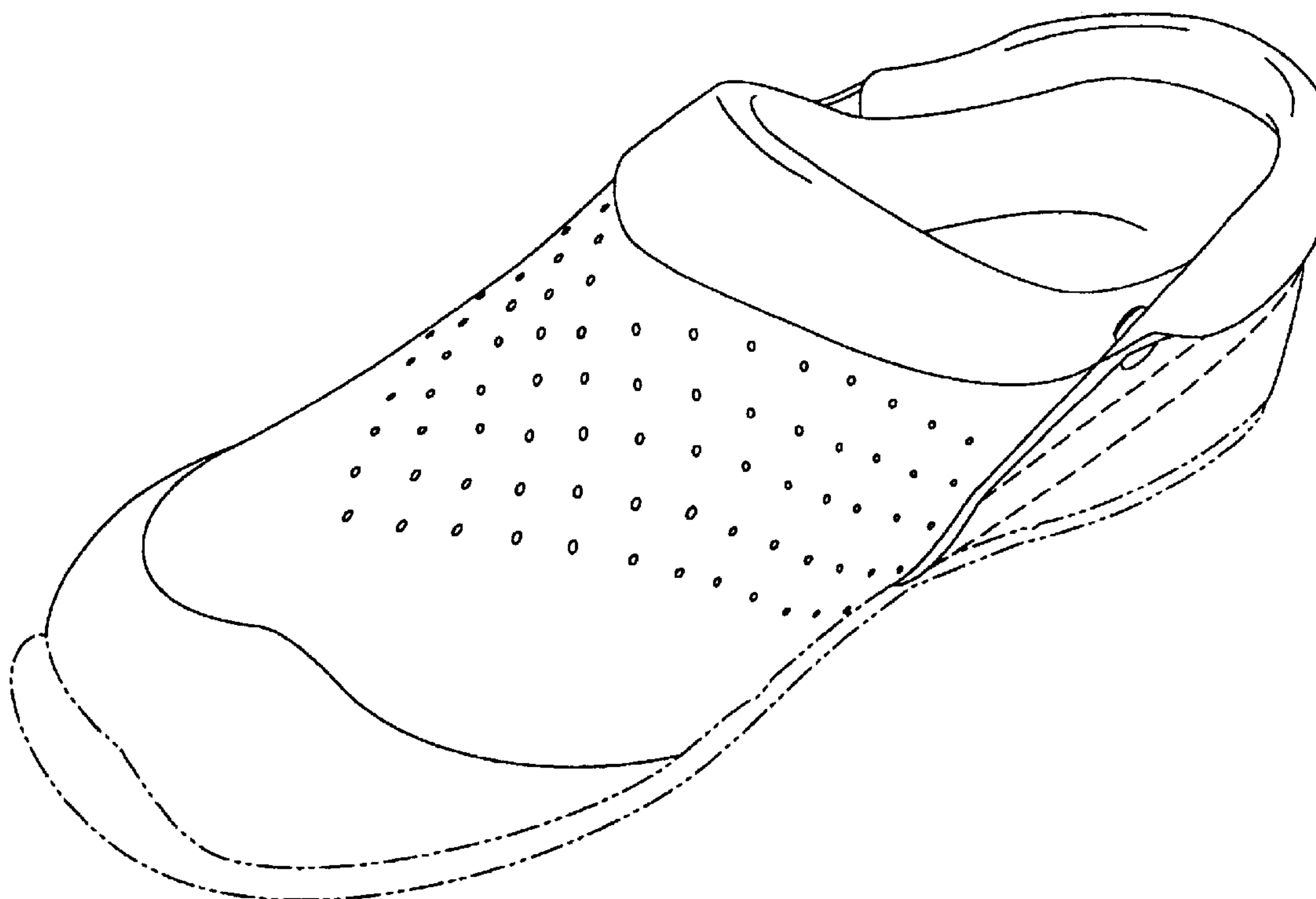
FIG. 4 is a left side view thereof;

FIG. 5 is a front view thereof; and,

FIG. 6 is a rear view thereof.

FIGS. 1-6 show features of an article of footwear in
phantom lines. These features are shown for environmental

line portions of the design form the boundary of the design,
with the phantom lines forming no part of the claimed
design.

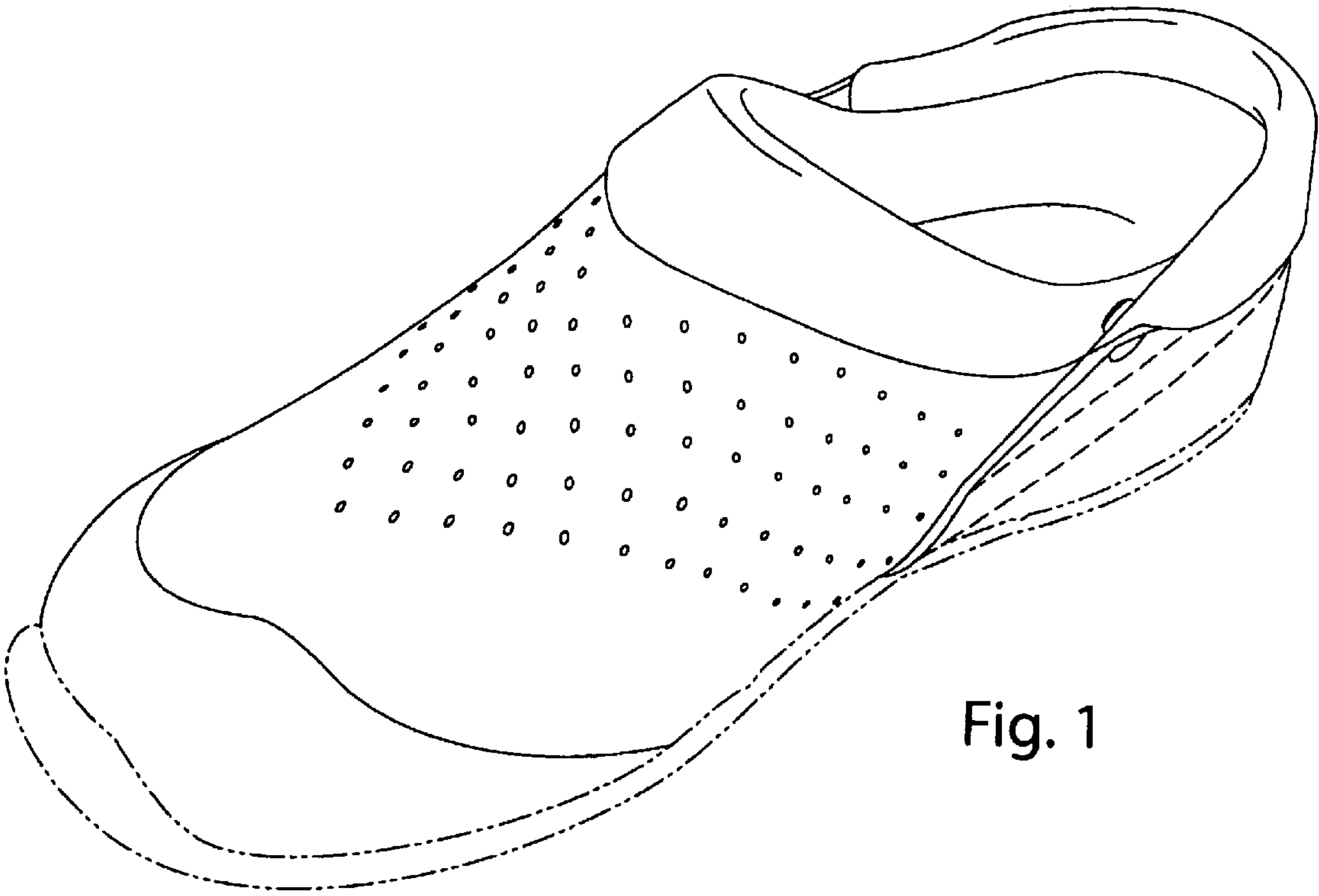

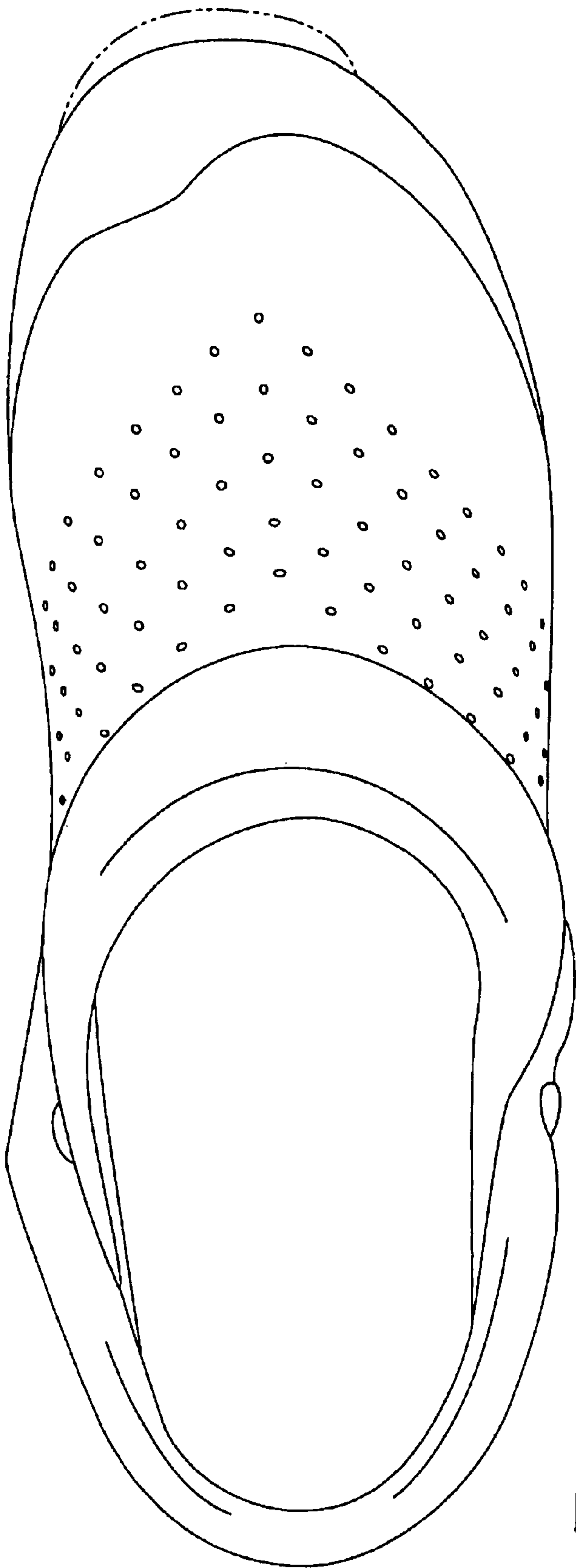

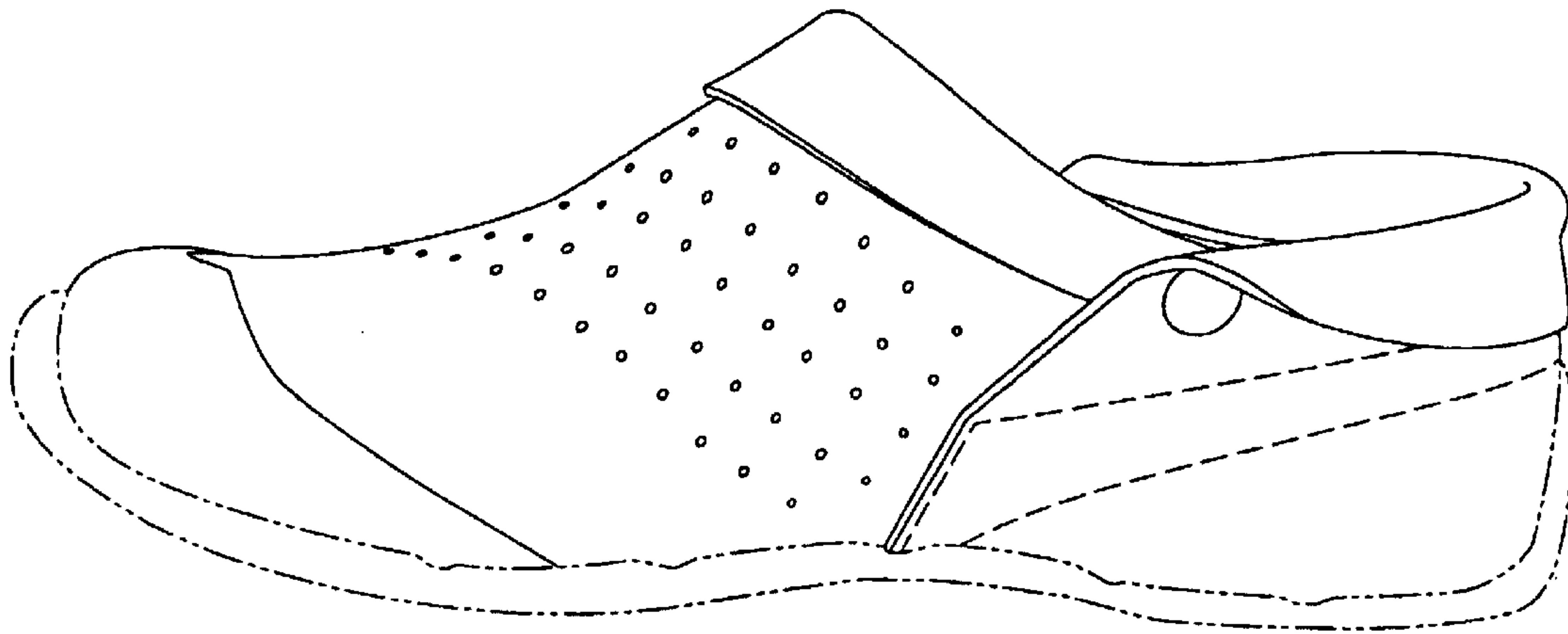

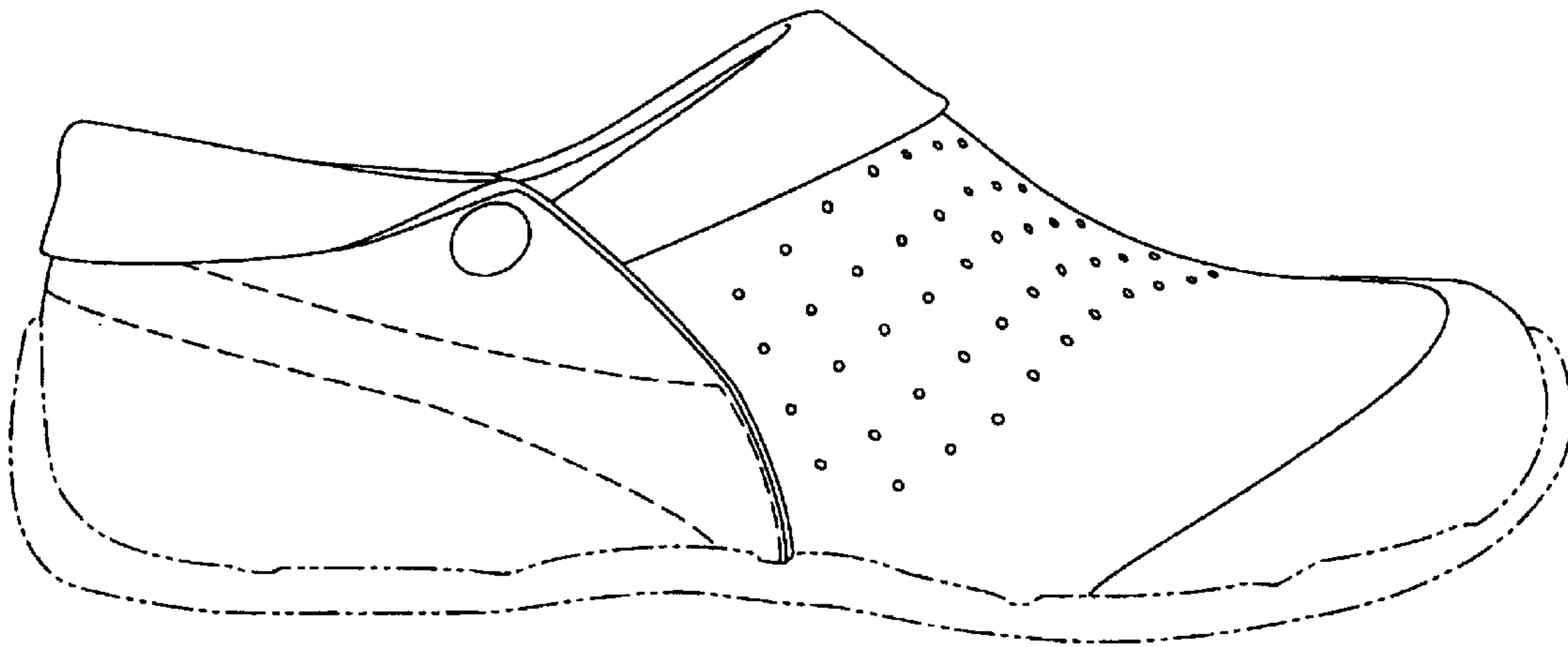

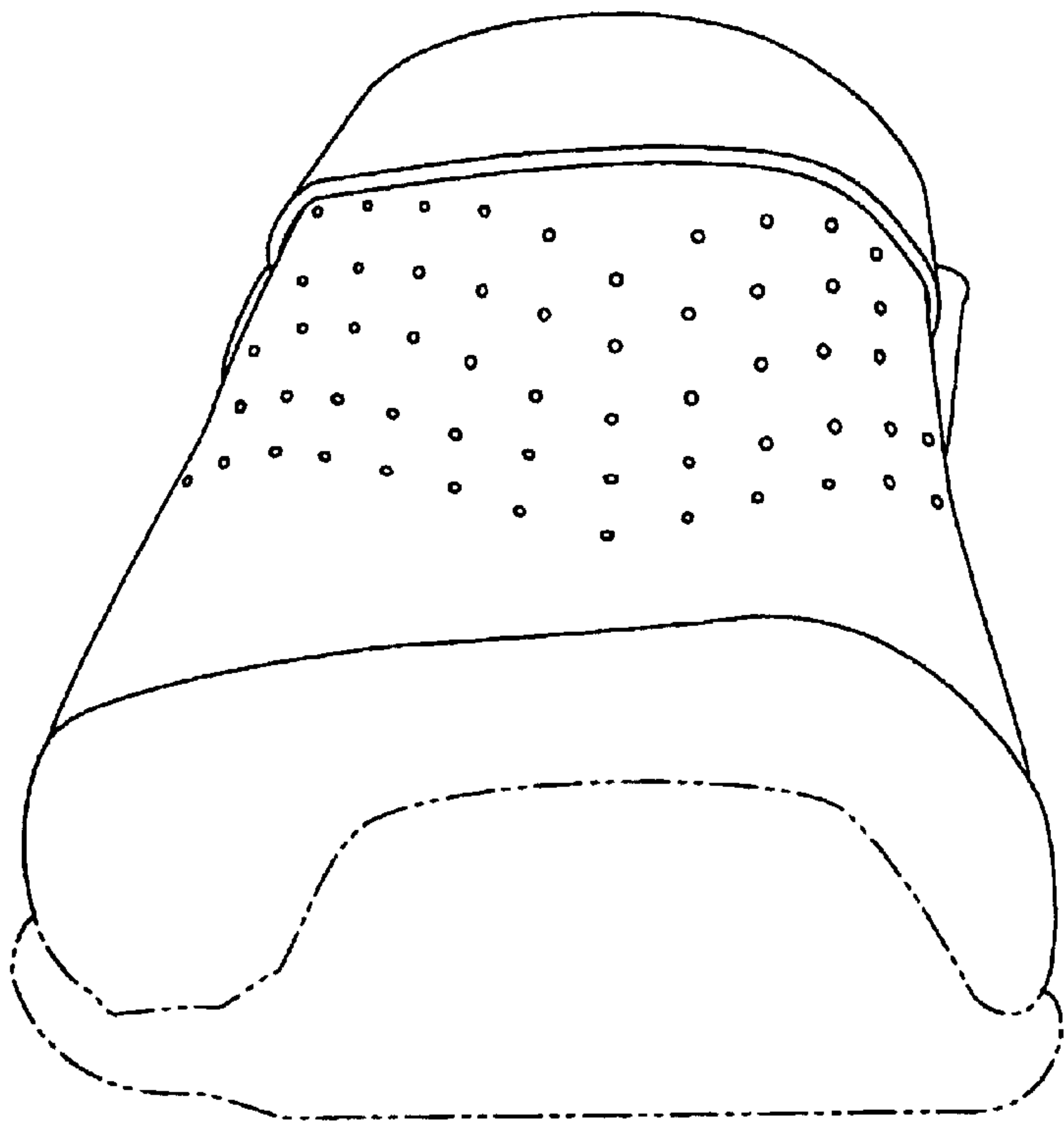

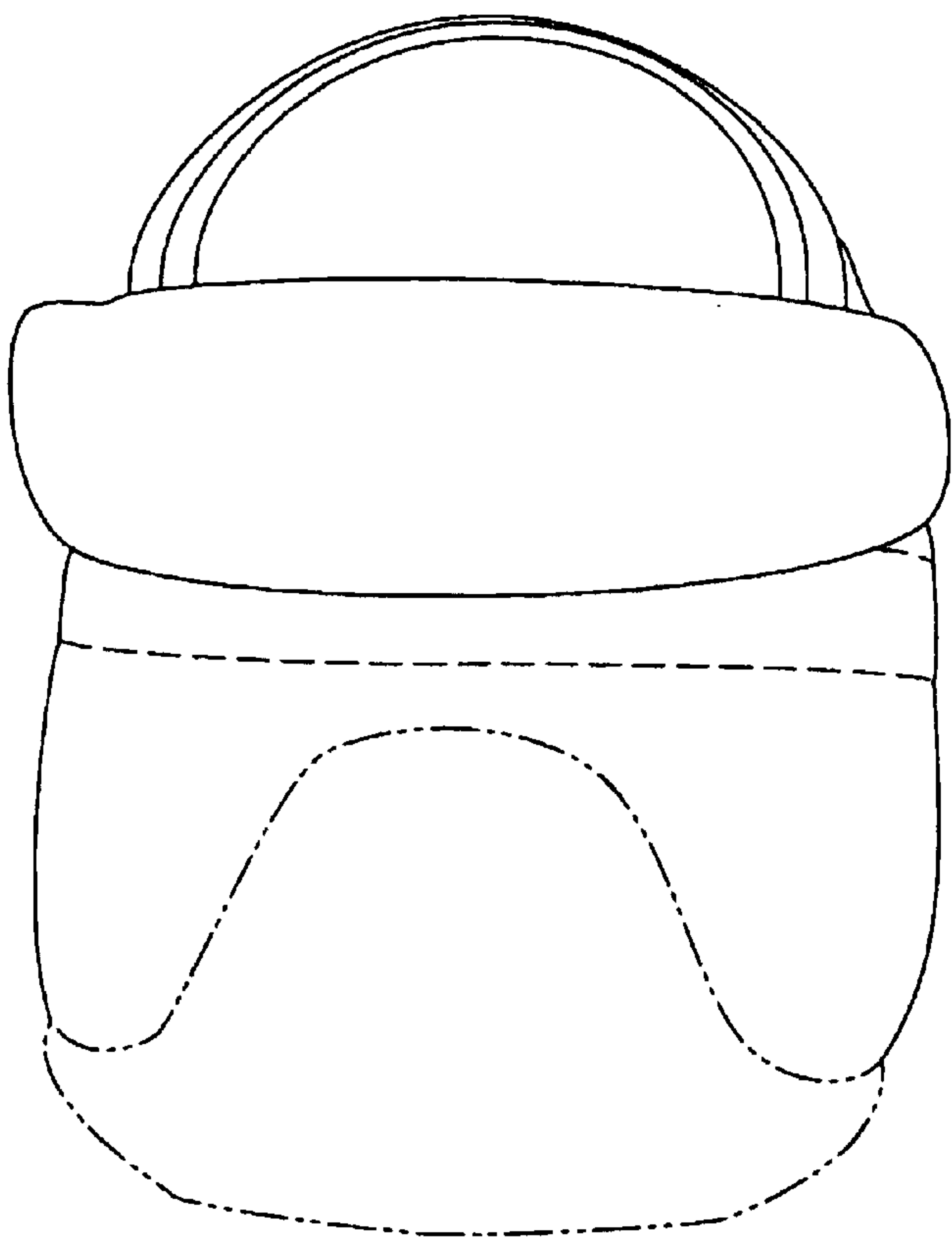
