DESCRIPTION

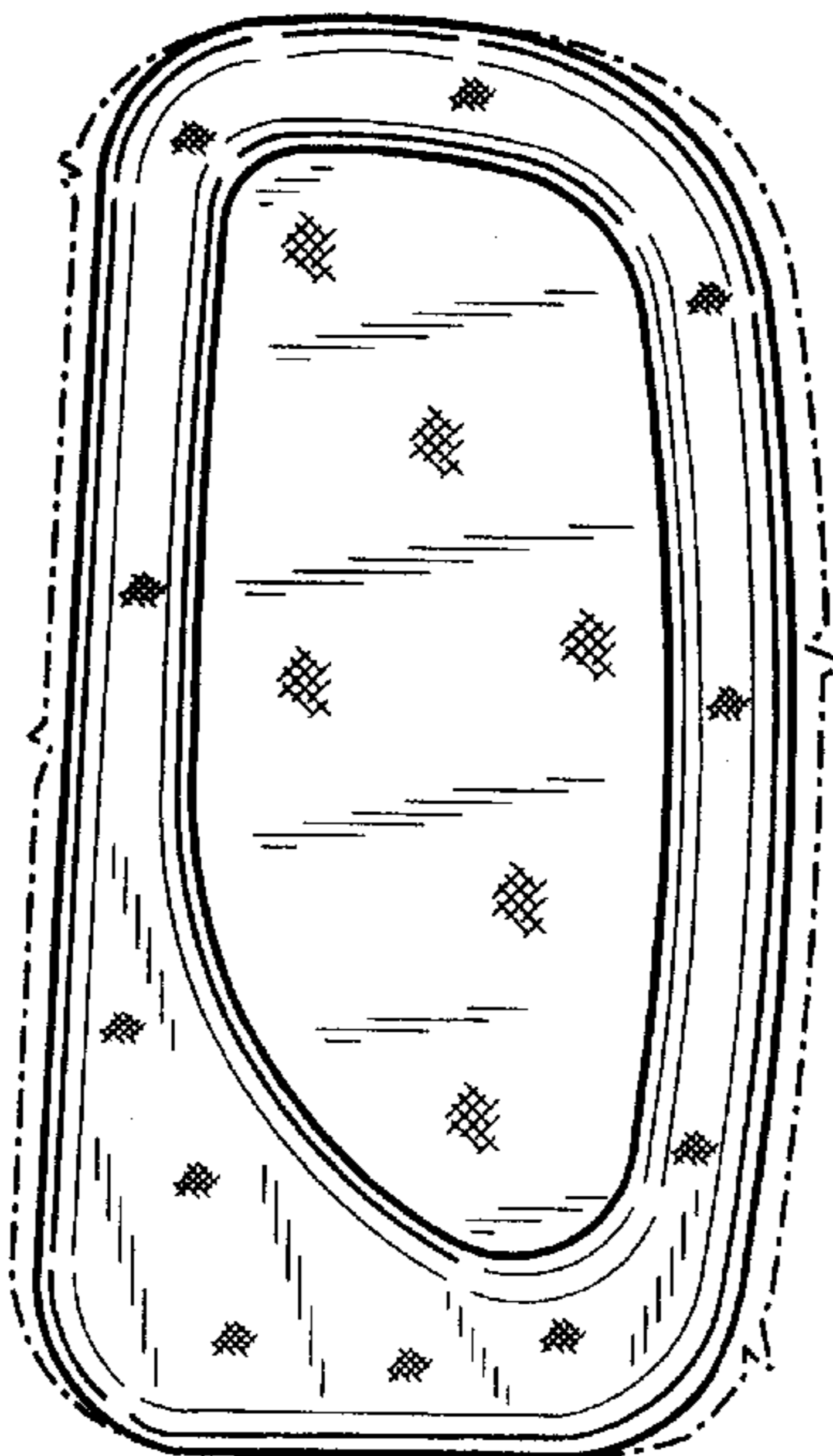

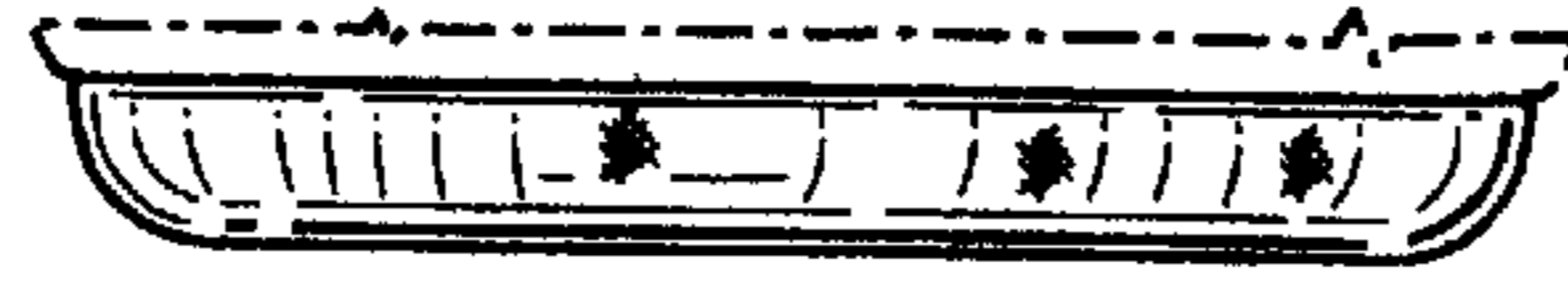

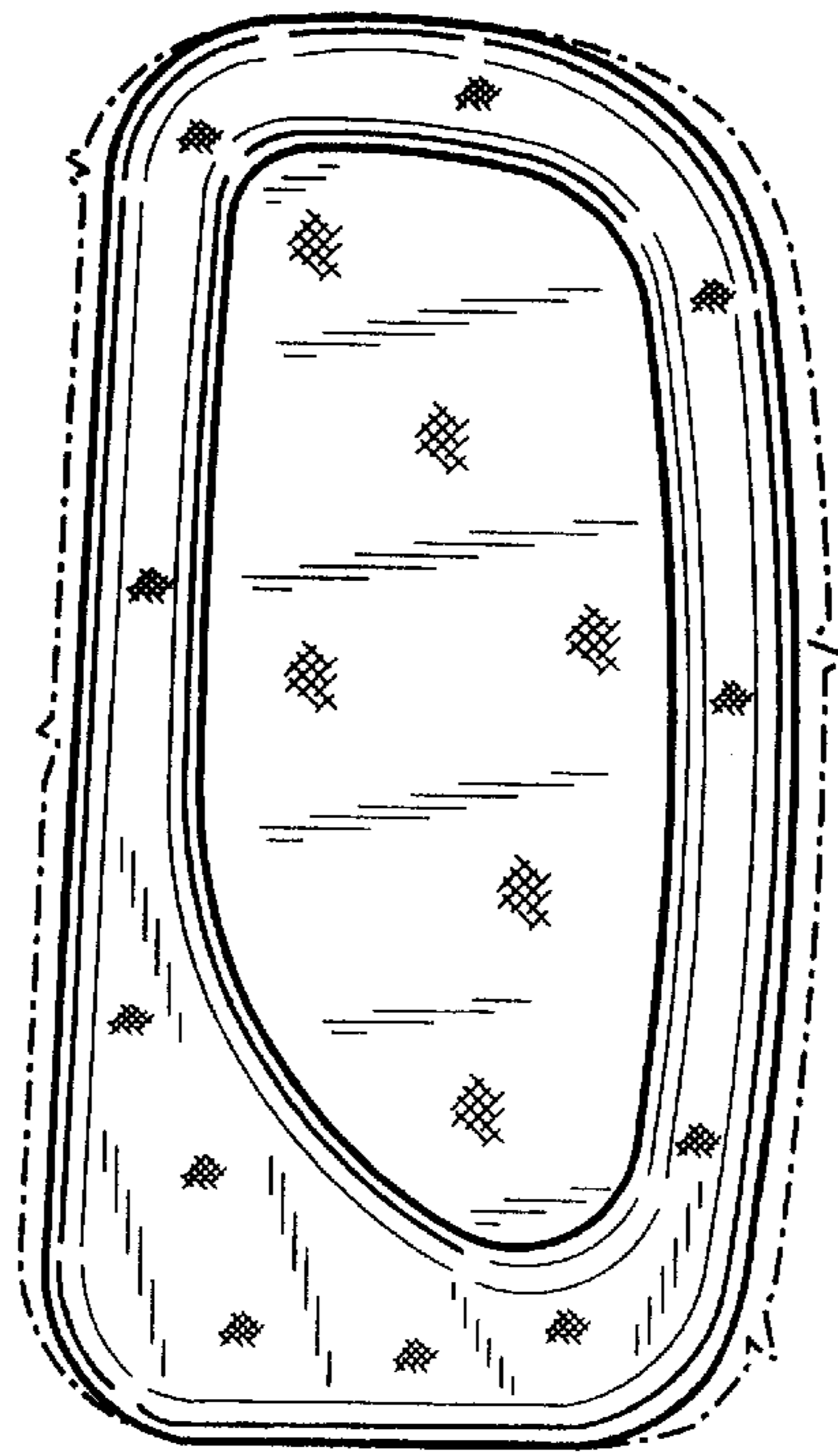

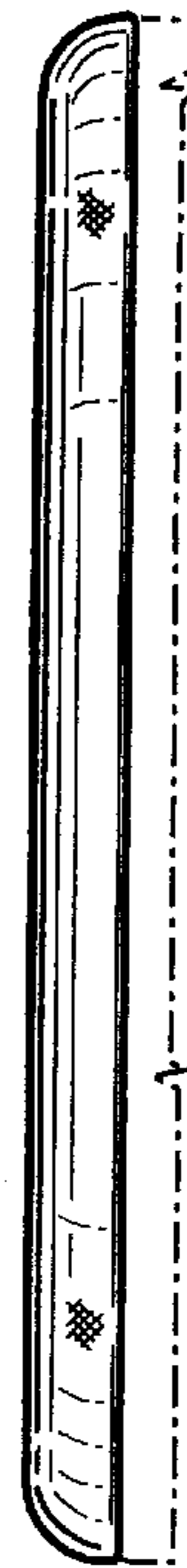

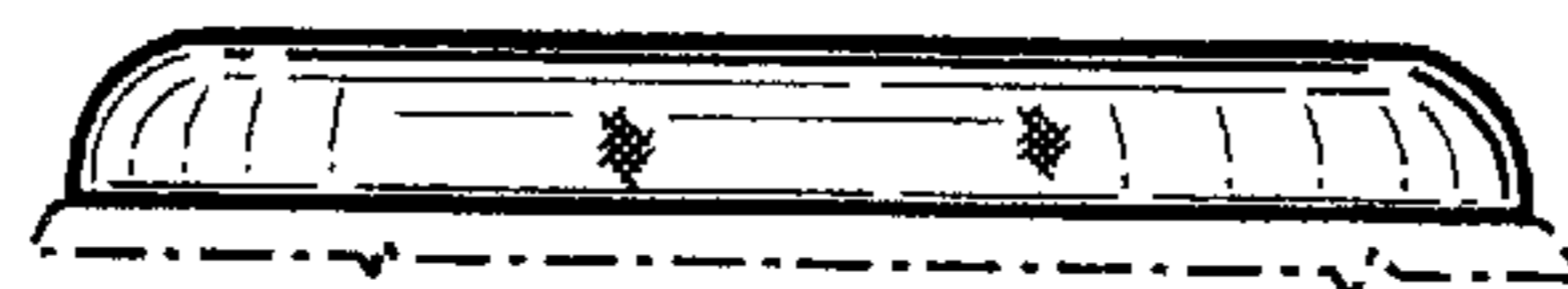
