(57) **CLAIM**

The ornamental design for a combined brush and bottle opener, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a combined brush and bottle opener showing my new design with the rear elevation being a mirror image thereof;

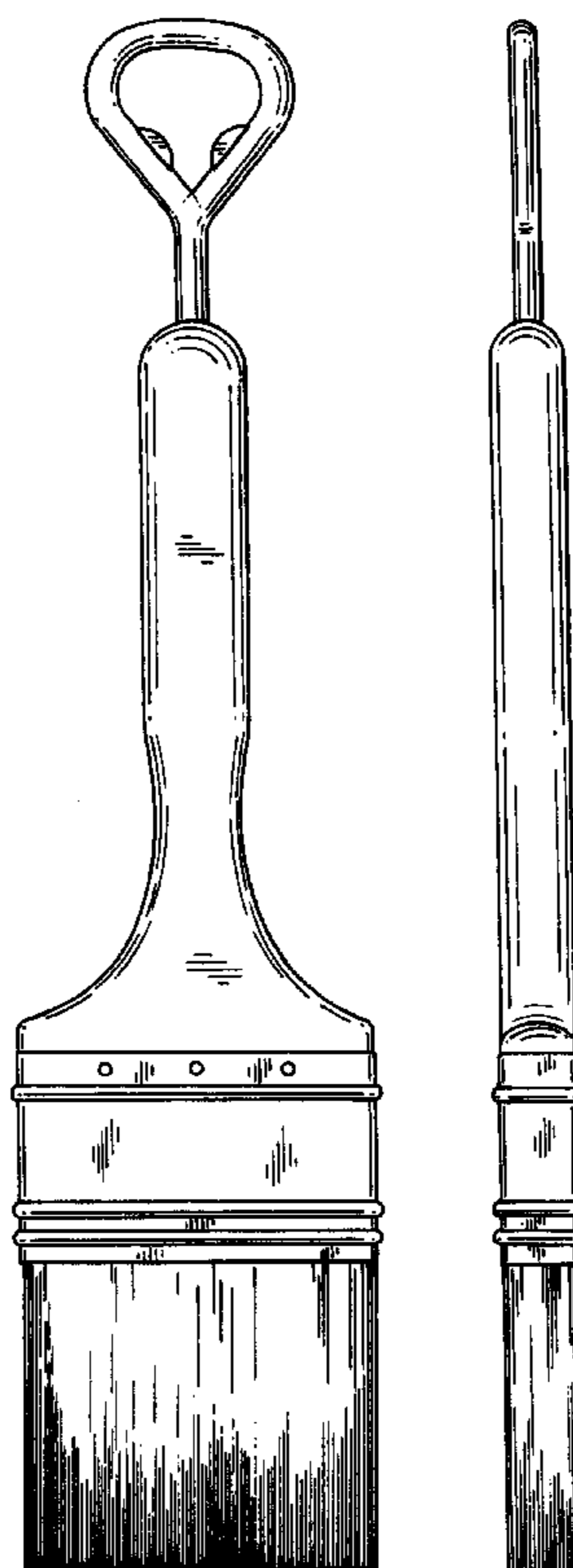
FIG. 2 is a right side elevational view of the combined brush and bottle opener of FIG. 1 with the left side being a mirror image thereof;

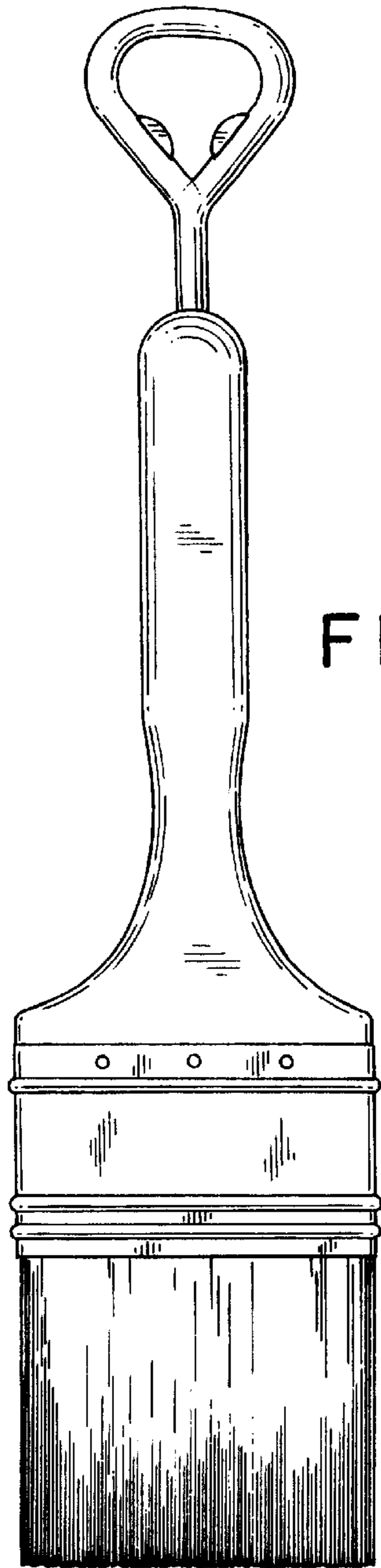
