FIG. 4 is a left side elevational view of an armchair;

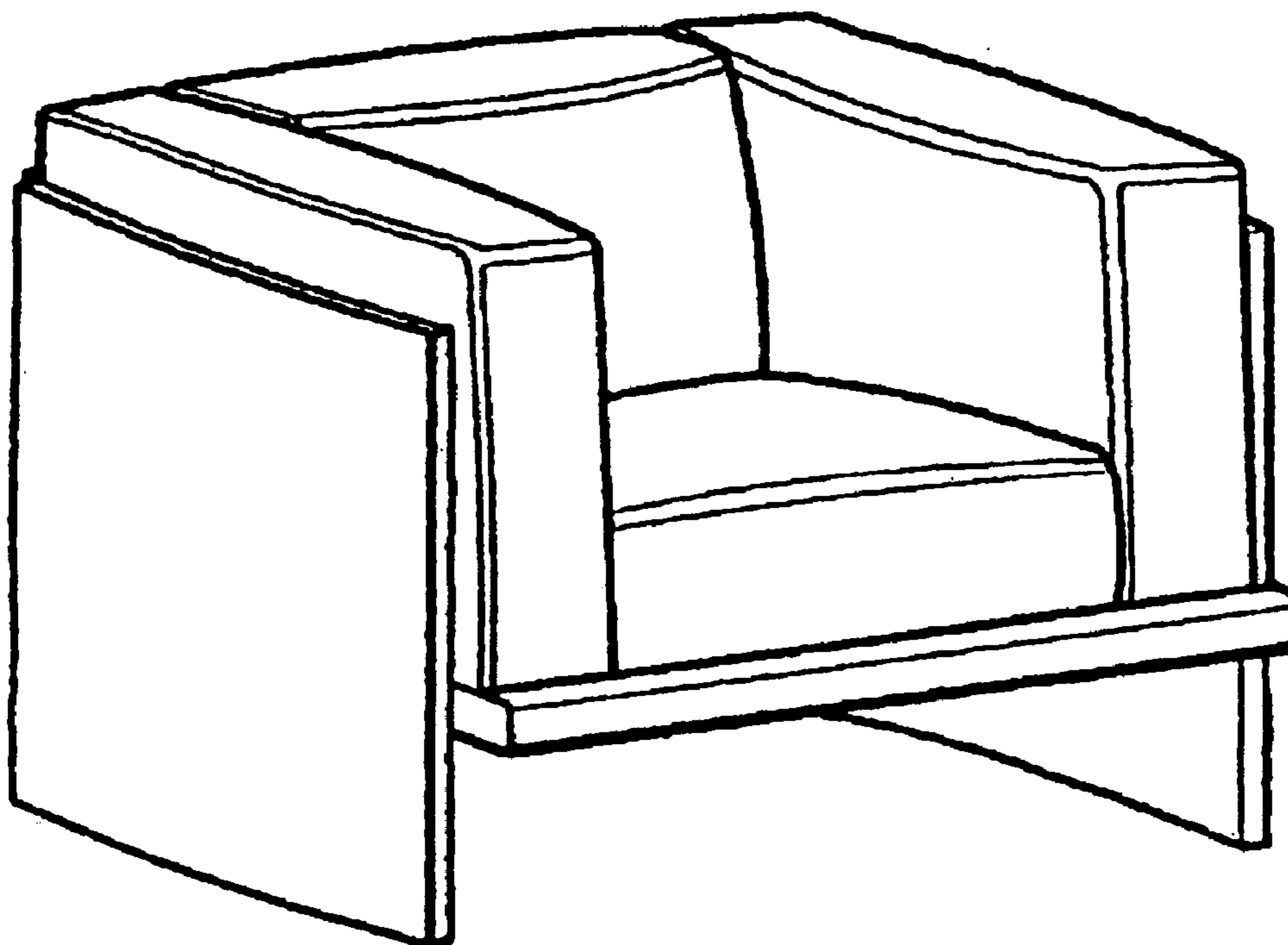
FIG. 5 is a front elevational view of an armchair;

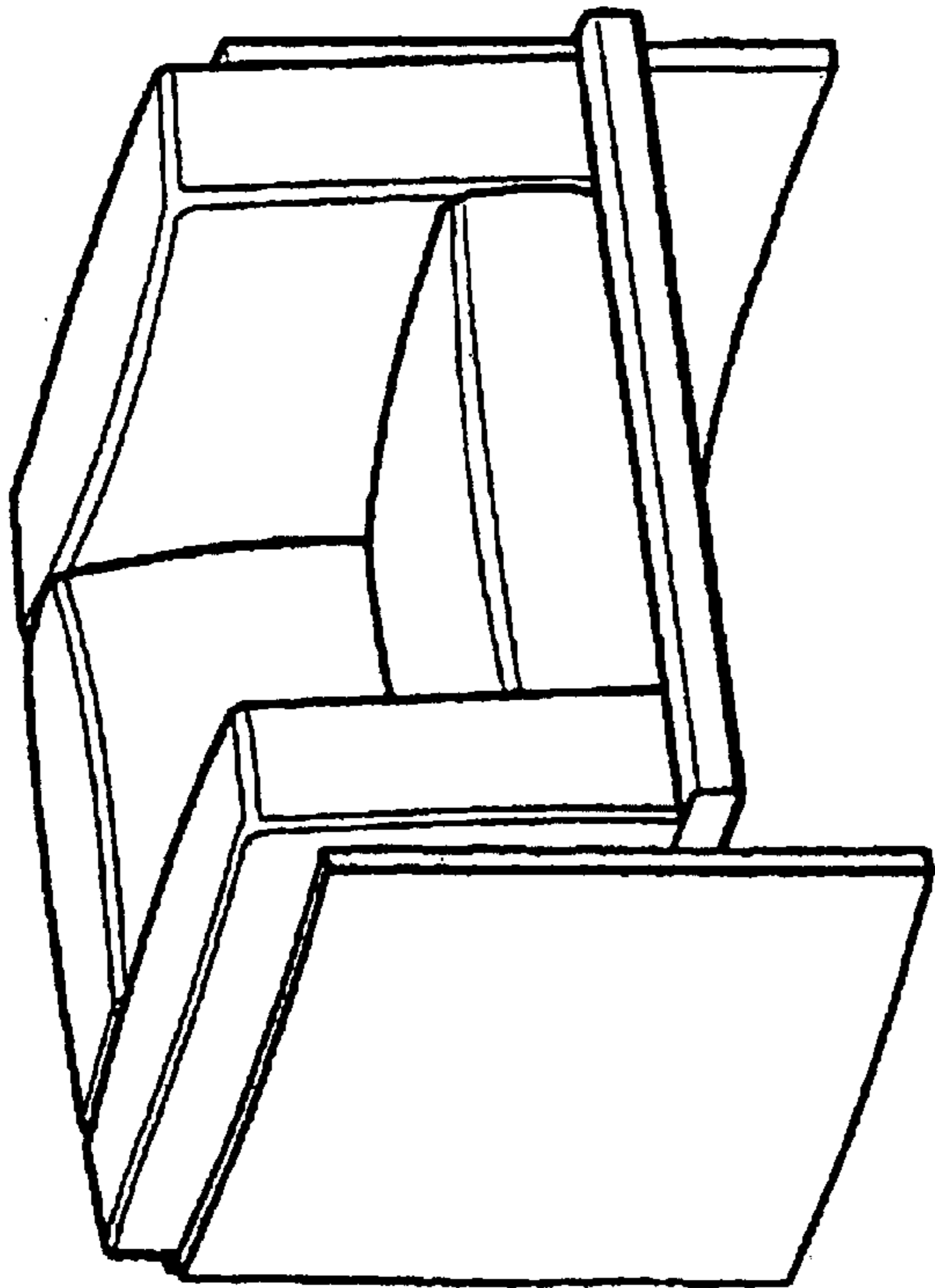

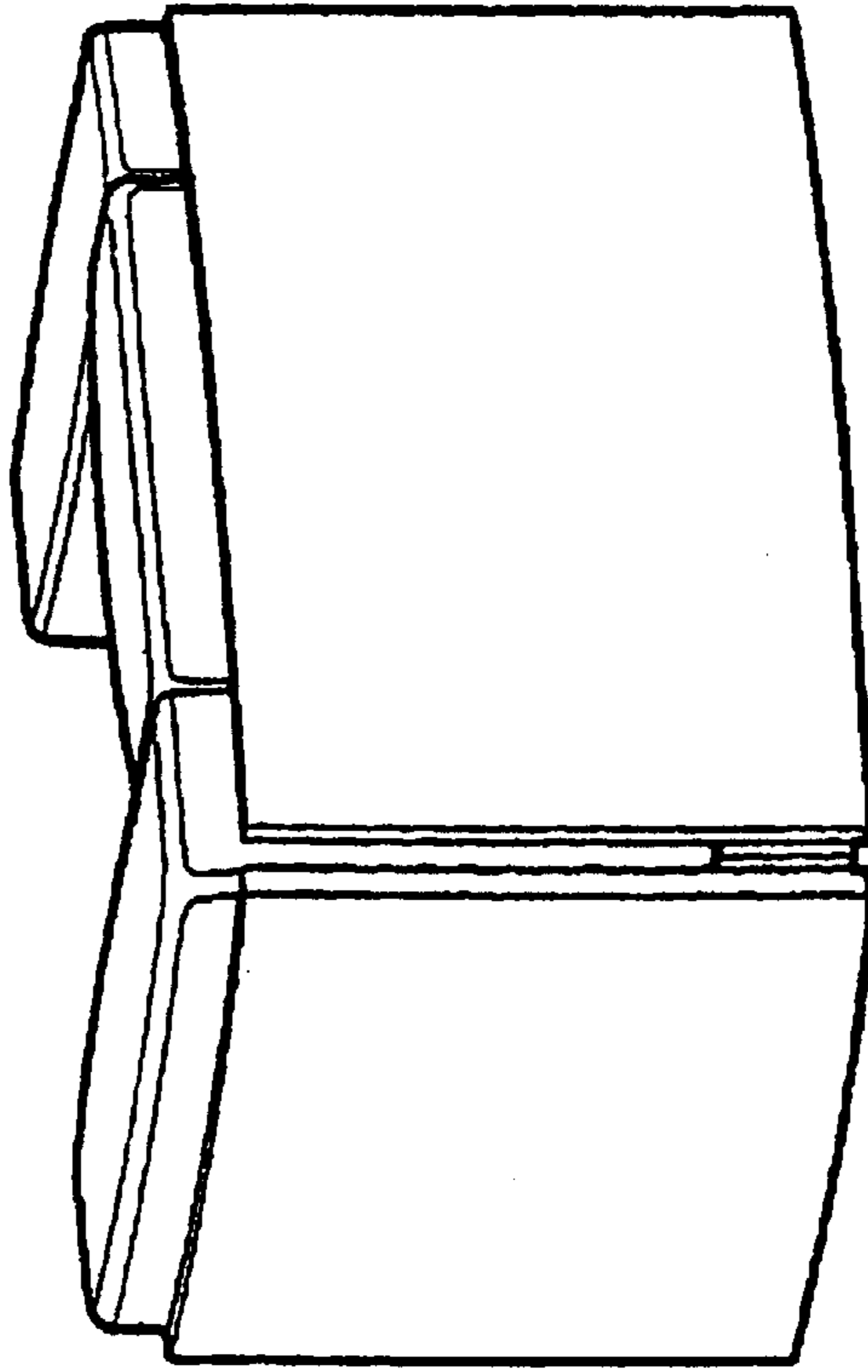

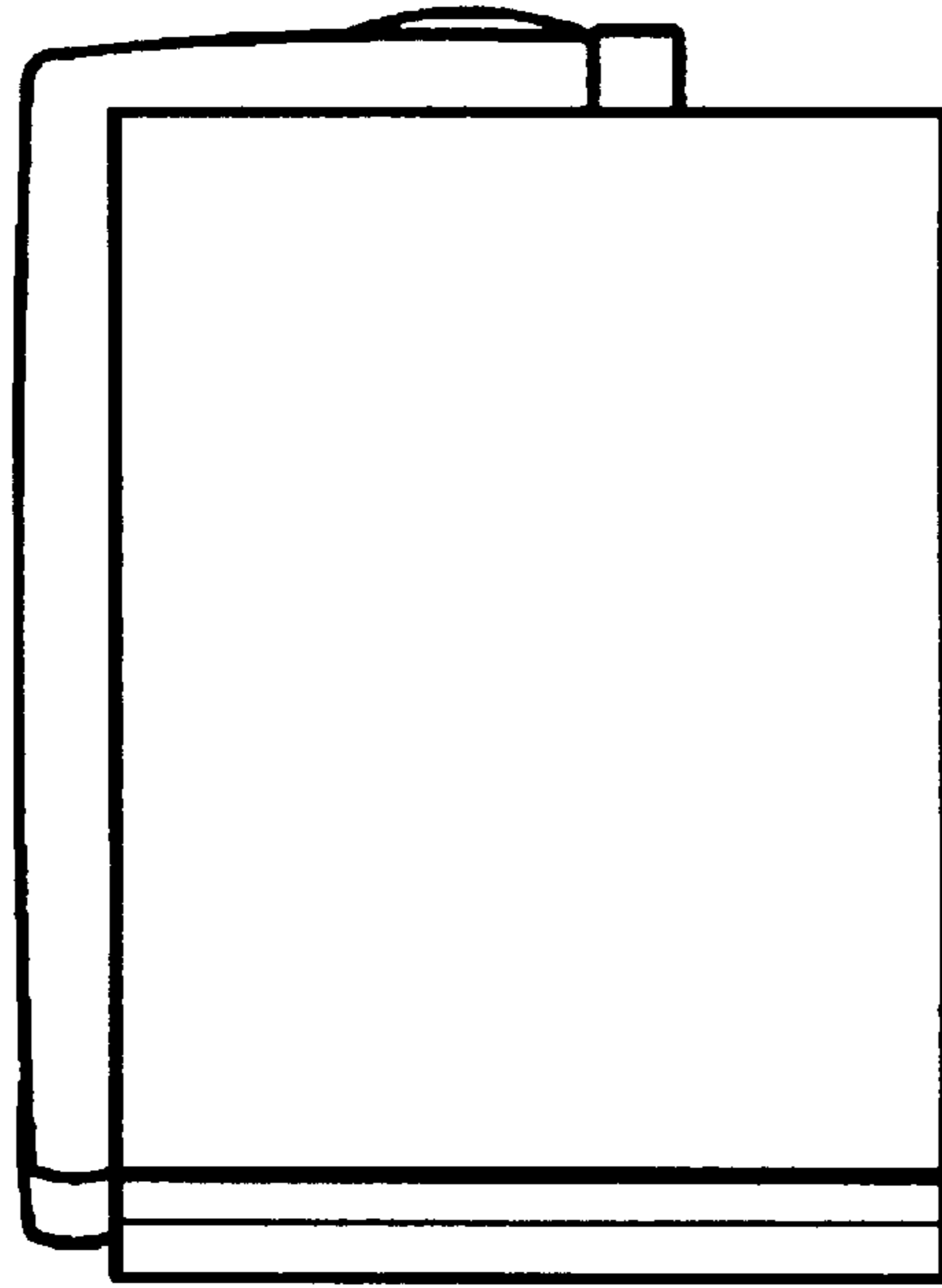

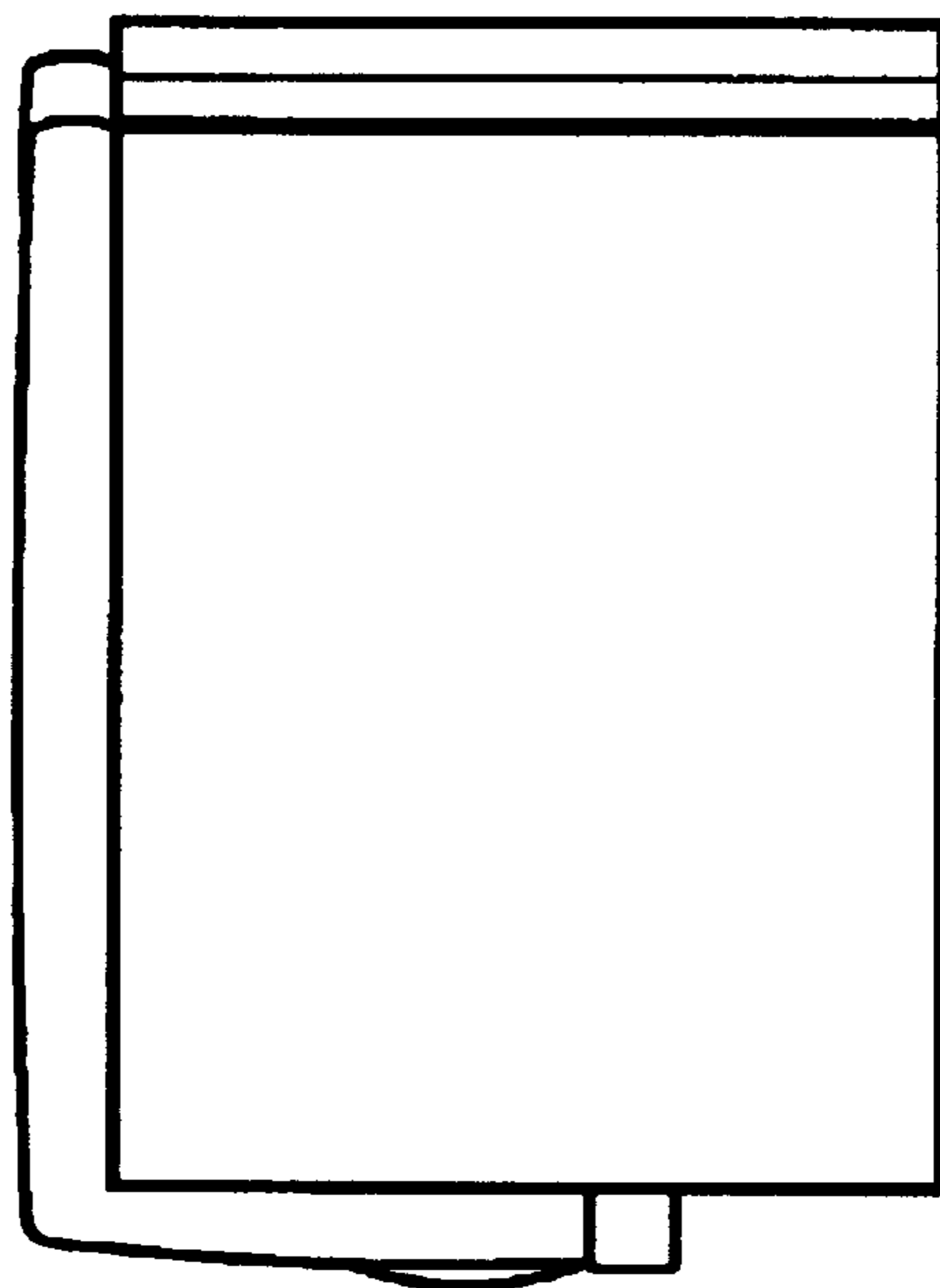

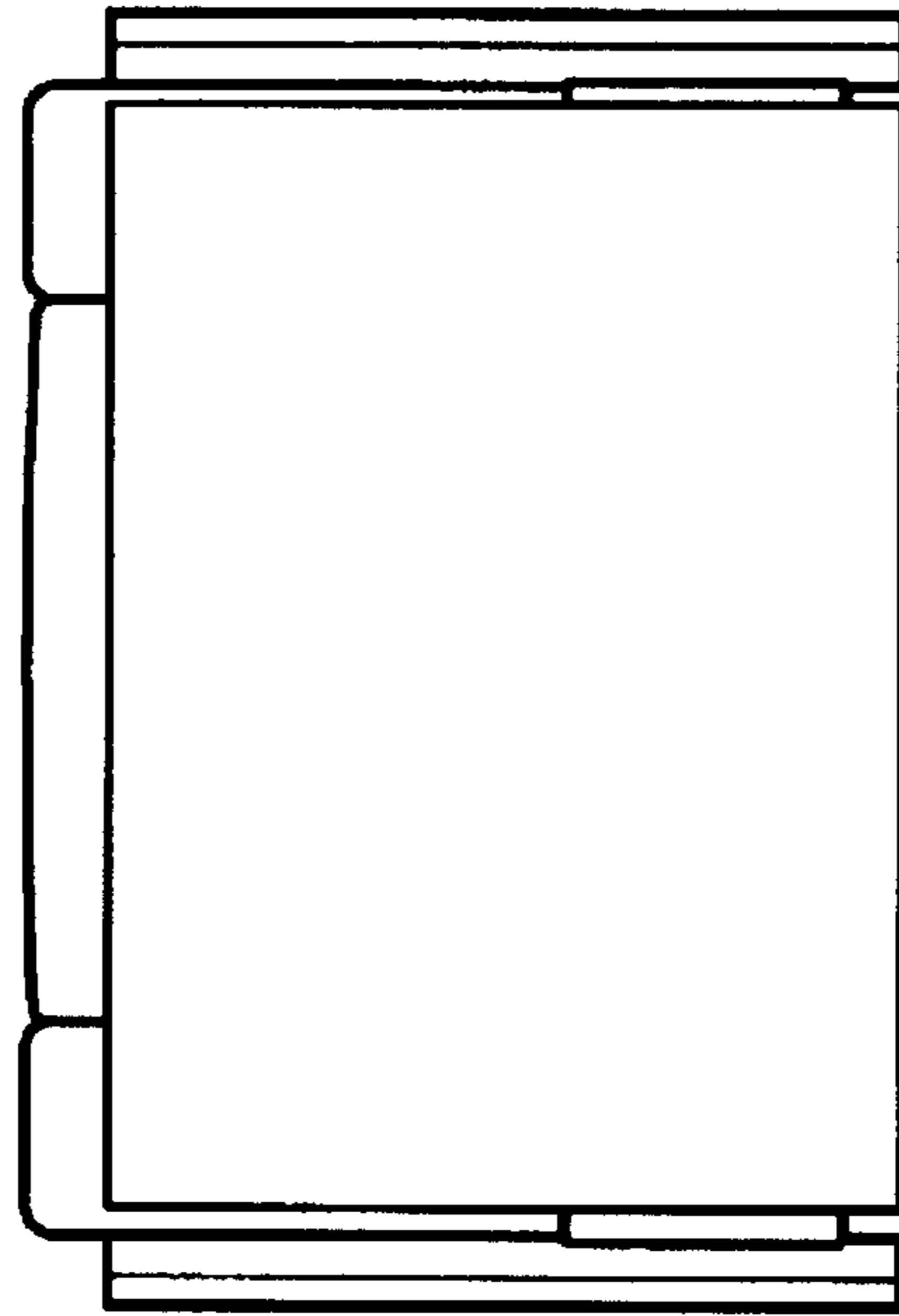

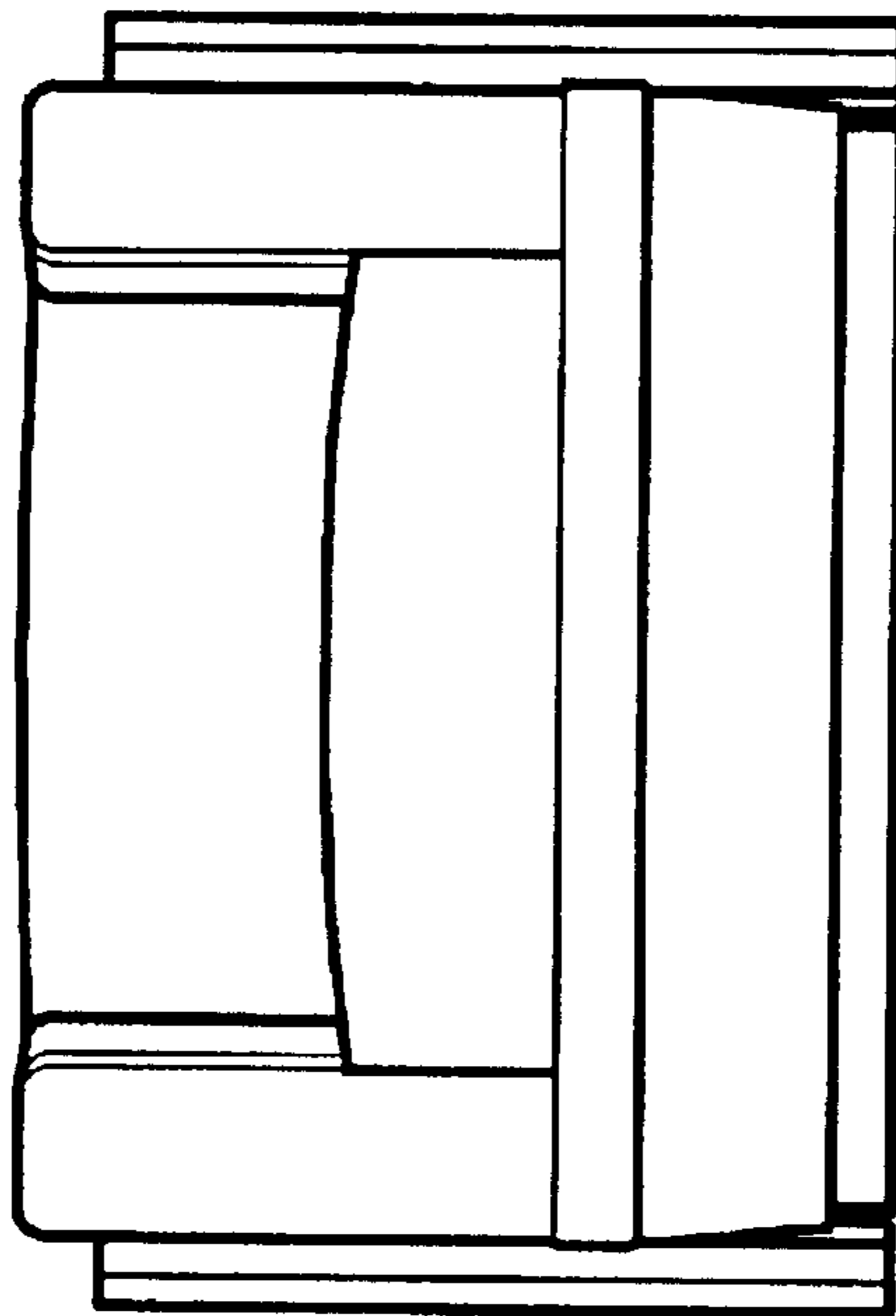

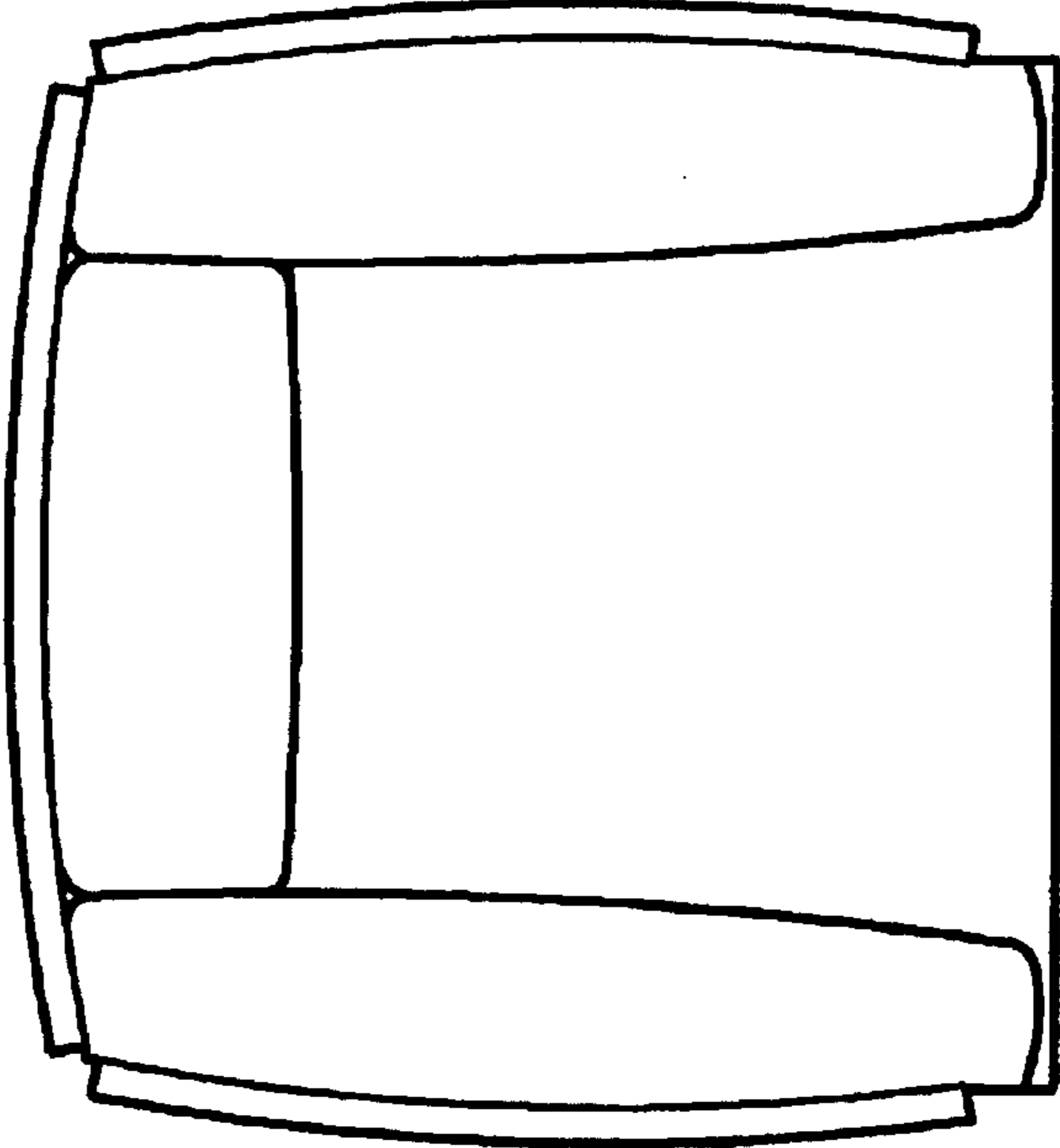

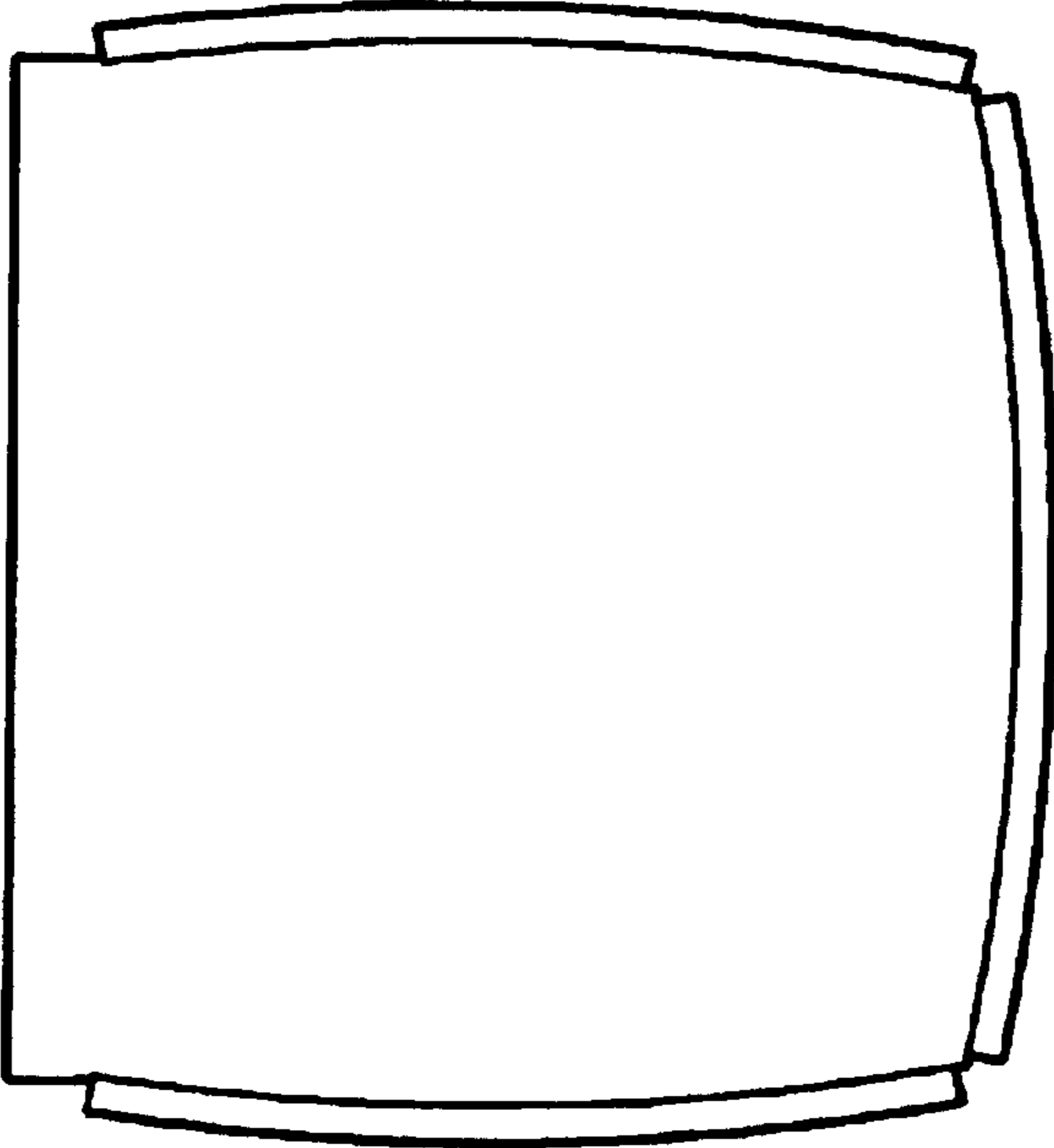
