**DESCRIPTION**

FIG. 1 is a perspective view of a banana holder, showing our  
new design;

FIG. 2 is a side elevational view thereof;

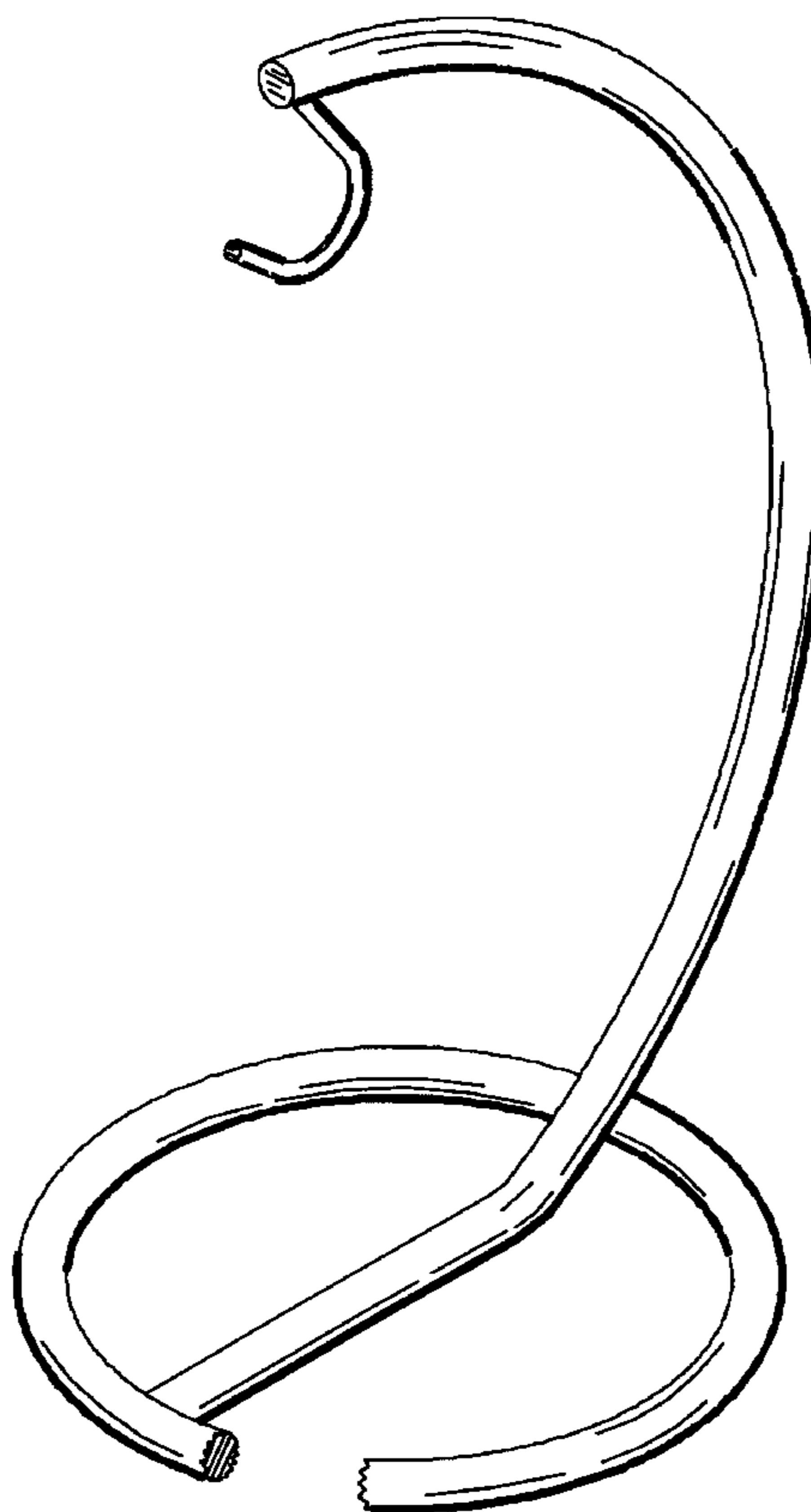
FIG. 3 is a top plan view thereof; and,

FIG. 4 is a front elevational view thereof.

The portion of the peripheral member that is shown broken  
away indicates that the space between the two ends may  
vary.

The cross-hatching does not indicate a type of material, but  
only identifies the section break.

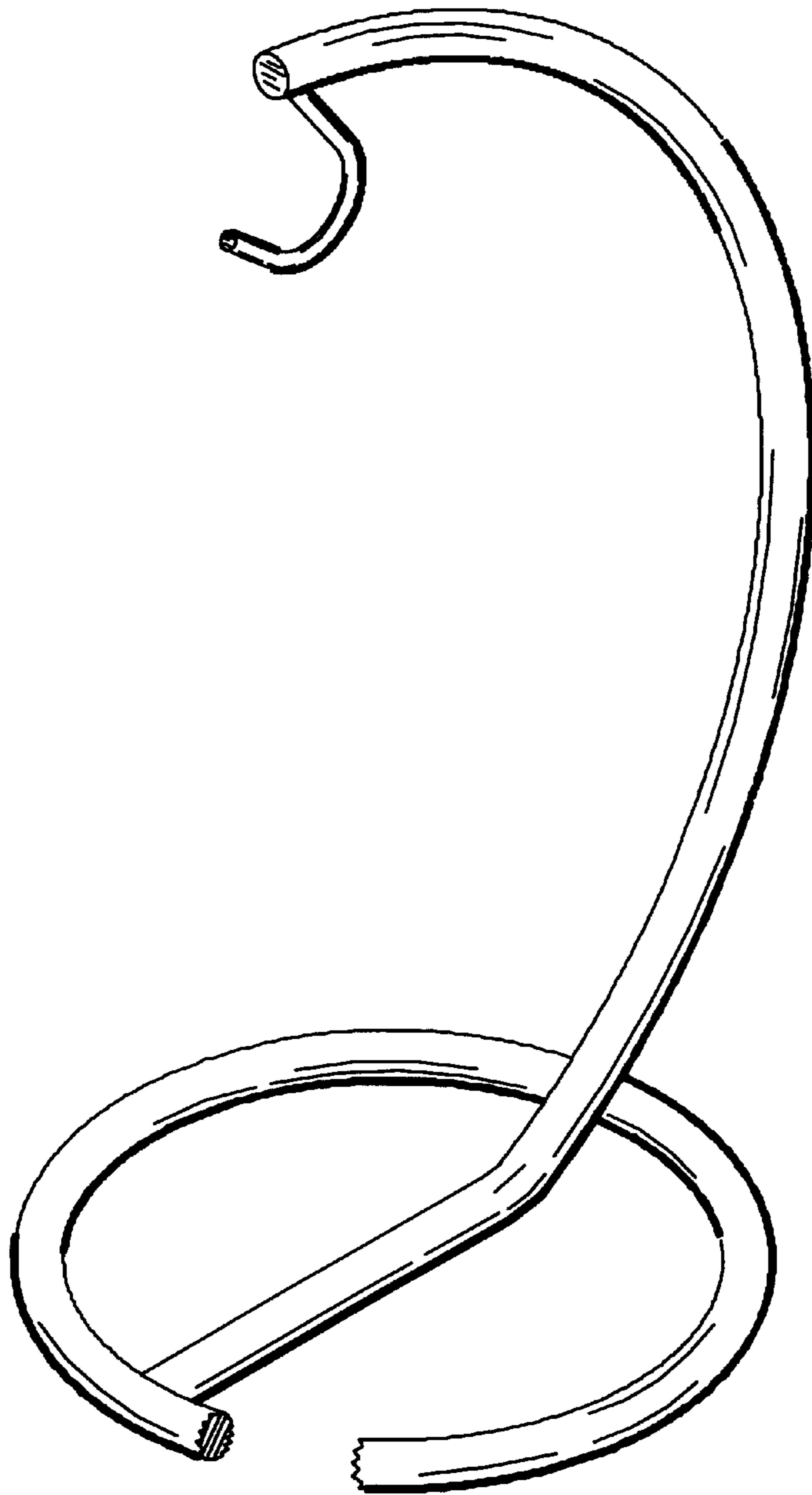

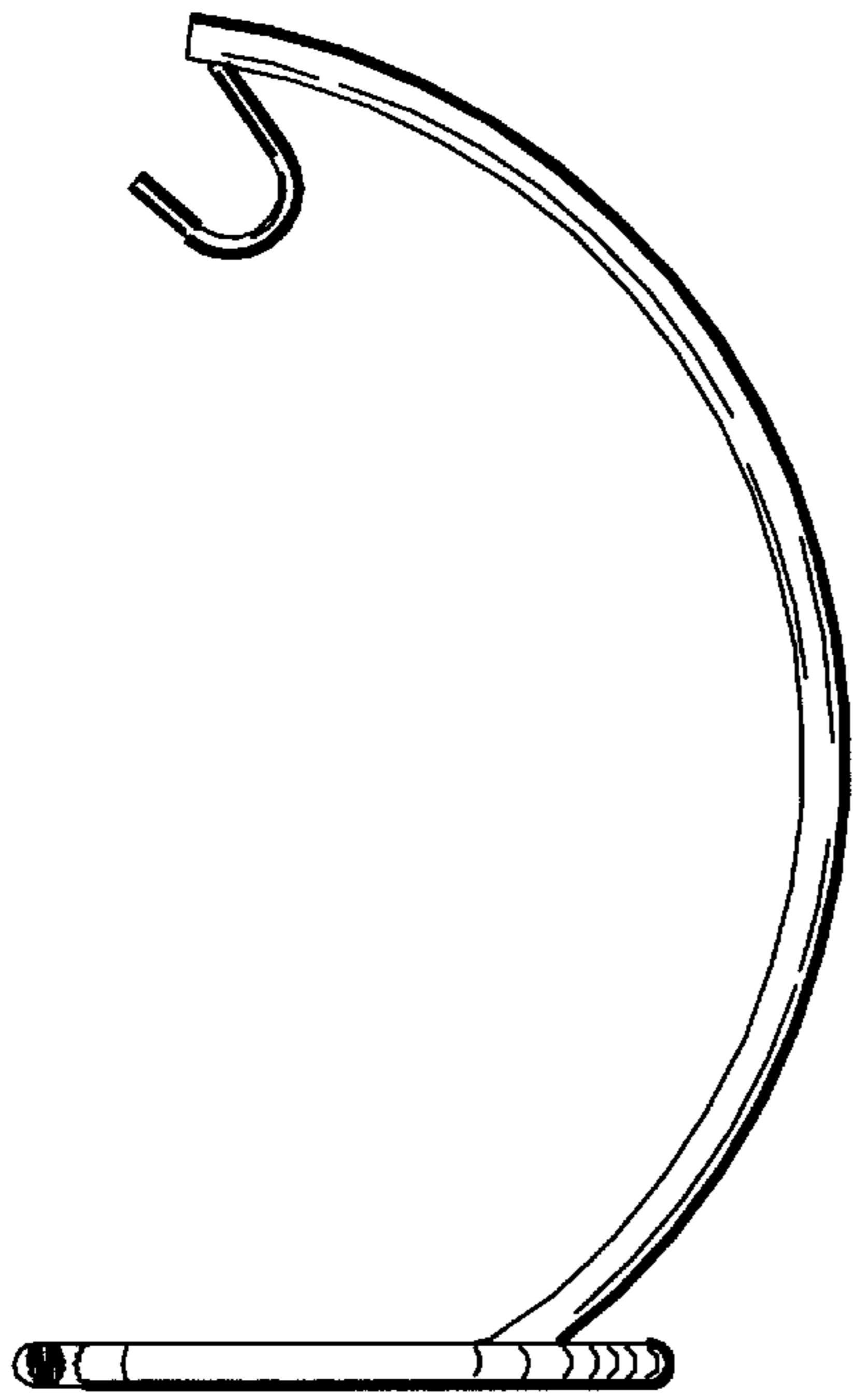

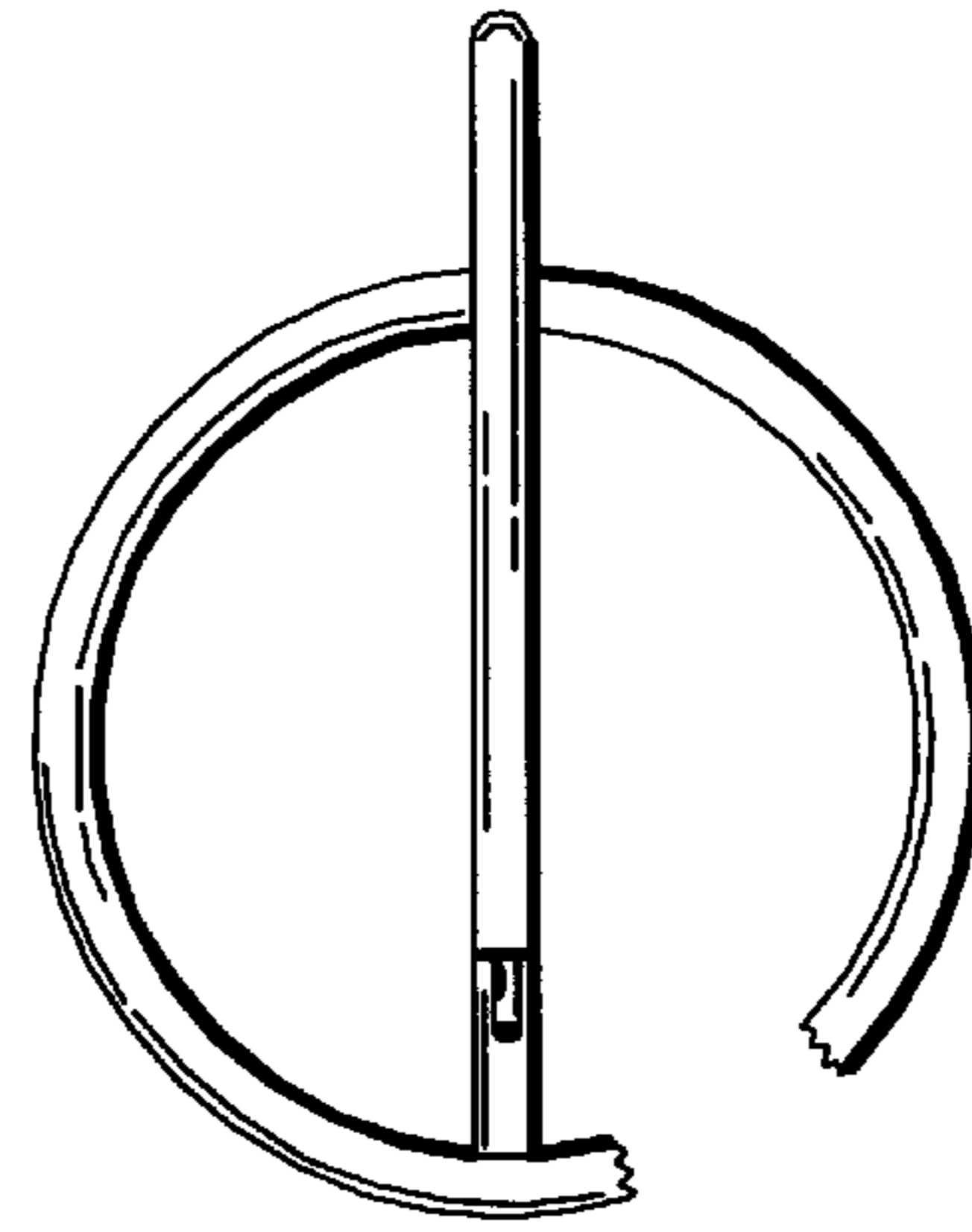

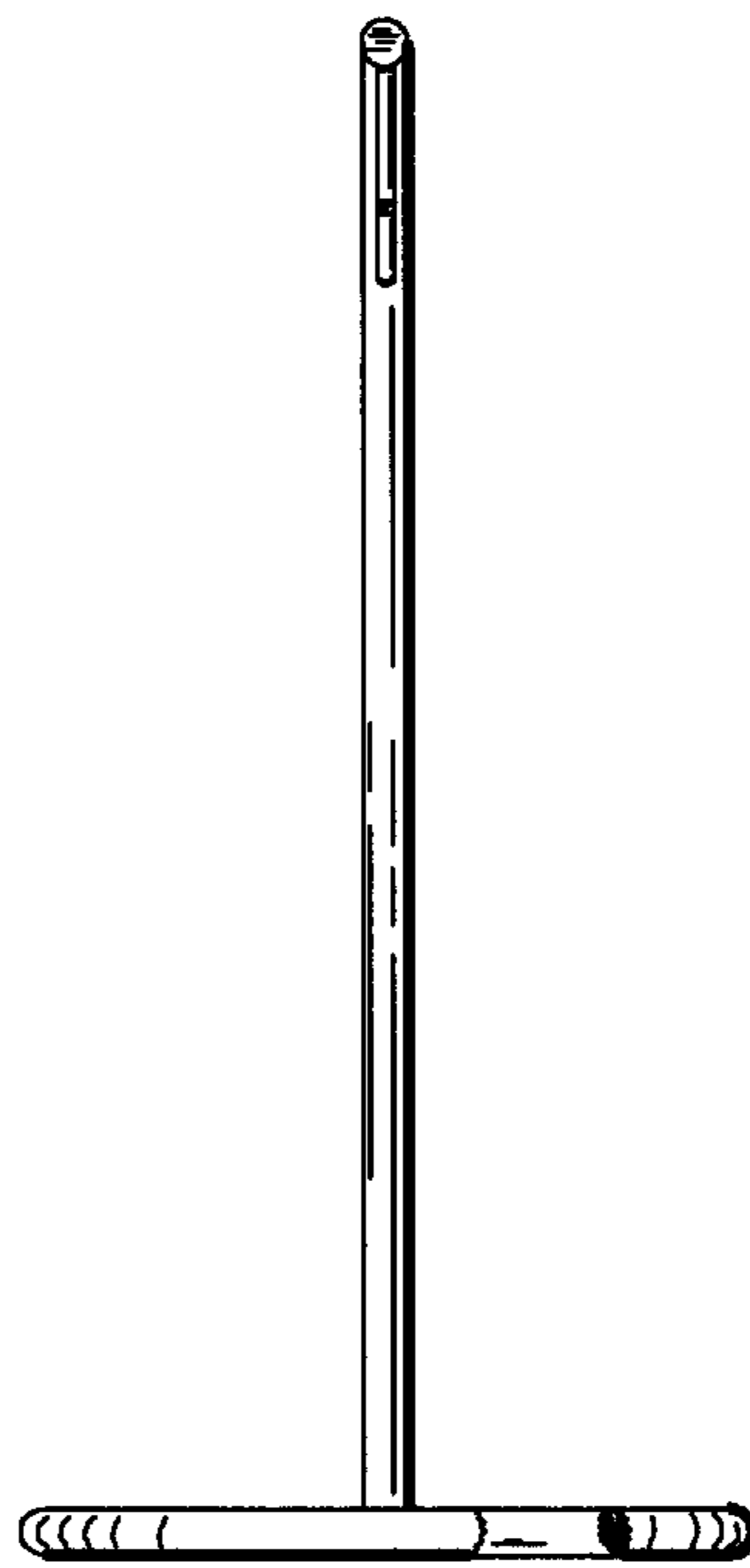
