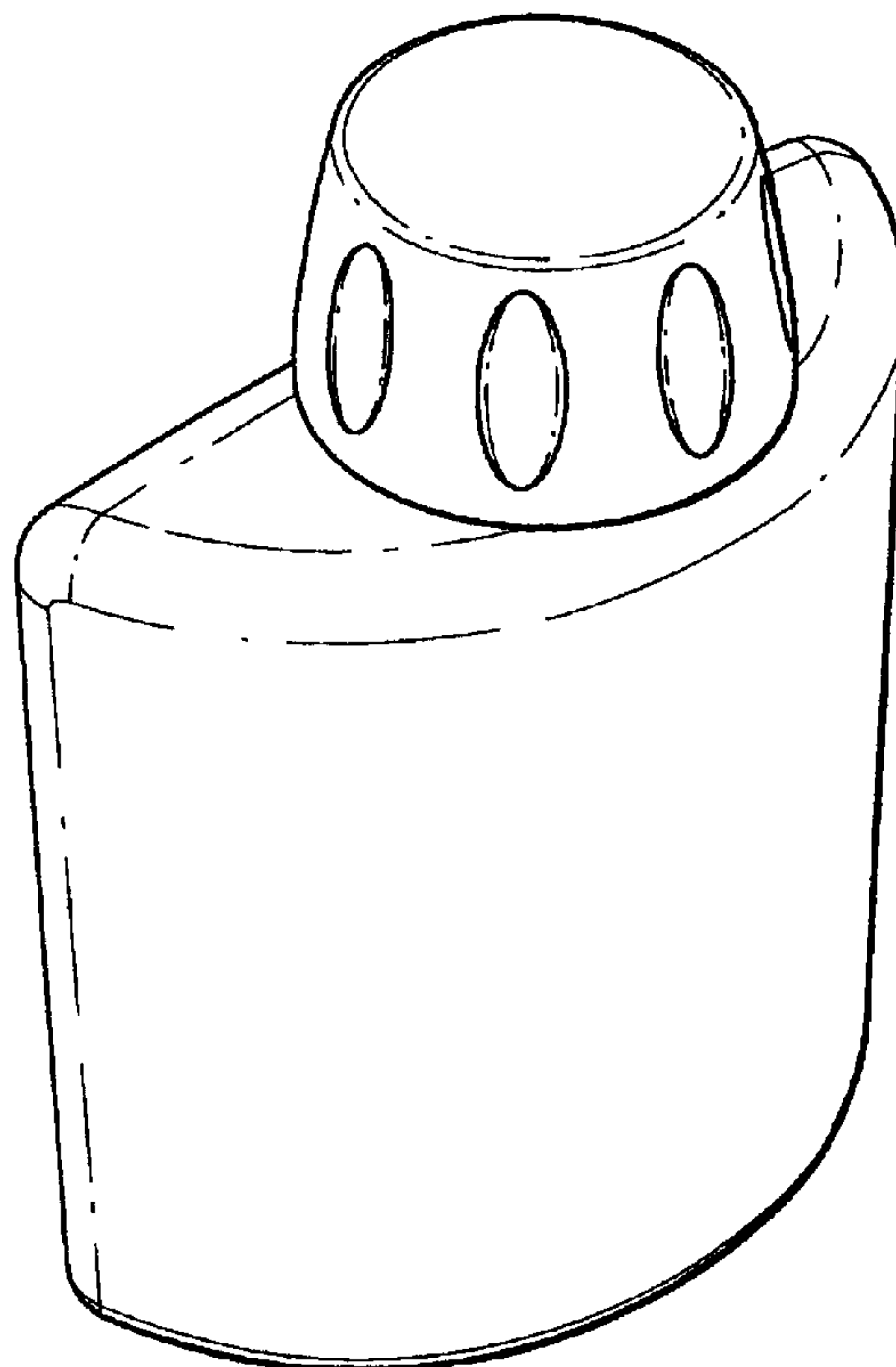
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front perspective view of a bottle of the present design;
FIG. 2 is a top, rear perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;
FIG. 5 is a top plan view thereof; and,

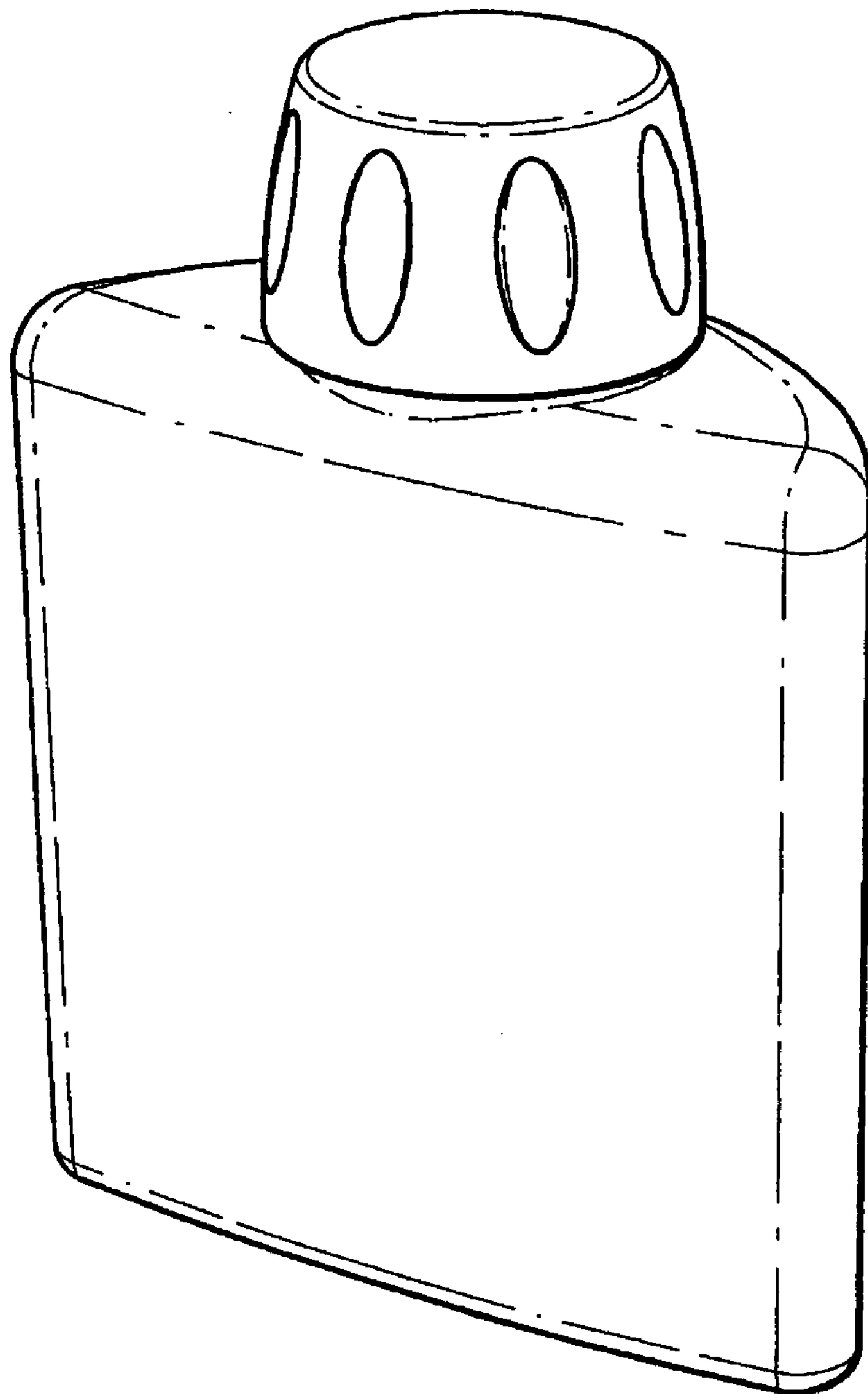

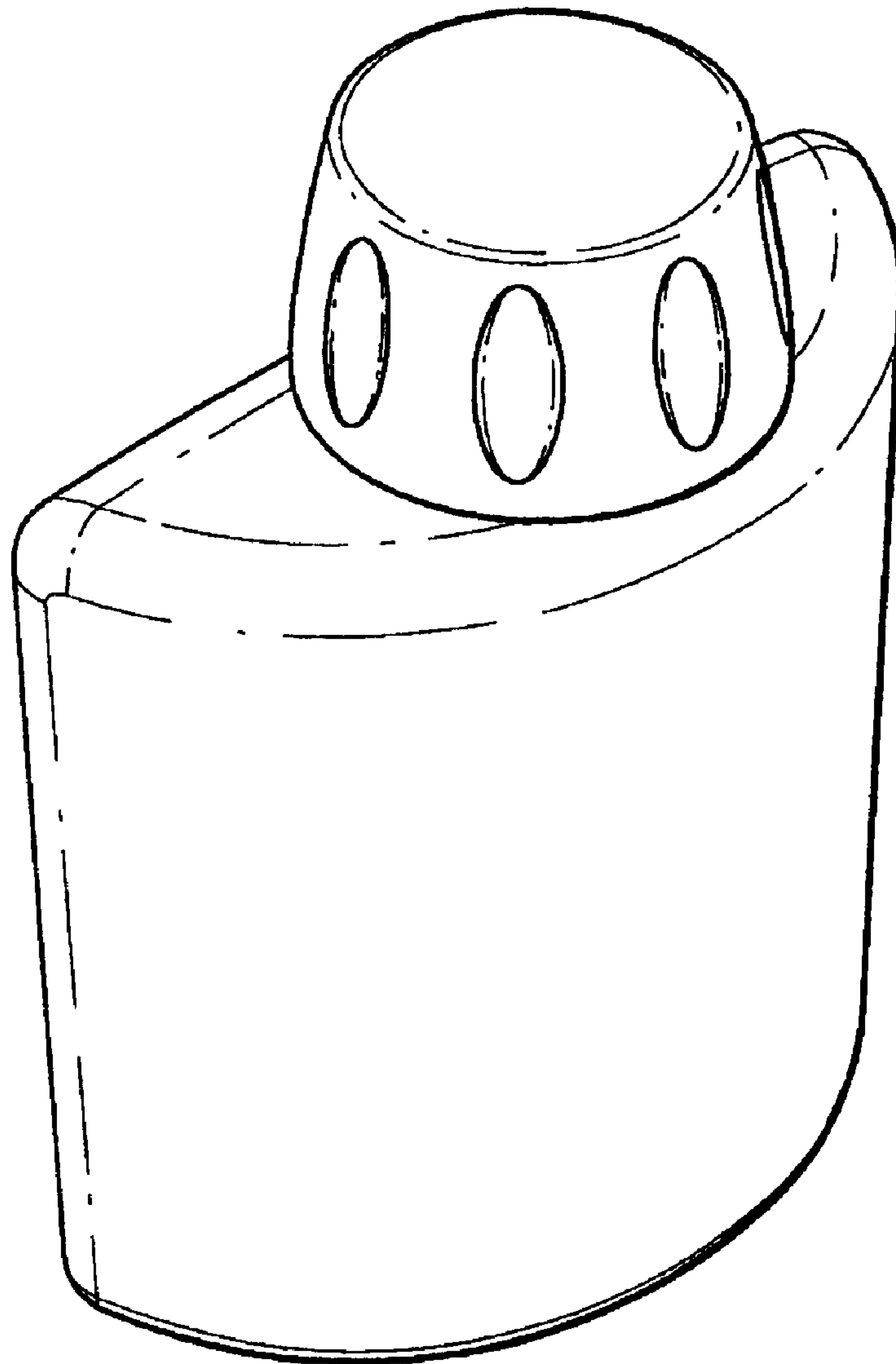

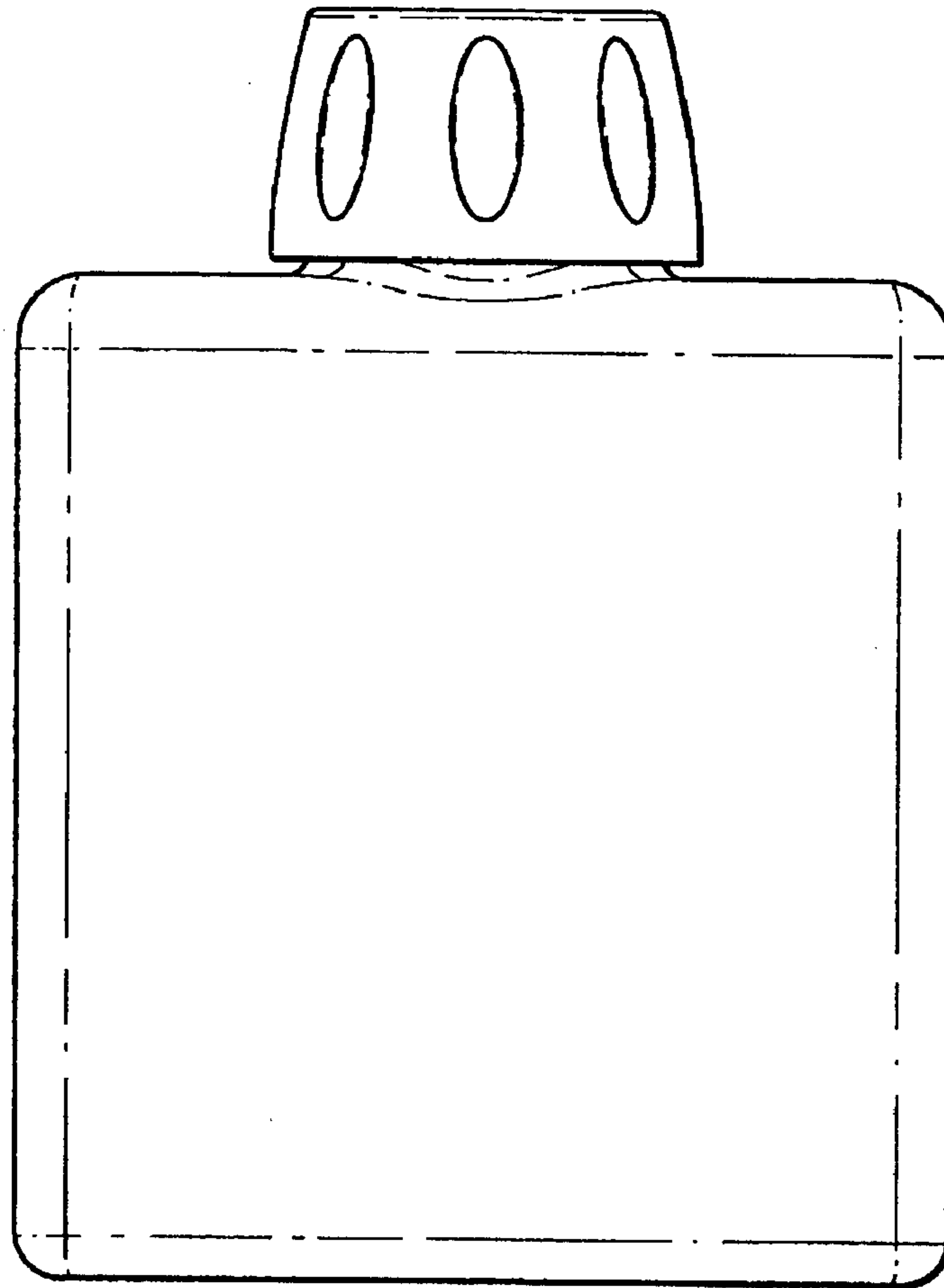

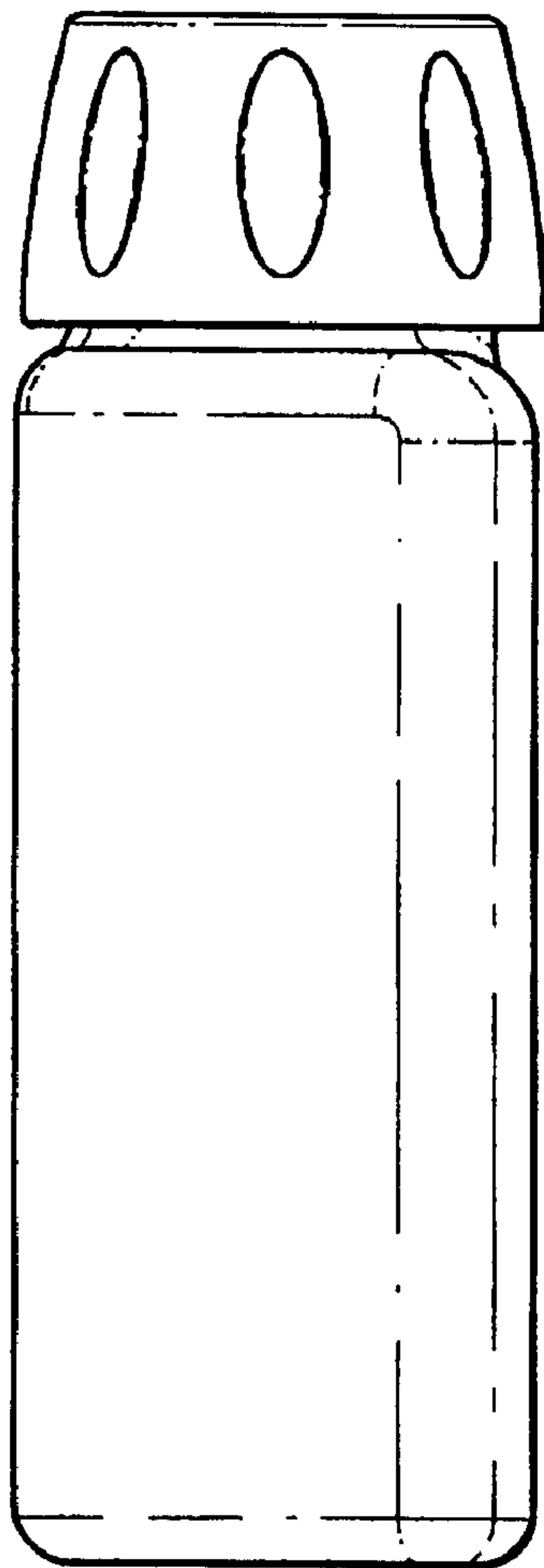

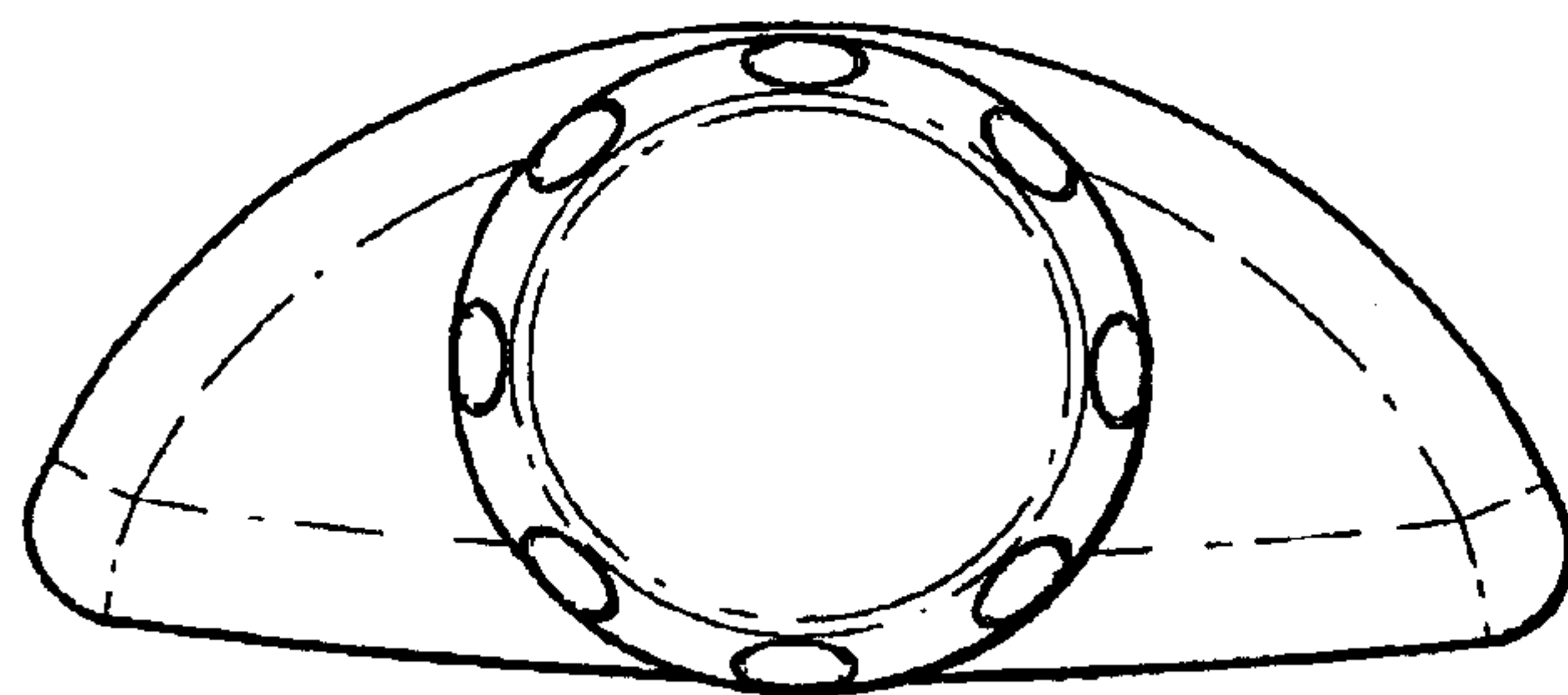

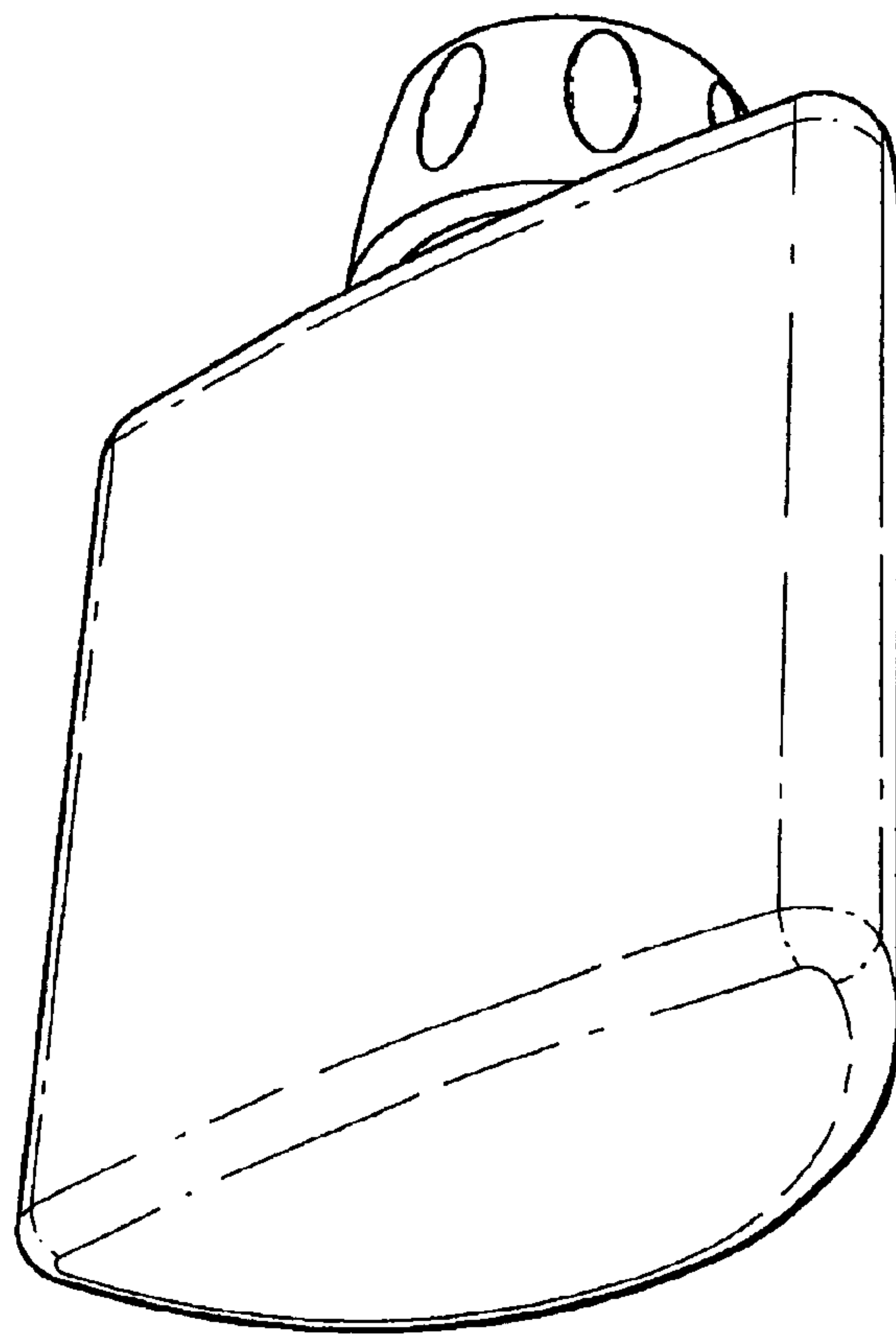
