(57) **CLAIM**

We claim the ornamental design for a bottle, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a bottle depicting the new design;

FIG. 2 is a front elevational view thereof from the direction indicated in FIG. 6;

FIG. 3 is a right side elevational view thereof, from the direction indicated in FIG. 6;

FIG. 4 is a rear elevational view thereof, taken from the direction indicated in FIG. 6;

FIG. 5 is a right side elevational view thereof, from the direction indicated in FIG. 6;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a perspective view of a second embodiment of the bottle shown in FIG. 1;

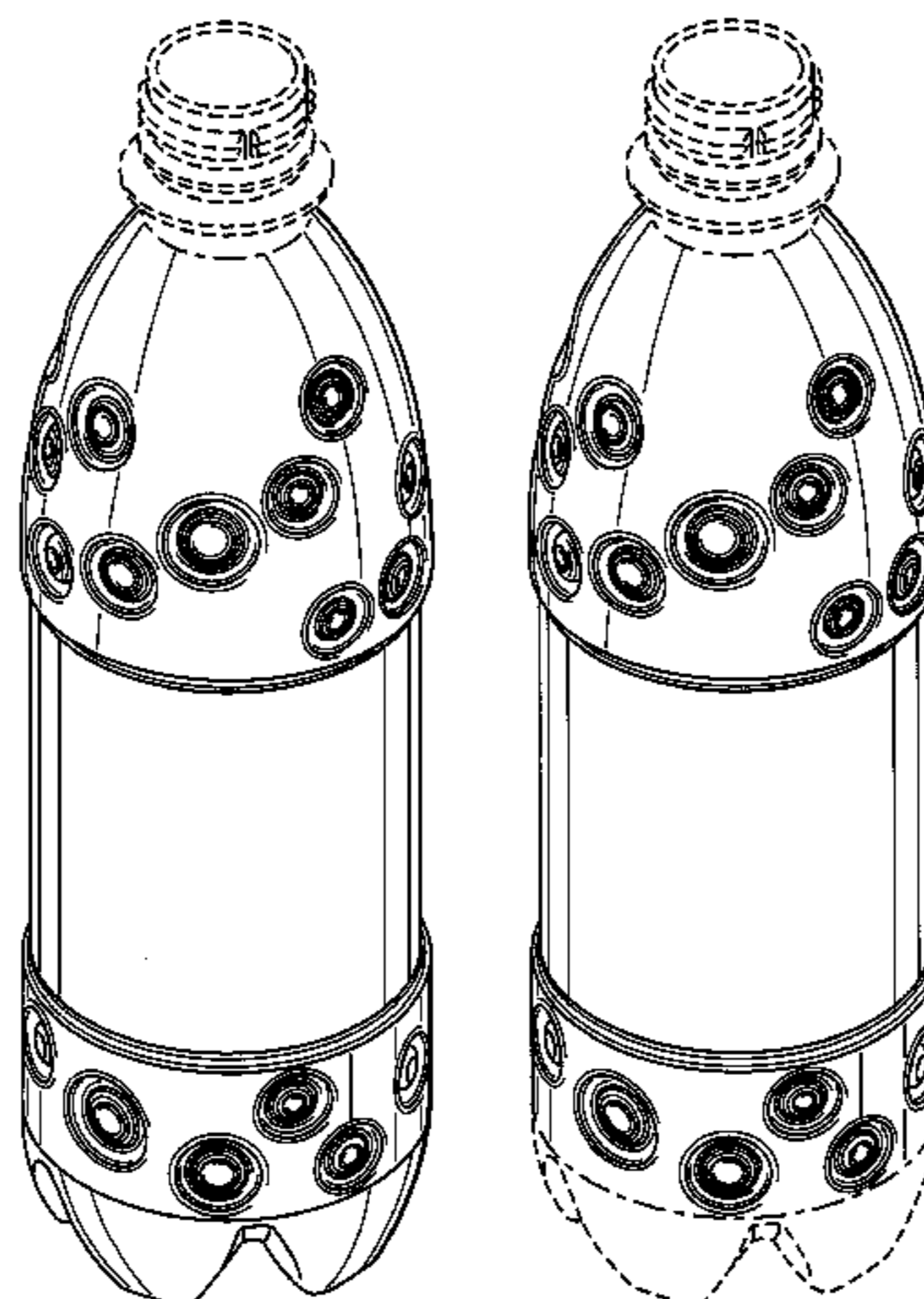
FIG. 13 is a top plan view thereof; and,

FIG. 9 is a front elevational view thereof from the direction indicated in FIG. 13;

FIG. 10 is a right side elevational view thereof, from the direction indicated in FIG. 13;

FIG. 11 is a rear elevational view thereof, taken from the direction indicated in FIG. 13;

FIG. 12 is a right side elevational view thereof, from the direction indicated in FIG. 13;

FIG. 14 is a bottom plan view thereof.

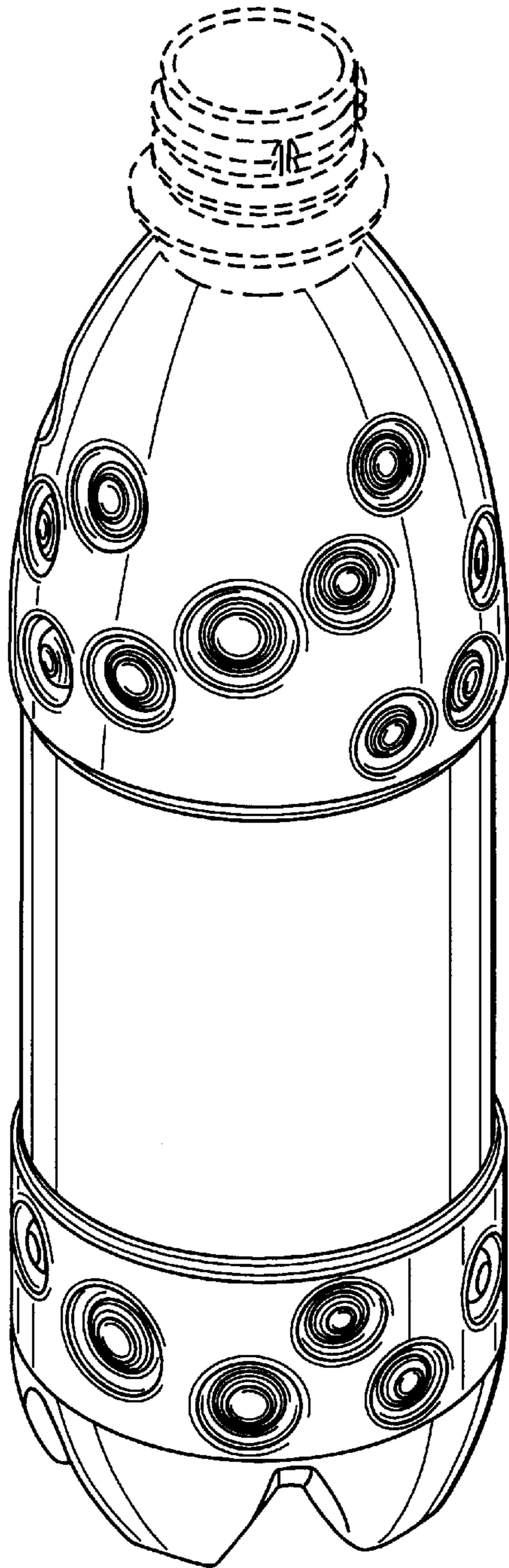
The dash lines shown in the drawings are for illustrative purposes only and form no part of the claimed design.

The dot-dash-dot lines shown in the drawings define the boundary of the claim and form no part of the claimed design.

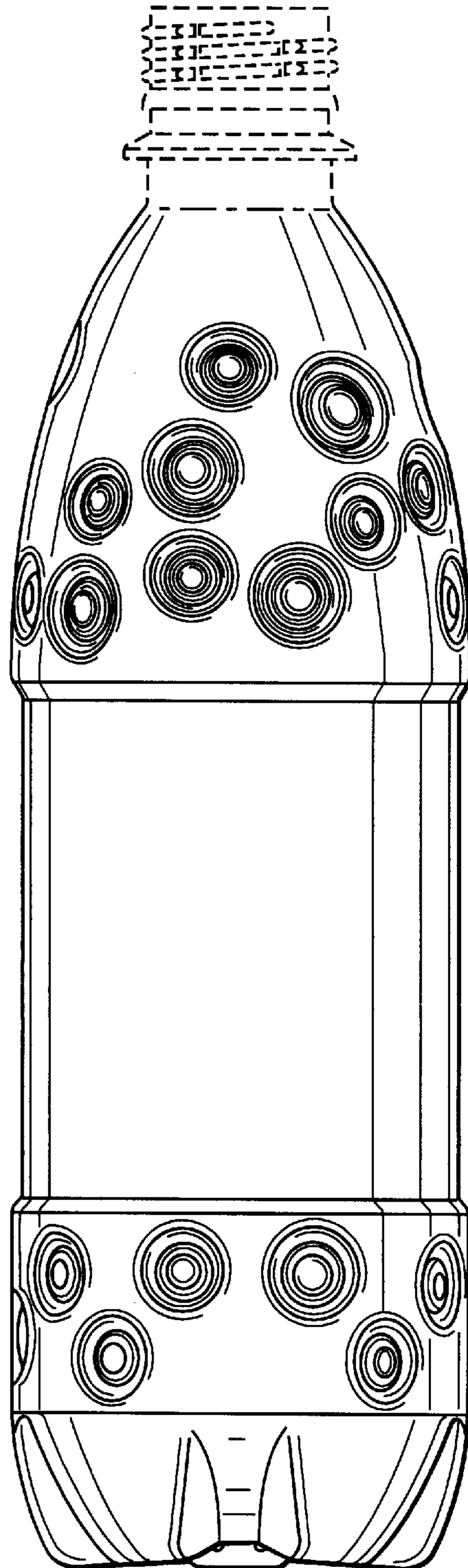

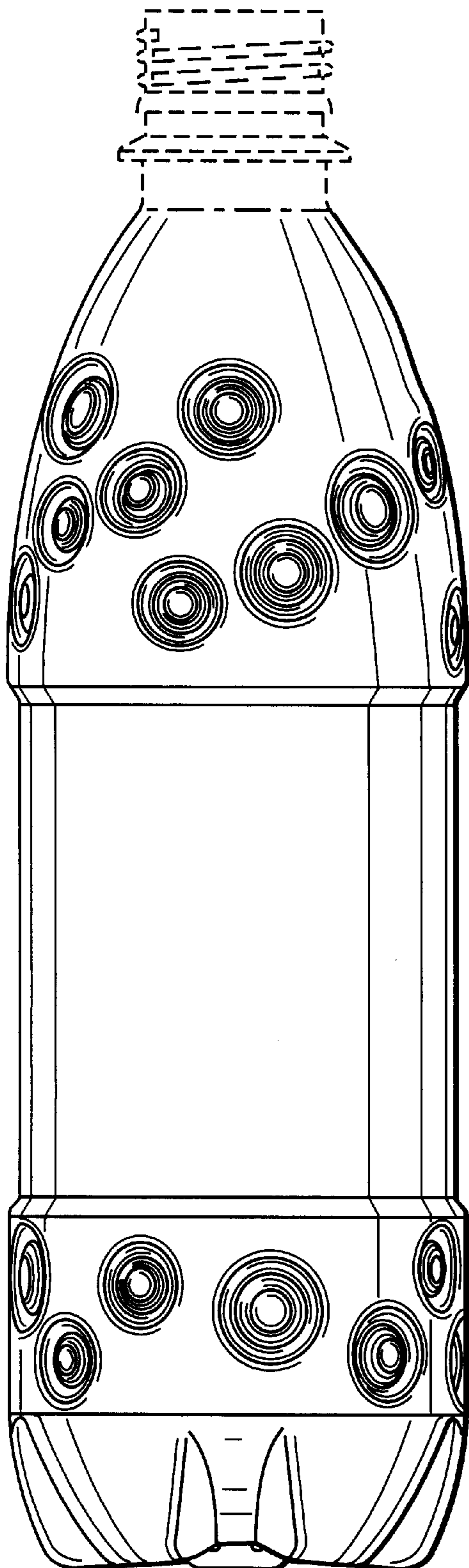

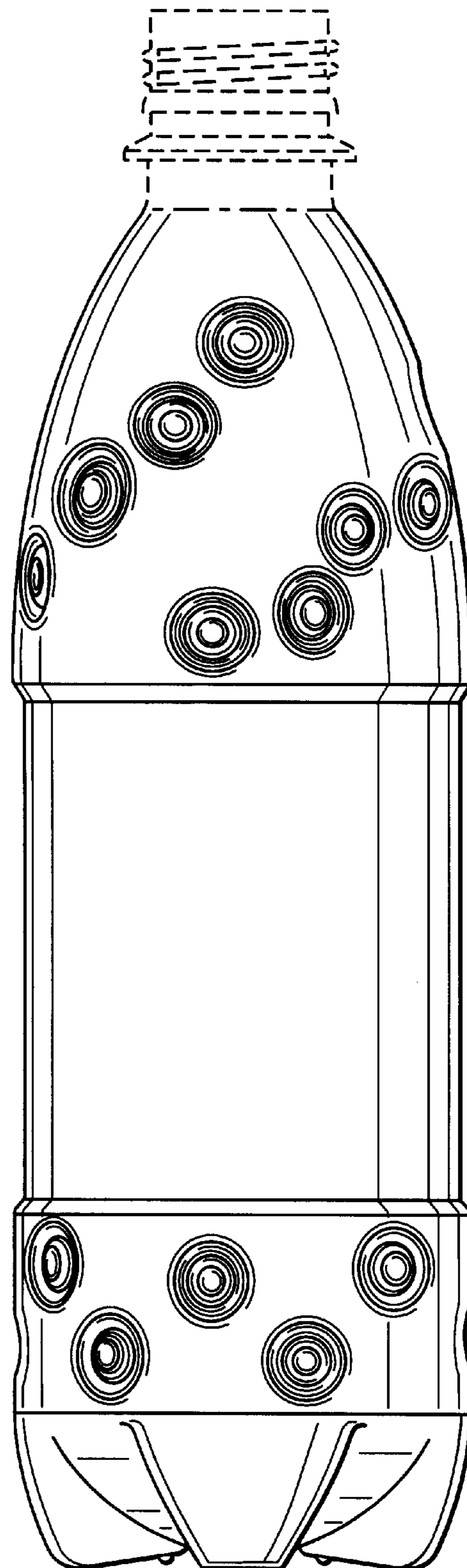

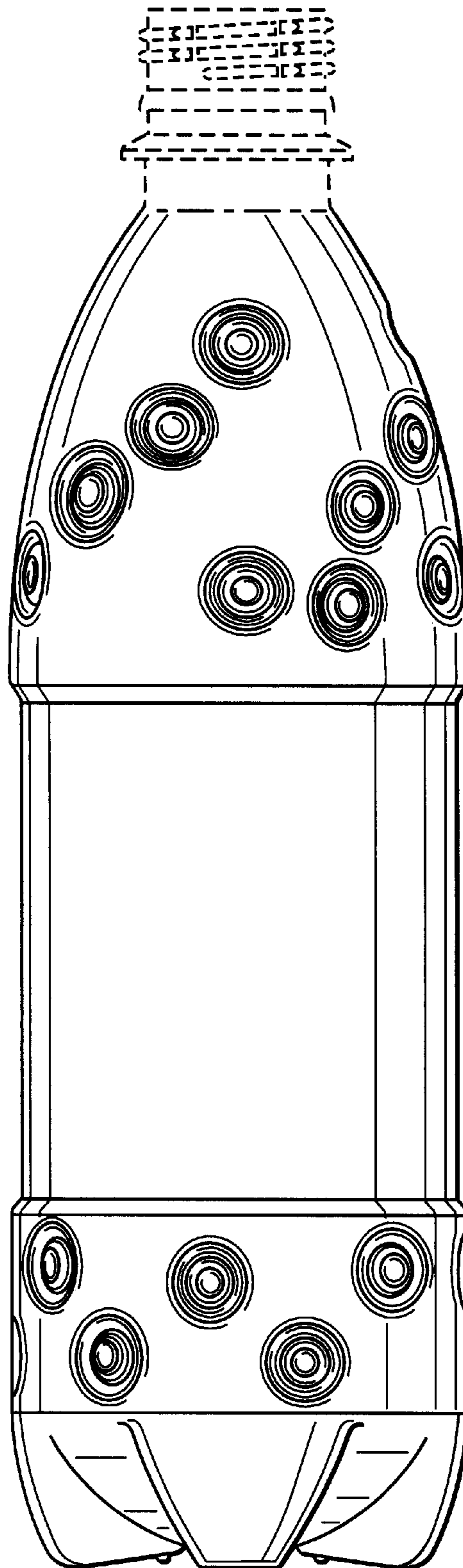

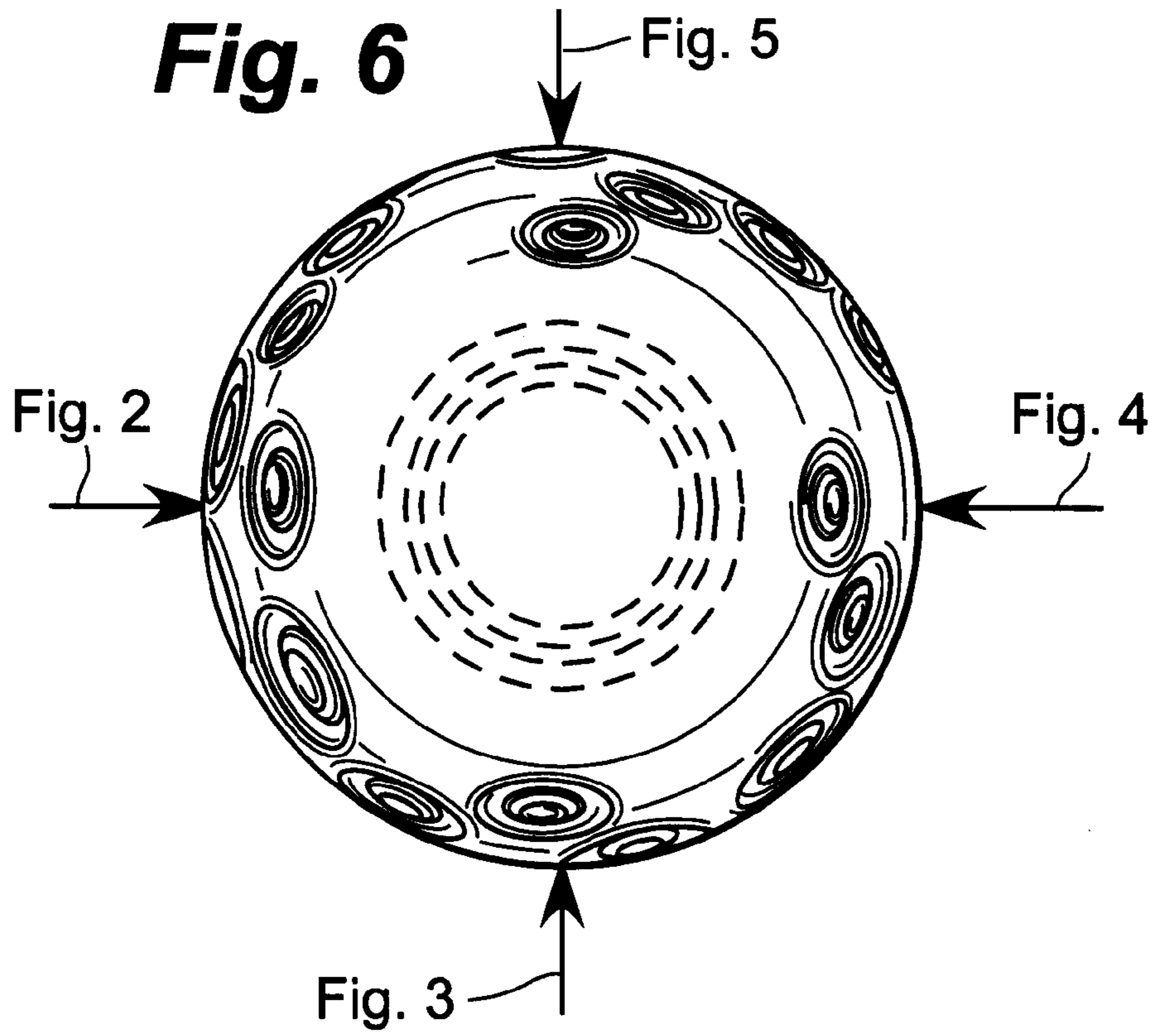

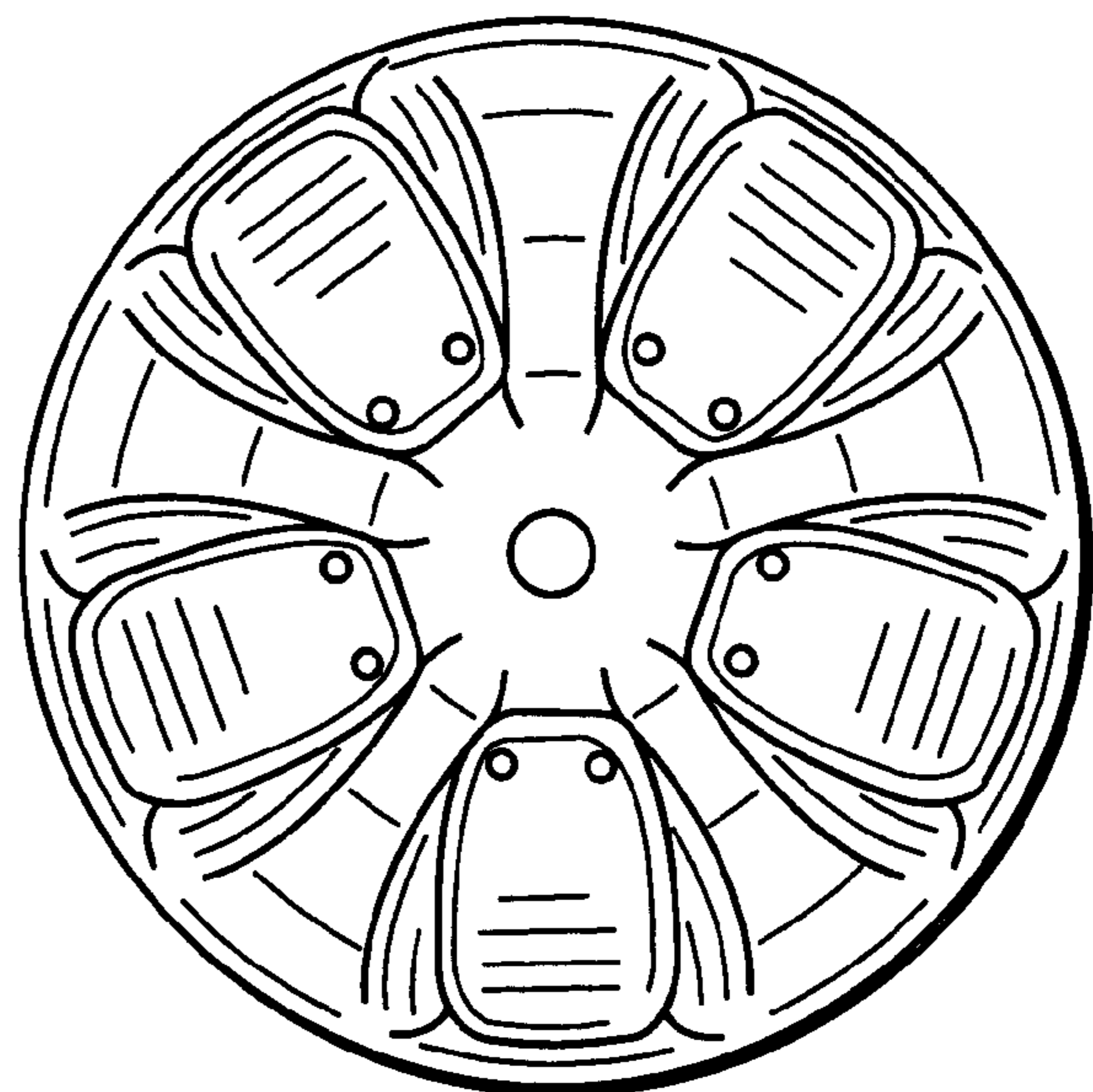

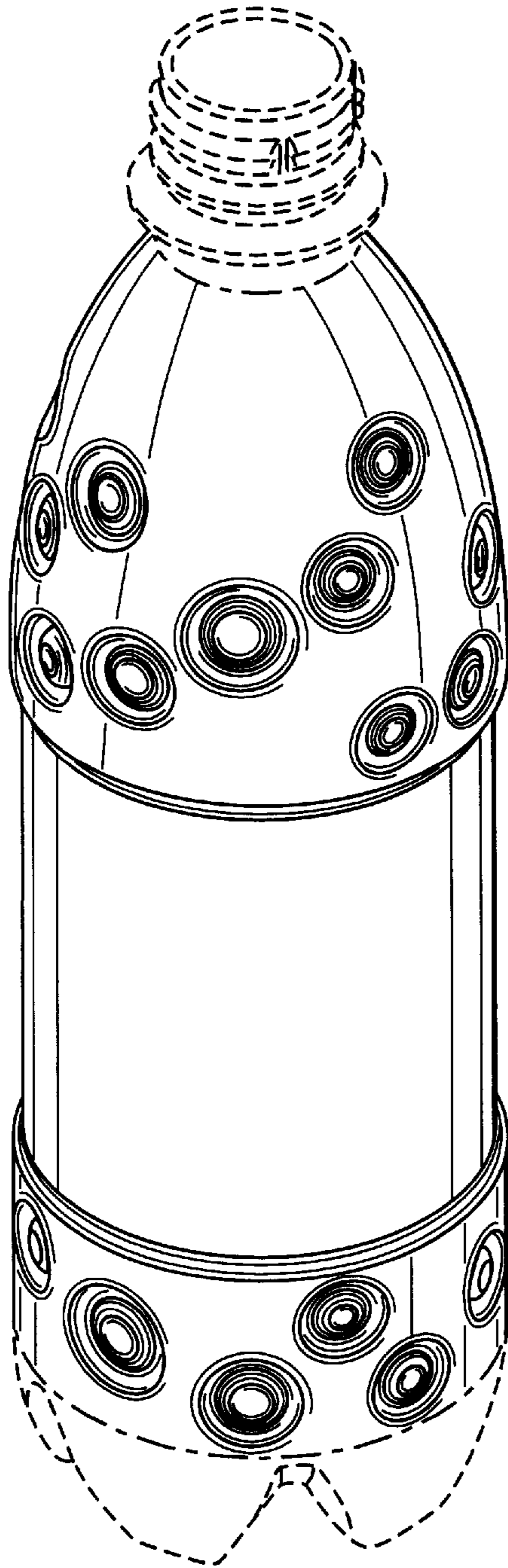




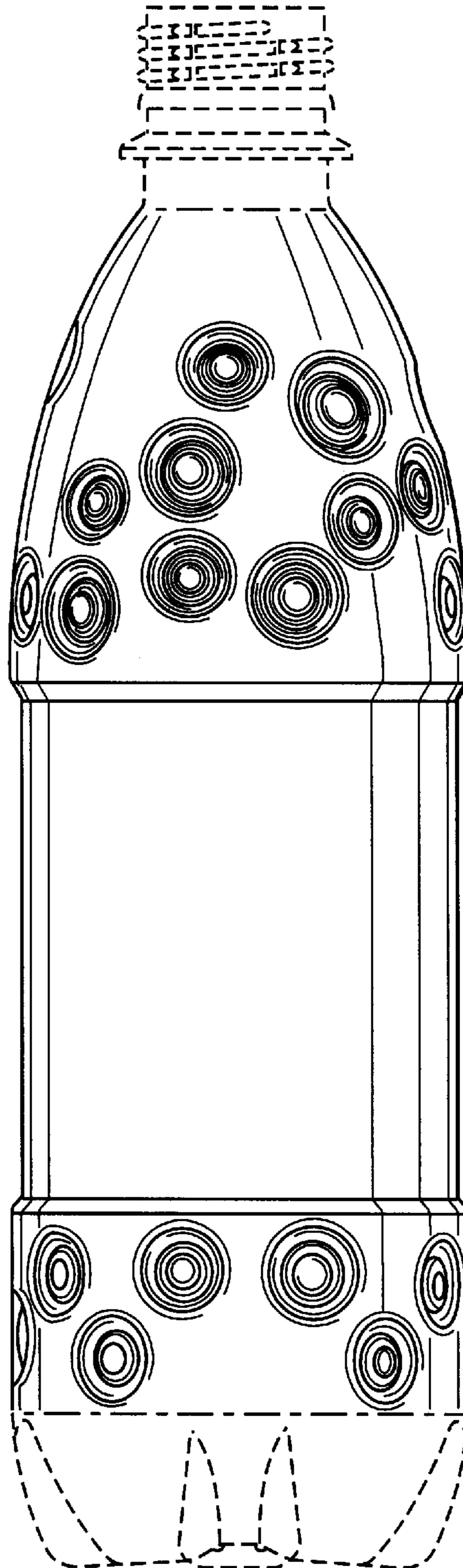

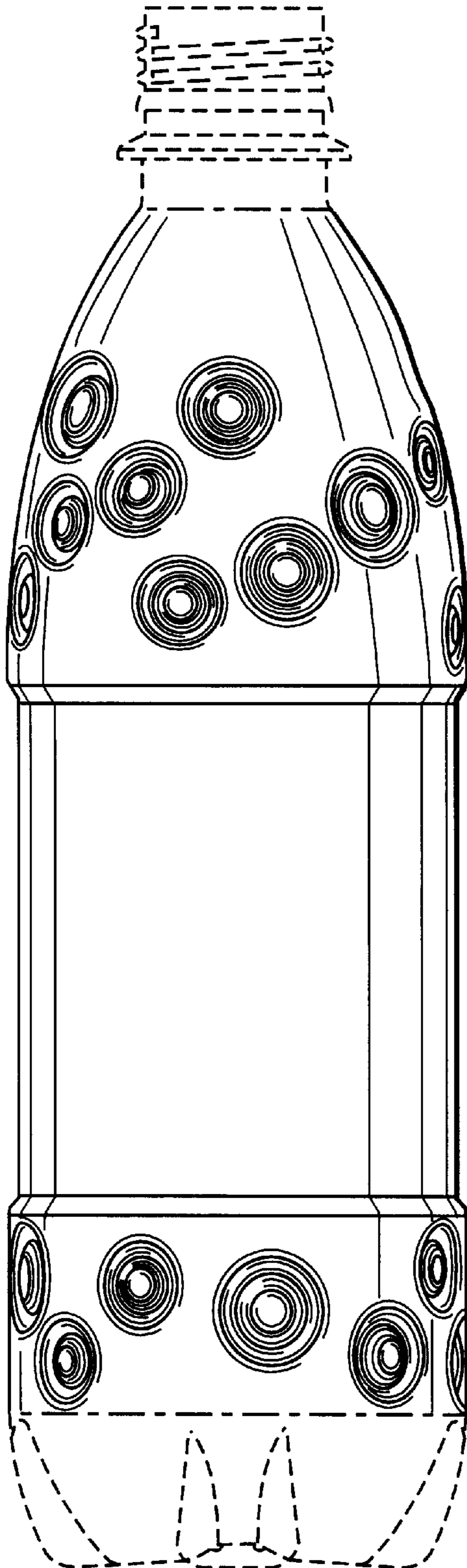

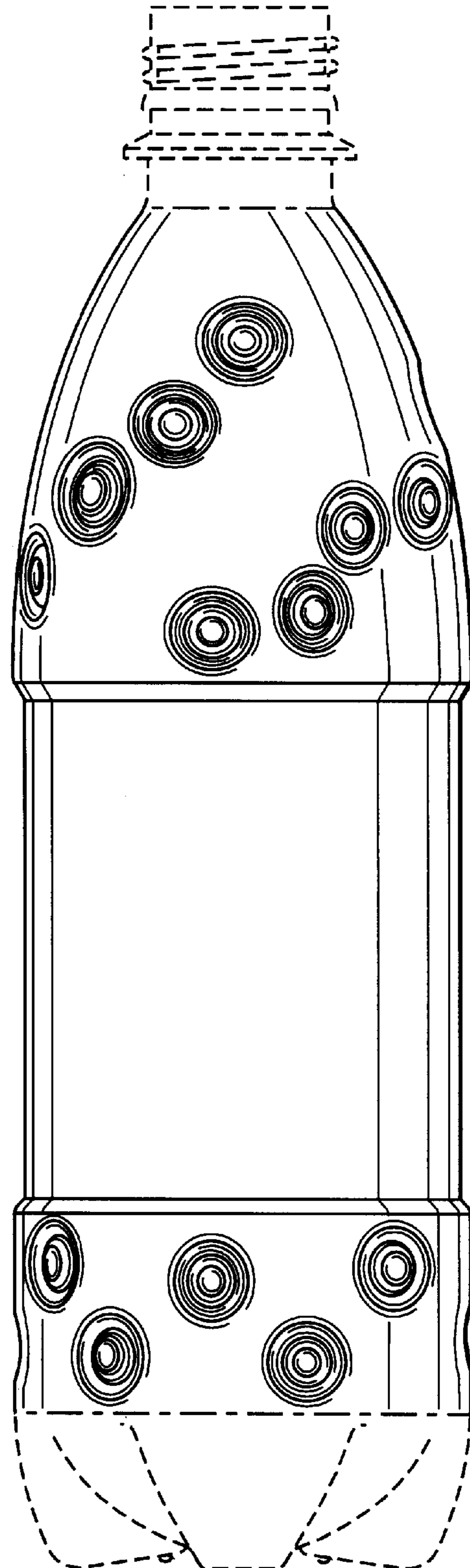

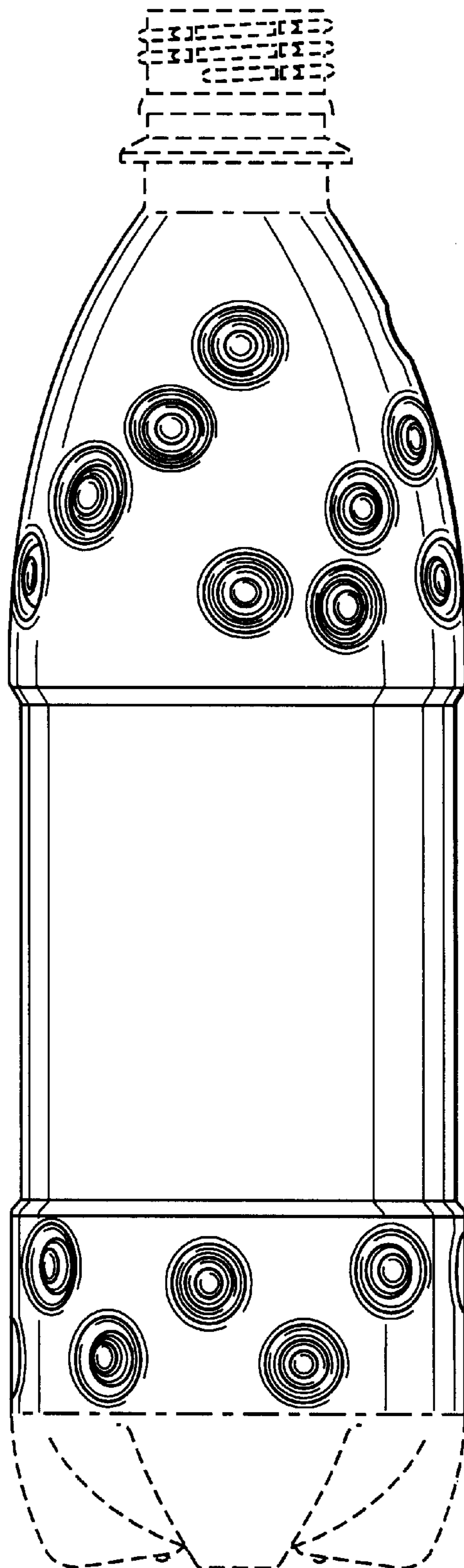

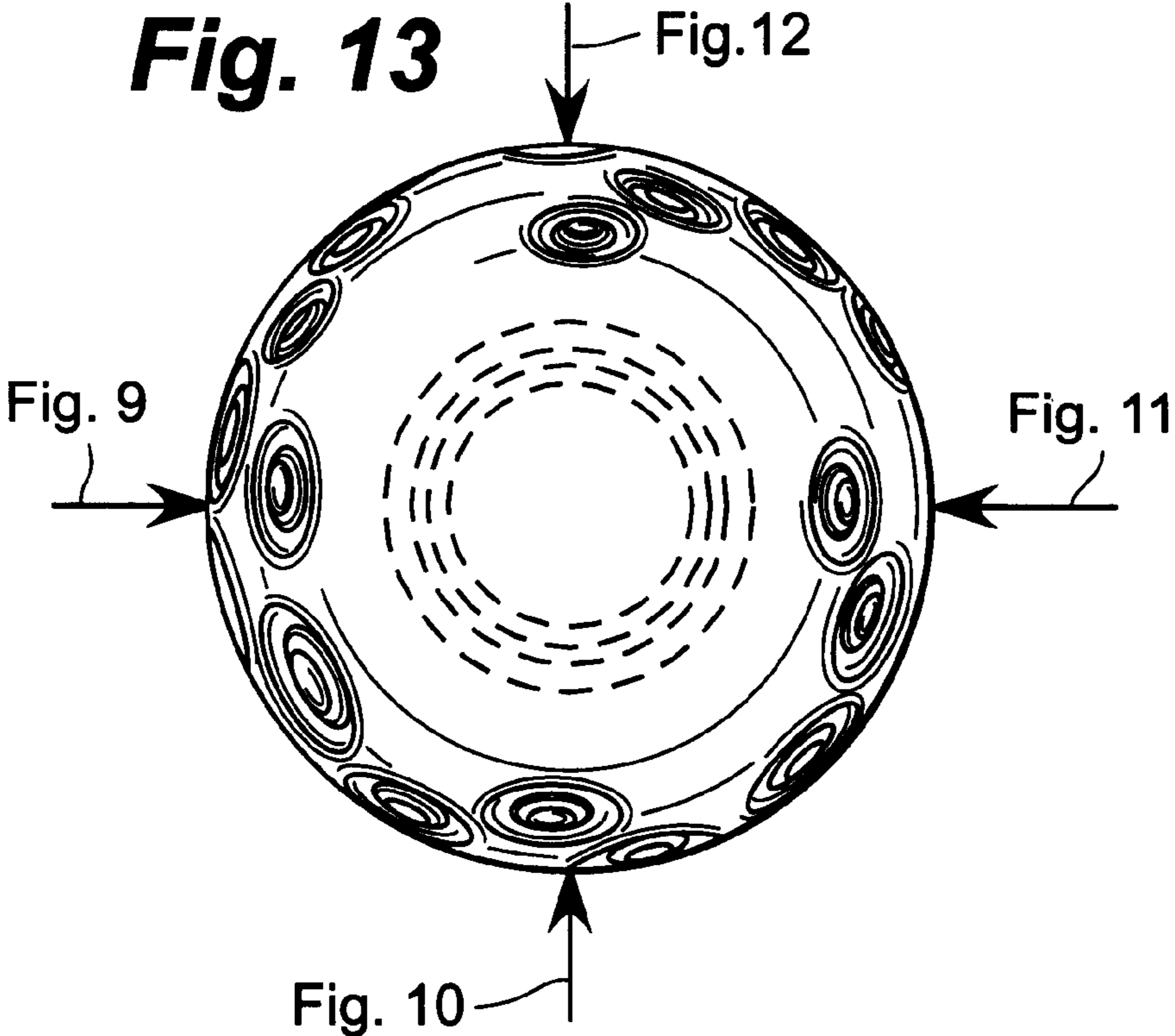
