invention; and,

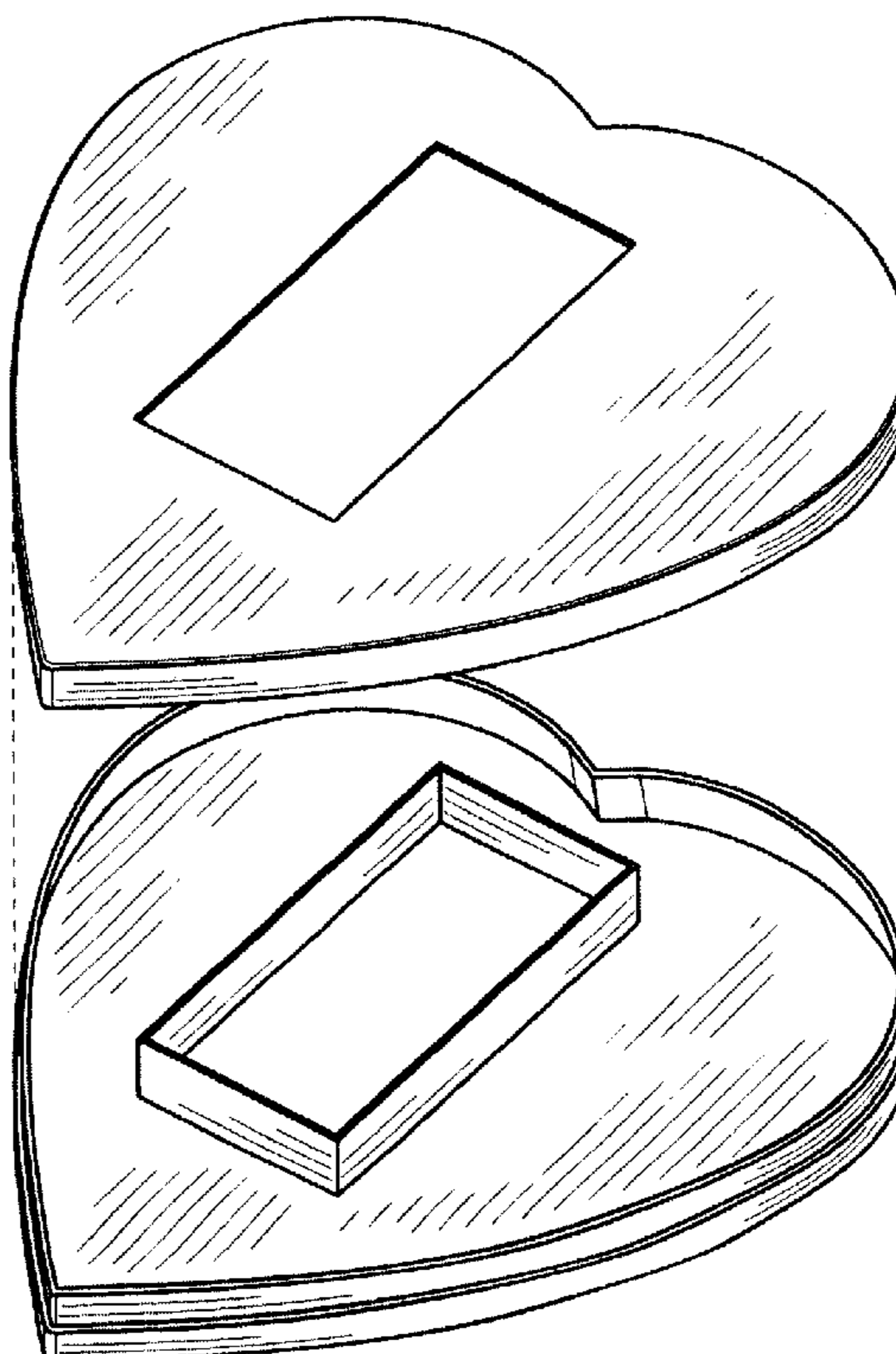
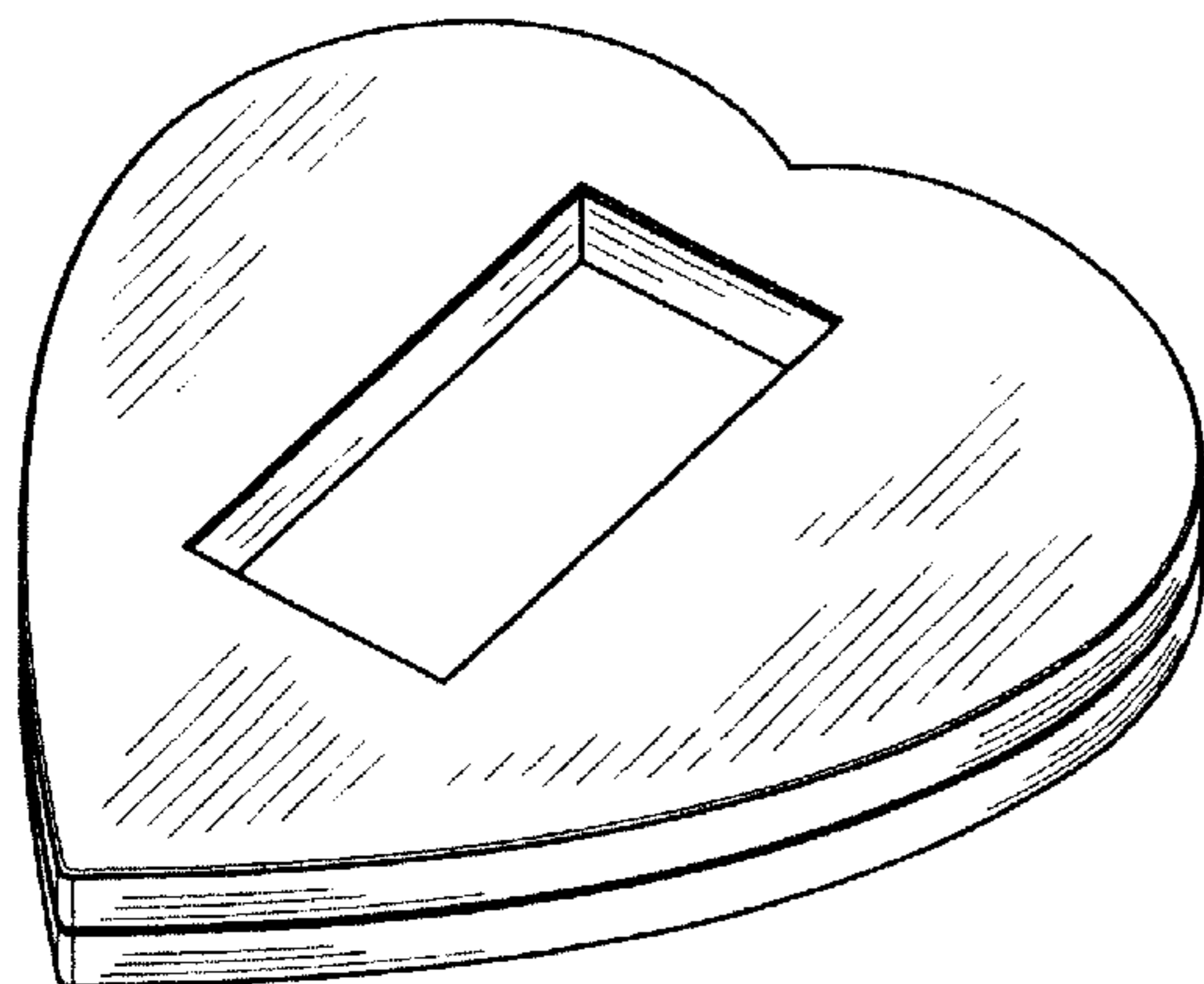
FIG. 7 is an exploded perspective view of a gift box

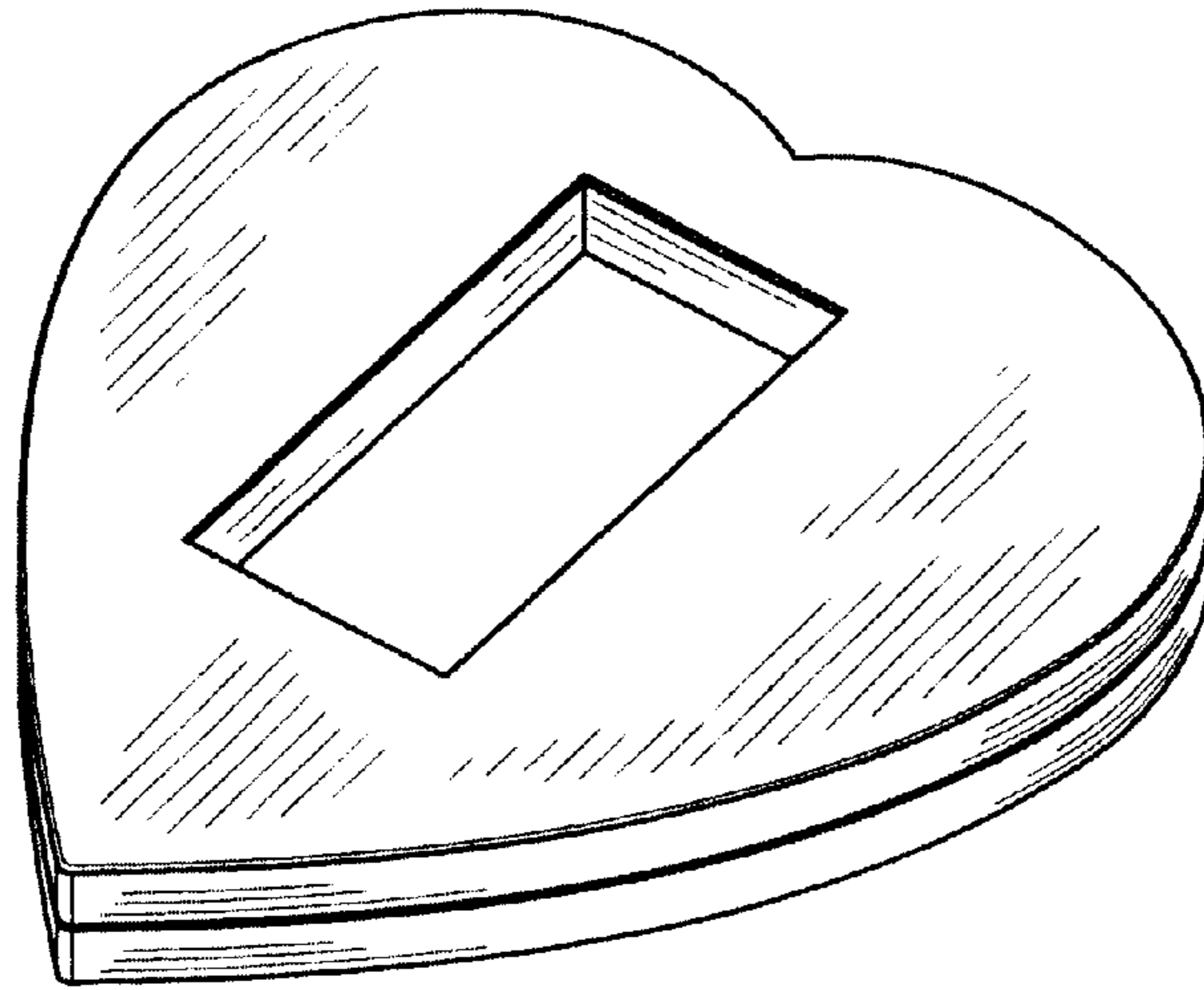

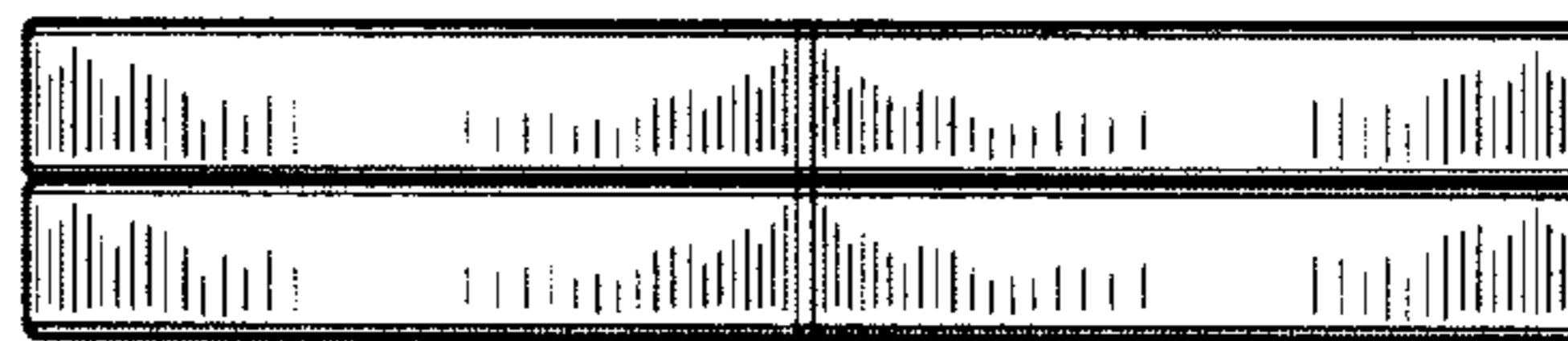

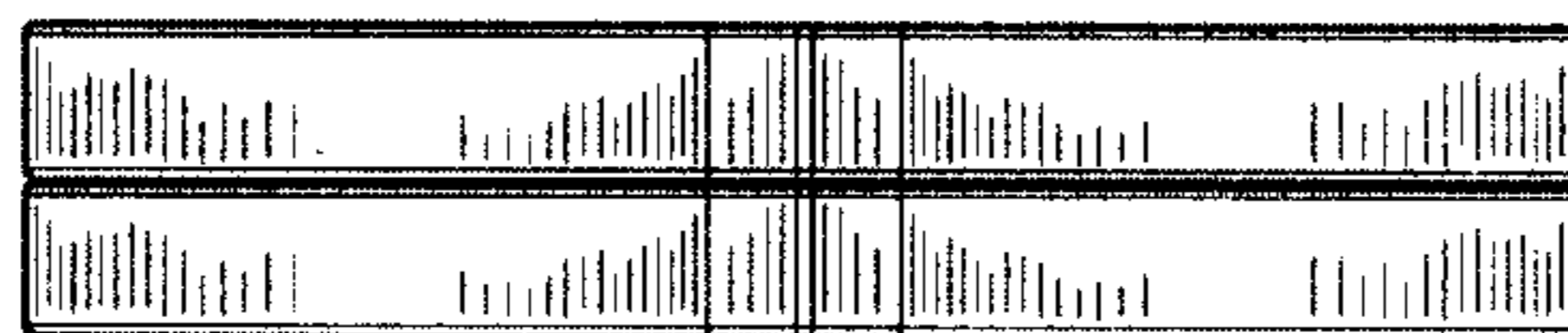

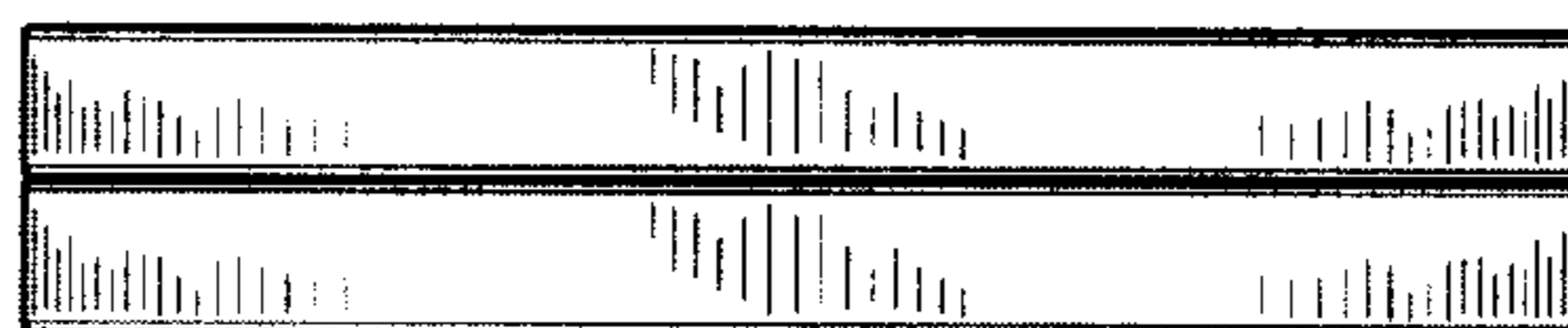

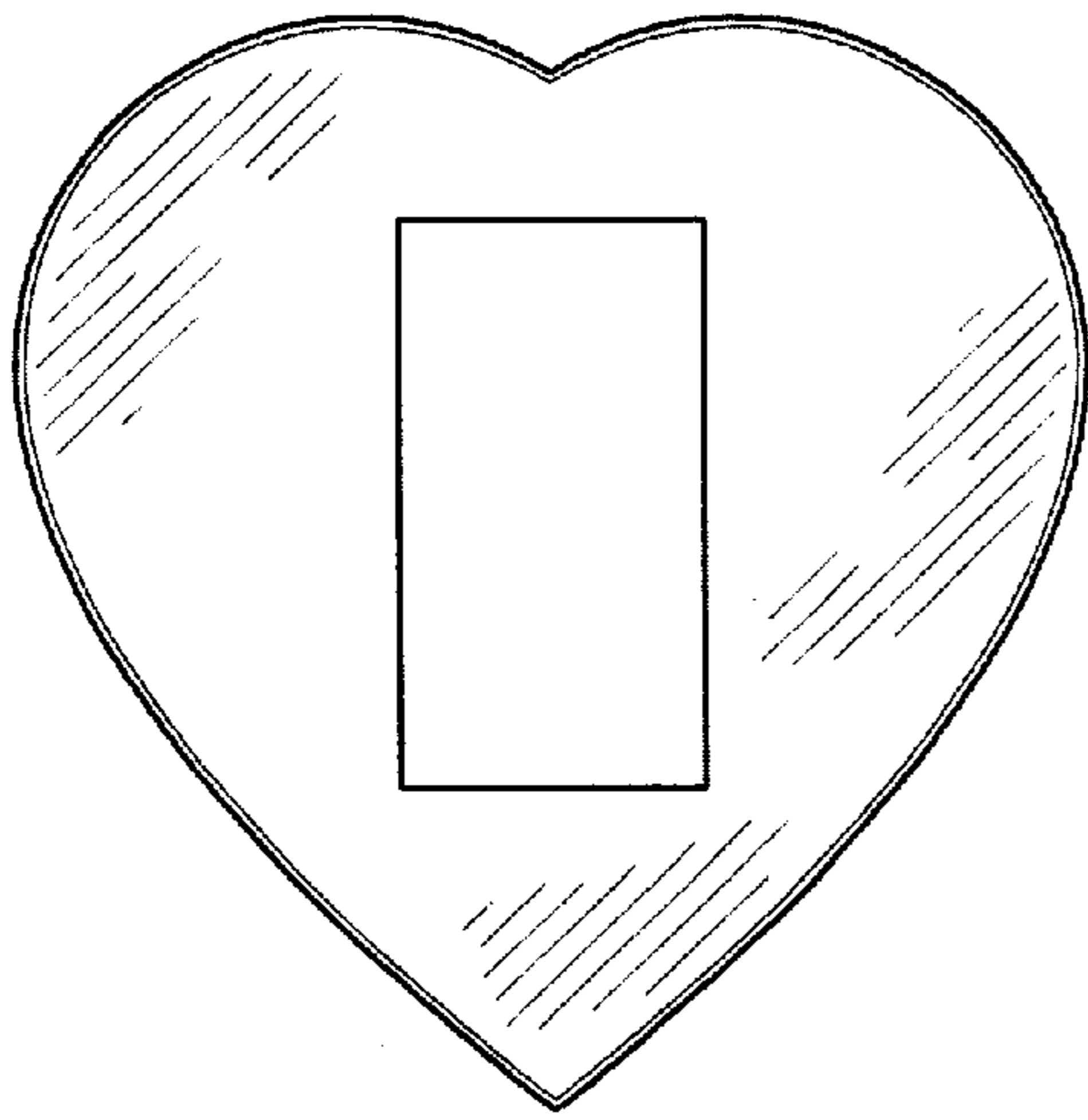

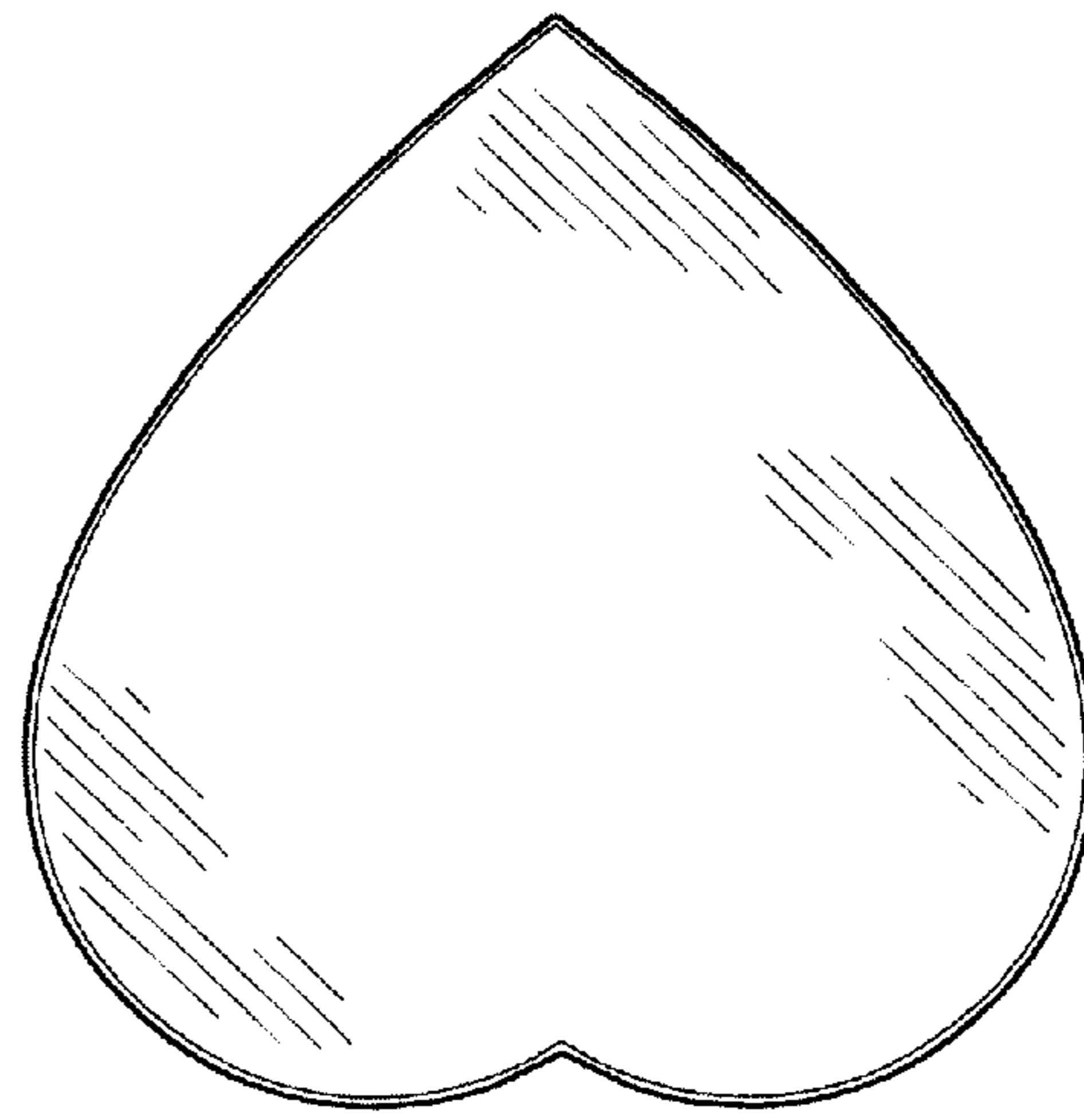

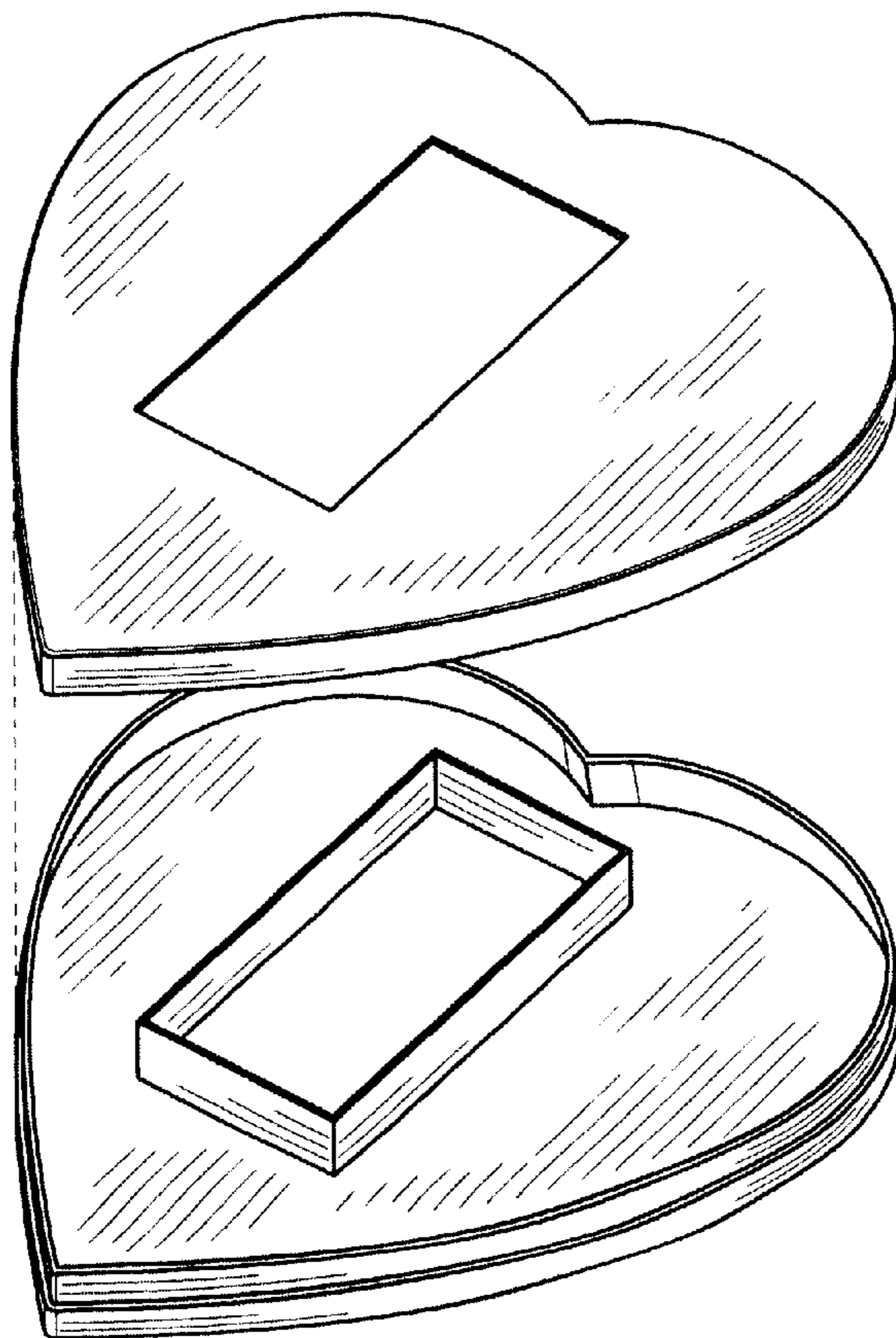
