(57) **CLAIM**

I claim the ornamental design for the passenger viewing mirror attachable to vehicle seat, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a passenger viewing mirror attachable to vehicle seat.

FIG. 2 is a rear view of the passenger viewing mirror attachable to vehicle seat.

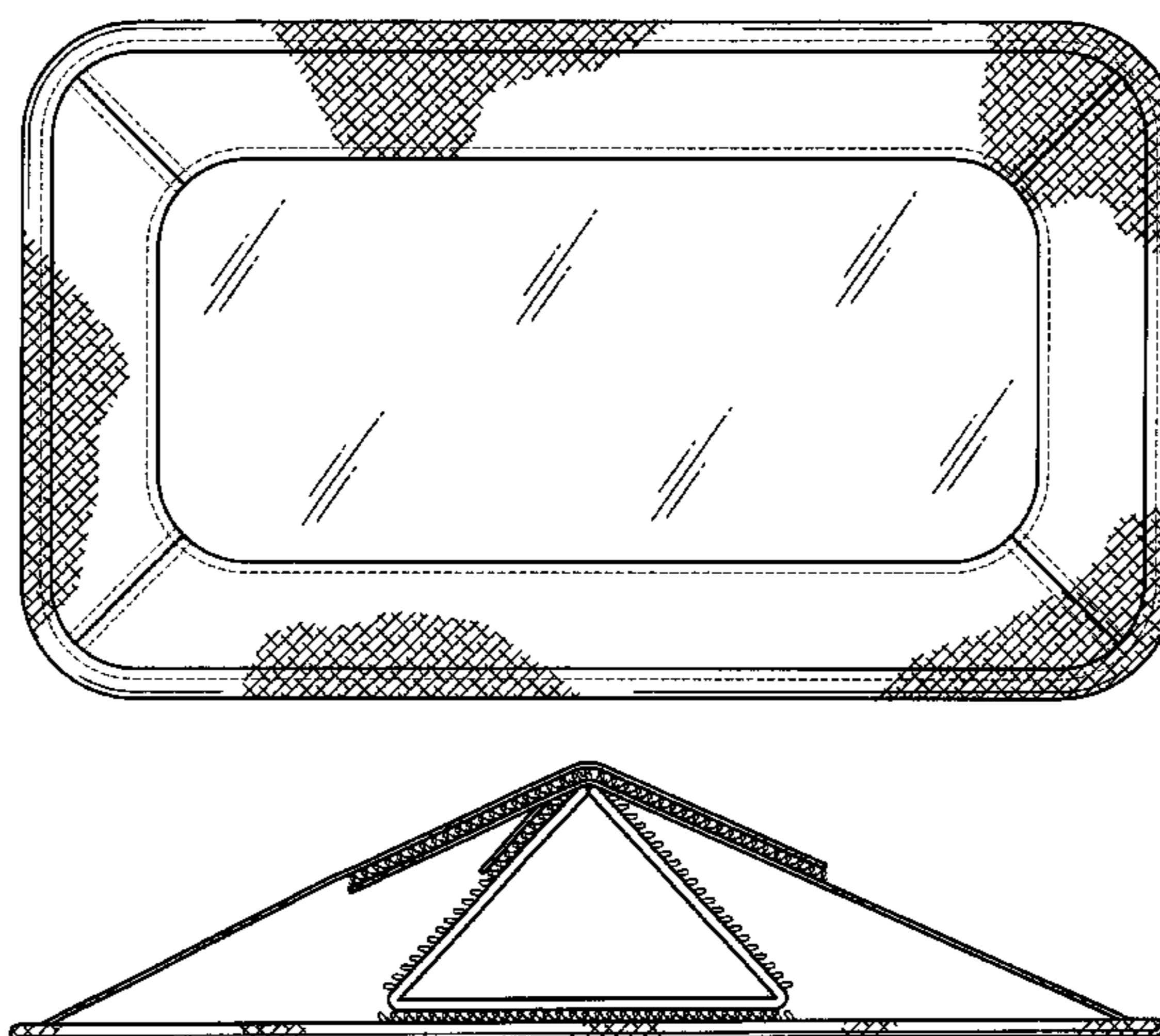
FIG. 3 is a top view of the passenger viewing mirror attachable to vehicle seat (the bottom view being a mirror image of the top view).

FIG. 4 is a right side view of the passenger viewing mirror attachable to vehicle seat; and,

FIG. 5 is a left side view of the passenger viewing mirror attachable to vehicle seat.

The cross hatched shading shown in FIGS. 1-5 is understood to cover the surface on which it is applied. The dashed lines shown on the passenger viewing mirror attachable to vehicle seat in FIGS. 1, 2, 4 and 5 are understood to represent stitching.

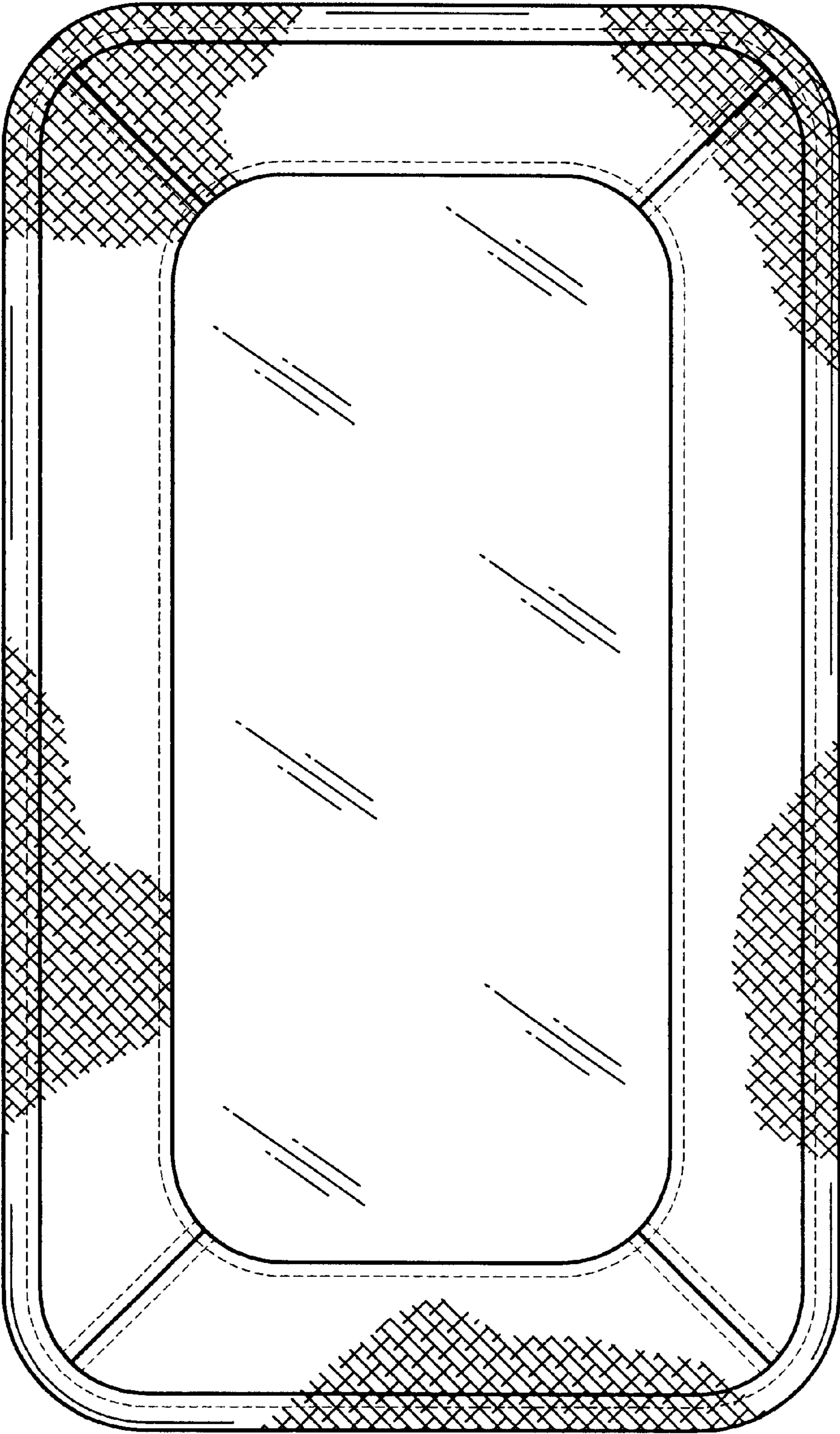

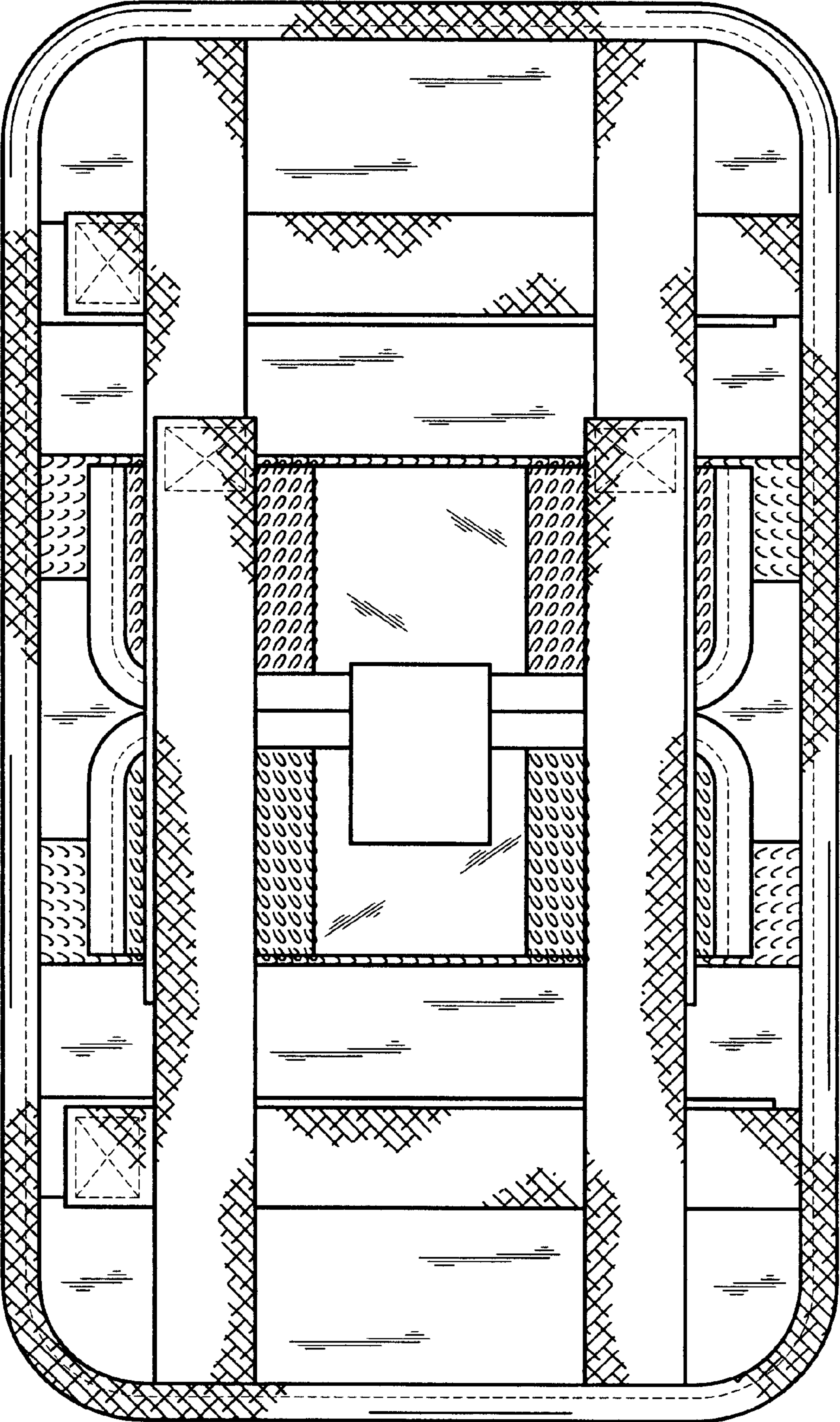

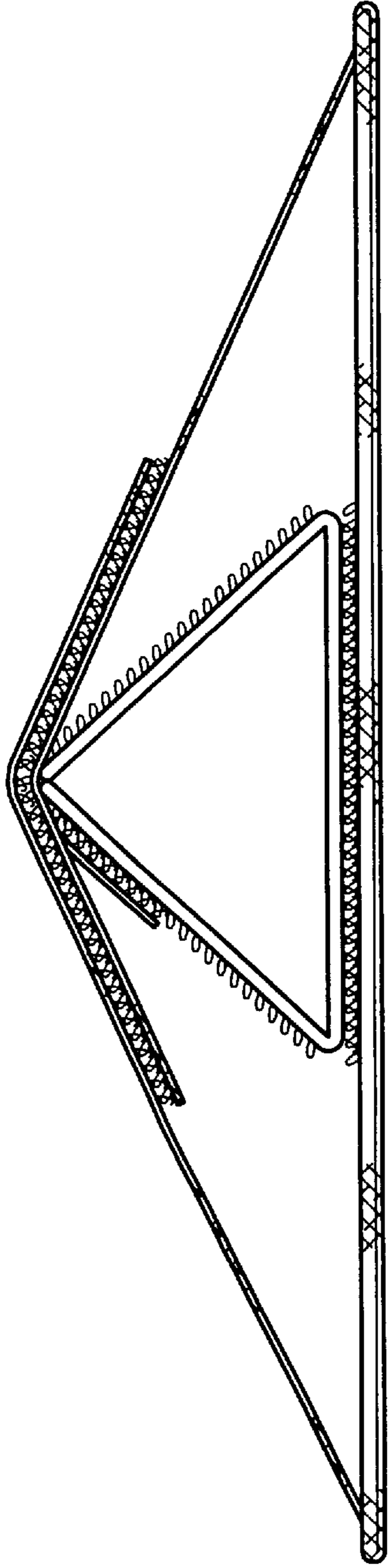

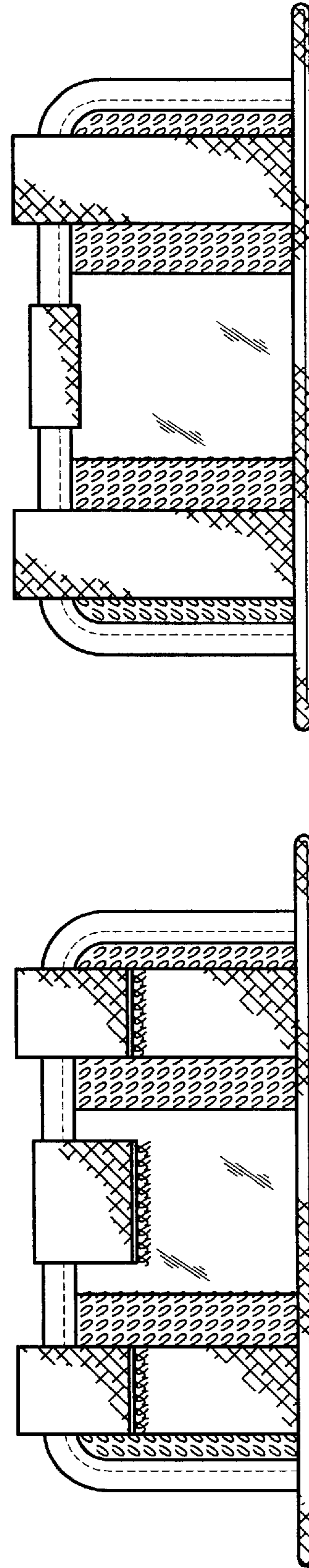
